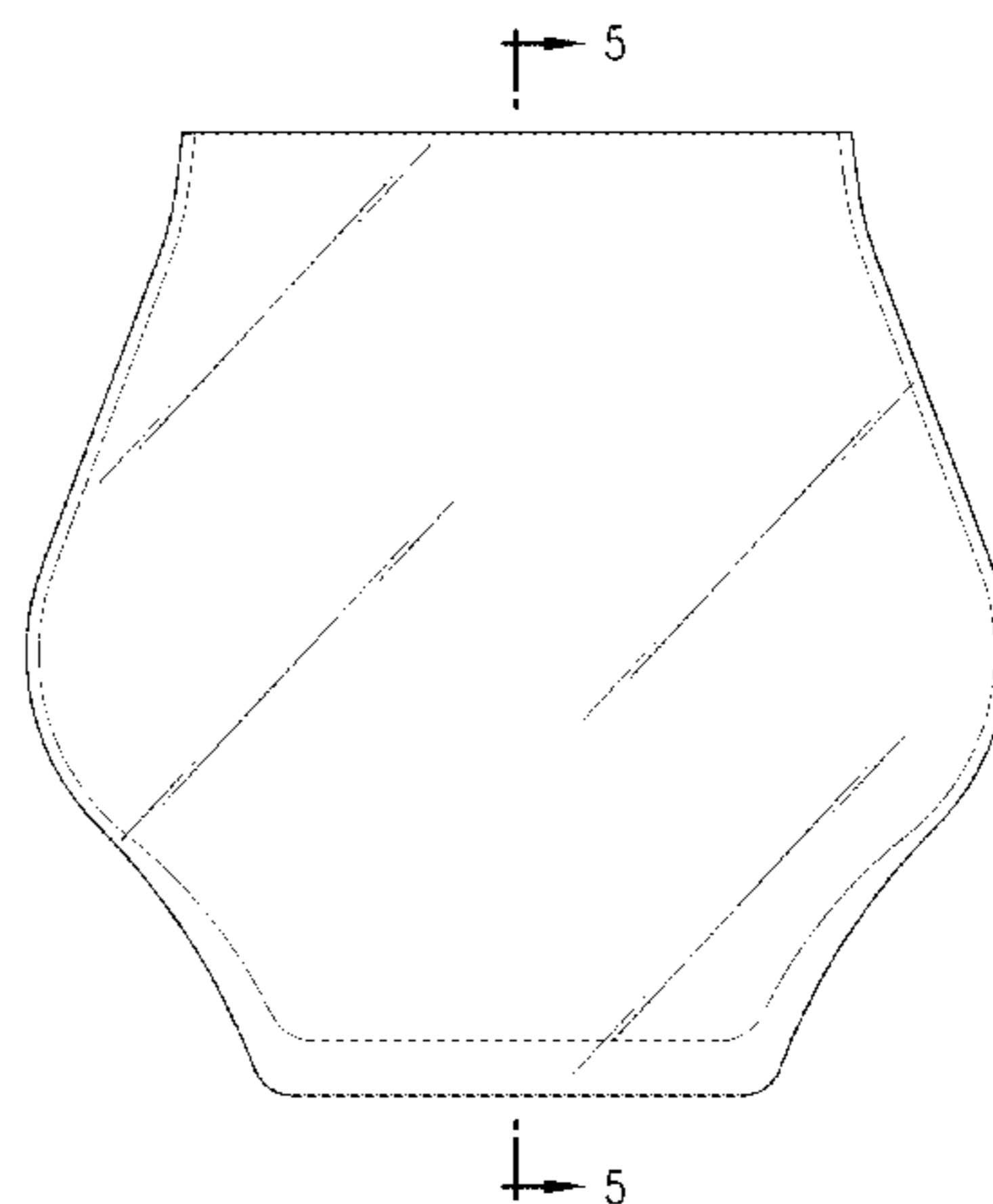
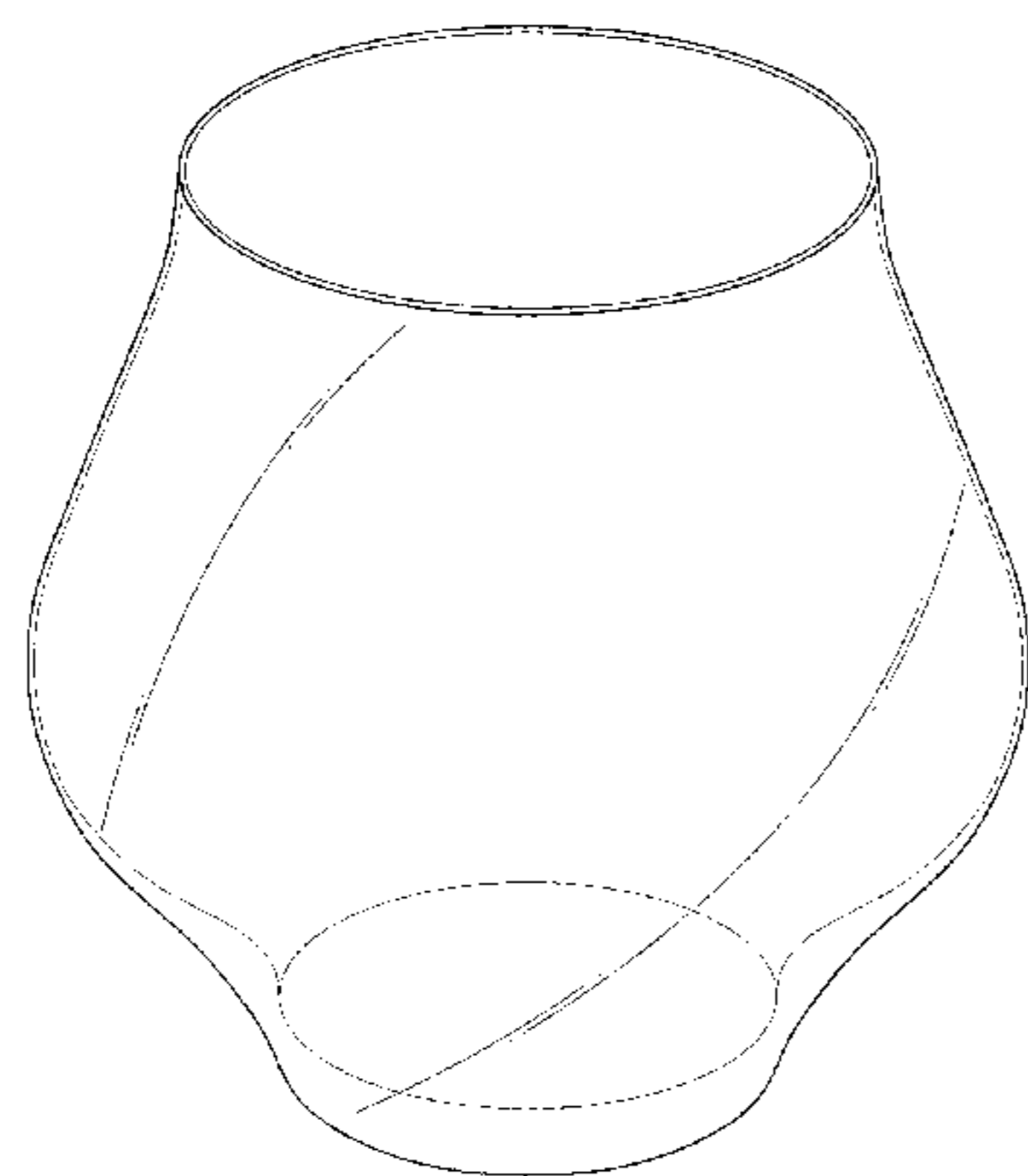
(57) **CLAIM**

I claim the ornamental design for a glass, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a glass showing my new design;  
FIG. 2 is side elevational view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof; and,  
FIG. 5 is a cross sectional view showing a section taken along line 5-5 of FIG. 2.

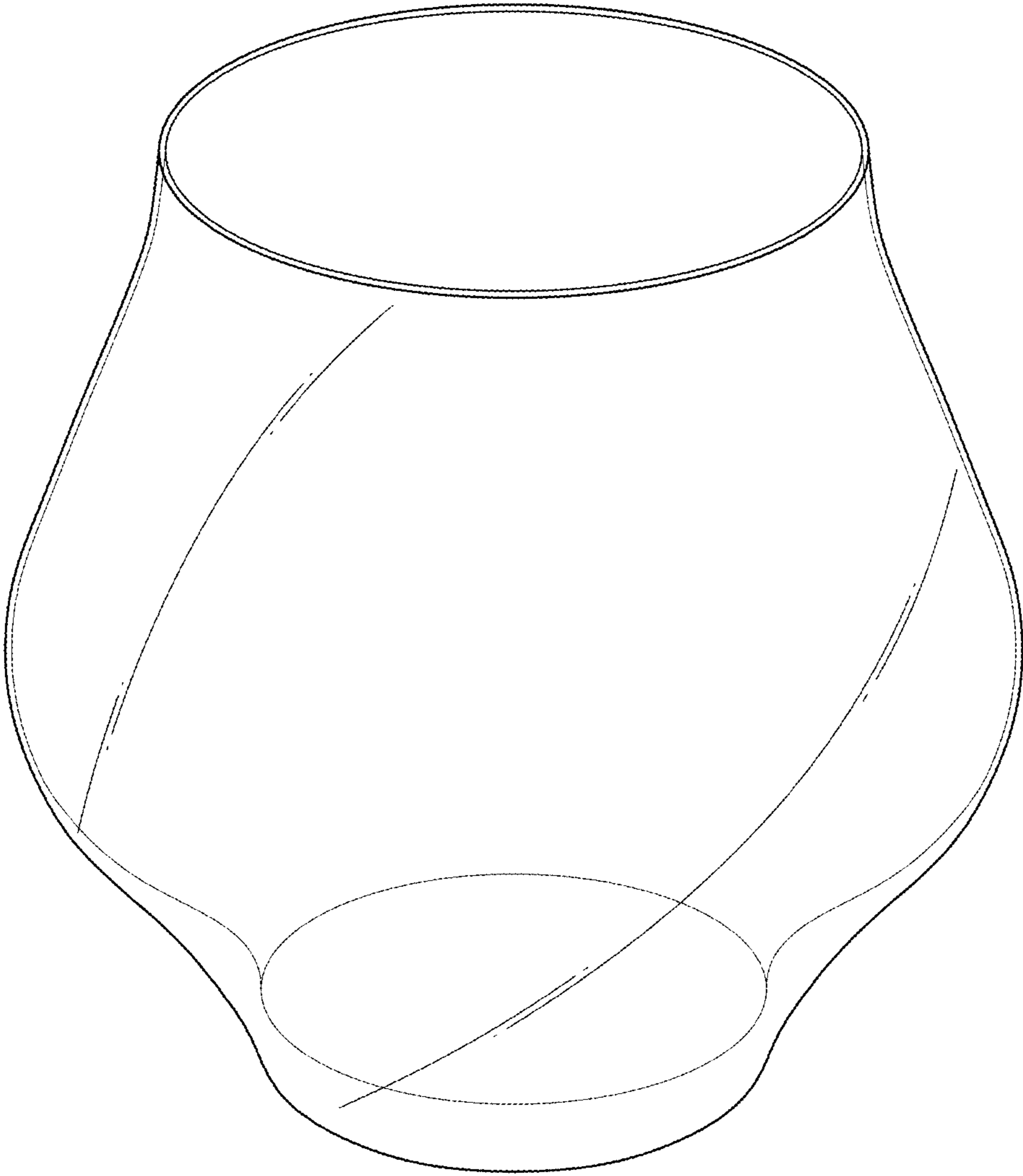

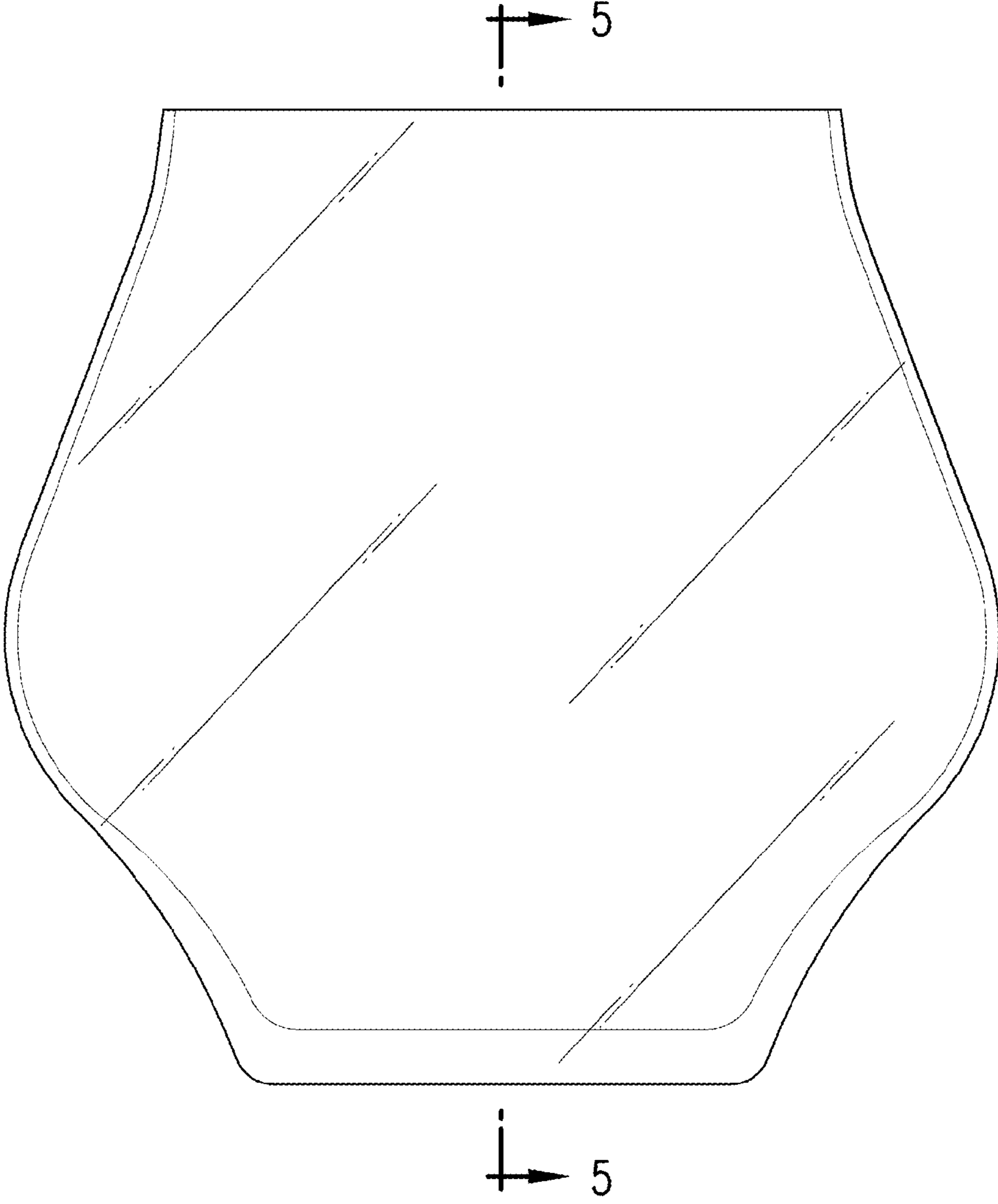

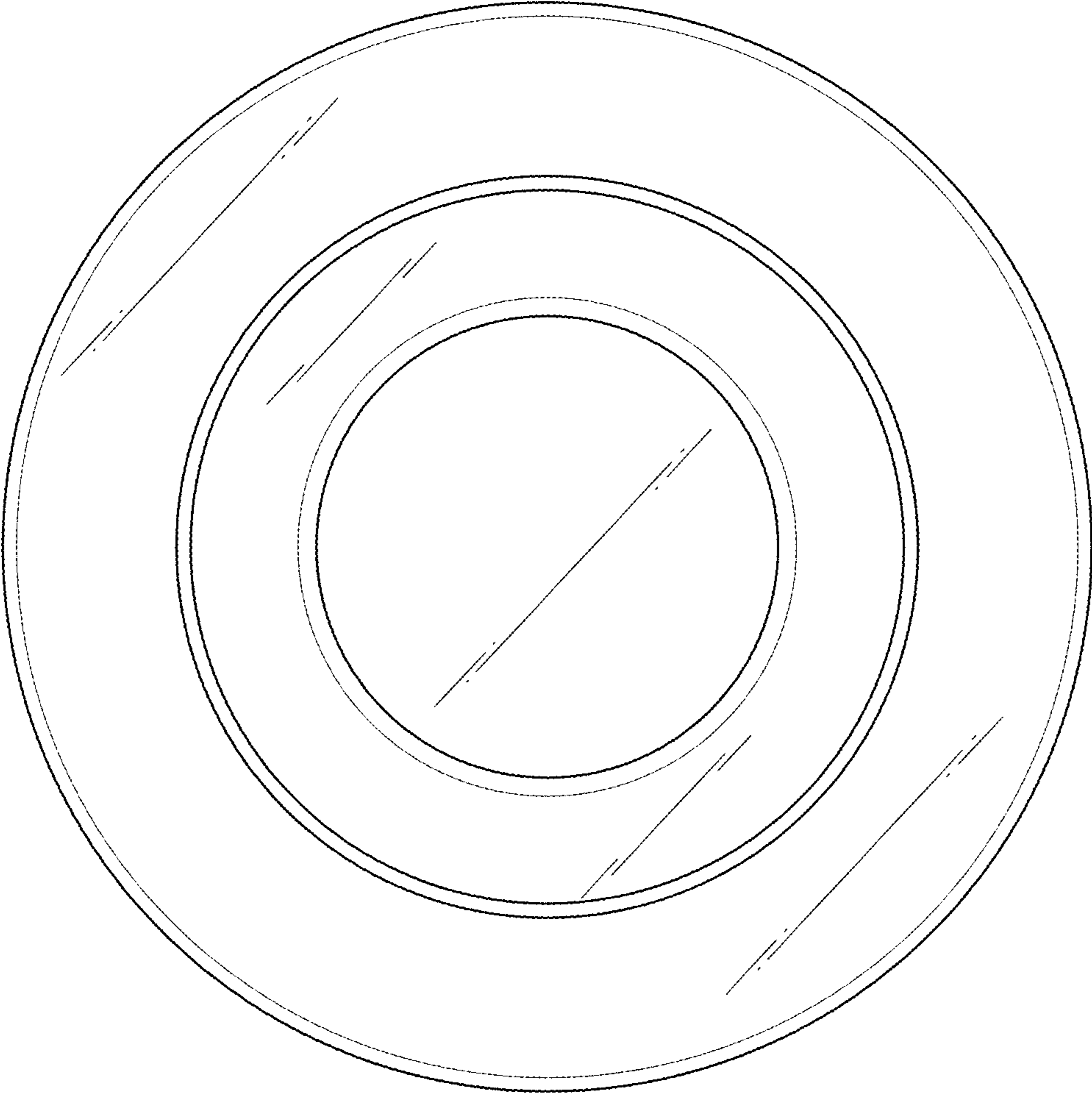

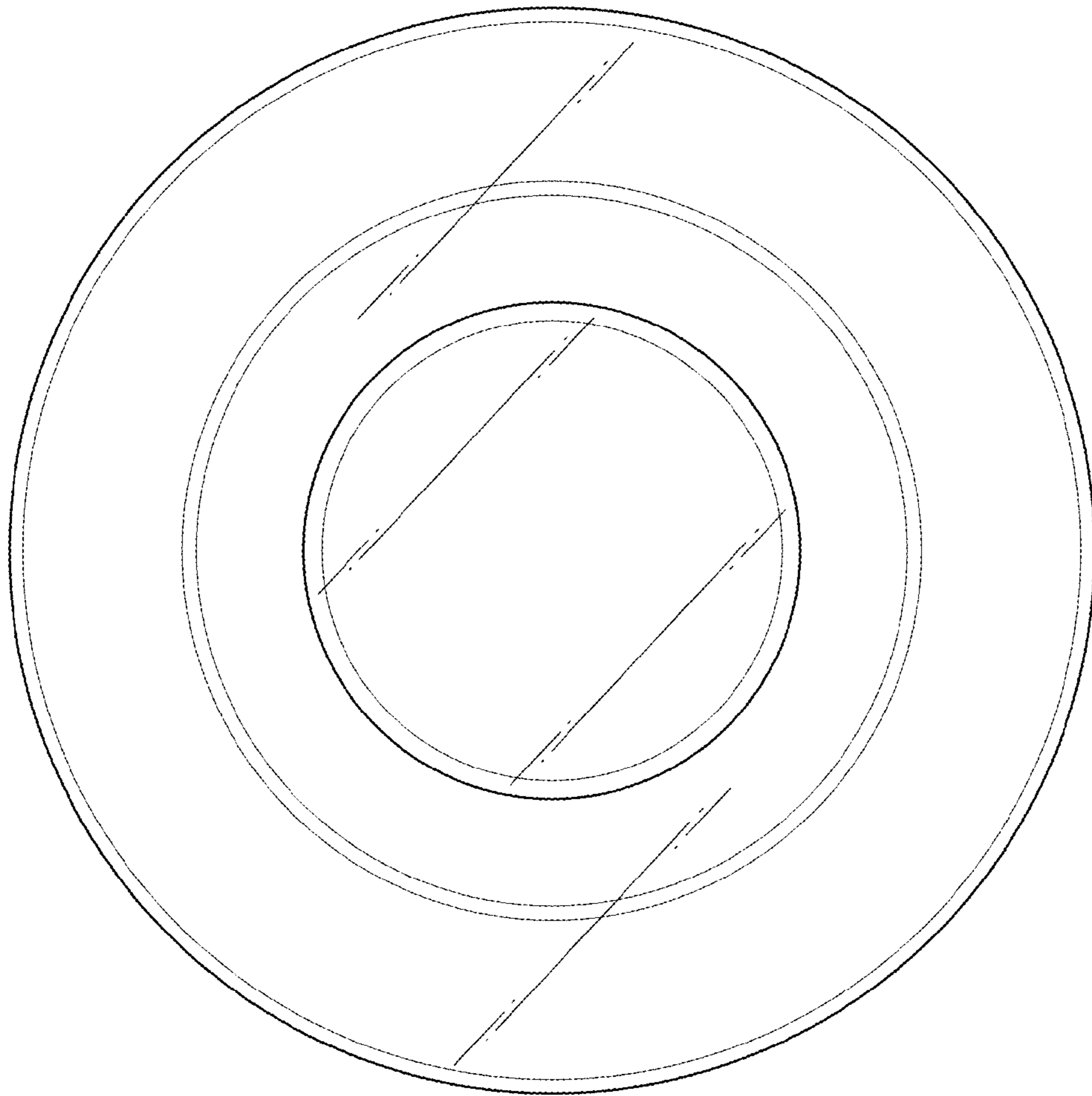

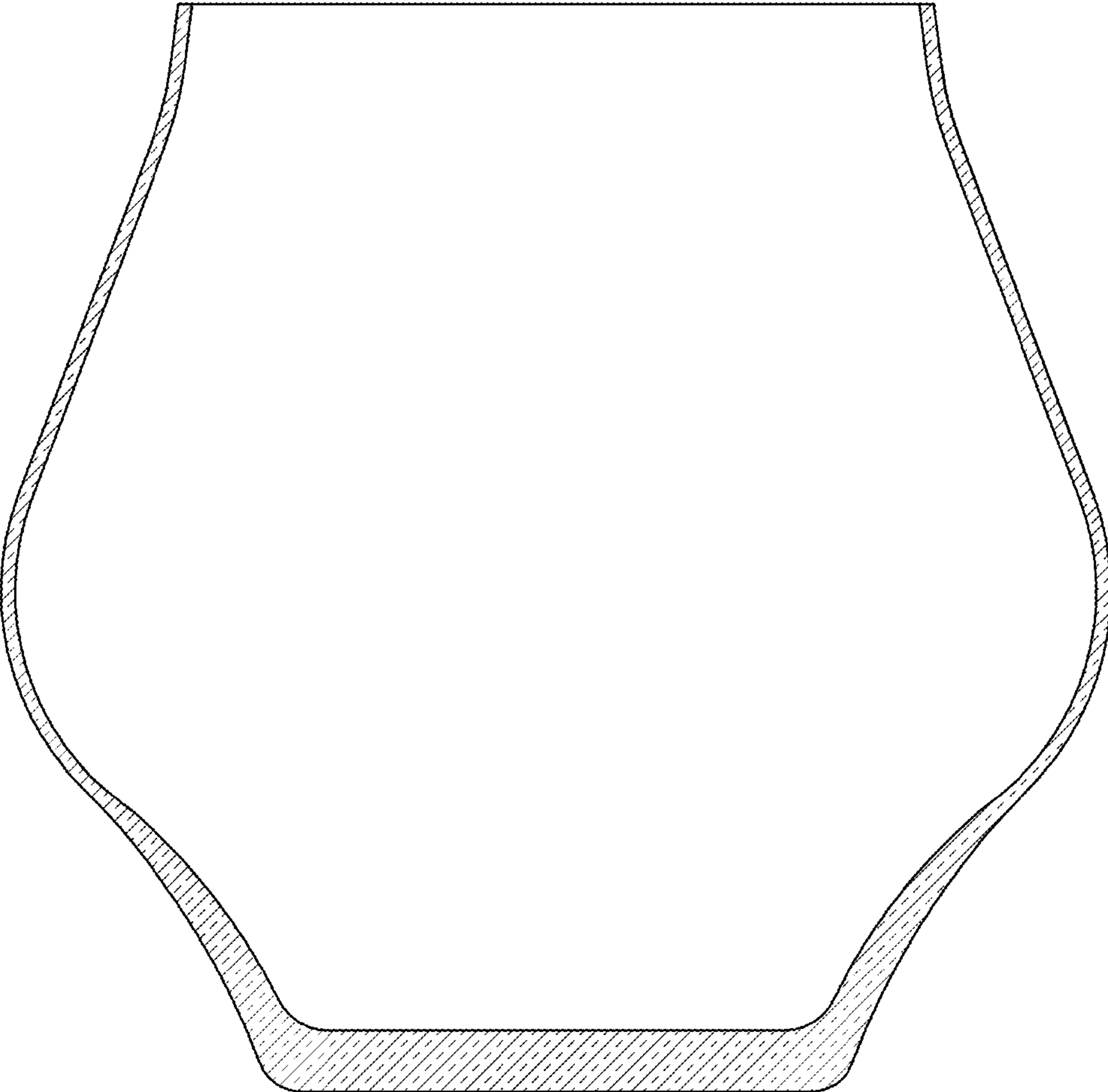
