FIG. 14 is an enlarged rear elevation view of the embodiment of FIG. 8.

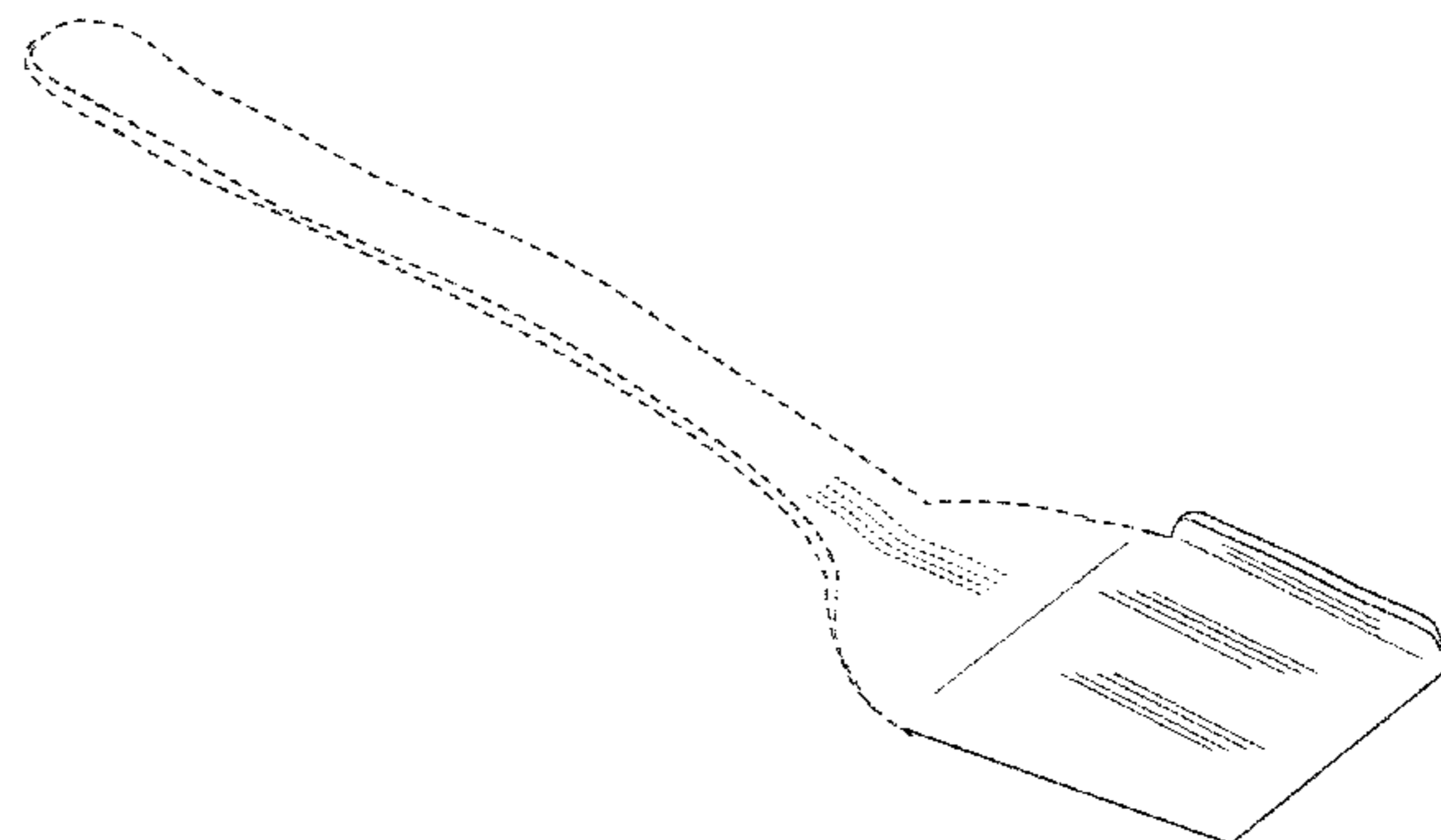
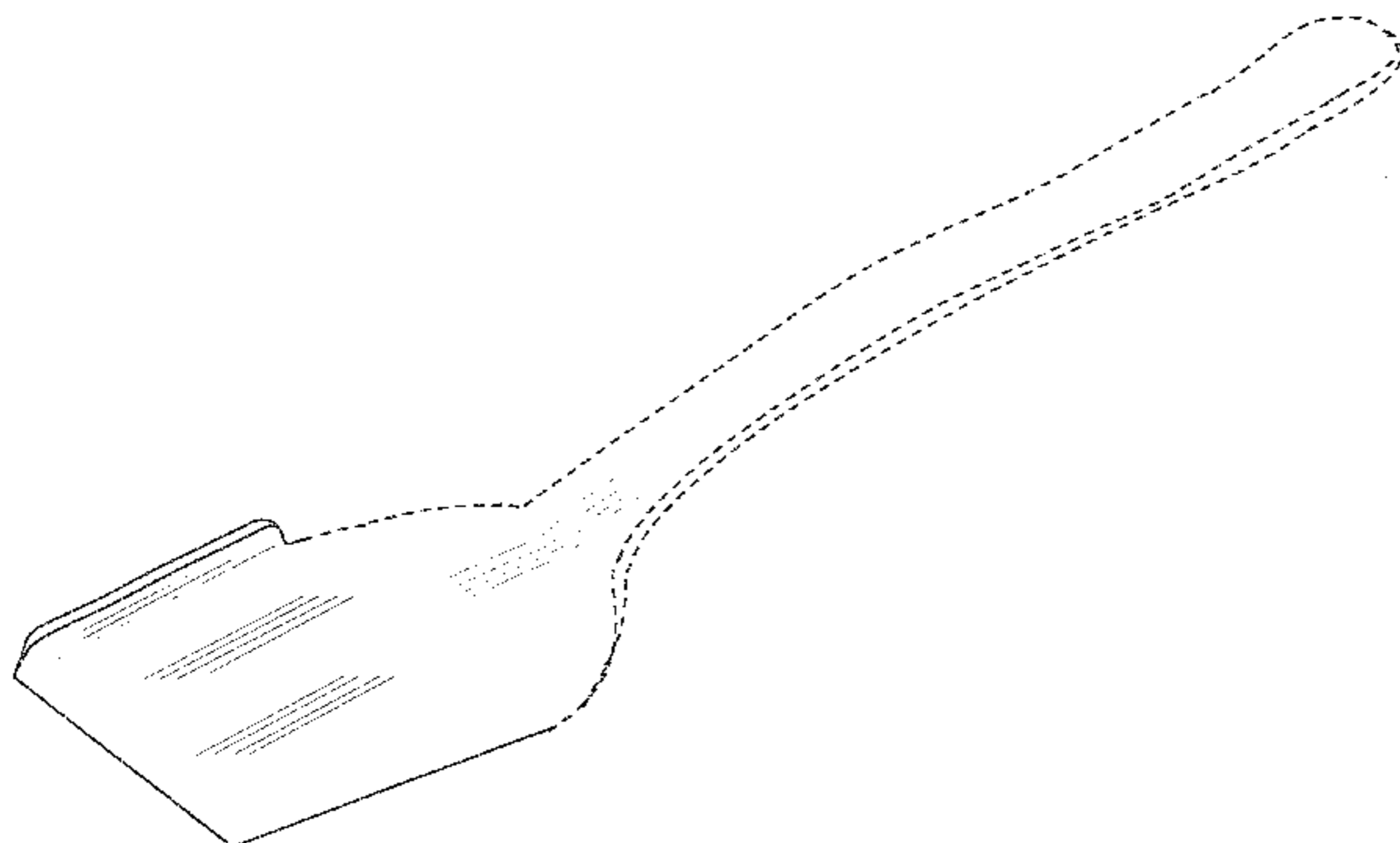

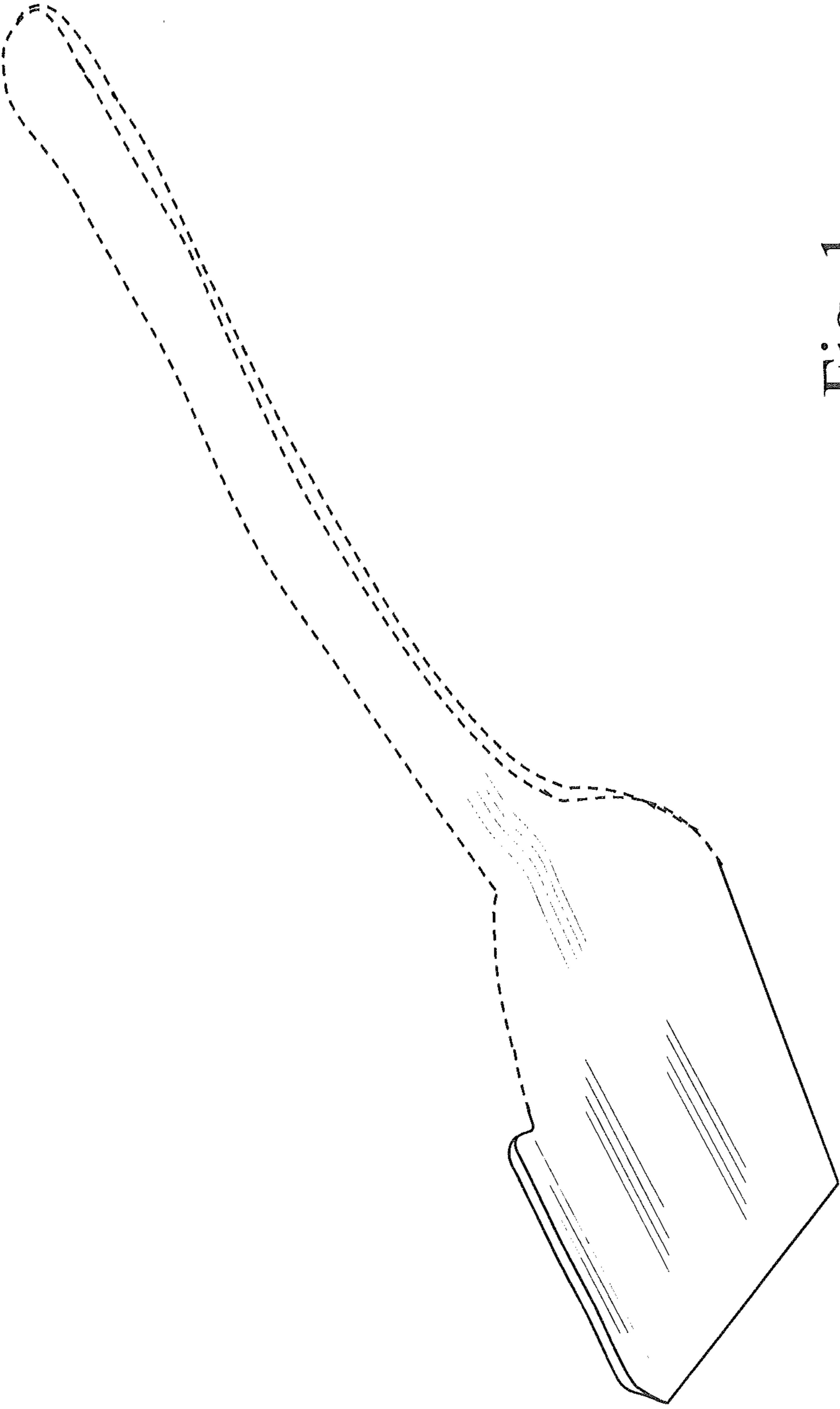

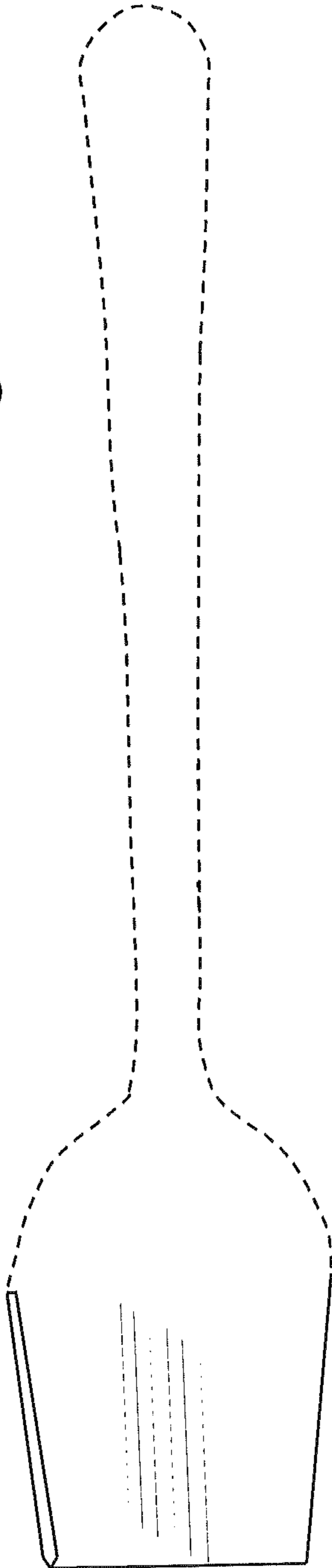

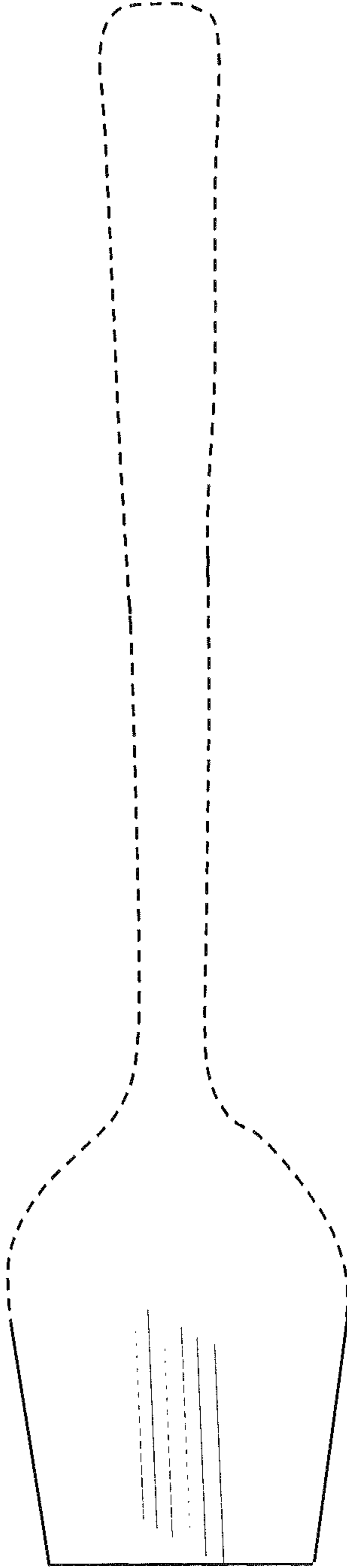

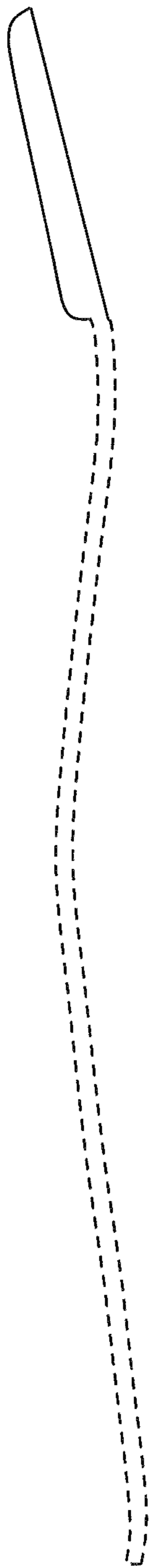

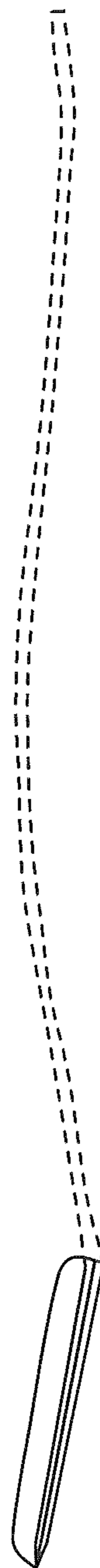

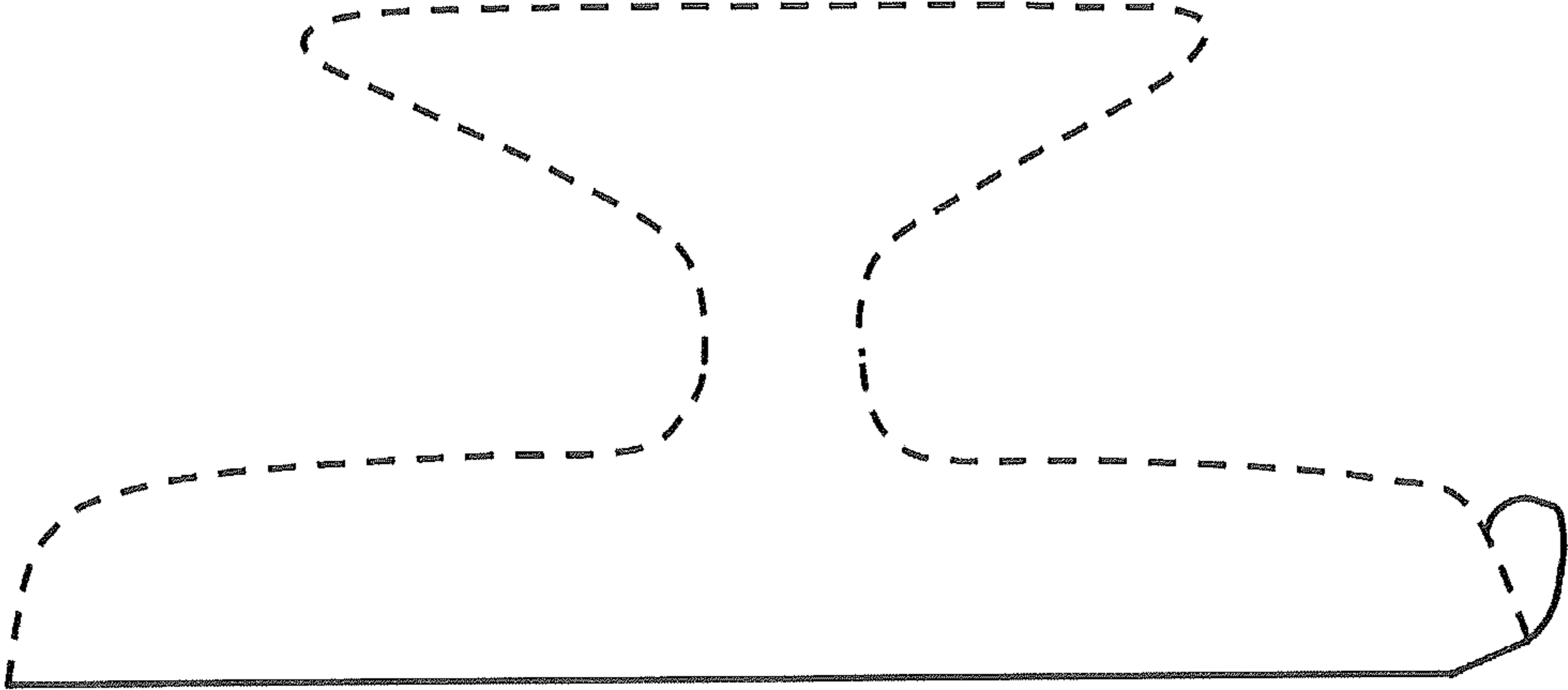
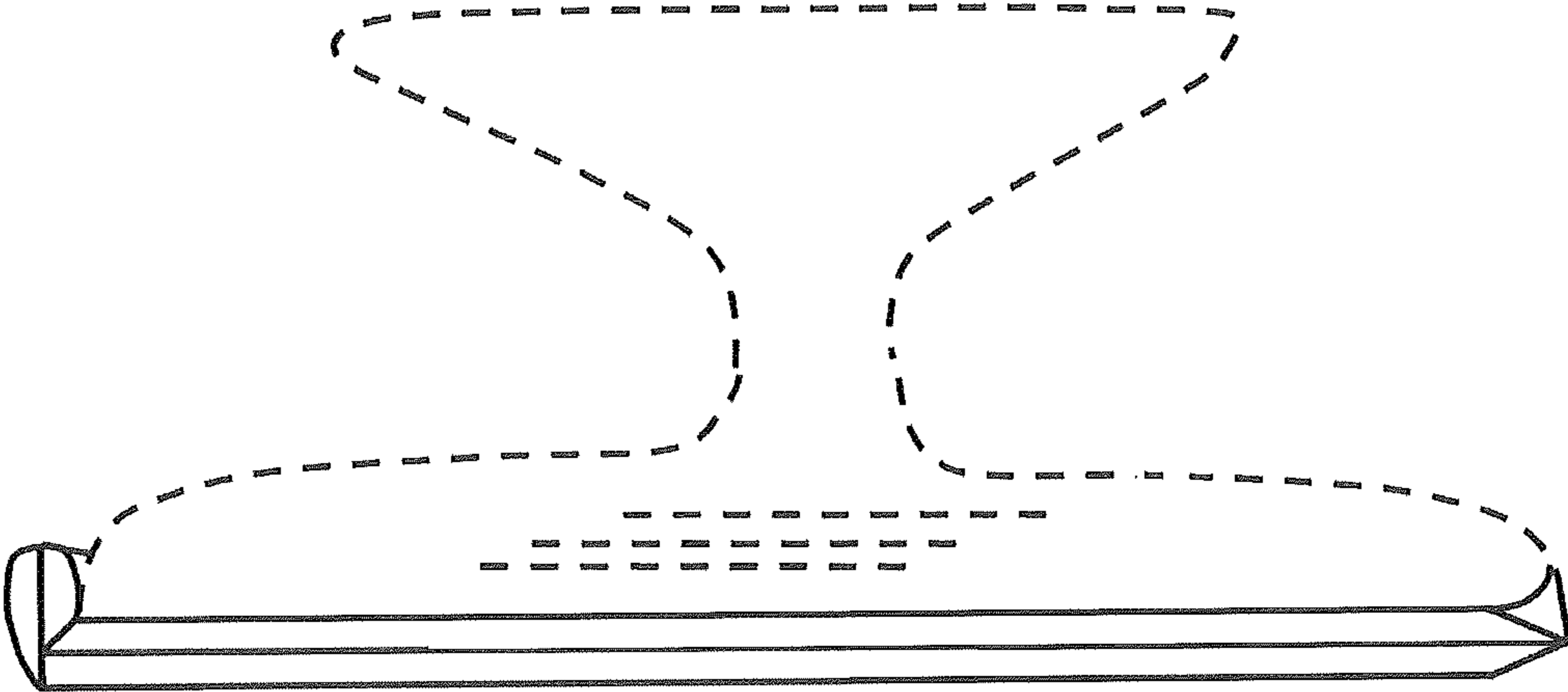

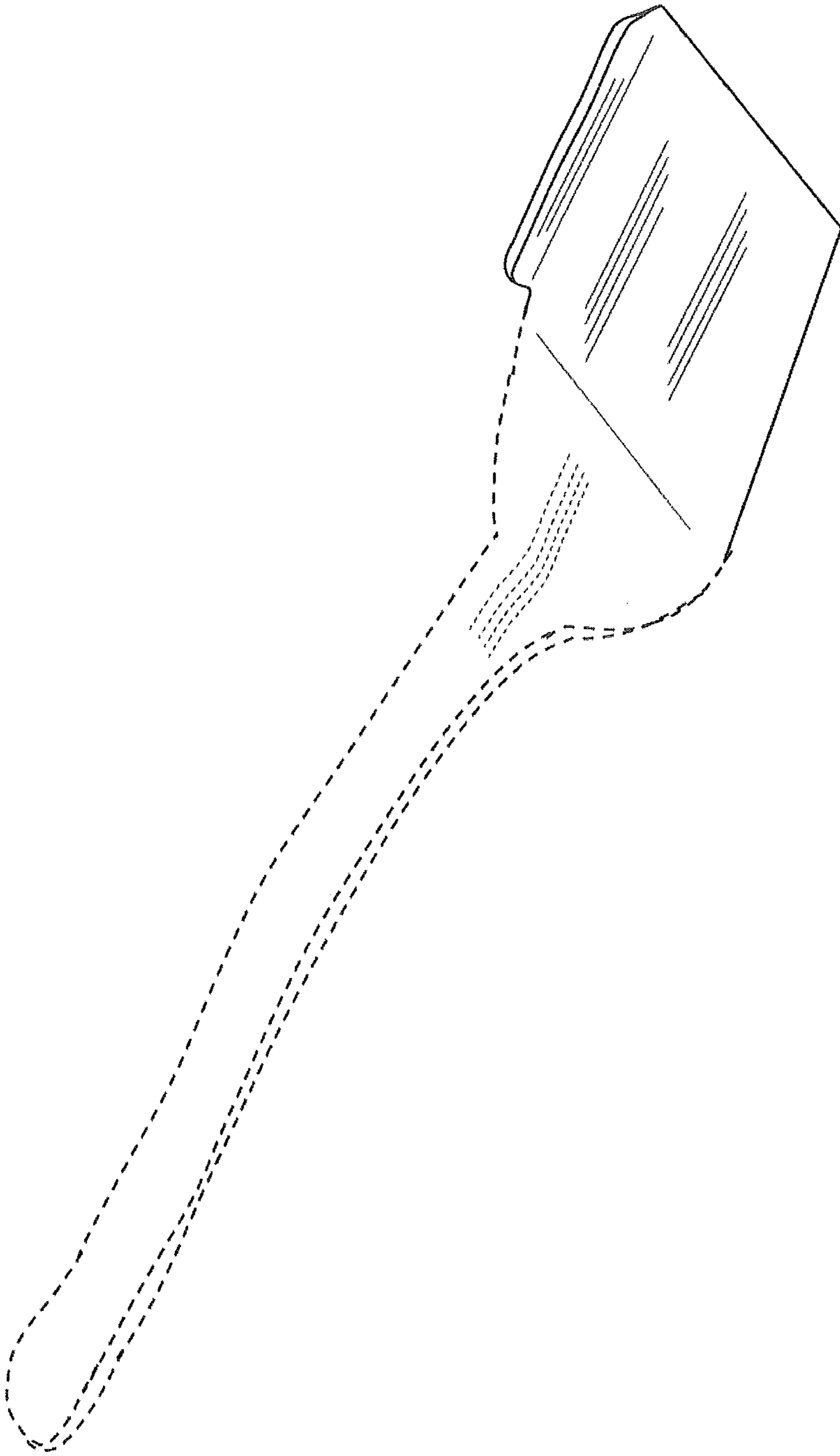

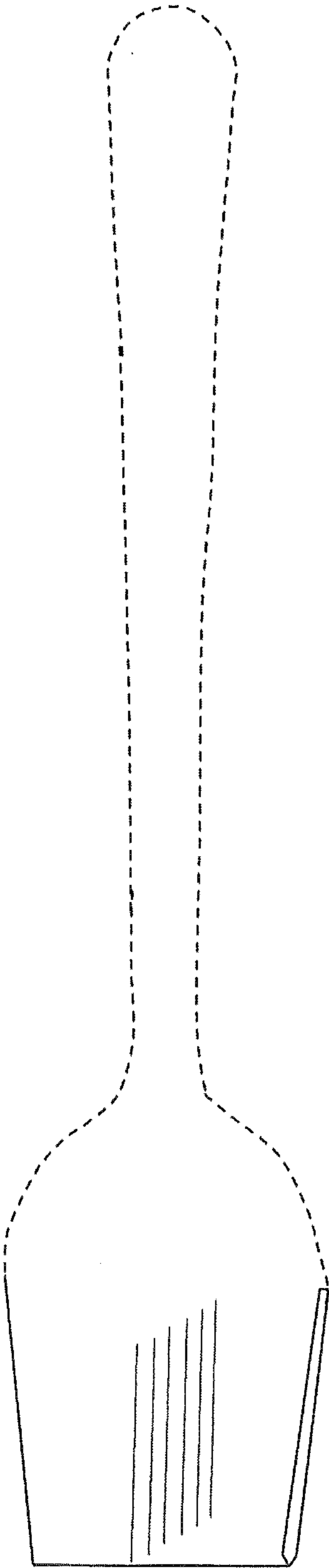

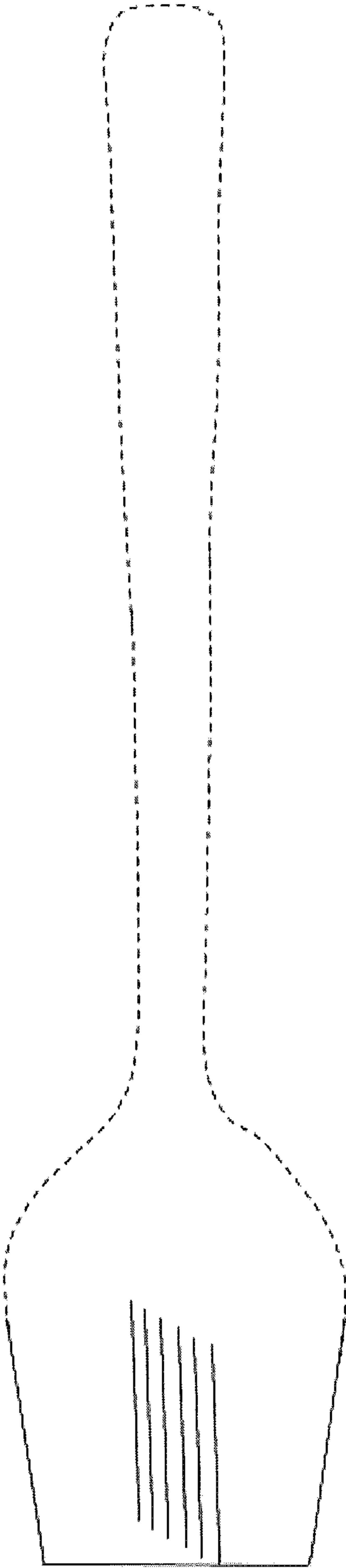

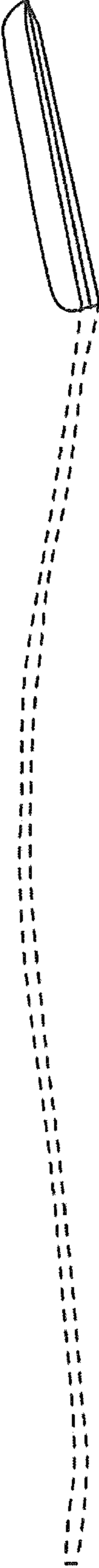

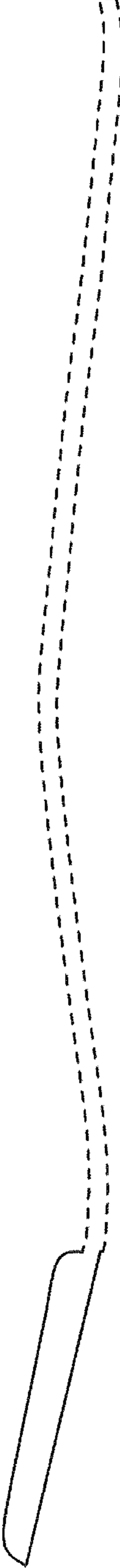

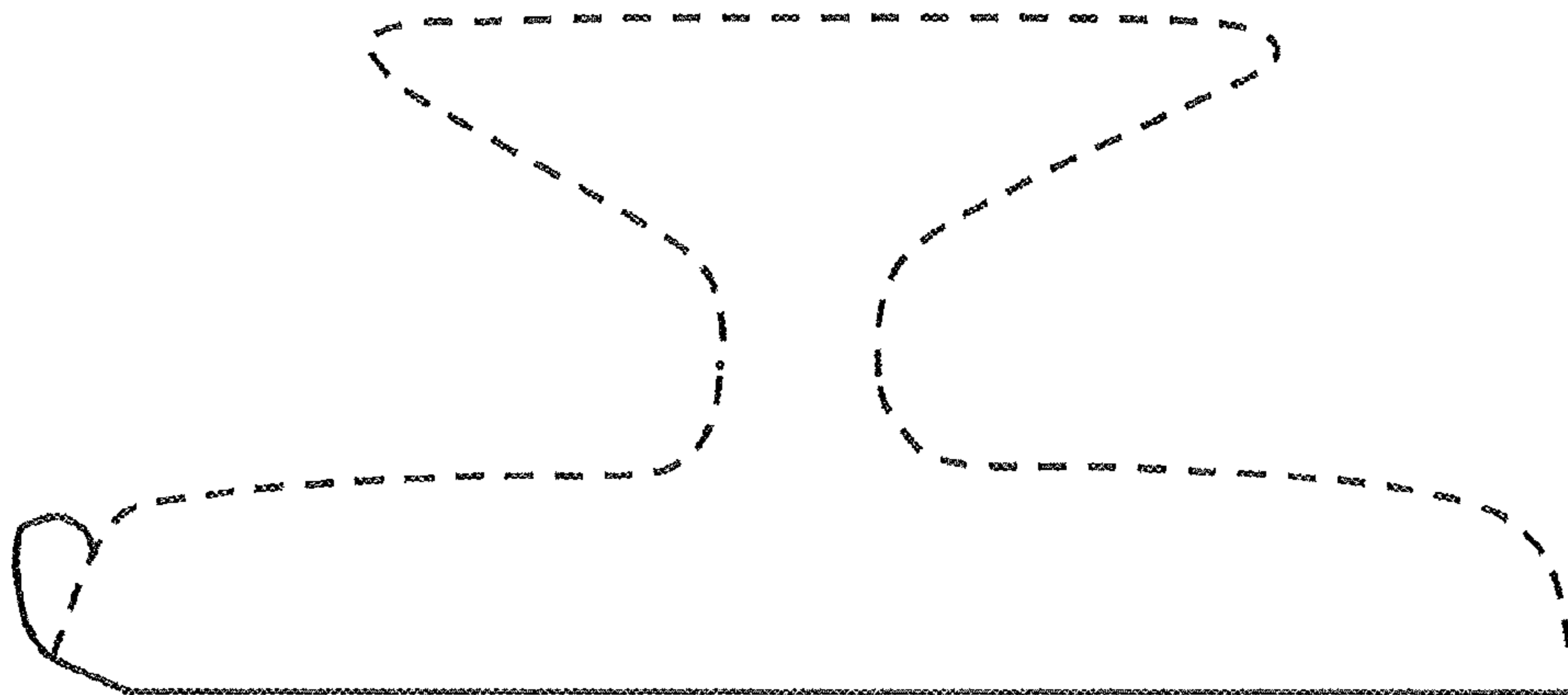
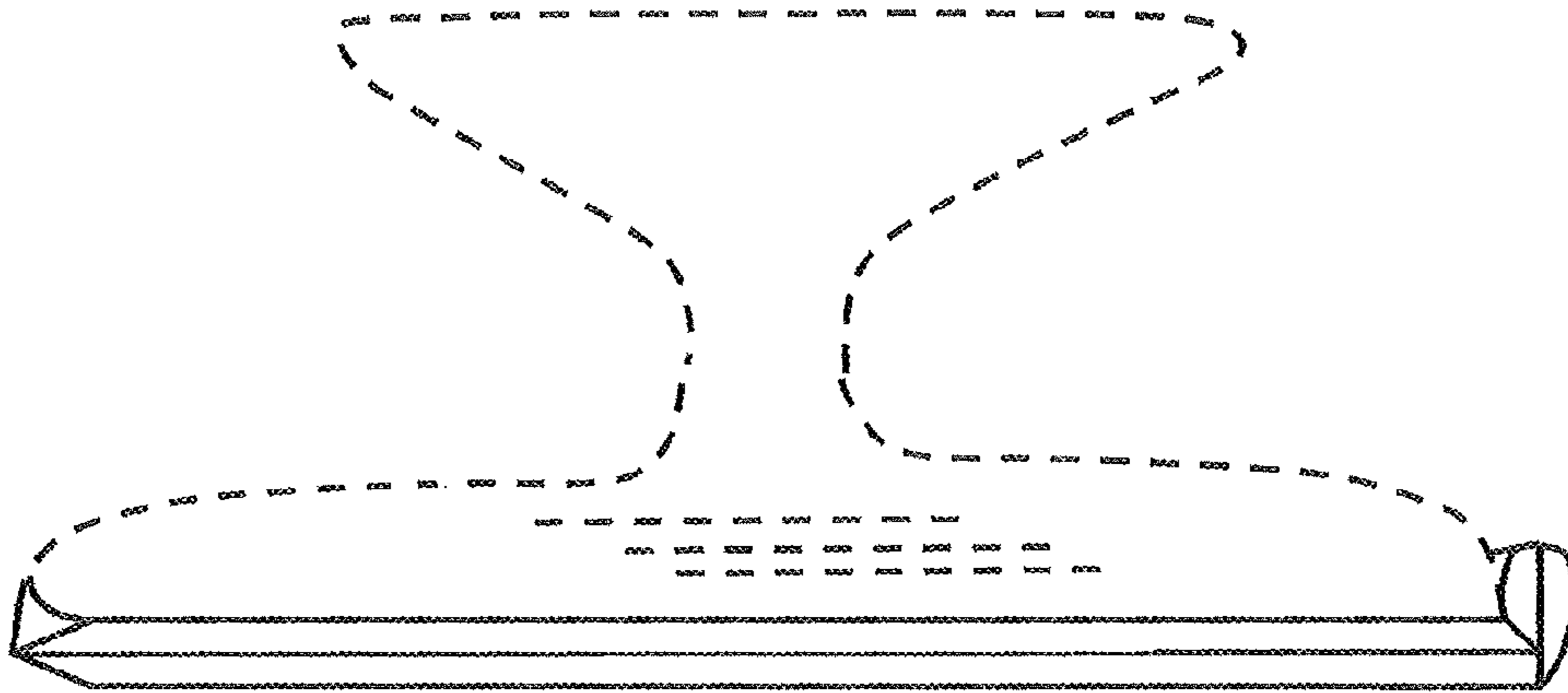
