(57) **CLAIM**

The ornamental design for a curved blade knife with integrated moveable guard, as shown and described.

**DESCRIPTION**

FIG. 1 is an upper perspective view of a curved blade knife with integrated moveable guard in closed position.

FIG. 2 is a lower perspective view of the curved blade knife with integrated moveable guard in closed position.

FIG. 3 is an upper perspective view of the curved blade knife with integrated moveable guard in open position.

FIG. 4 is a lower perspective view of the curved blade knife with integrated moveable guard in open position.

FIG. 5 is a left side view of the curved blade knife with integrated moveable guard in open position.

FIG. 6 is a left side view of the curved blade knife with integrated moveable guard in half open position.

FIG. 7 is a left side view of the curved blade knife with integrated moveable guard in closed position, the right side views of which are not shown as they are mirror images of FIGS. 5, 6 and 7 respectively.

FIG. 8 is a top view of the curved blade knife with integrated moveable guard in closed position.

FIG. 9 is a top view of the curved blade knife with integrated moveable guard in half open position.

FIG. 10 is a top view of the curved blade knife with integrated moveable guard in open position.

FIG. 11 is a bottom view of the curved blade knife with integrated moveable guard in closed position.

FIG. 12 is a bottom view of the curved blade knife with integrated moveable guard in half open position.

FIG. 13 is a bottom view of the curved blade knife with integrated moveable guard in open position.

FIG. 14 is a front view of the curved blade knife with integrated moveable guard in closed position.

FIG. 15 is a front view of the curved blade knife with integrated moveable guard in half open position.

FIG. 16 is a front view of the curved blade knife with integrated moveable guard in open position.

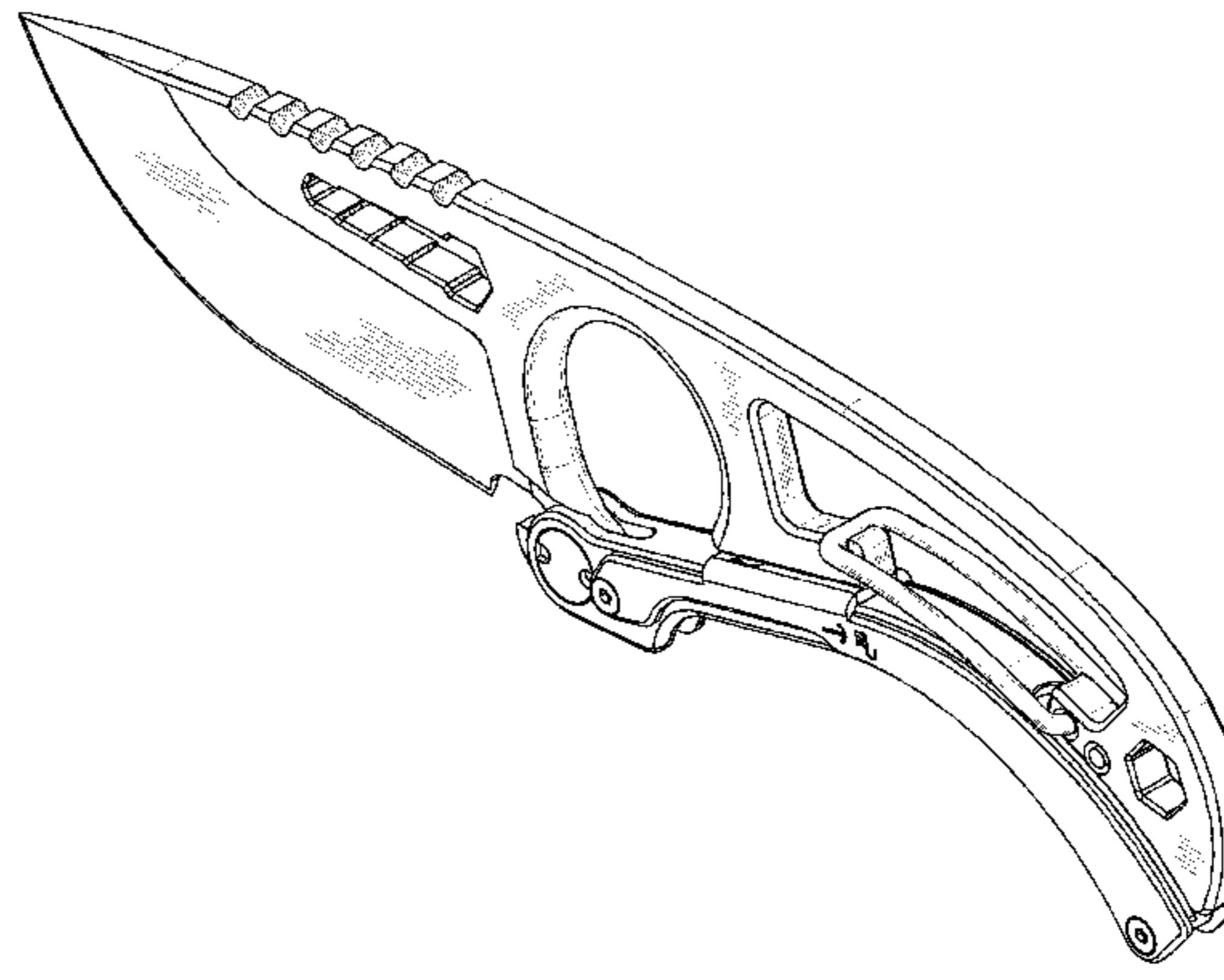
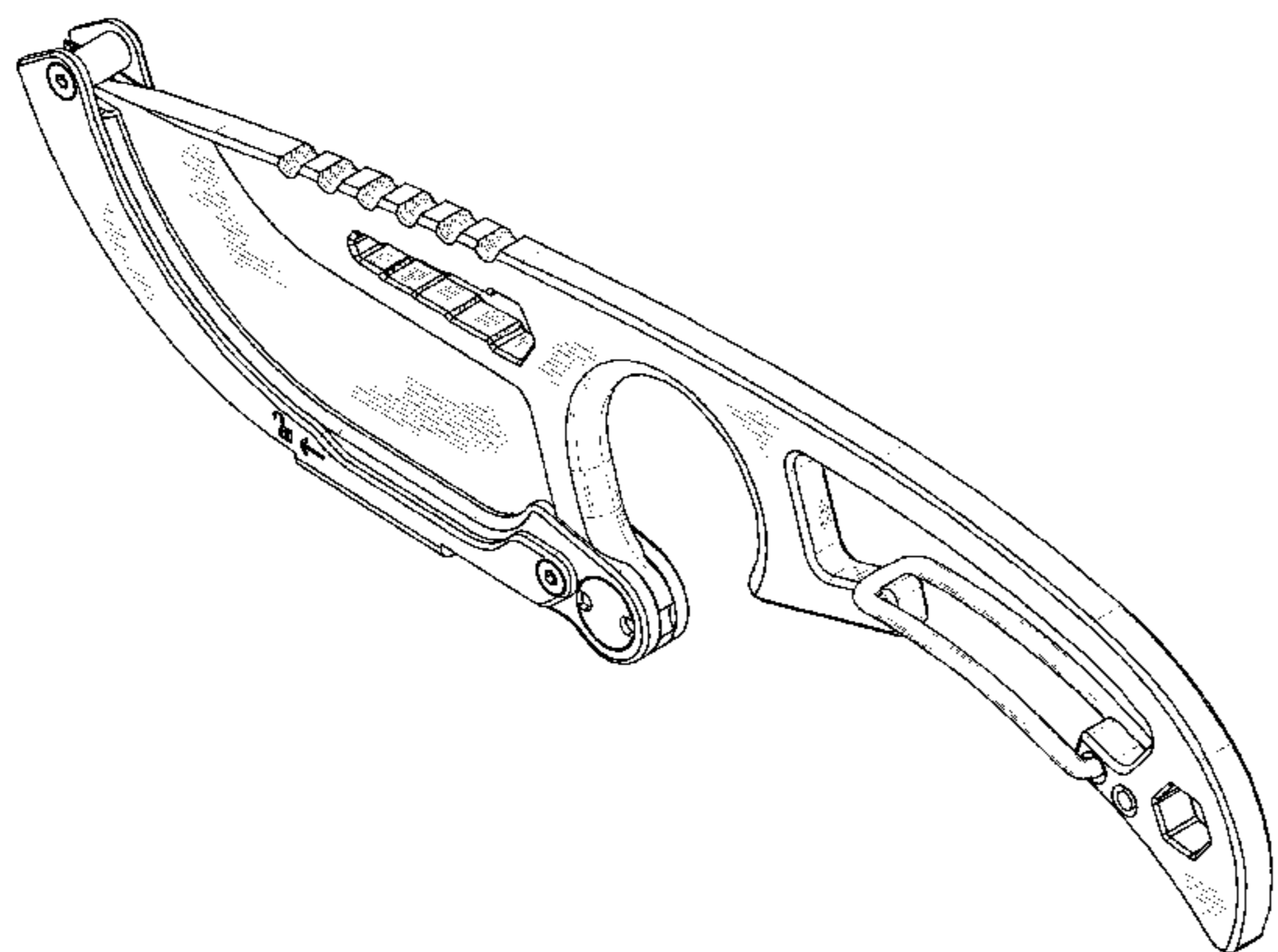
FIG. 17 is a rear view of the curved blade knife with integrated moveable guard in closed position.

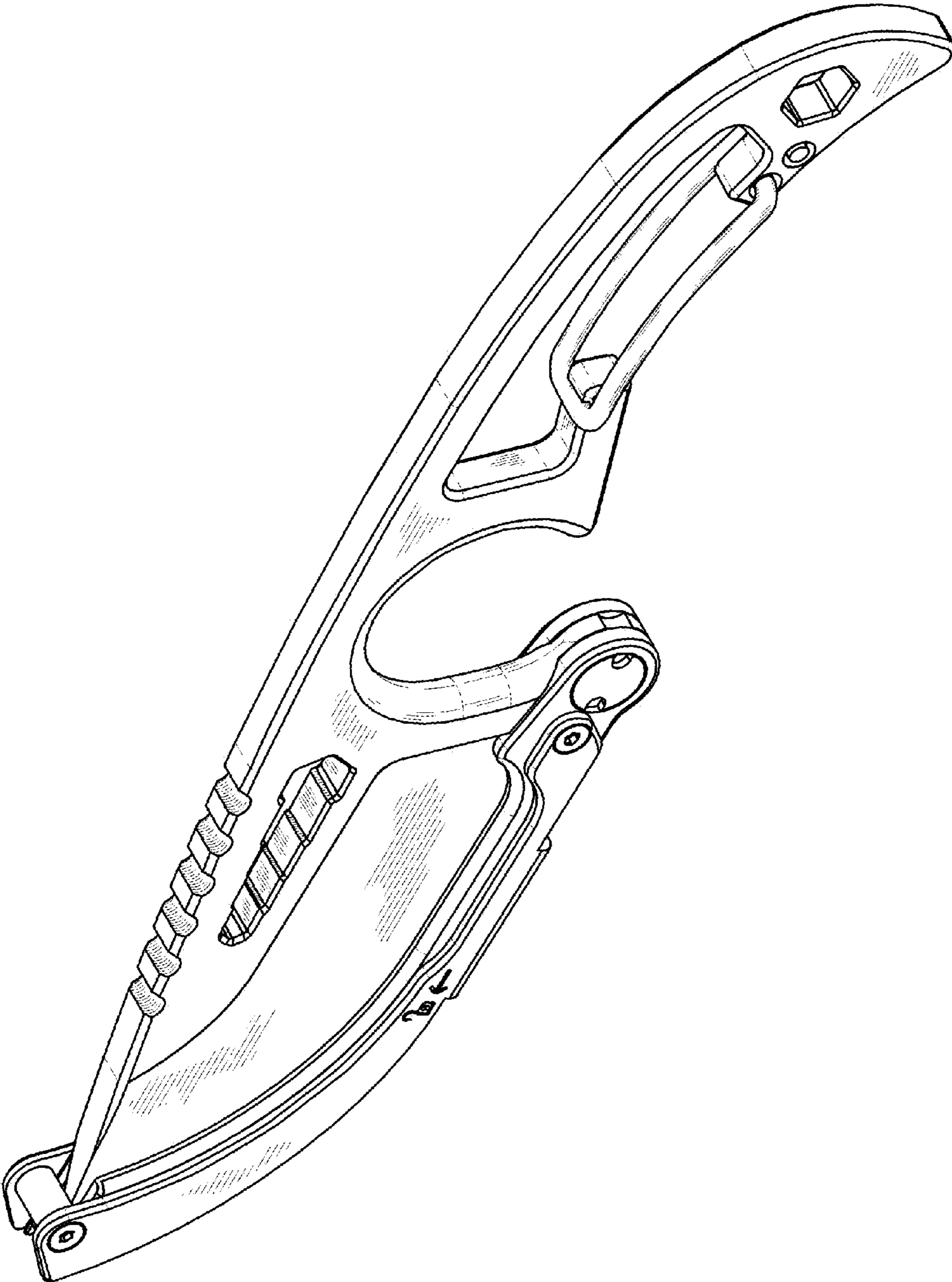

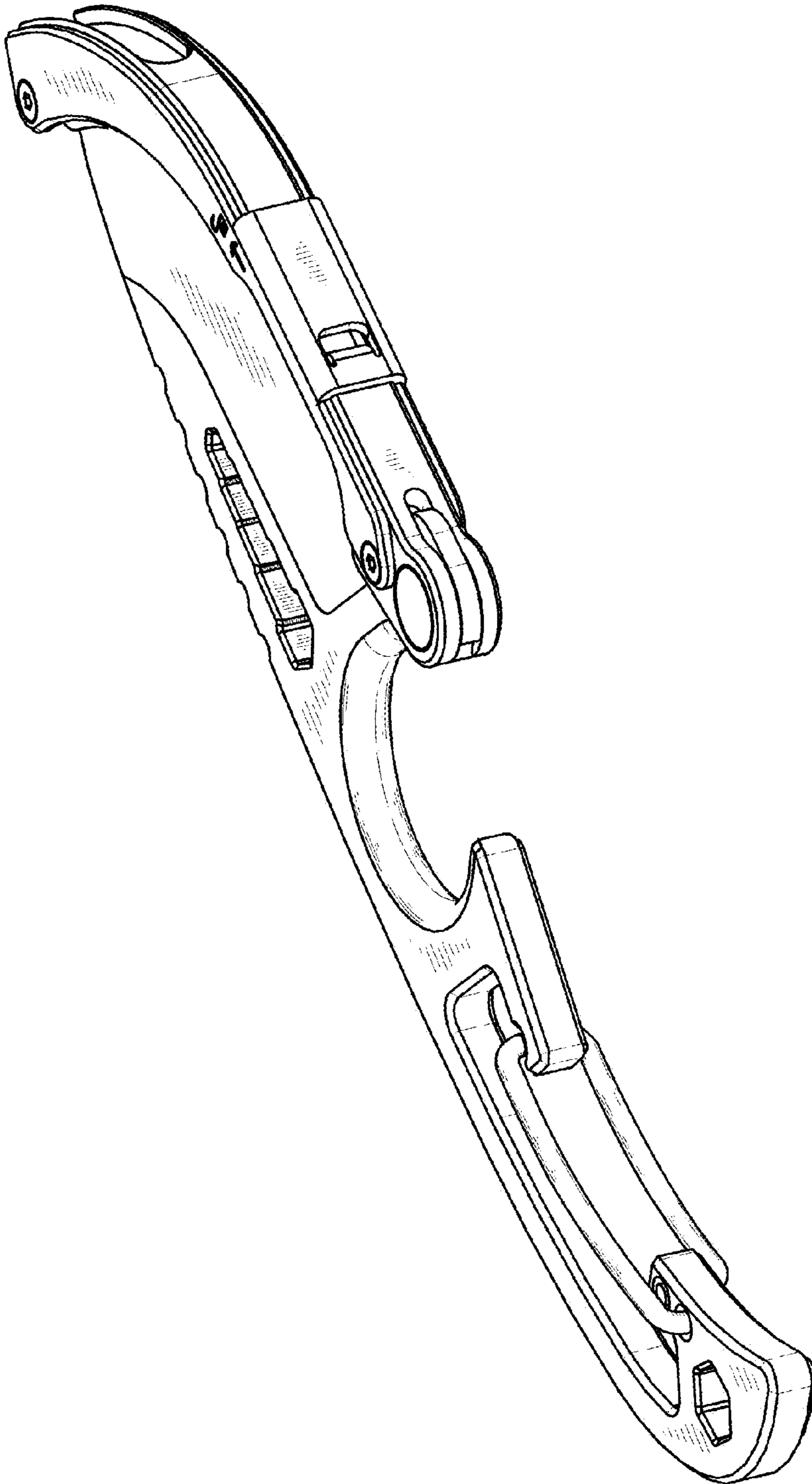

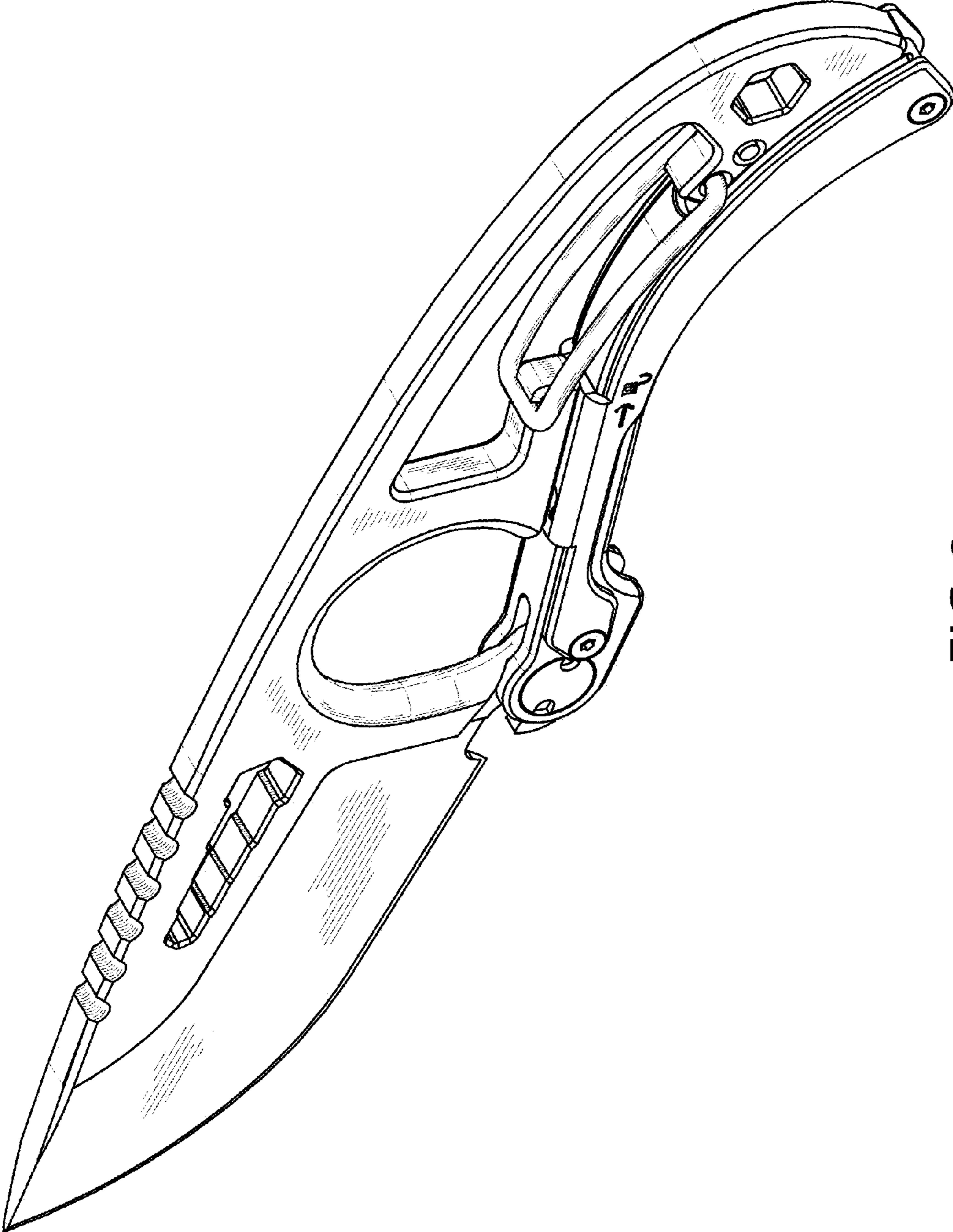

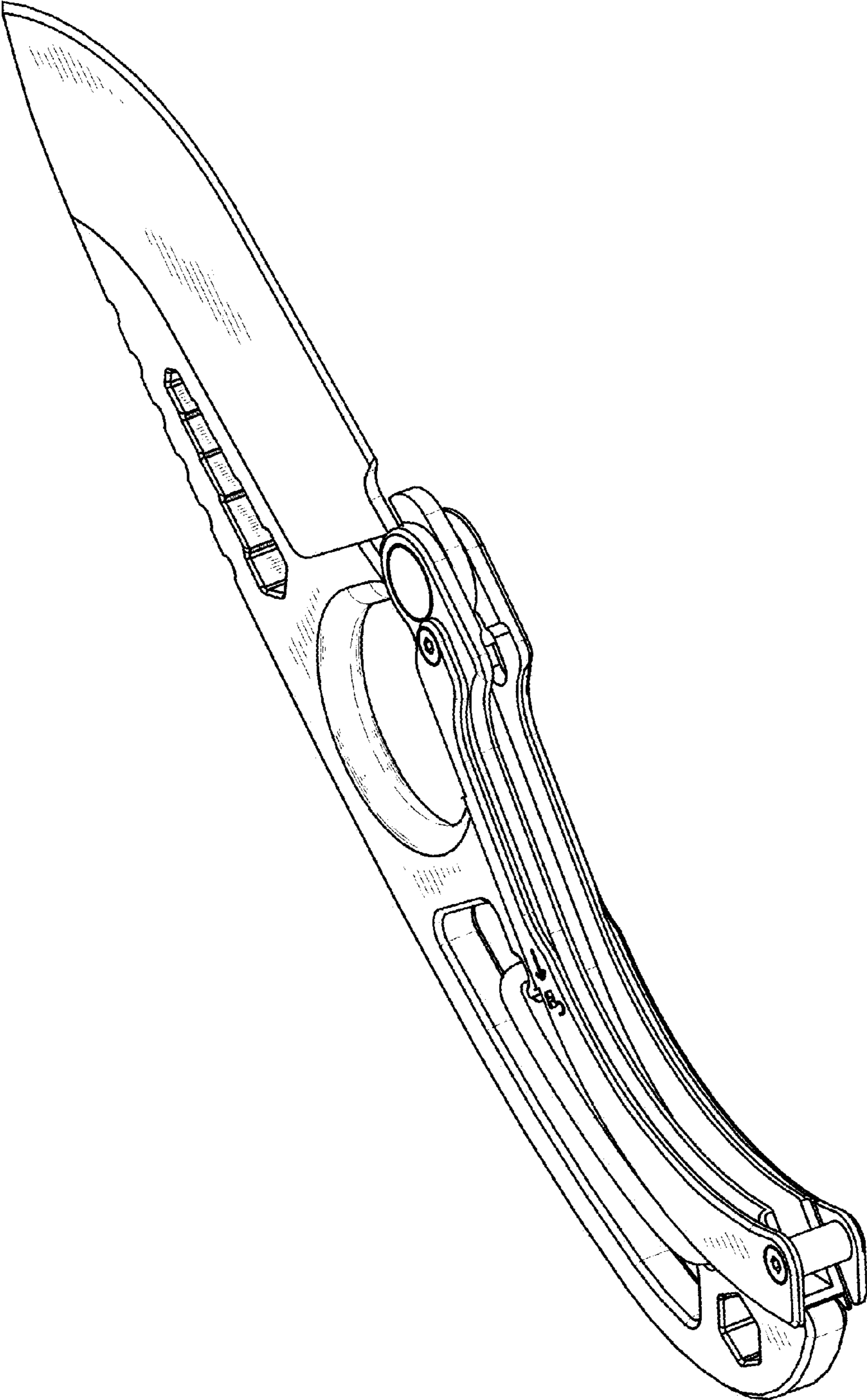

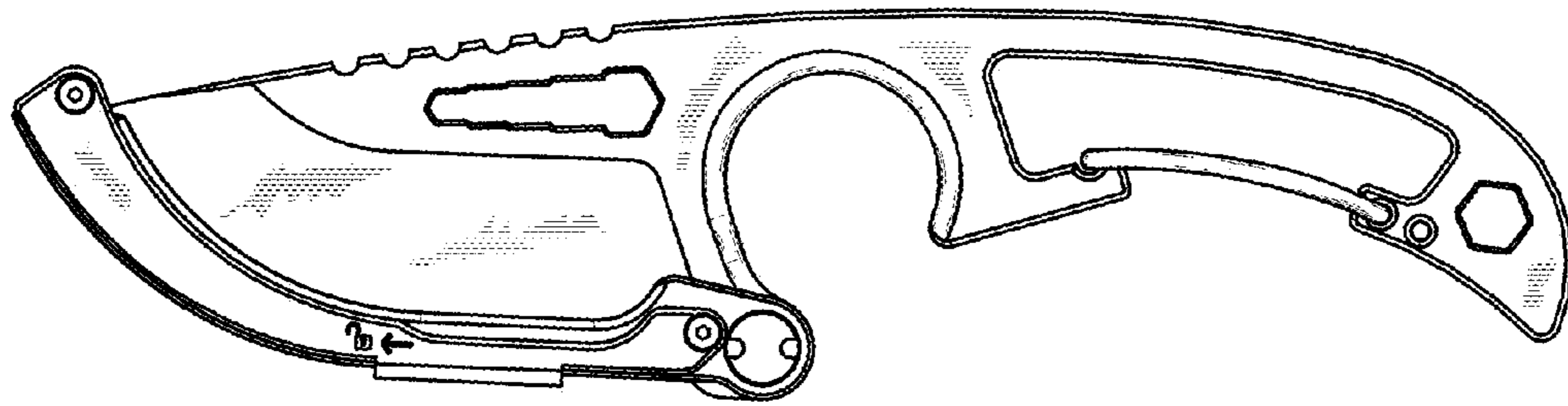

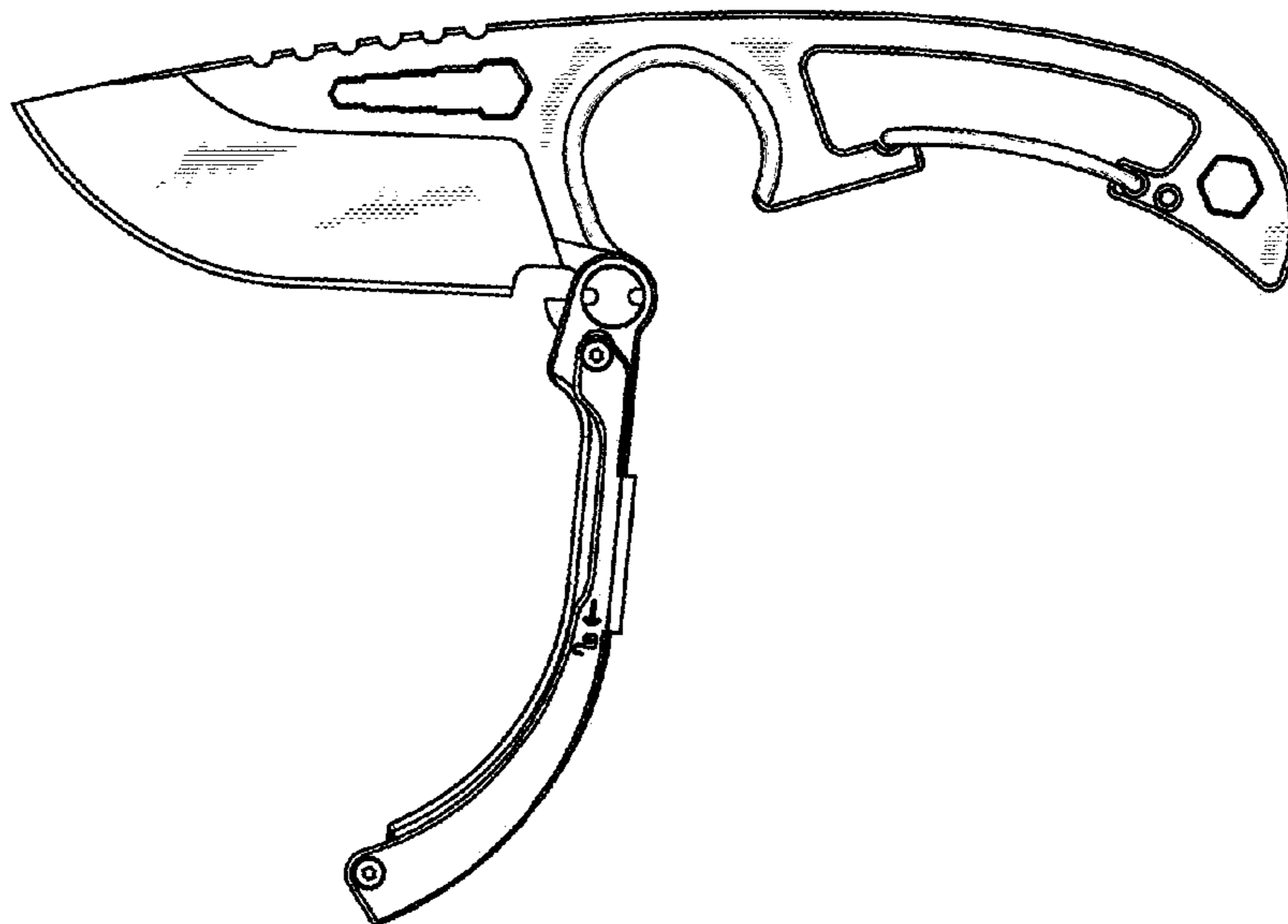

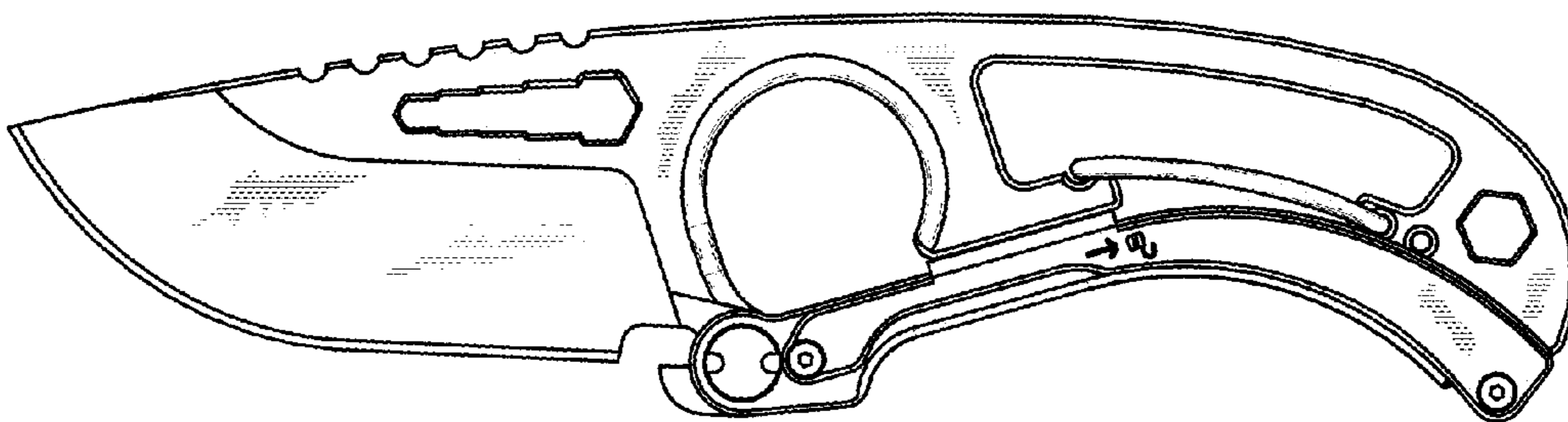

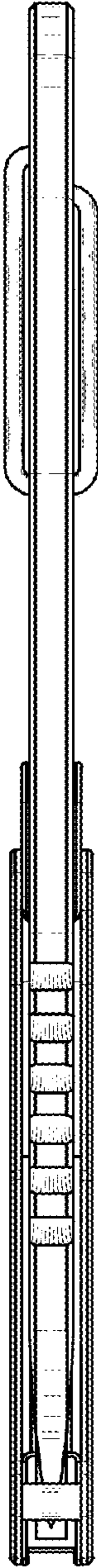

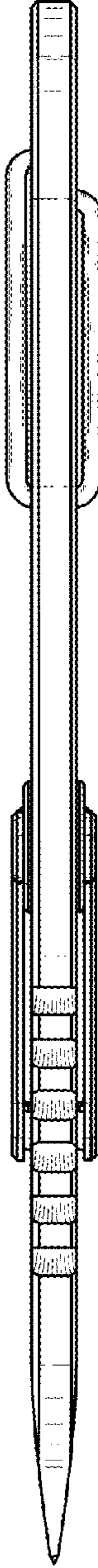

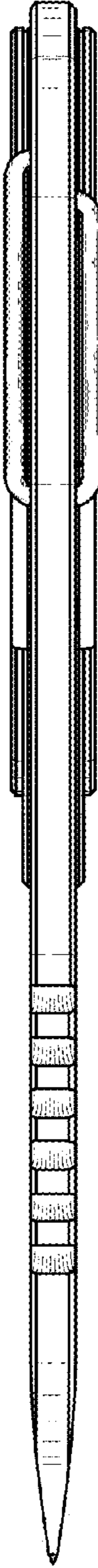

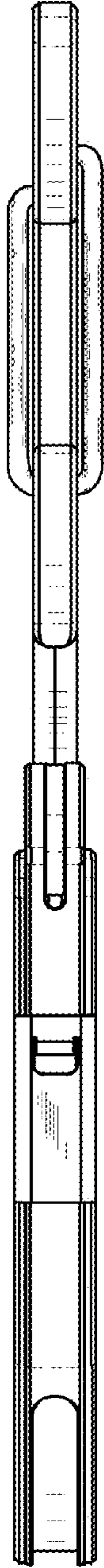

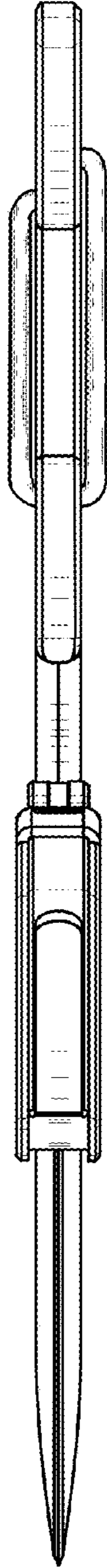

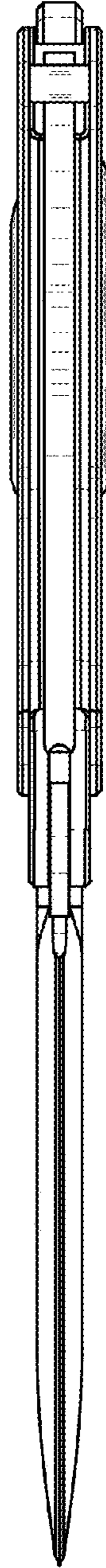

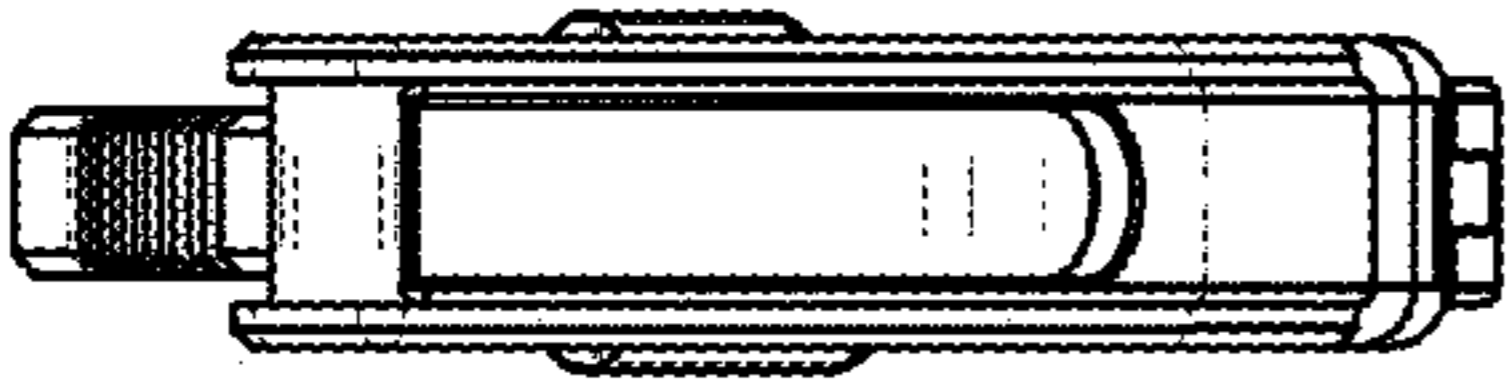

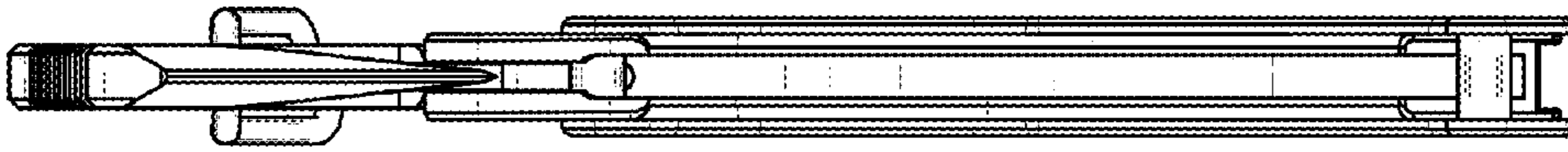

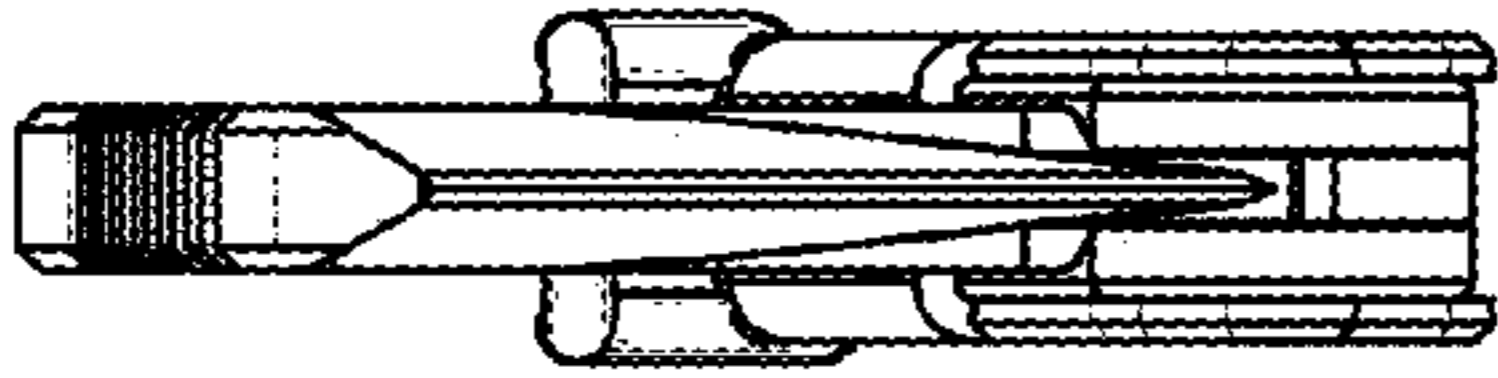

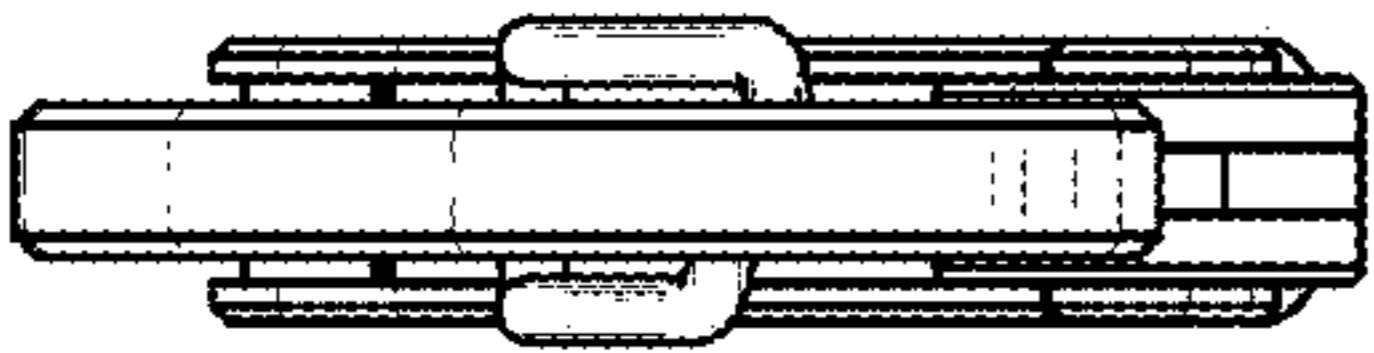

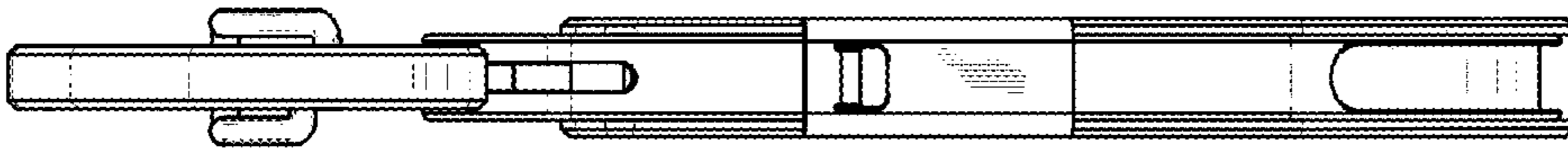

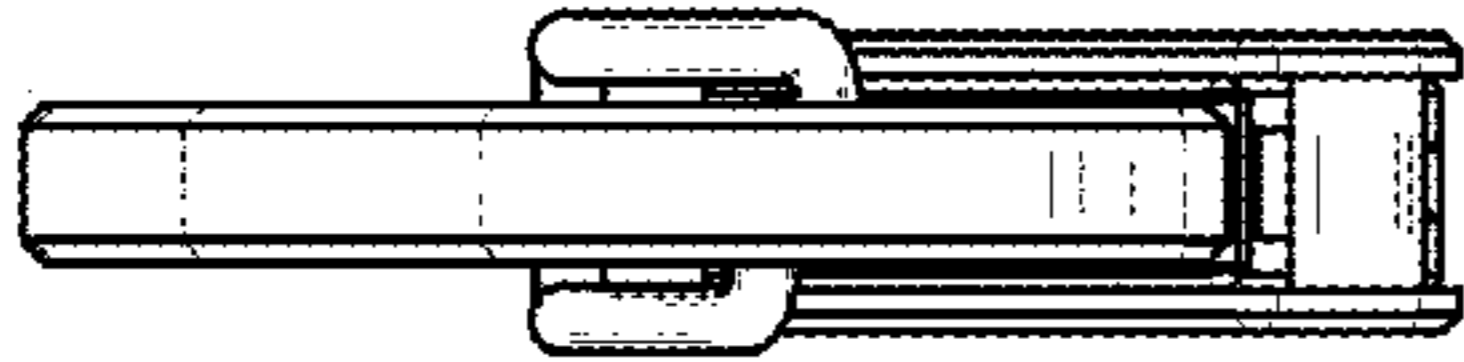
