(57) **CLAIM**

The ornamental design for a strap hook, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing a strap hook showing my new design;

FIG. 2 is a perspective view of the strap portion of the strap hook of FIG. 1 with the hook removed for clarity of illustration;

FIG. 3 is a top view thereof, (the bottom view being a mirror image);

FIG. 4 is a sectional view thereof taken along line 4-4 of FIG. 3;

FIG. 5 is a sectional view thereof taken along line 5-5 of FIG. 3;

FIG. 6 is a front view thereof, (the rear view being a mirror image);

FIG. 7 is a perspective view of the hook portion of the strap hook of FIG. 1 with the strap removed for clarity of illustration;

FIG. 8 is a front view thereof, (the rear view being a mirror image);

FIG. 9 is a right side view thereof;

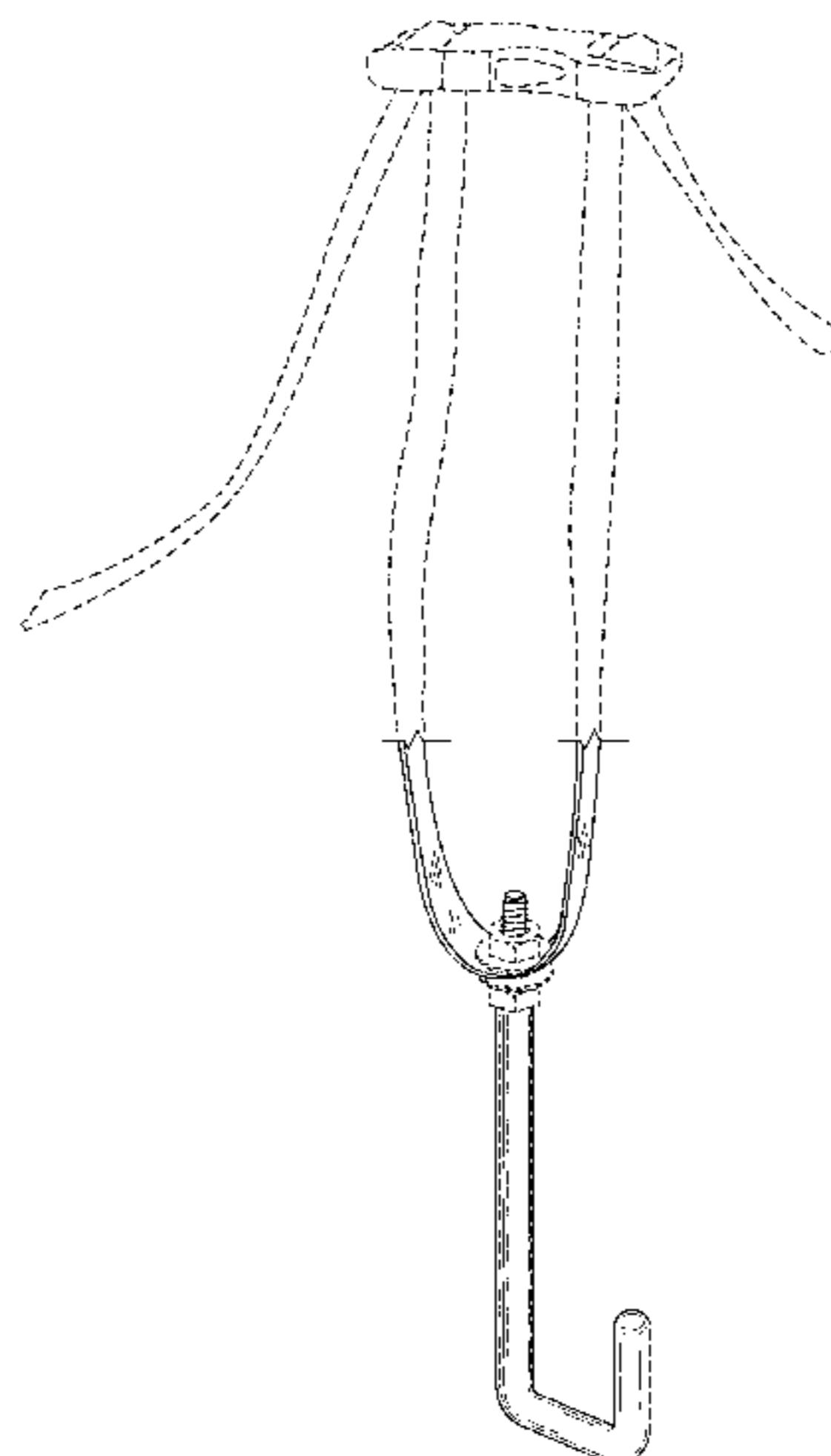
FIG. 10 is a left side view thereof;

FIG. 11 is a top view thereof; and,

FIG. 12 is a bottom view thereof.

The strap portion of the strap hook is shown with a symbolic break in its length. The appearance of any portion of the article beyond the break lines forms no part of the claimed design. The broken line portion of the figure drawings is included to show unclaimed subject matter only and forms no part of the claimed design.

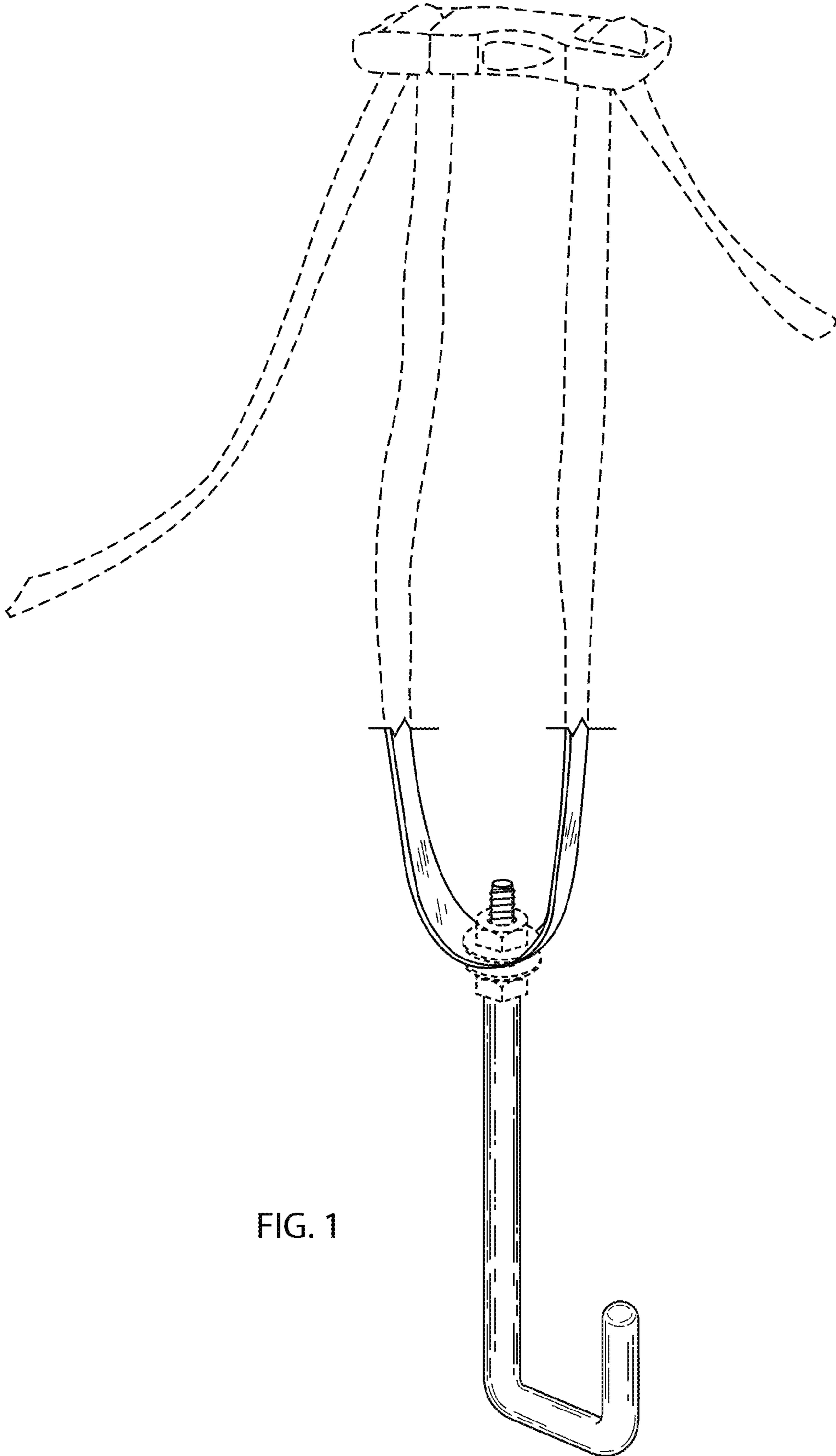

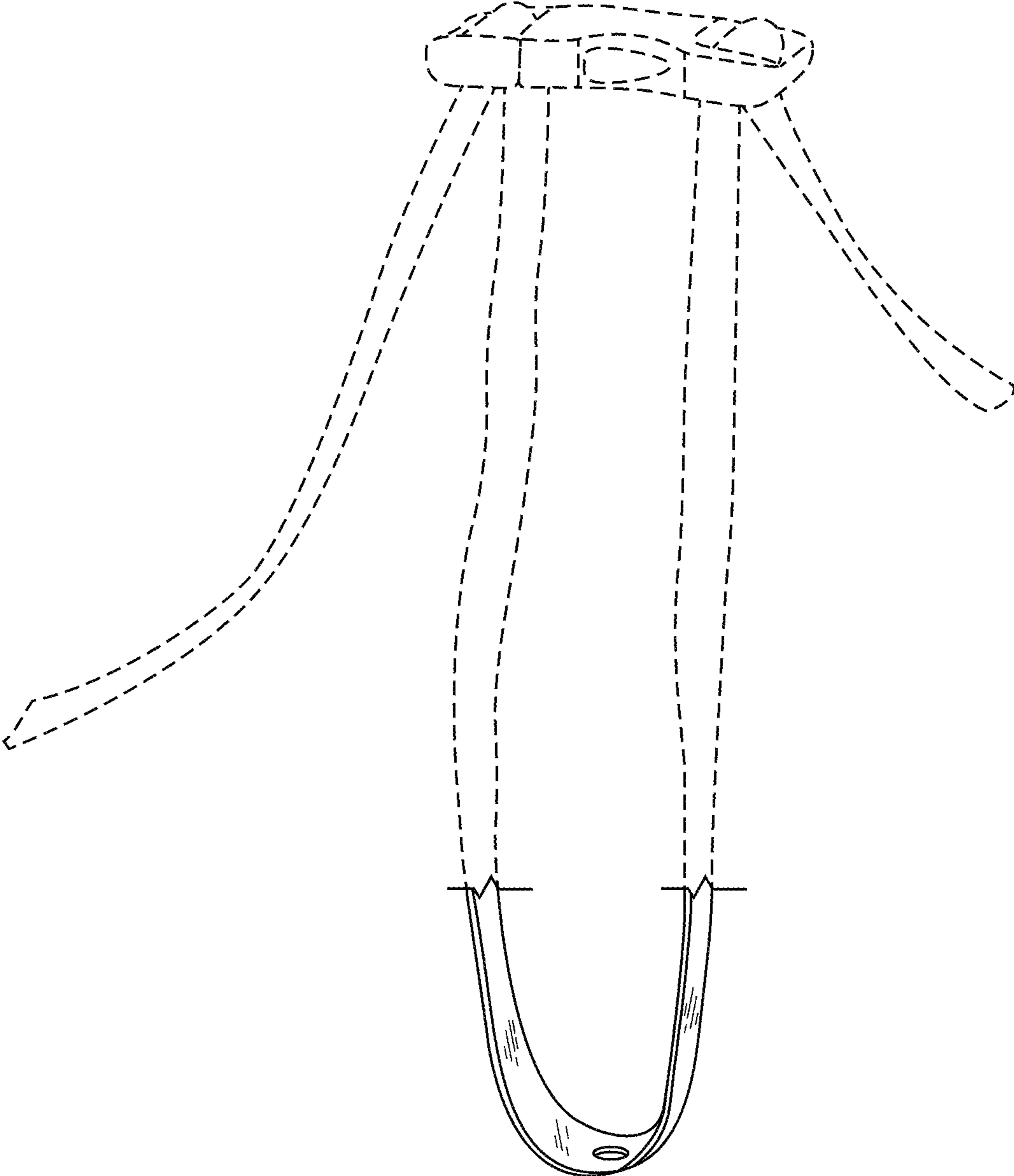

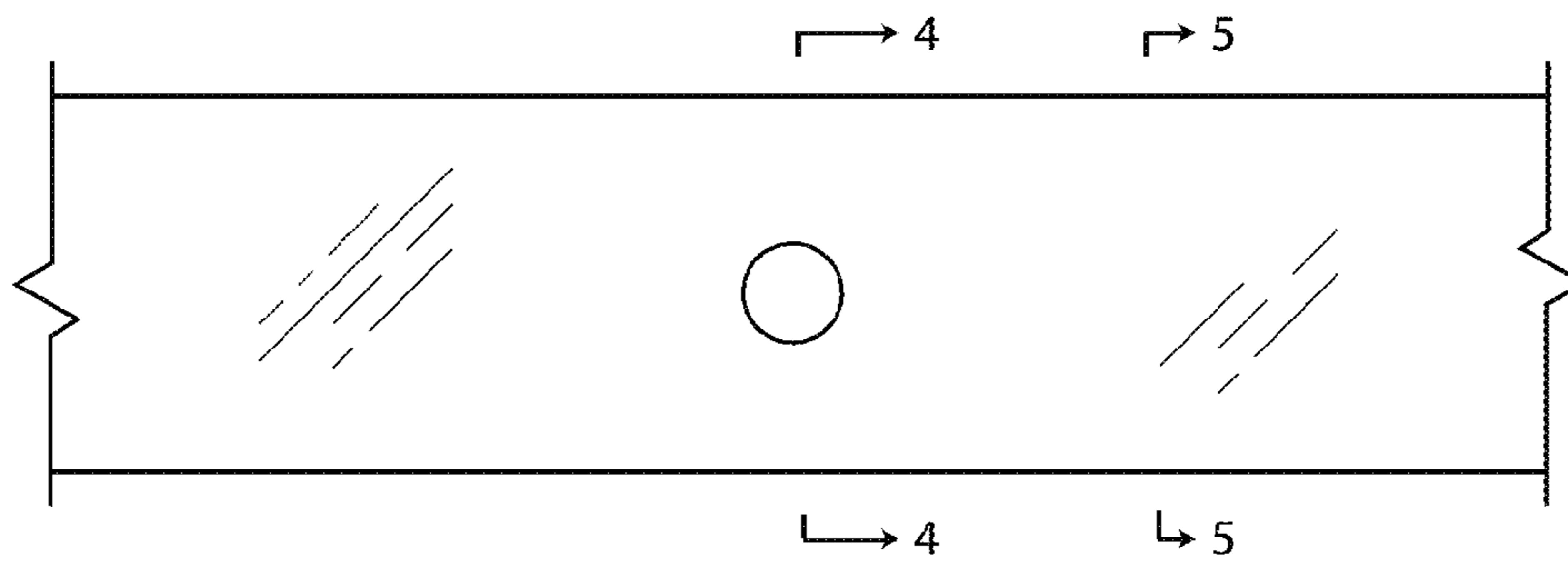

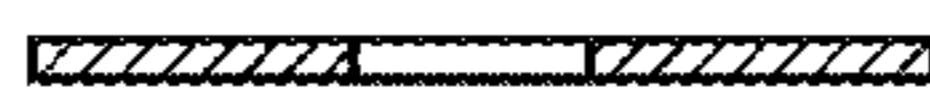

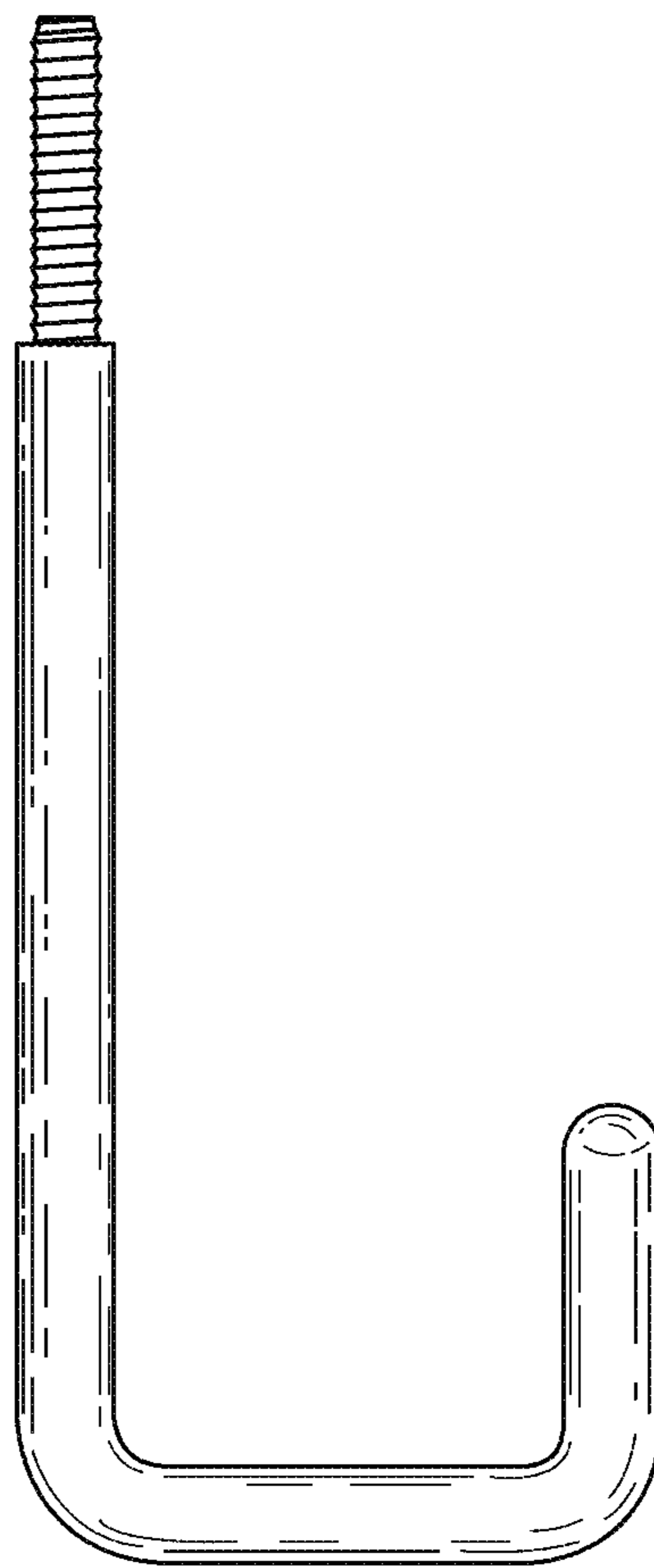

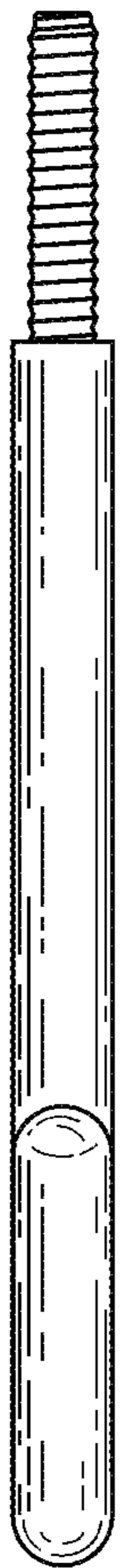

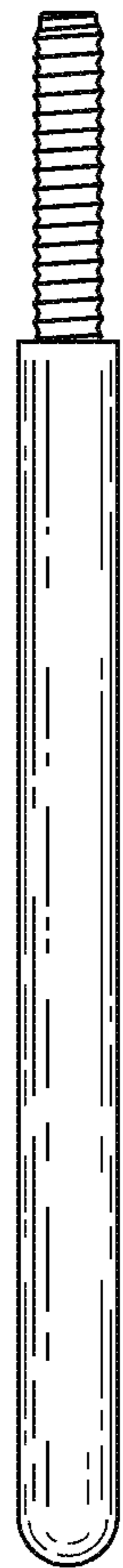
