**DESCRIPTION**

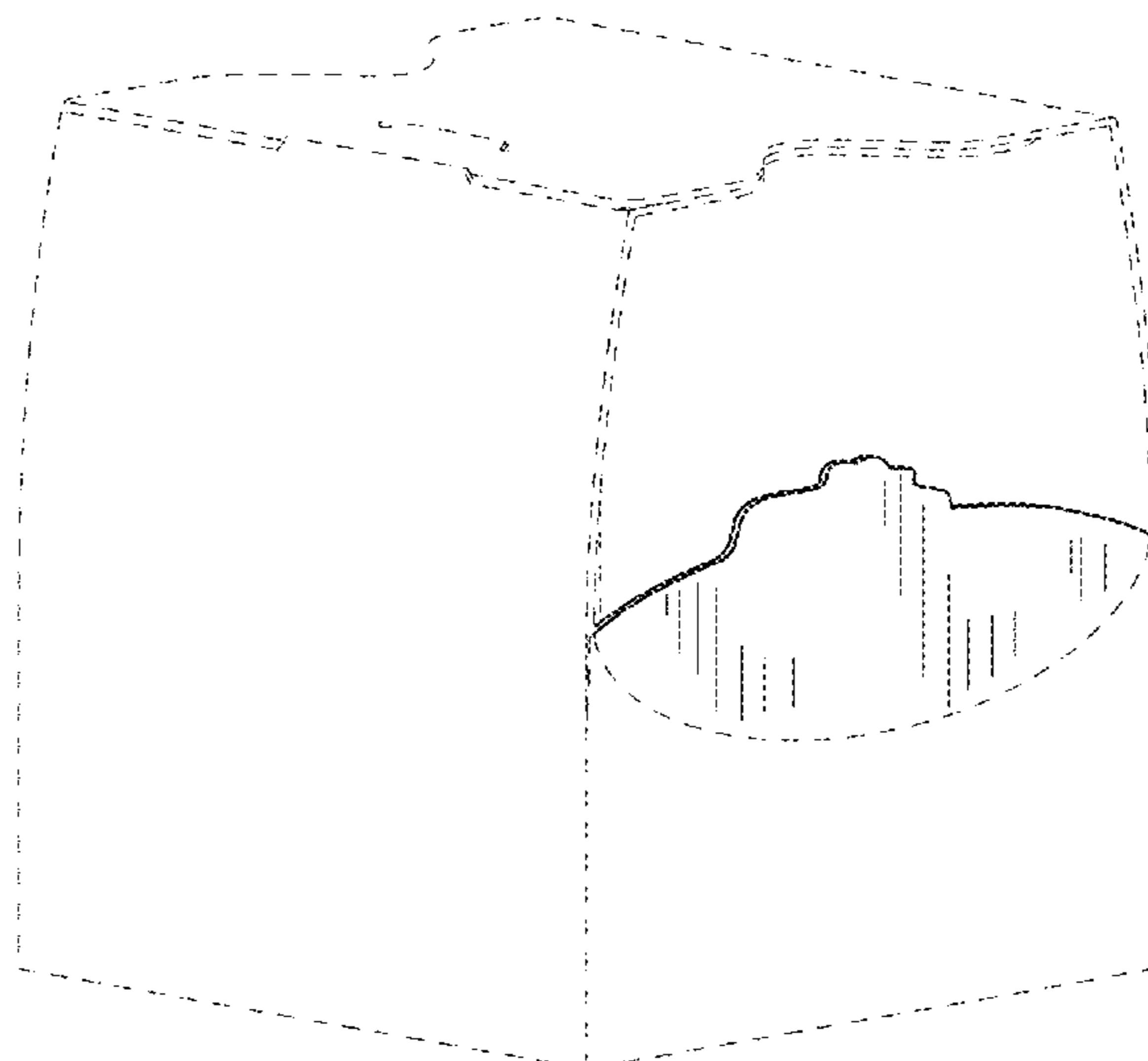
FIG. 1 is a top perspective view of the carton, showing my new design;

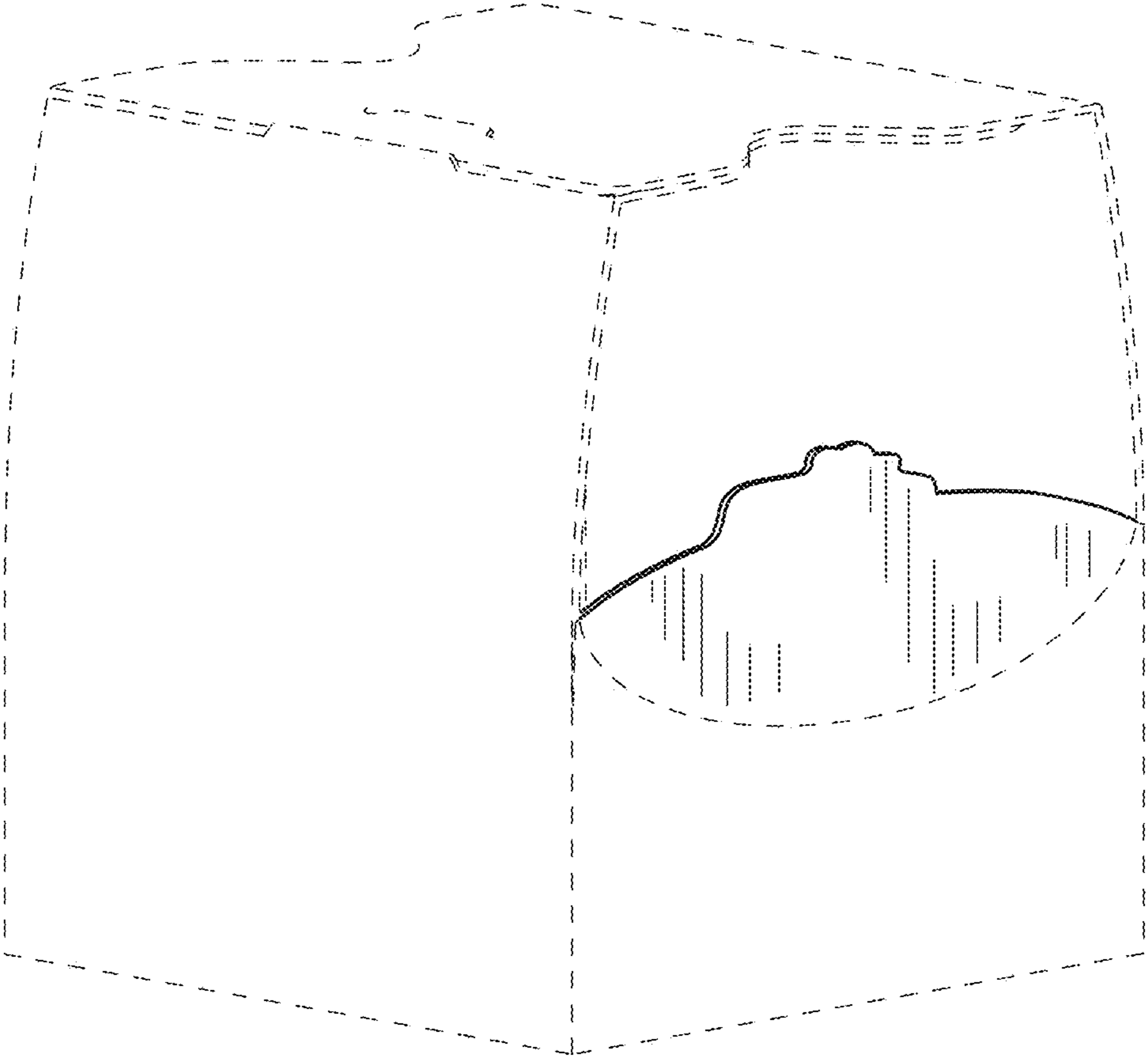

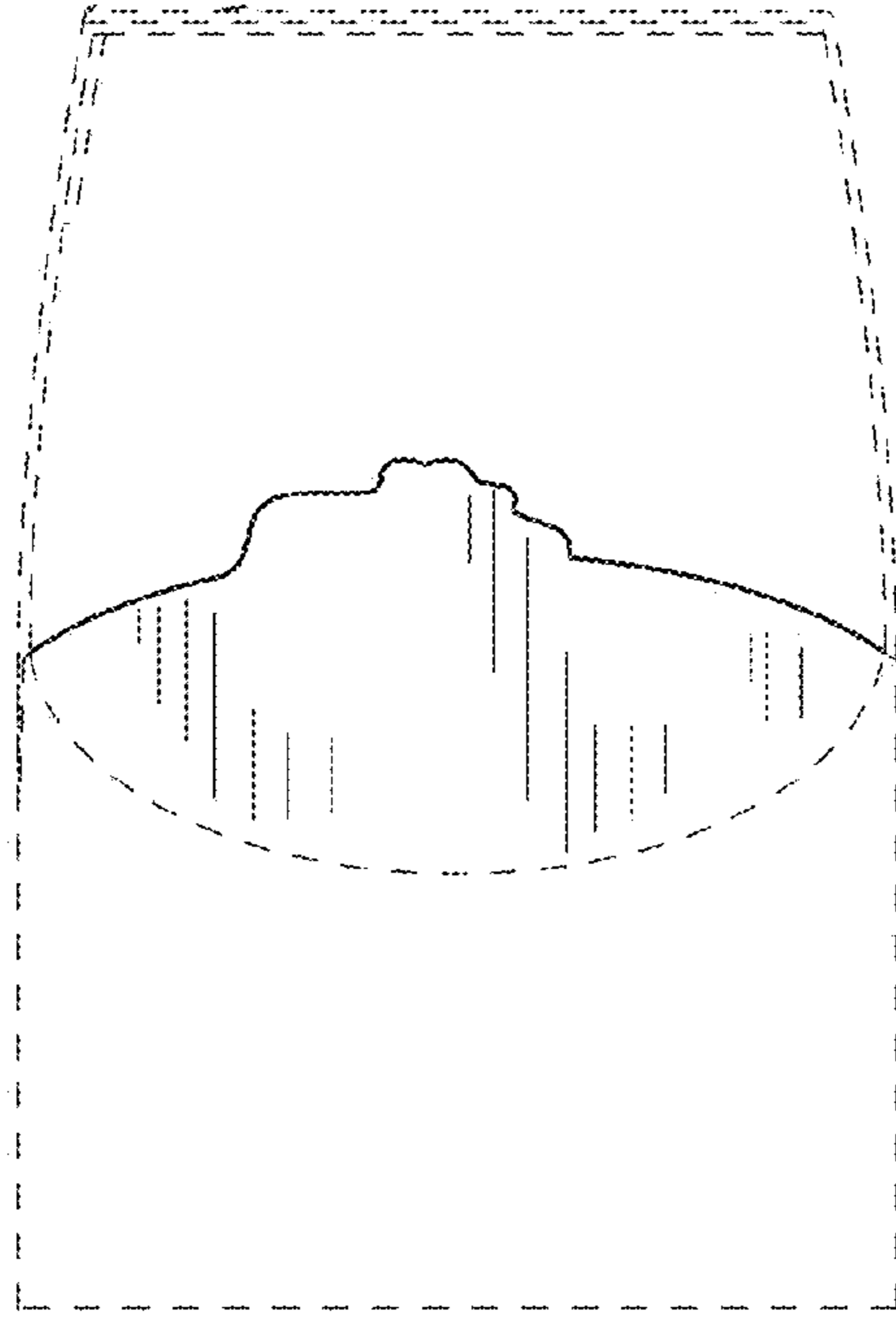

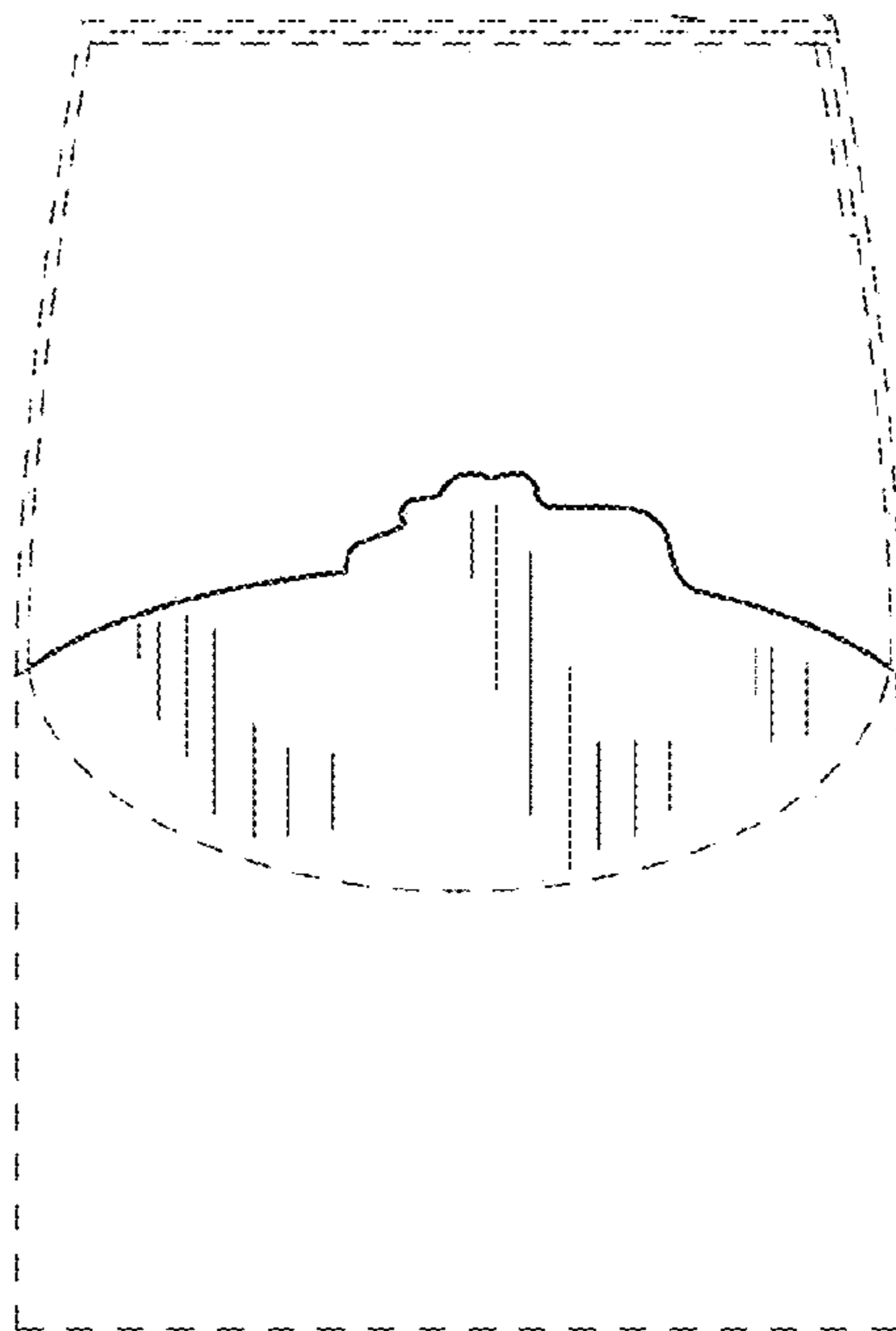

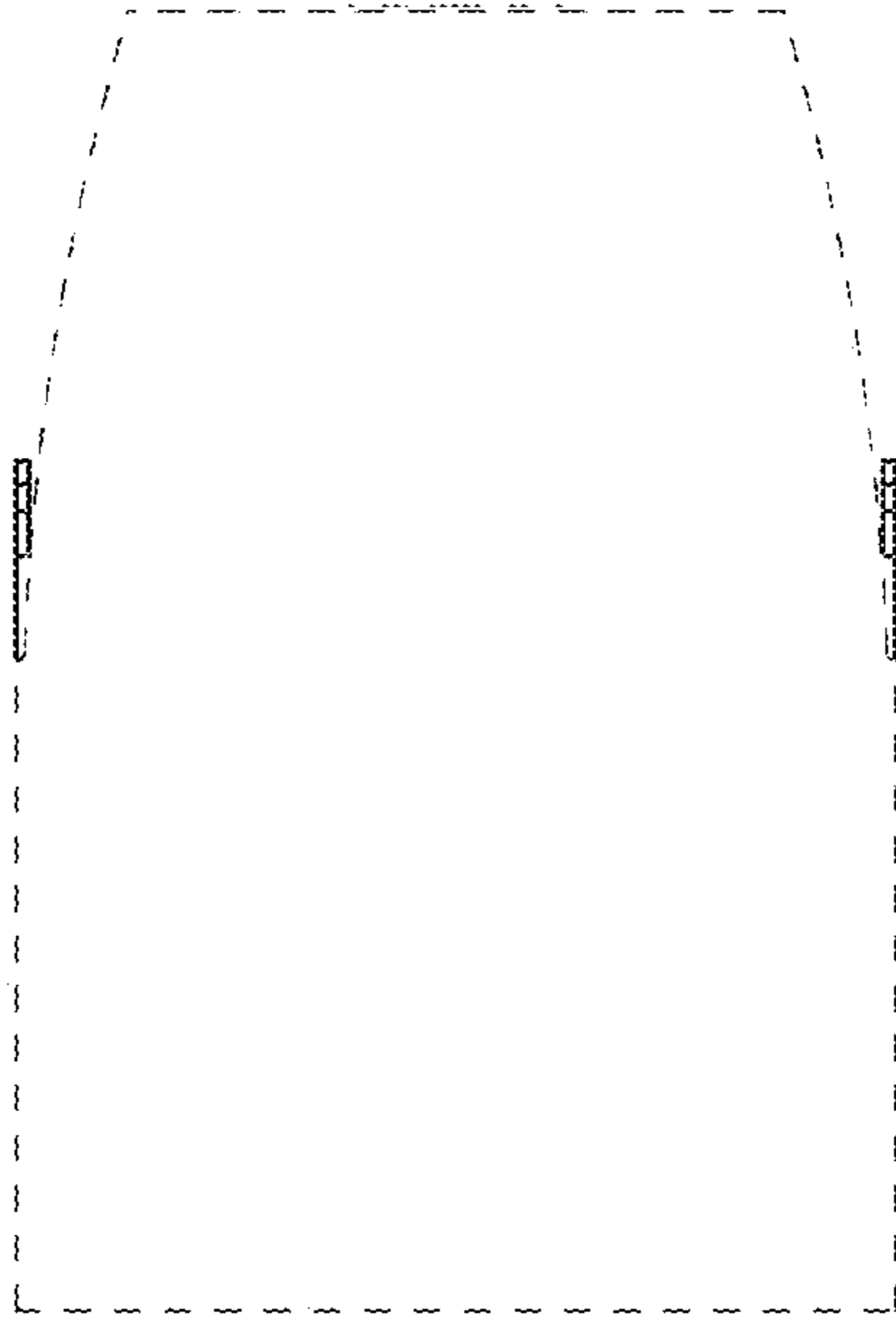

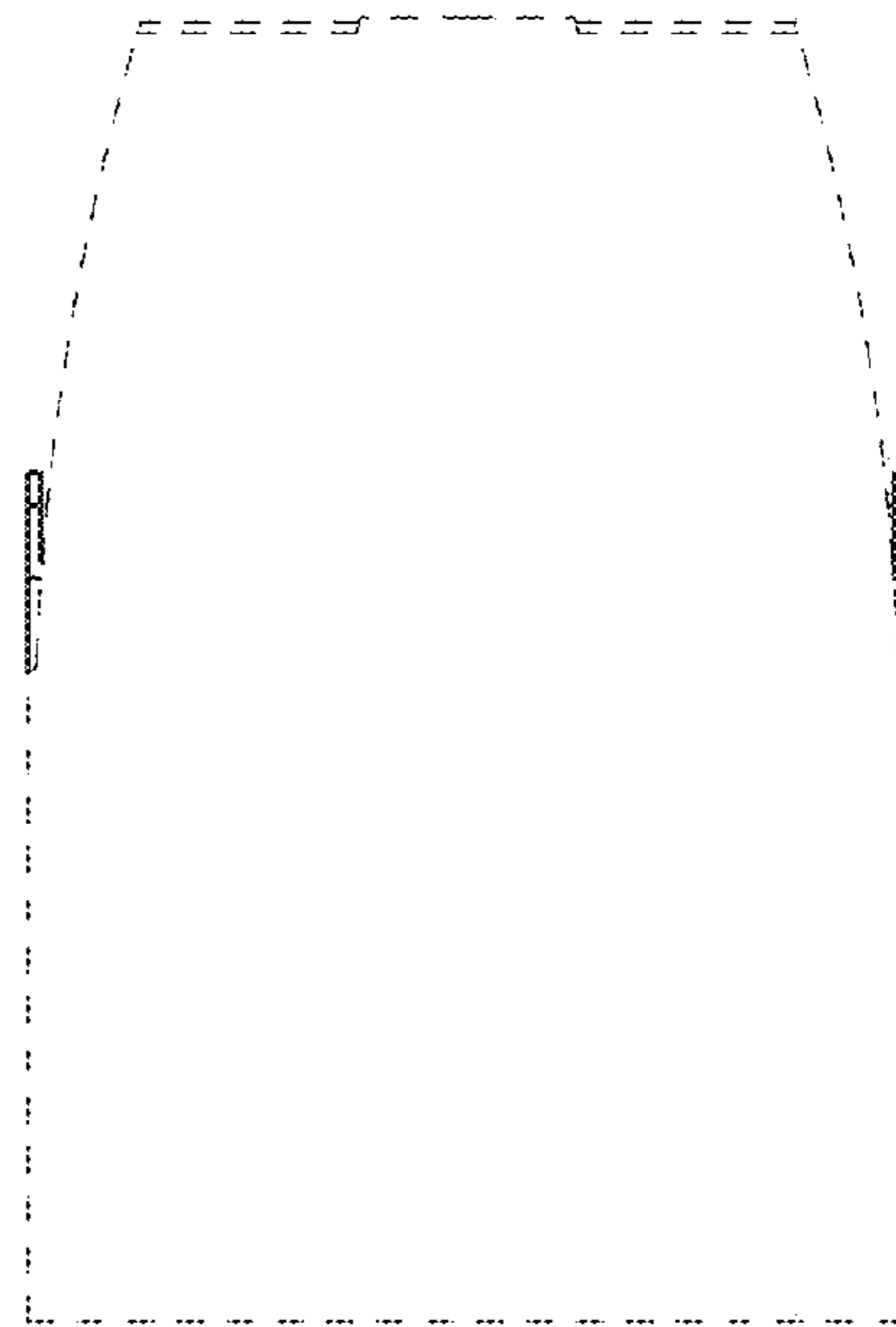

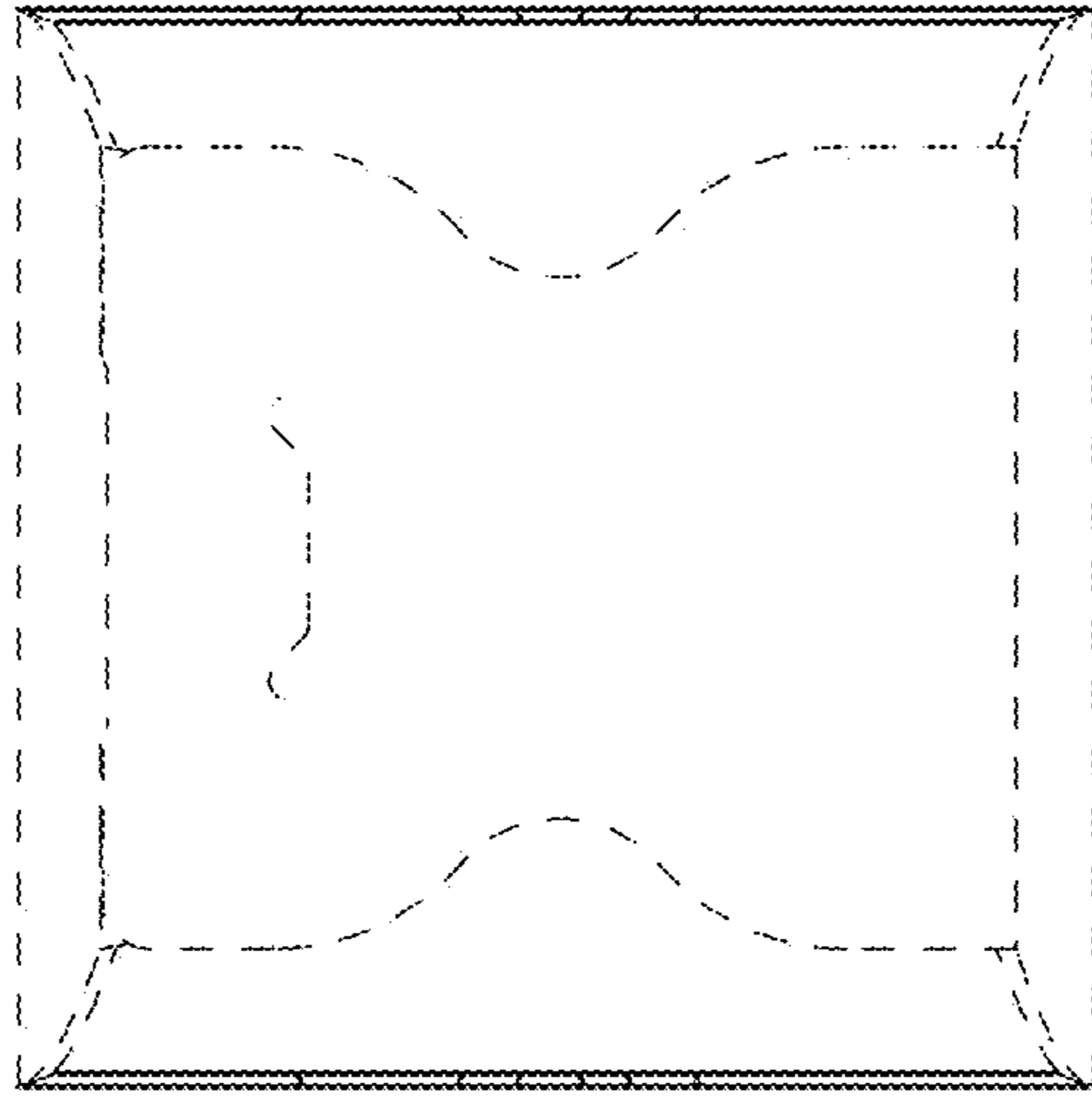

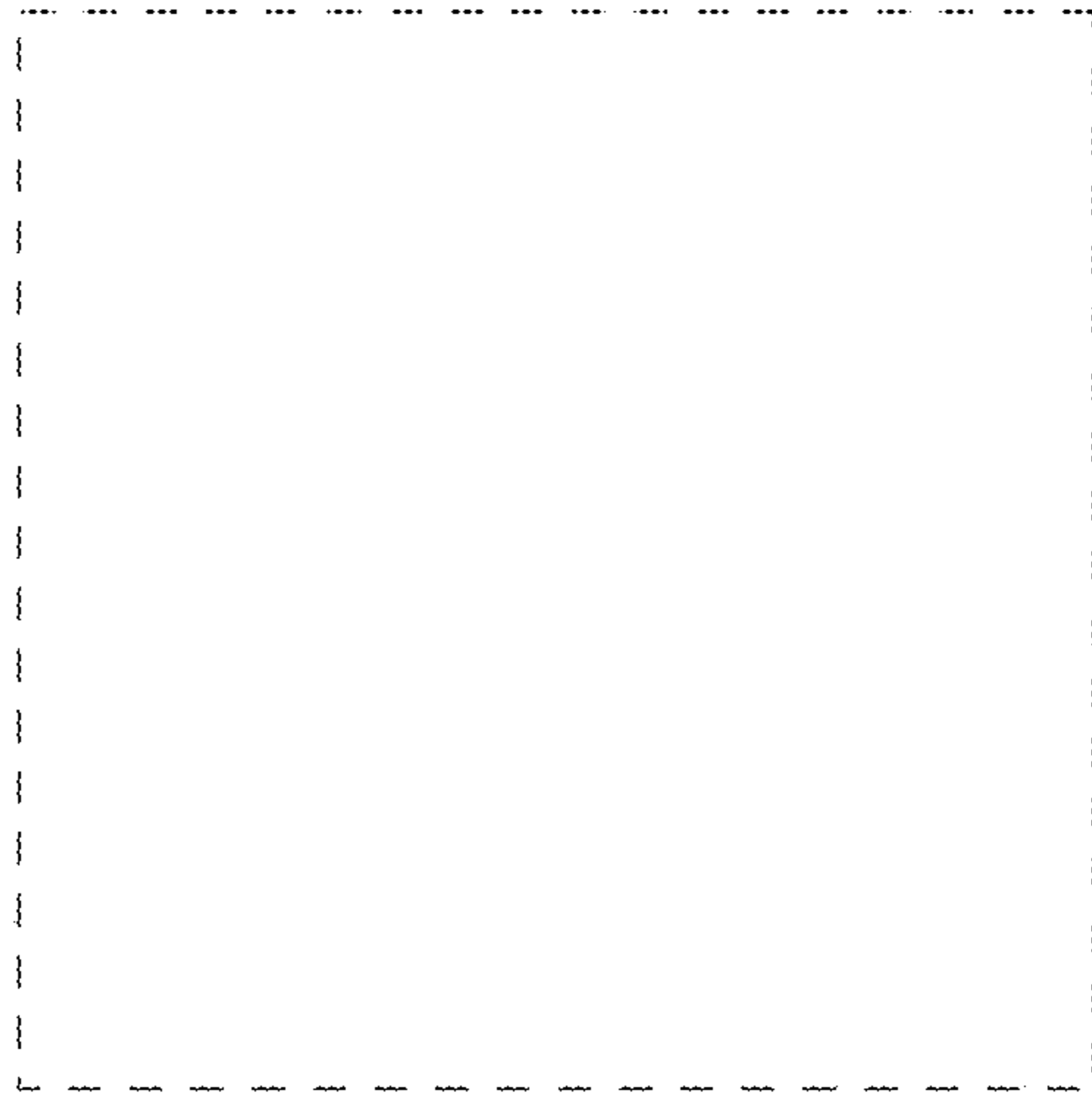
