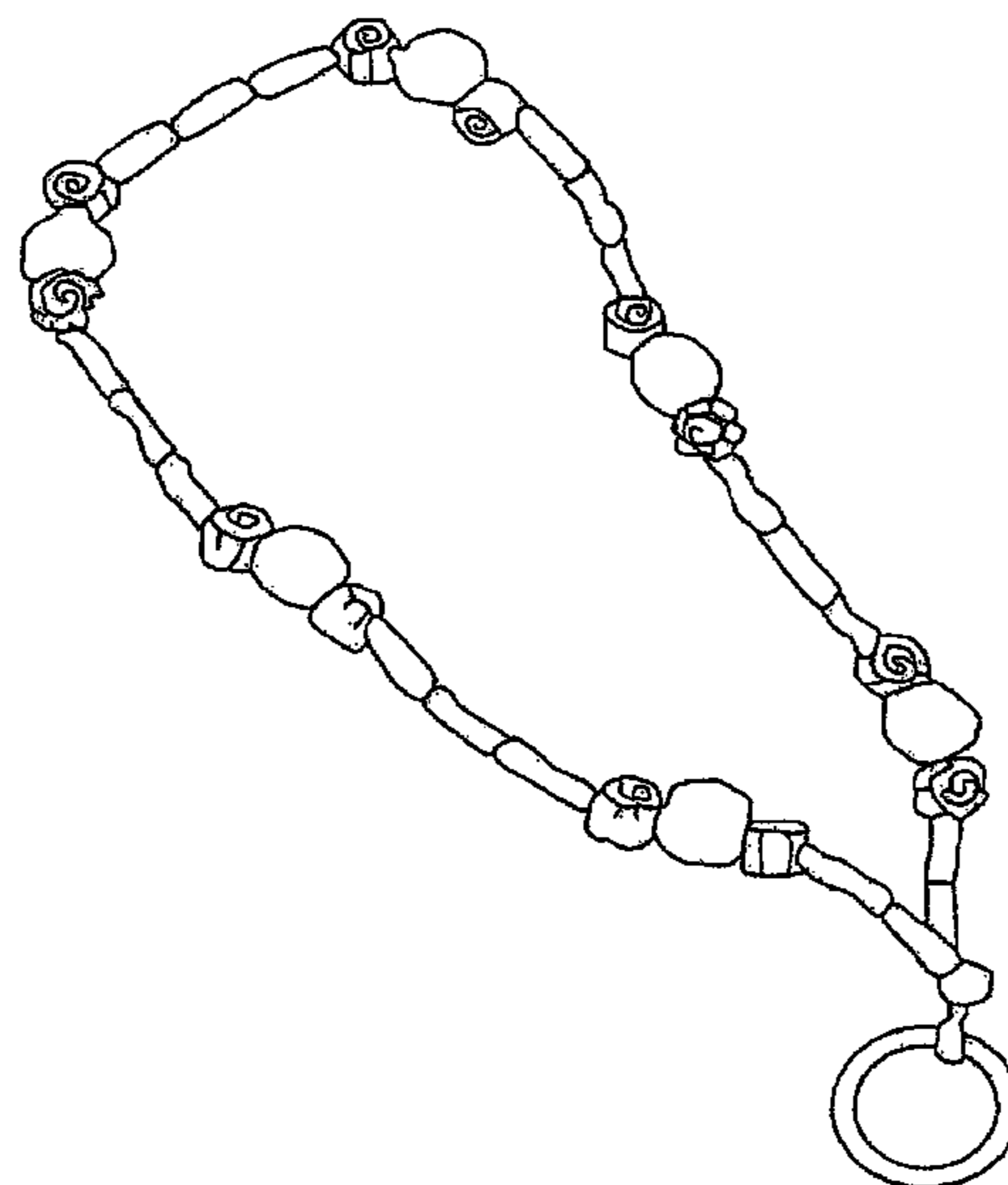

(57) **CLAIM**
The ornamental design for article of foot jewelry, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the ankle portion of an article of foot jewelry showing my new design; the ankle portion is shown separately for clarity.
FIG. 2 is a perspective view of the toe portion of an article of foot jewelry showing my new design; the toe portion is shown separately for clarity.
FIG. 3 is a perspective view of an article of foot jewelry showing my new design; the ankle portion and toe portion are shown together.
FIG. 4 is a front elevational view of the article of foot jewelry.
FIG. 5 is a rear elevational view of the article of foot jewelry.
FIG. 6 is a right side elevational view of the article of foot jewelry.
FIG. 7 is a left side elevational view of the article of foot jewelry.
FIG. 8 is a top plan view of the article of foot jewelry; and, FIG. 9 is a bottom plan view of the article of foot jewelry.
The broken line portions in FIG. 3 illustrate environmental subject matter only and form no part of the claimed design.

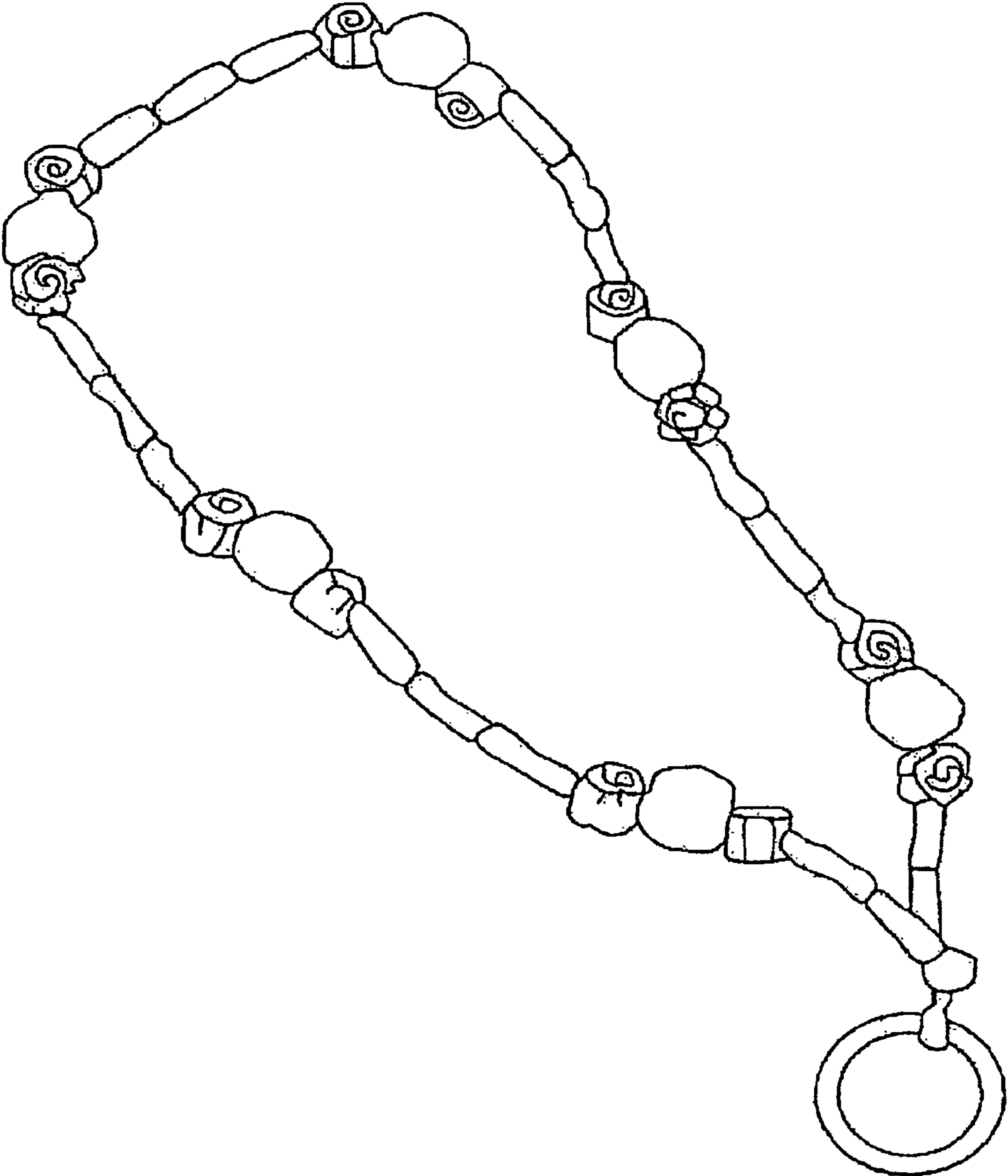

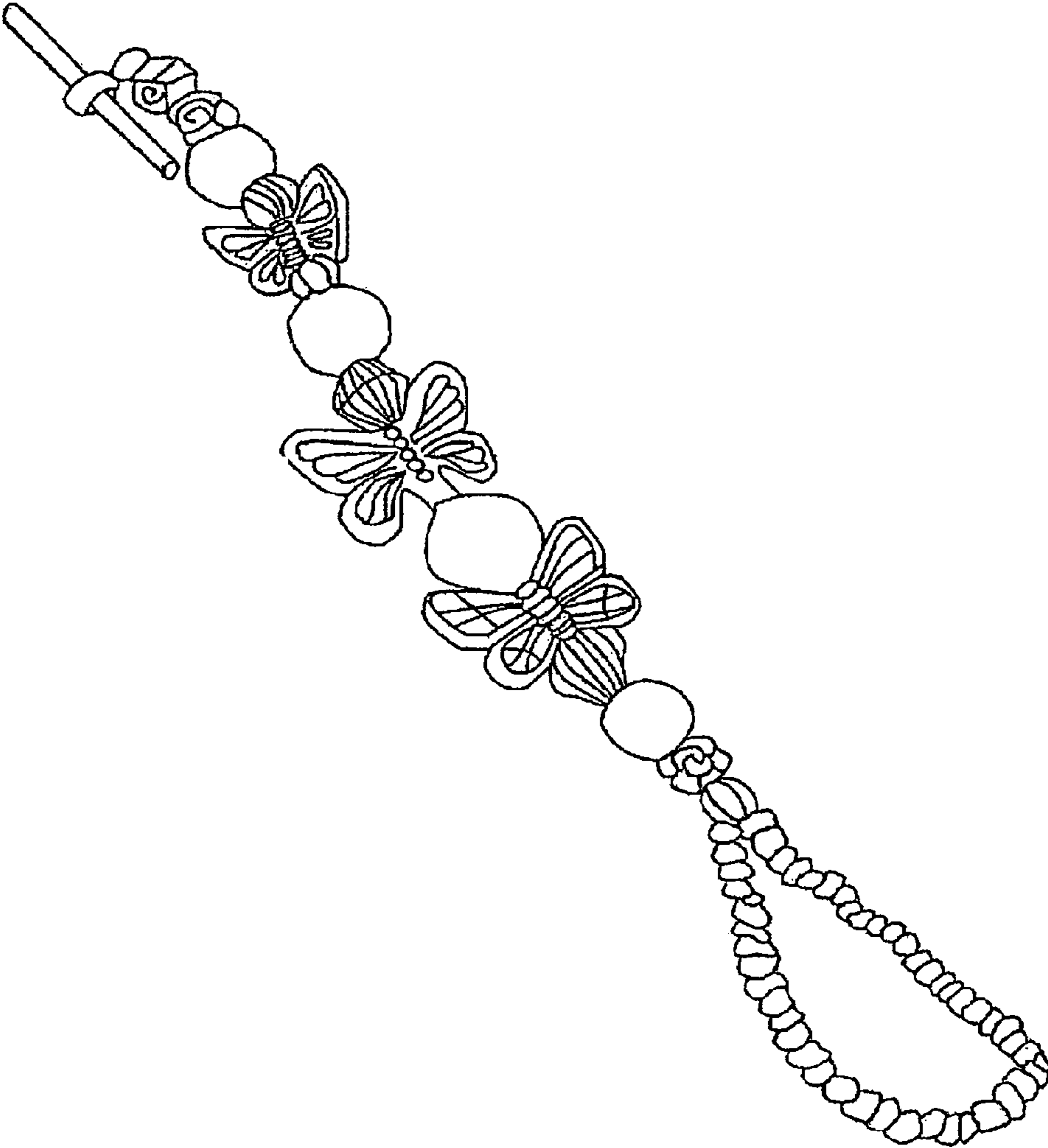

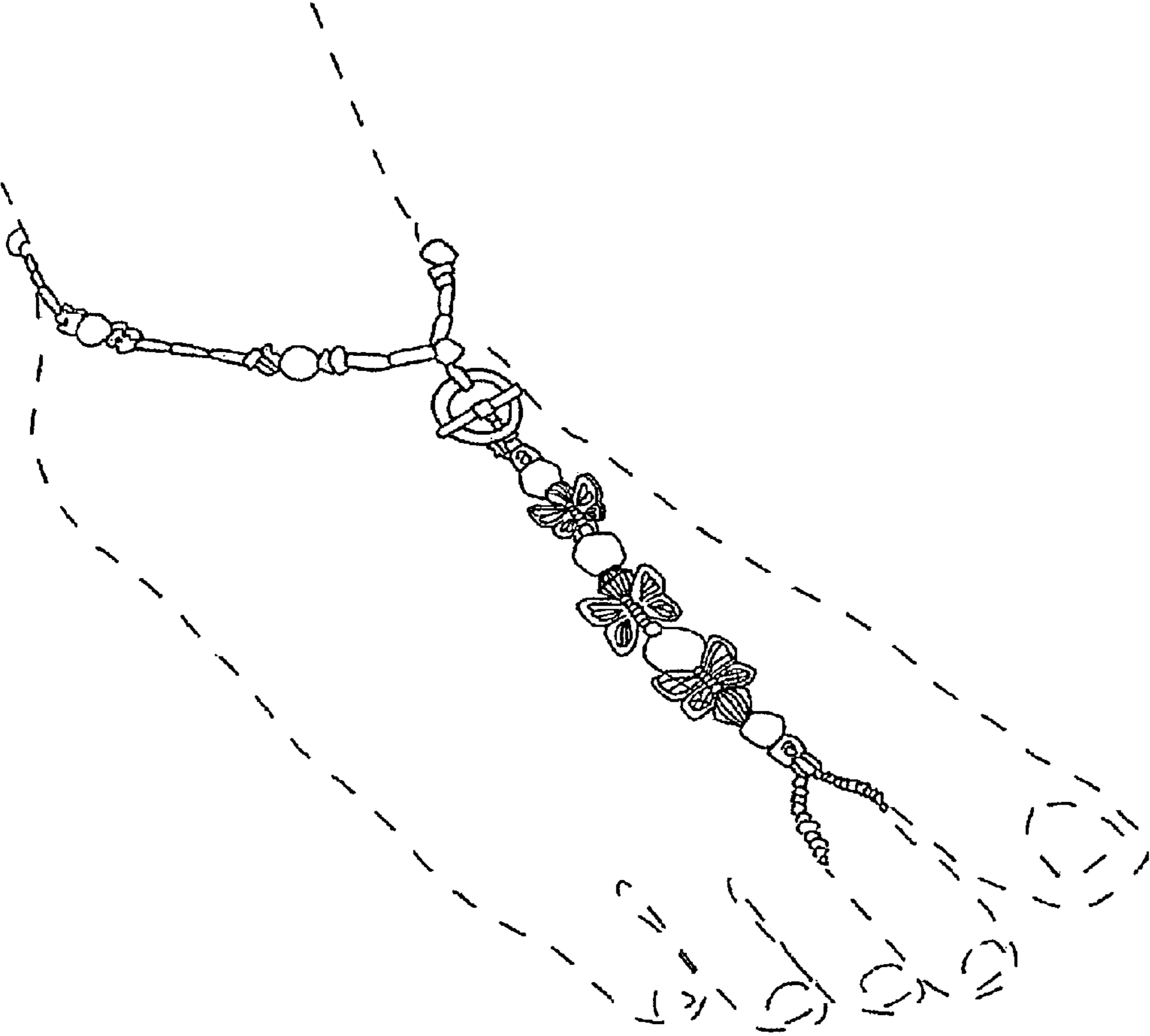

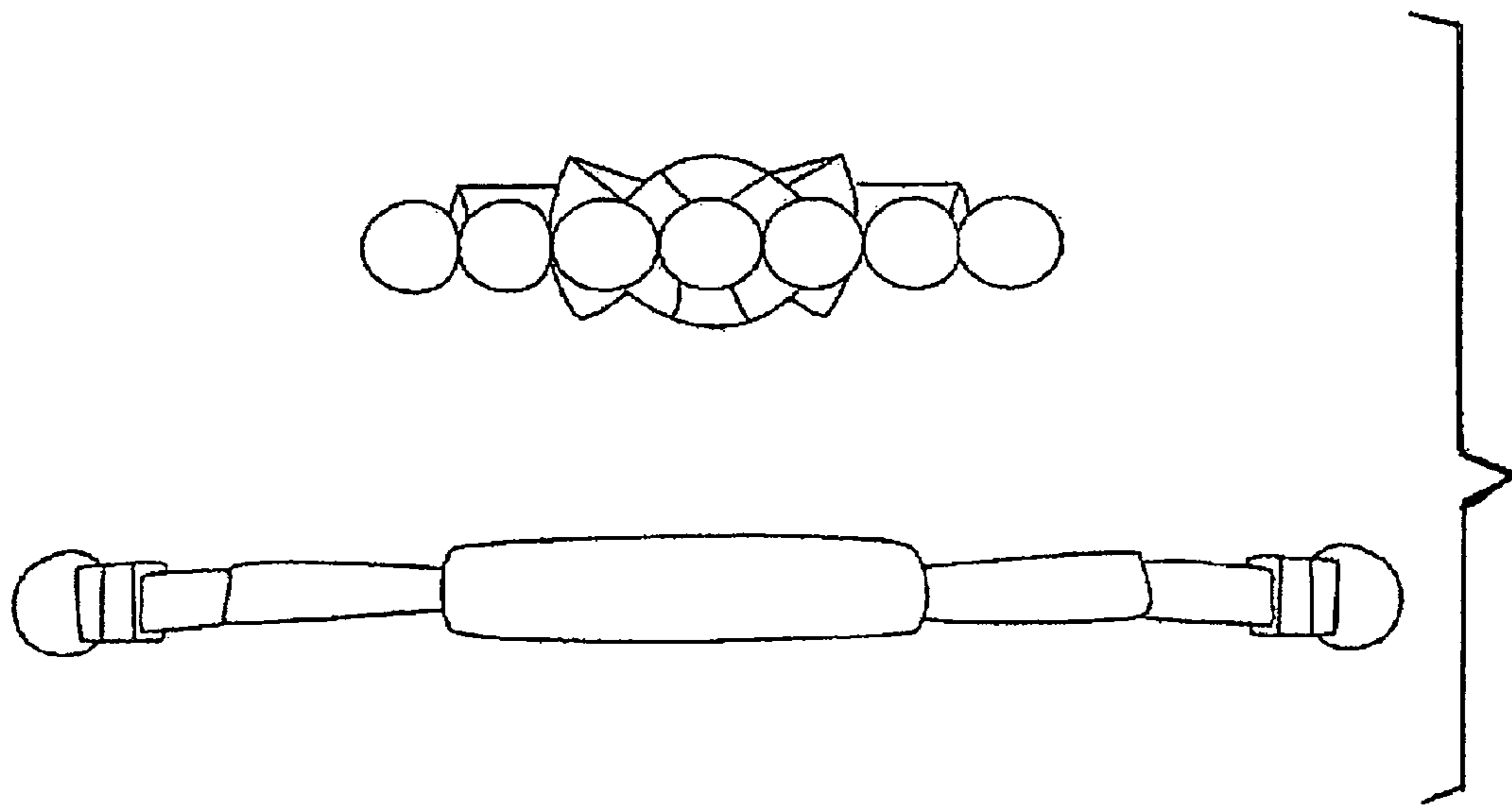

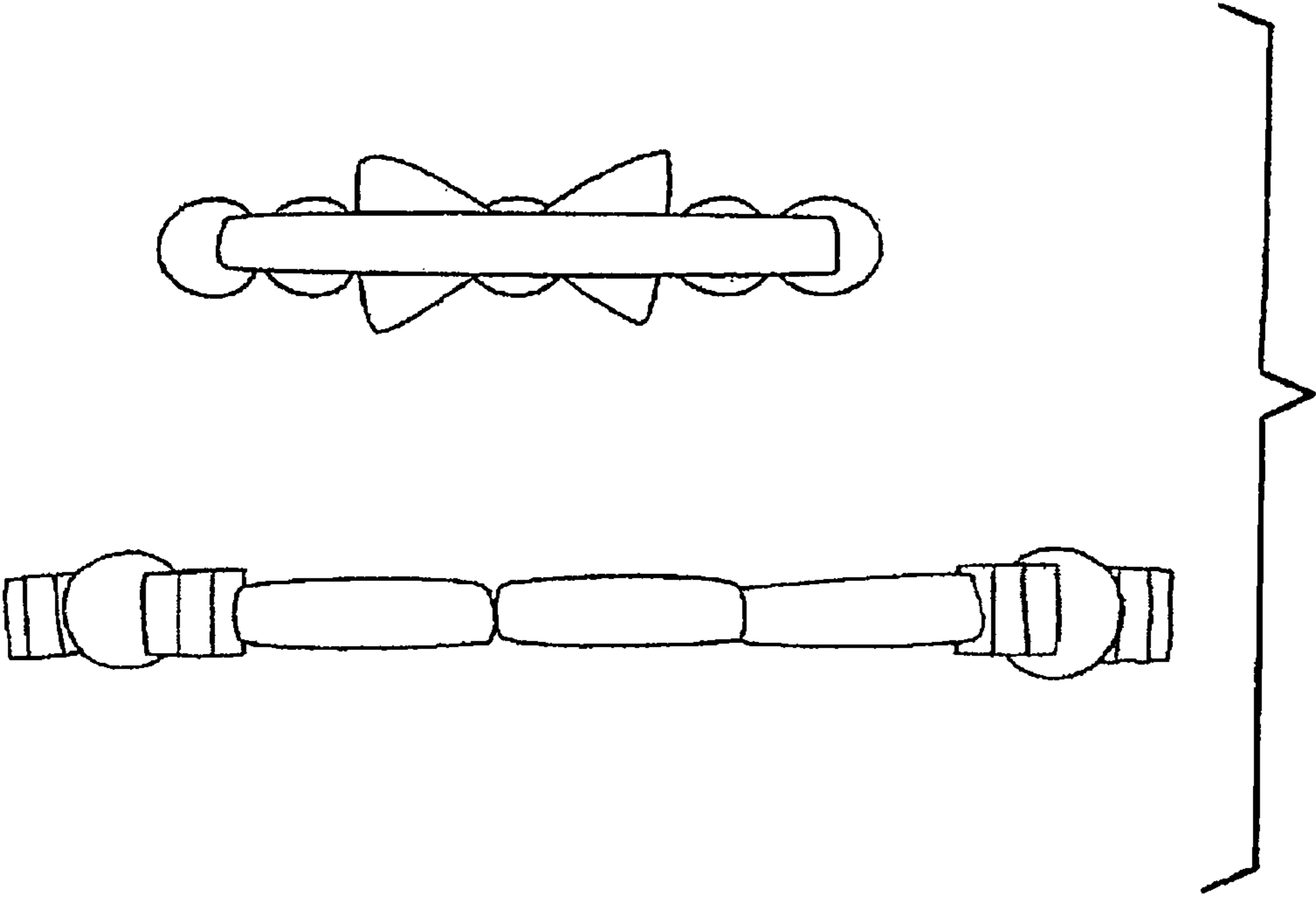

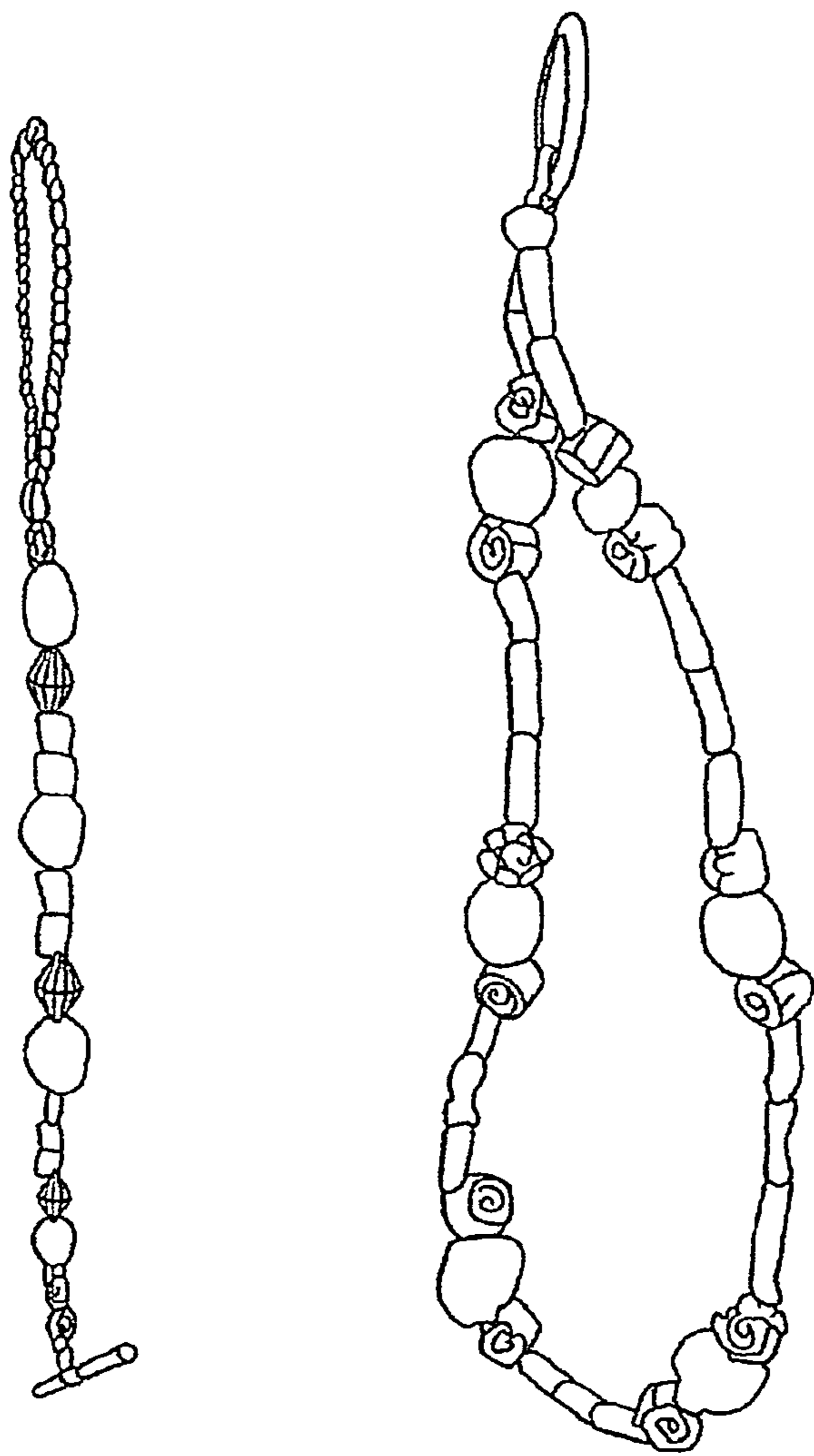

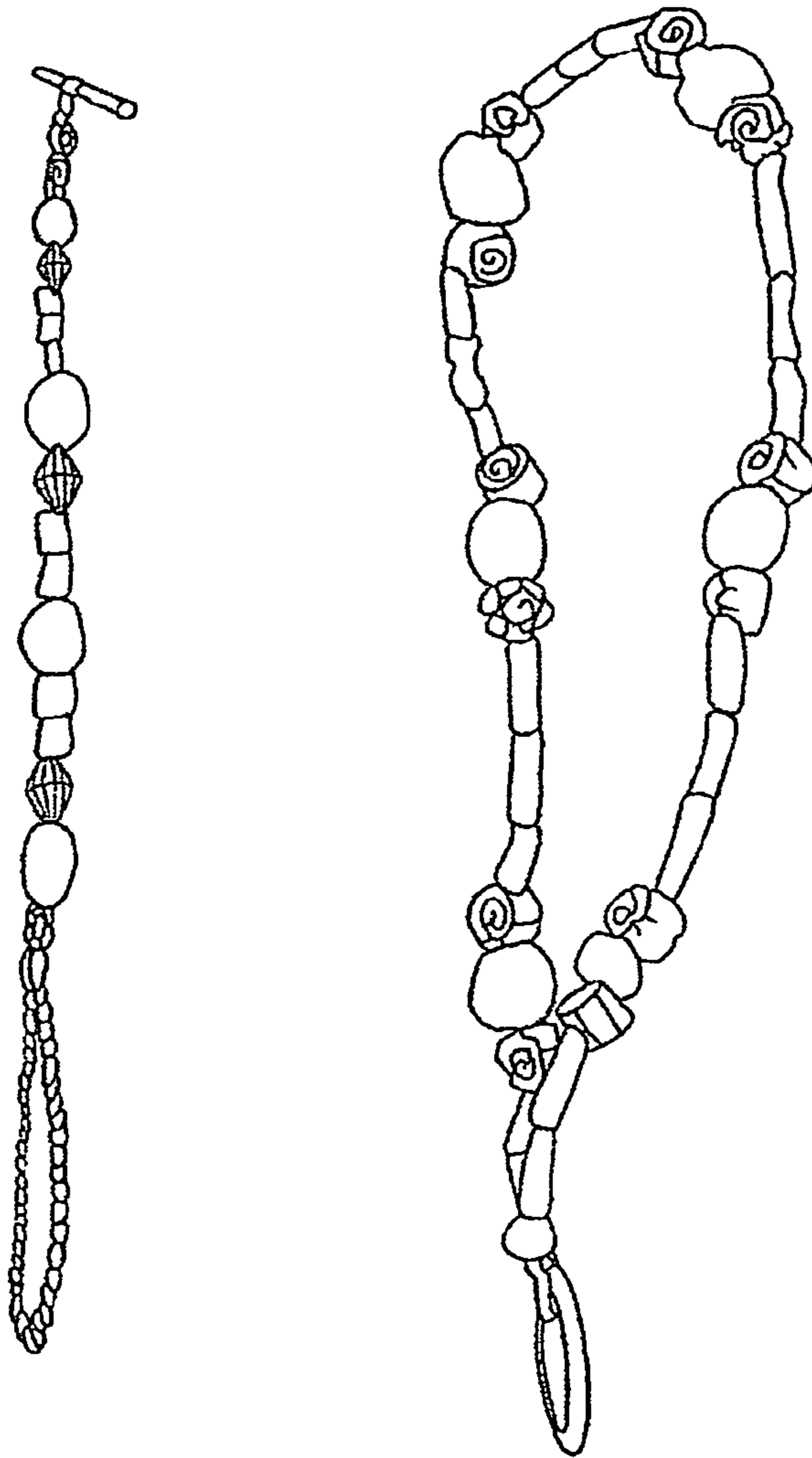

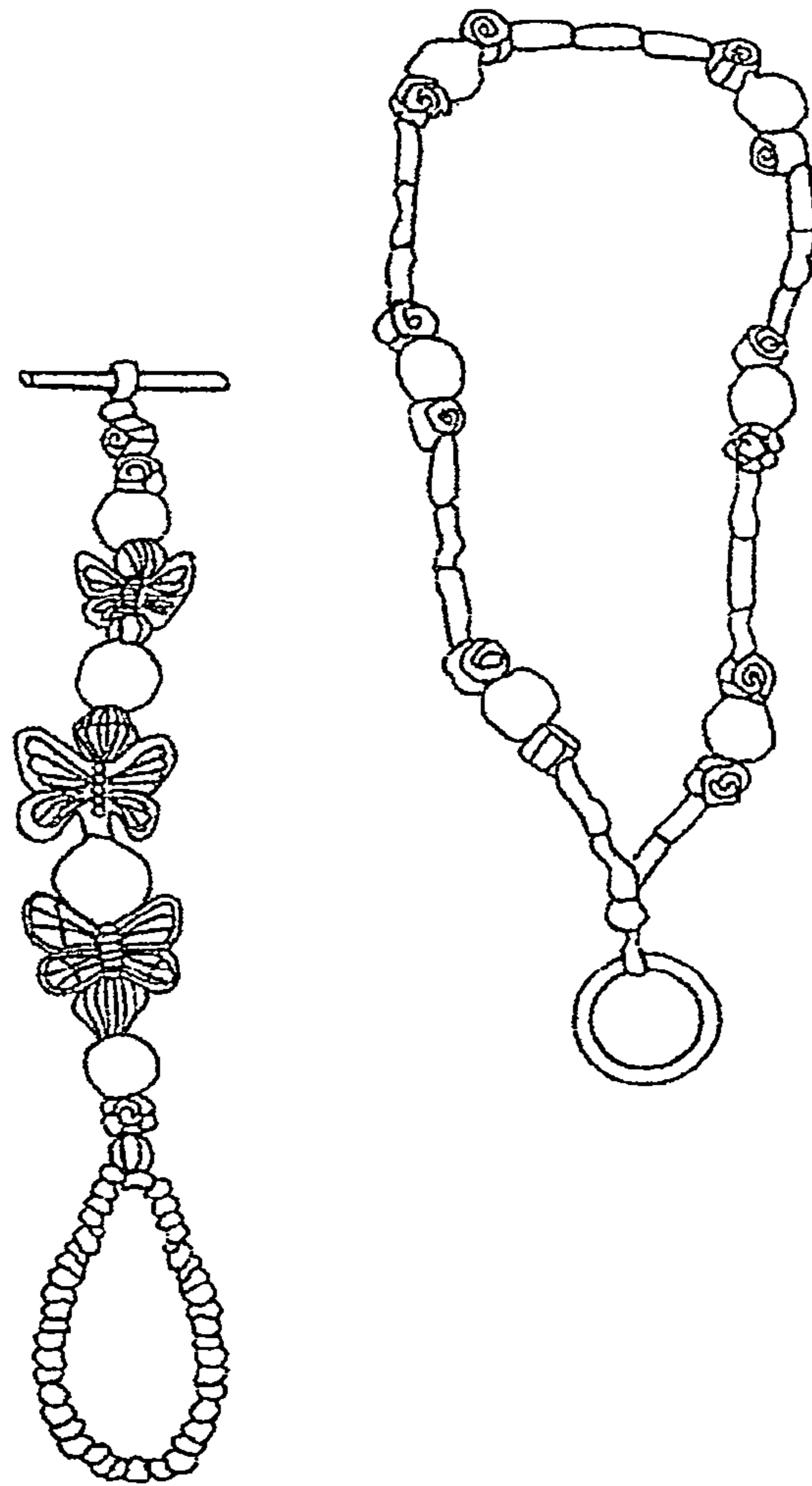

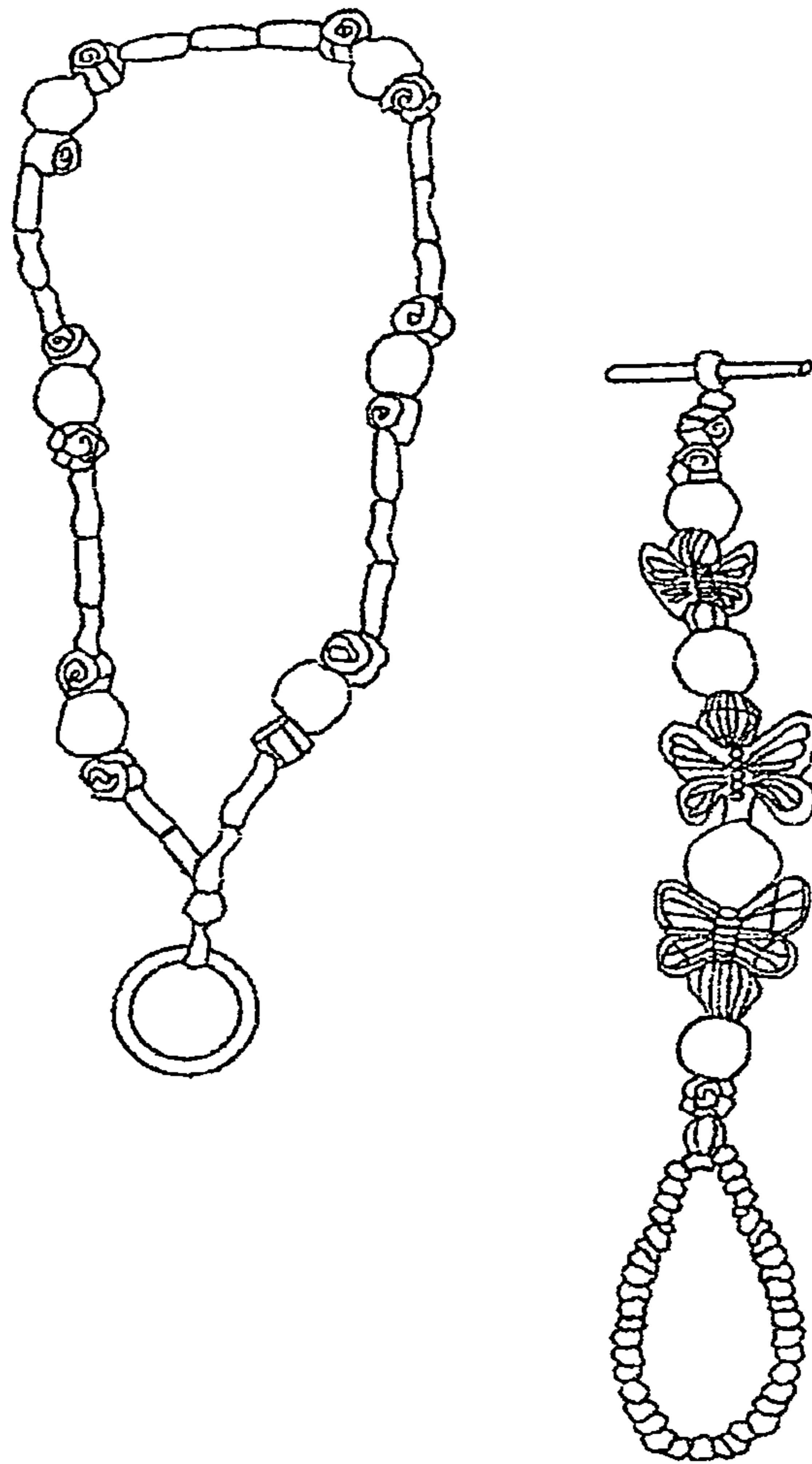
