(57) **CLAIM**

The ornamental design for a golf cart rear body, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a rear golf cart body showing our design for a retrofitted or remanufactured golf cart with the rear seat on the same horizontal plane as the front seat.

FIG. 2 is an elevational side view of the rear golf cart body of FIG. 1.

FIG. 3 is a perspective view of the rear golf cart body of FIG. 1 with the remainder of the golf cart removed.

FIG. 4 is an elevational front end view of the rear golf cart body of FIG. 3.

FIG. 5 is an elevational rear end view of the rear golf cart body of FIG. 3.

FIG. 6 is an elevational side view of the rear golf cart body of FIG. 3.

FIG. 7 is an elevational side view of the opposing side of the rear golf cart body of FIG. 3.

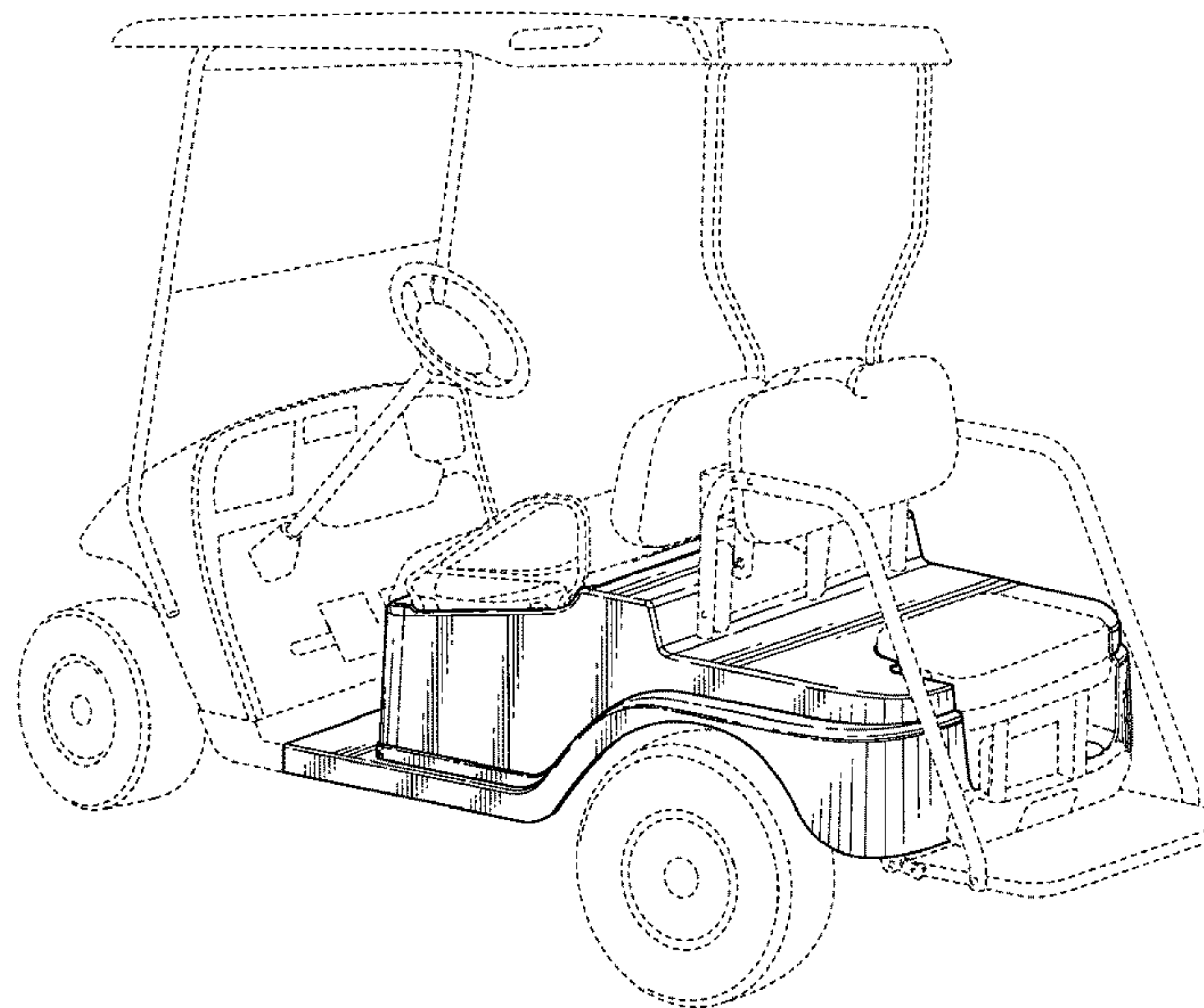
FIG. 8 is a top or plan view of the rear golf cart body of FIG. 3; and,

FIG. 9 is a bottom view of the rear golf cart body of FIG. 3.

This design for a golf cart rear body is intended for retrofitted or remanufactured golf carts.

A characteristic feature of the design is that the rear seat of the golf cart is on the same horizontal plane as the front seat of the golf cart. The broken lines shown illustrate environmental structure and form no part of the claimed design.

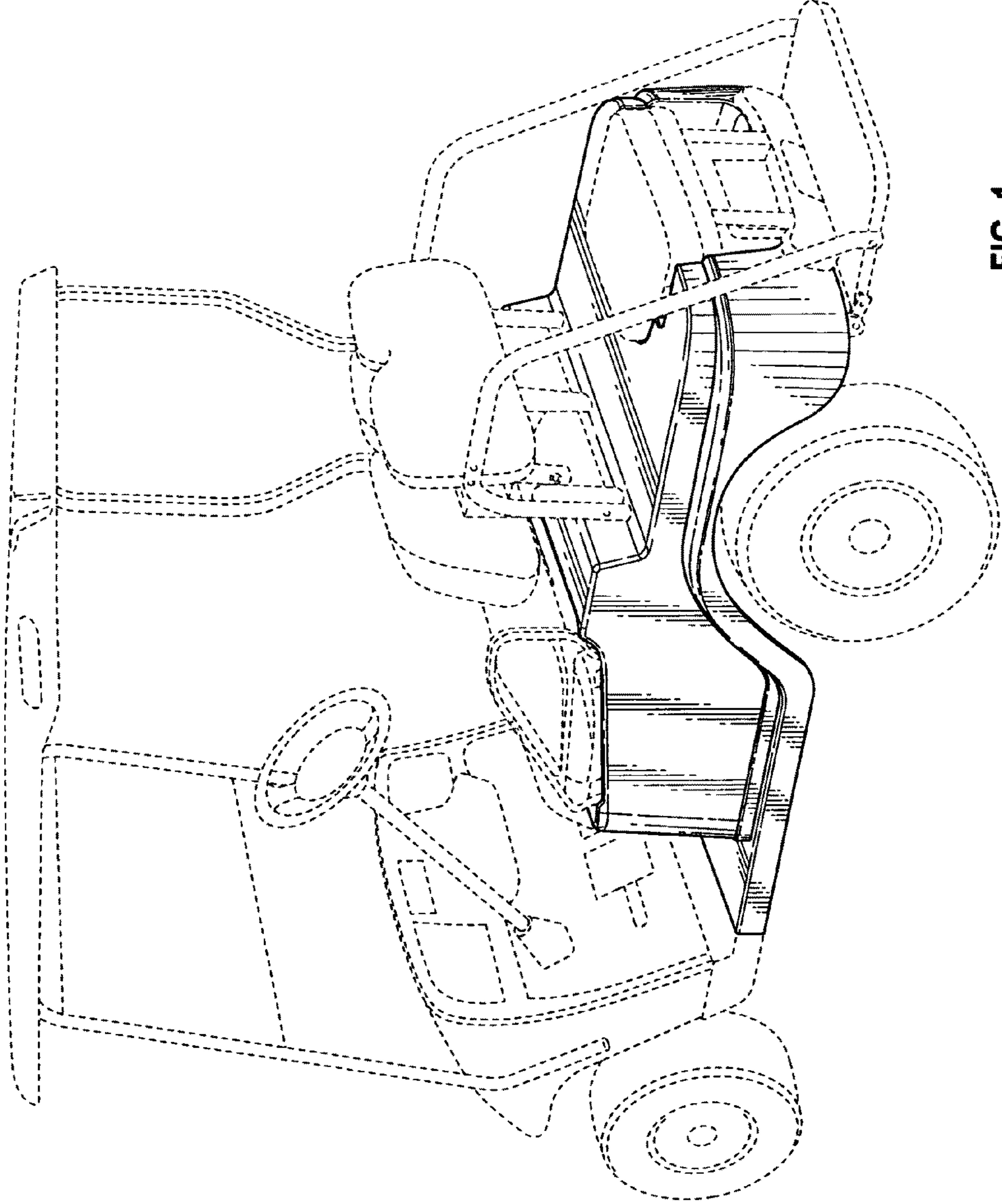

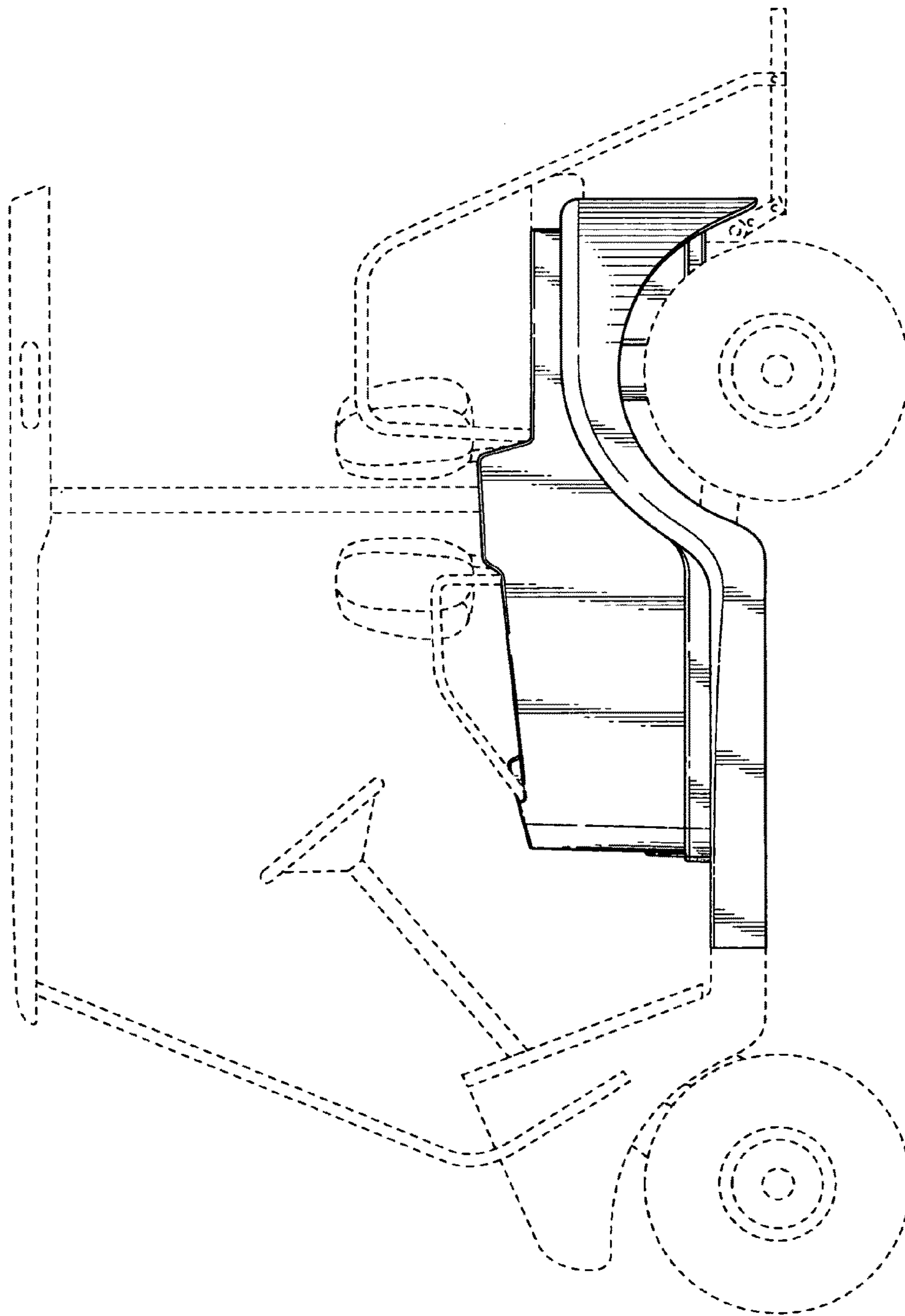

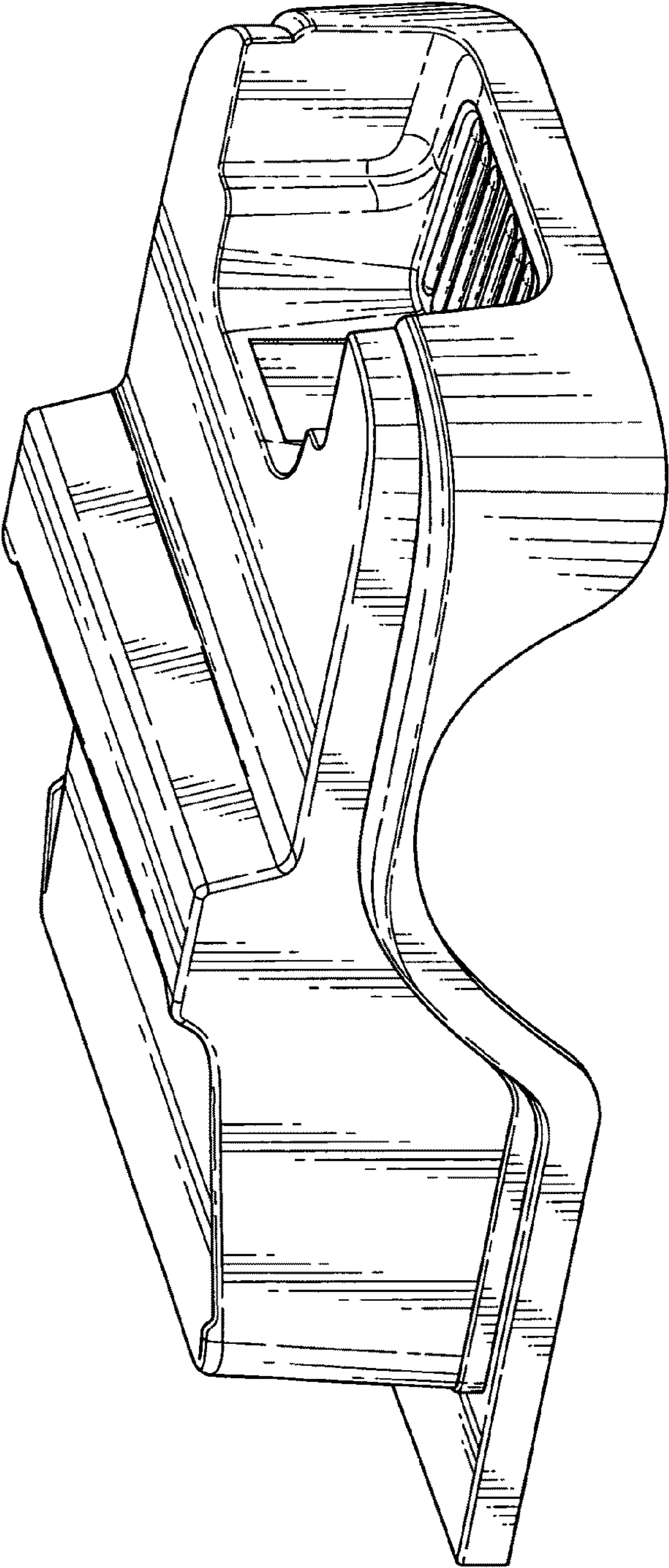

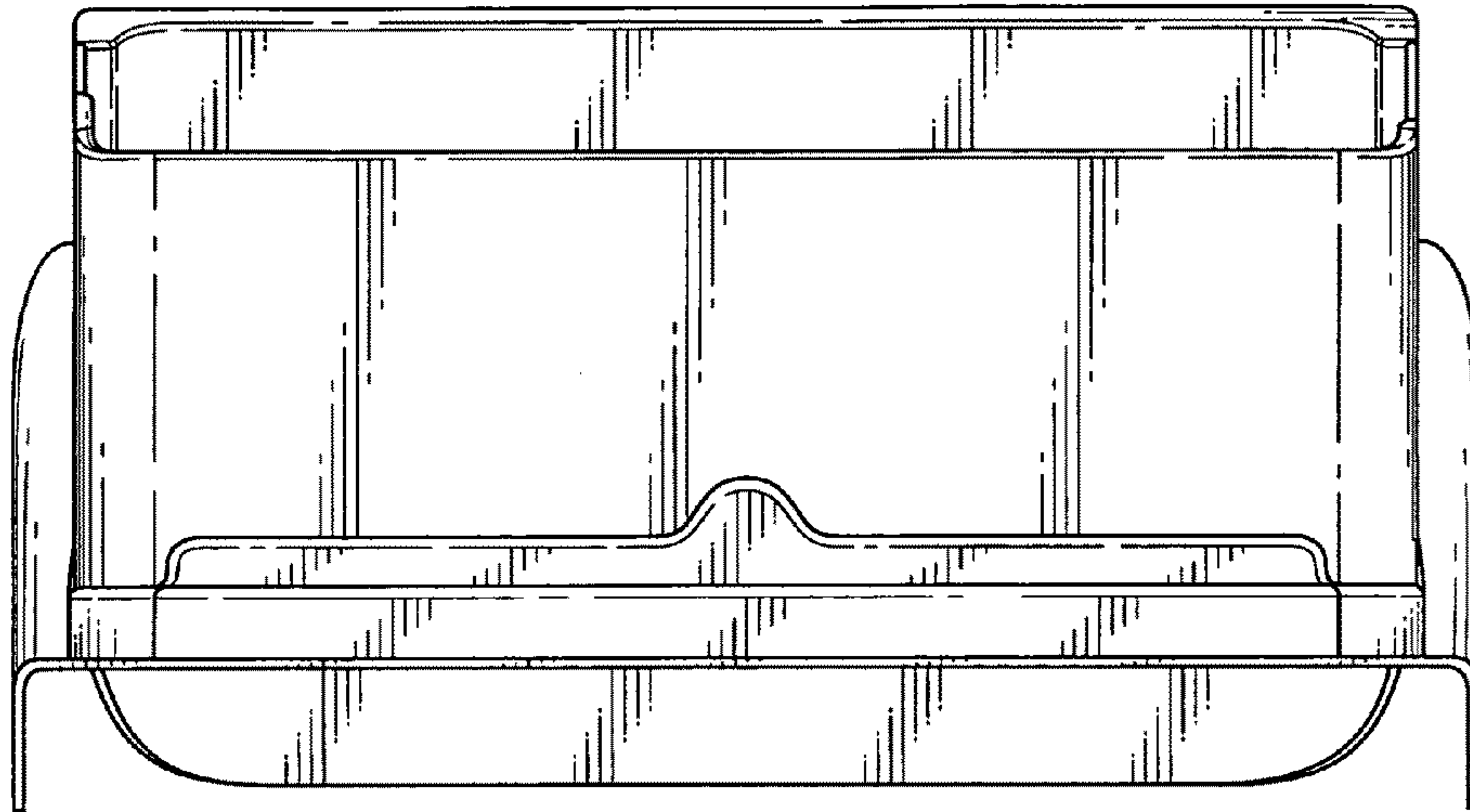

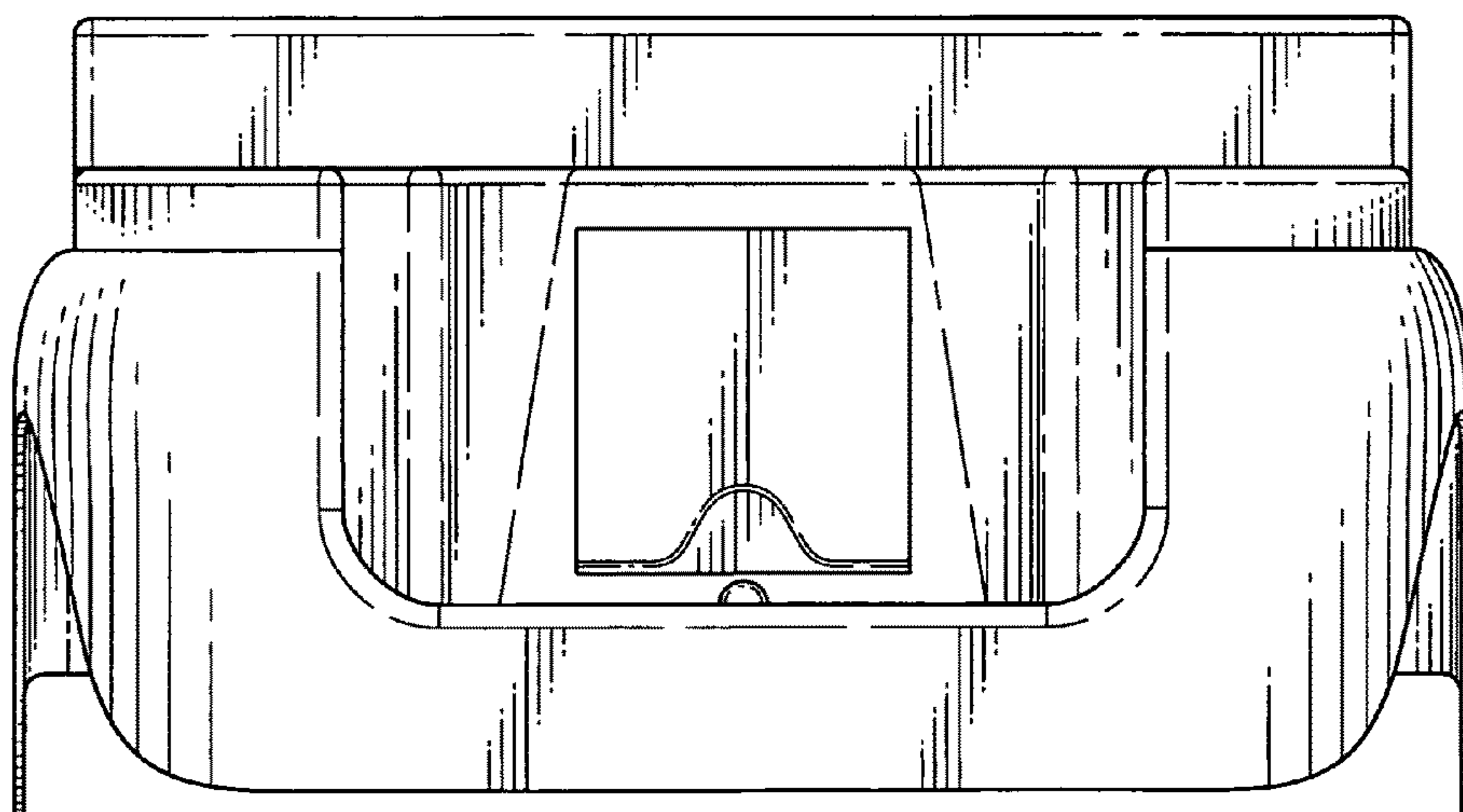

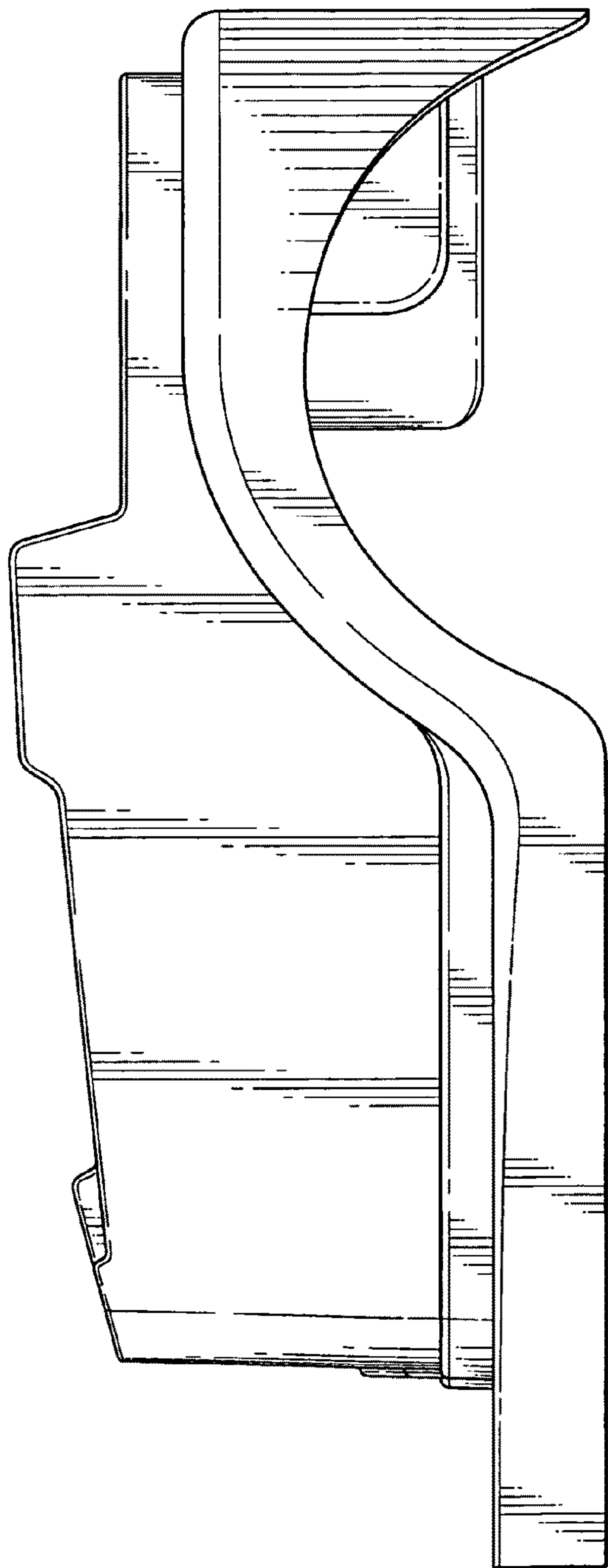

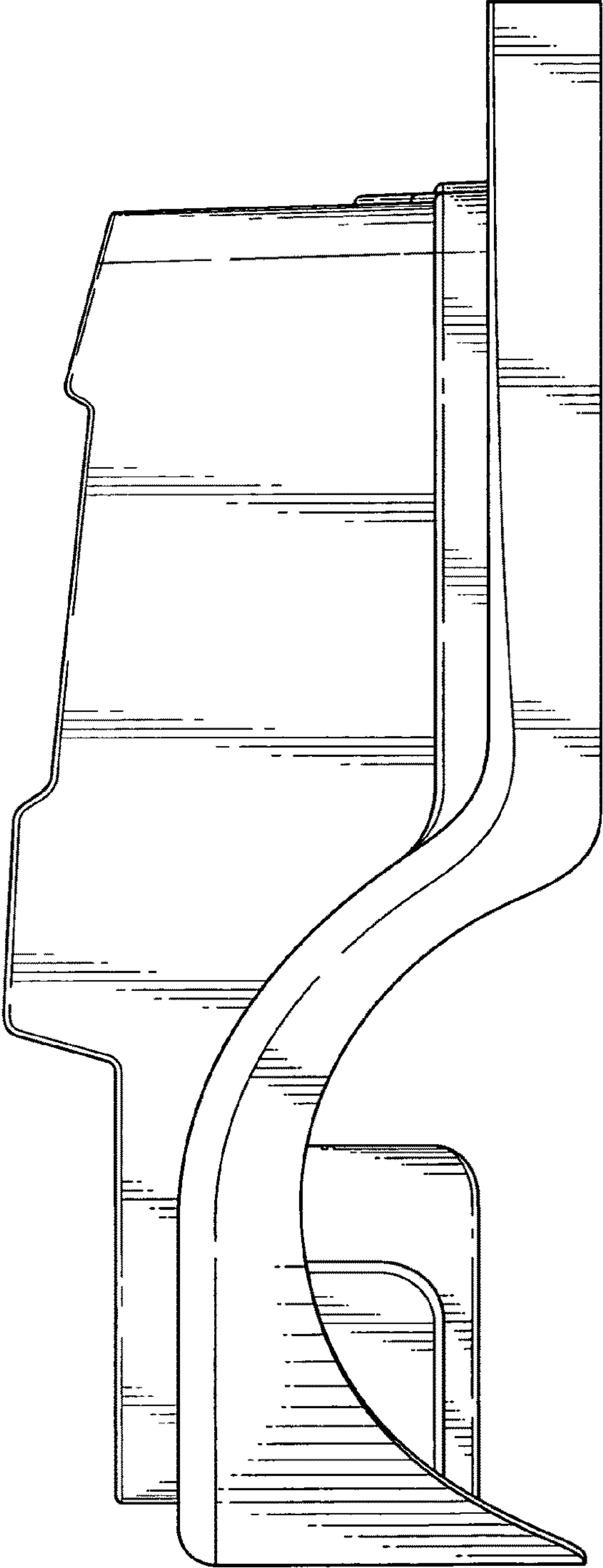

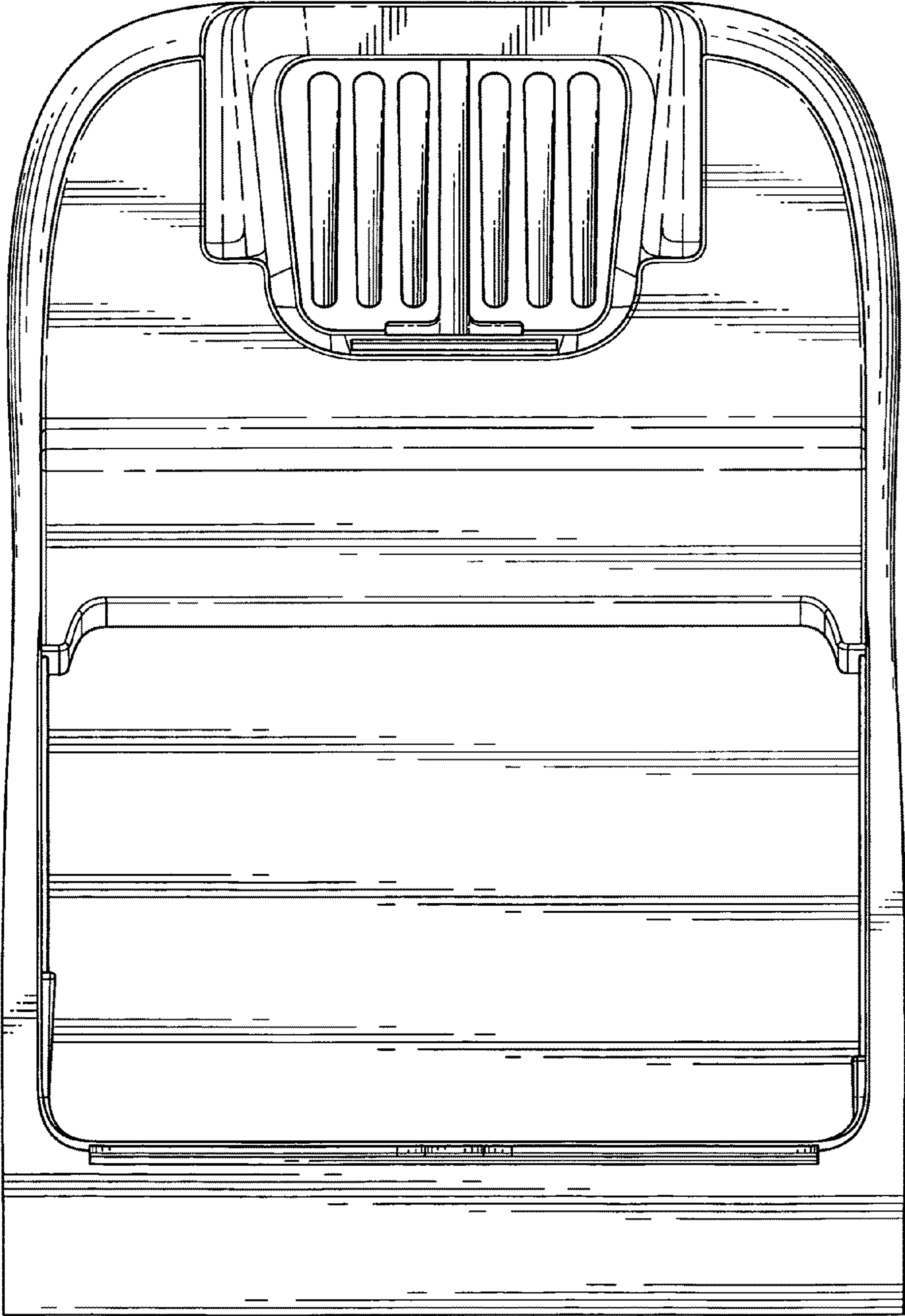

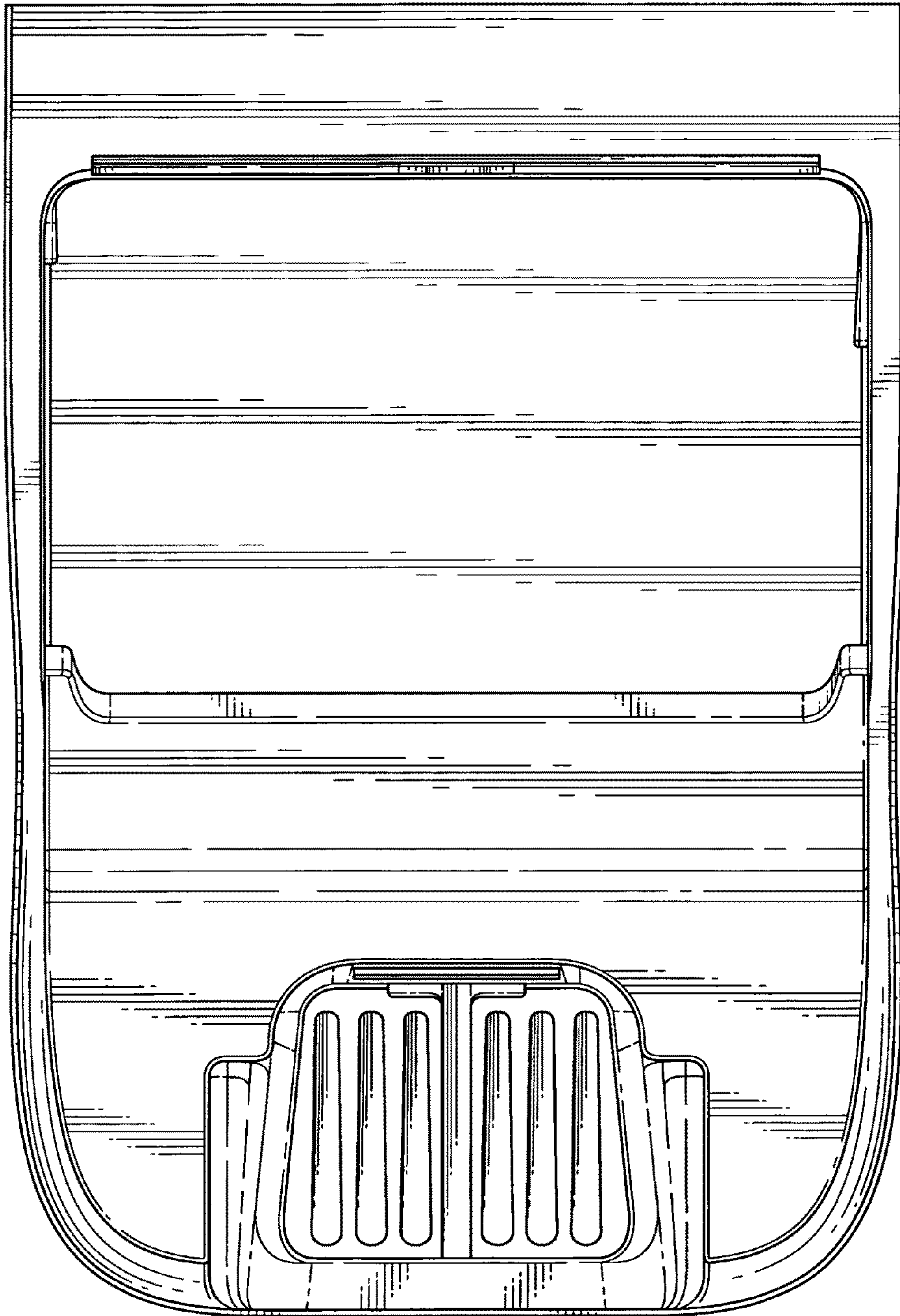
