(57) **CLAIM**

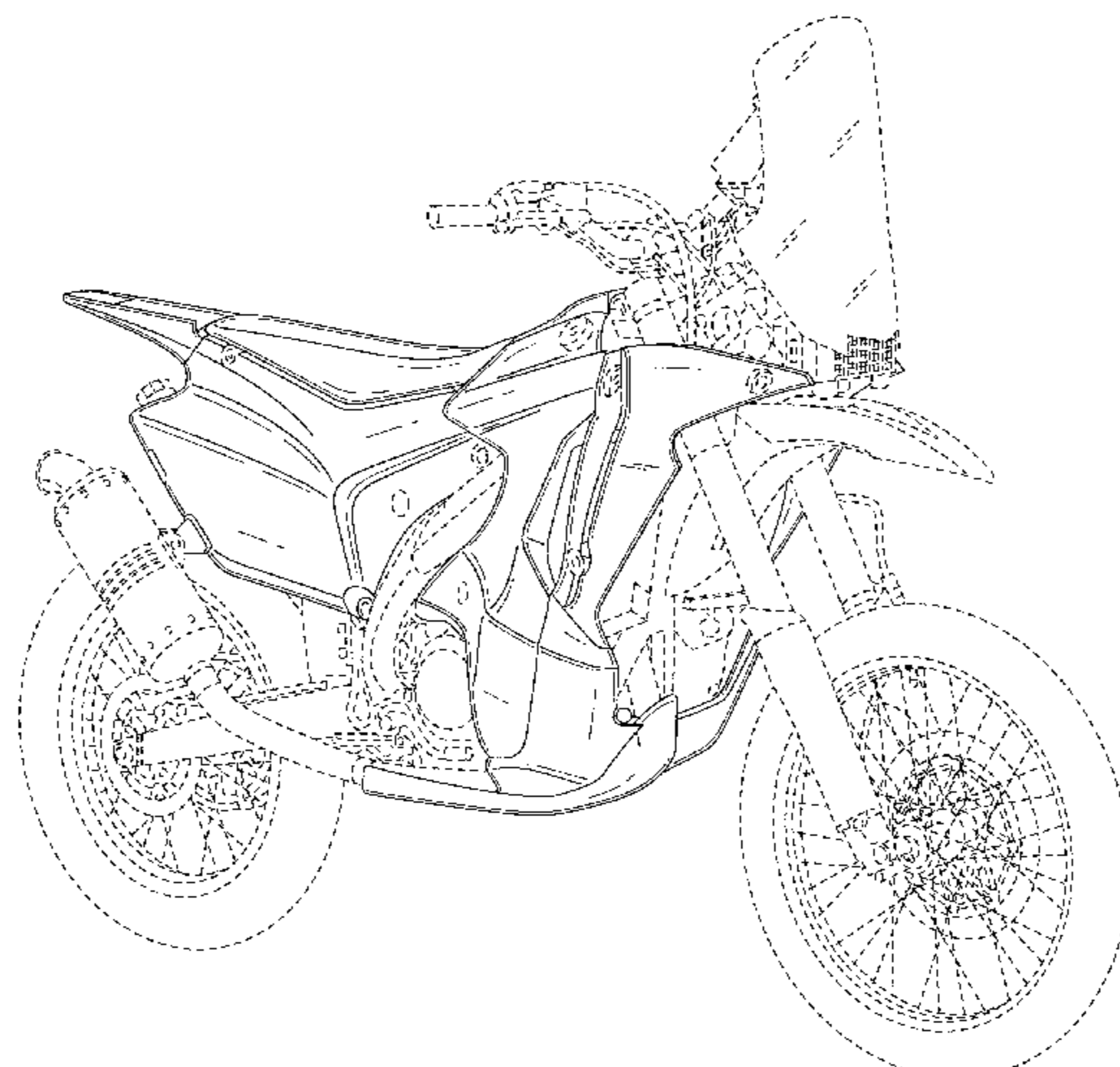
The ornamental design for a motorcycle and/or replica thereof, as shown and described.

DESCRIPTION

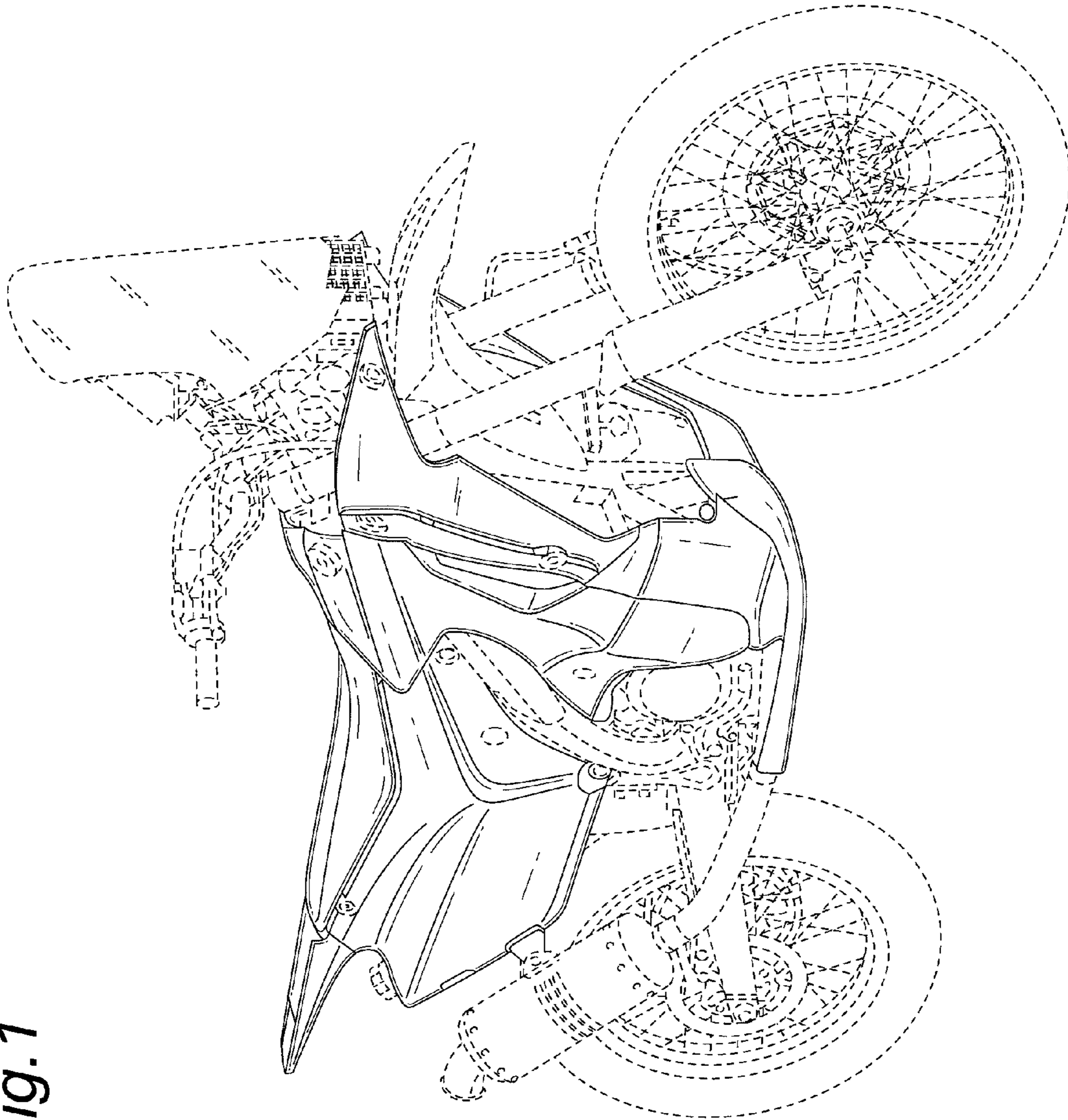

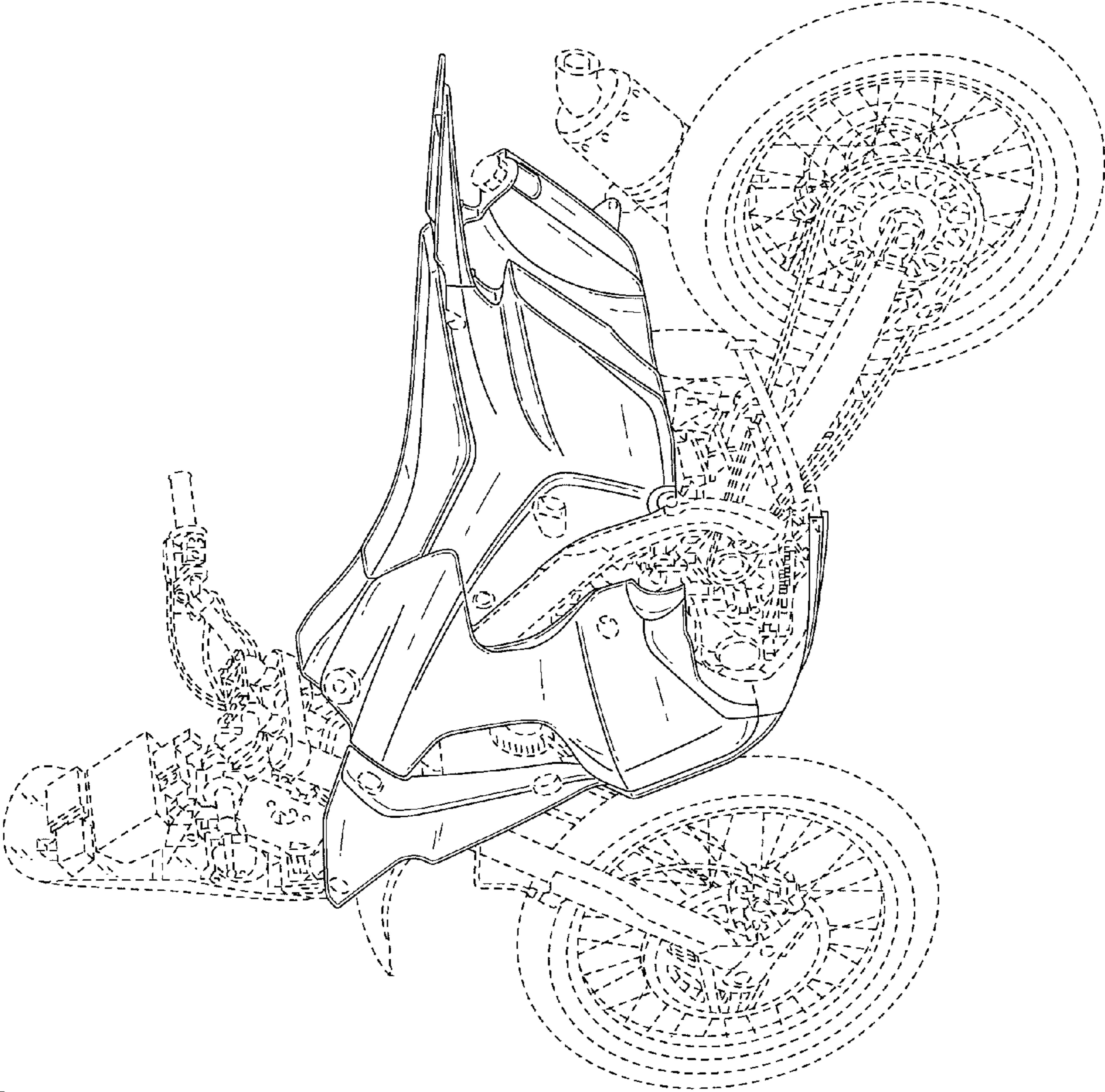

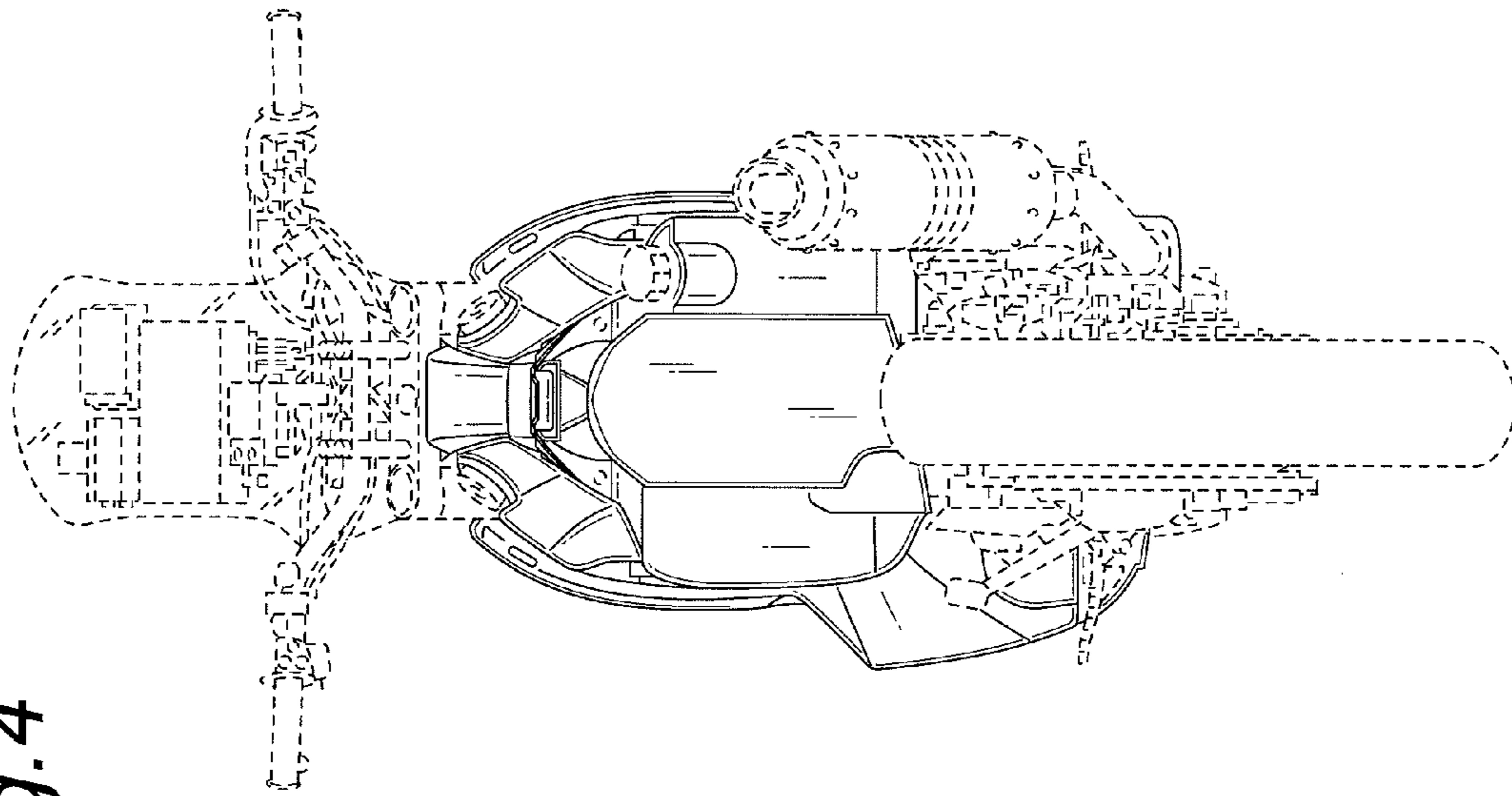

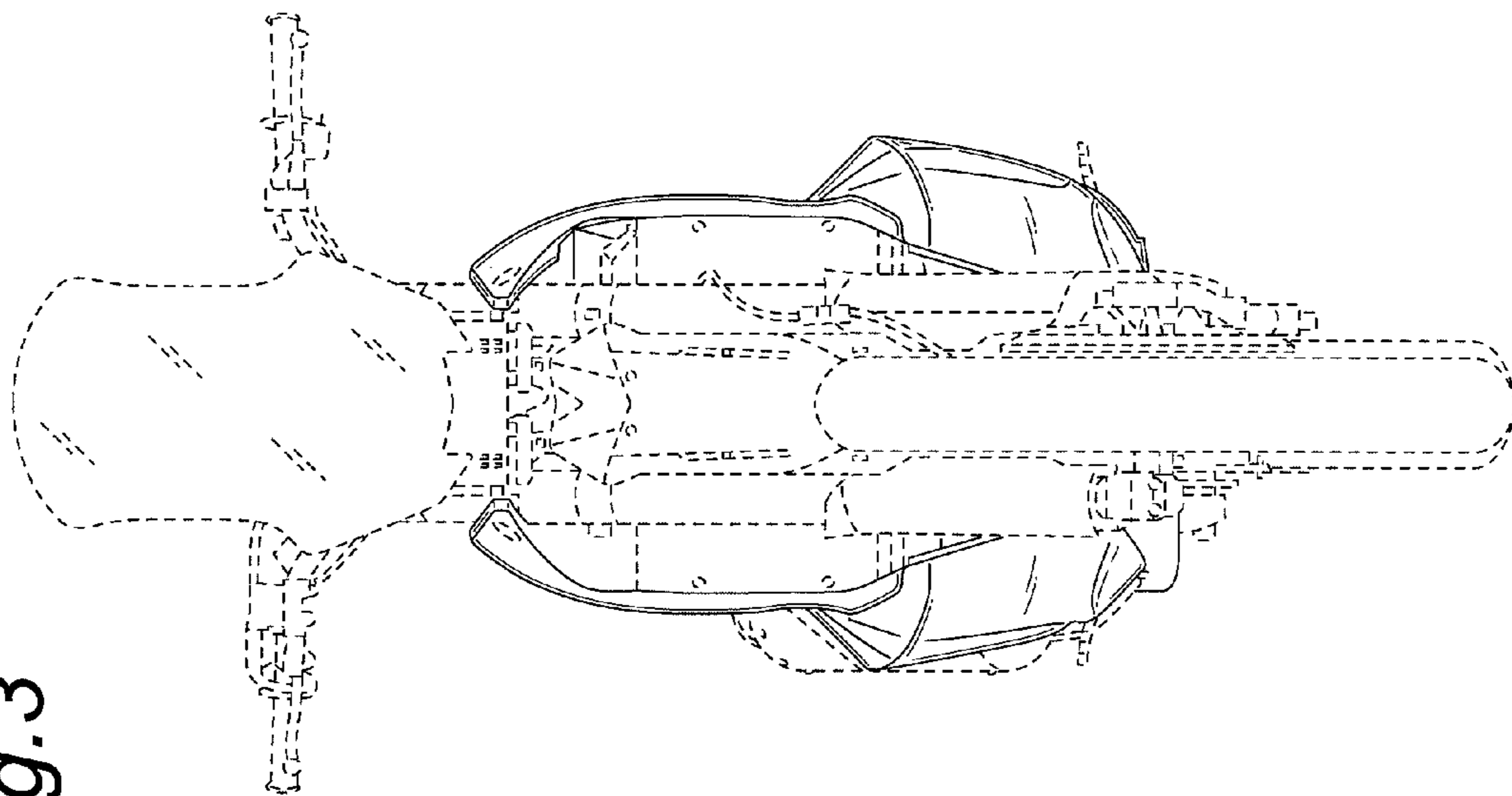
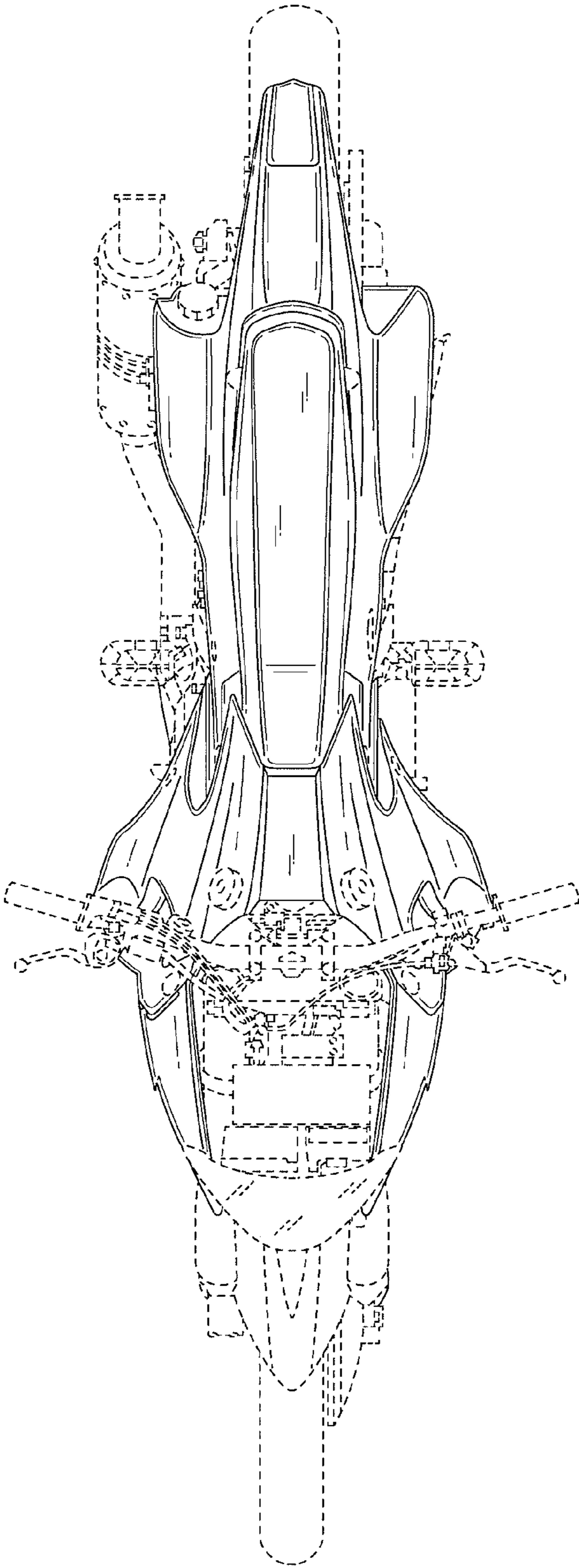

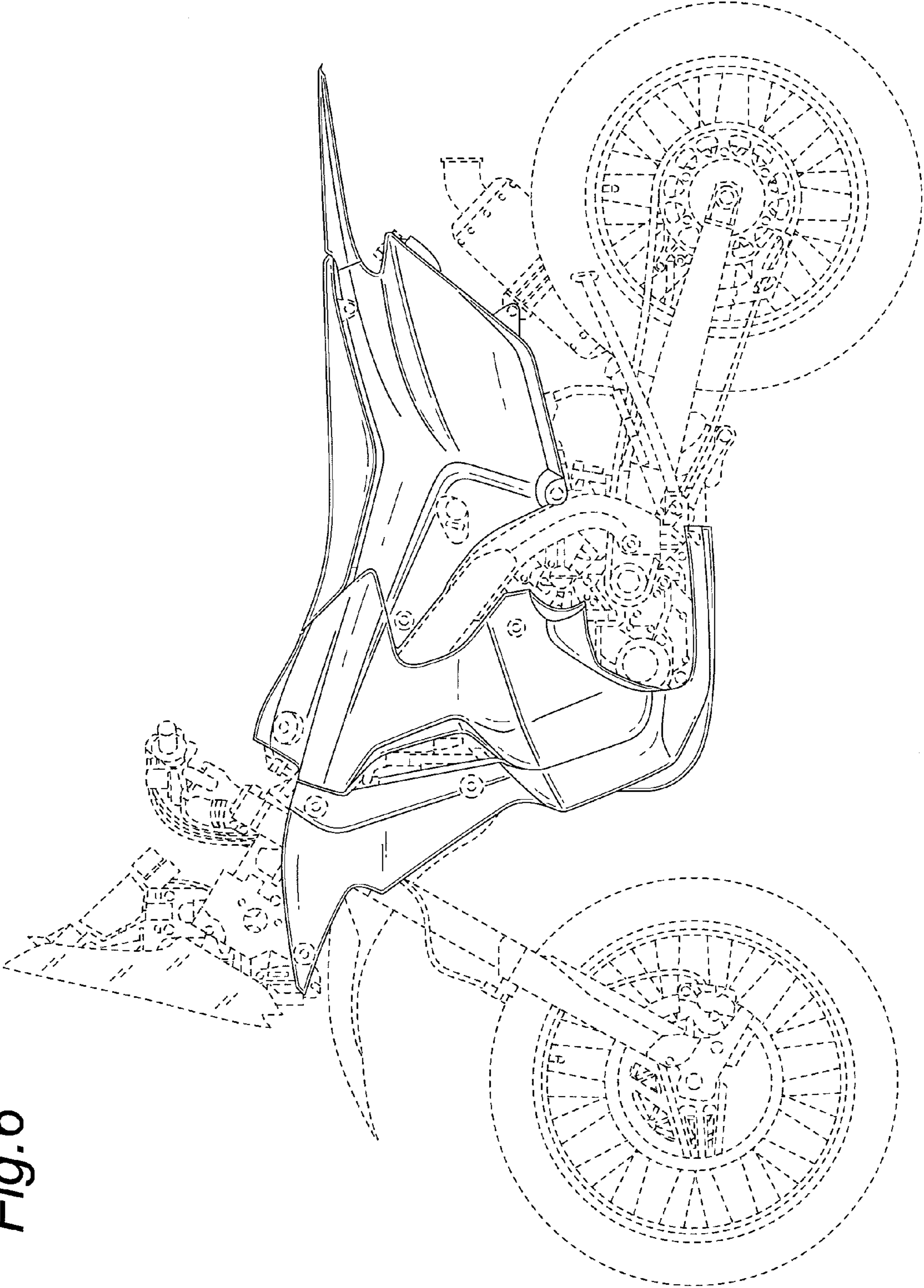
