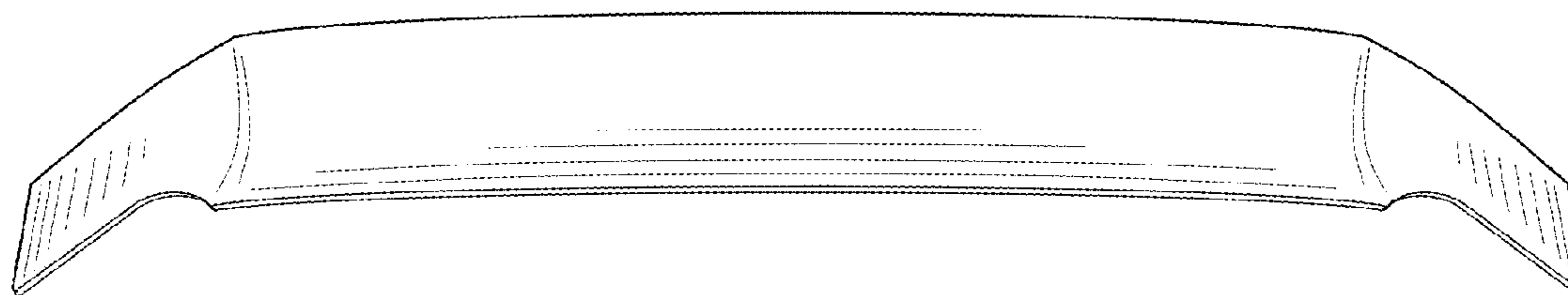
(57) **CLAIM**

We claim the ornamental design of an automobile rear window ornament, as shown and described.

**DESCRIPTION**

FIG. 1 is rear-top perspective view of an automobile rear window ornament in accord with the present design; FIG. 2 is a front-top perspective view of the rear window ornament of FIG. 1; FIG. 3 is a top-left perspective view of the rear window ornament of FIG. 1; FIG. 4 left elevational view of the rear window ornament of FIG. 1; and, FIG. 5 is a rear-left perspective view of the rear window ornament of FIG. 1.

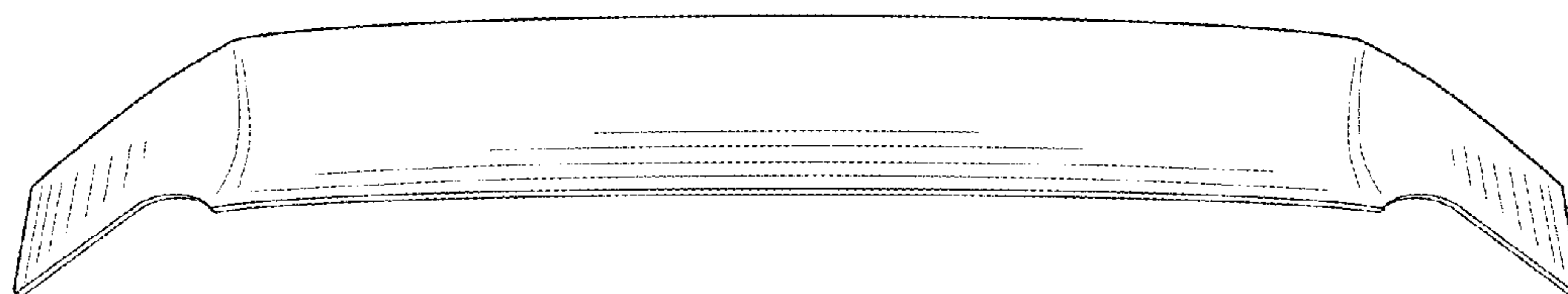

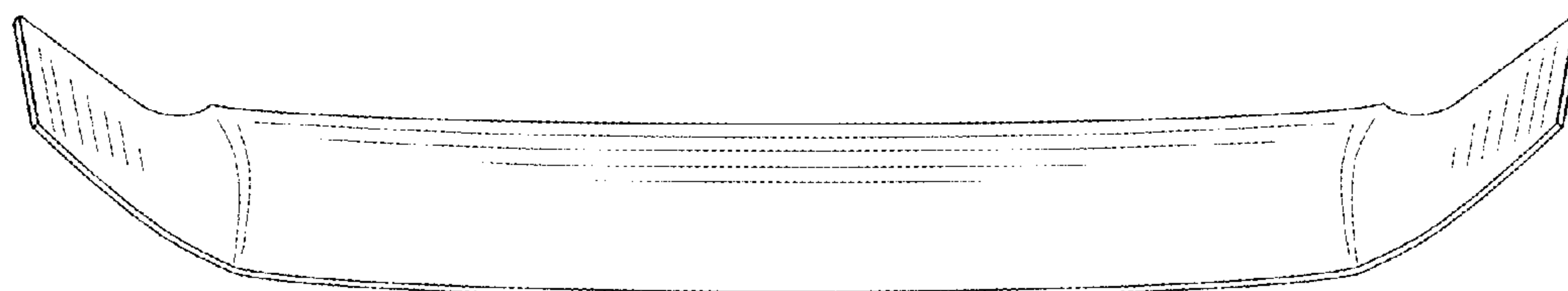

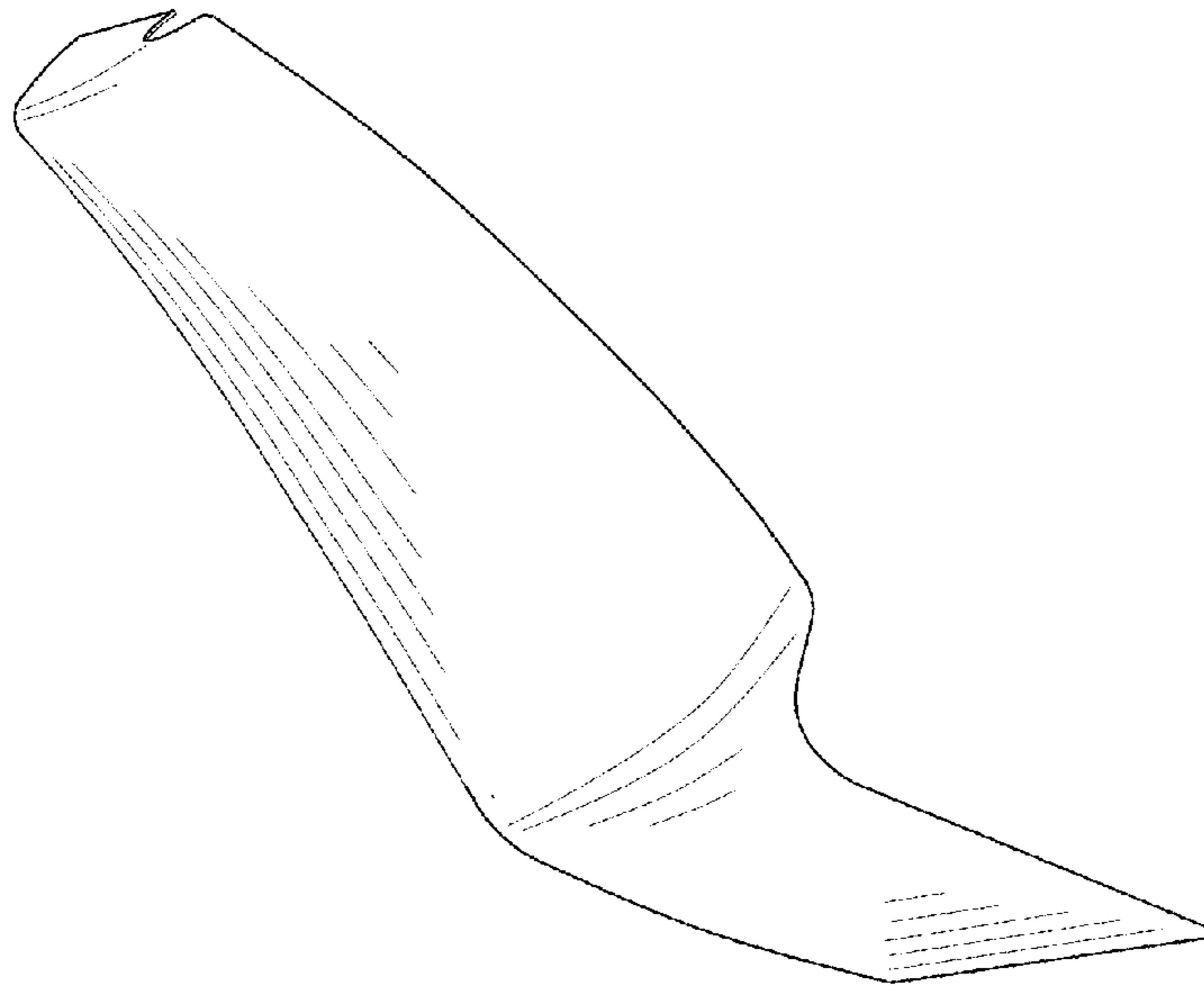

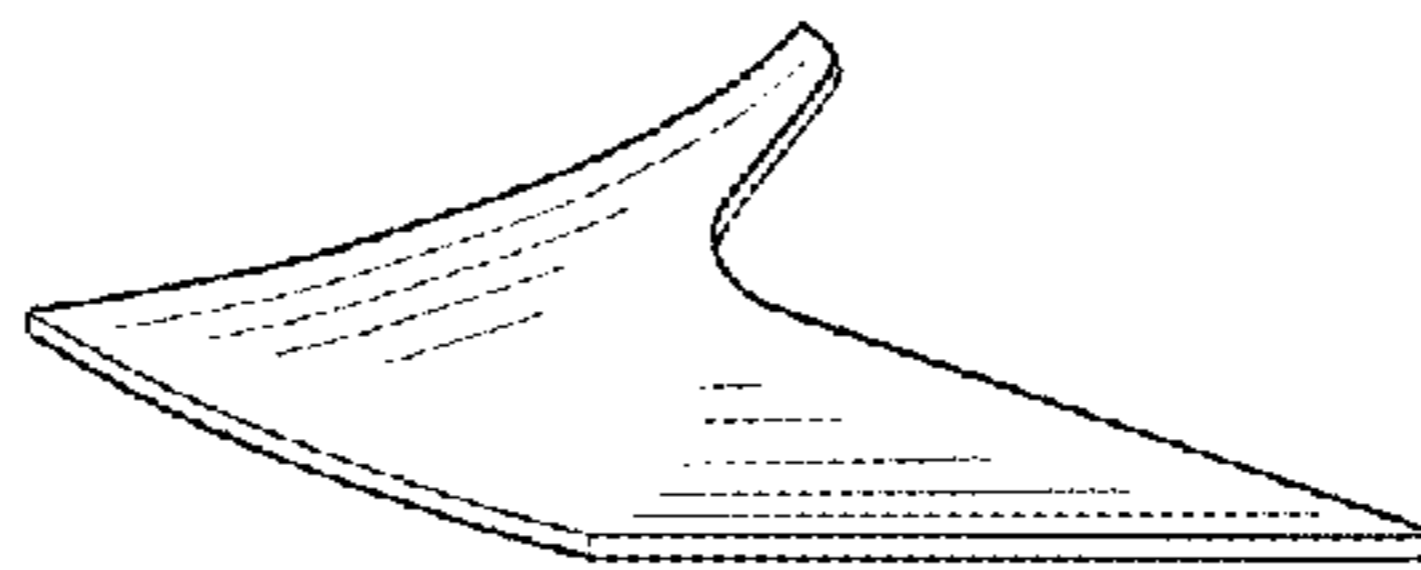

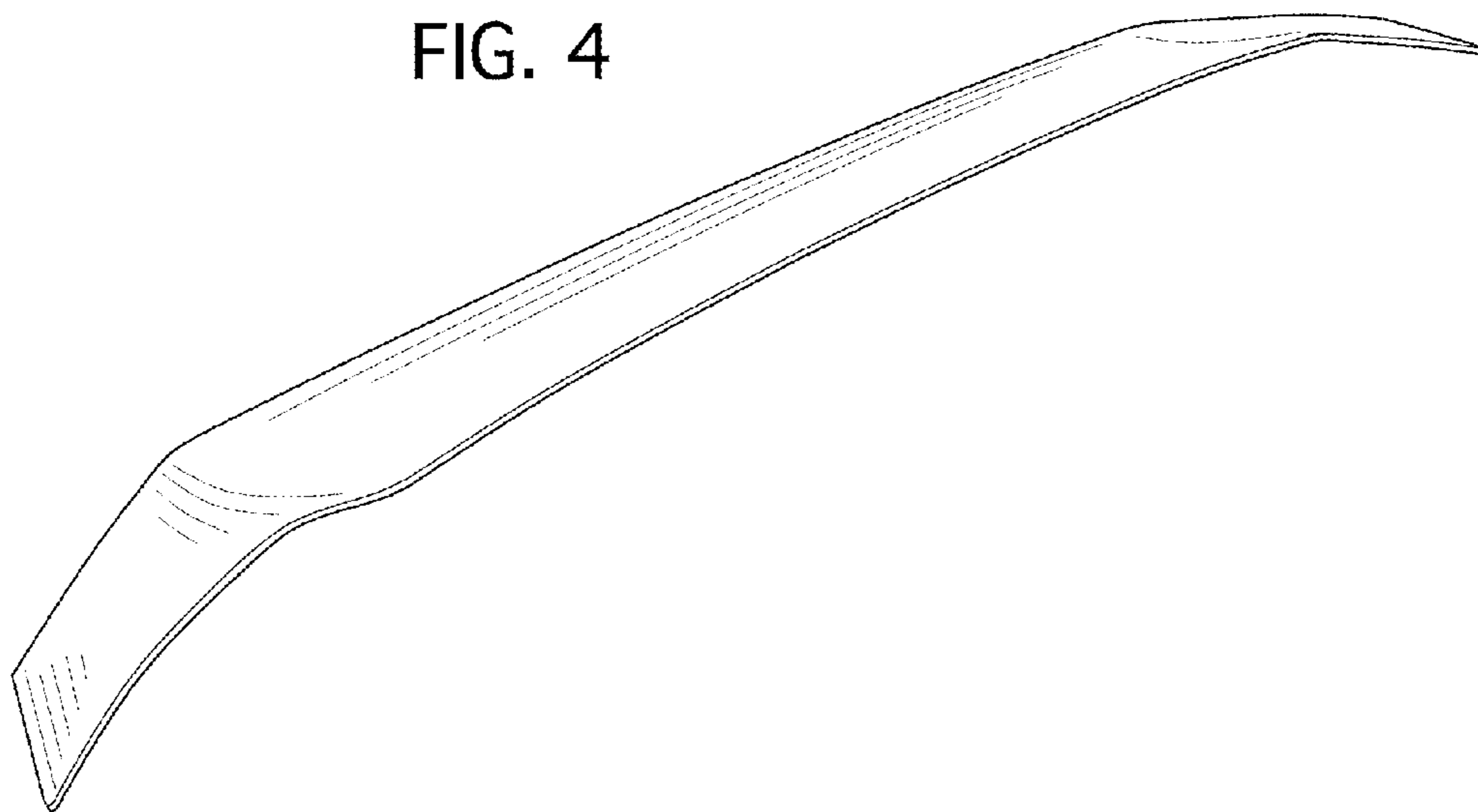
