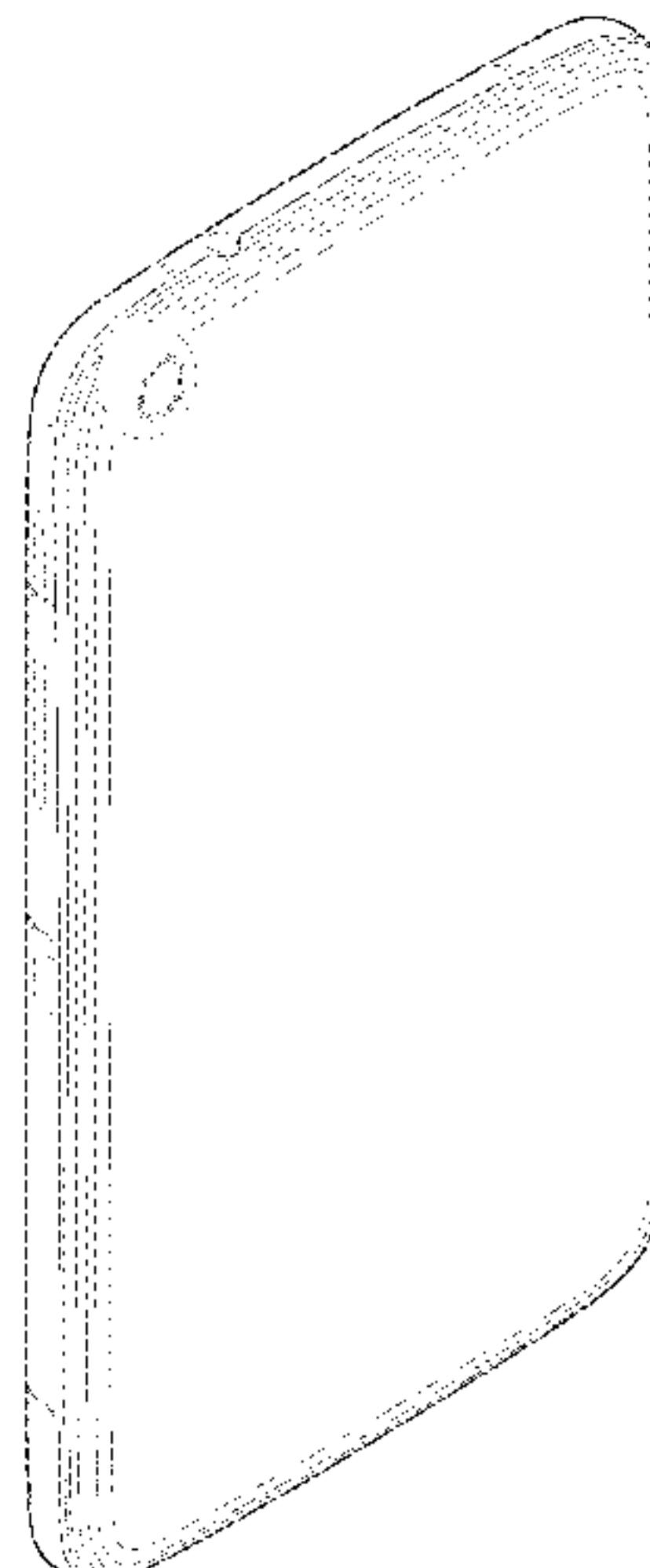
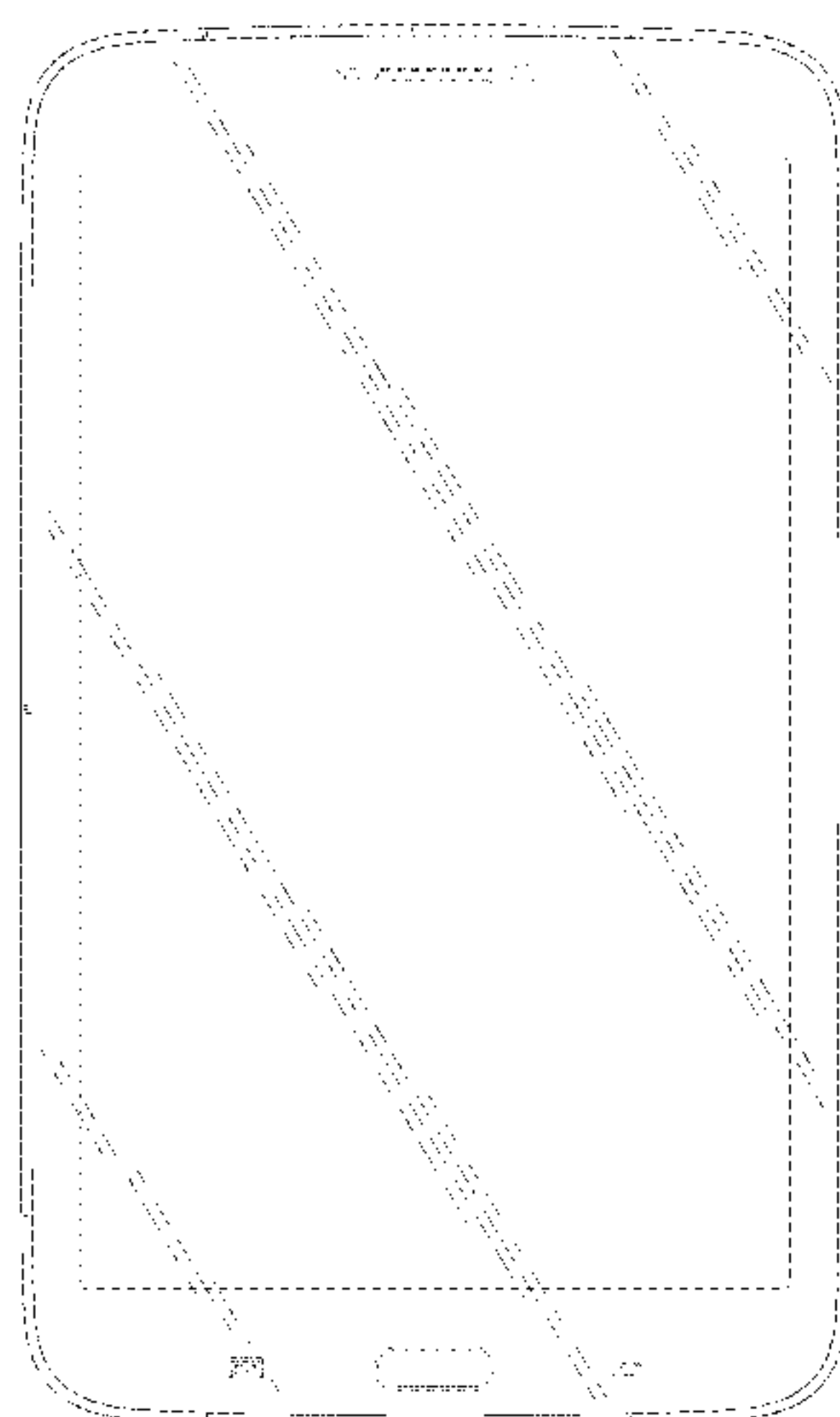
The ornamental design for a mobile terminal, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a mobile terminal showing my new design;

FIG. 6 is a top plan view thereof;

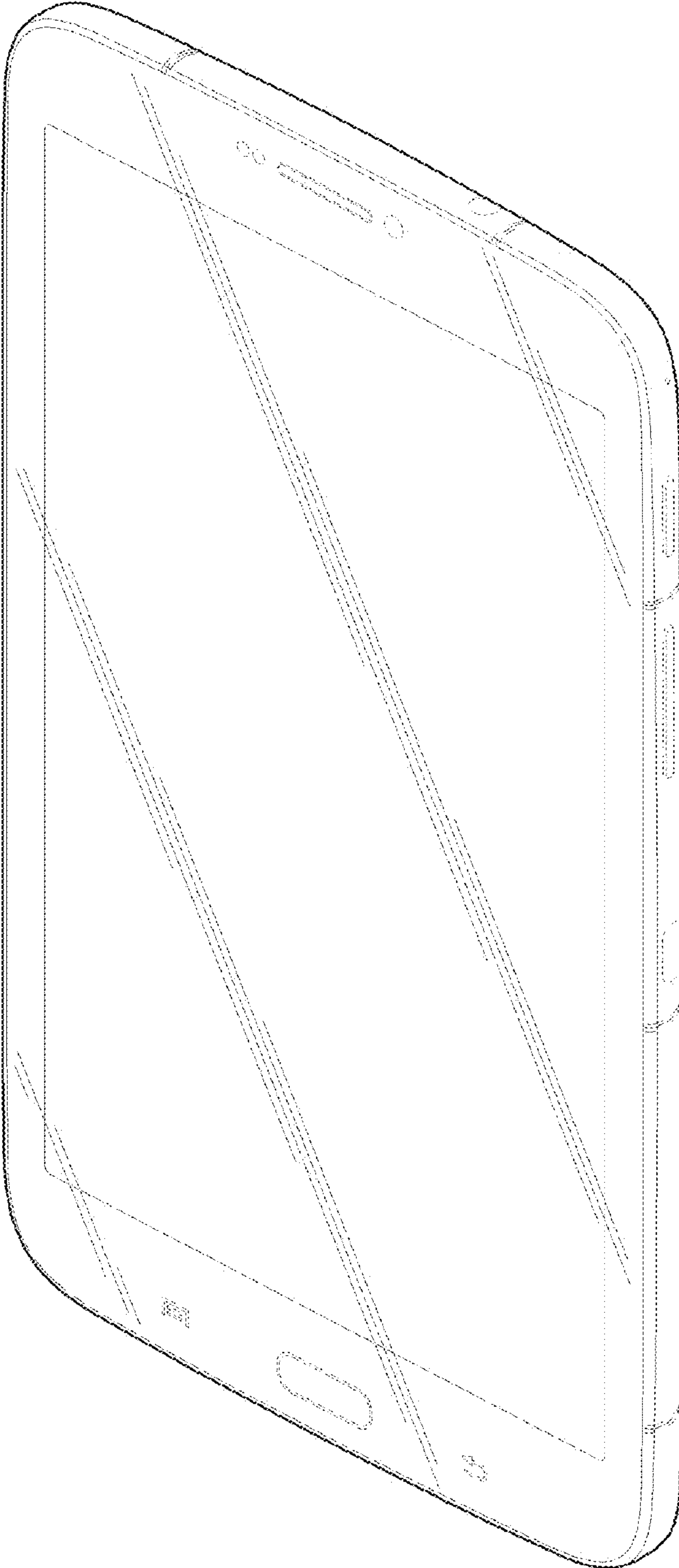

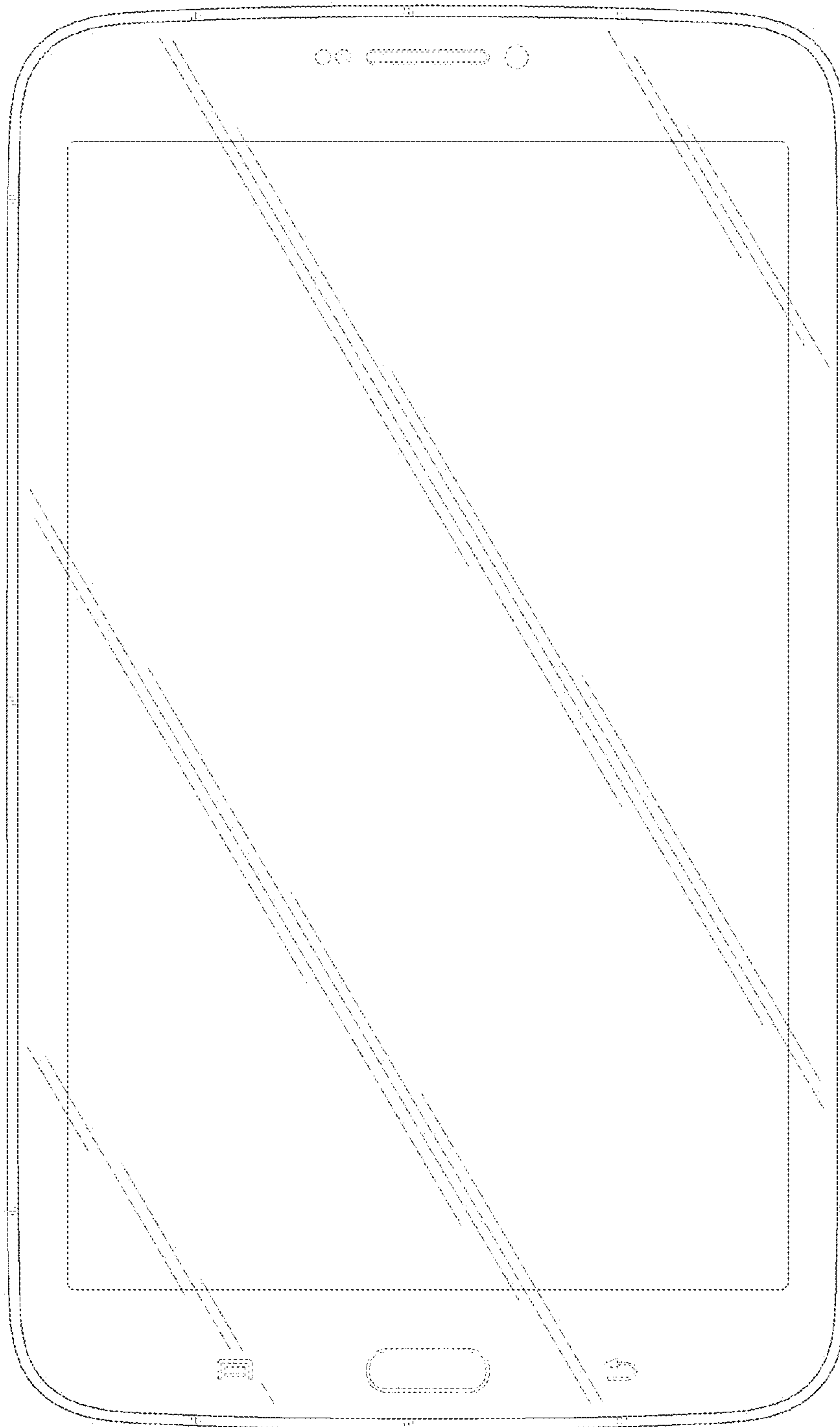

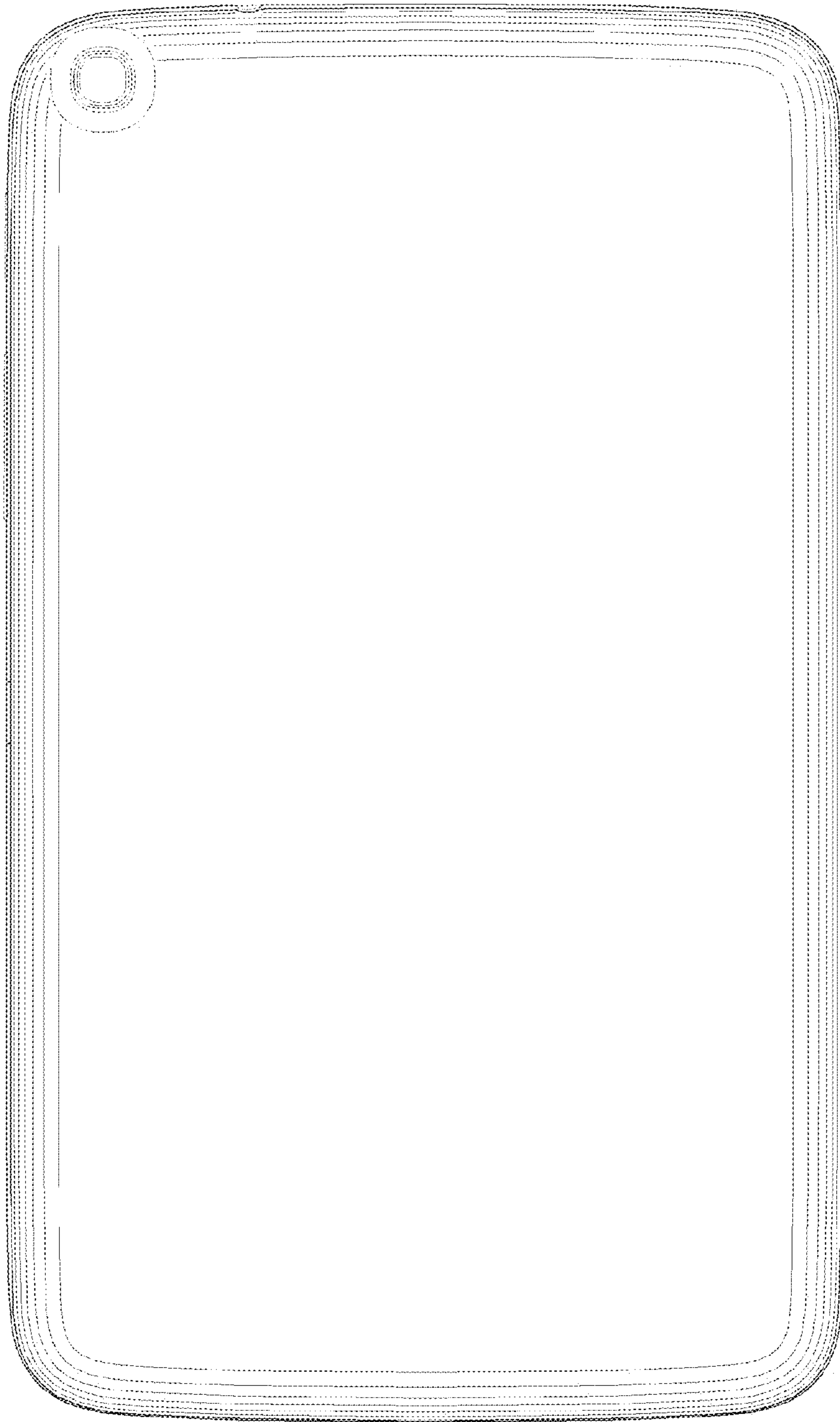

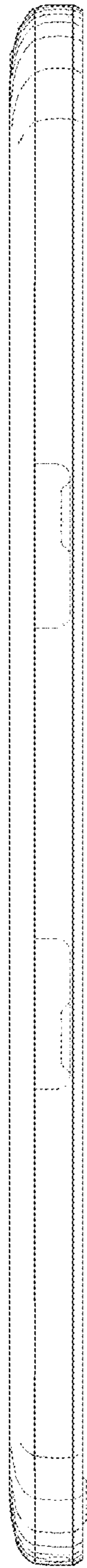

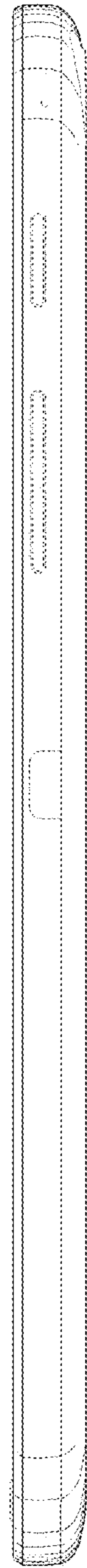

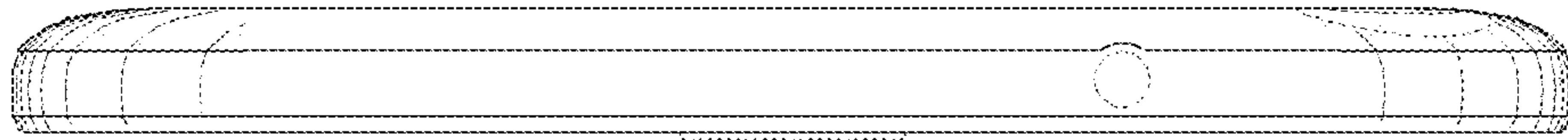

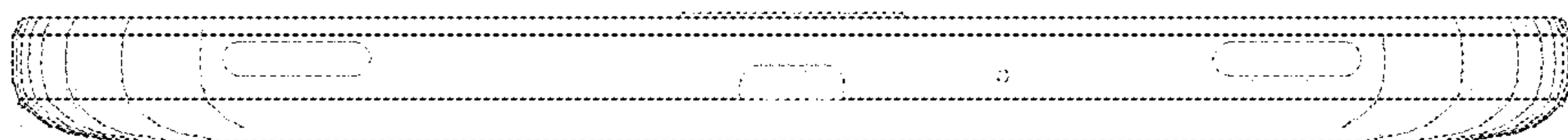
