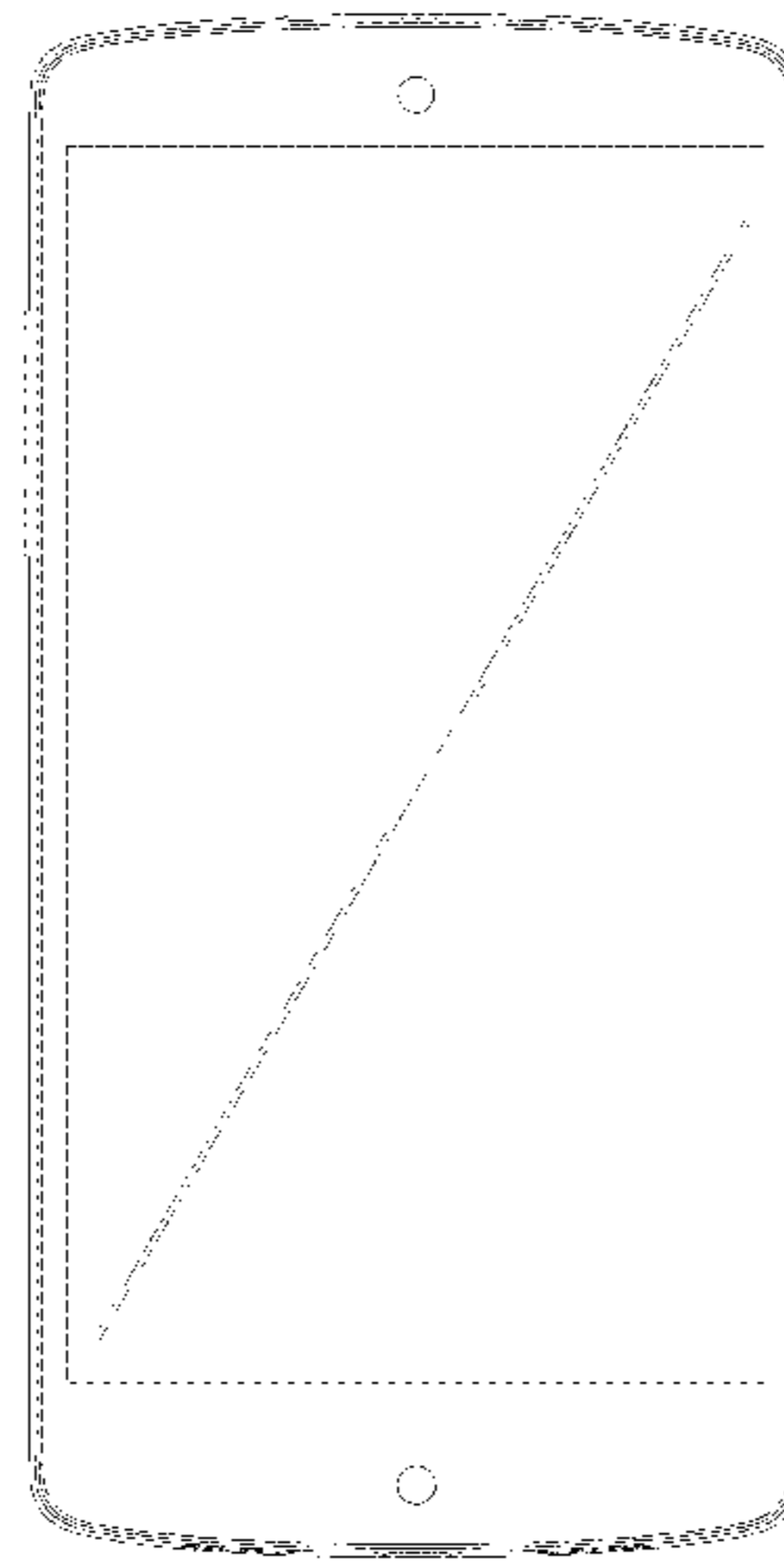
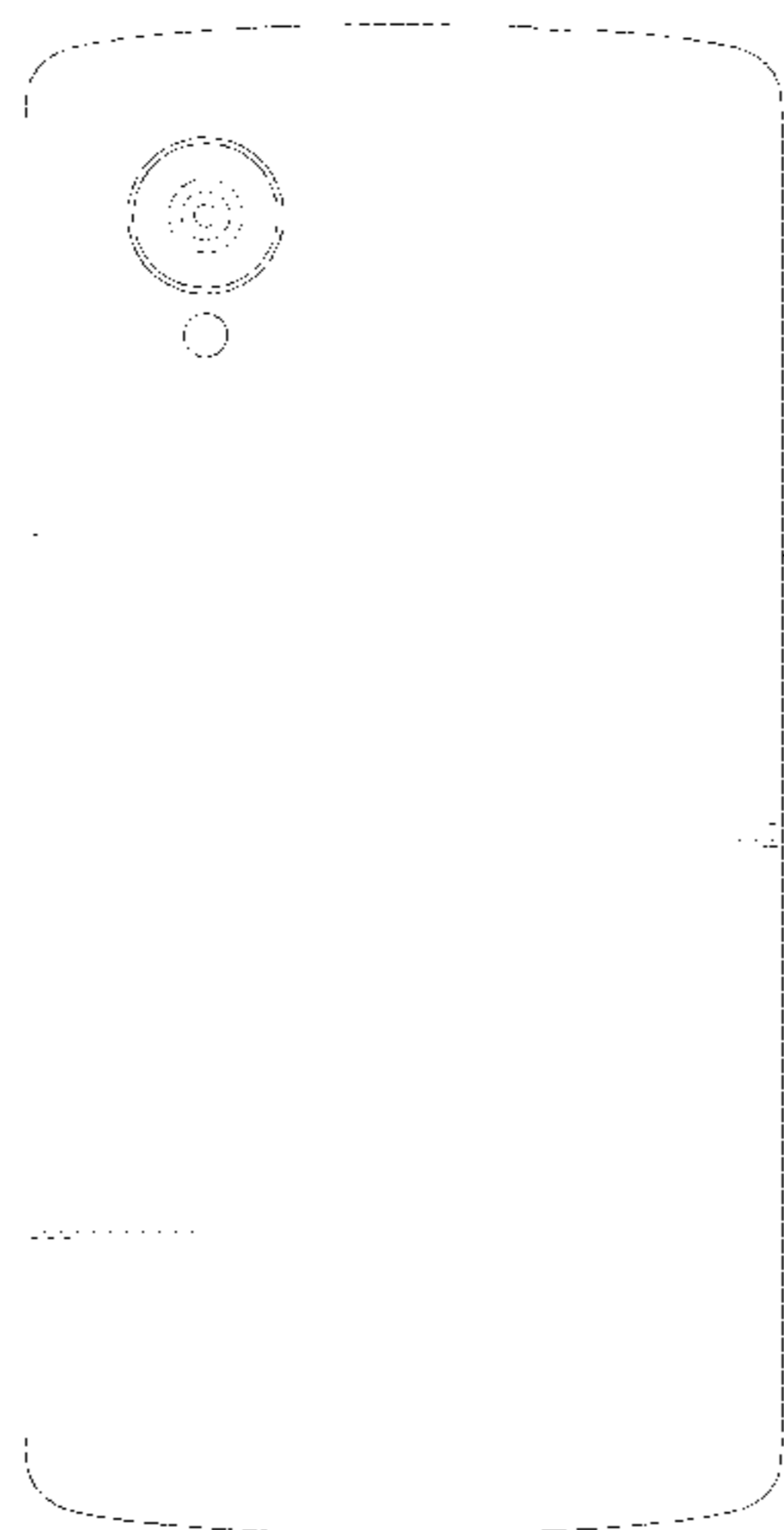
The ornamental design for a mobile phone, as shown and

**DESCRIPTION**

FIG. 1 is a perspective view of a mobile phone showing our  
new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof; and,  
FIG. 8 is a front view thereof showing the state that during  
operation, a circular indicator at the front-lower part has been  
lit.

The broken lines shown in the figures that are immediately  
adjacent to the shaded areas and define unshaded and unin-  
terrupted regions represent the bounds of the claim. The cir-  
cular broken line feature at the top shows environment that is  
superimposed on a continuous surface. The broken lines form  
no part of the claimed design.

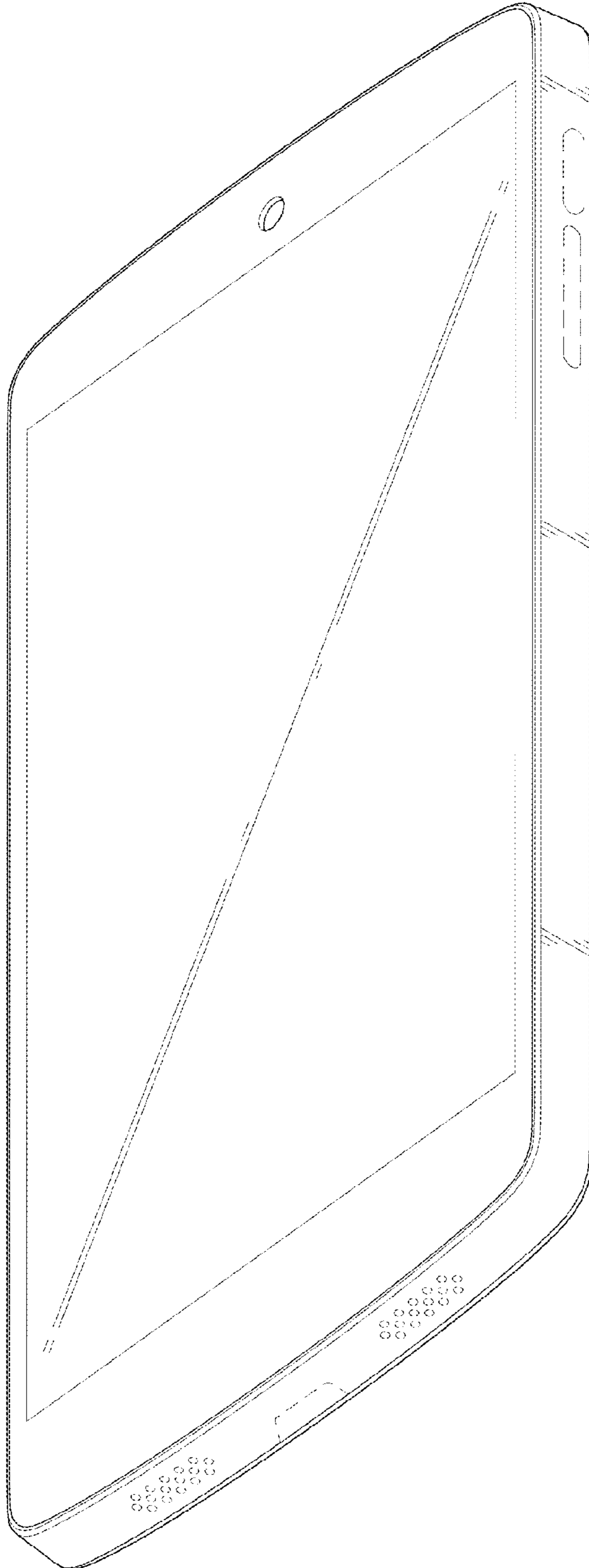

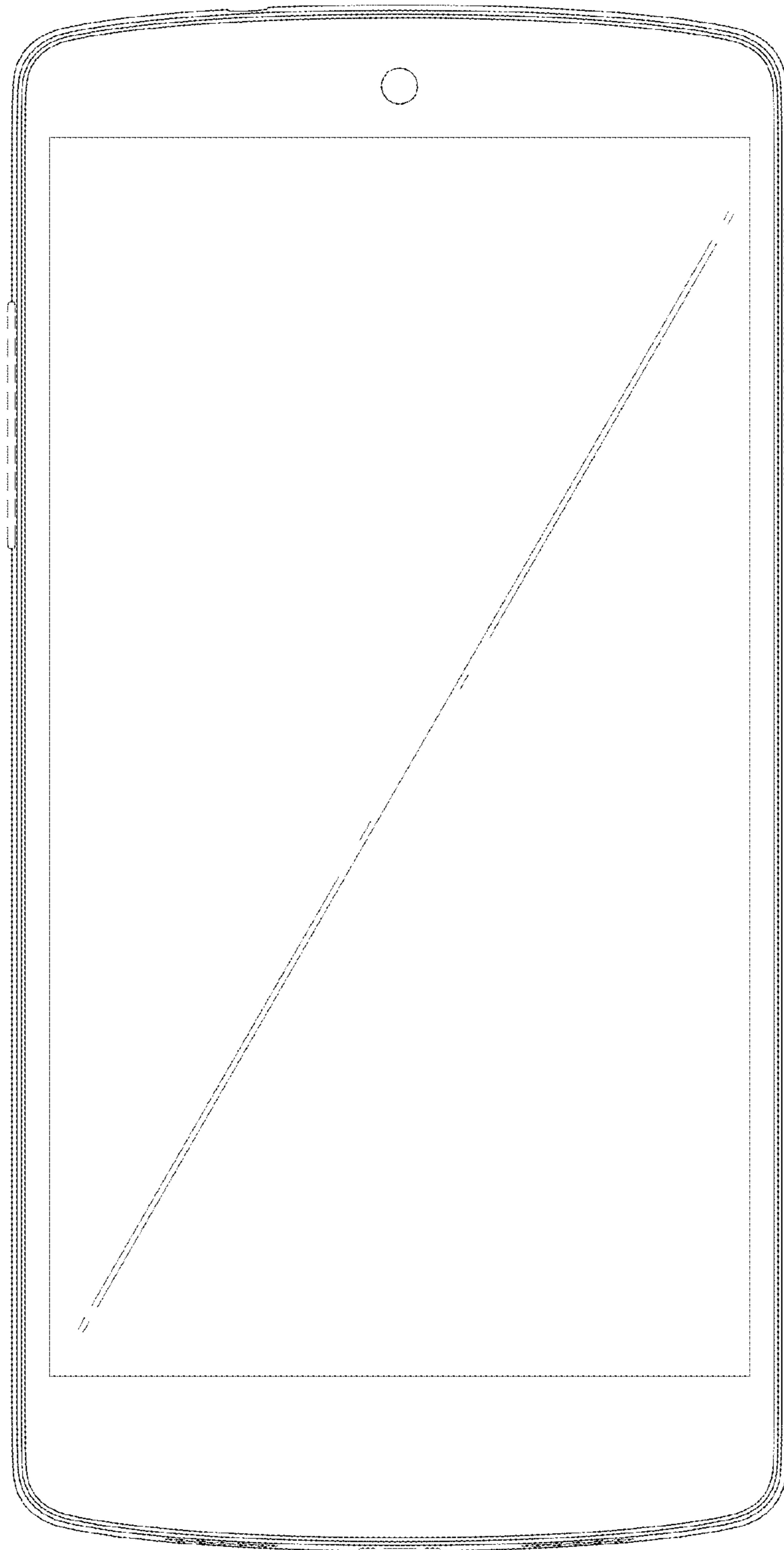

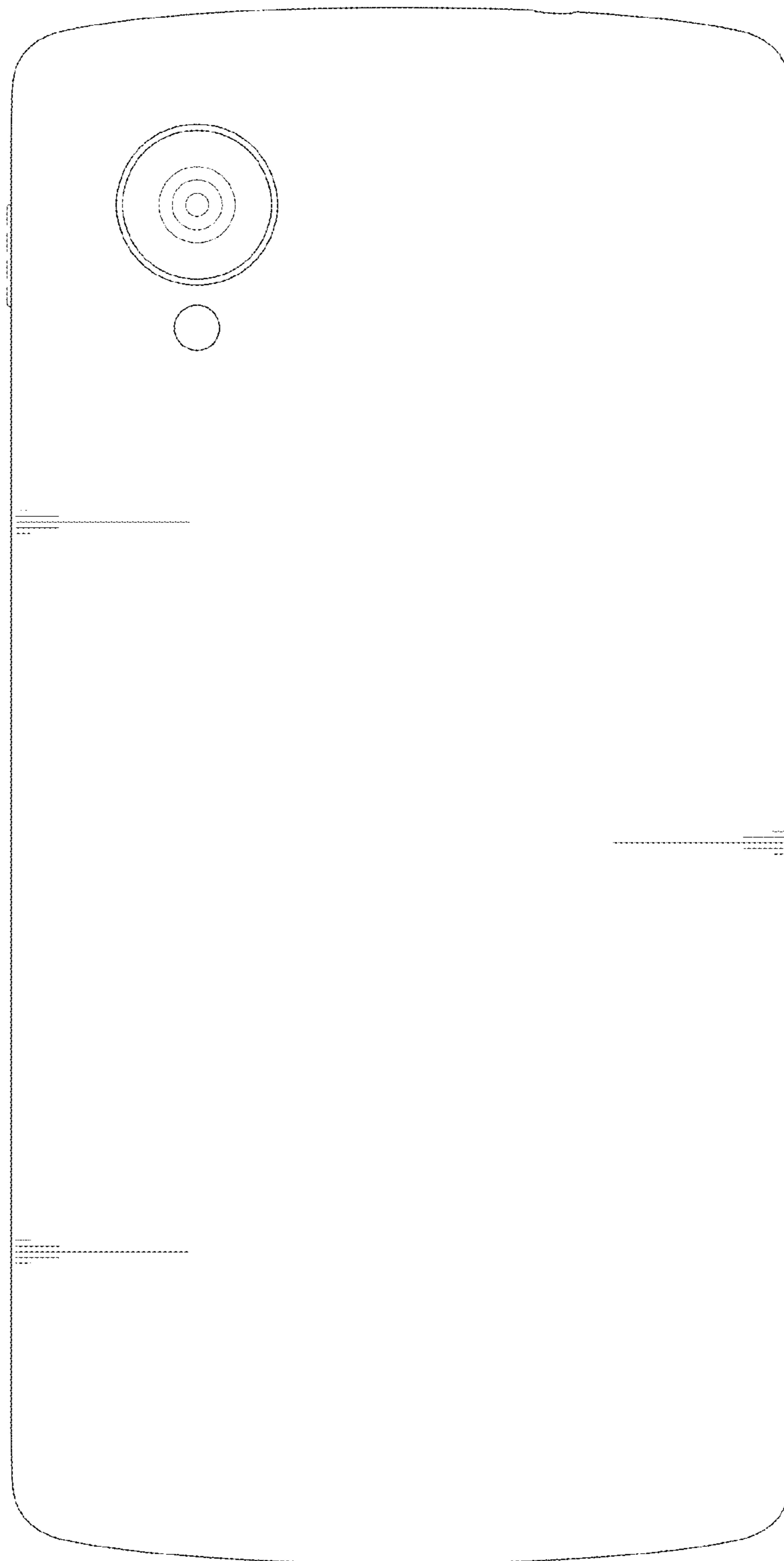

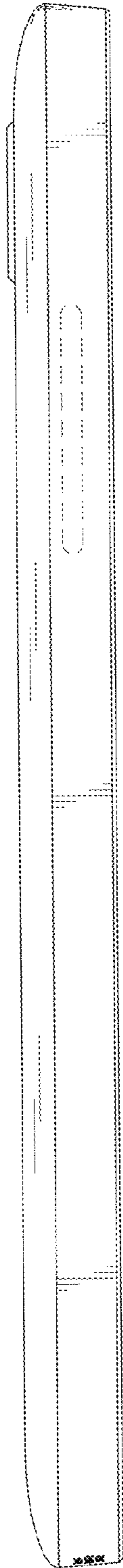

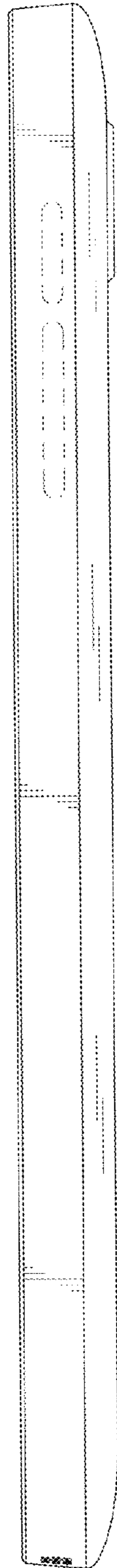

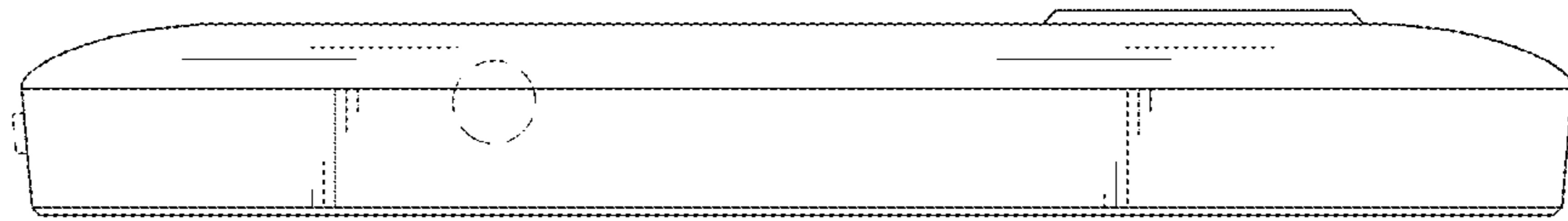

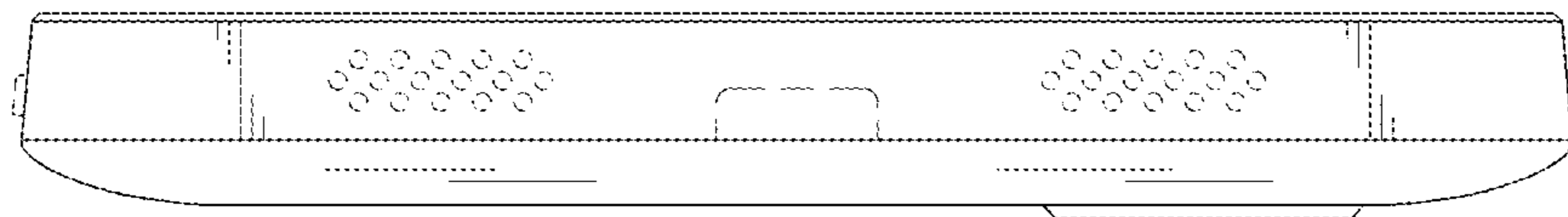
