FIG. 4 is a bottom plan view thereof;

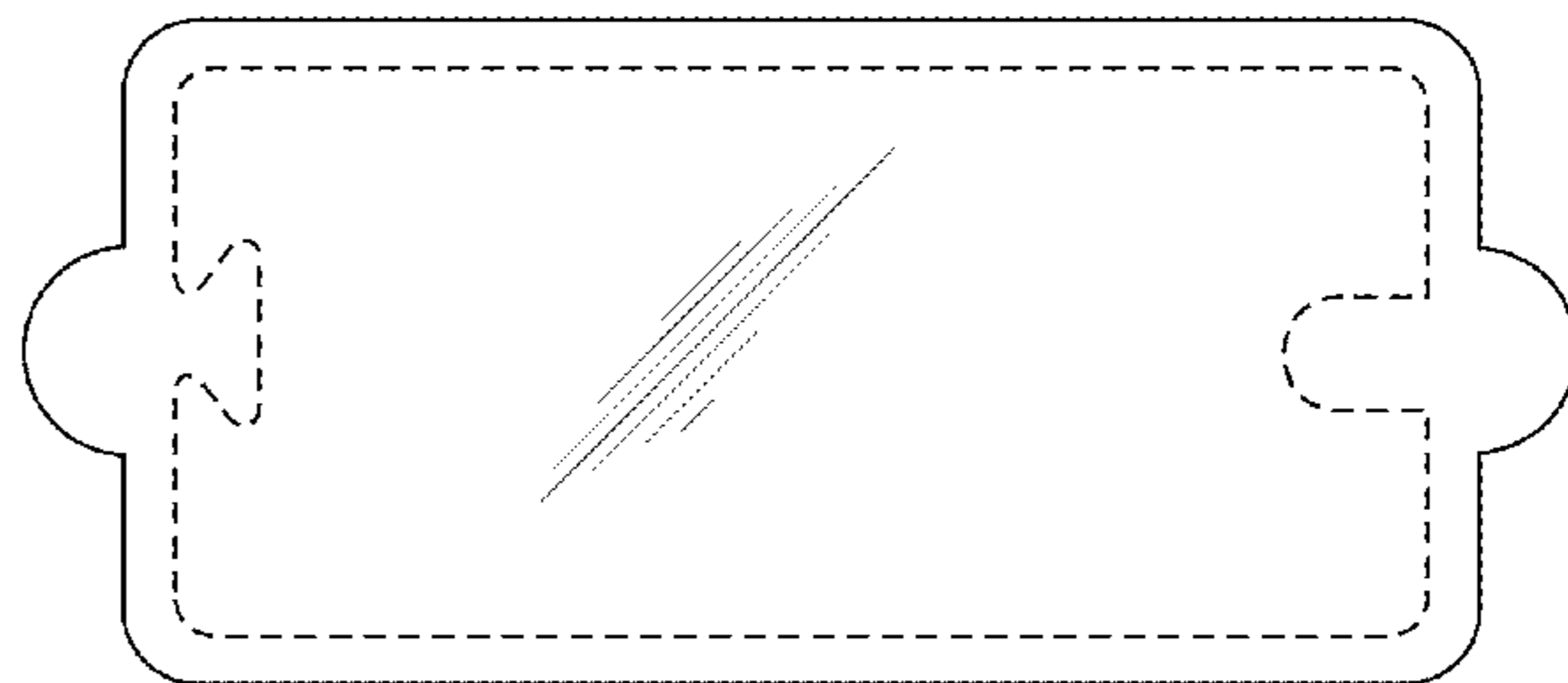
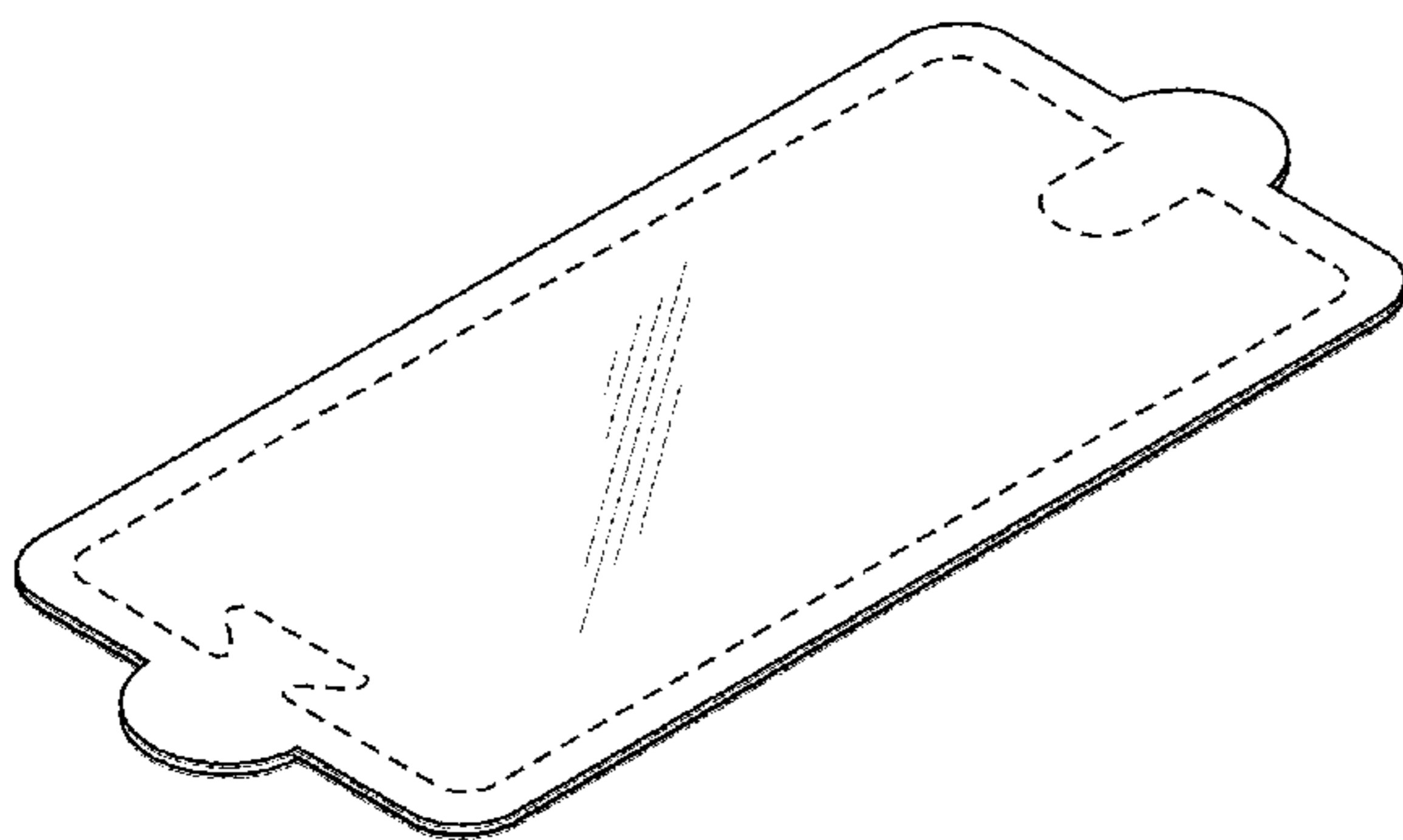
FIG. 5 is left side elevation view thereof;

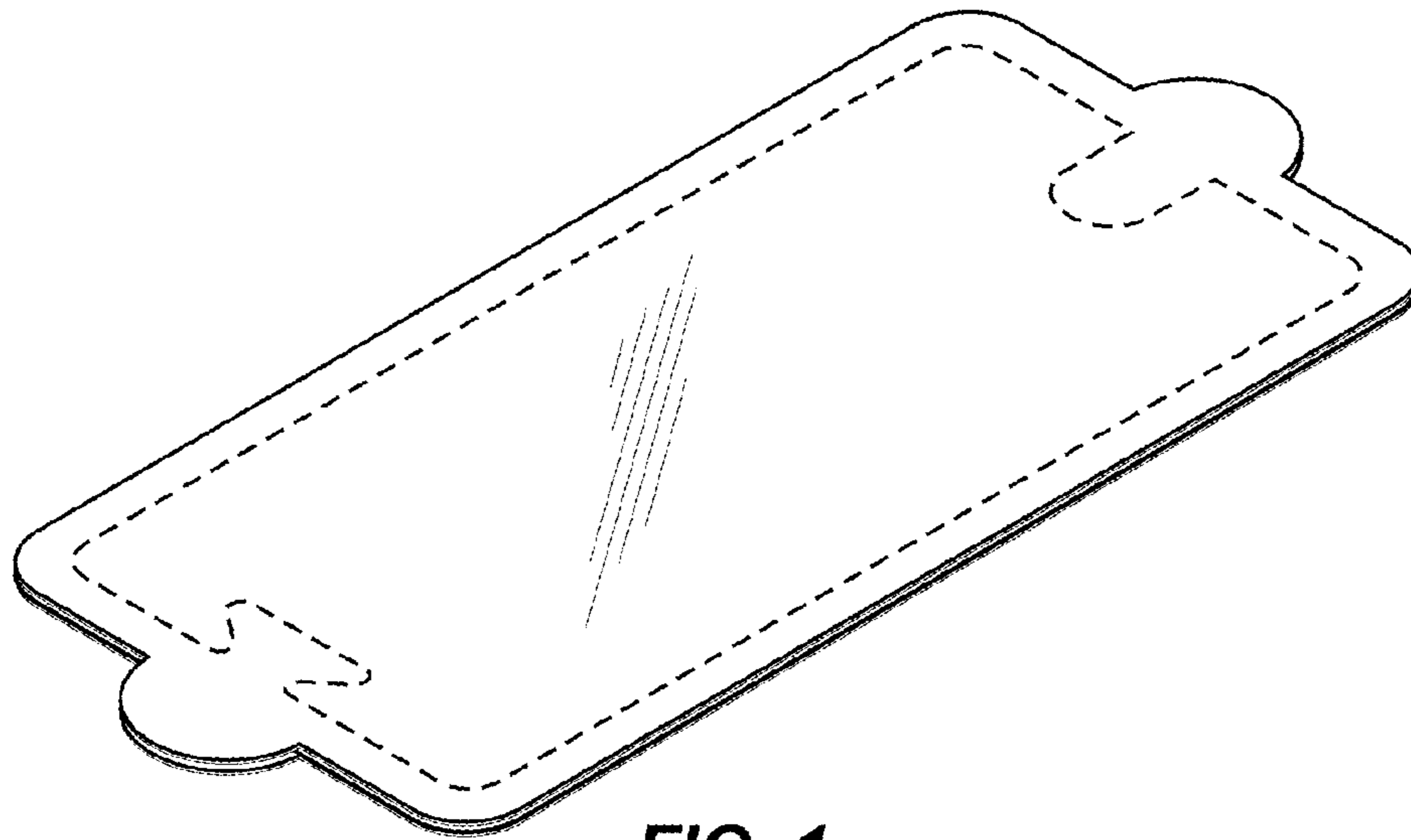
FIG. 6 is a right side elevation view thereof; and,

FIG. 7 is rear elevation view thereof.

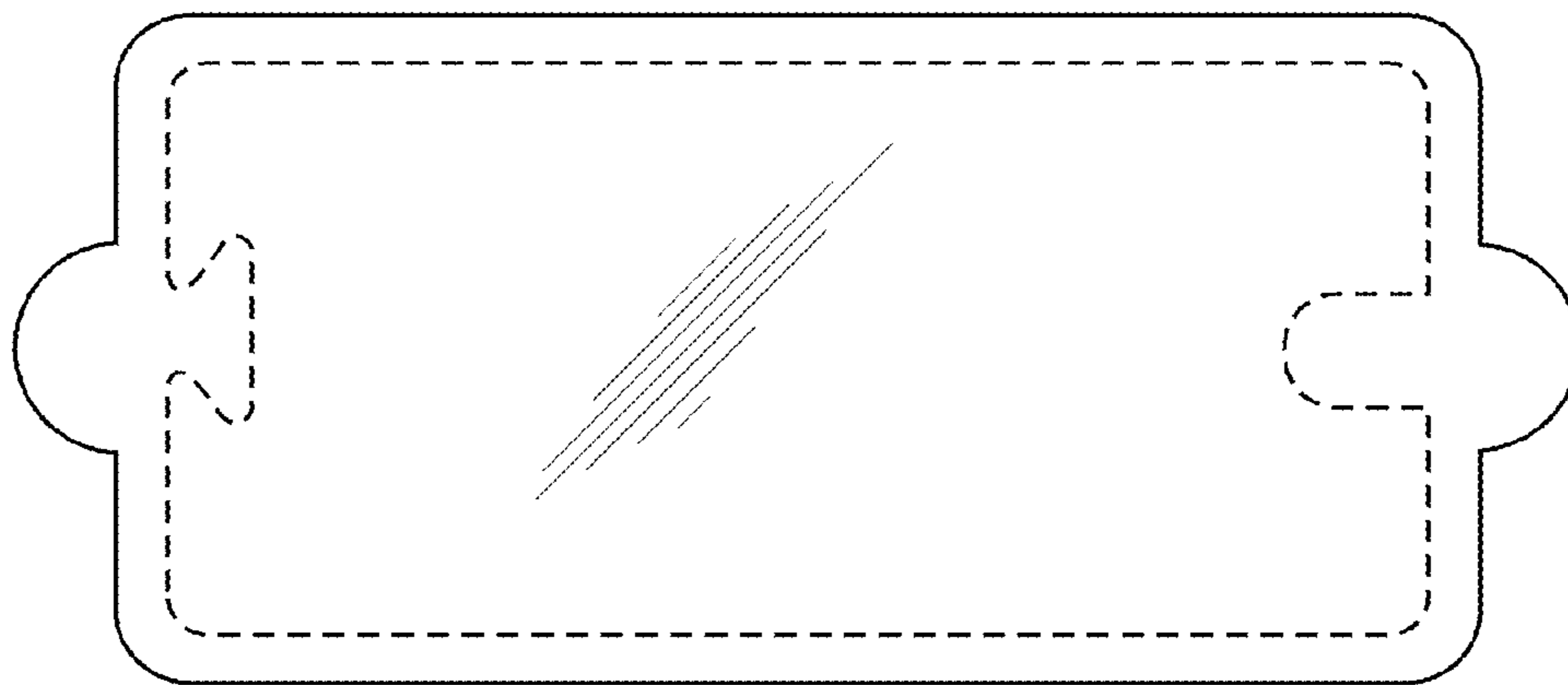

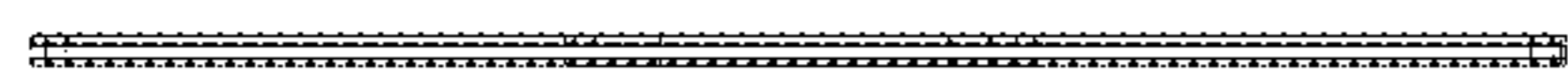




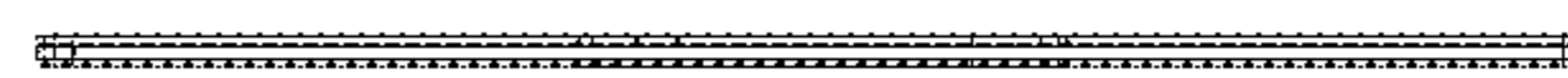

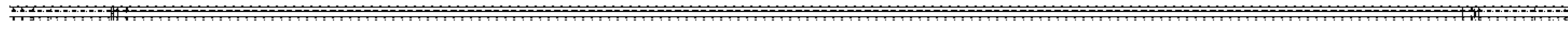

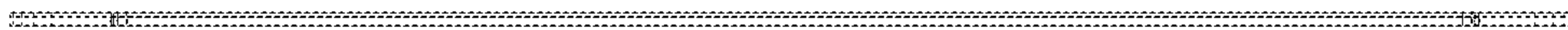

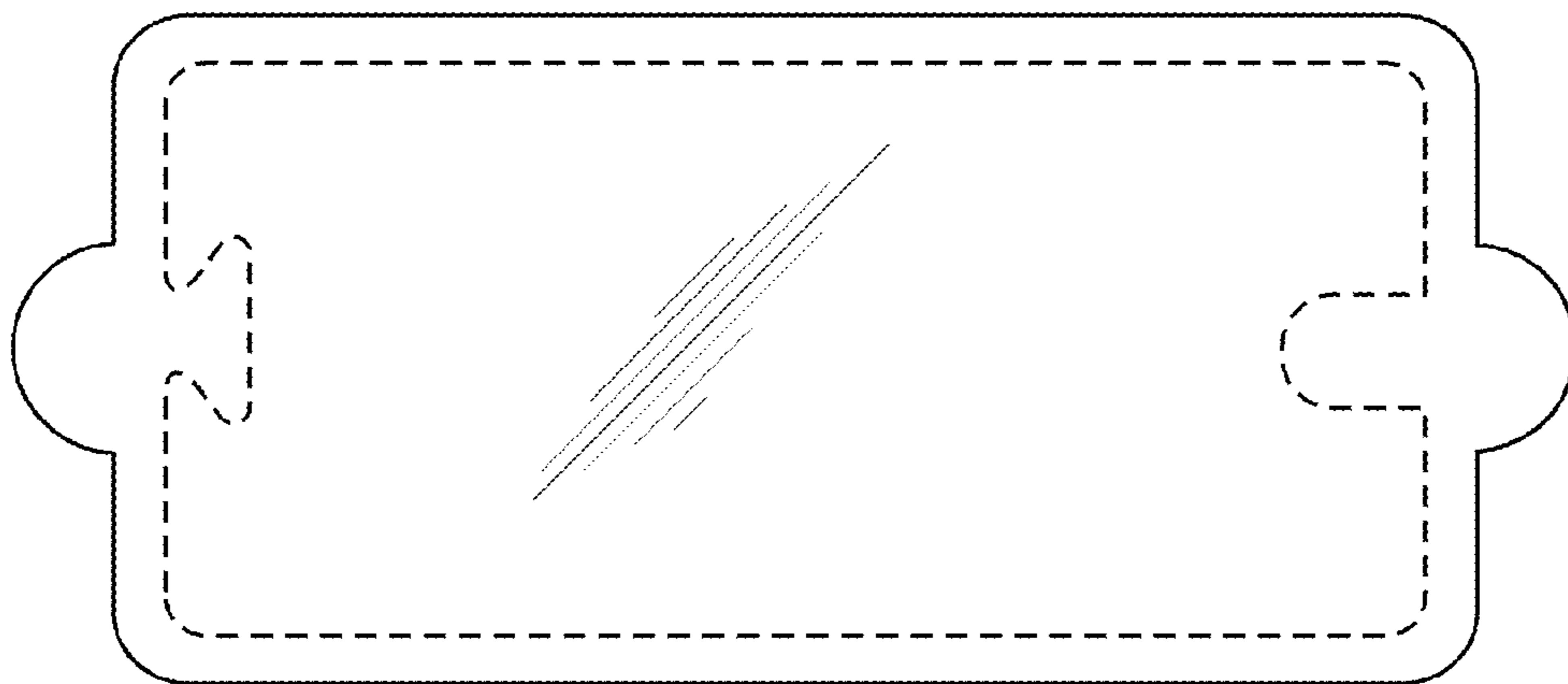
