I claim the ornamental design for a keyboard for tablet computer, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a keyboard for tablet computer showing my new design;  
FIG. 2 is a front view thereof;

FIG. 4 is a left-side view thereof;

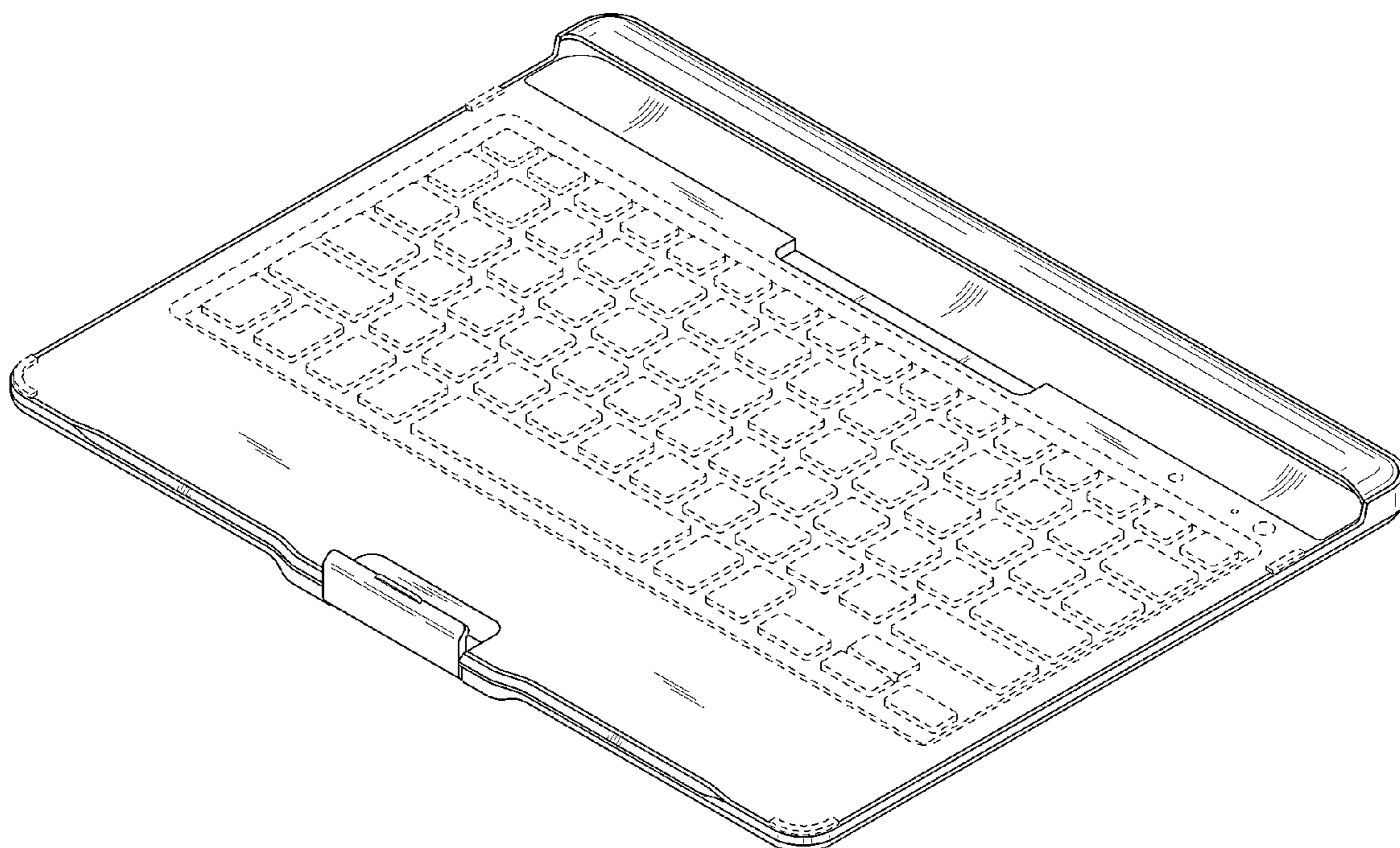

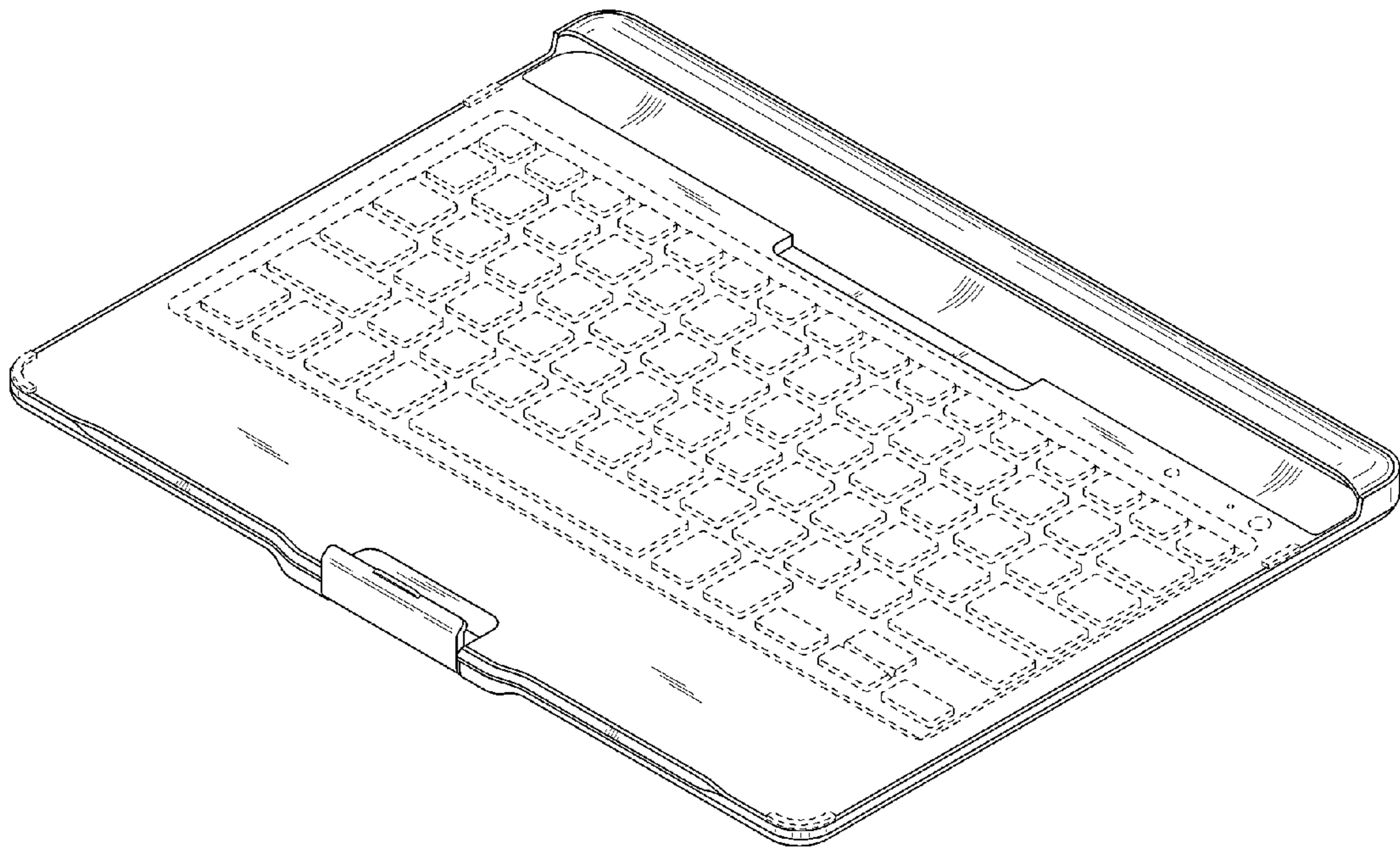

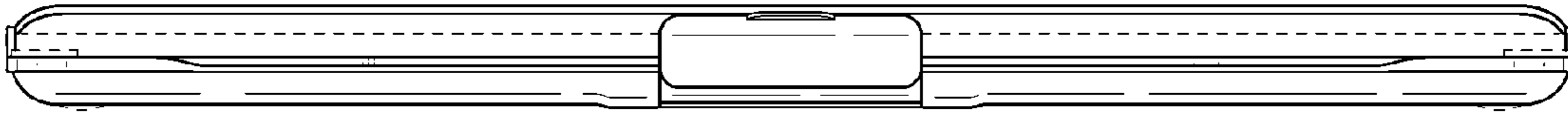

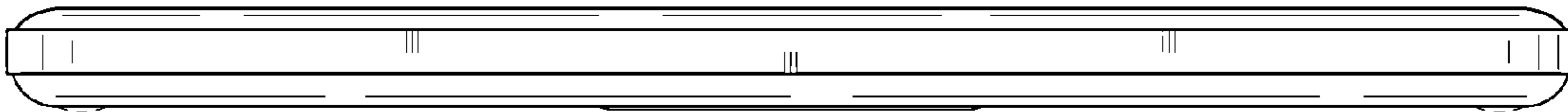

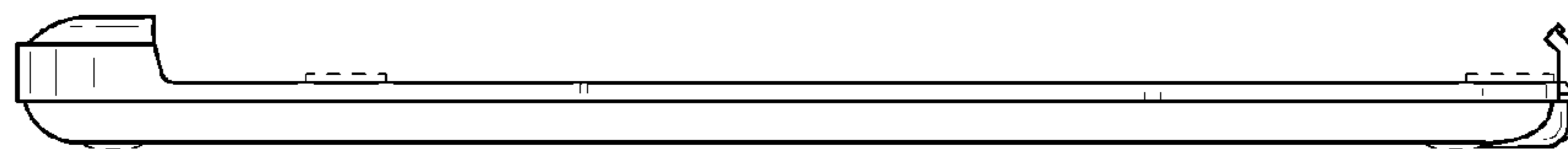

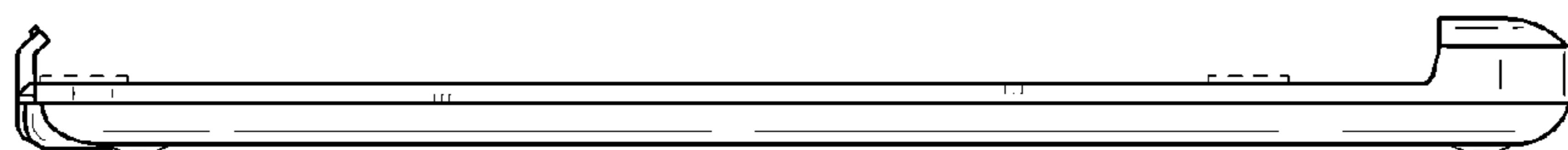

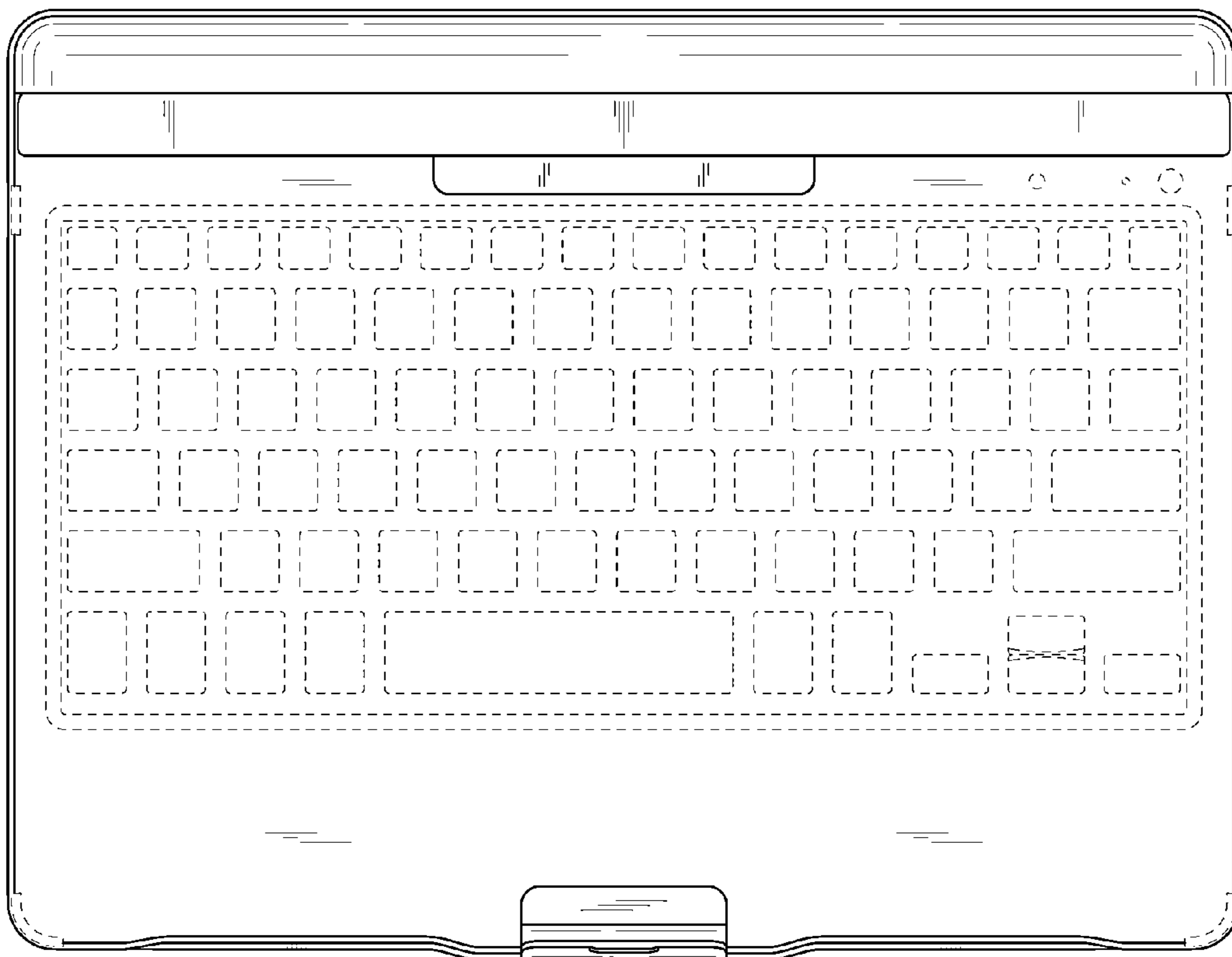
