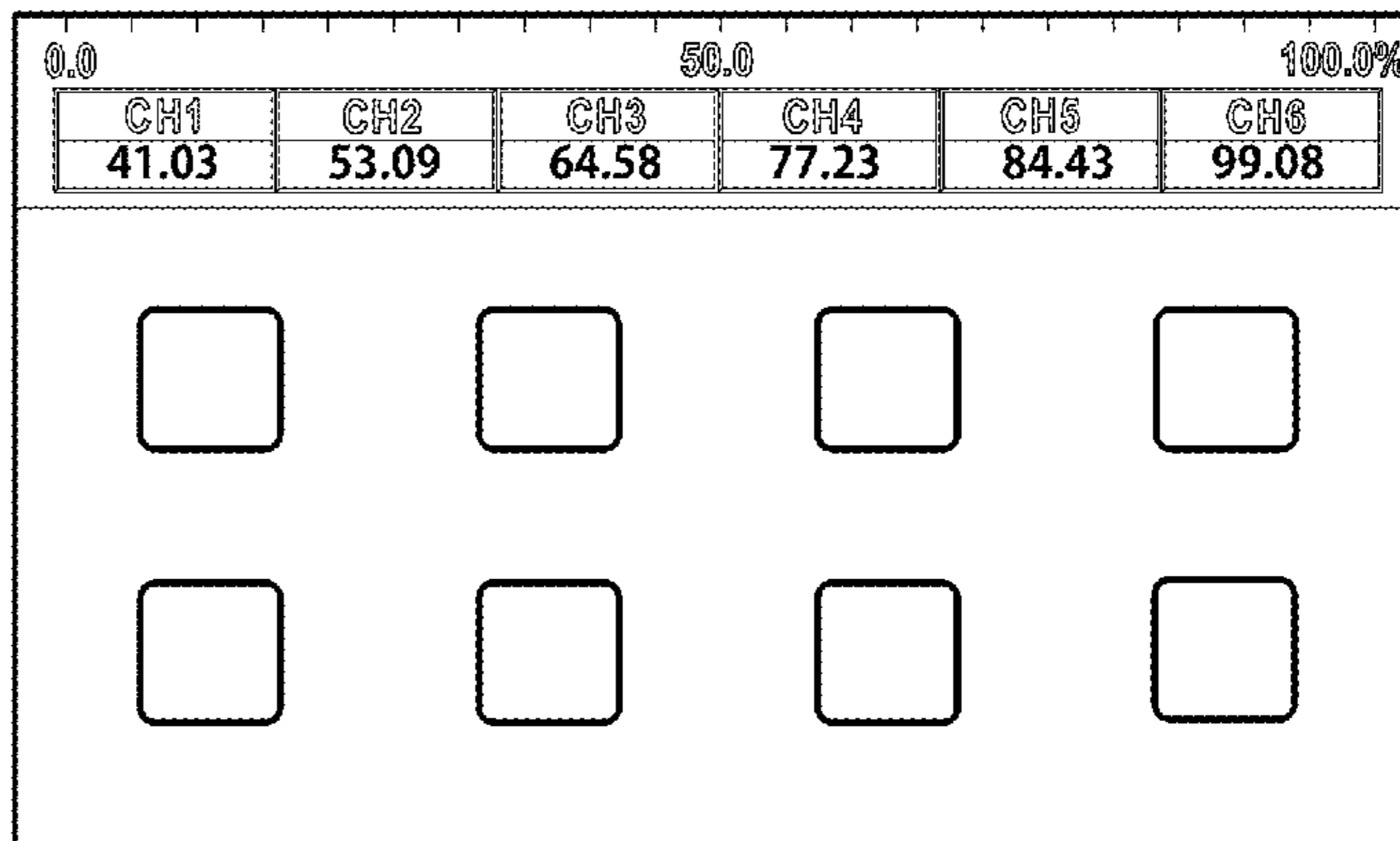
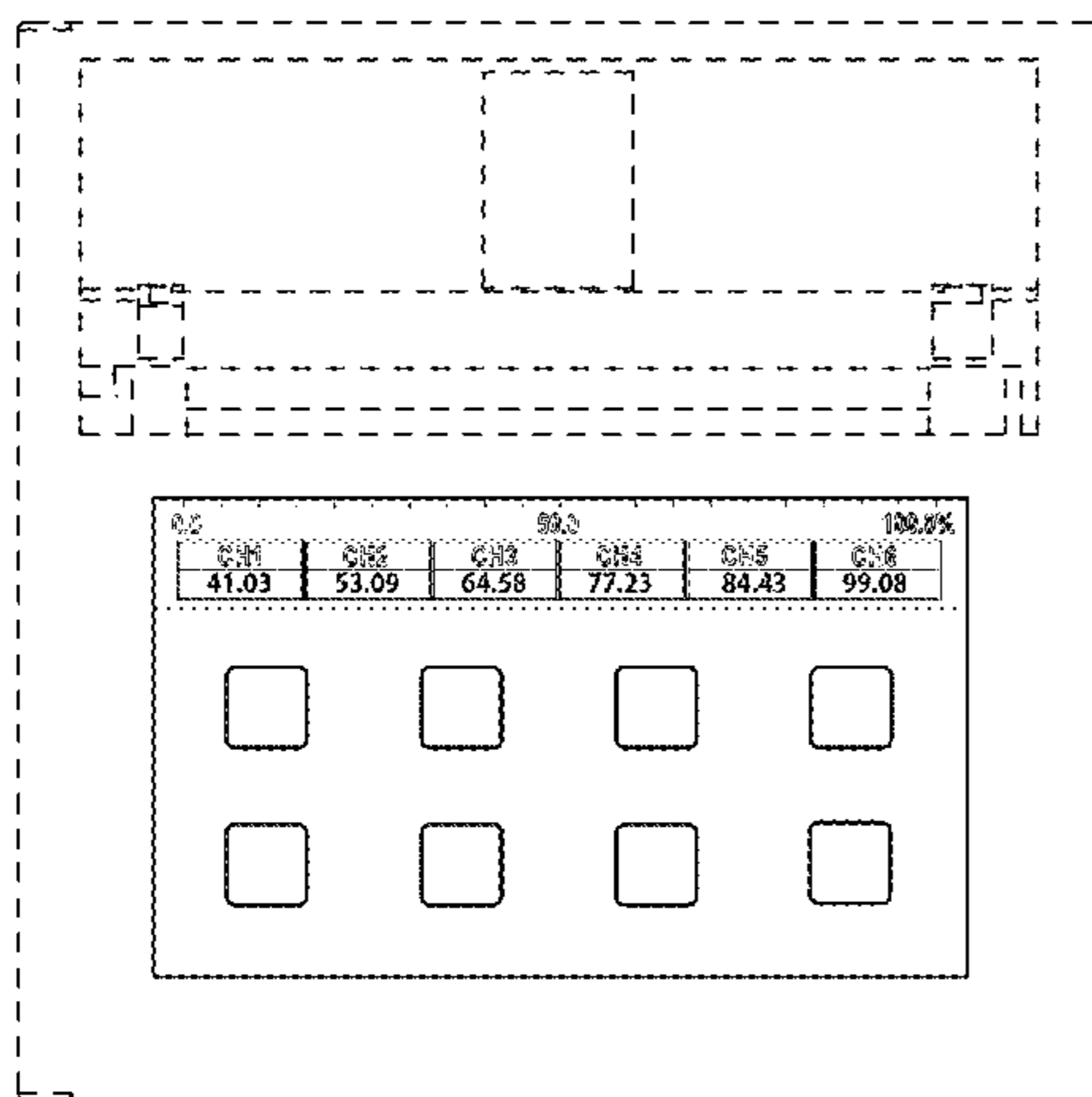
The ornamental design for a portion of a recorder display panel with graphical user interface, as shown and described.

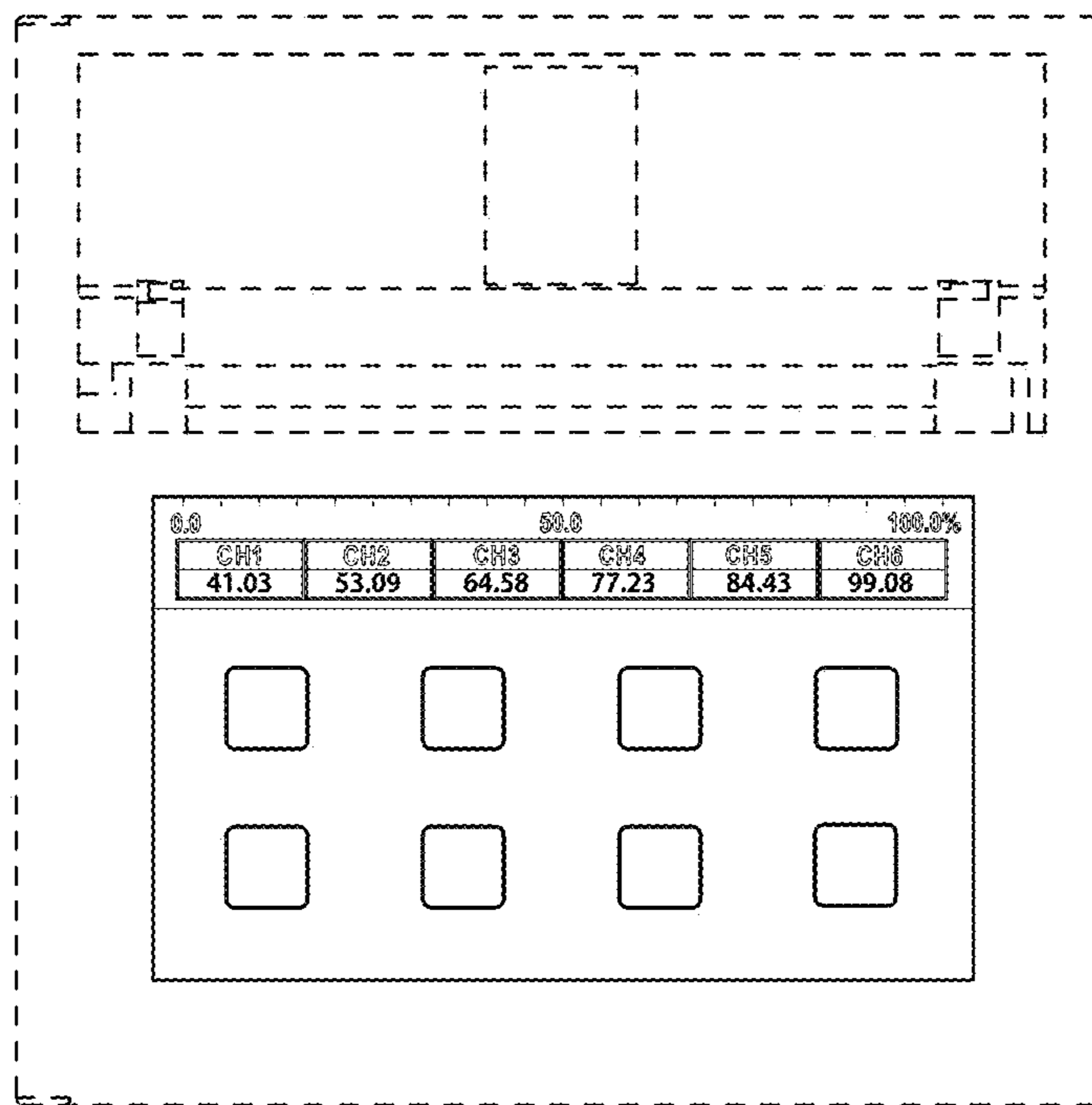

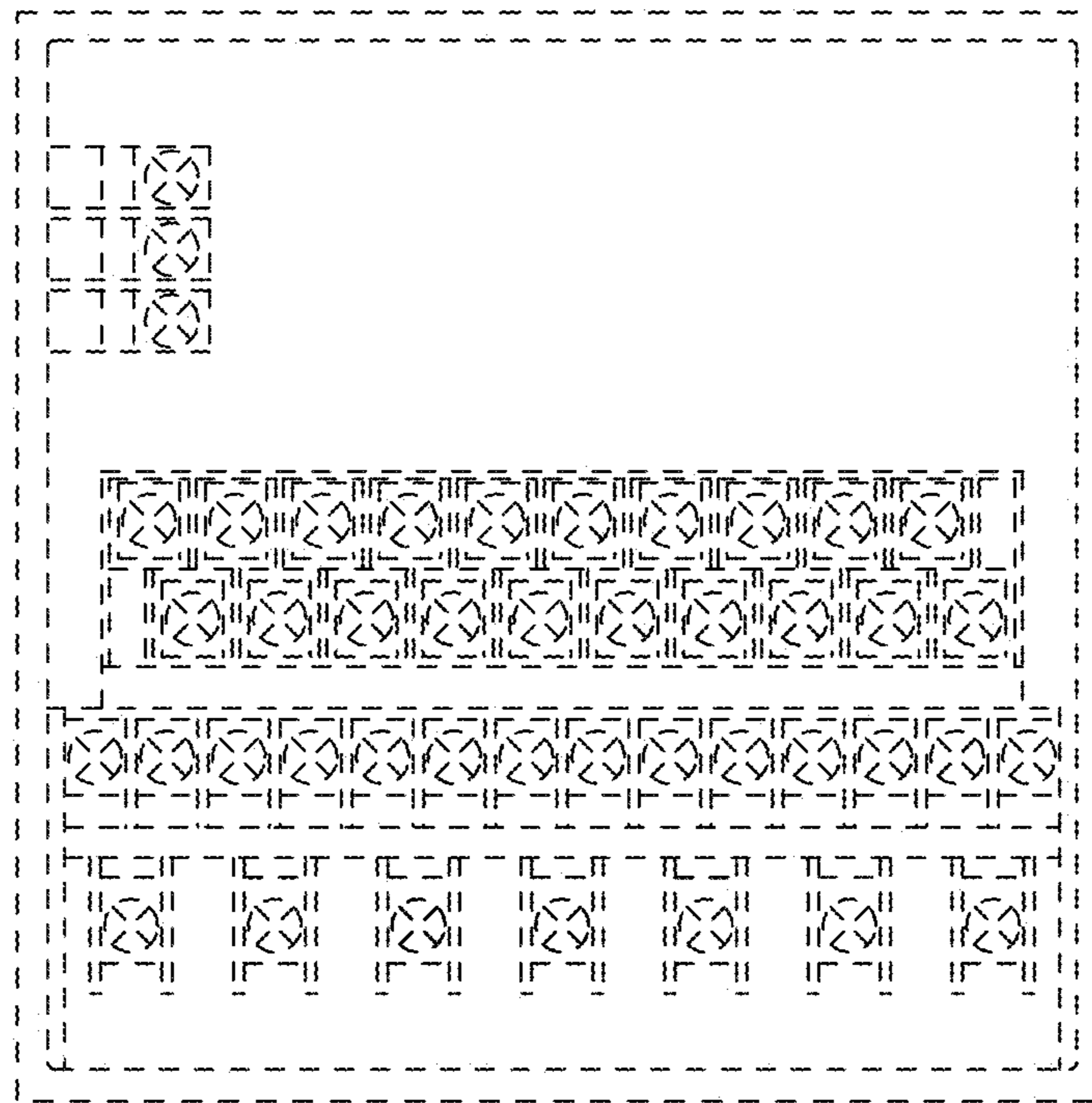

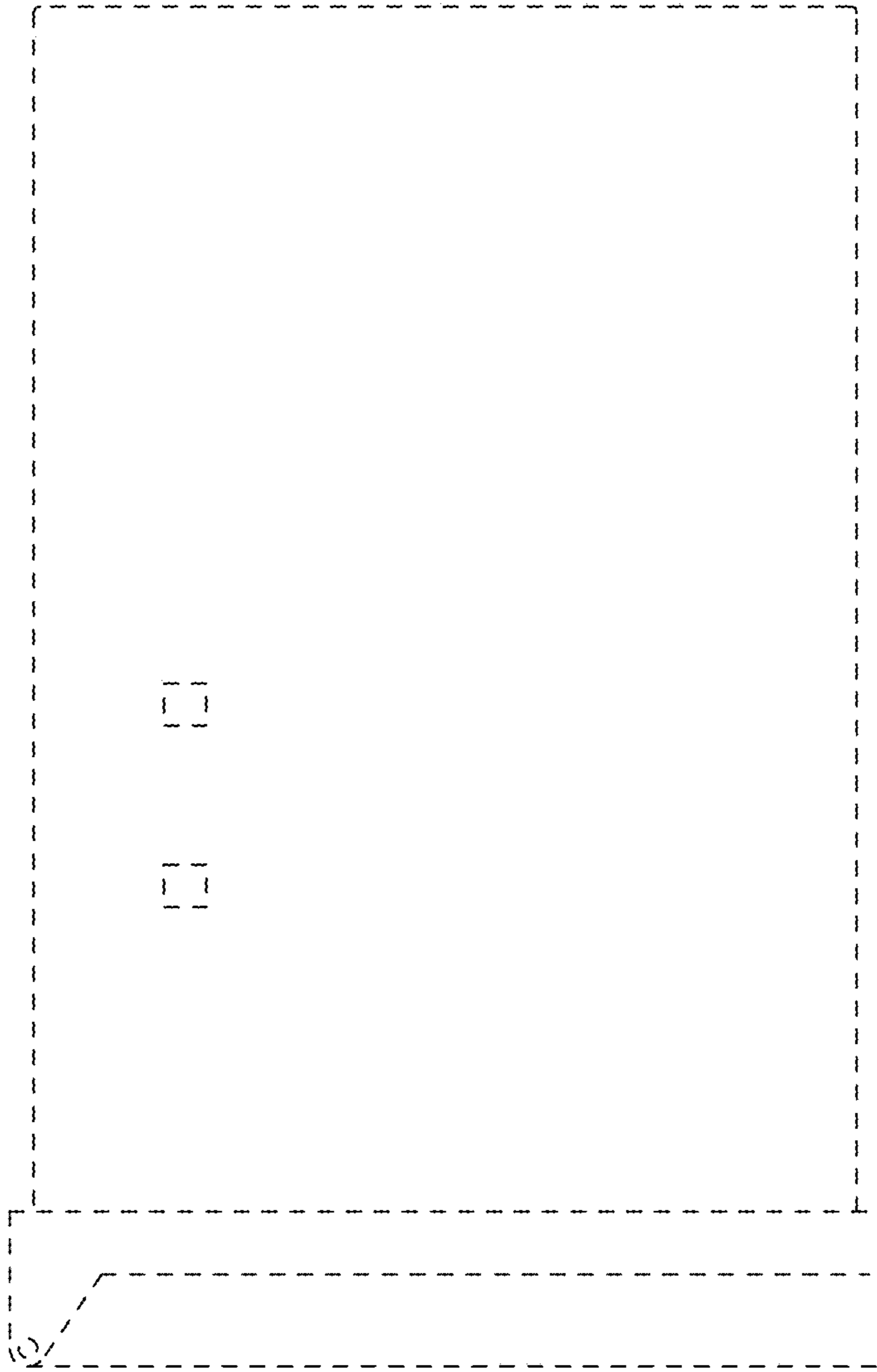

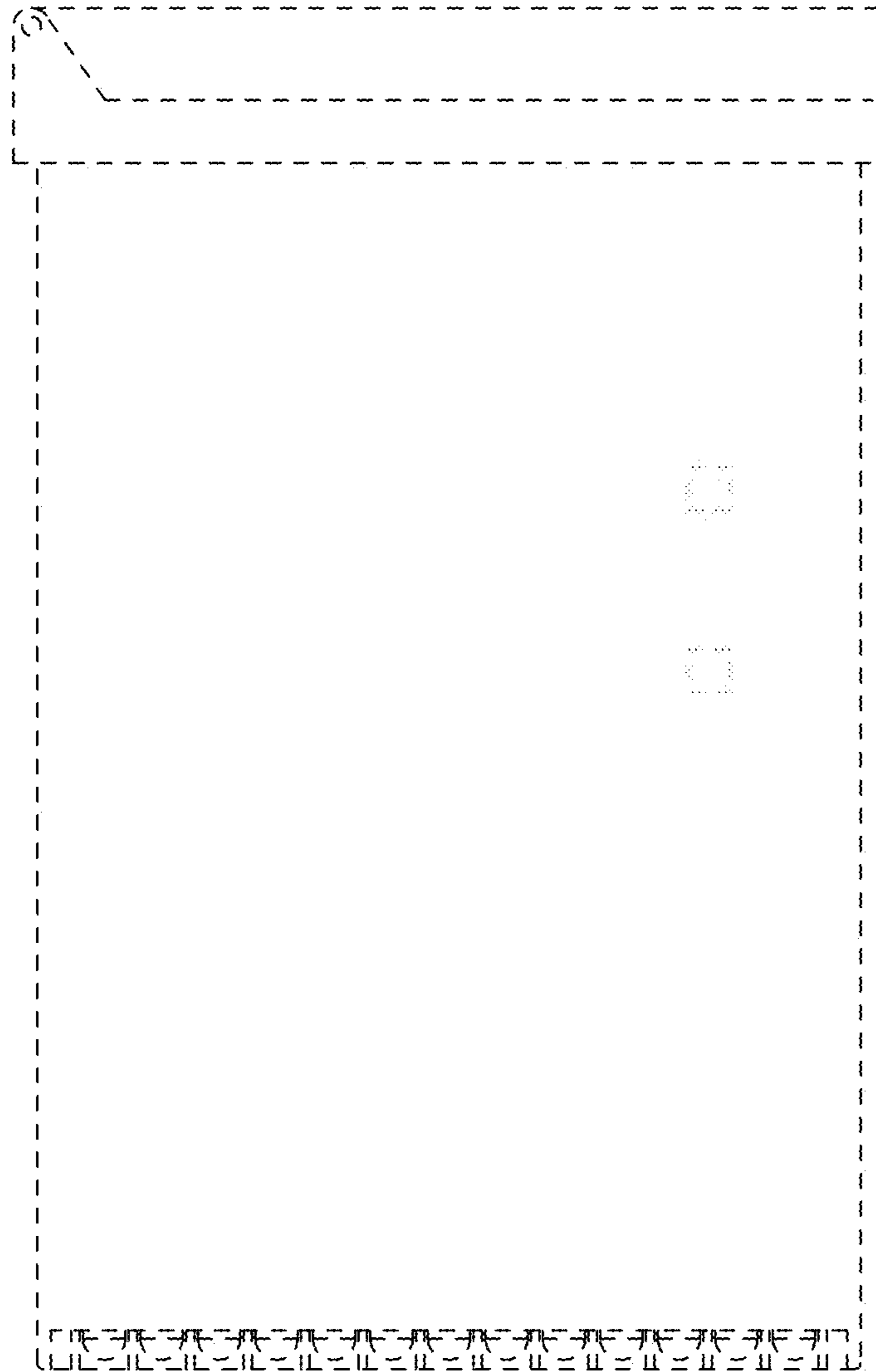

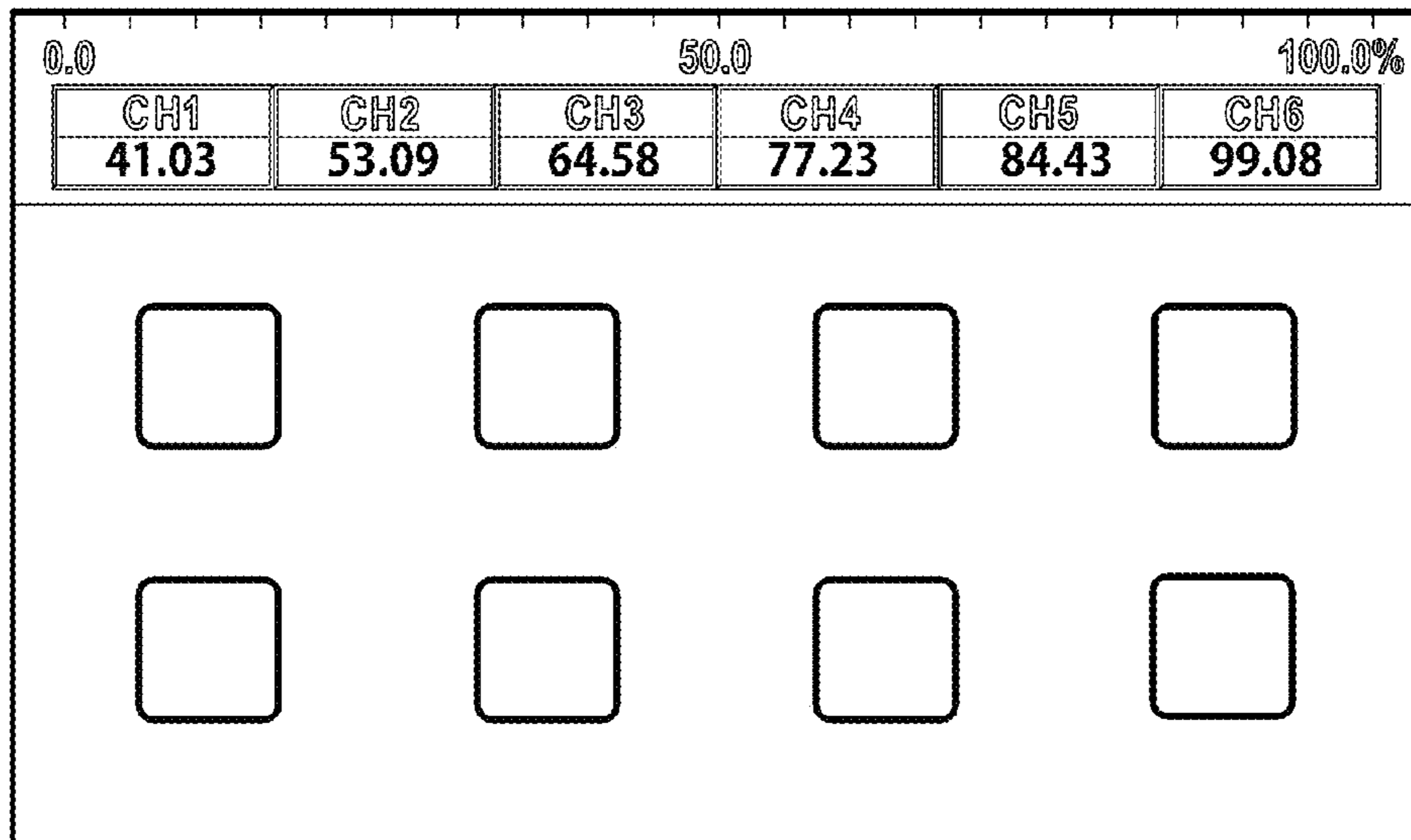
