(57) **CLAIM**

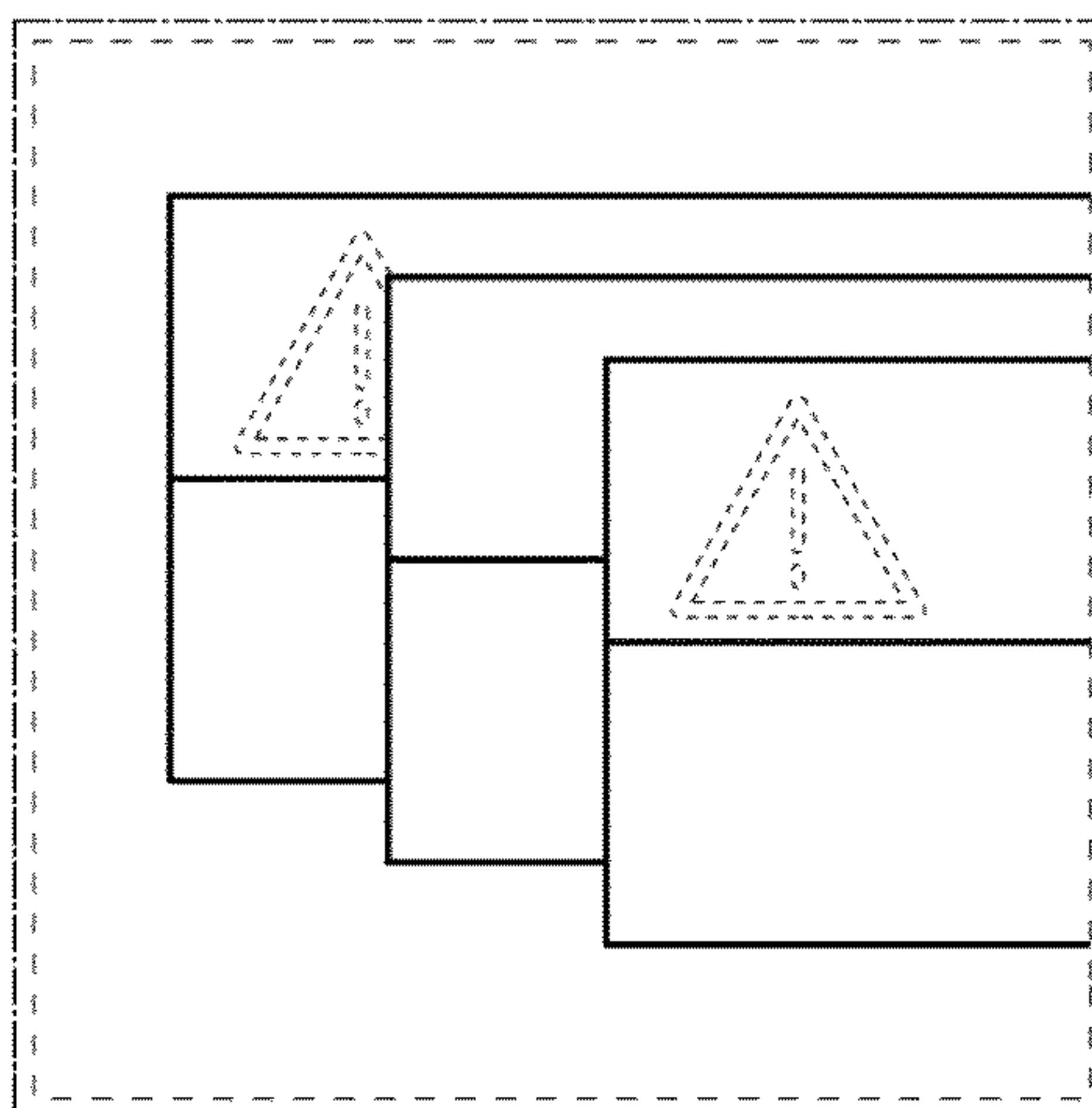
The ornamental design for an display screen or portion thereof with icon, as shown and described.
