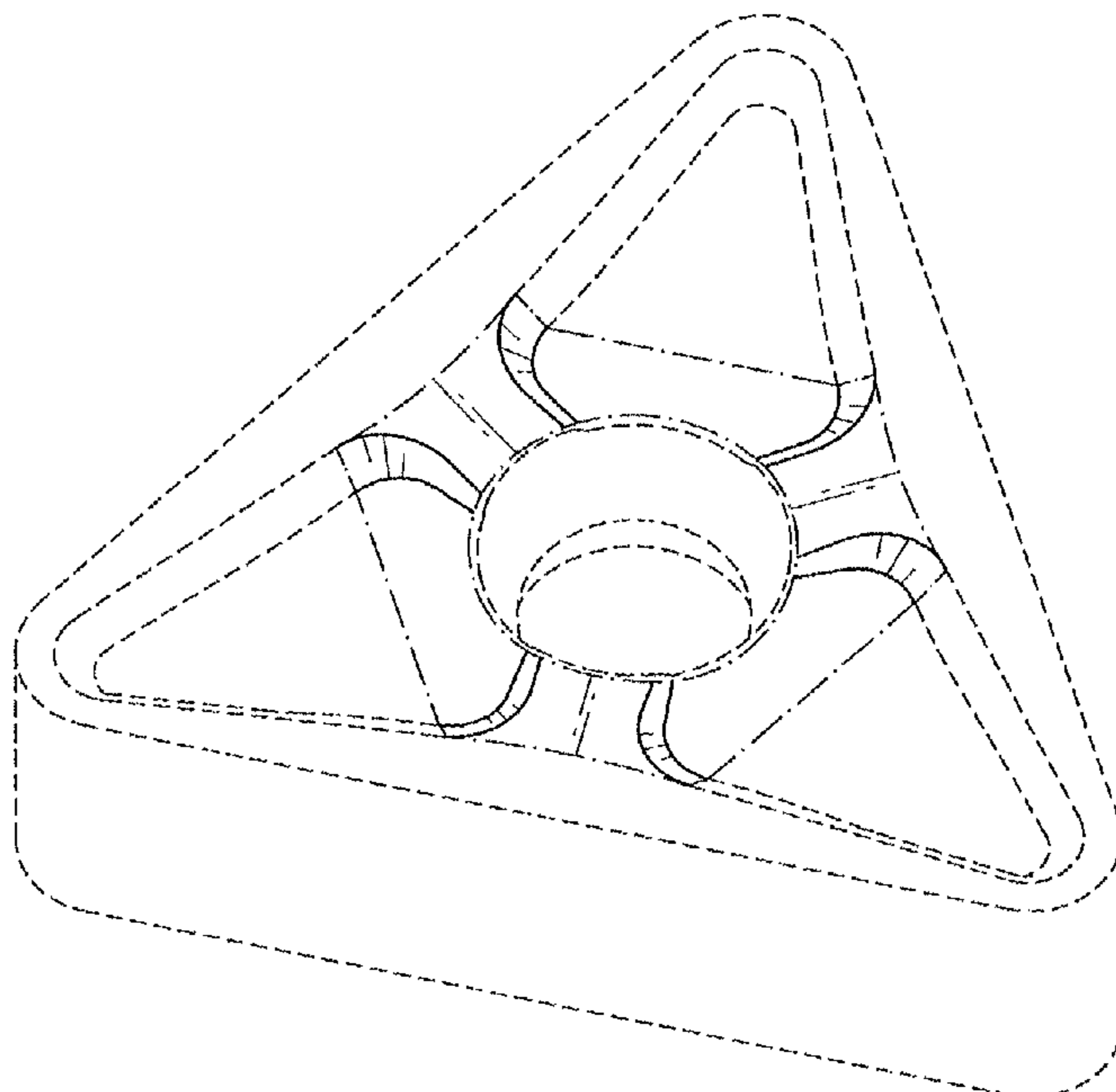
(57) **CLAIM**

The ornamental design for a cutting insert, as shown and described.

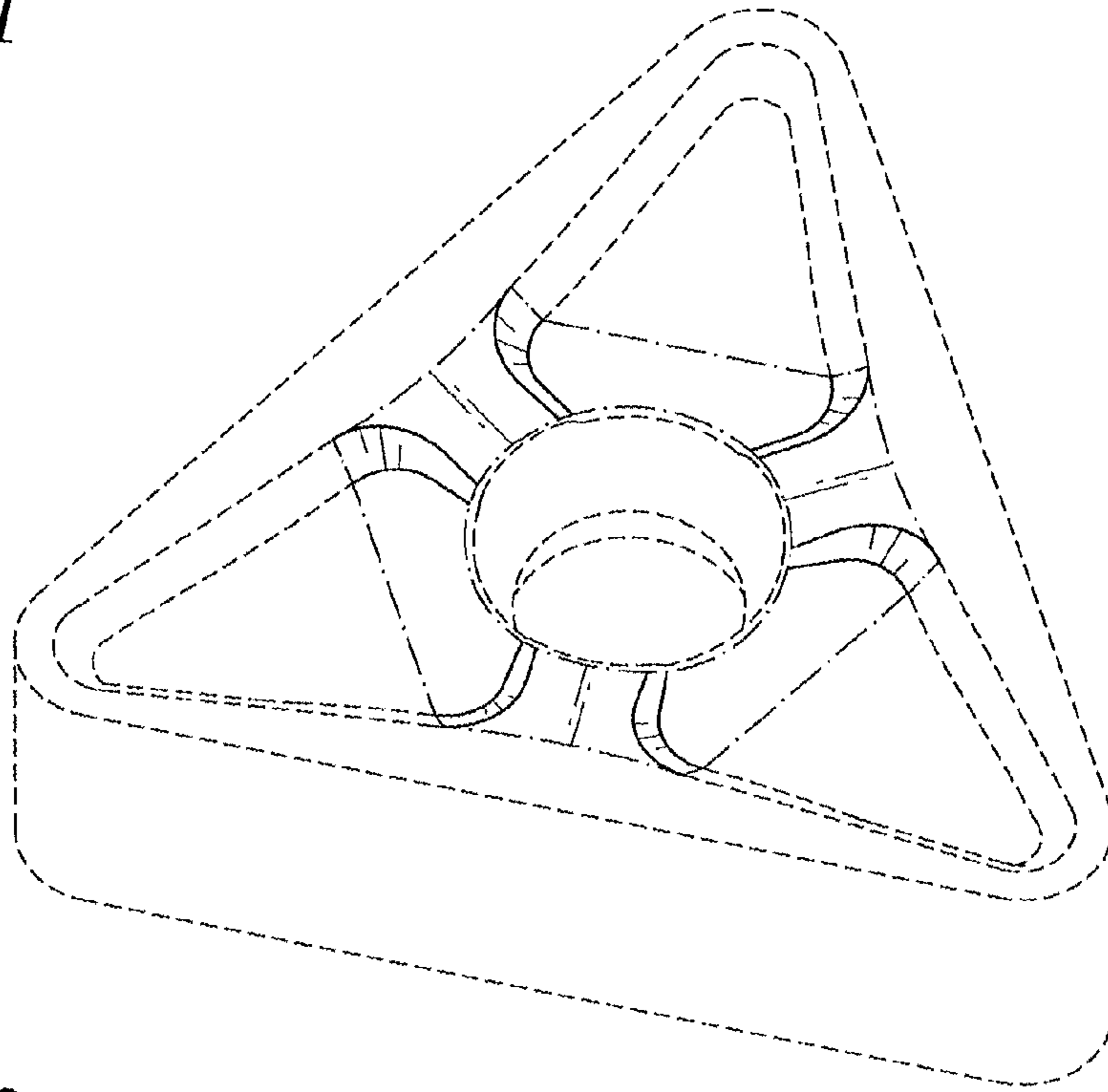
**DESCRIPTION**

FIG. 1 is a perspective view of a cutting insert showing my new design;

The surface shadings and broken line environmental showing is for illustrative purposes only and forms no part of the claimed design. Dash-dot broken lines show boundaries of the claimed design.

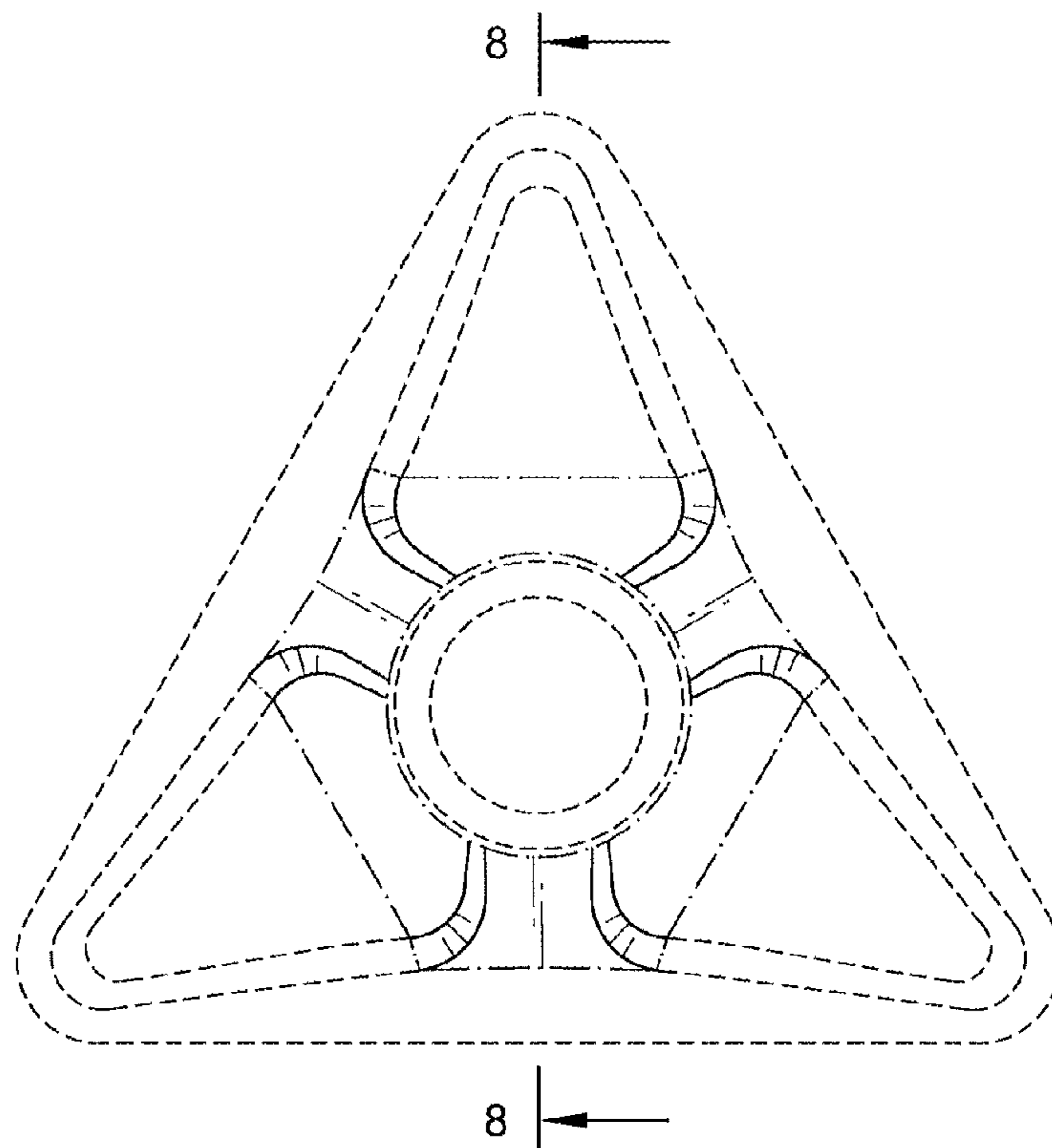

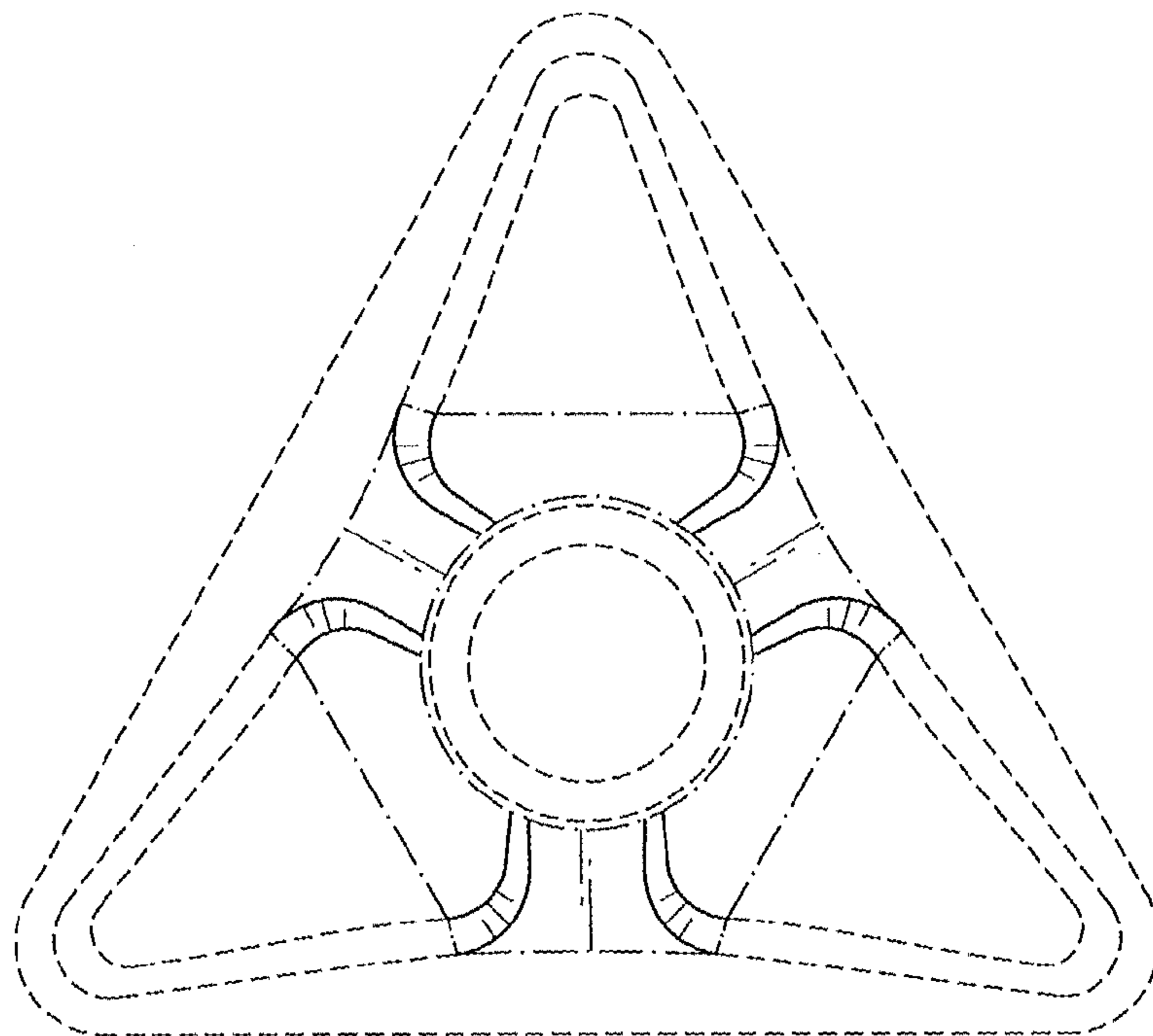

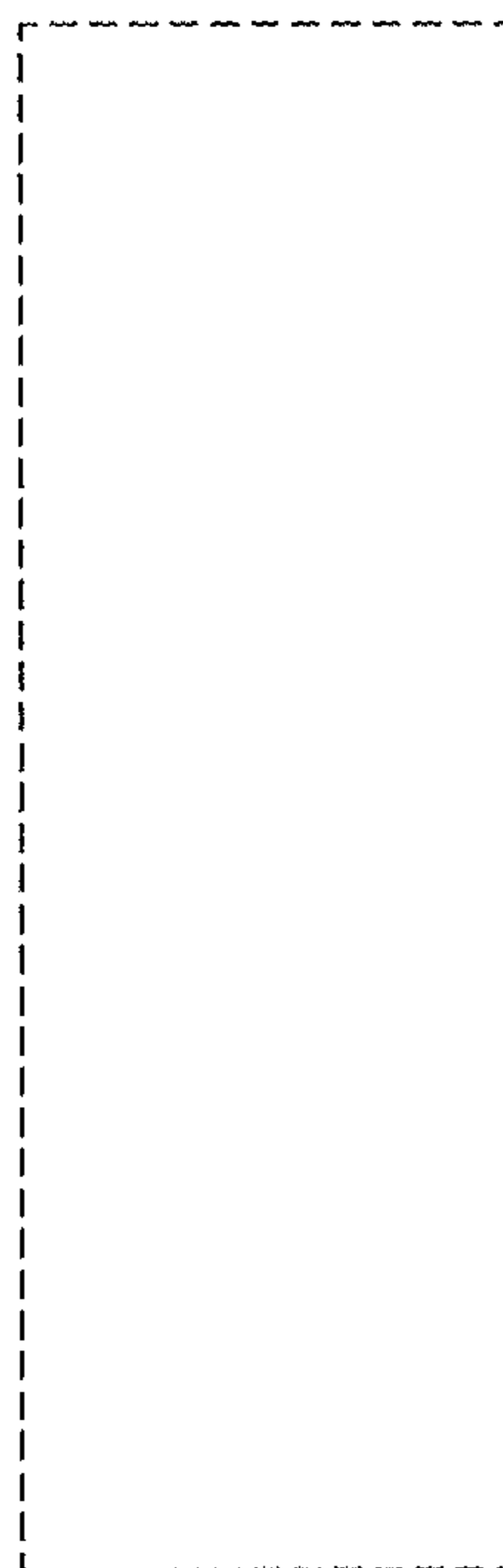

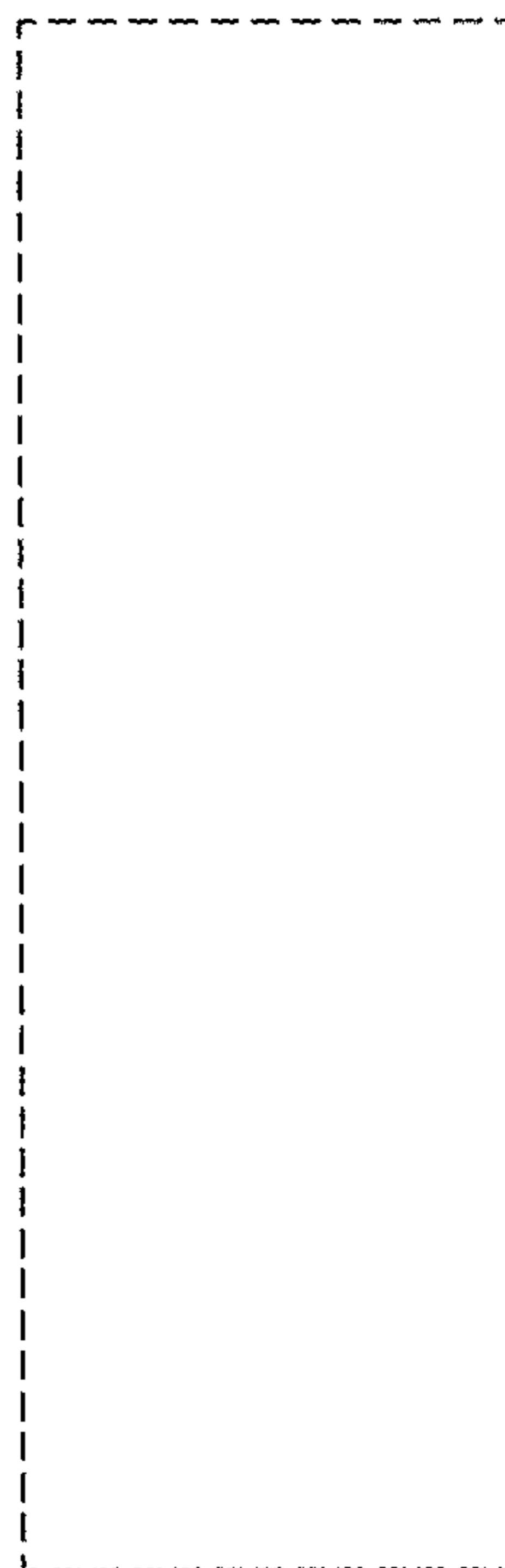

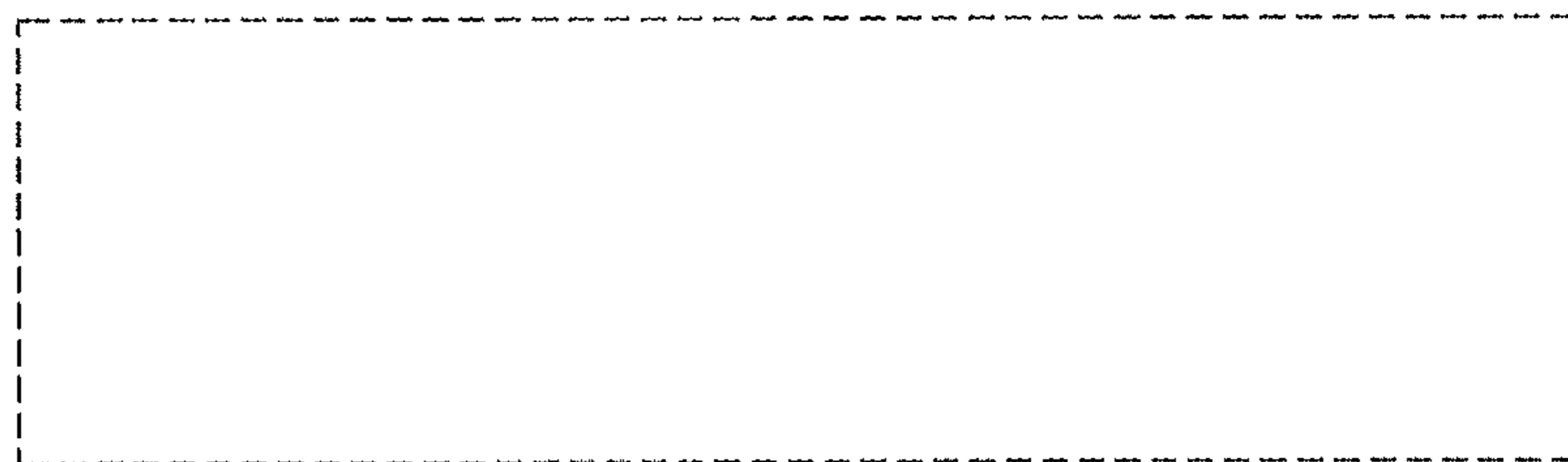
