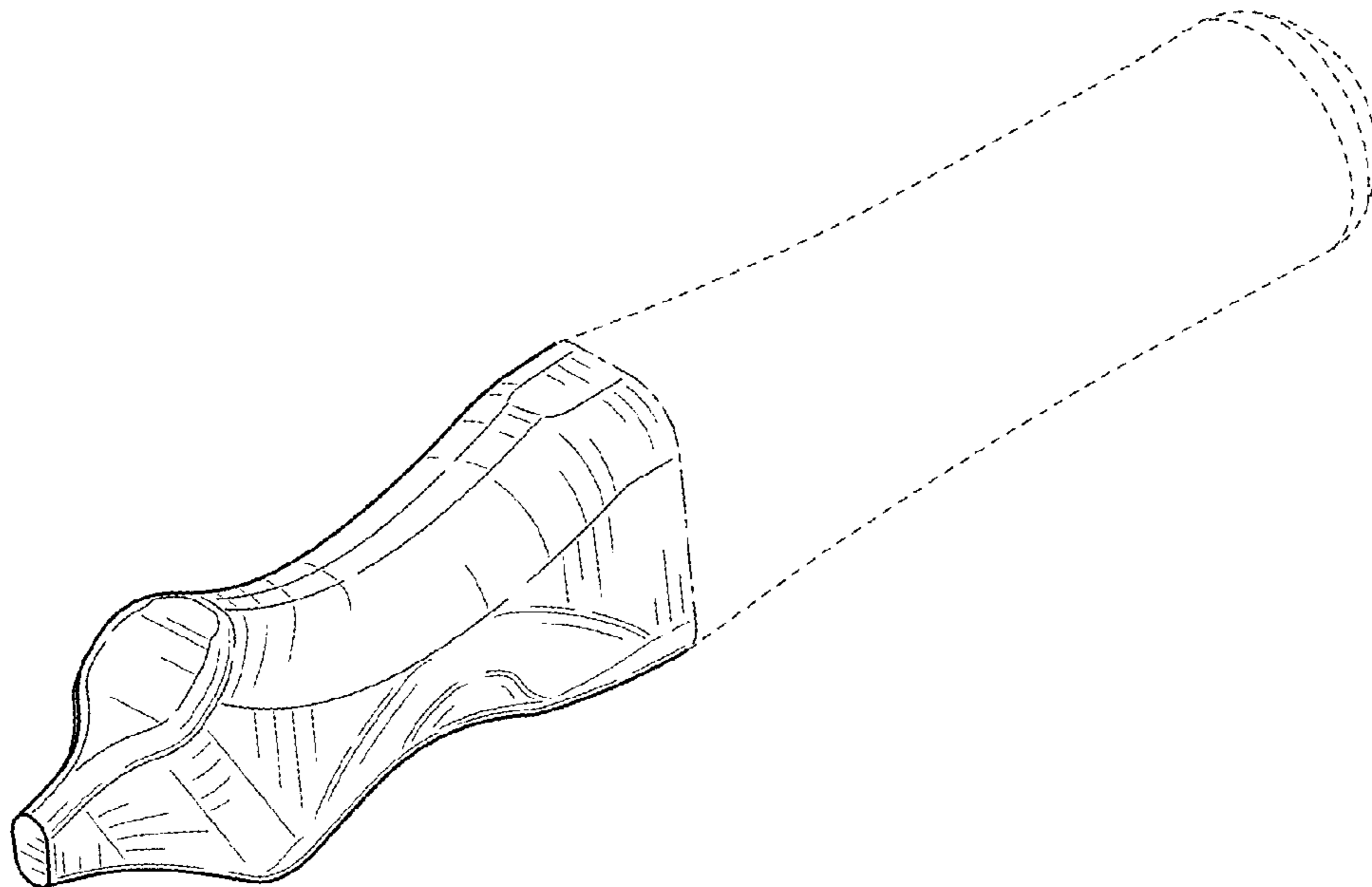
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a scalpel handle grip in accordance with the present invention;

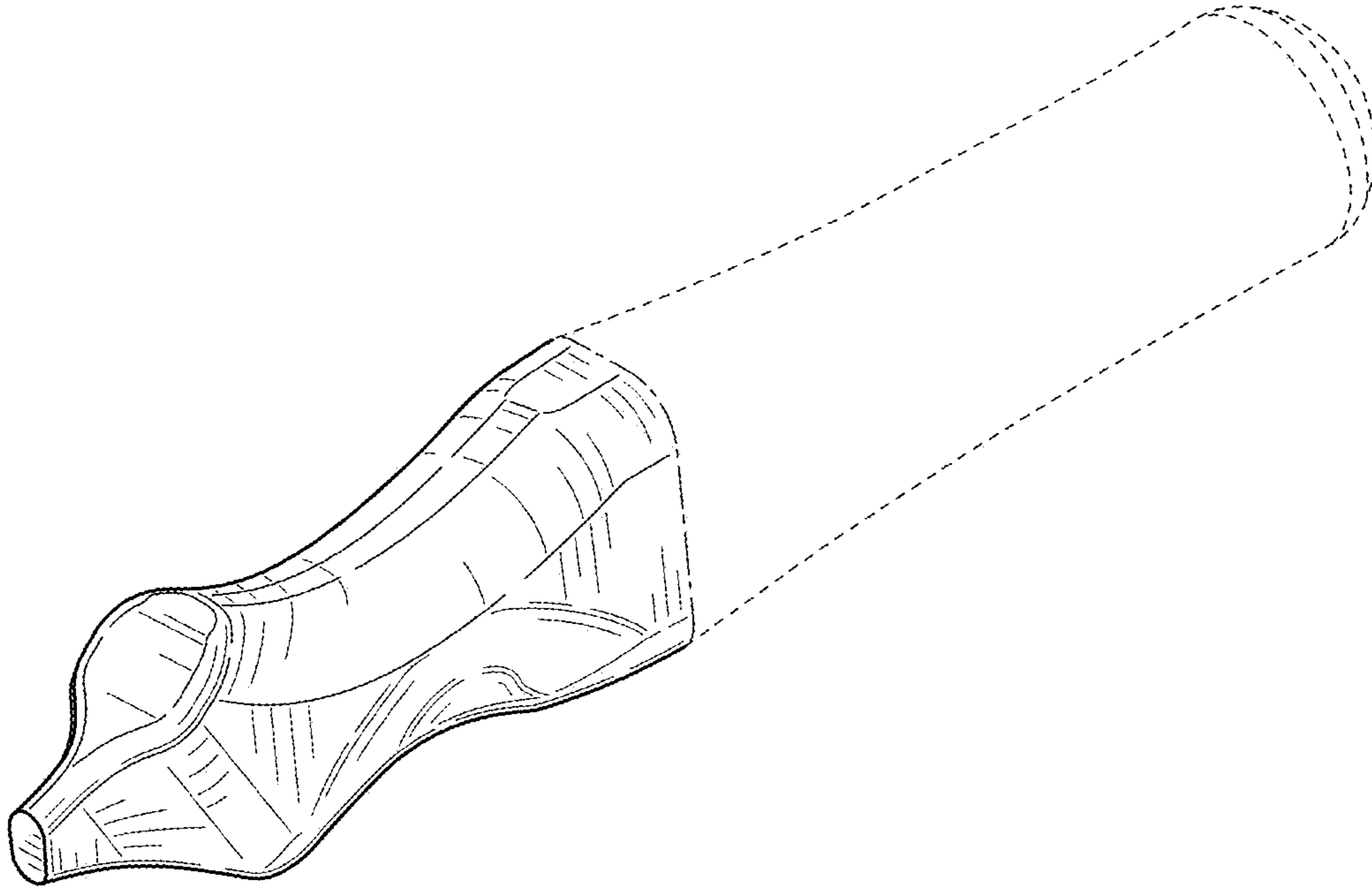

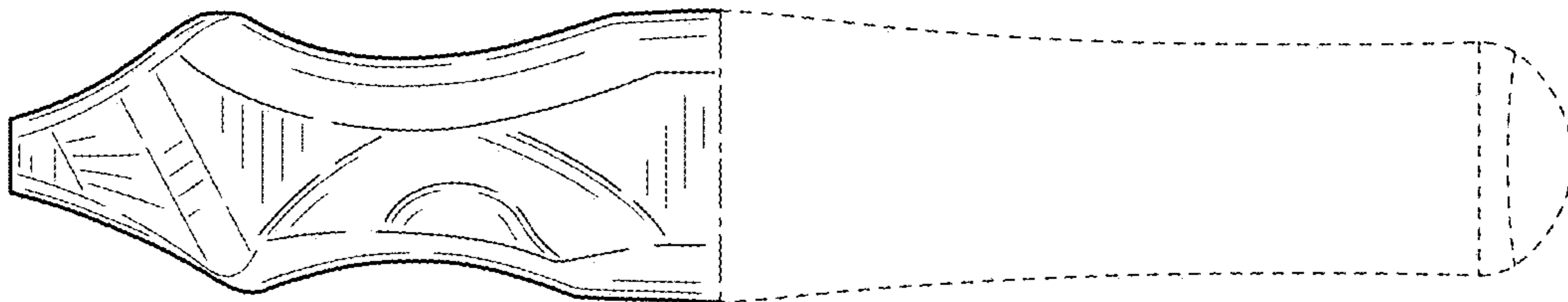

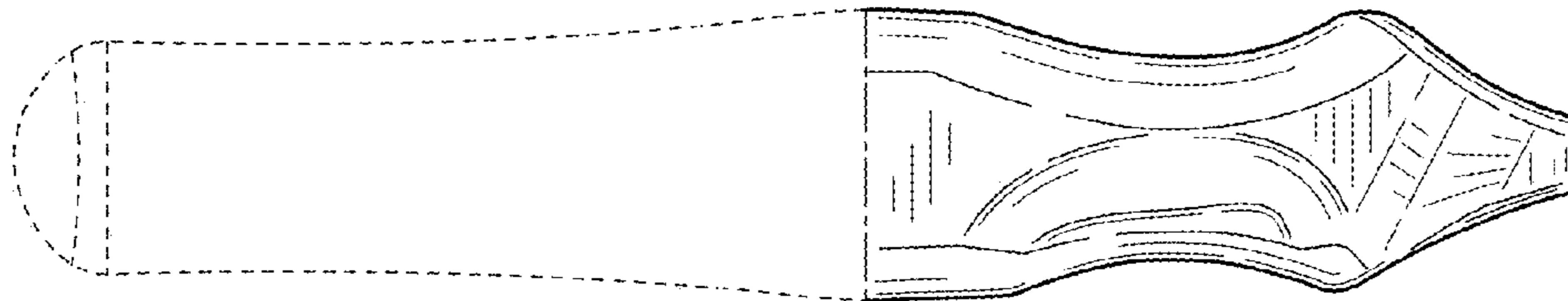

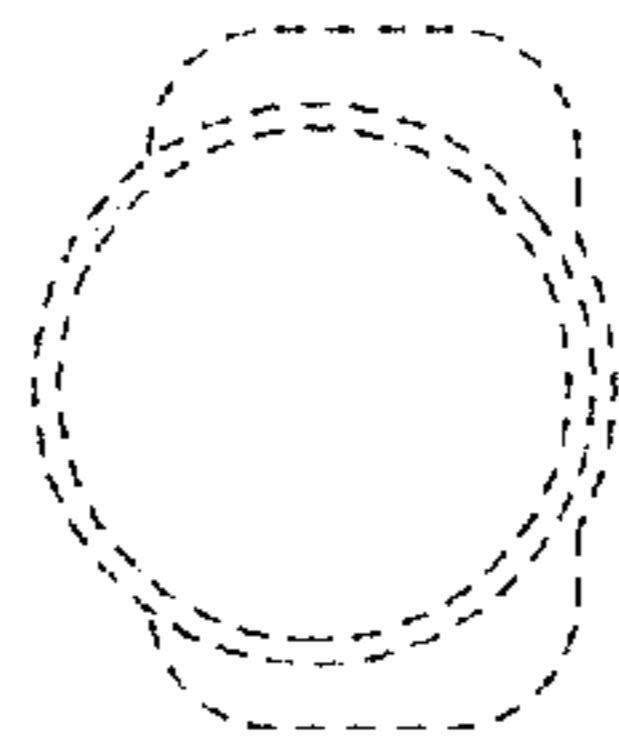

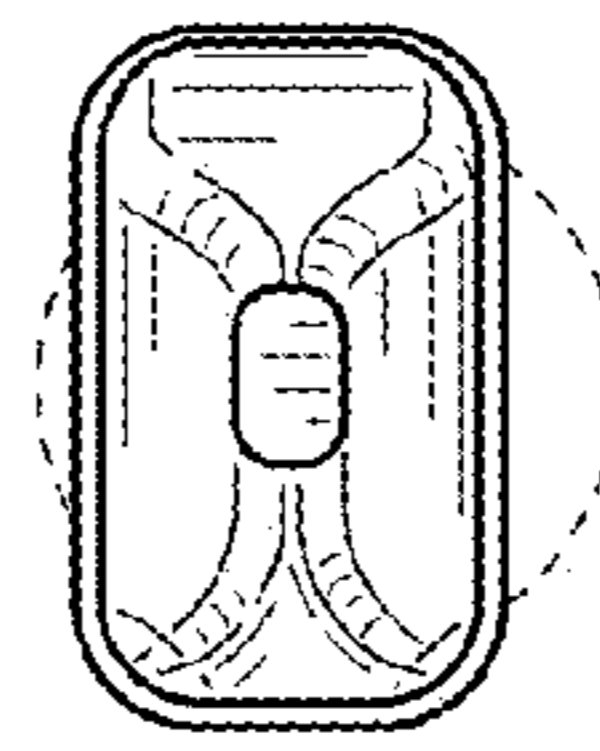

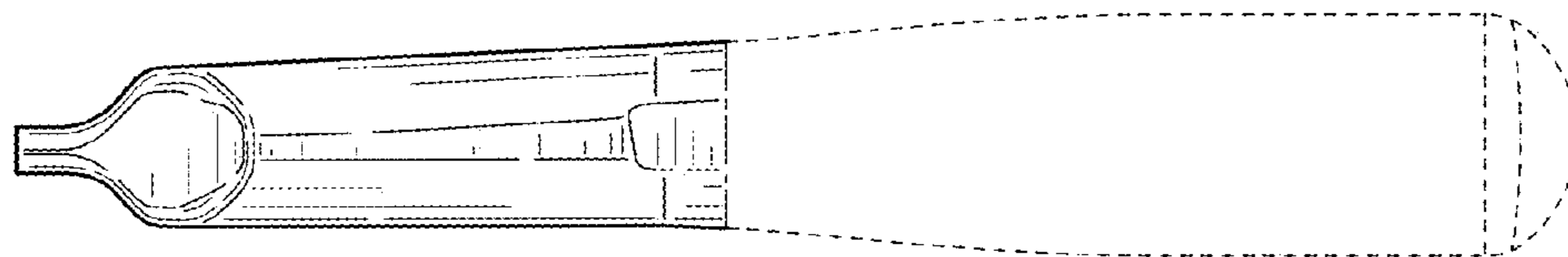

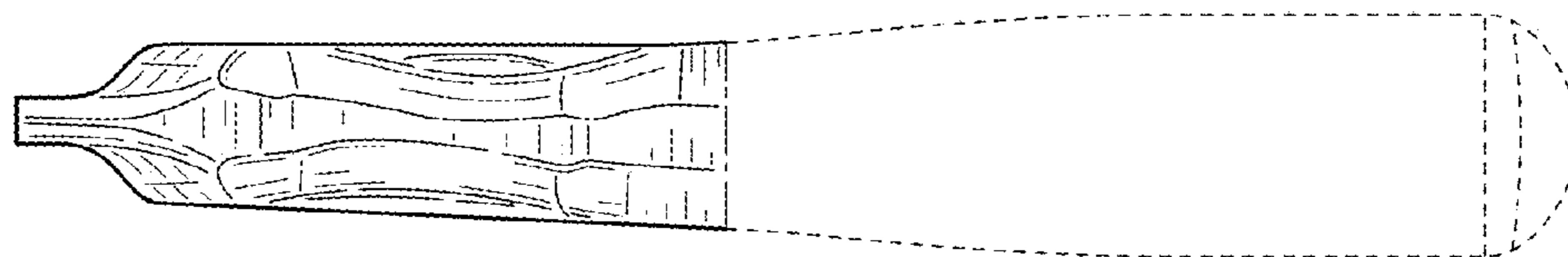
