FIG. 1 is a front view of a headphone cover showing my new design;

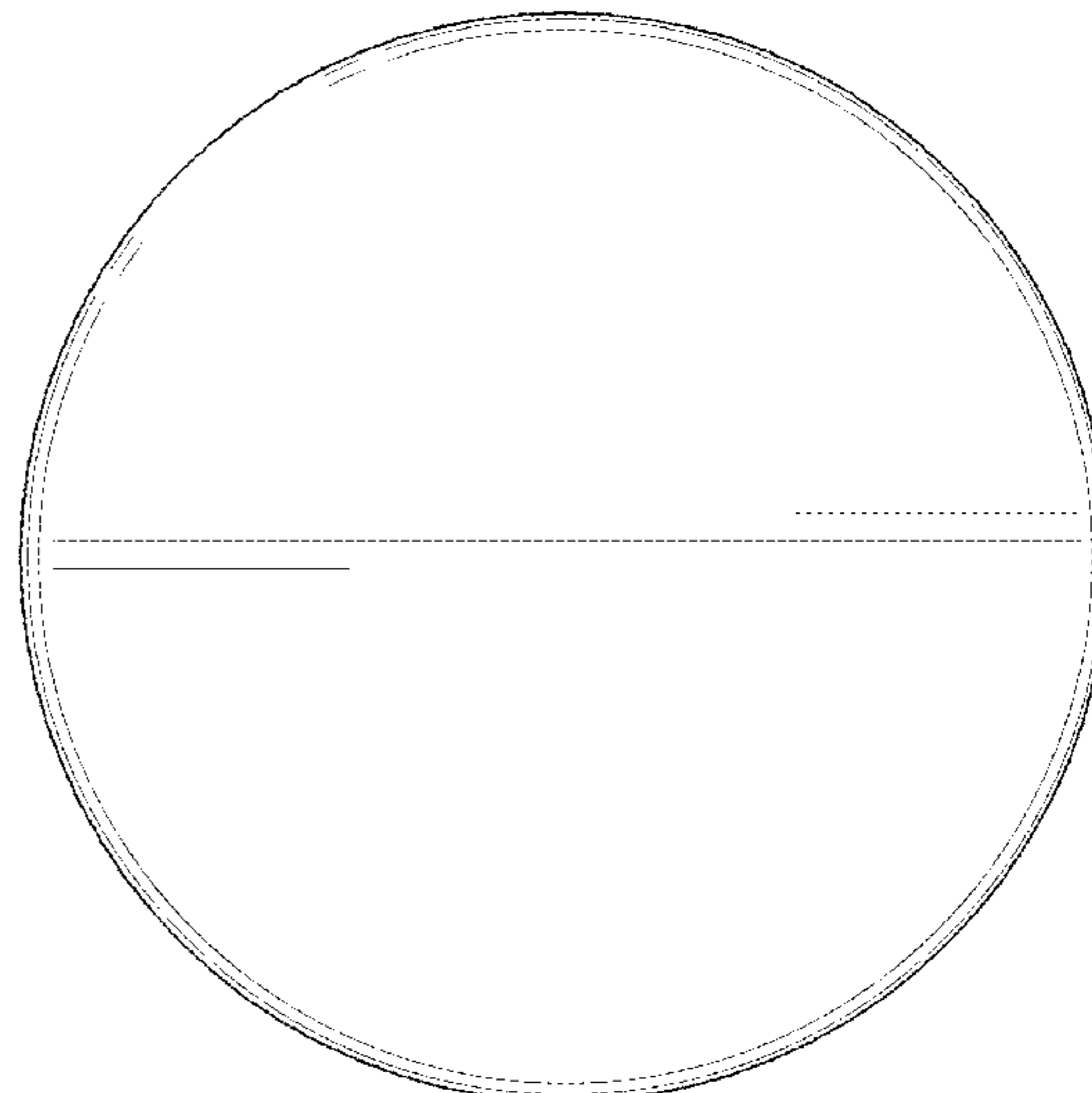
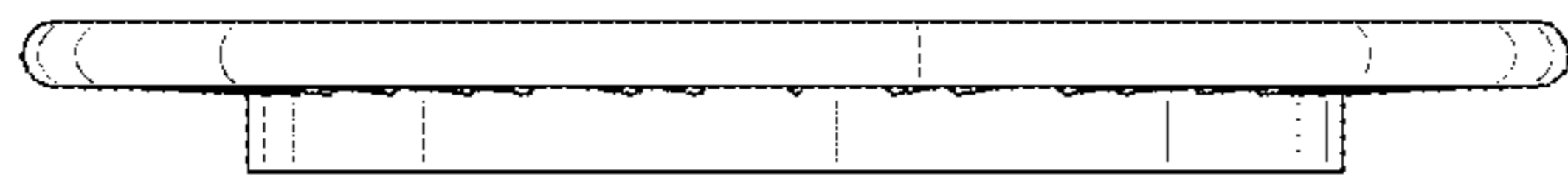
FIG. 2 is a top view thereof;

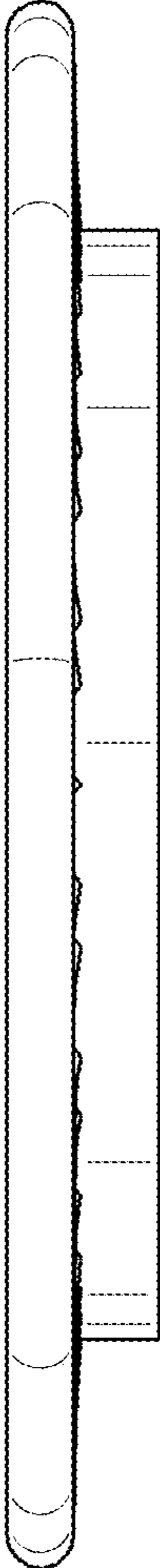

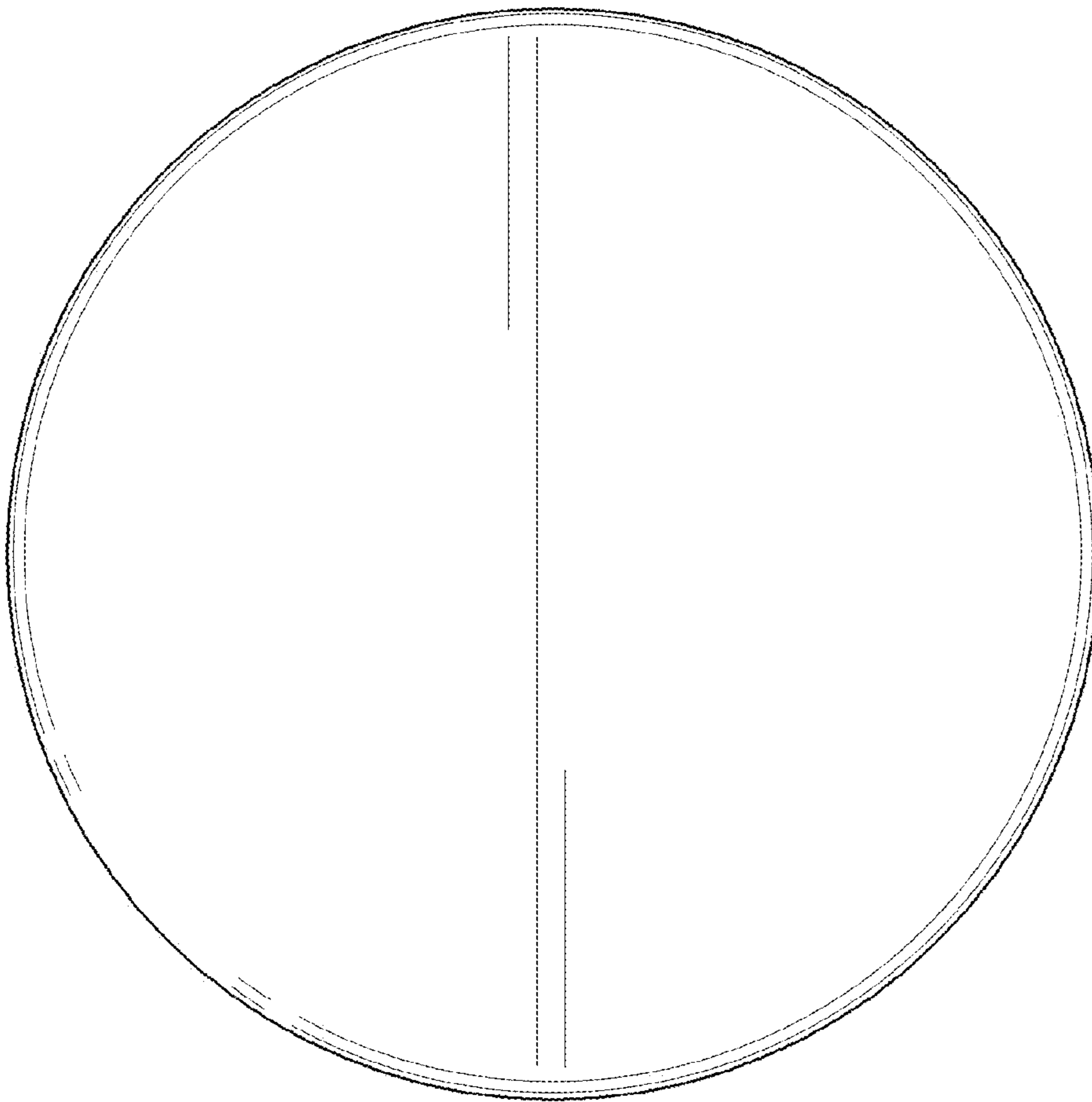

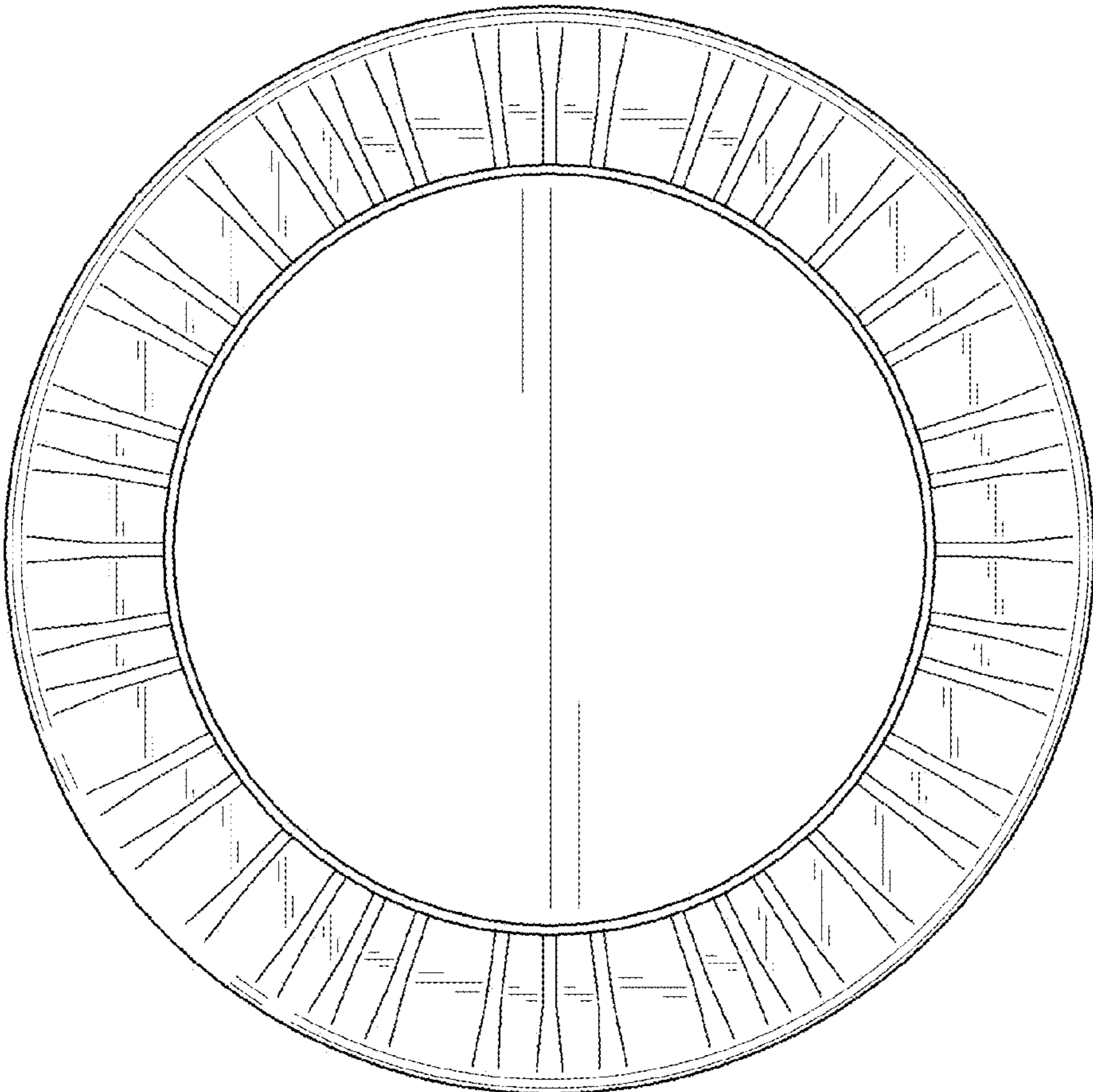

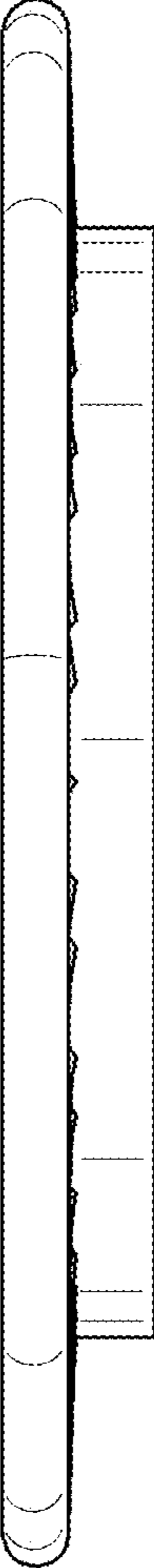
