(57) **CLAIM**

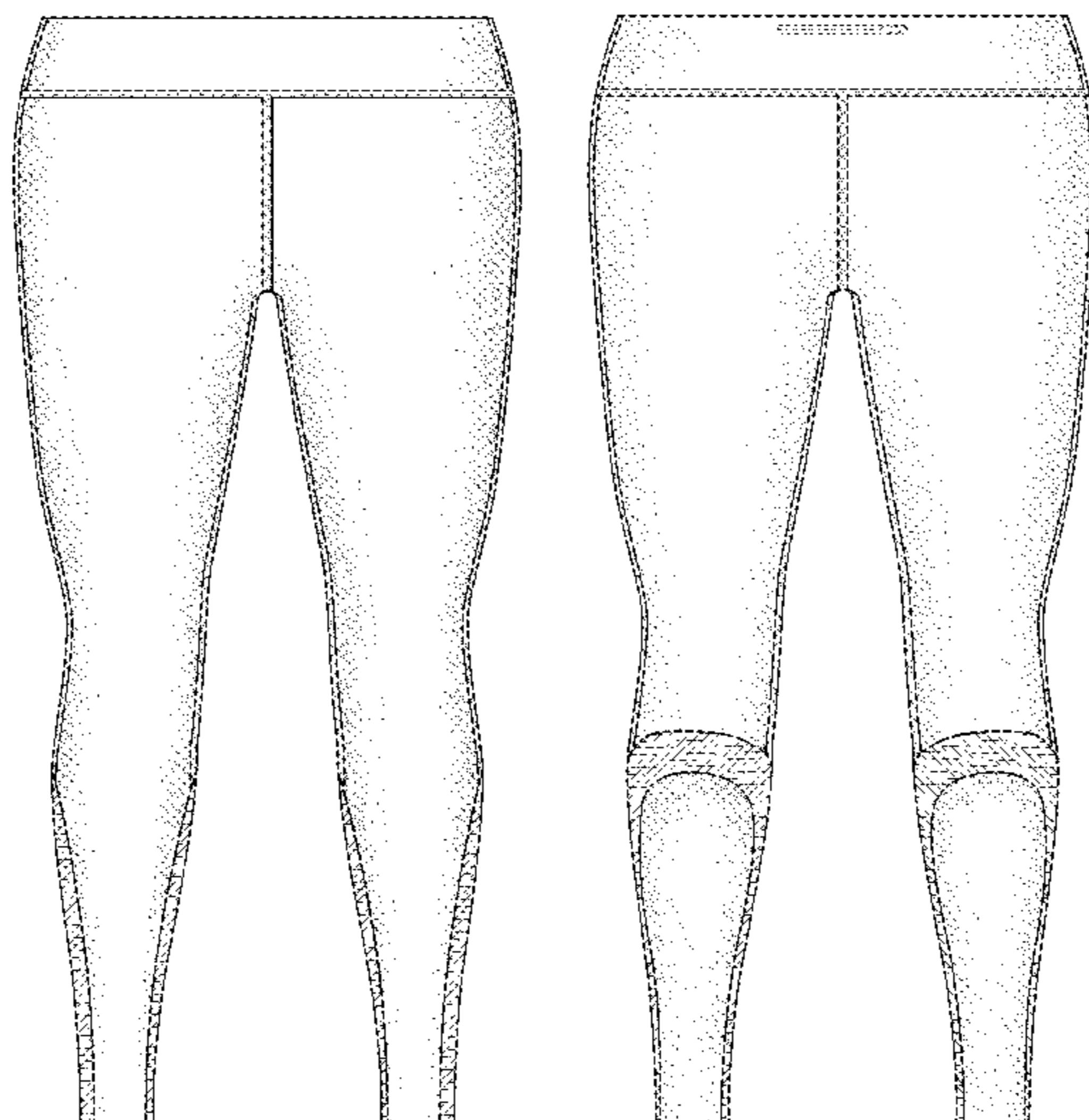
The ornamental design for a pants, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a pants showing my new design in an in-use configuration;
FIG. 2 is a front left perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left side view thereof; and,
FIG. 6 is a right side view thereof.

The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The unshaded regions, demarcated by broken lines, represent unclaimed portions of the pants and form no part of the claimed design.

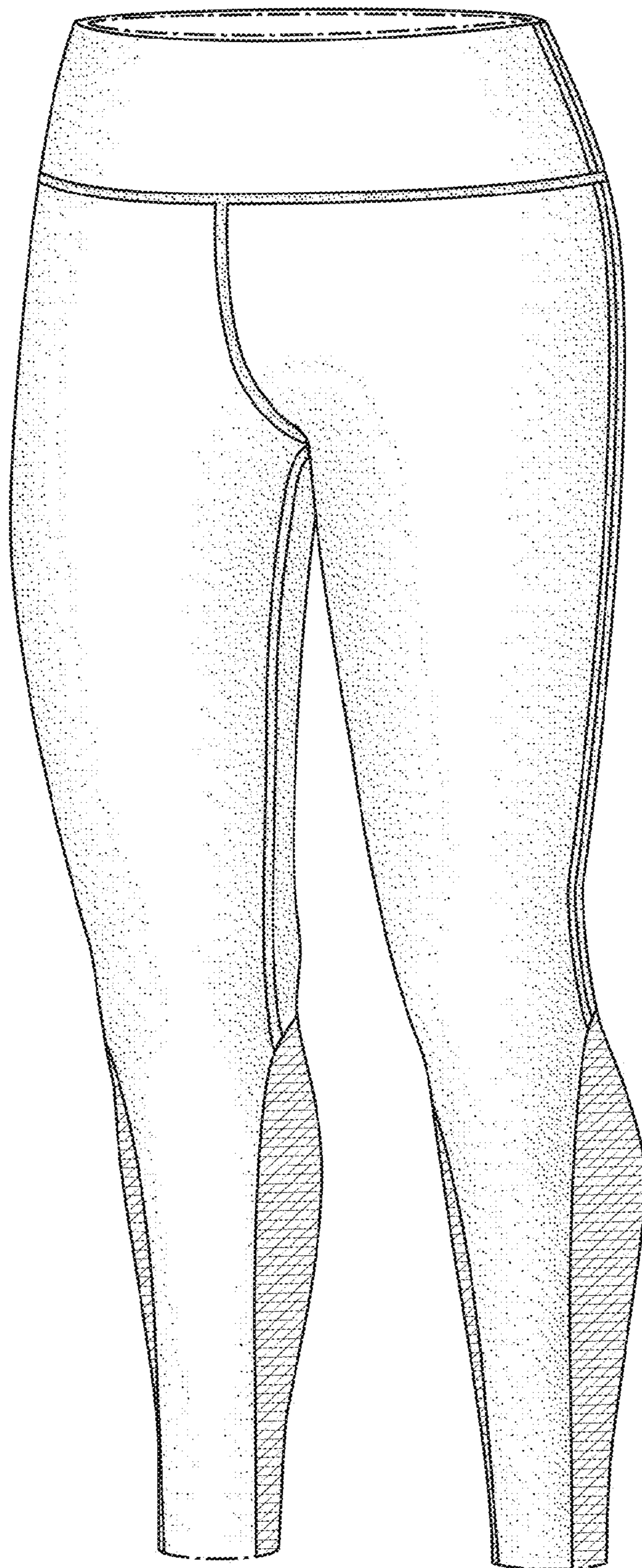

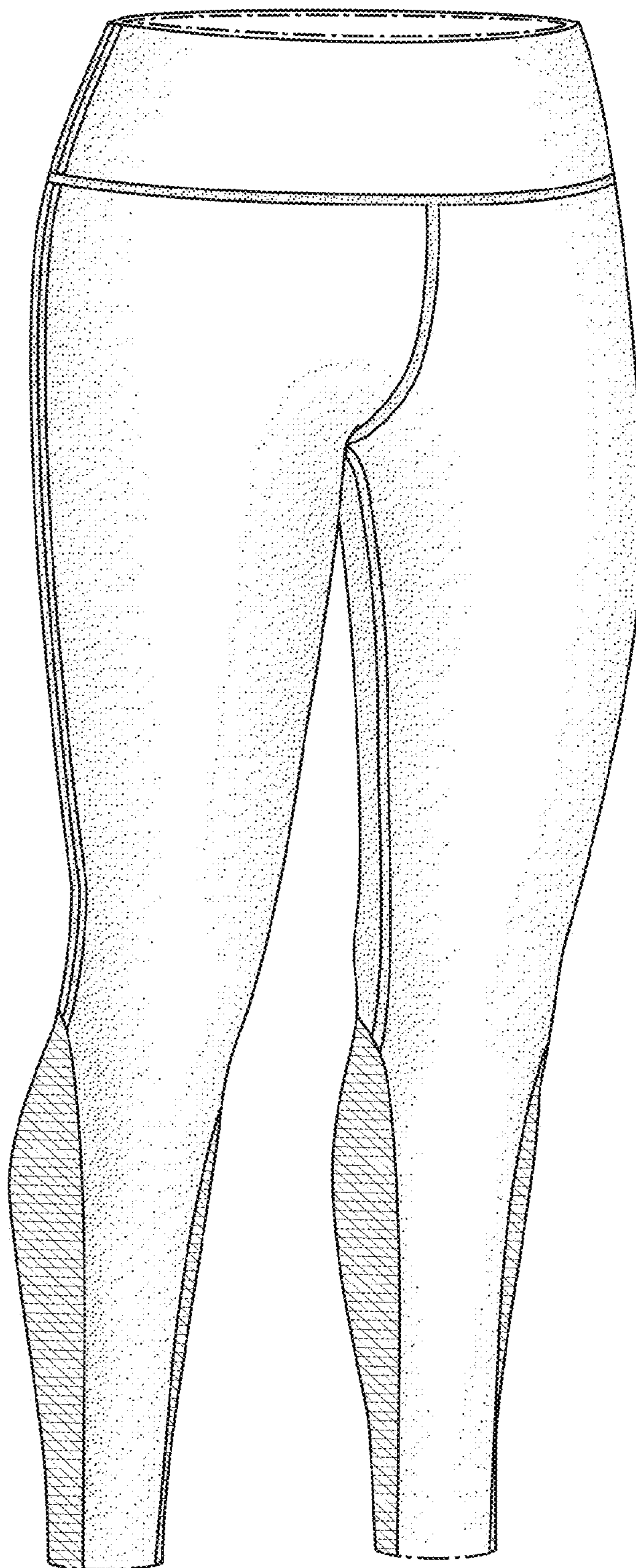

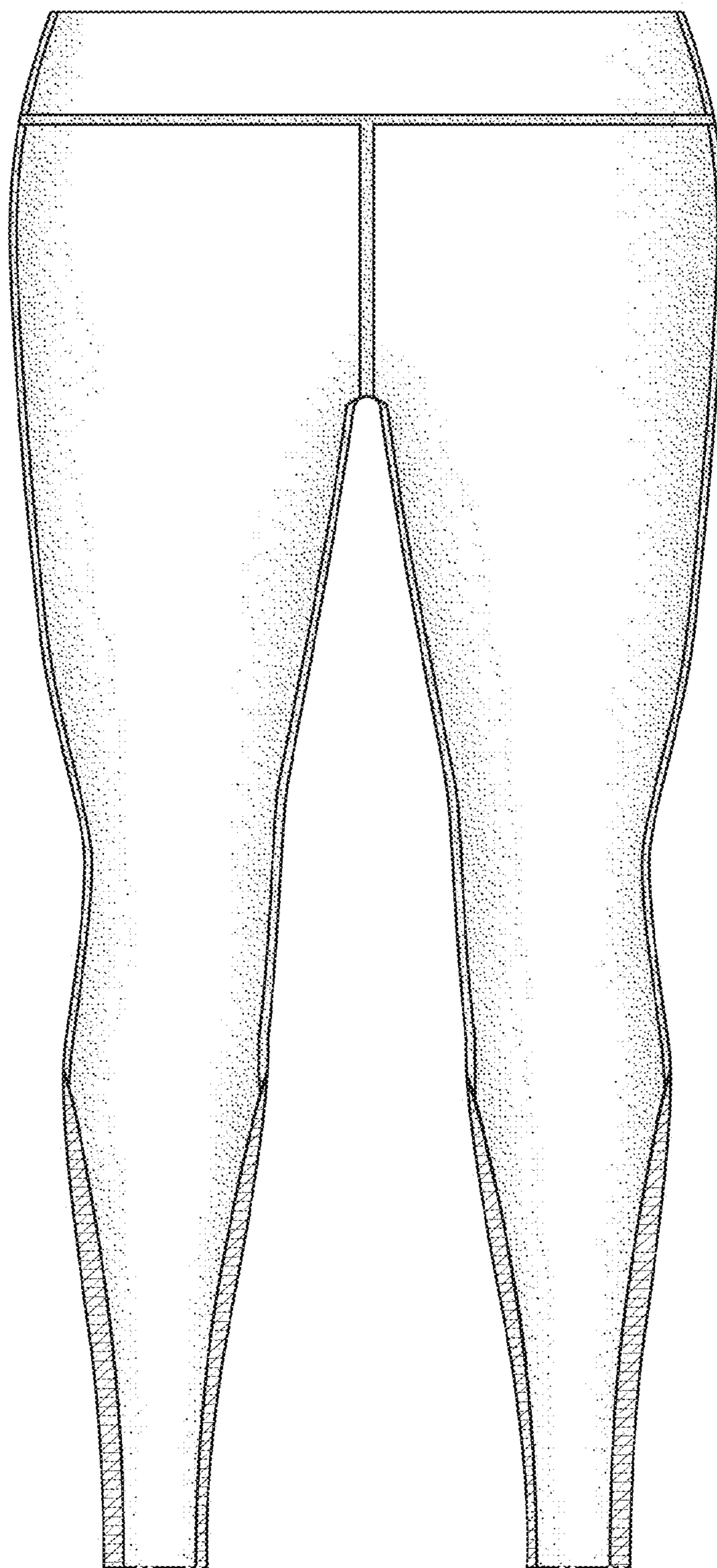

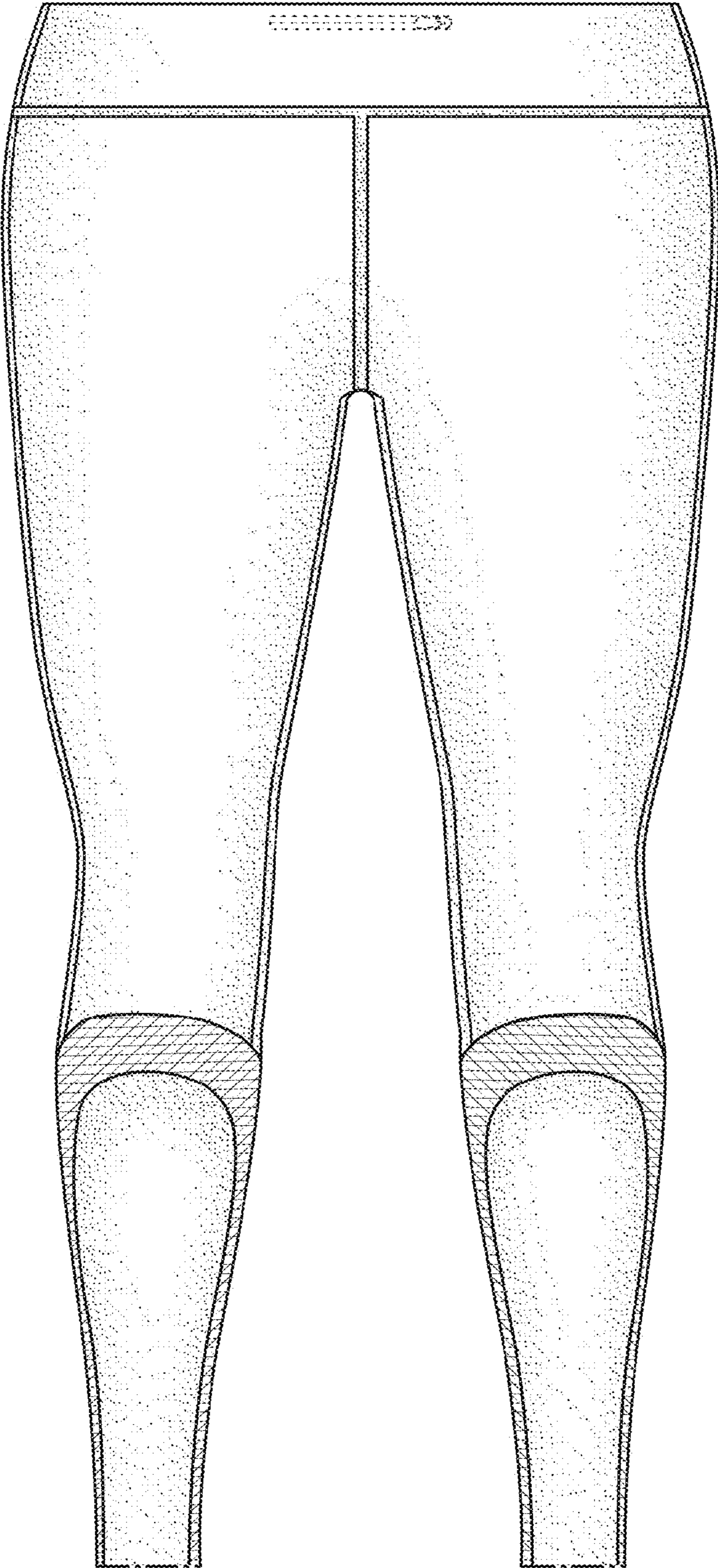

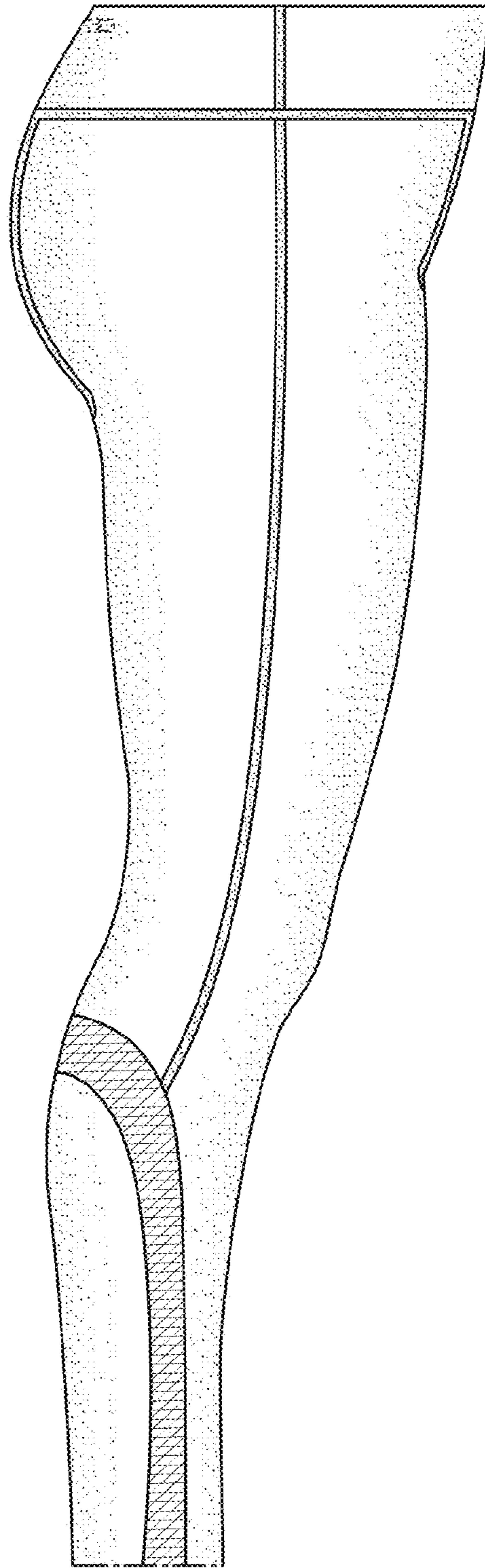

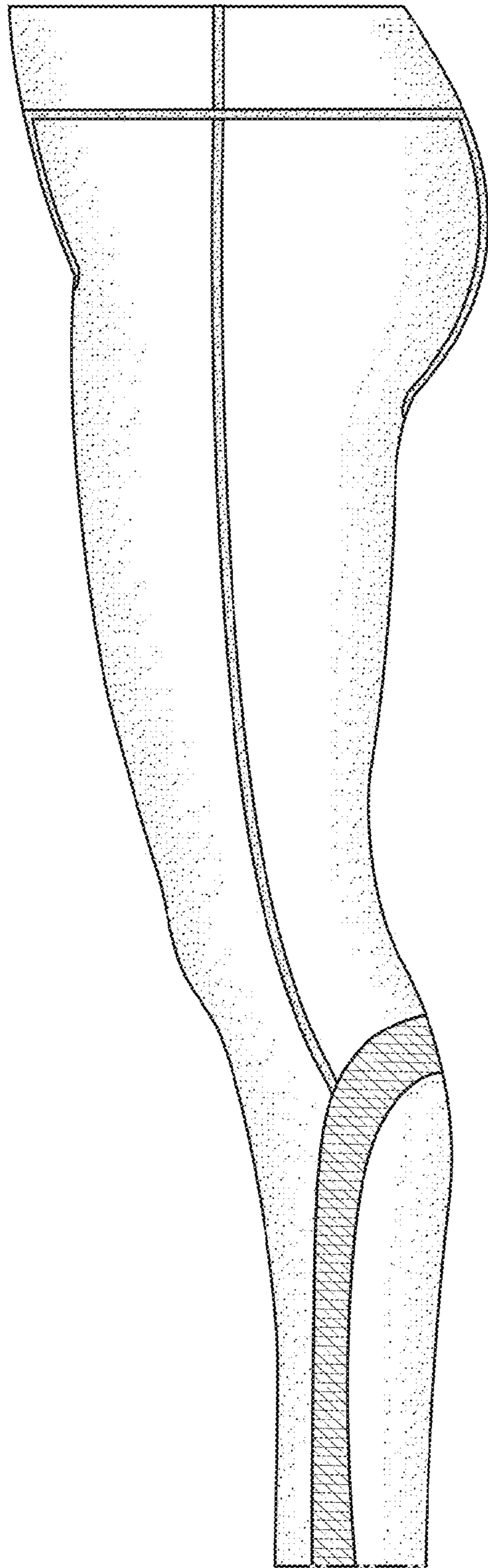
