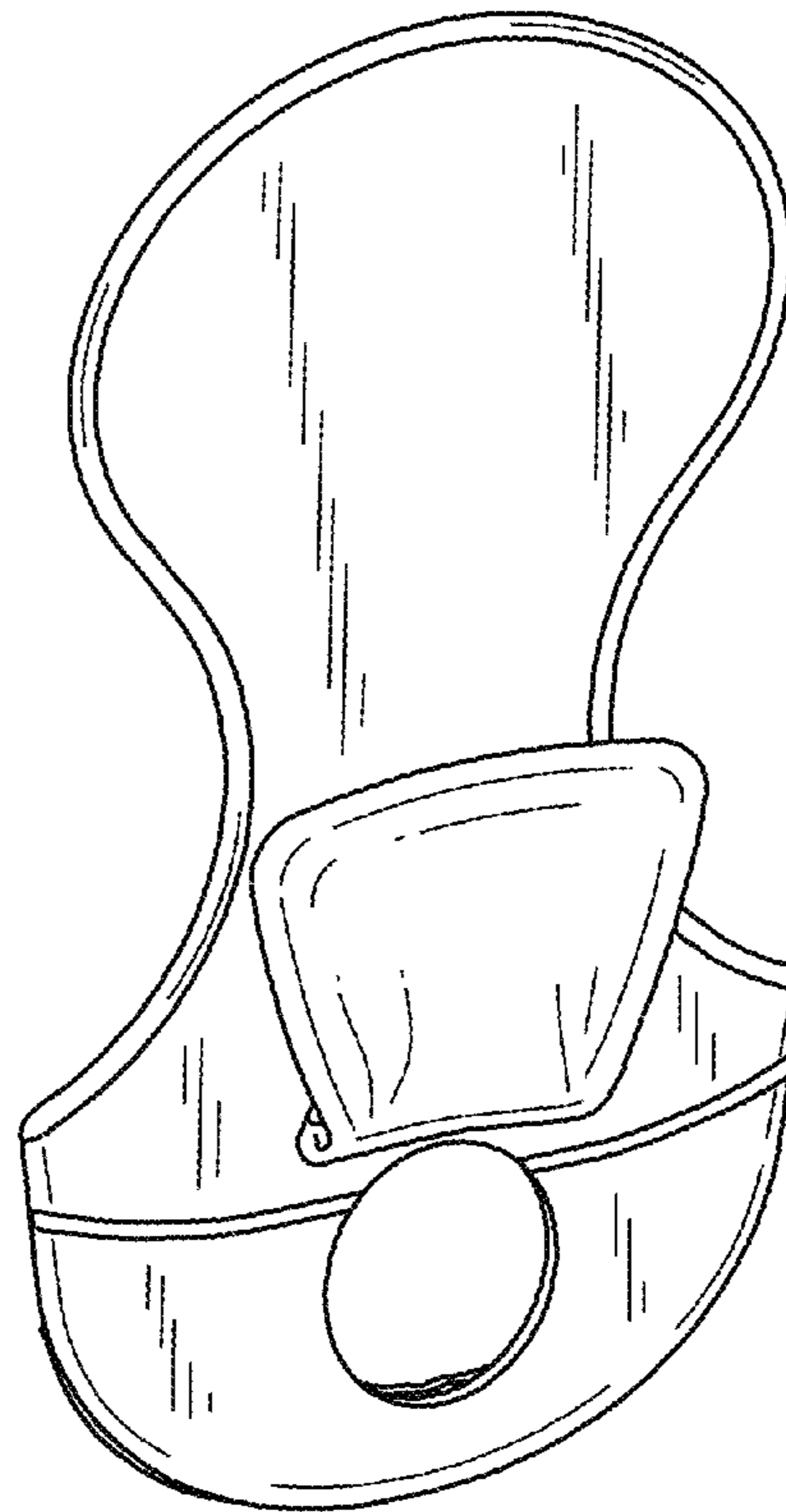
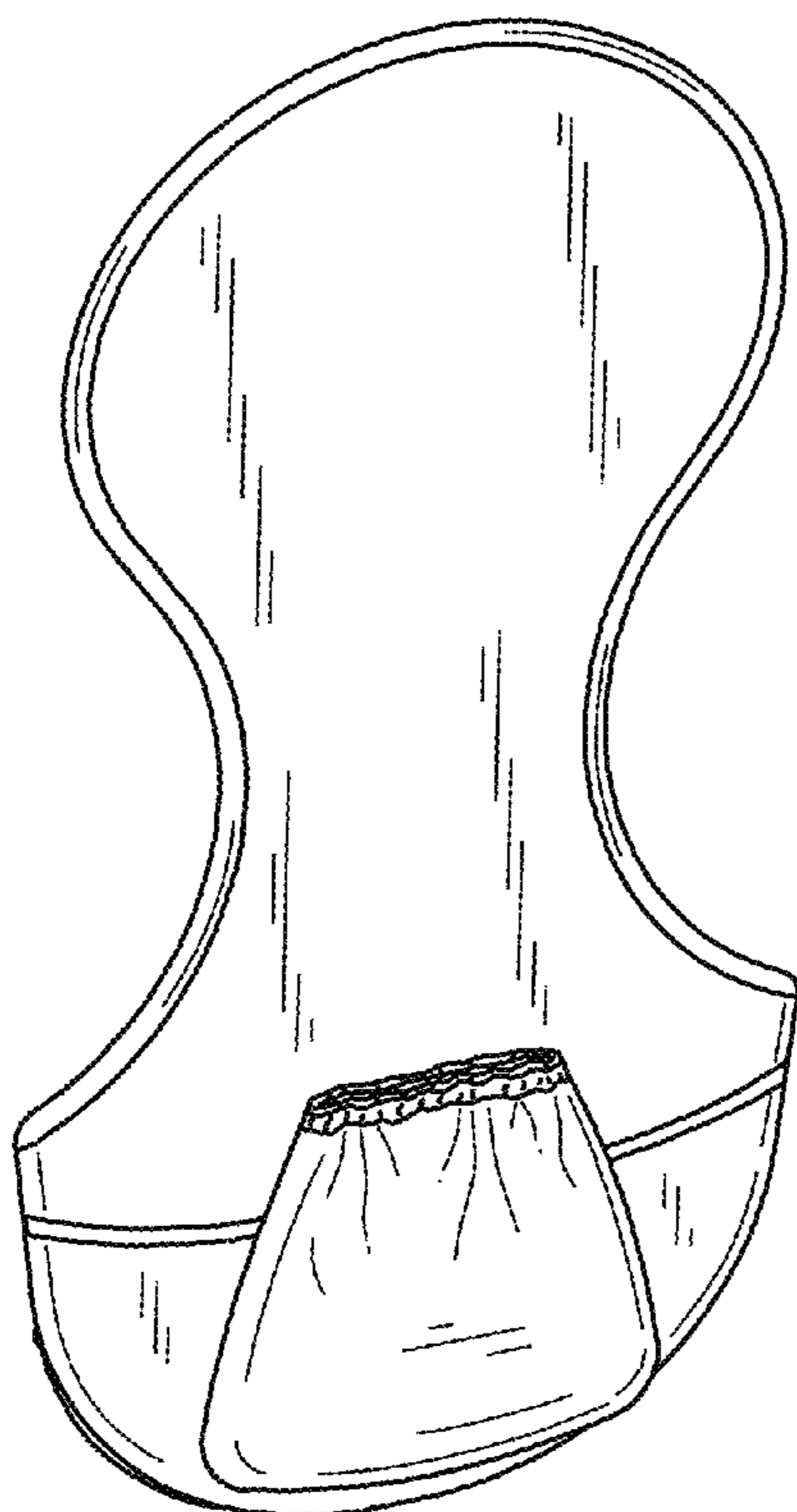
(57) **CLAIM**

The ornamental design for a breastfeeding apparel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a breastfeeding apparel, showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left side elevation view thereof, the right side elevation being a mirror image thereto;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a front perspective view thereof shown in an alternate configuration of use.

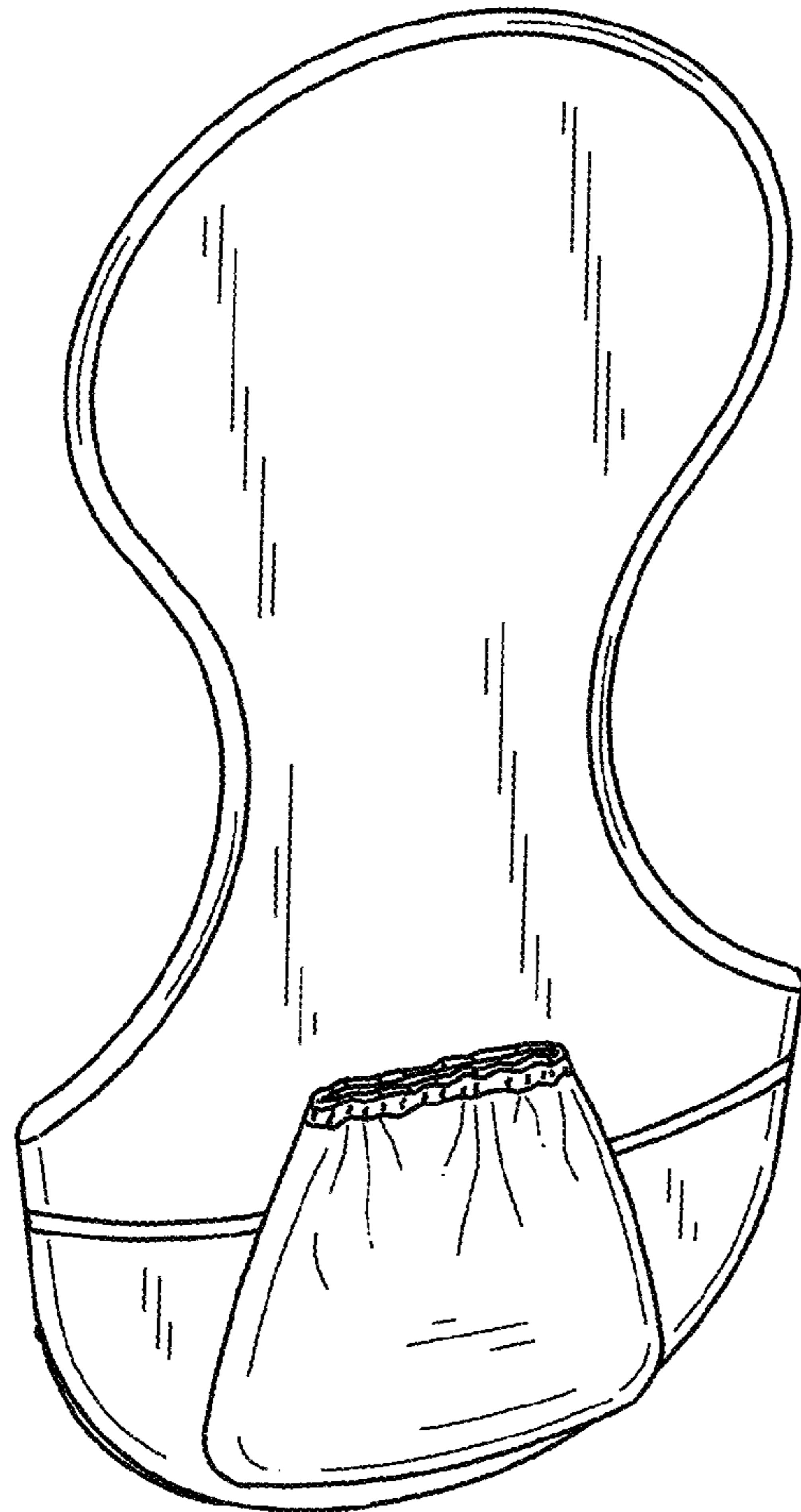

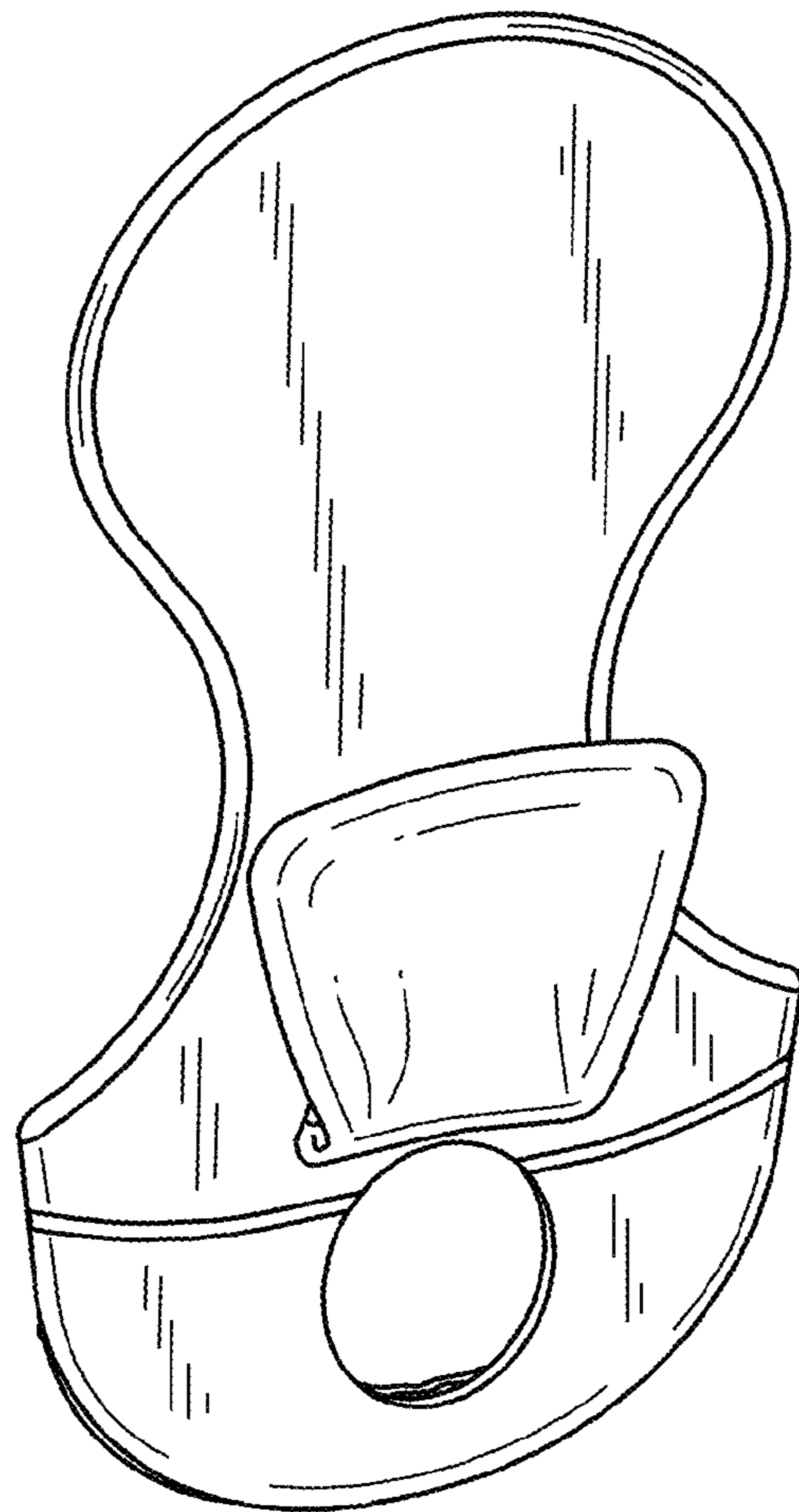

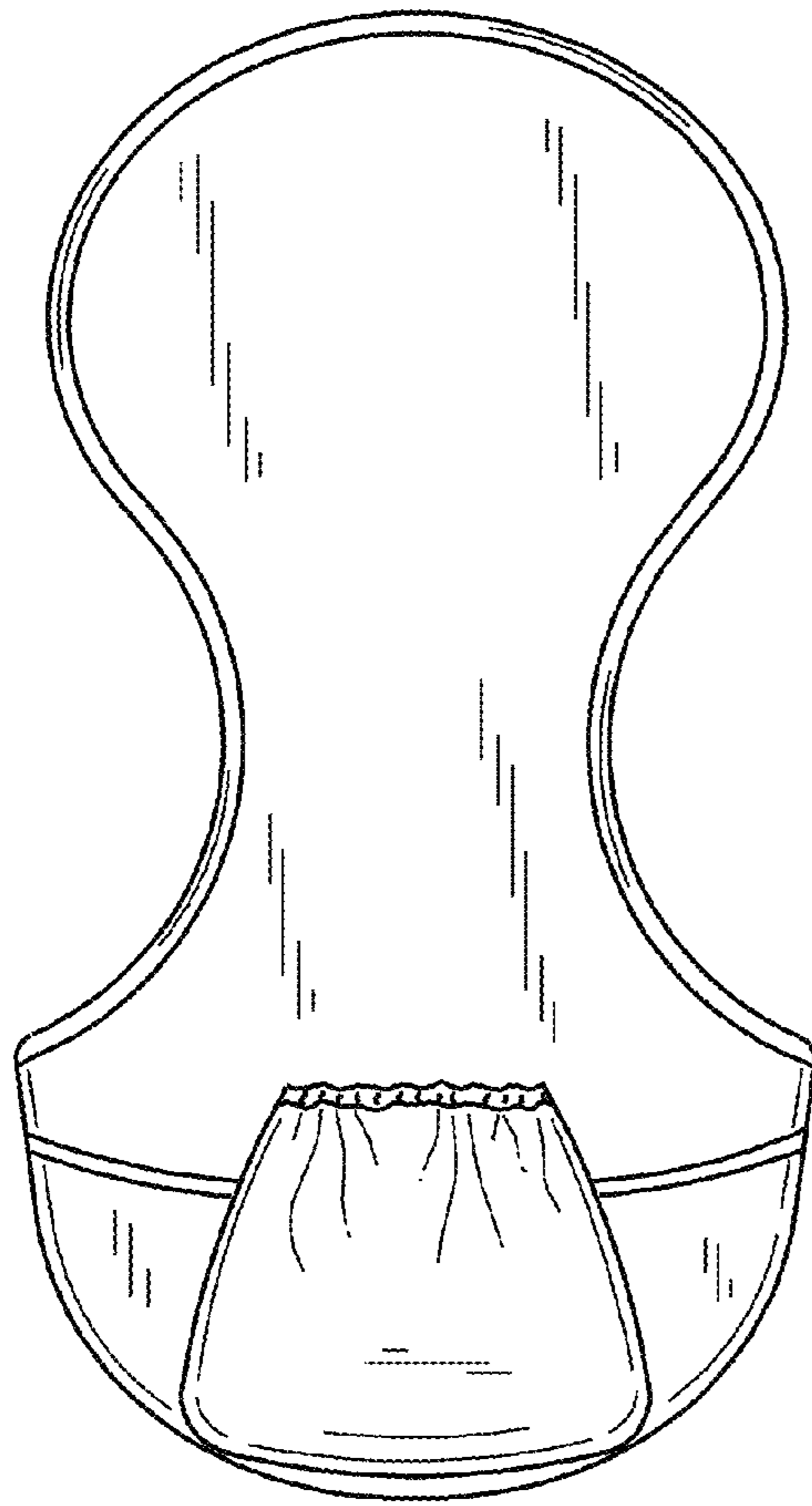

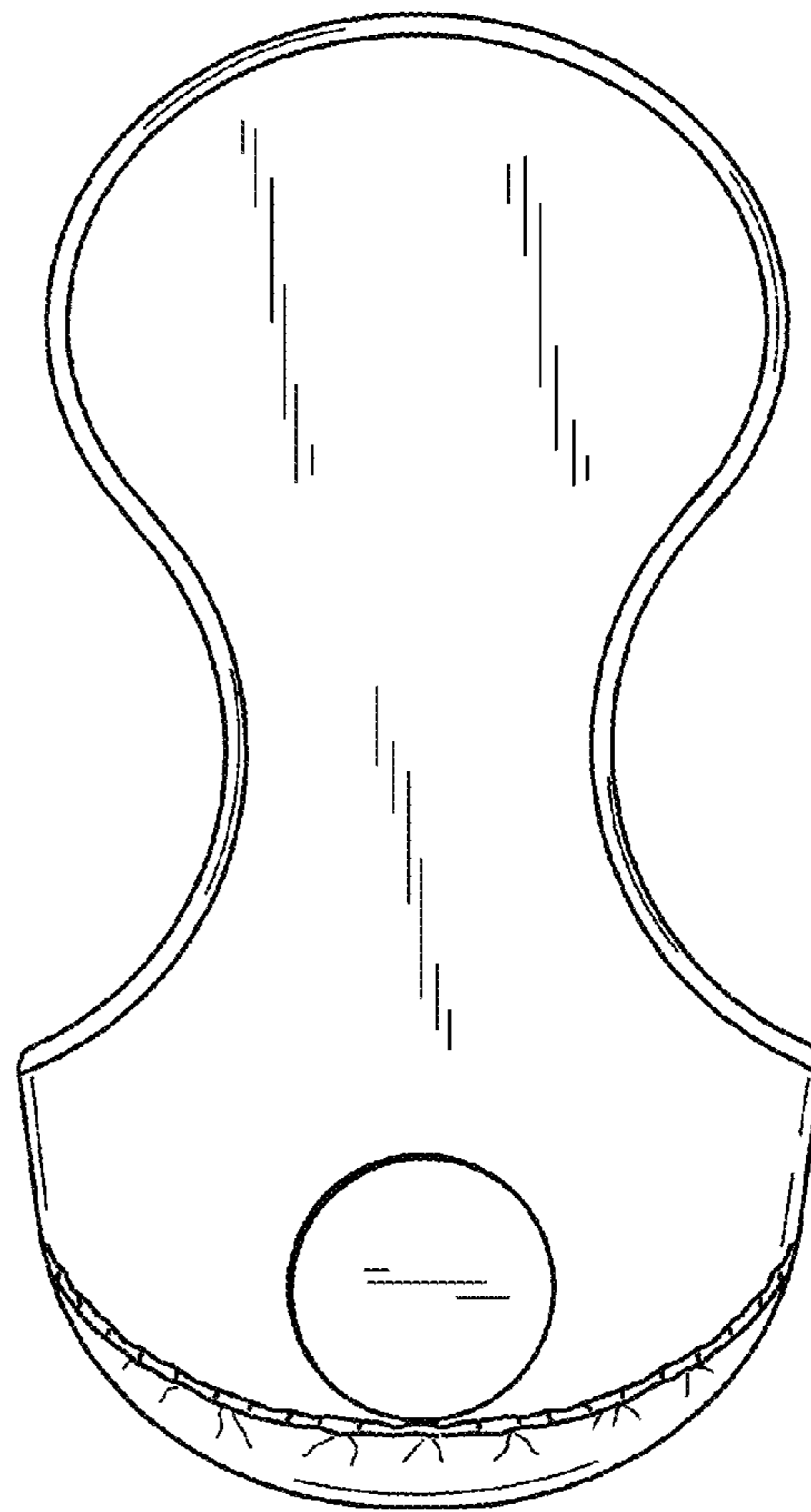

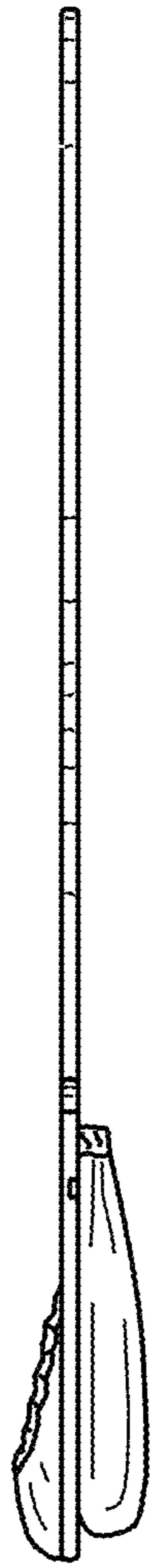

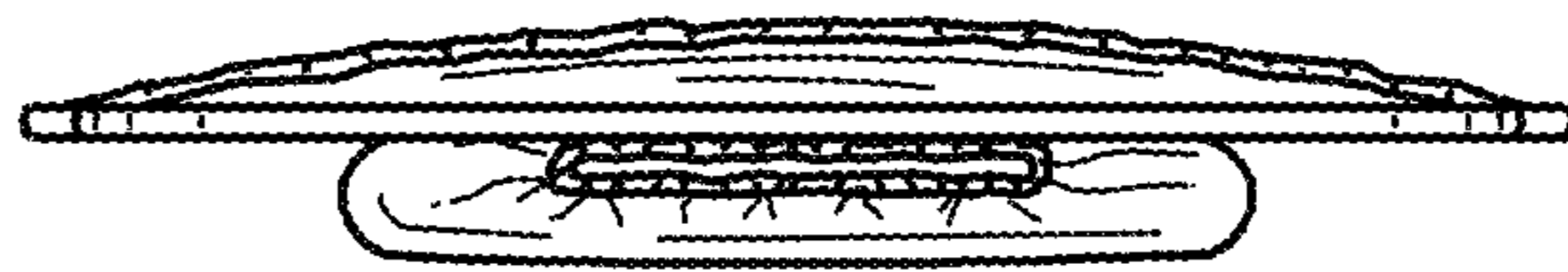

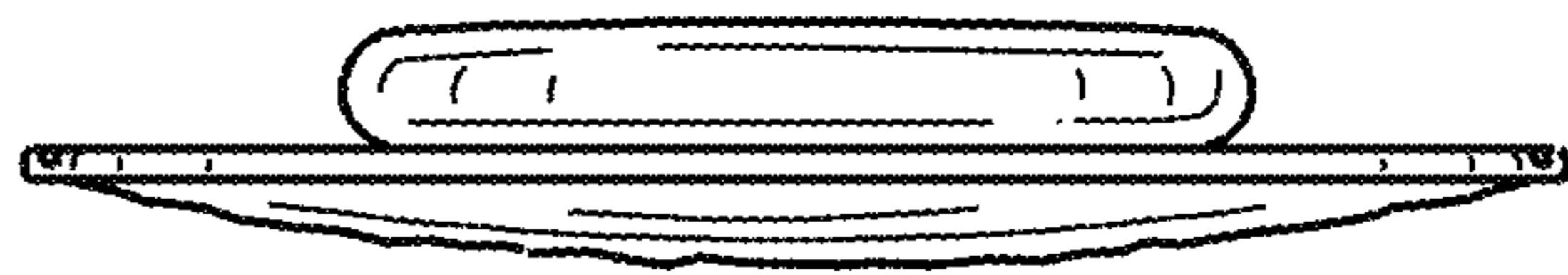
