FIG. 3 is a top view thereof.

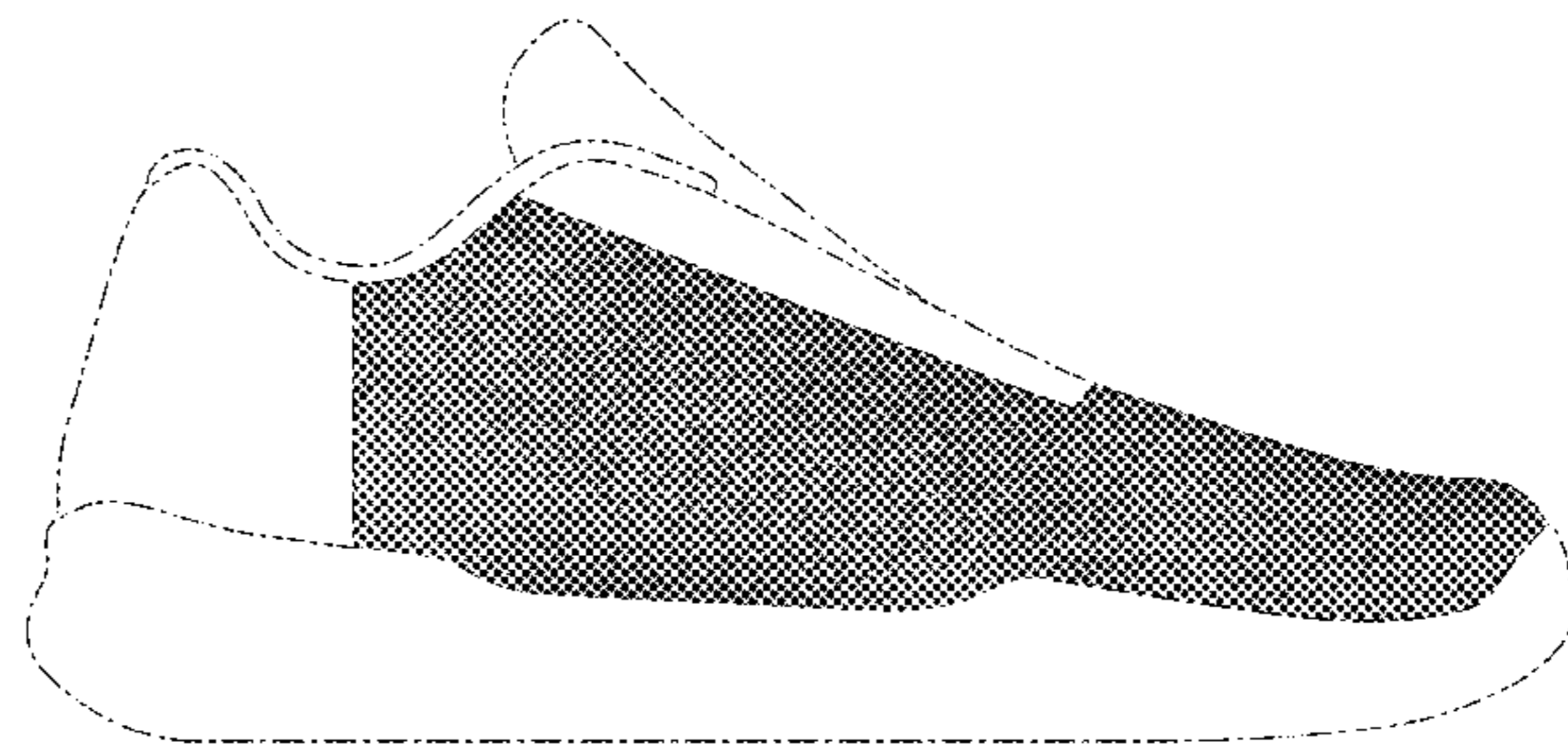
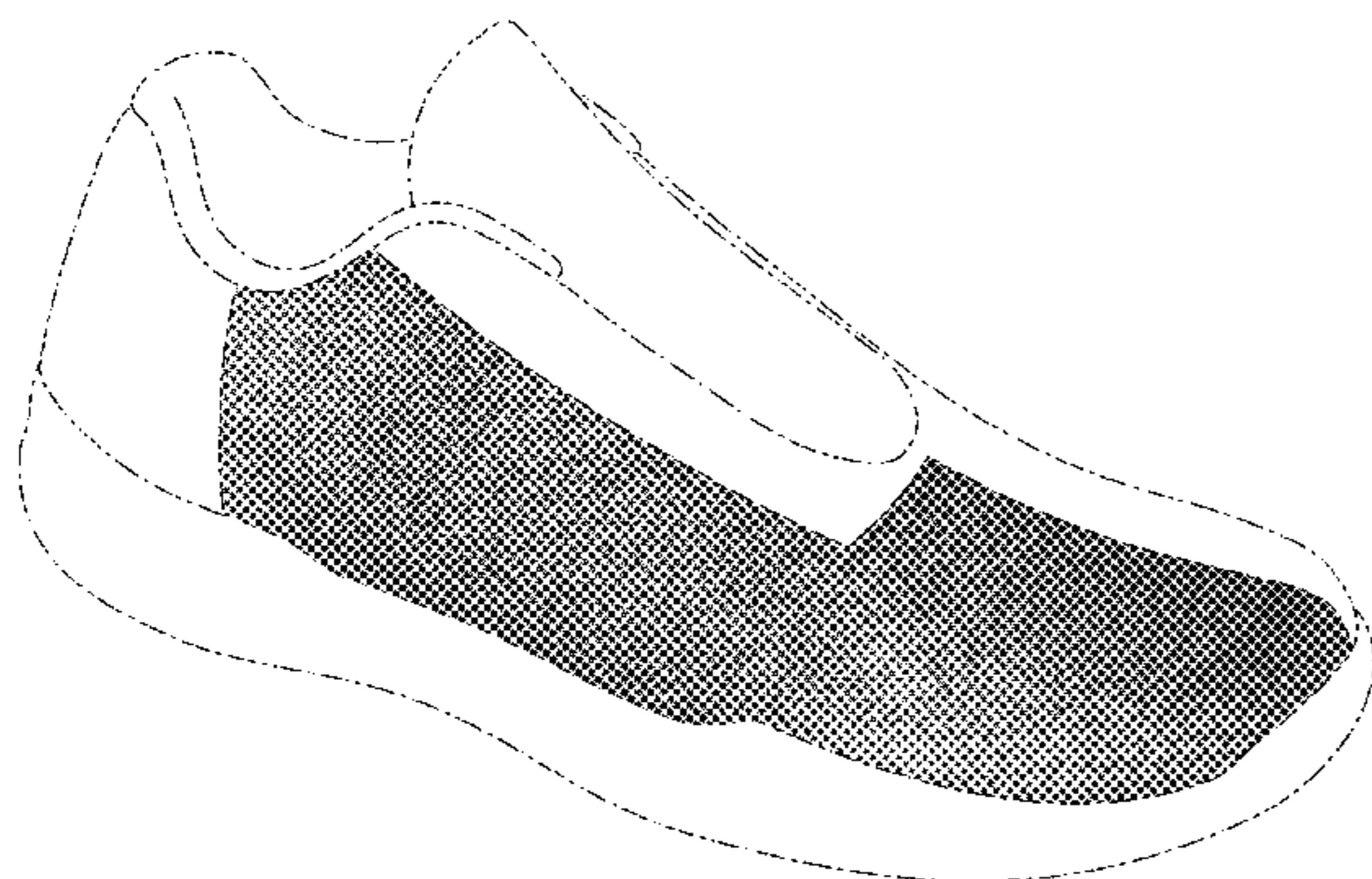

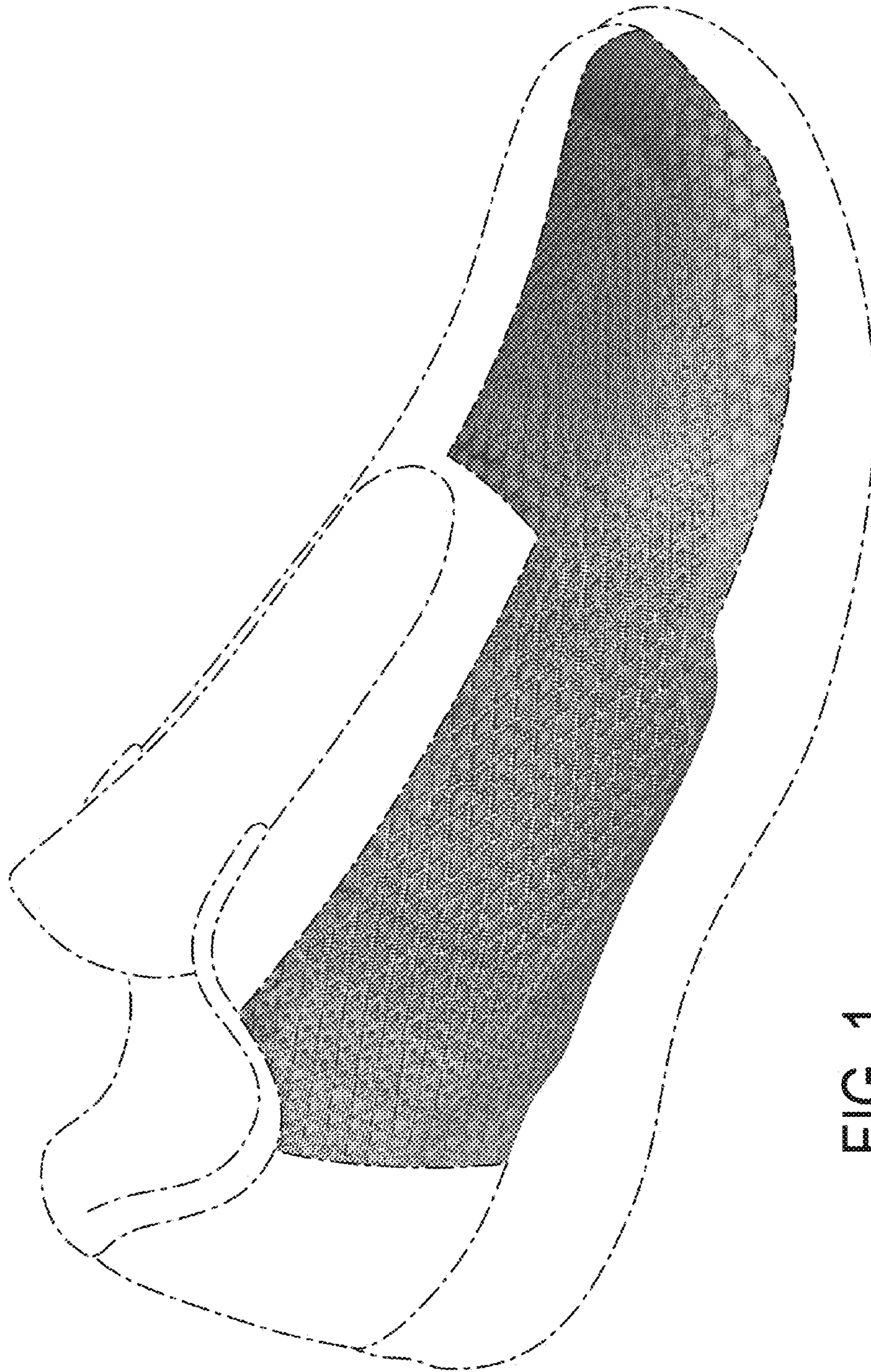

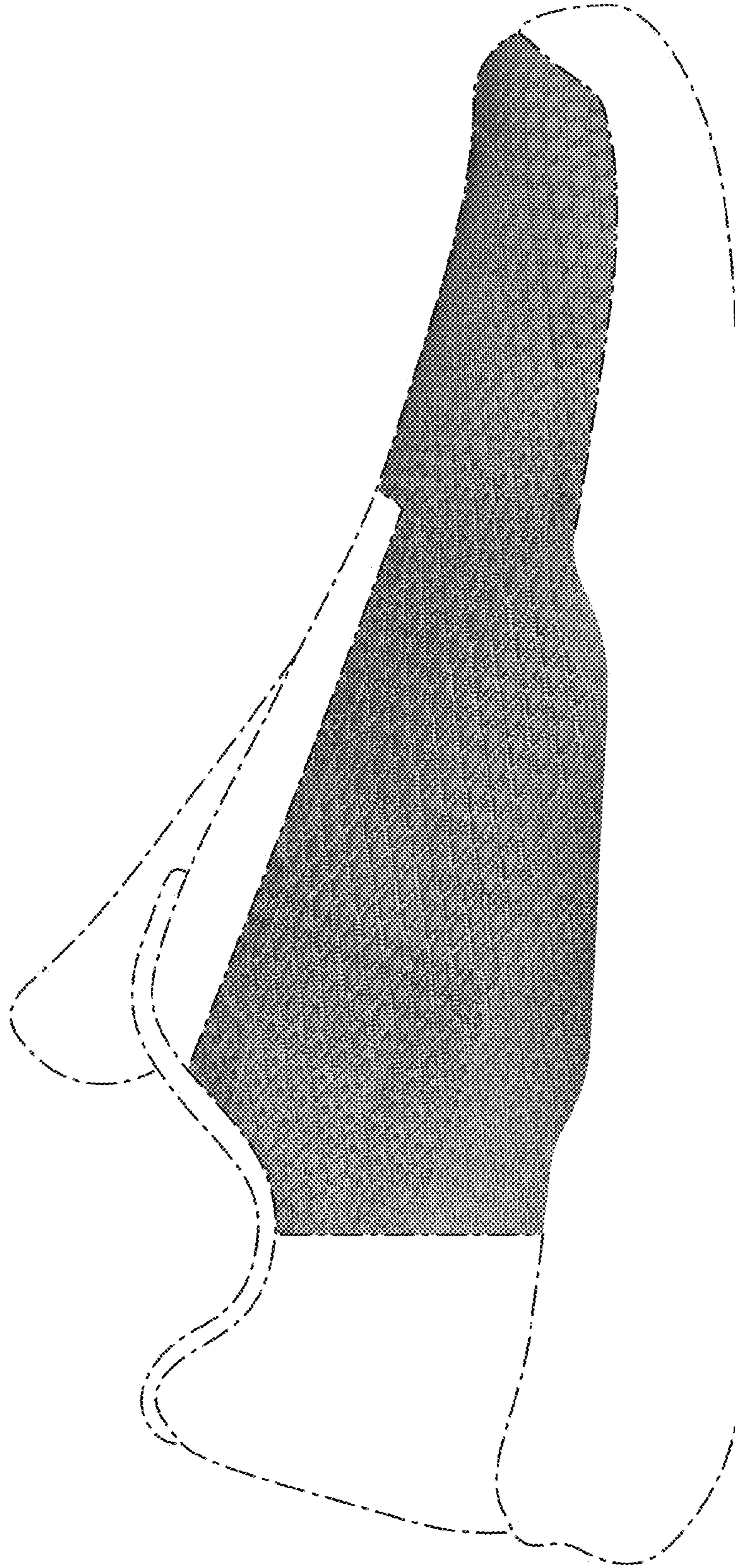

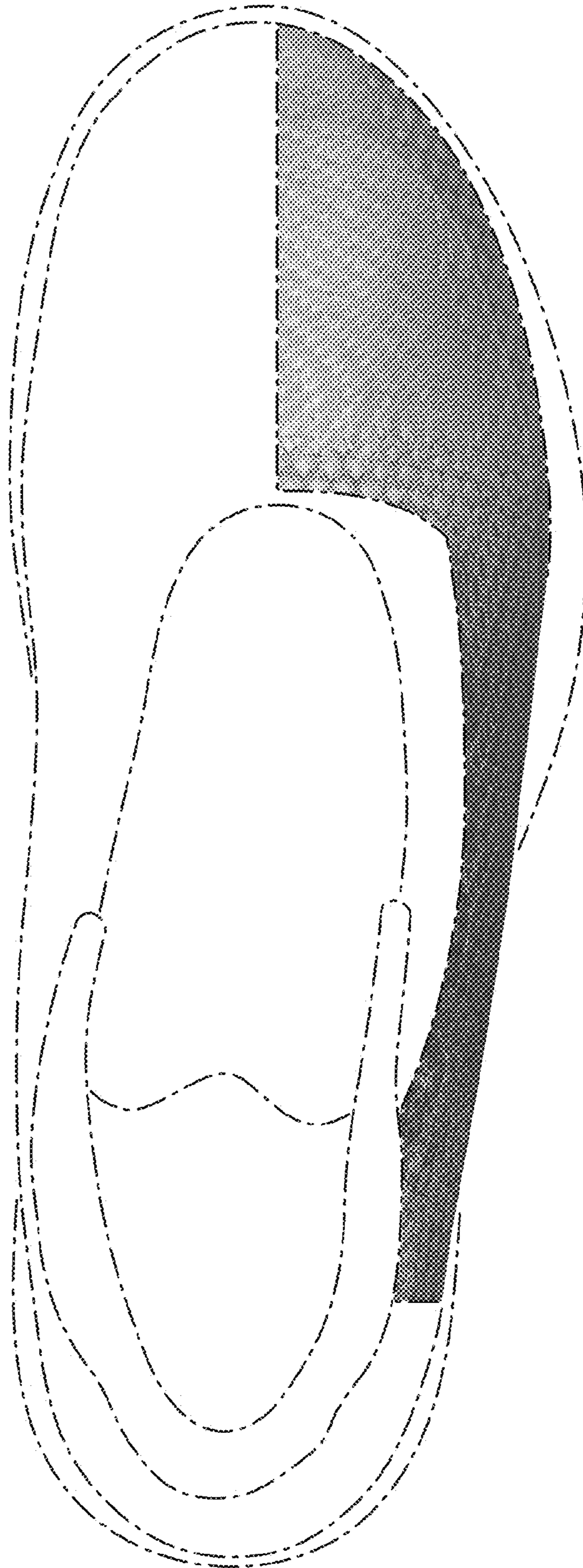
