(57) **CLAIM**

The ornamental design for a saddle block for a headphone stand, as shown and described.

**DESCRIPTION**

This application is related to an application entitled "Headphone Stand," Ser. No. 29/513,400, and filed on the same date herewith. The contents of that application are incorporated by reference herein in their entirety.

FIG. 1 is a perspective view of the saddle block for a headphone stand, illustrating my new design;

FIG. 2 is a side elevational view of the saddle block;

FIG. 3 is a front elevational view of the saddle block;

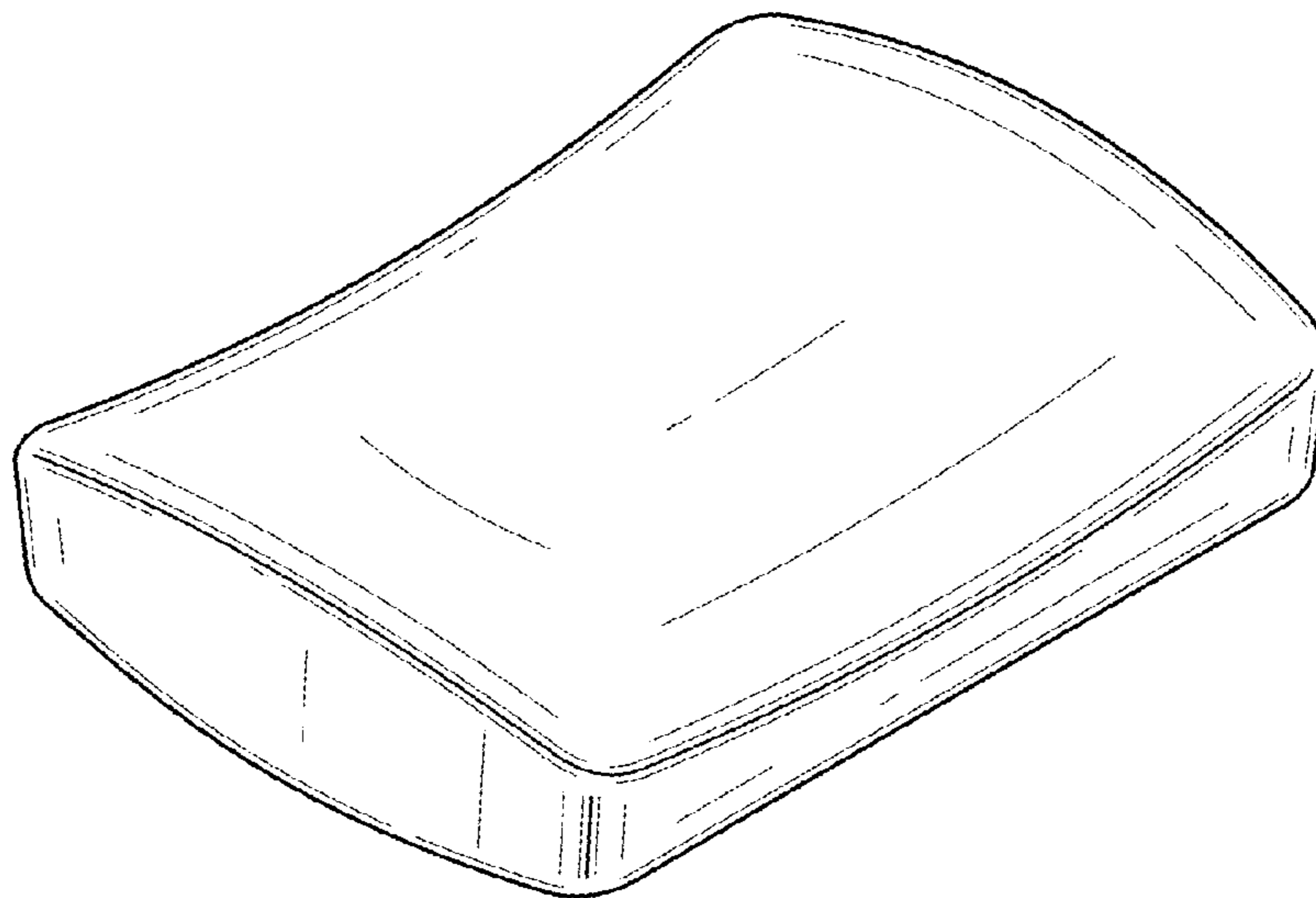
FIG. 4 is a rear elevational view of the saddle block;

FIG. 5 is a top plan view of the saddle block; and,

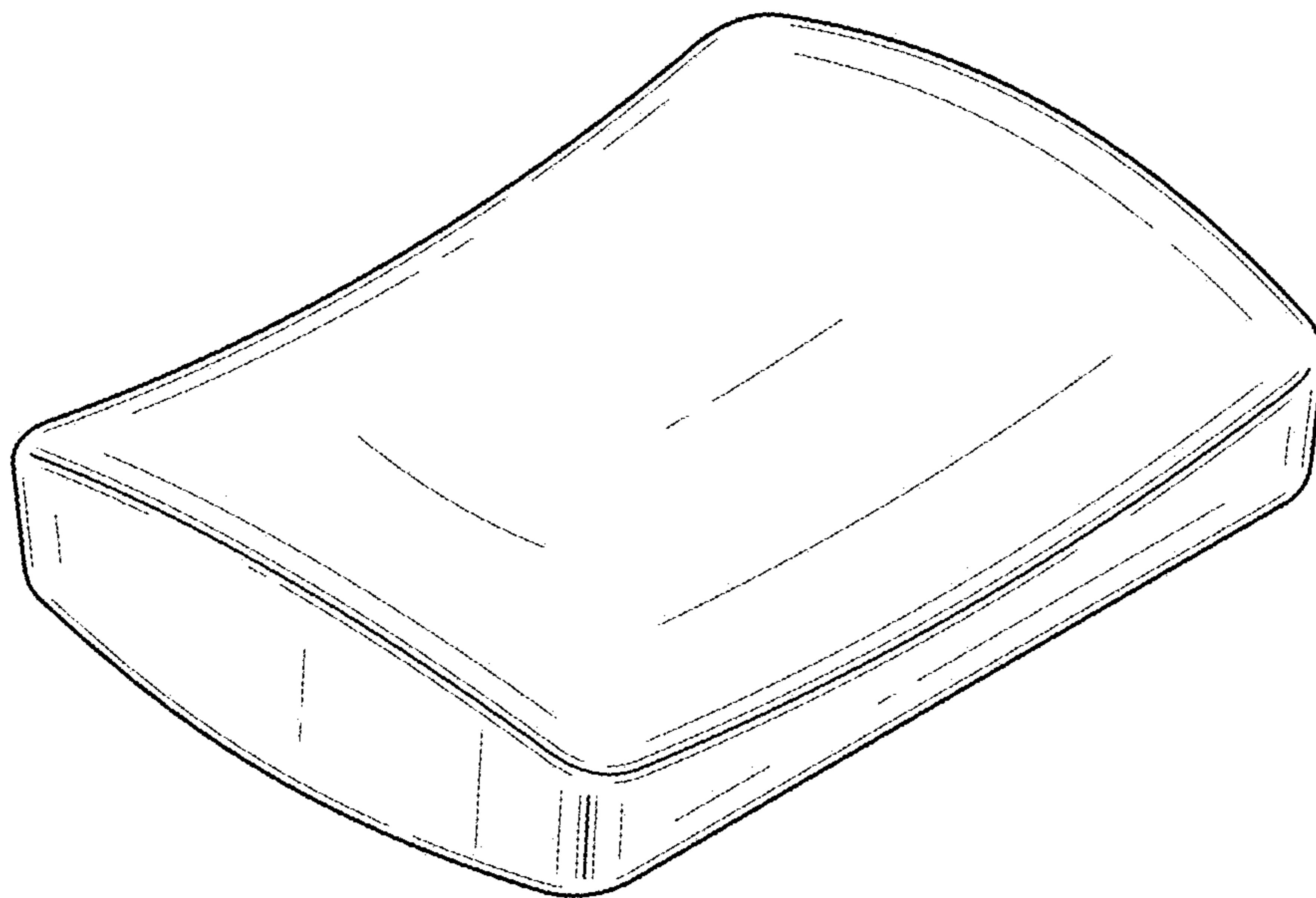

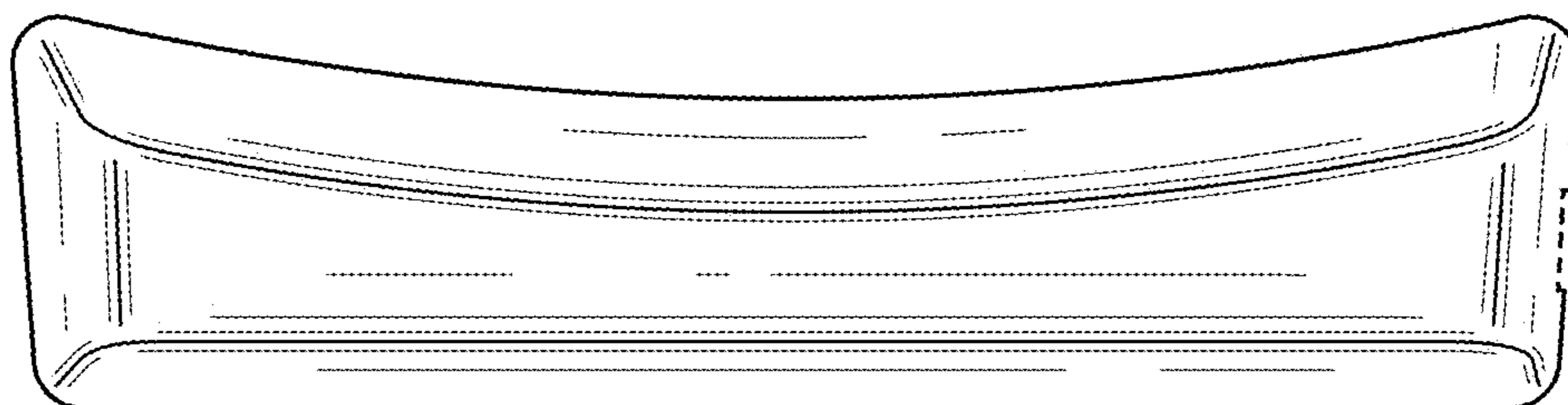

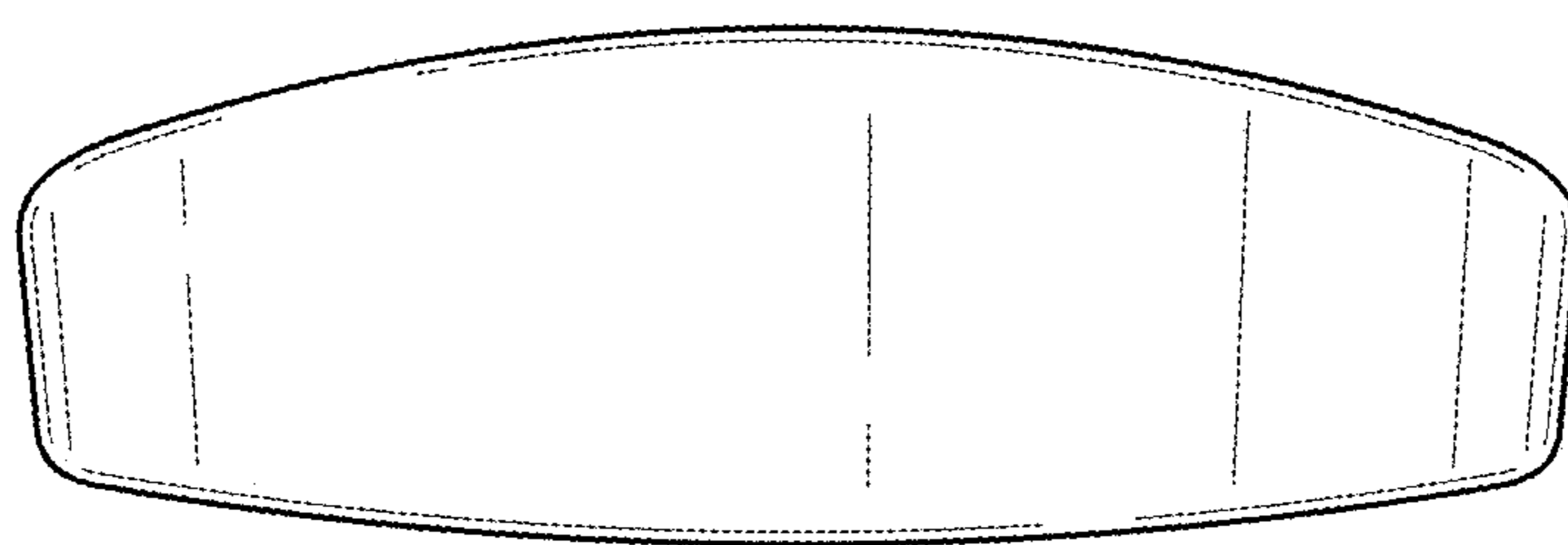

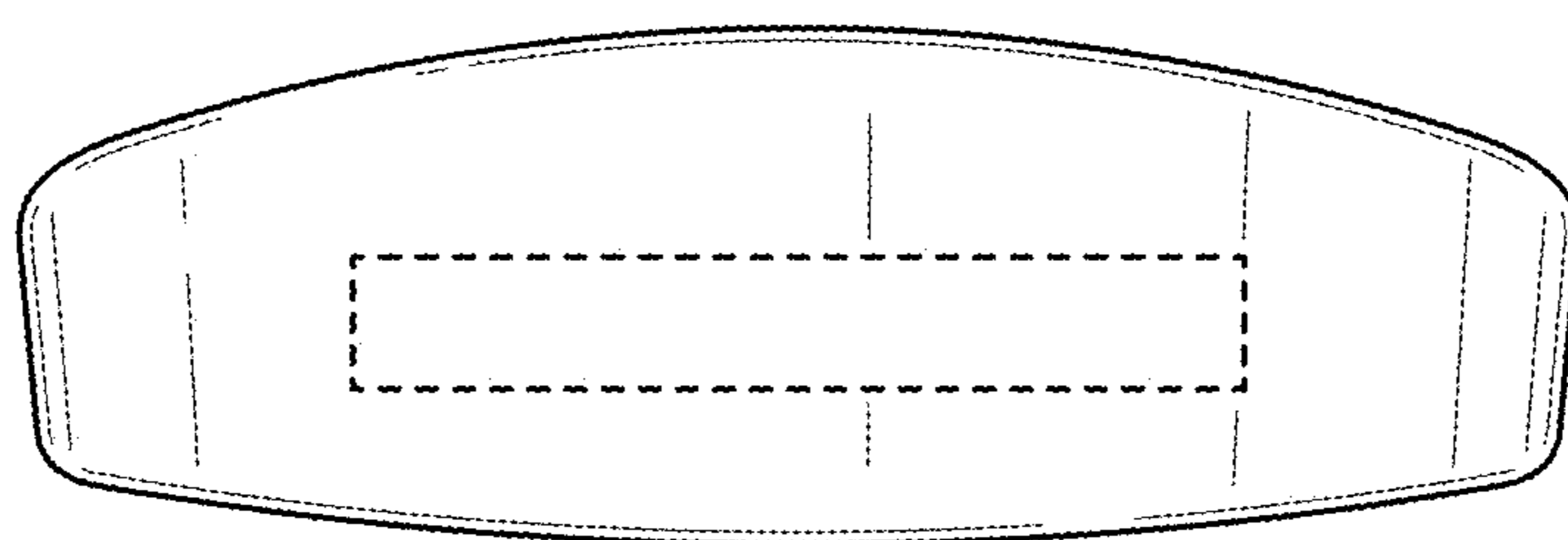

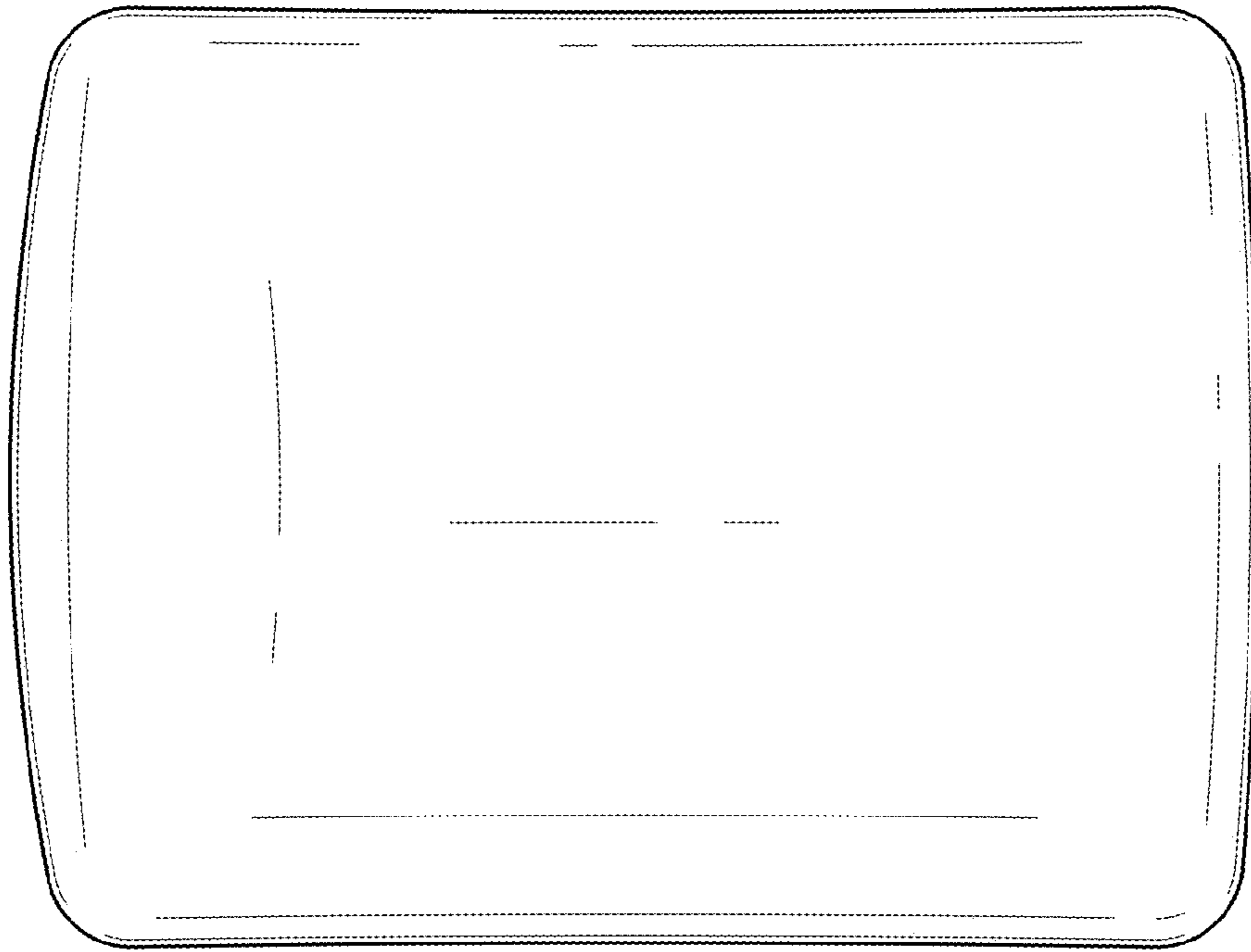

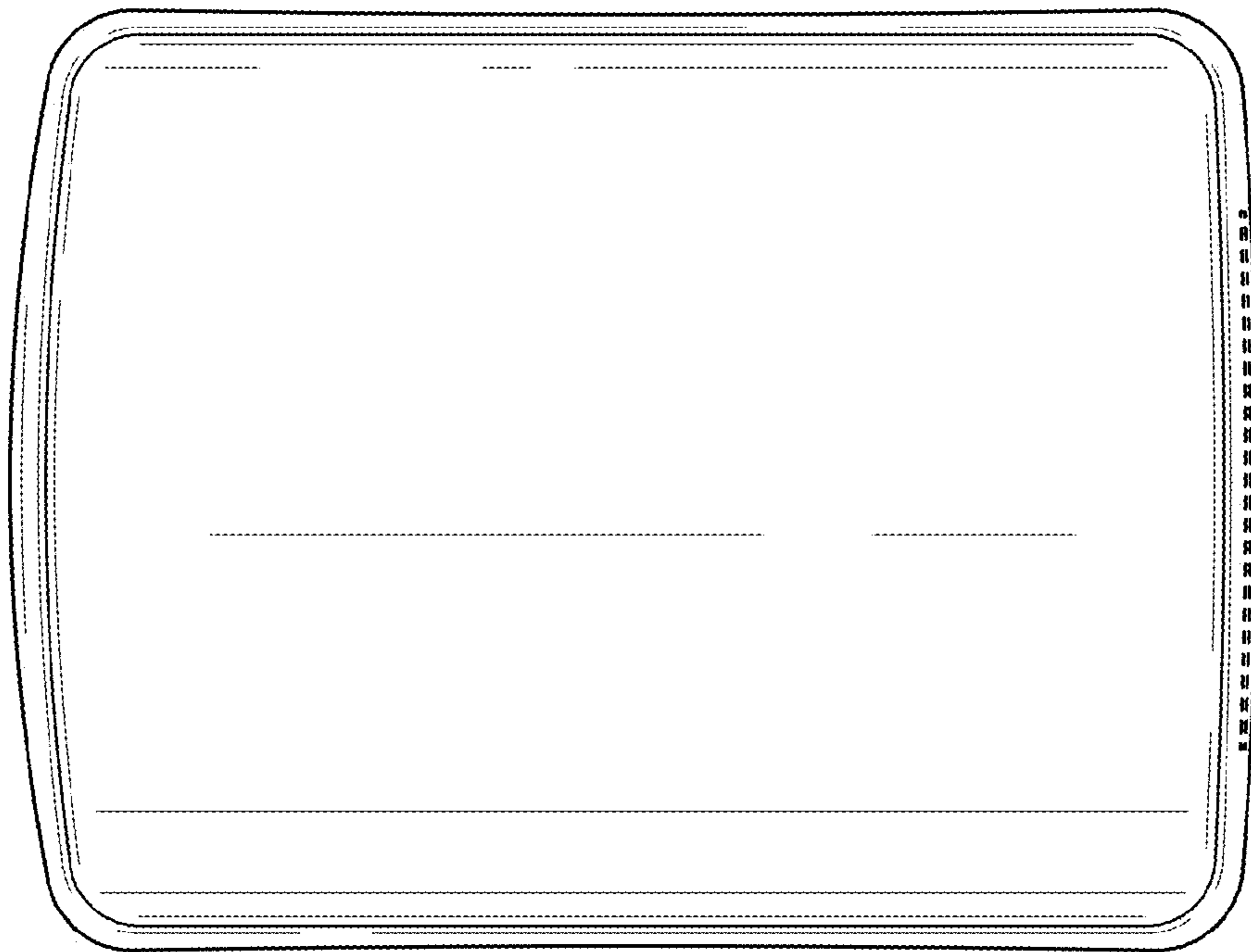
