(57) **CLAIM**

We claim the ornamental design for a cutting disk, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a cutting disk;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

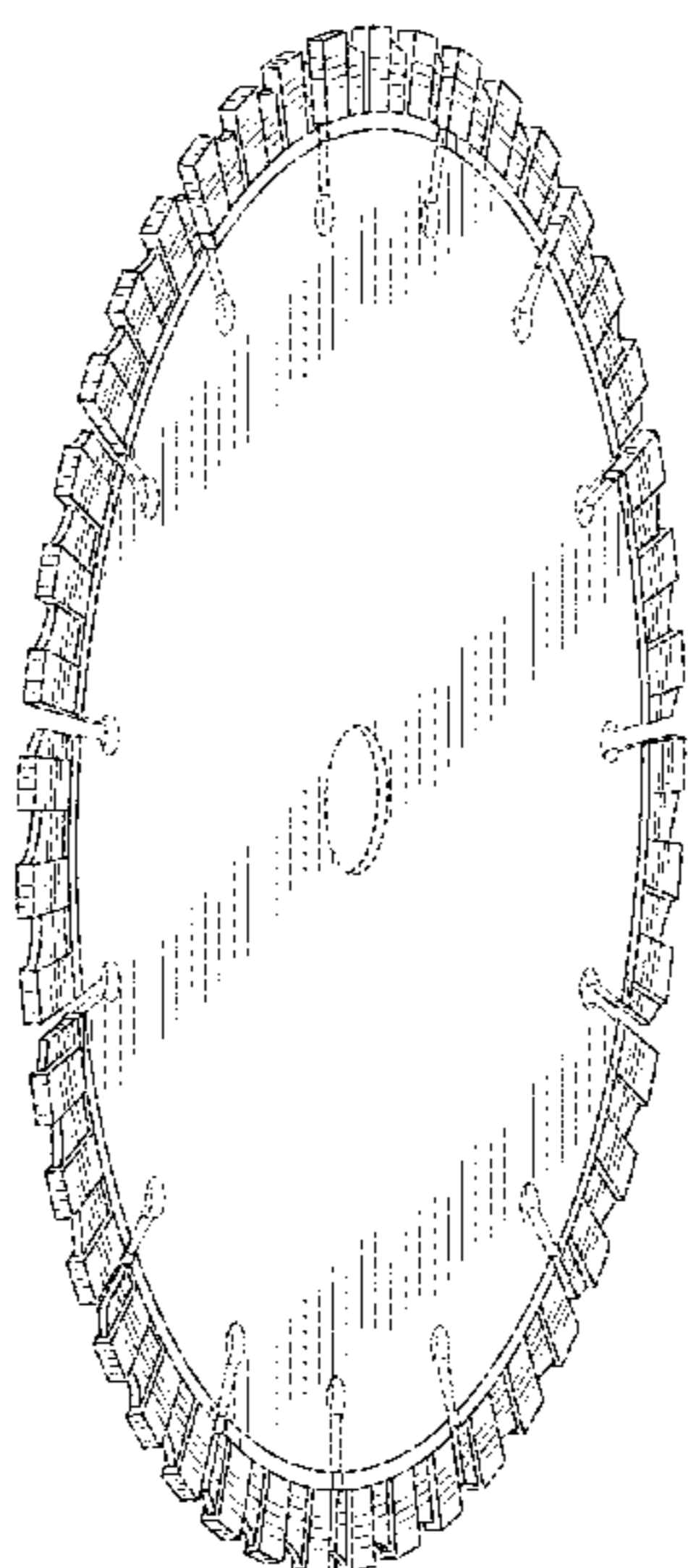
FIG. 4 is a left side elevational view thereof; and,

FIG. 5 is an enlarged view taken from the area '5' in FIG. 2.

The right side view is a mirror image of FIG. 4 and is therefore not illustrated.

The even length broken lines depict unclaimed portions of the cutting disk. The dot-dash broken lines depict the location and boundaries of detailed views and form no part of the claimed design.

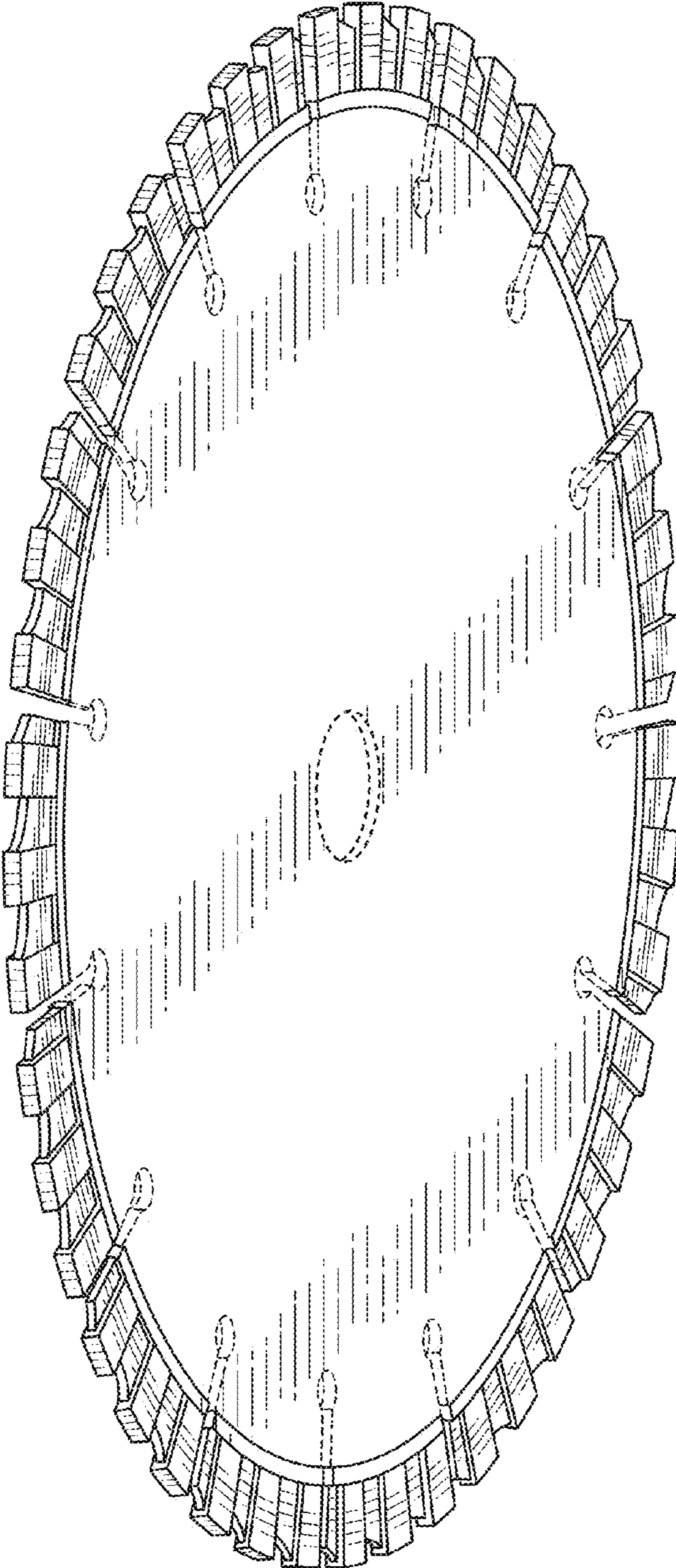

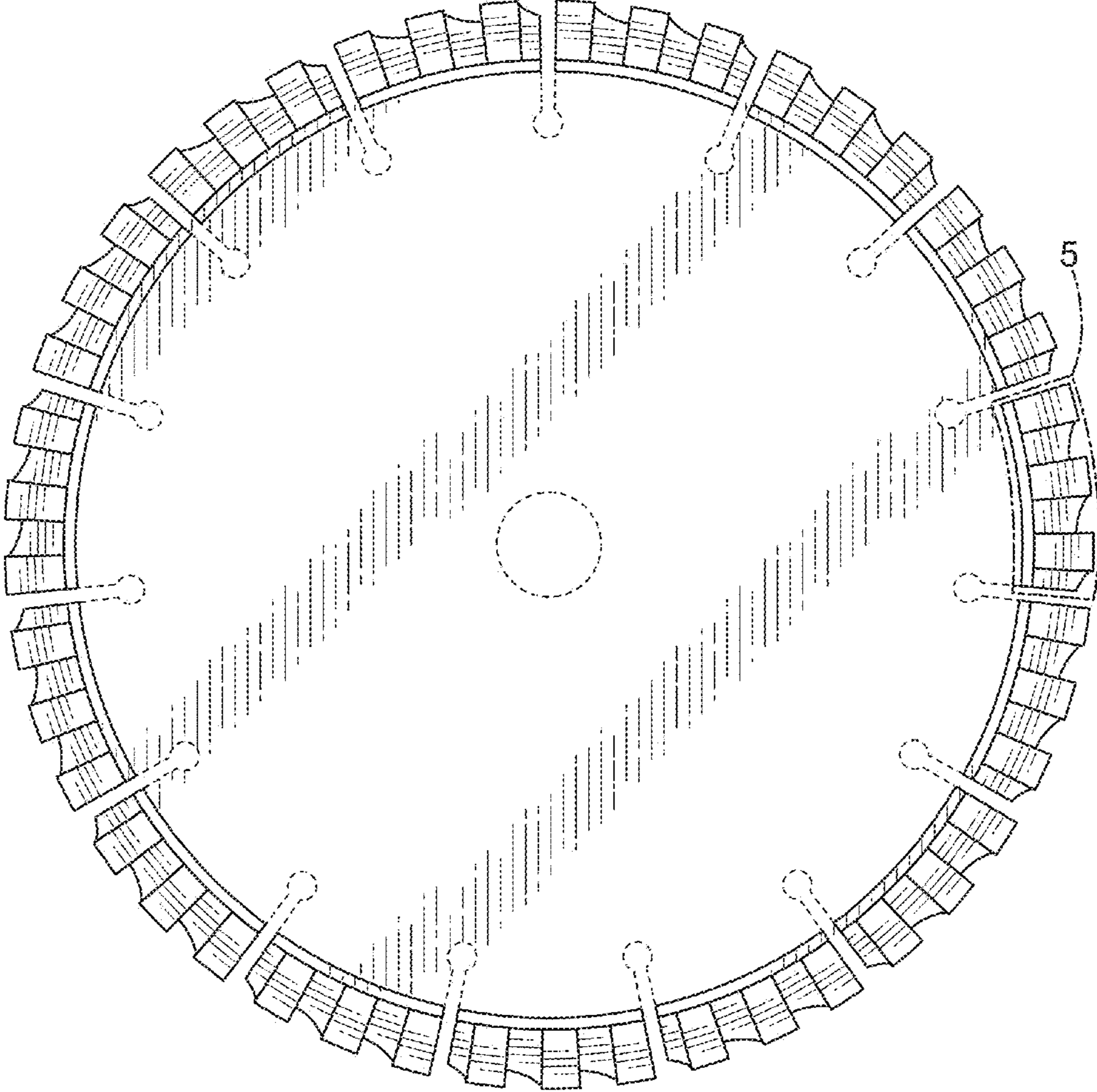

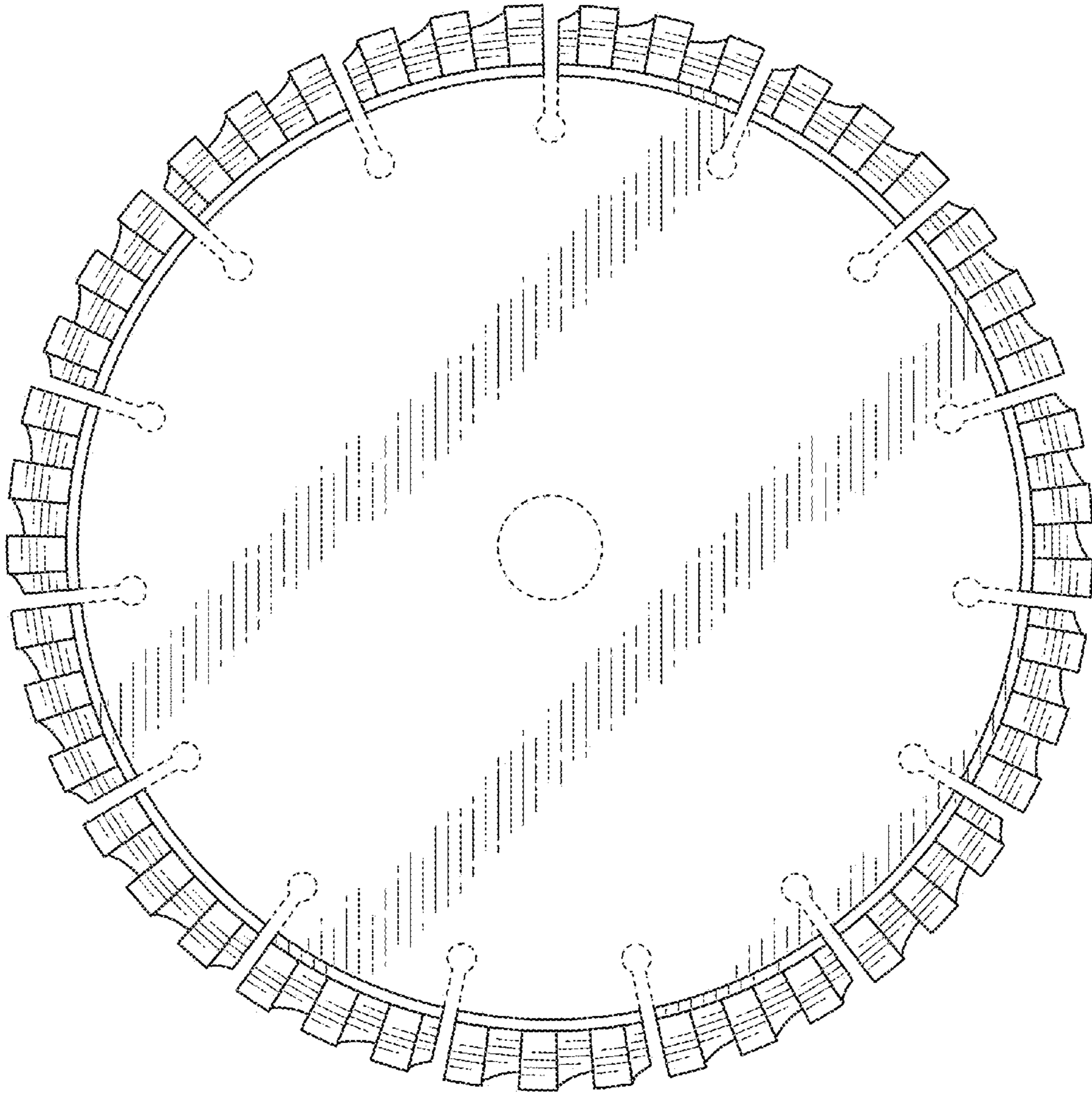

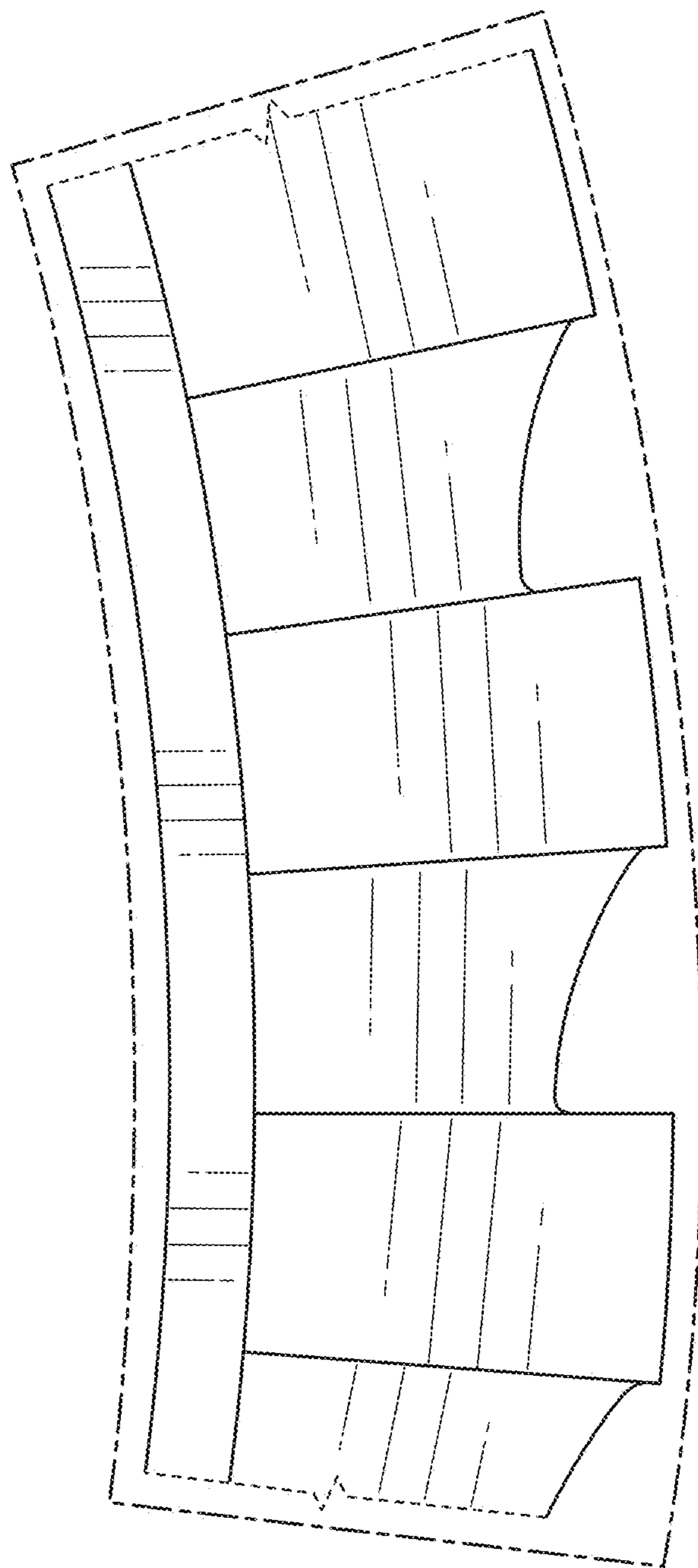
