The ornamental design for a portion of container, as shown and described.

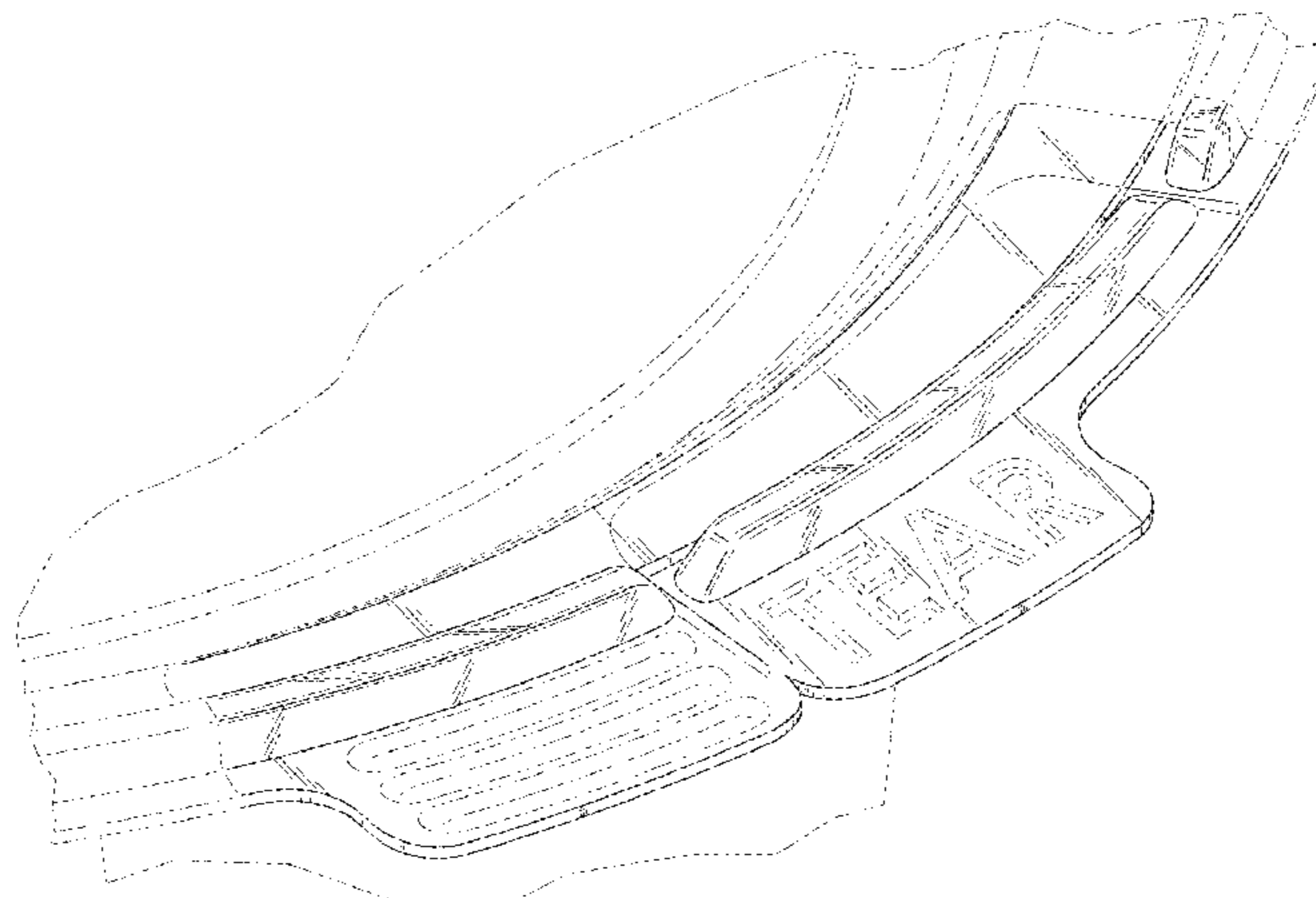
**DESCRIPTION**

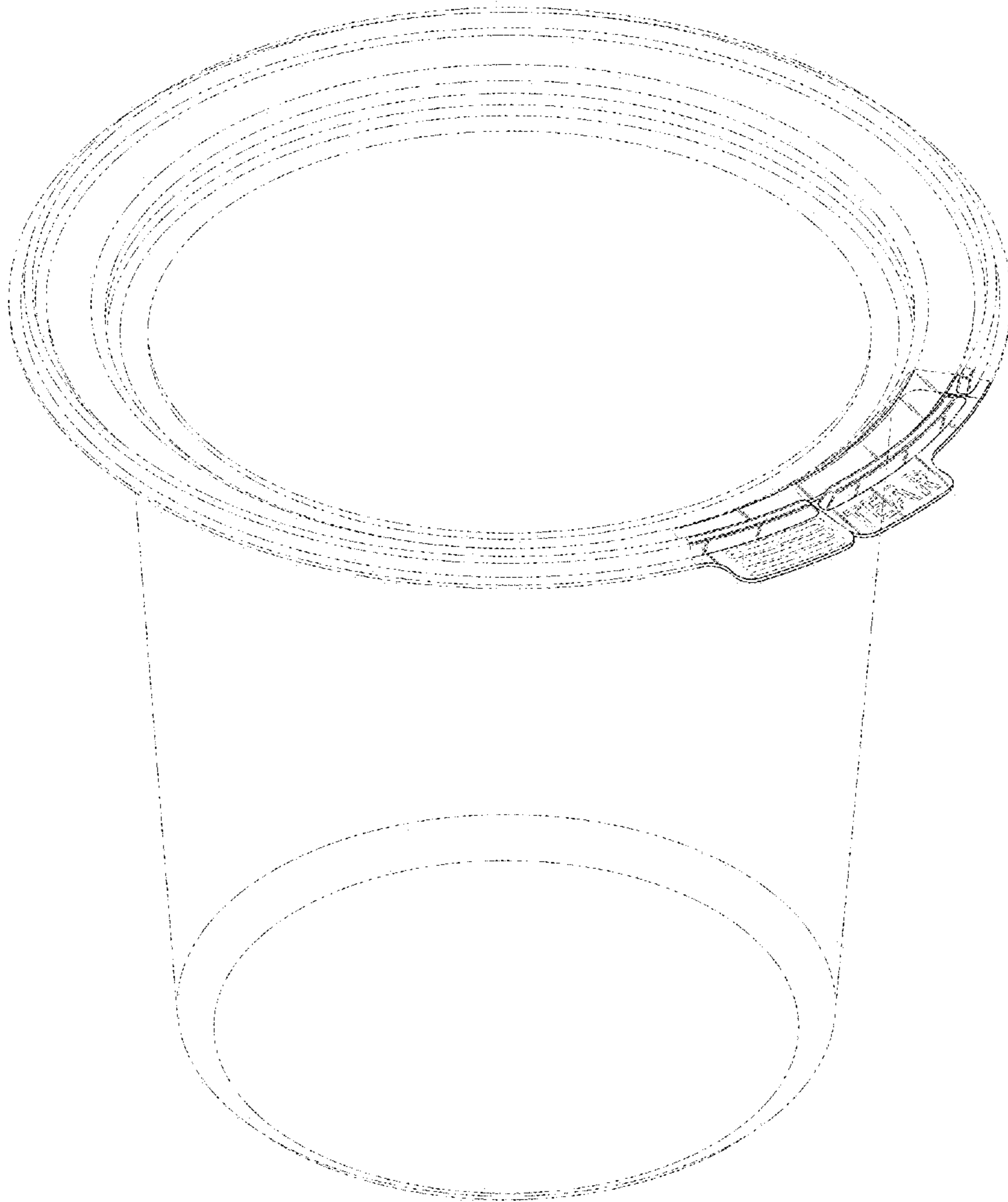

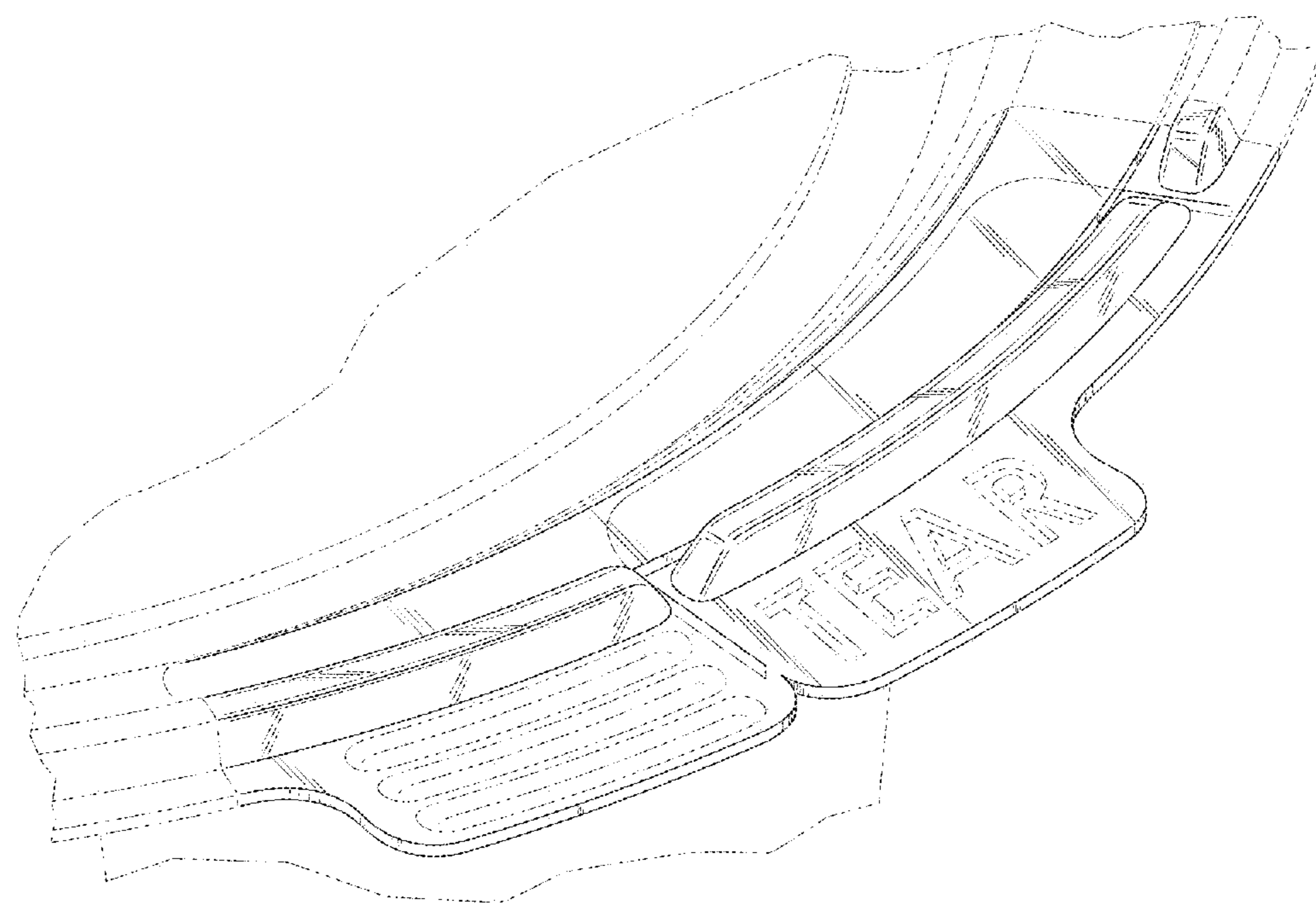

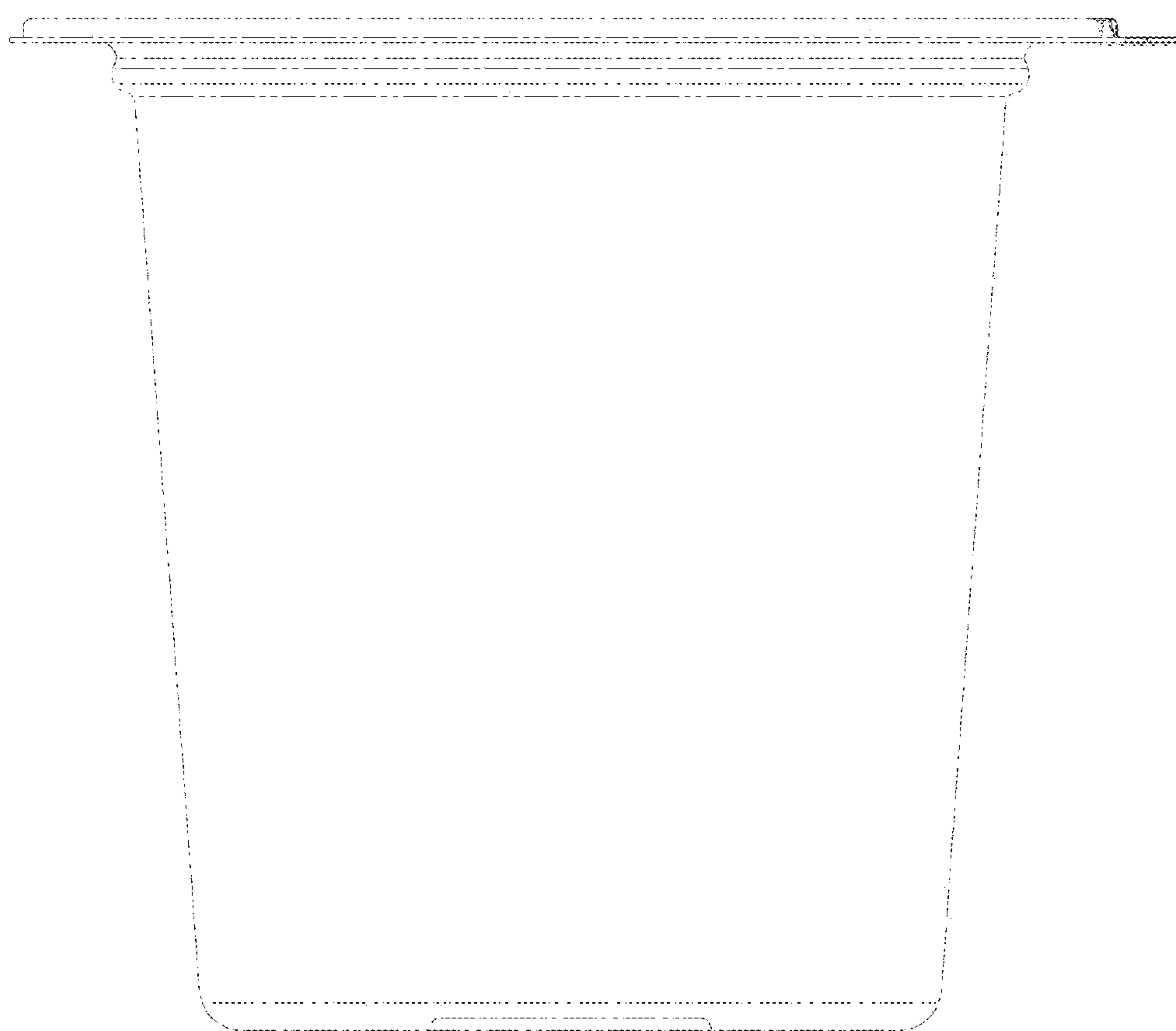

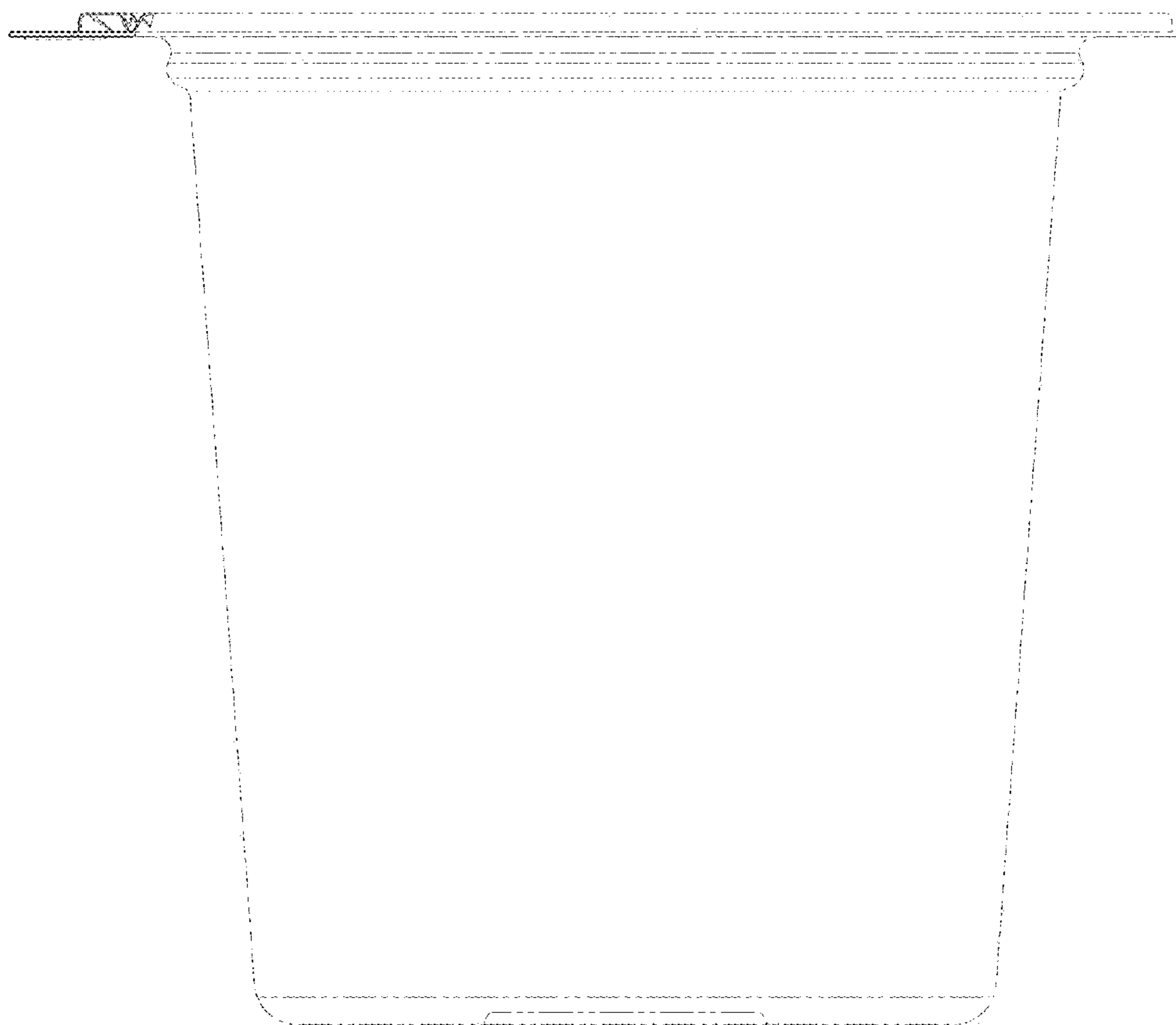

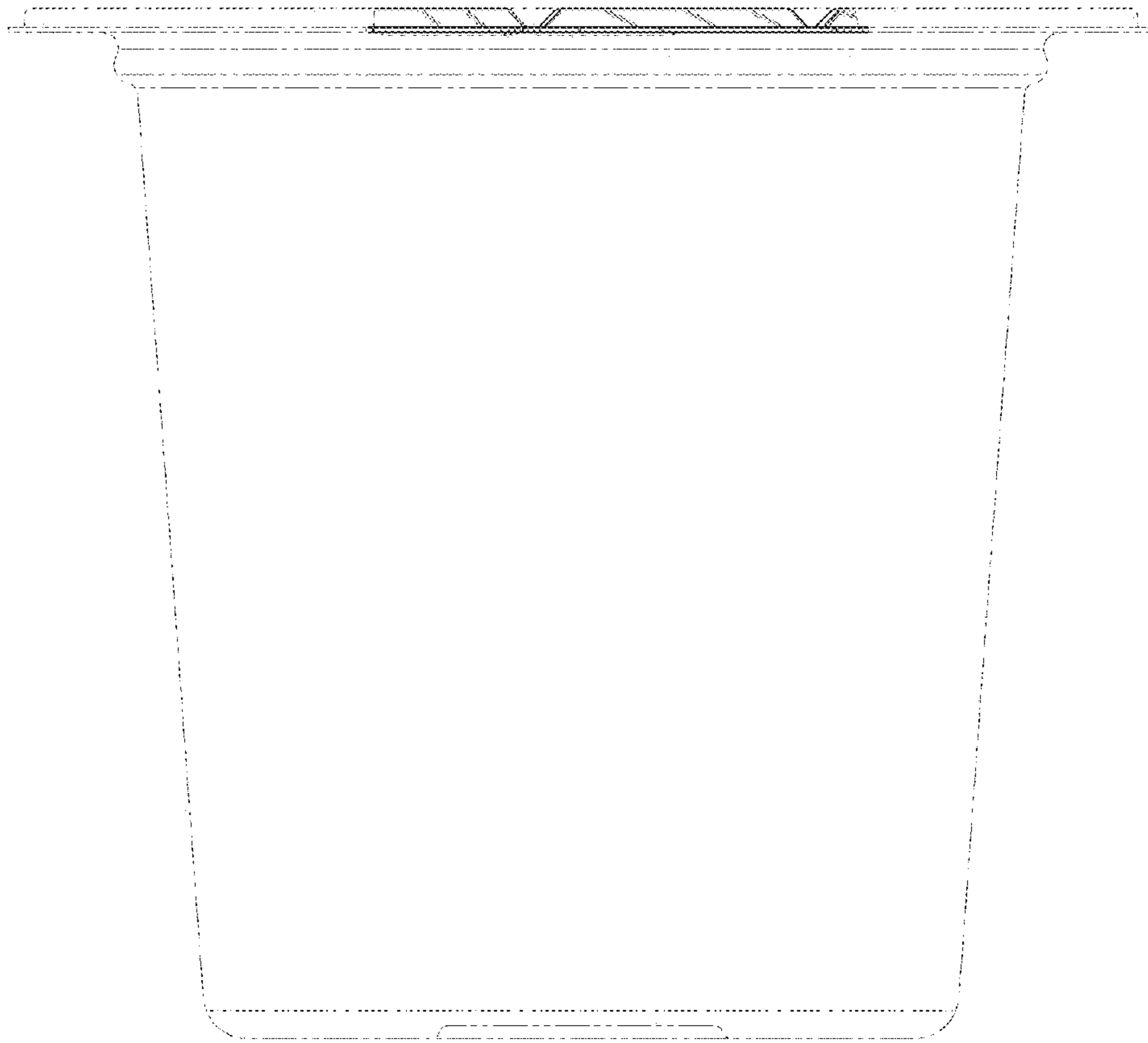

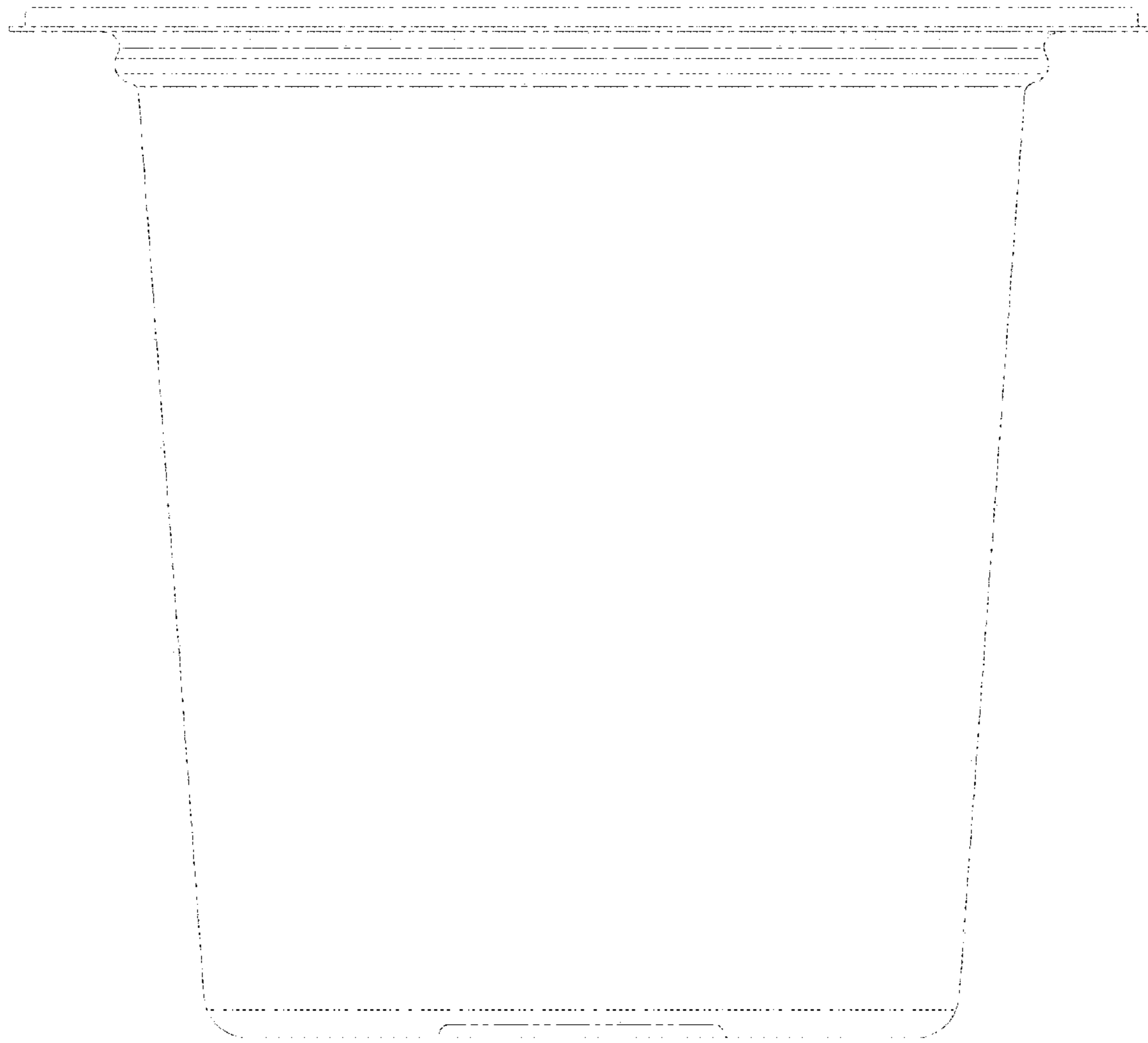

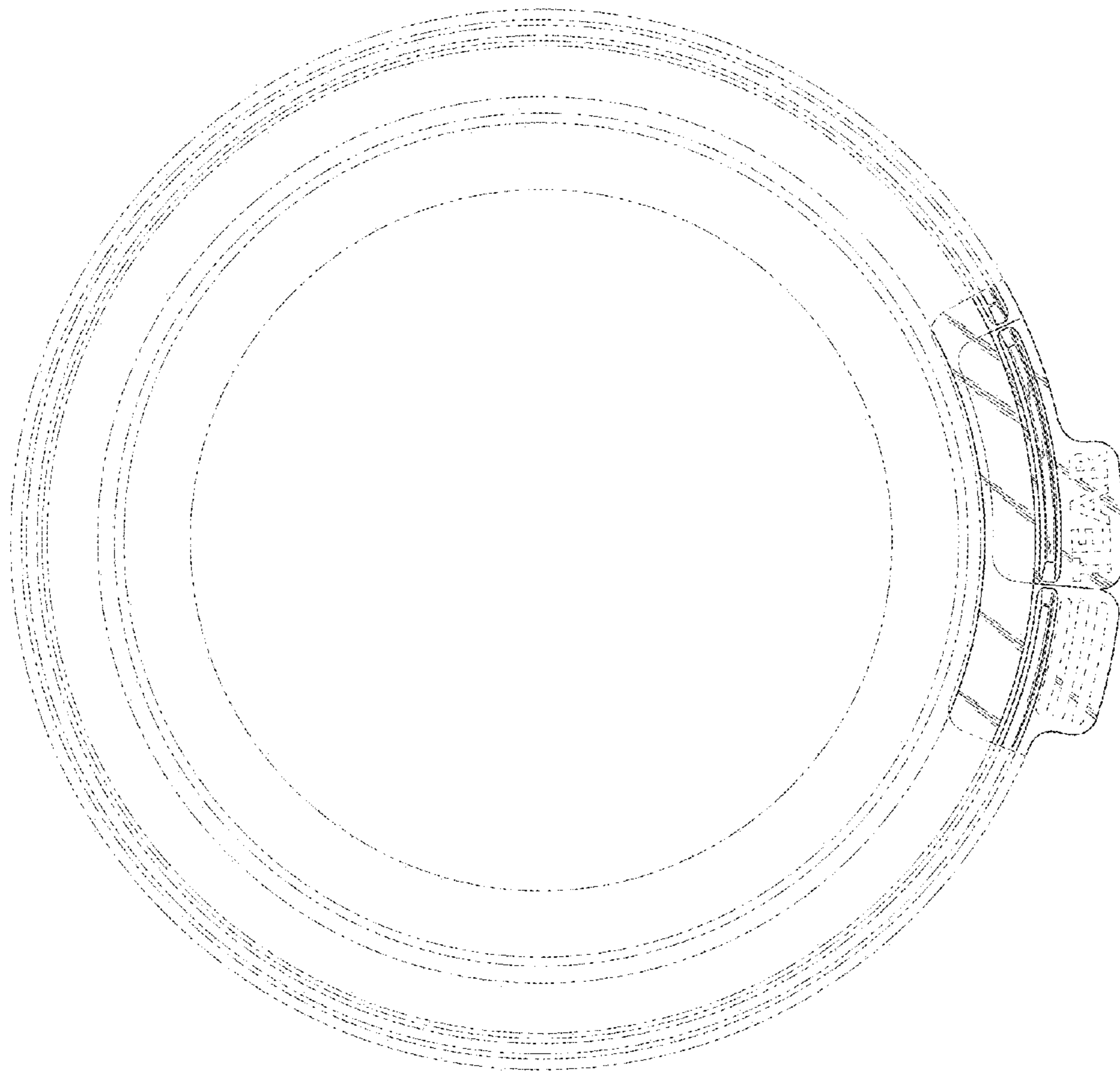

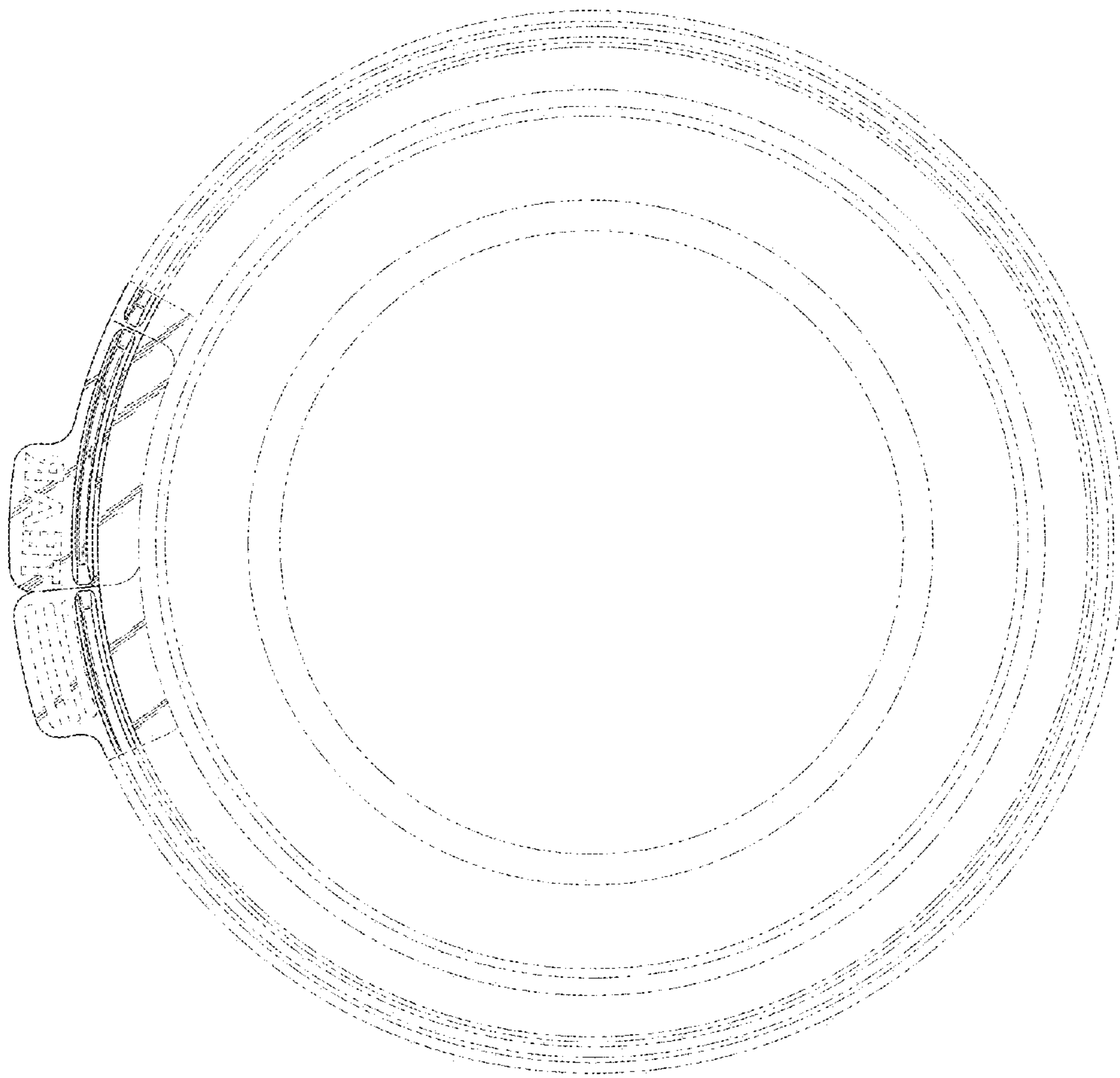
