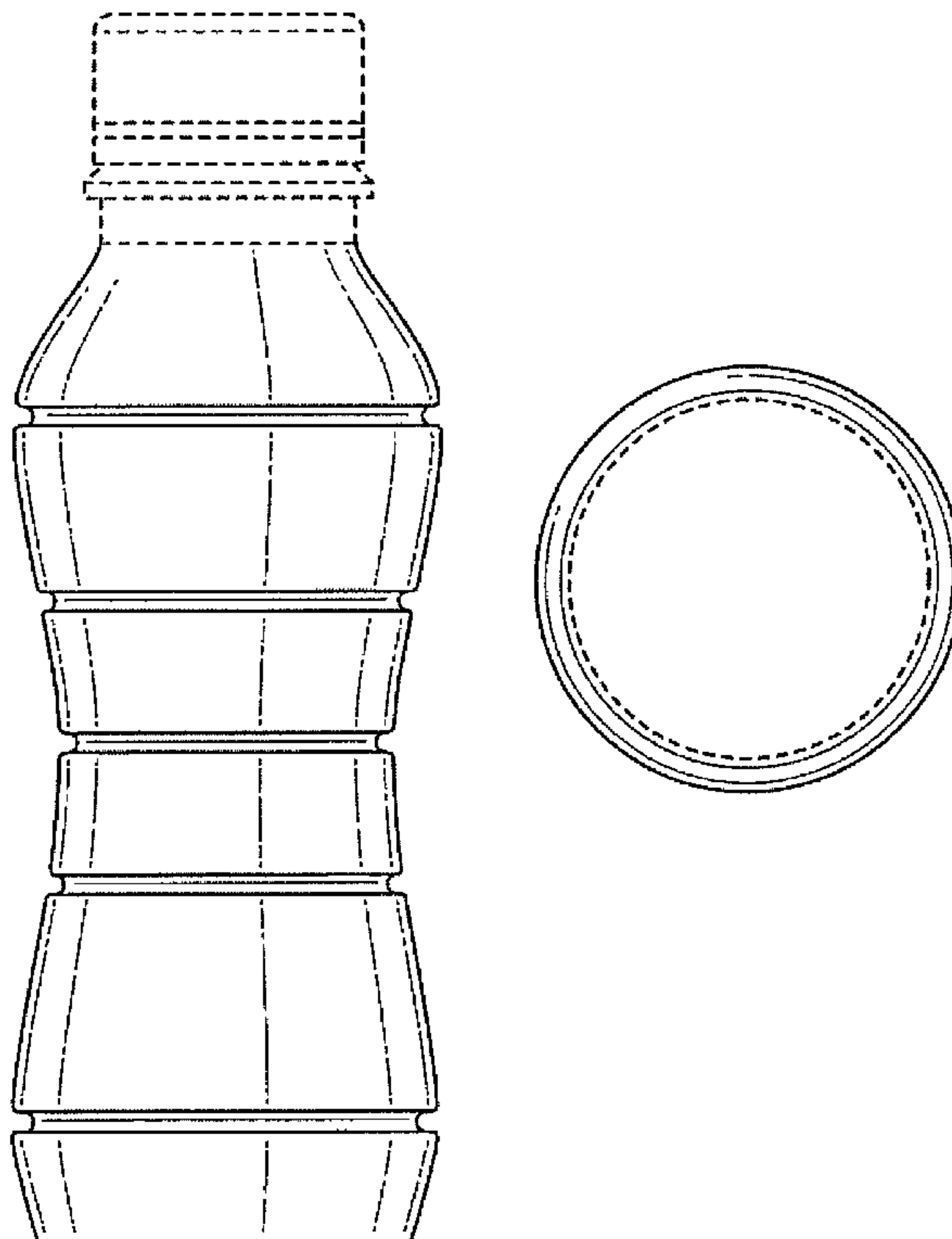
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of our new design for a container.
FIG. 2 is a front view of the container of FIG. 1.

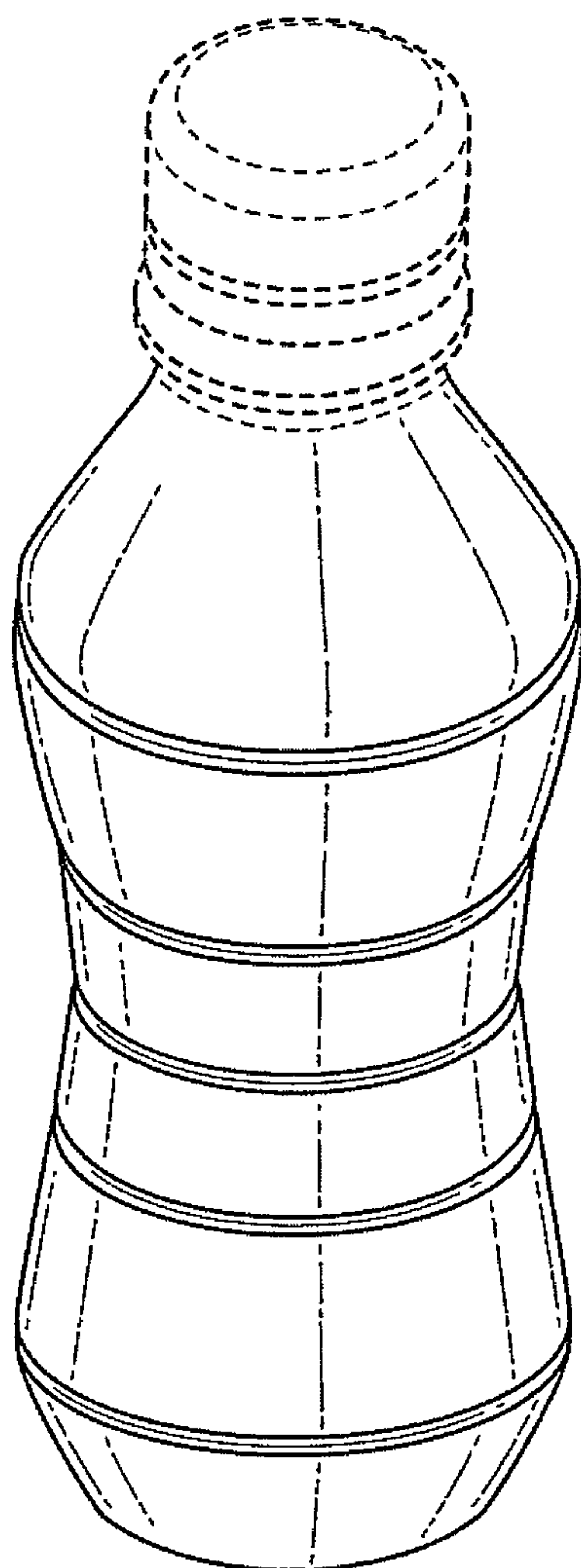

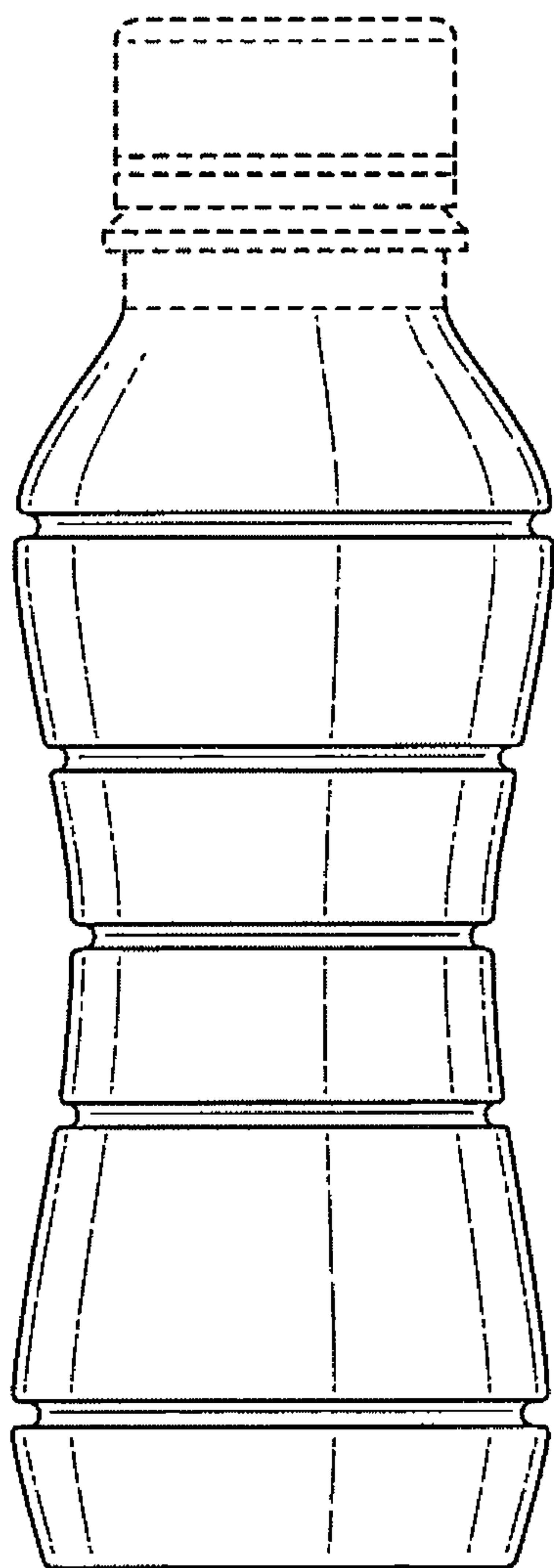

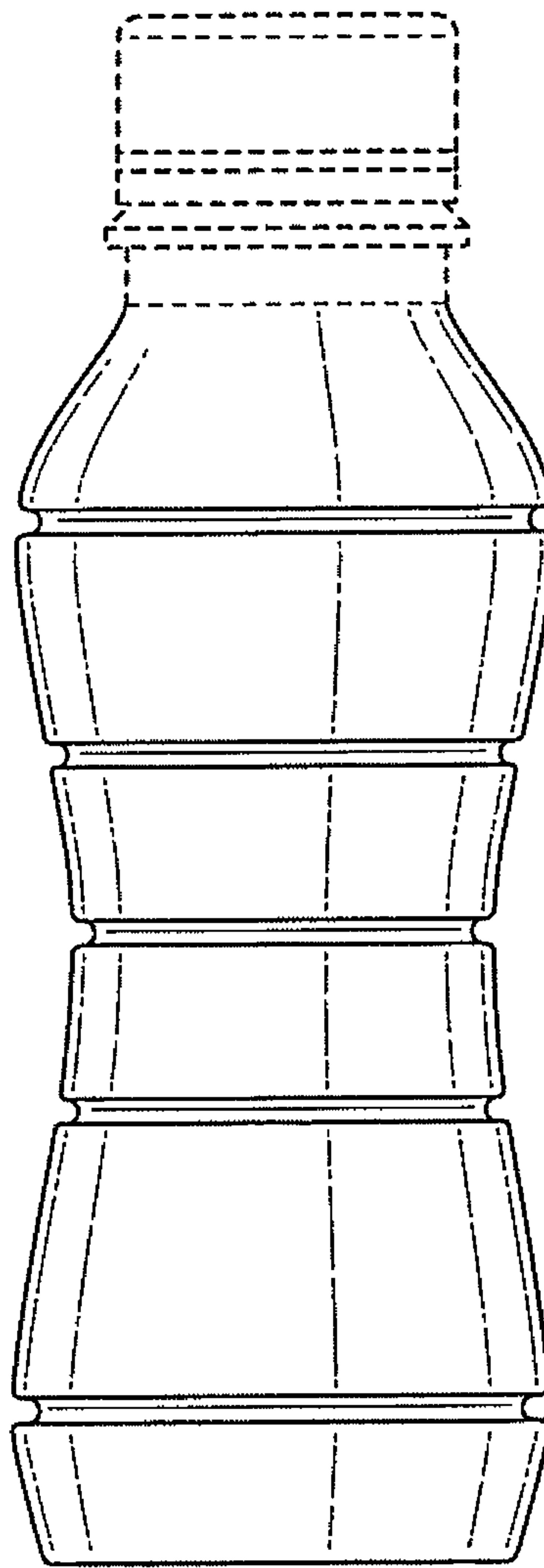

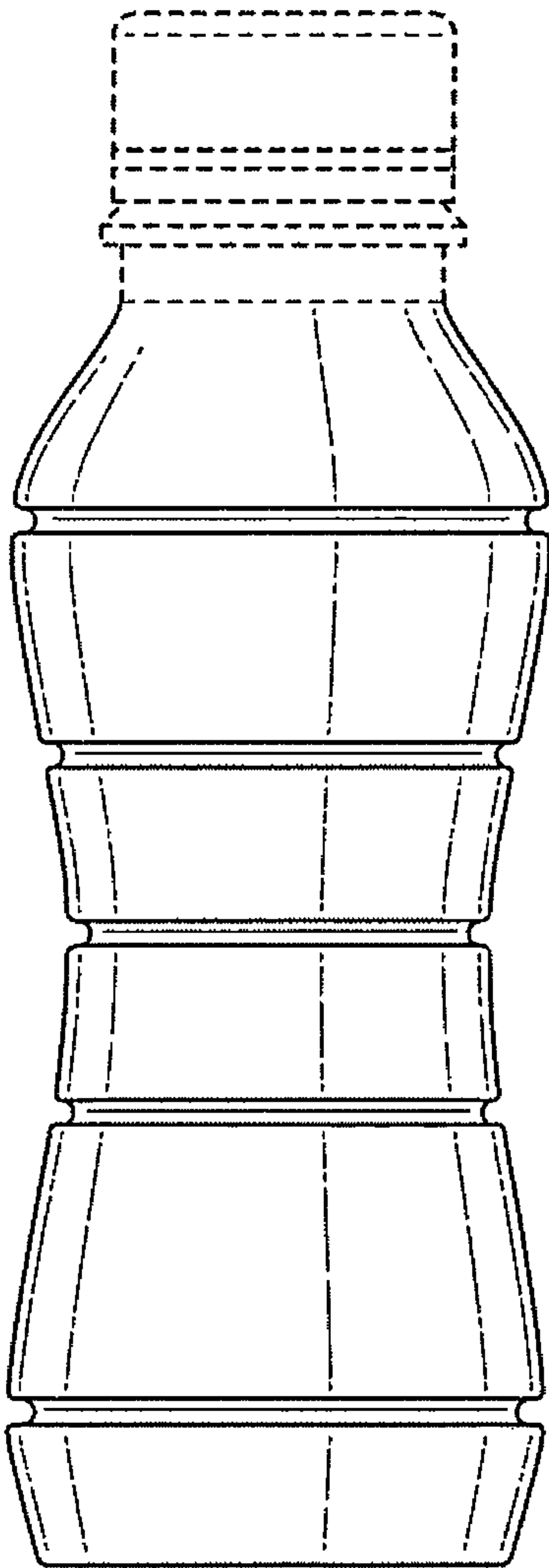

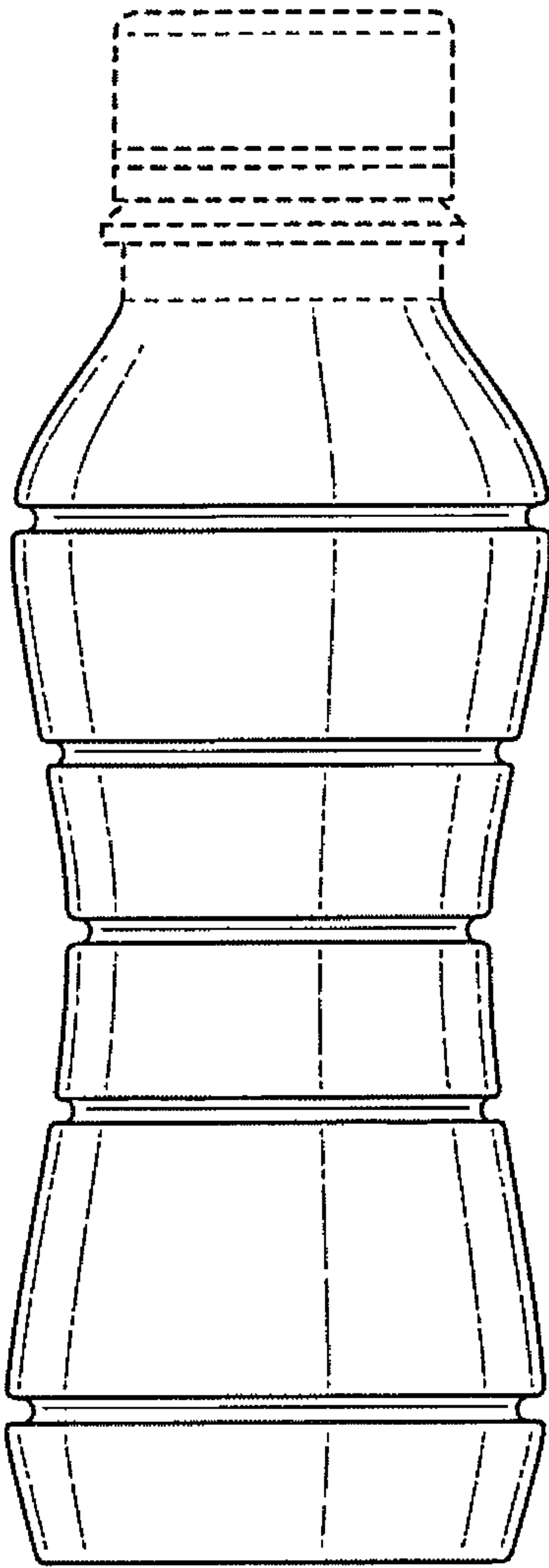

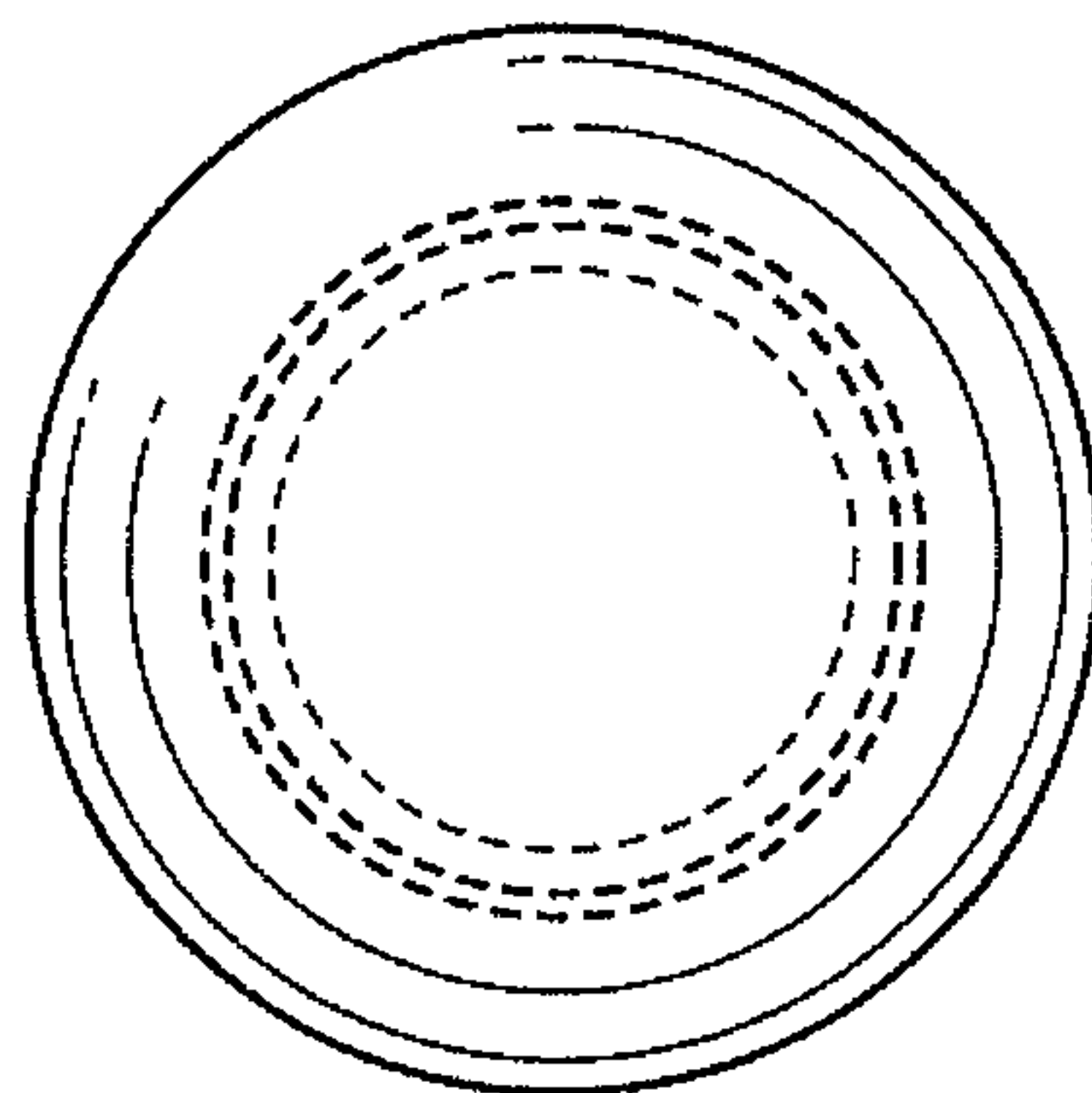

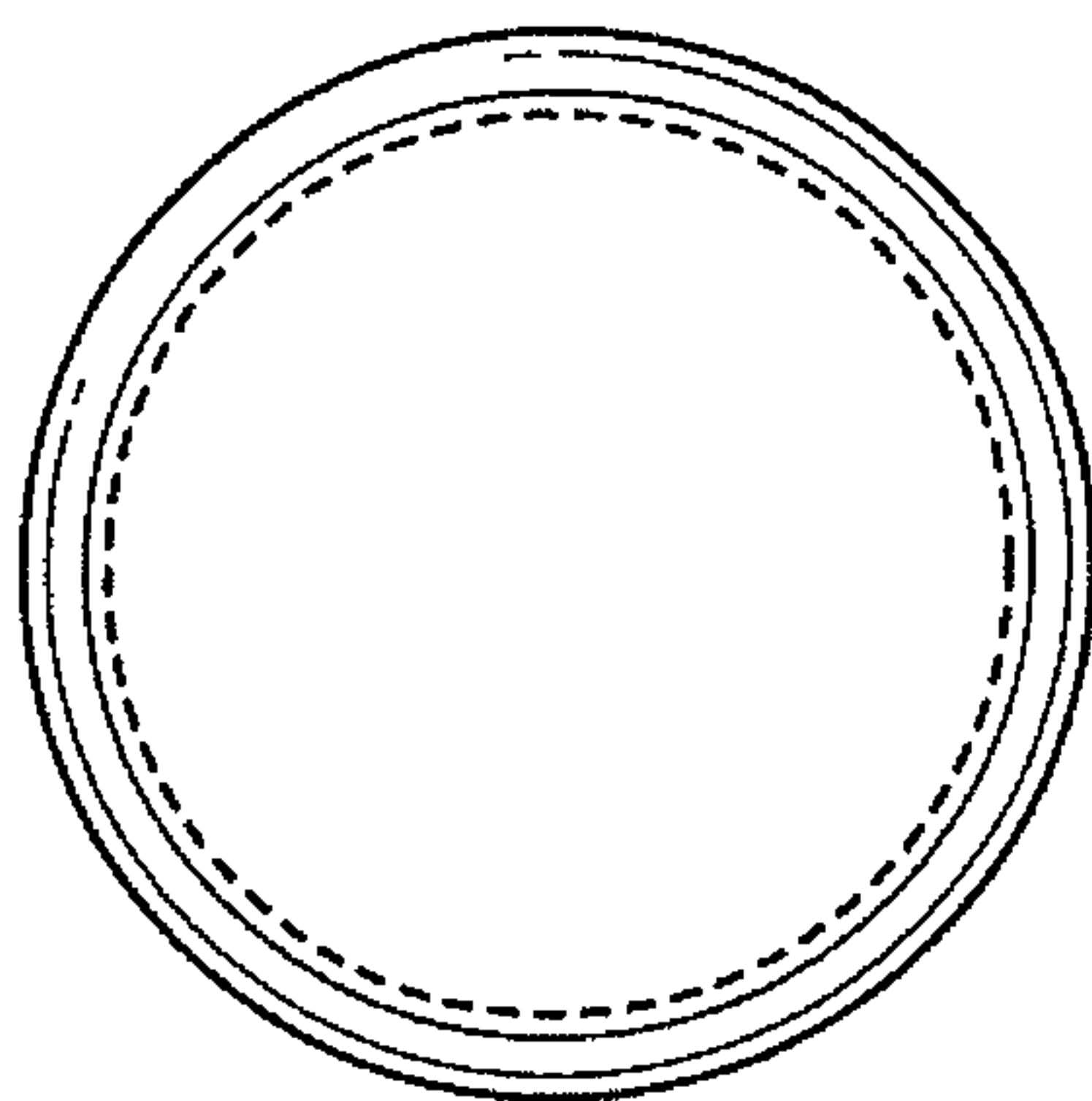
