(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a bottle showing my new design (with the rear view being the same);

FIG. 2 is a side view of the bottle shown in FIG. 1 (with the other side view being the same)

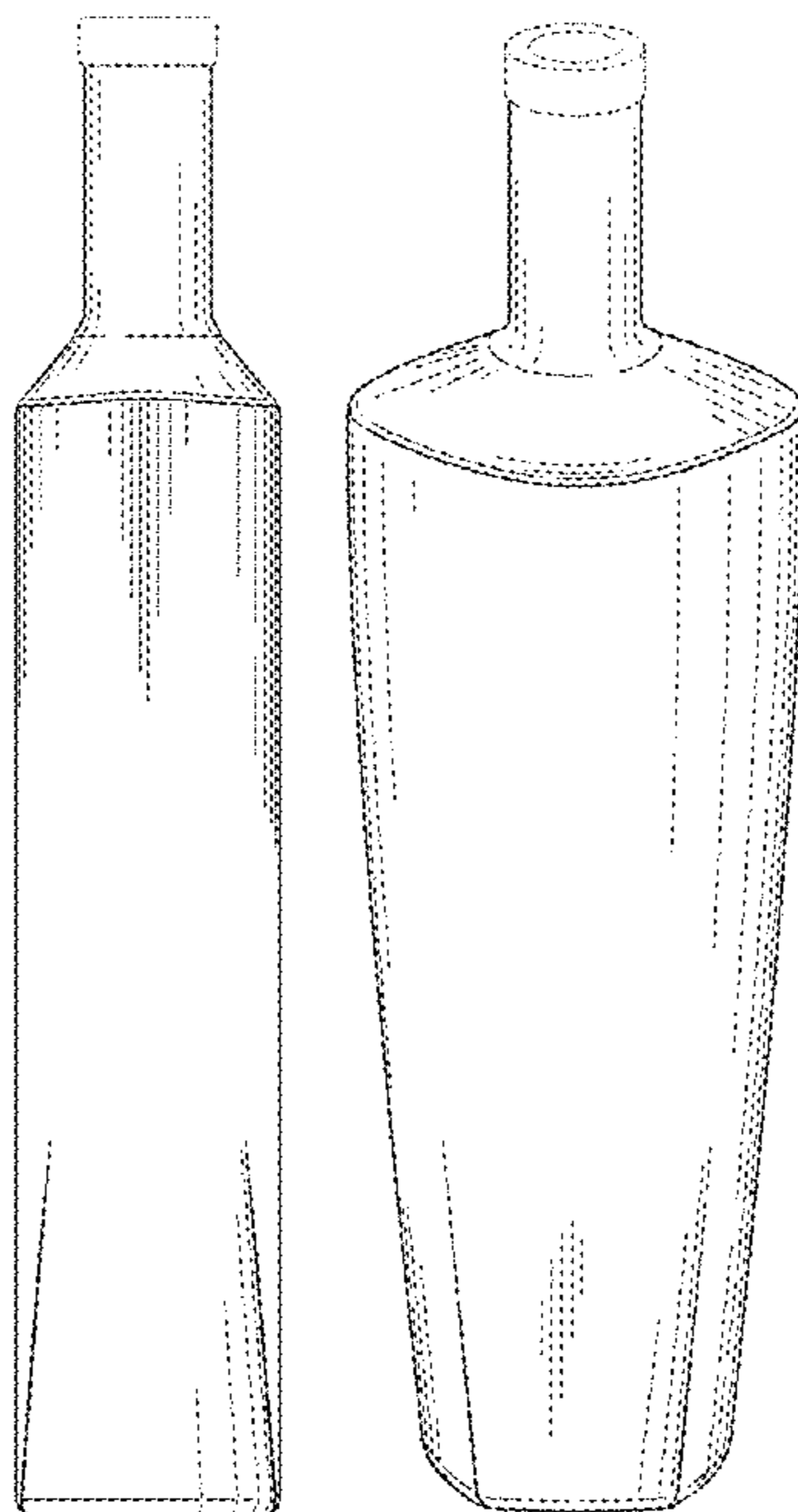
FIG. 3 is a top view of the bottle shown in FIG. 1;

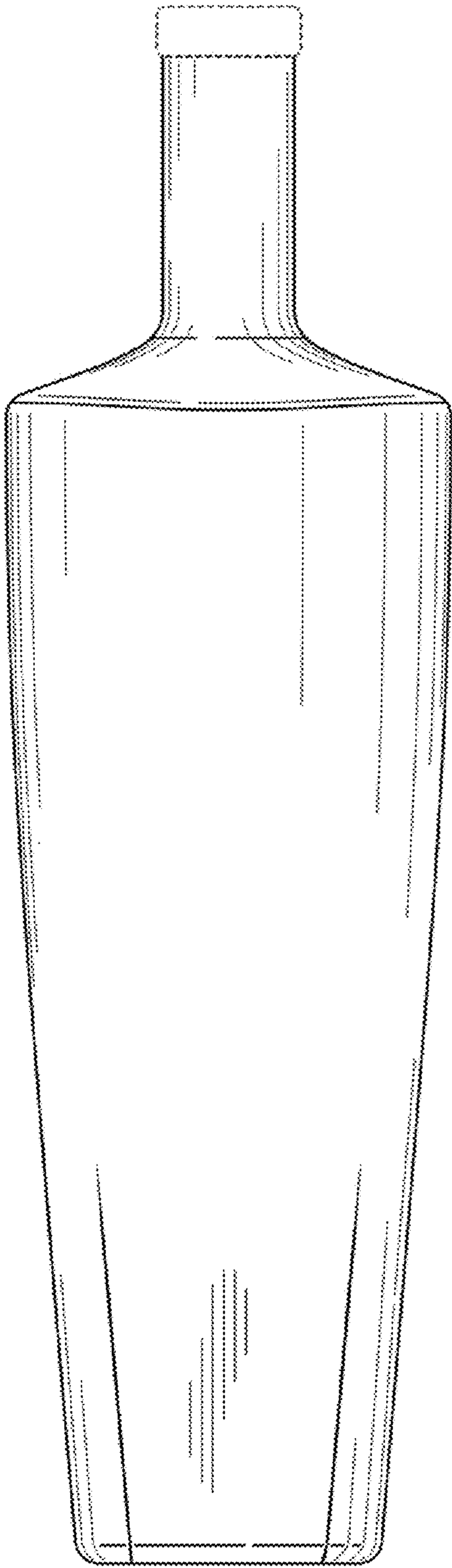

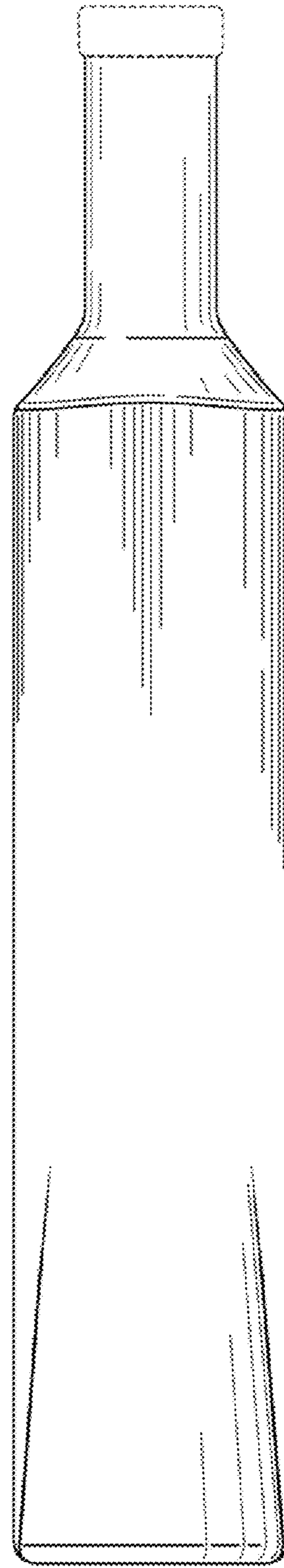

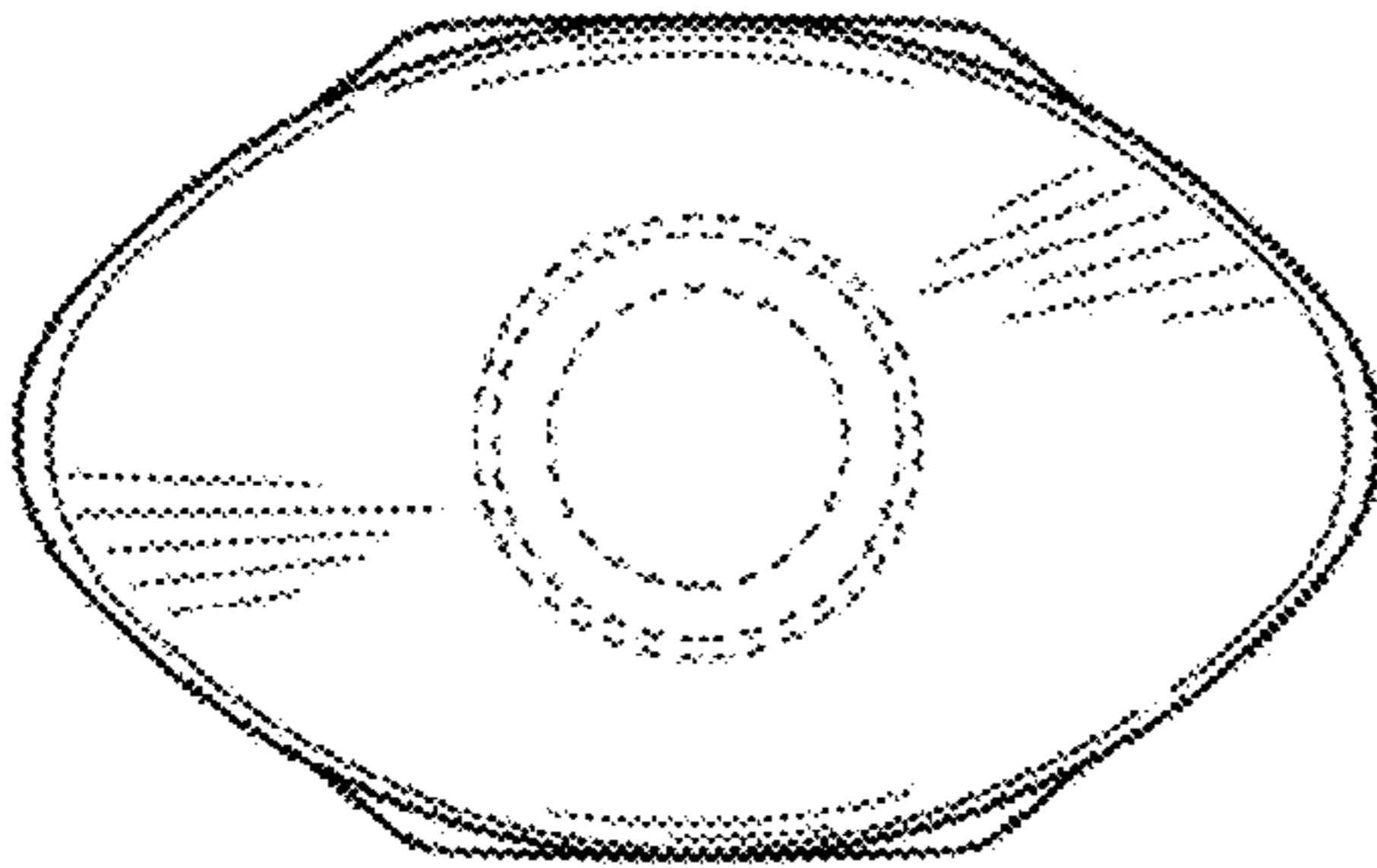

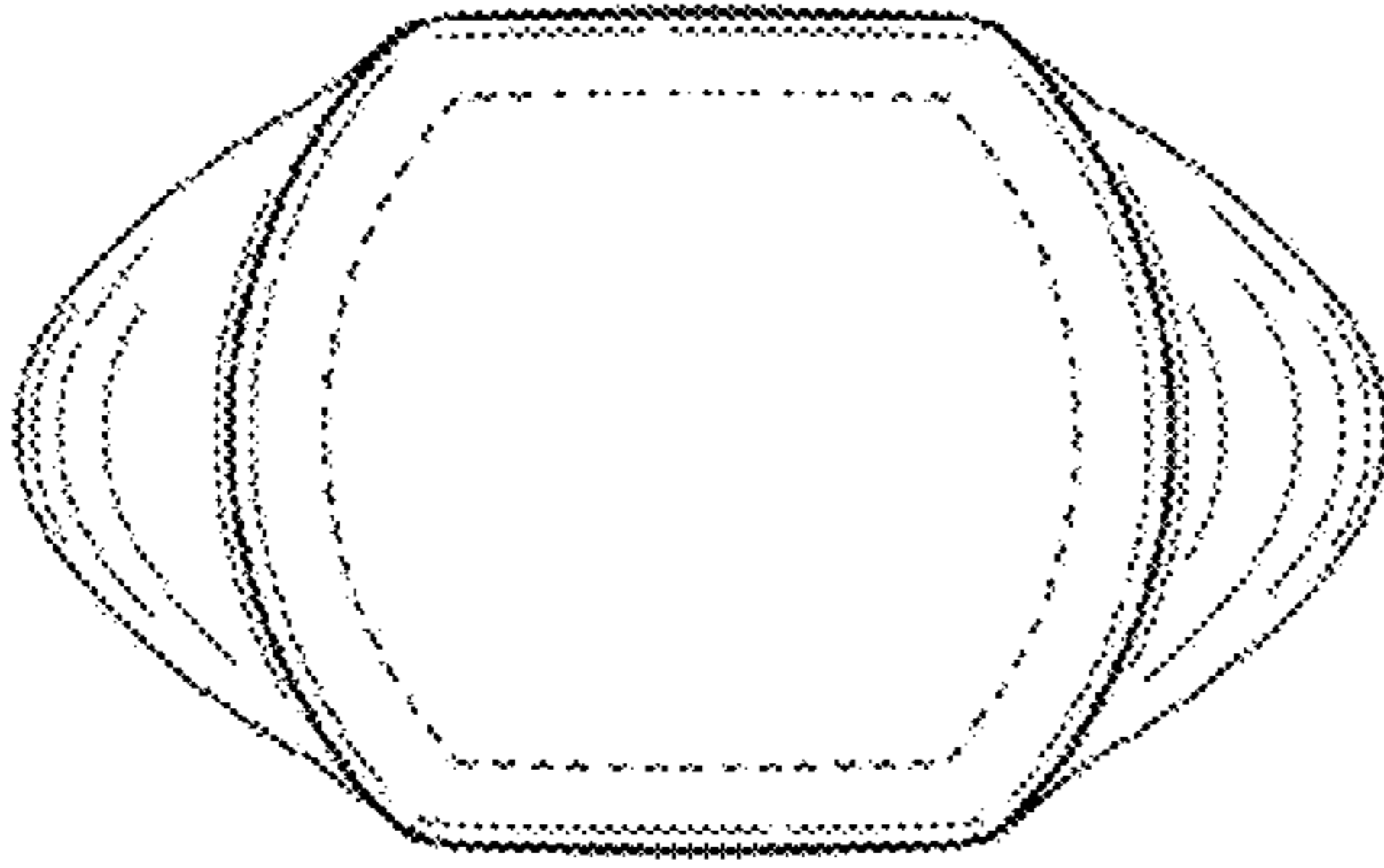

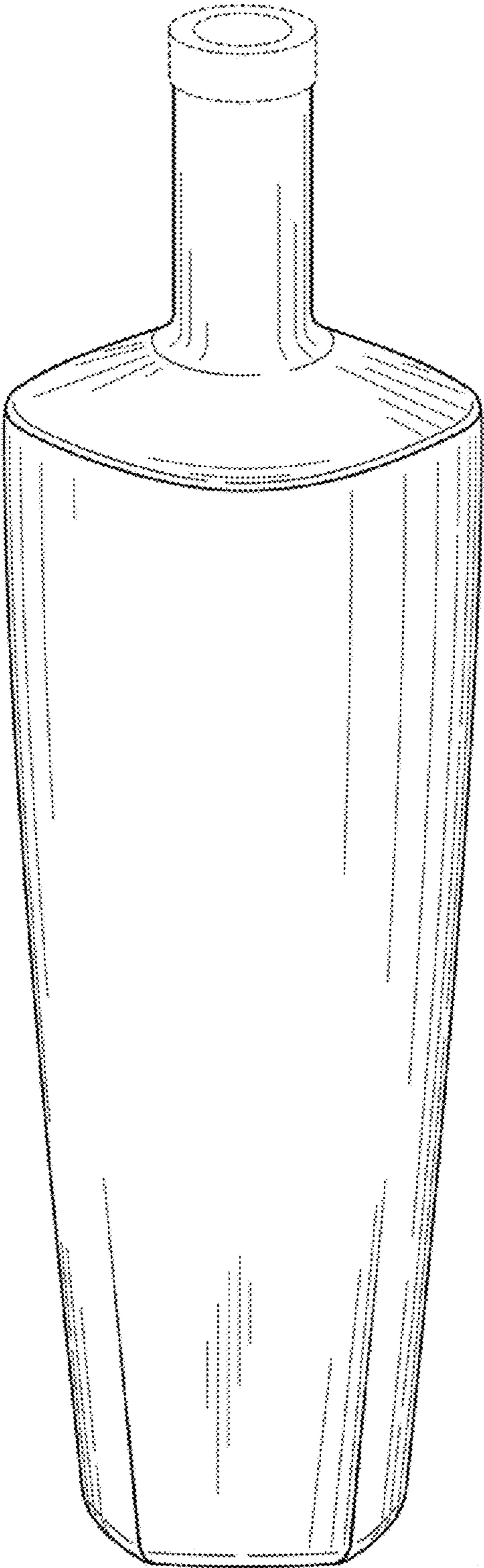
