(57) **CLAIM**

I claim the ornamental design for an electronic device display with an animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the first image of an electronic device display with an animated graphical user interface showing my new design;

FIG. 2 is a front view of a second image thereof;

FIG. 3 is a front view of a third image thereof;

FIG. 4 is a front view of a fourth image thereof; and,

FIG. 5 is a front view of a fifth image thereof.

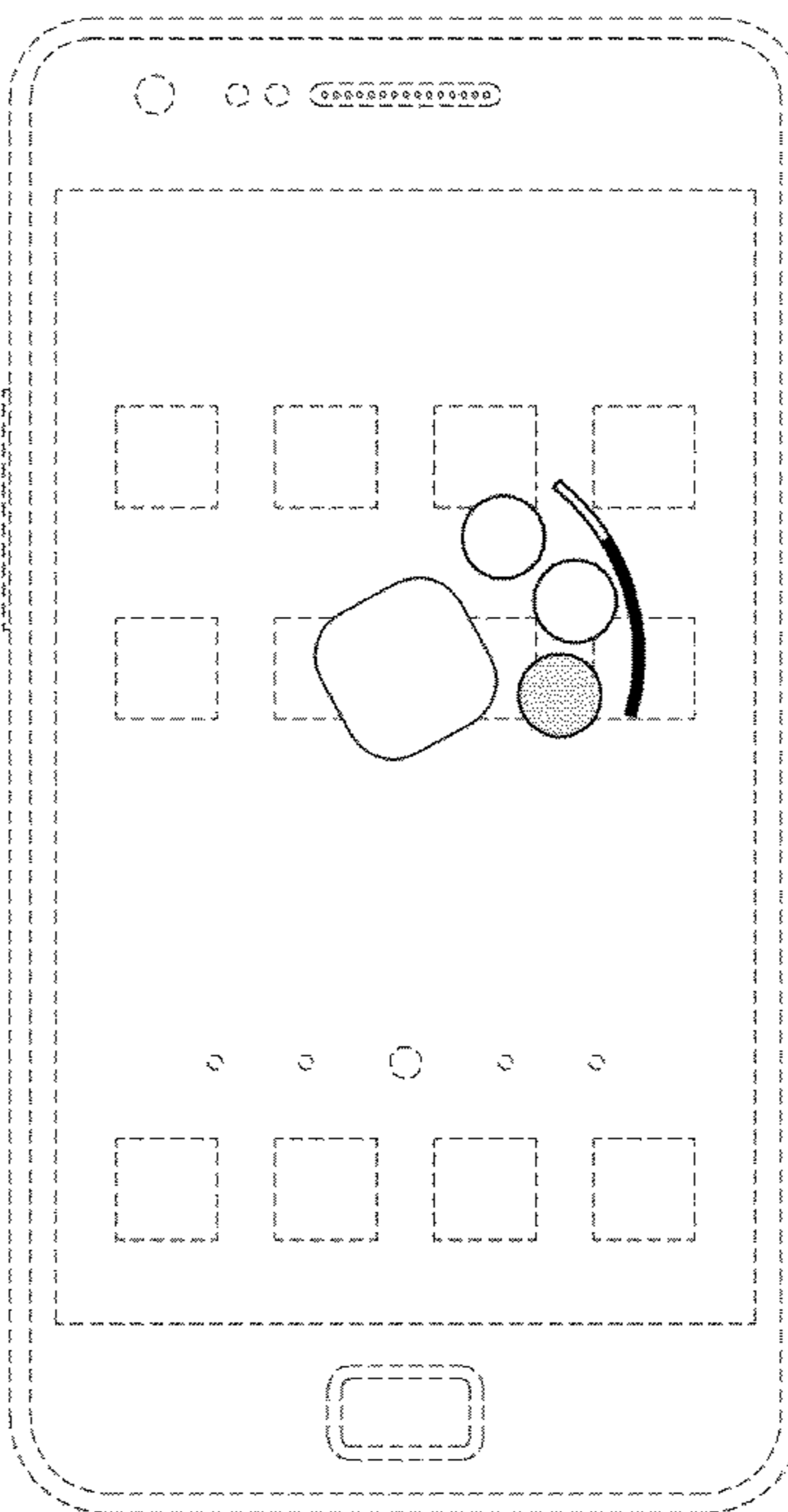
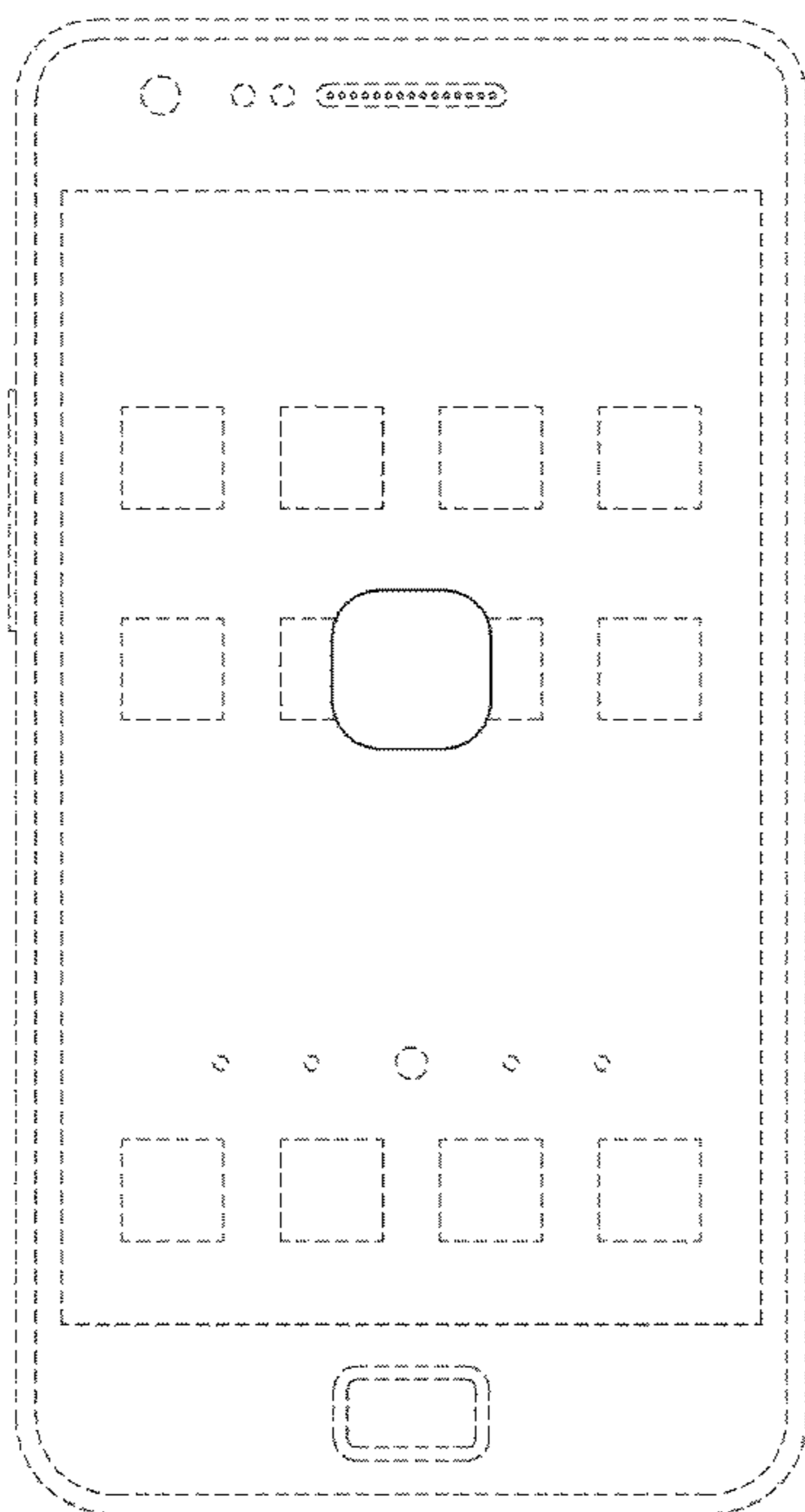

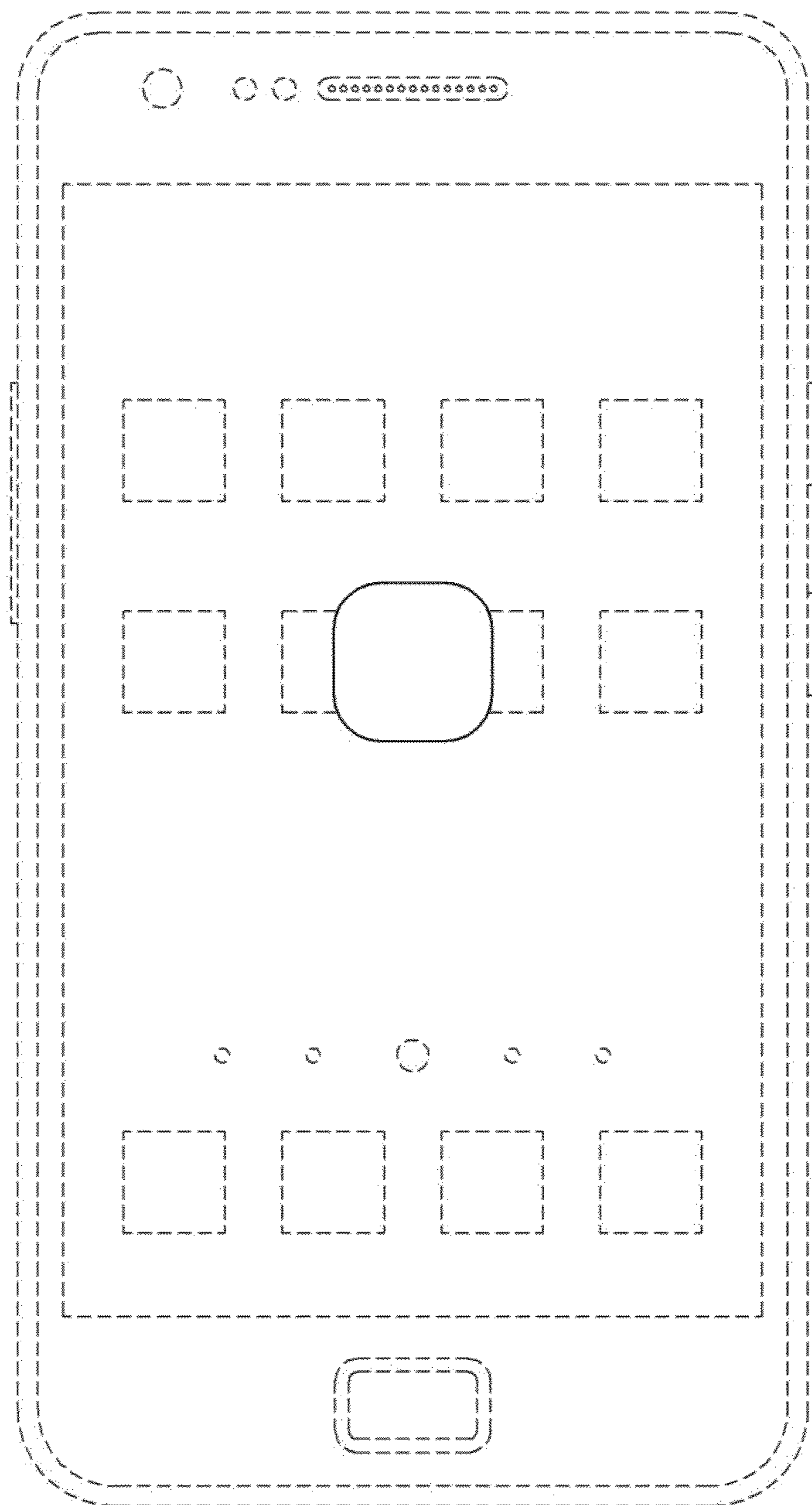

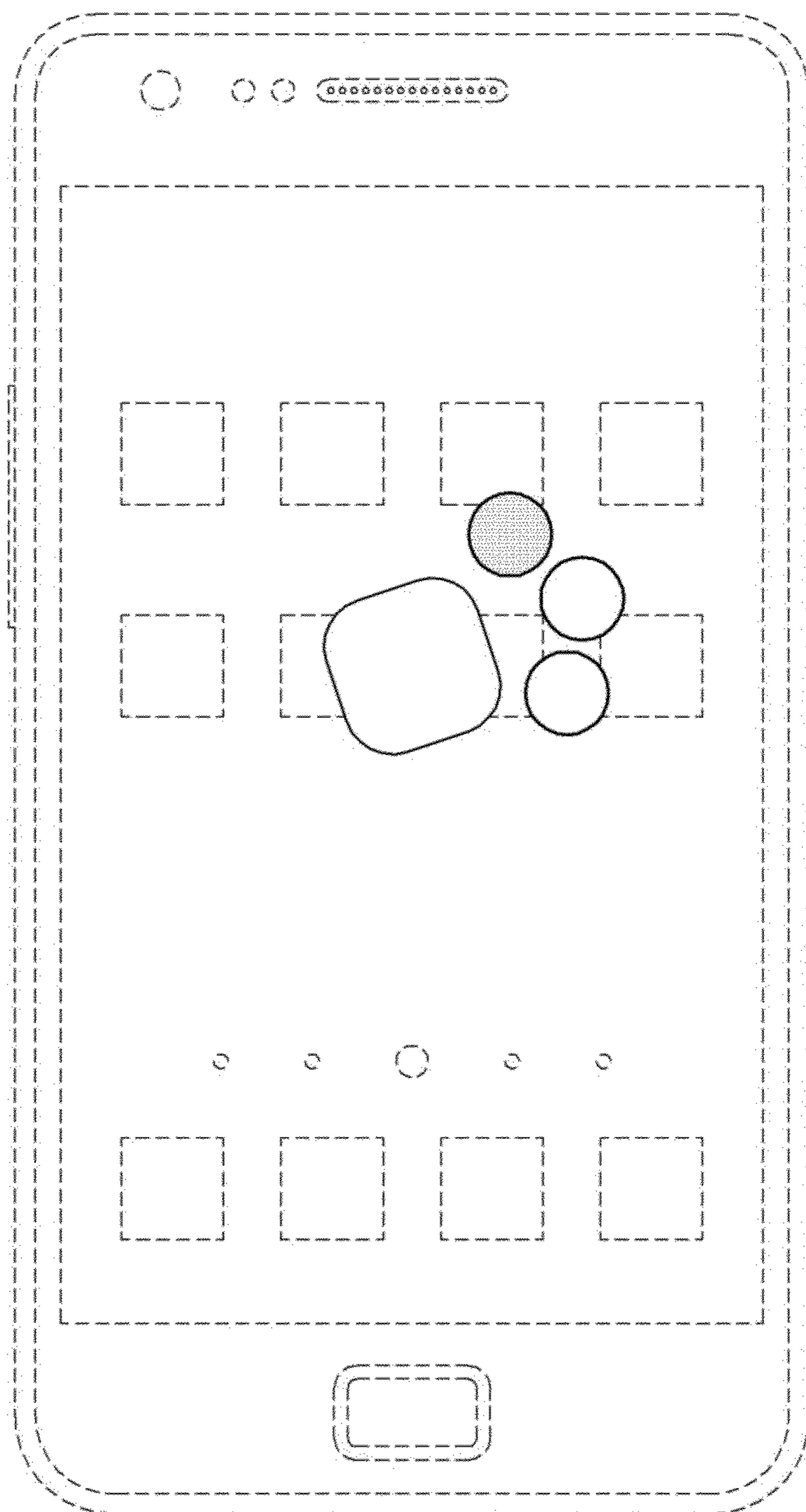

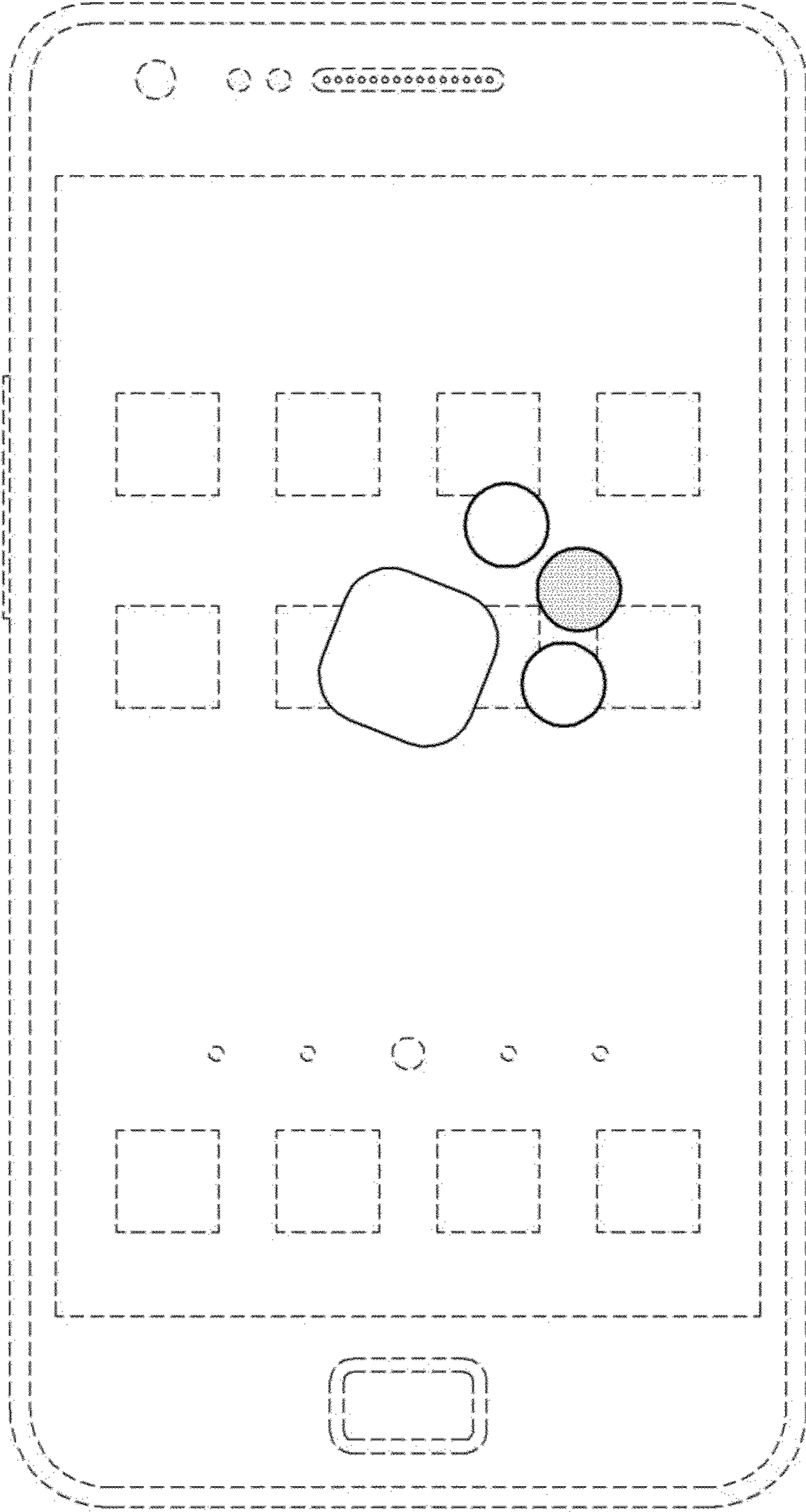

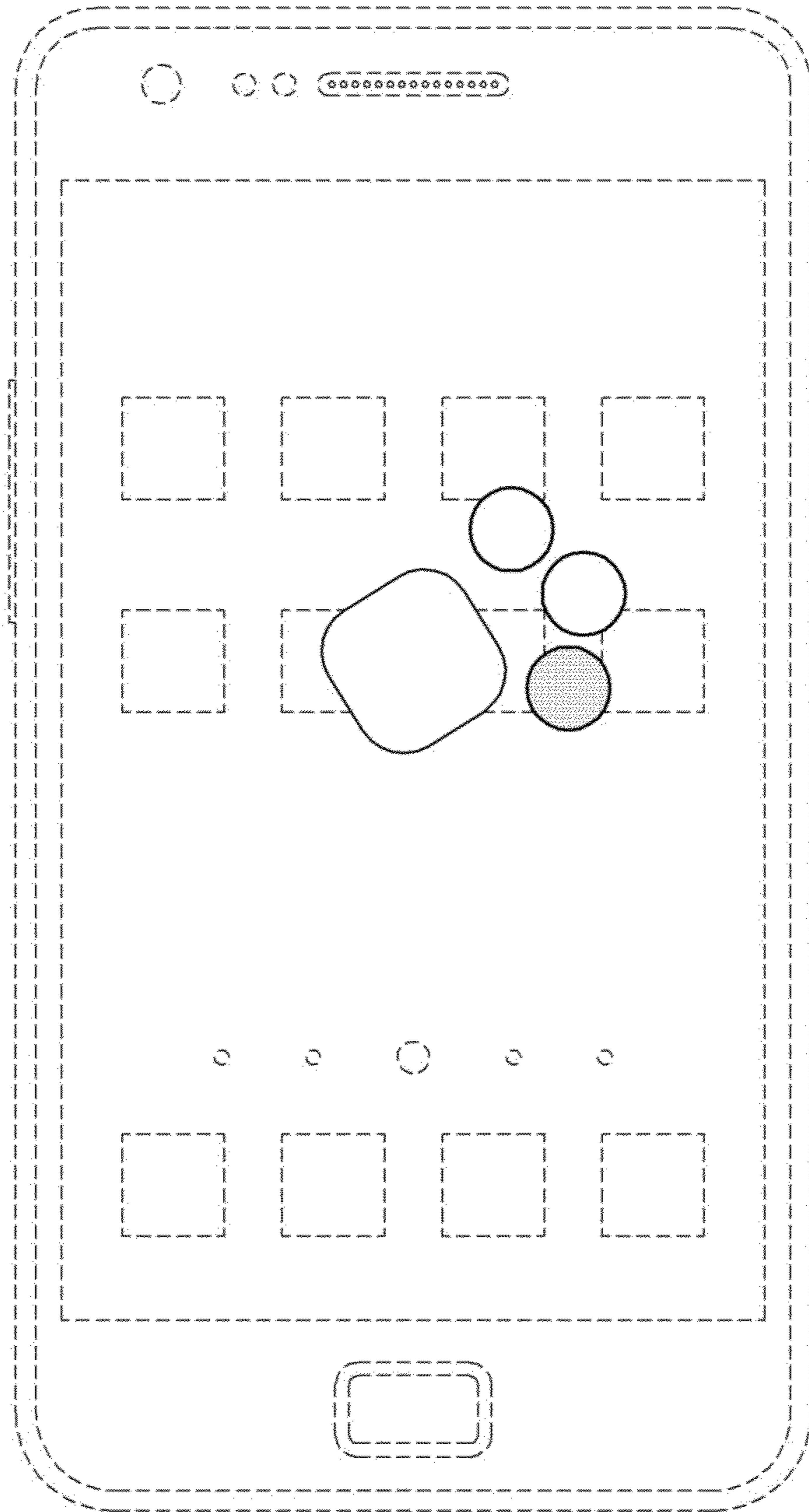
