(57) **CLAIM**

The ornamental design for a toner cartridge, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of front, left and top of toner cartridge showing our new design; FIG. 2 is a perspective view of rear, right and bottom thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a top view thereof; and, FIG. 8 is a bottom view thereof.

The broken lines showing of the toner cartridge are included for the purpose of illustrating portions of the toner cartridge and form no part of the claimed design.

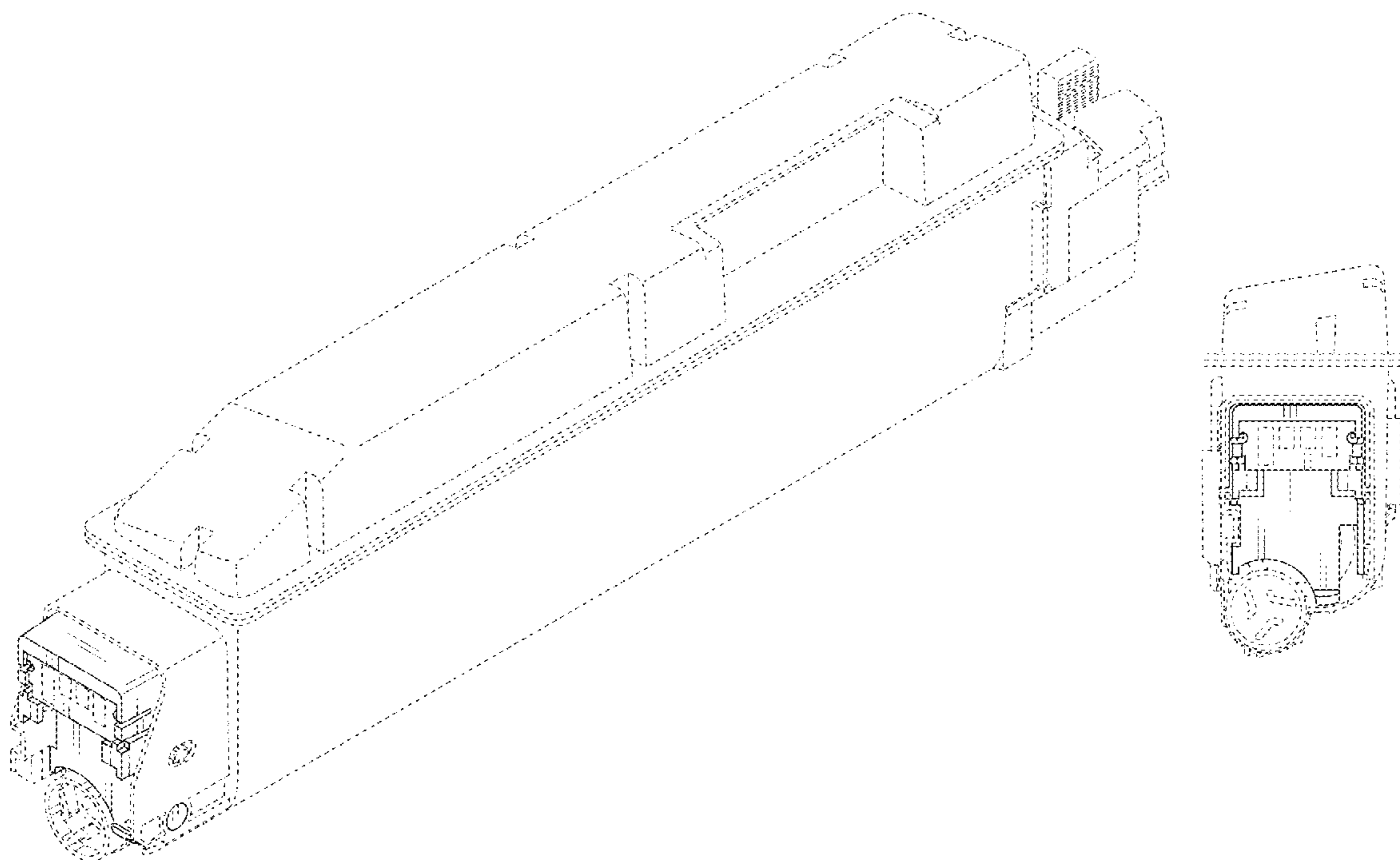

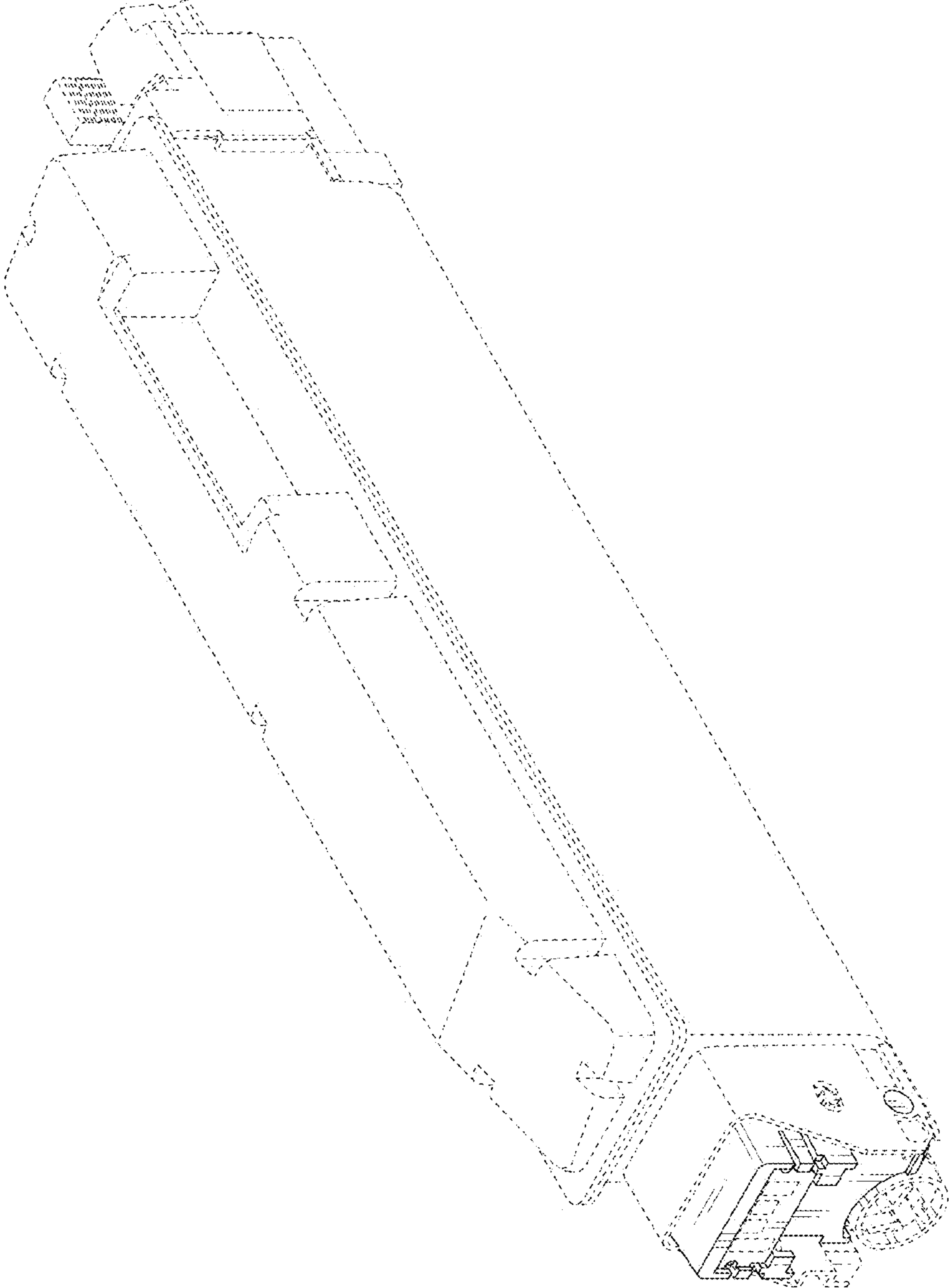

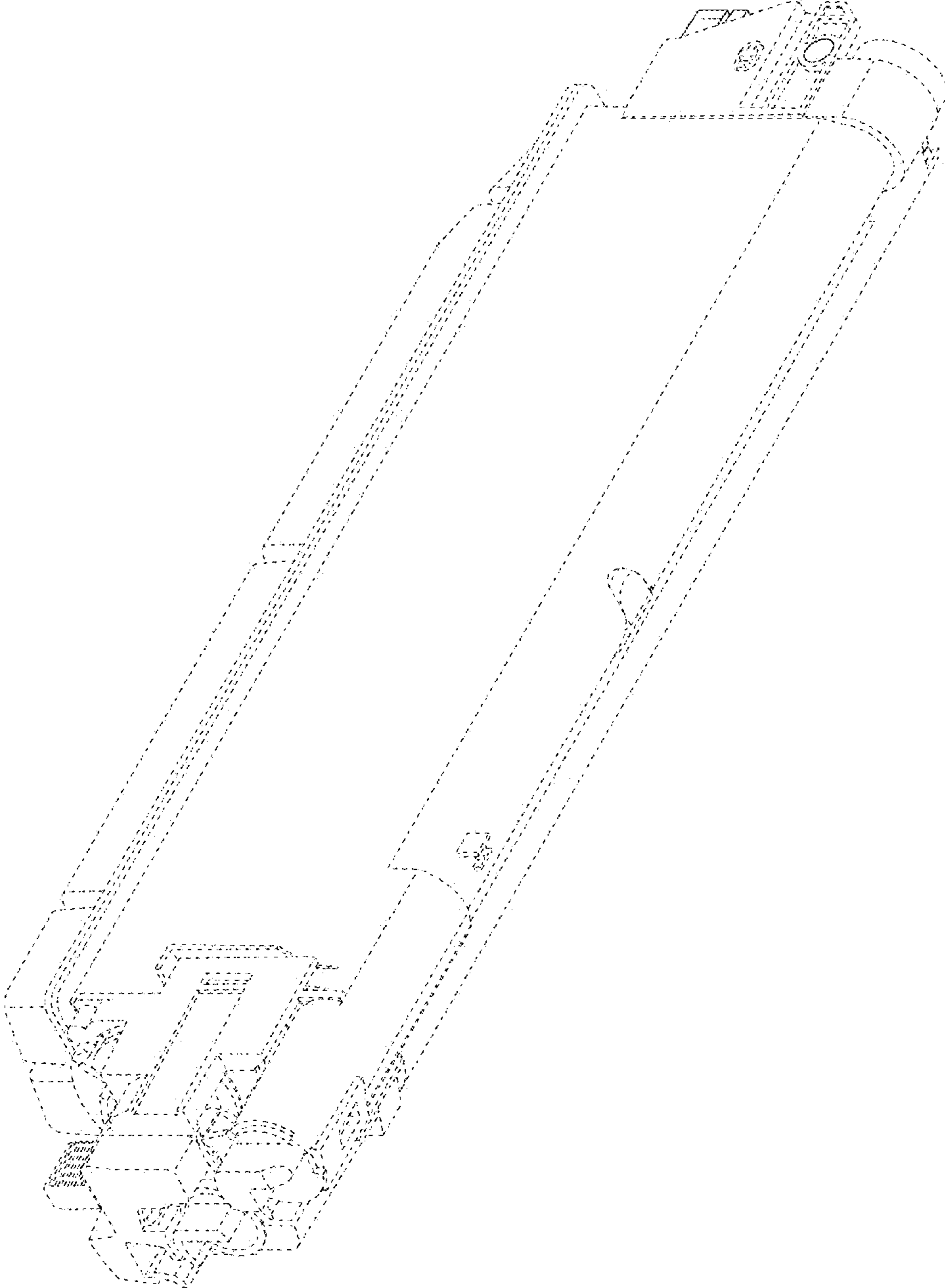

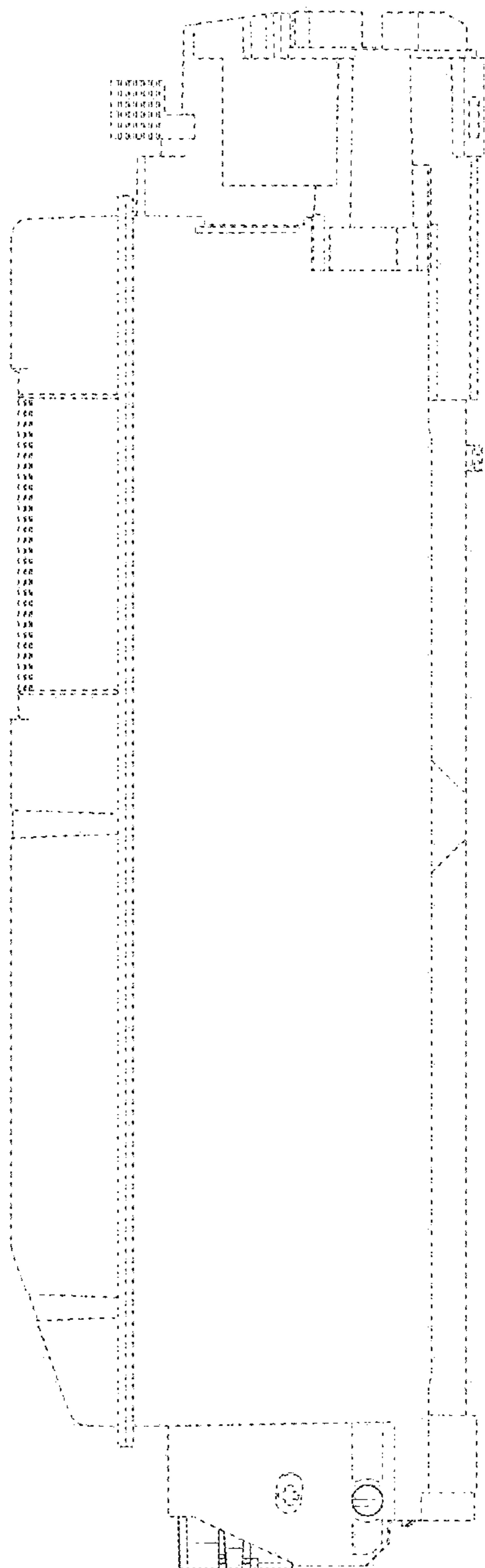

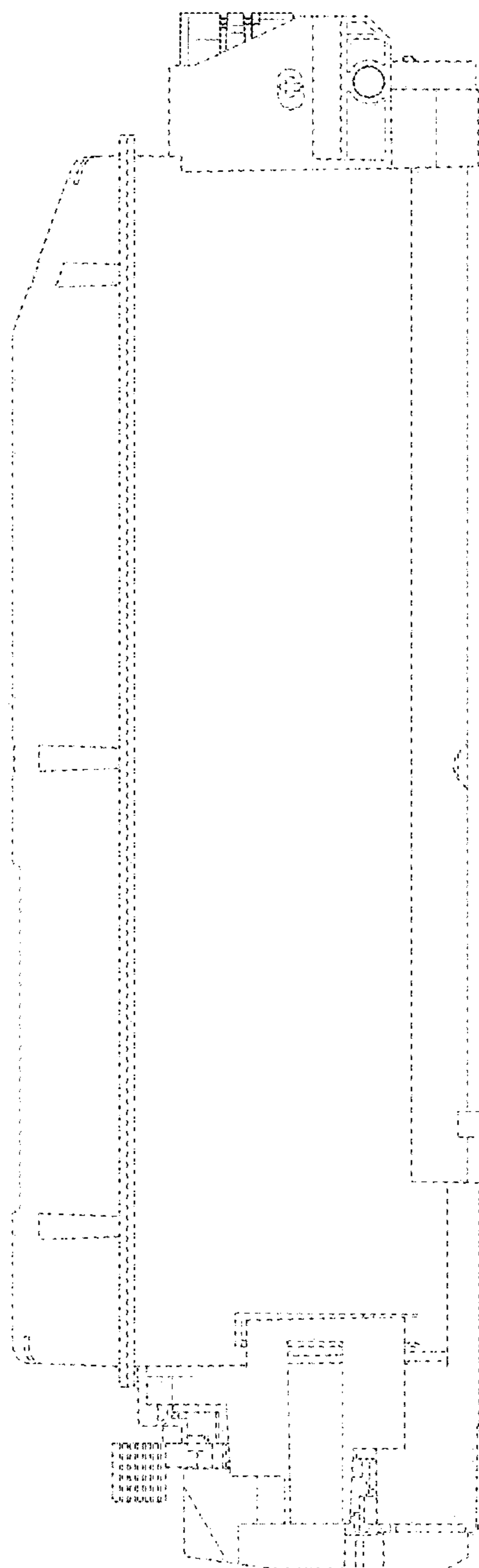

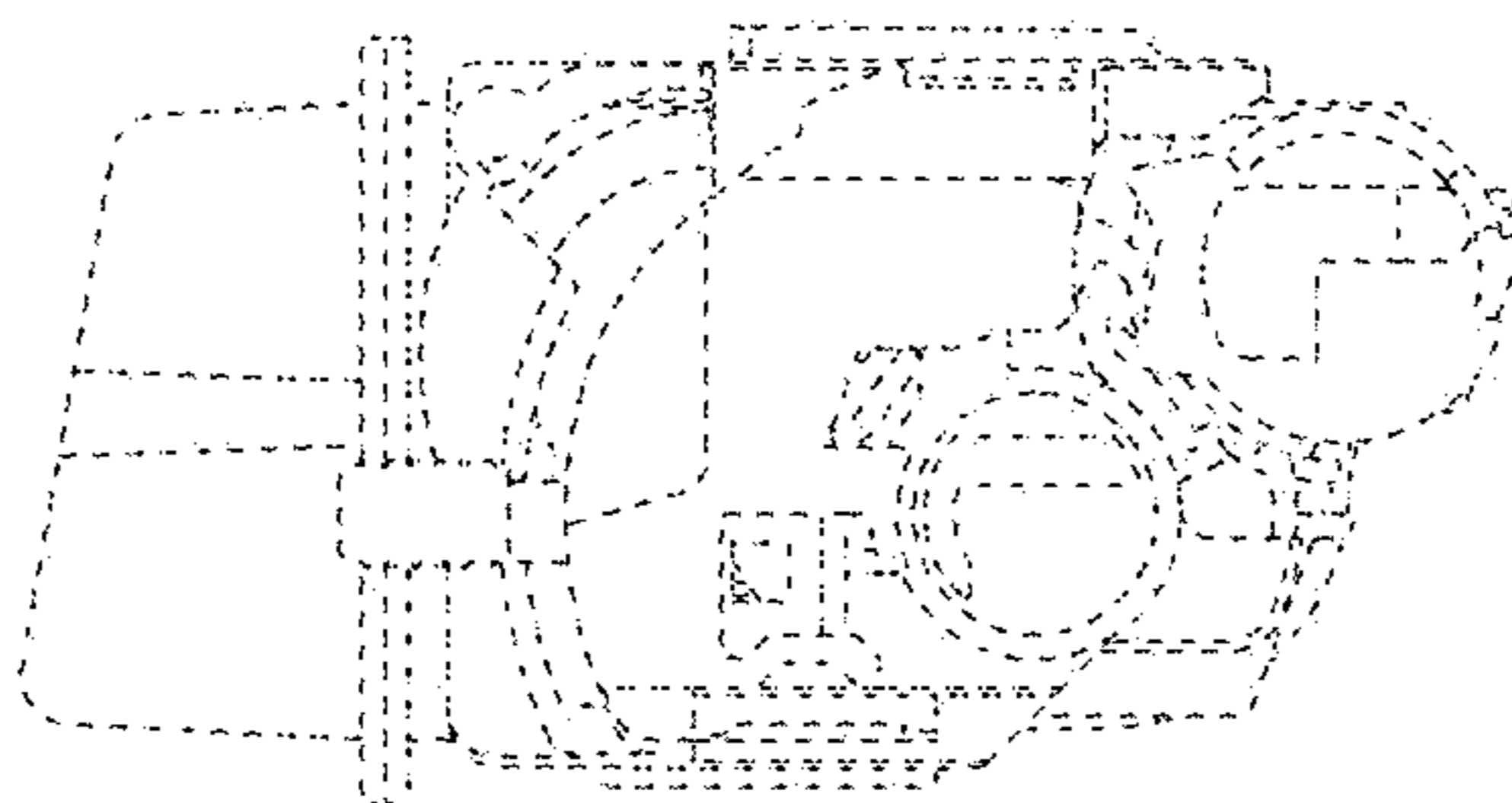

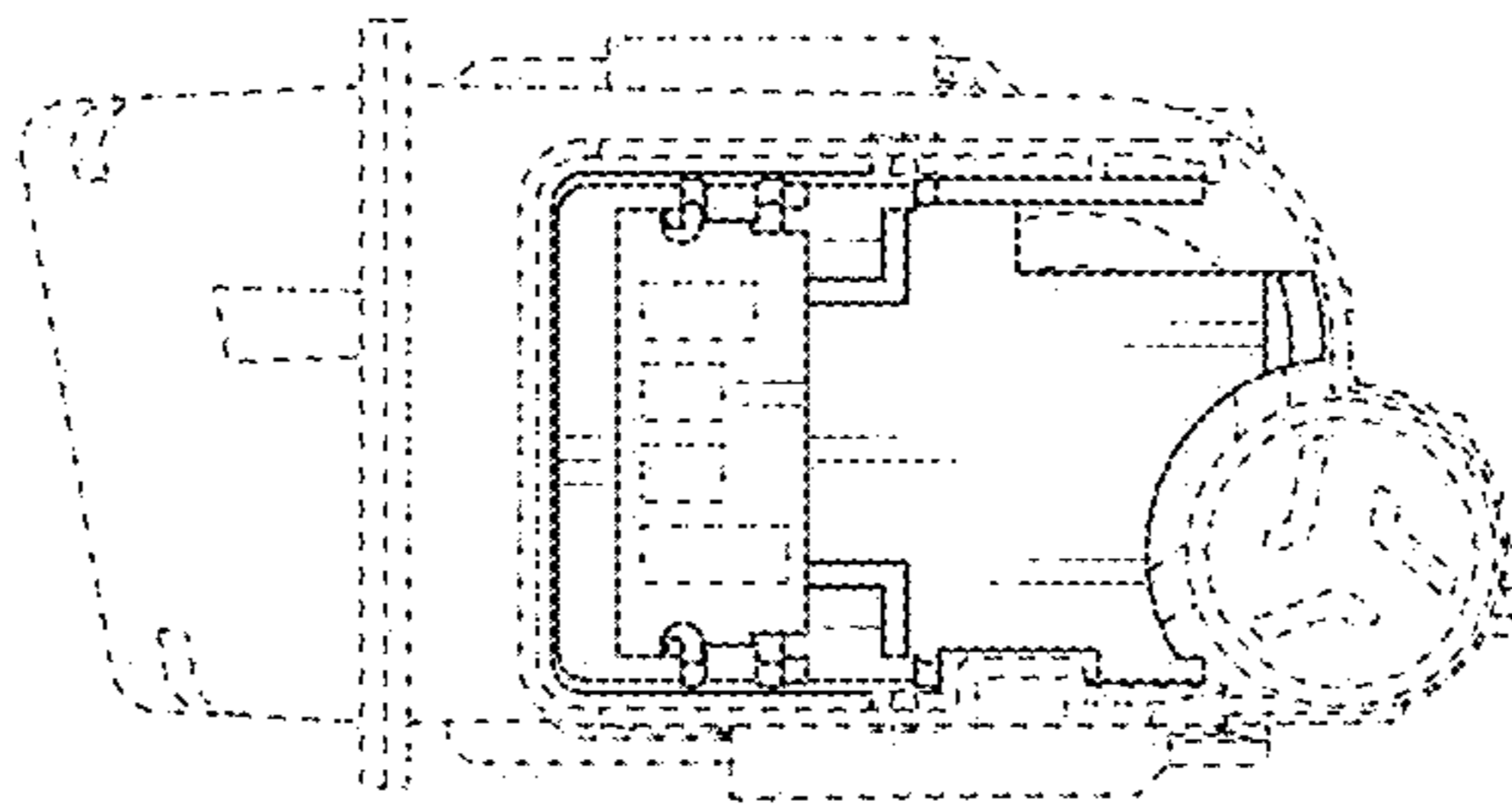

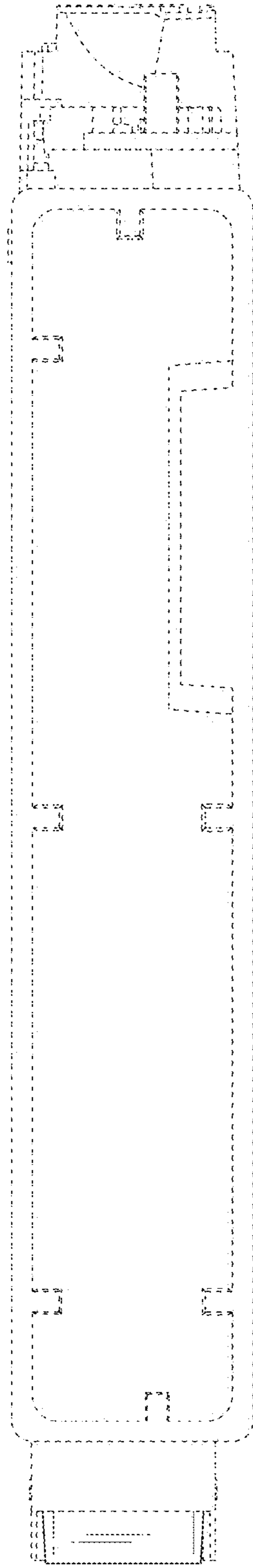
