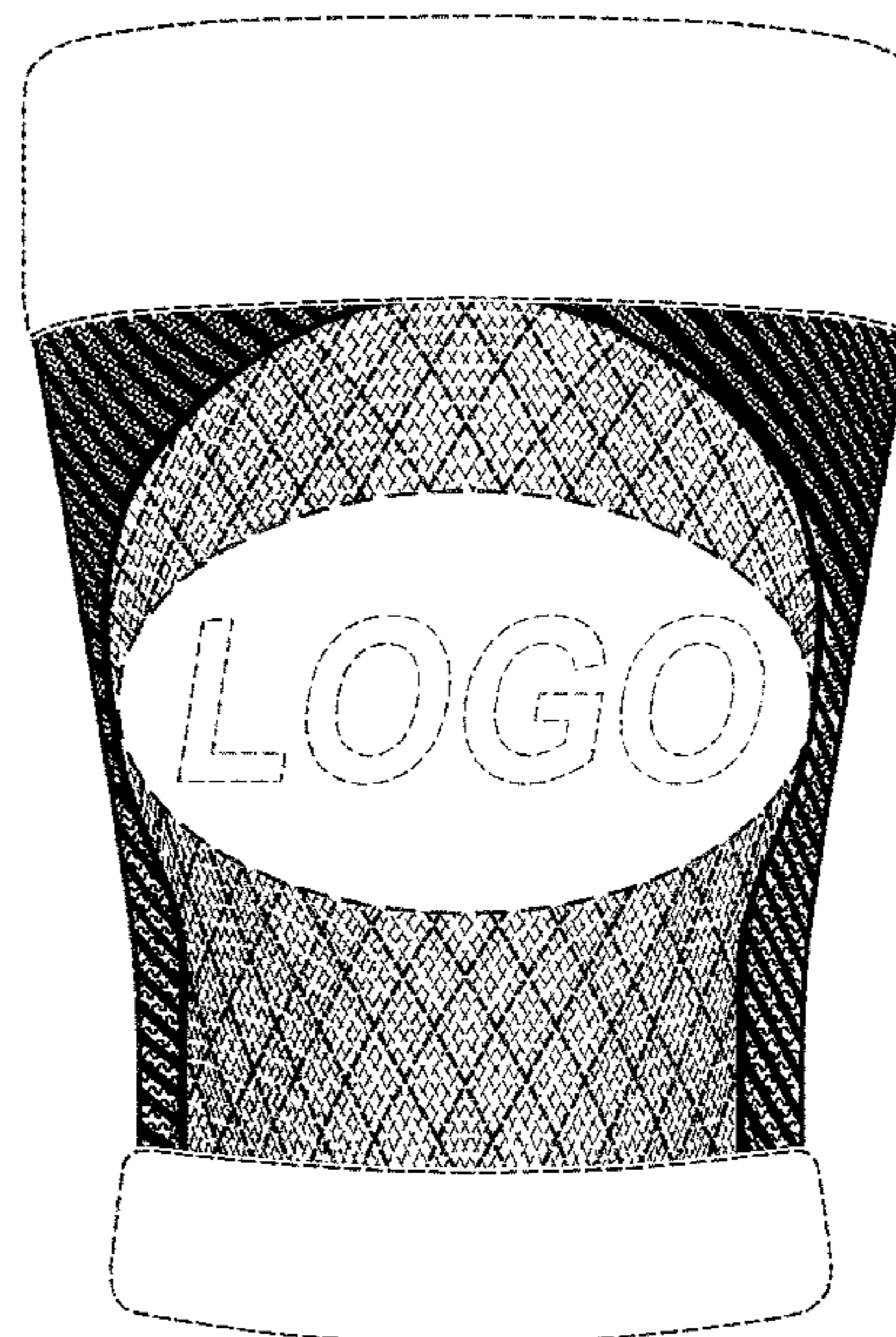
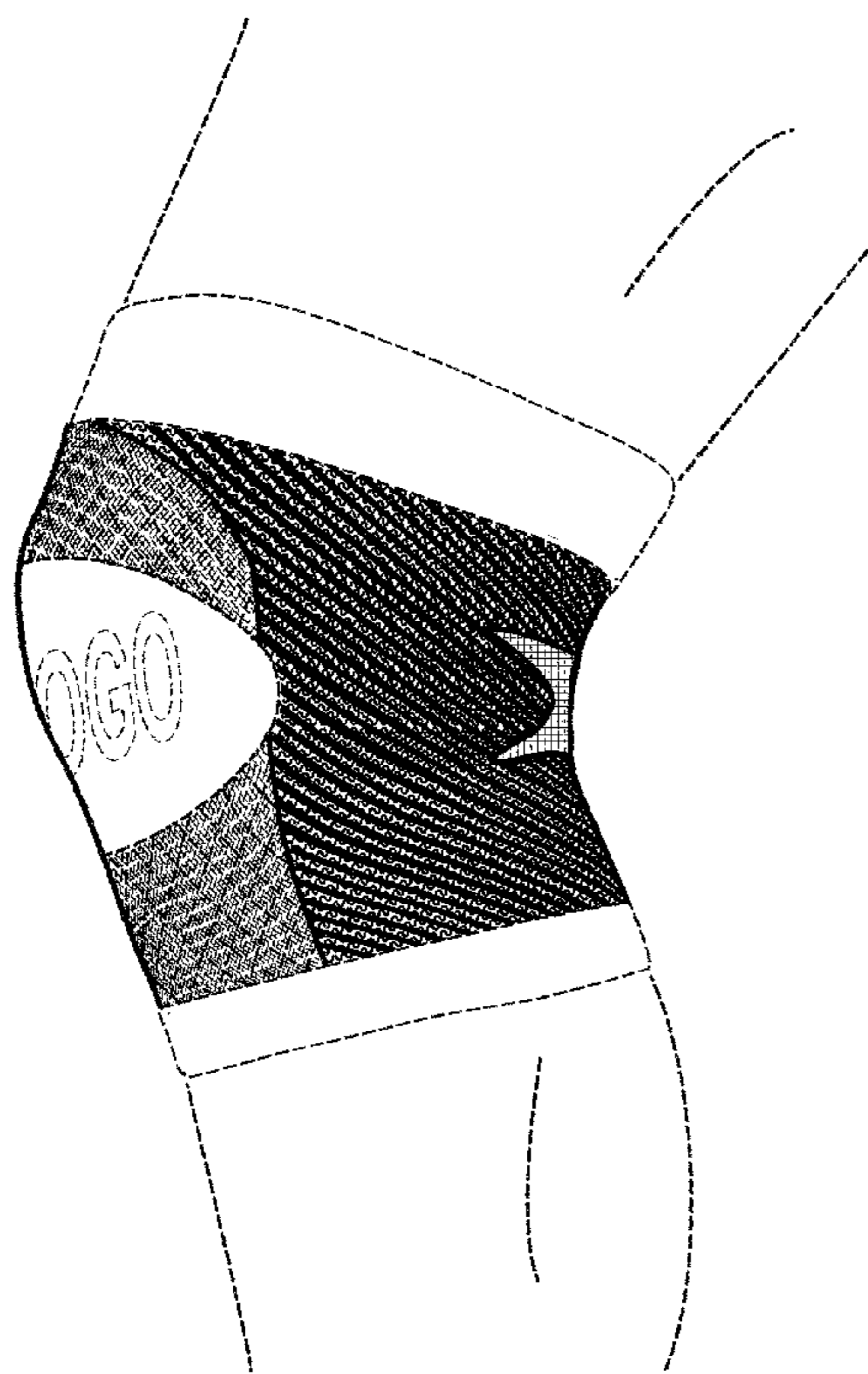
(57) **CLAIM**
 I claim the ornamental design for a compression knee sleeve, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a compression knee sleeve, as worn on the leg of a user;
 FIG. 2 is a front view of the compression knee sleeve;
 FIG. 3 is a rear view of the compression knee sleeve;
 FIG. 4 is a left side view of the compression knee sleeve; and,
 FIG. 5 is a right side view of the compression knee sleeve.
 The broken line showing of a human leg in FIG. 1 is for the purpose of showing environment which forms no part of the claim. The broken line showing on the compression knee sleeve is for the purpose of illustrating portions of the sleeve which form no part of the claim. The patterns on the sleeve represent claimed yarn and thread contrast.

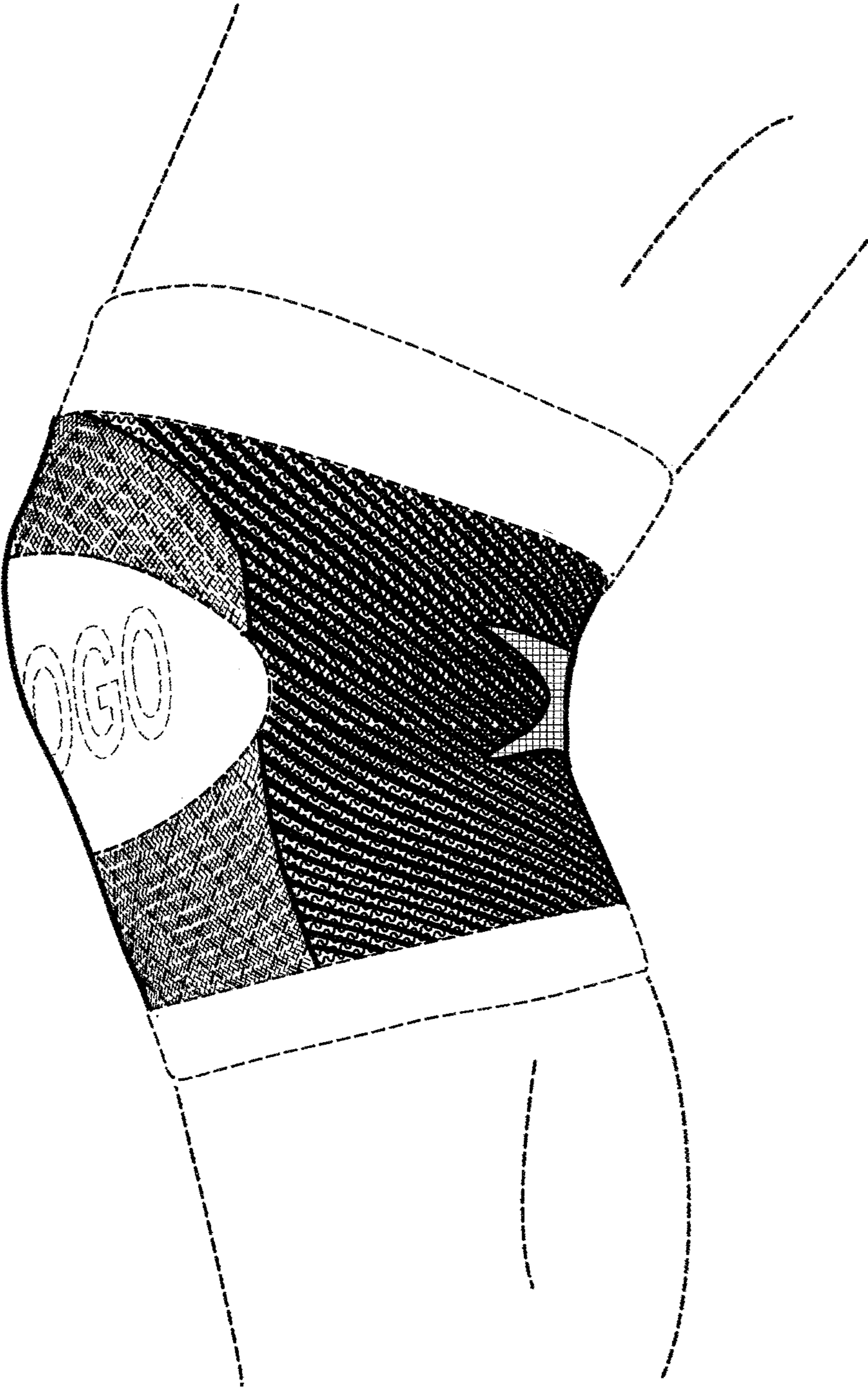

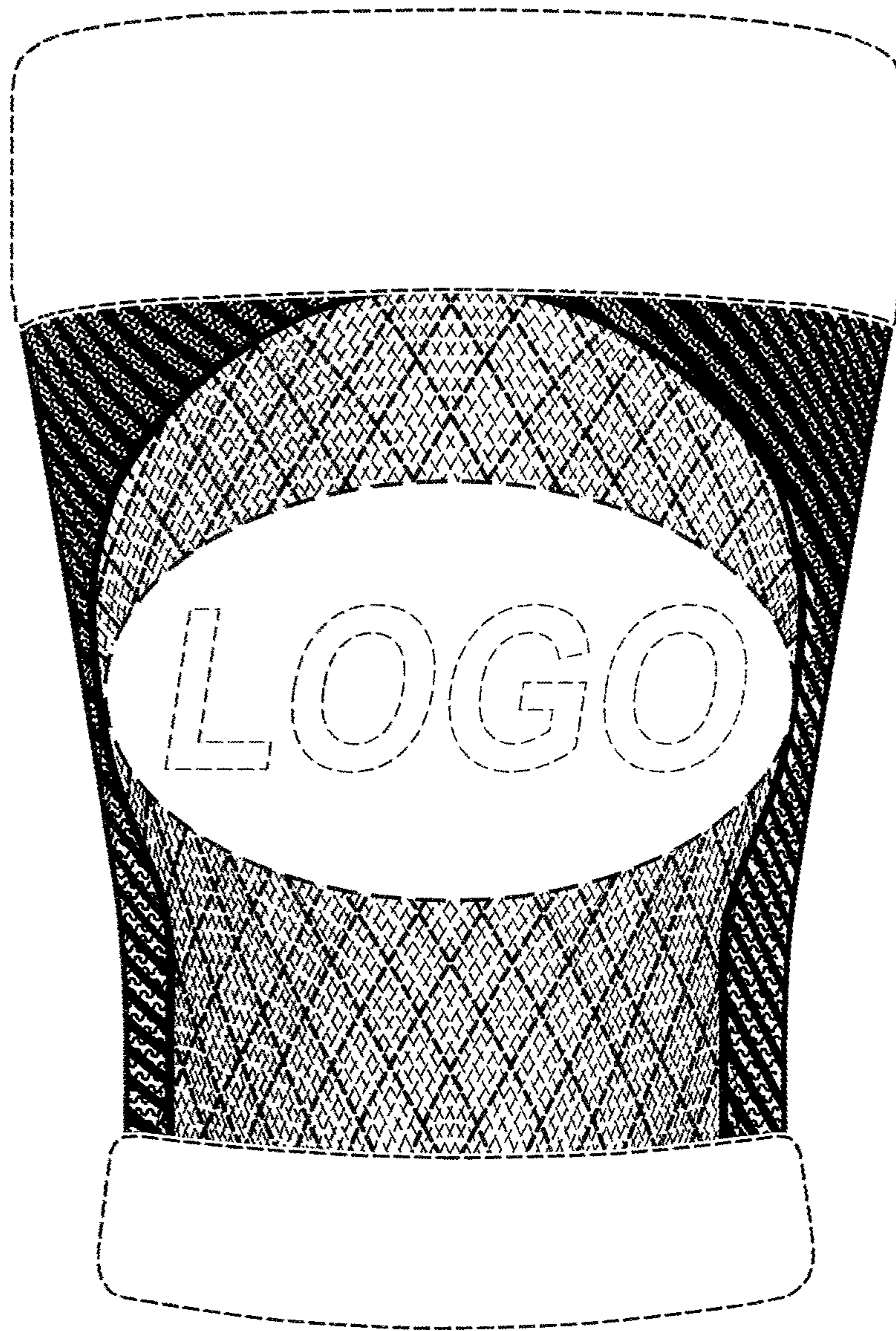

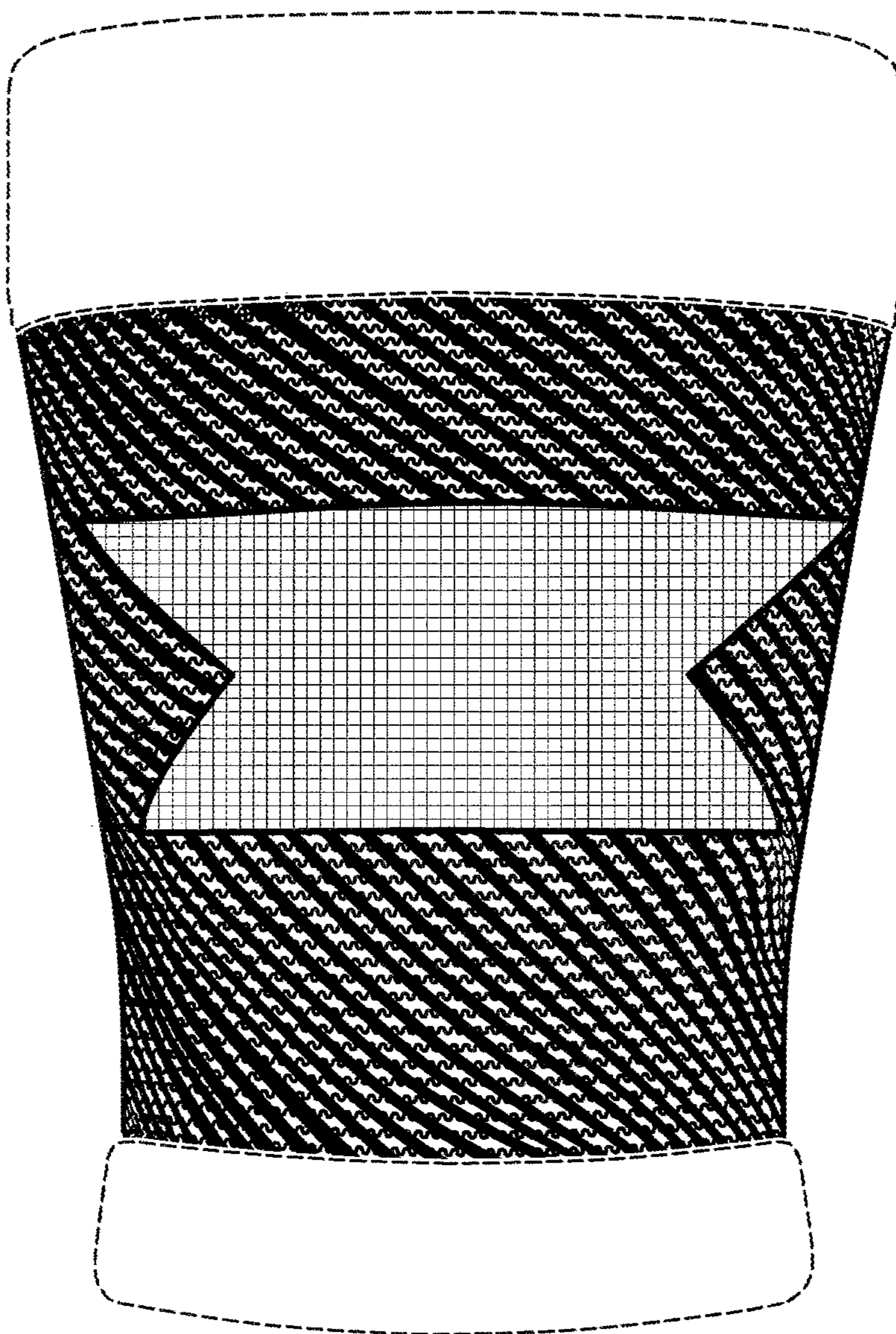

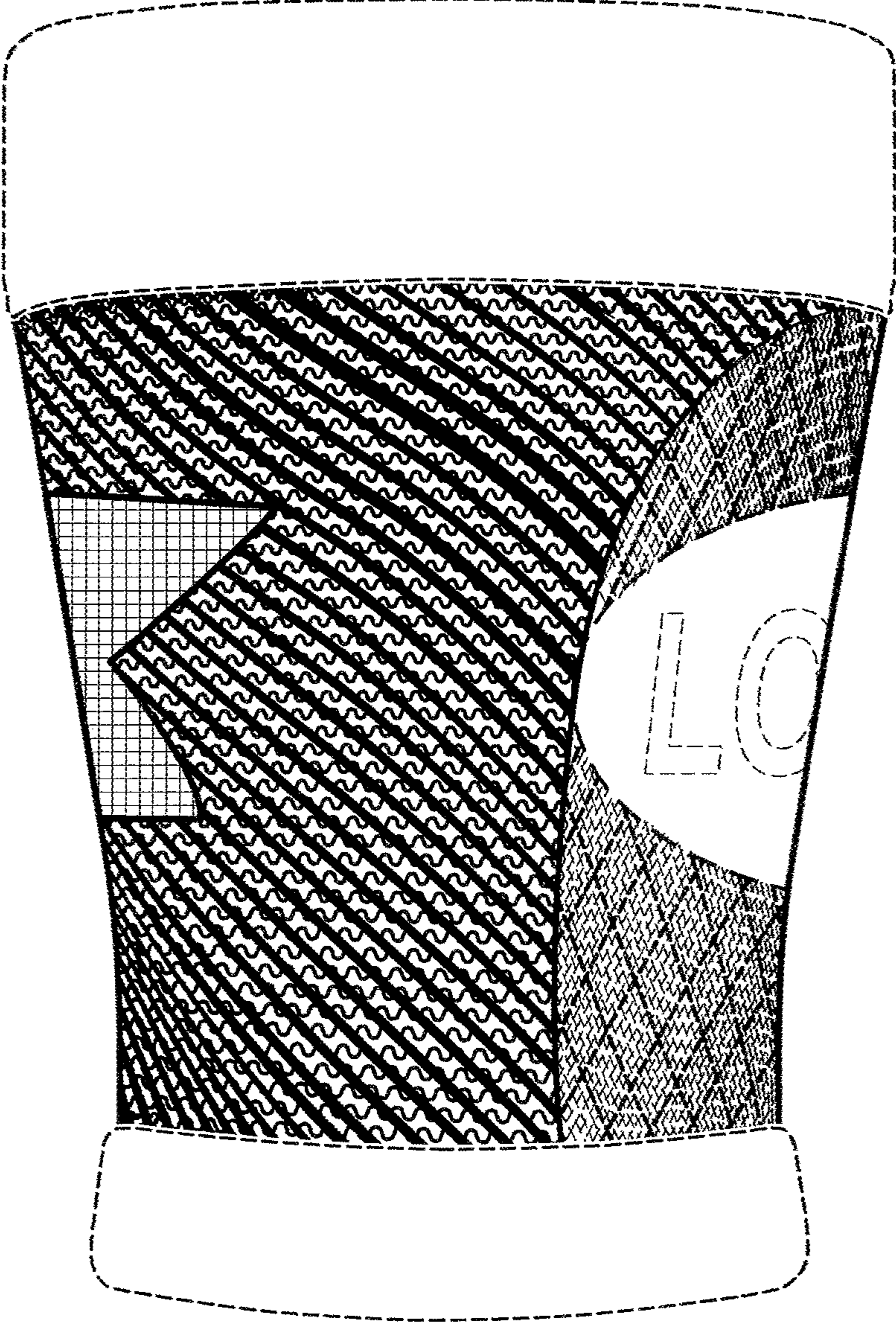

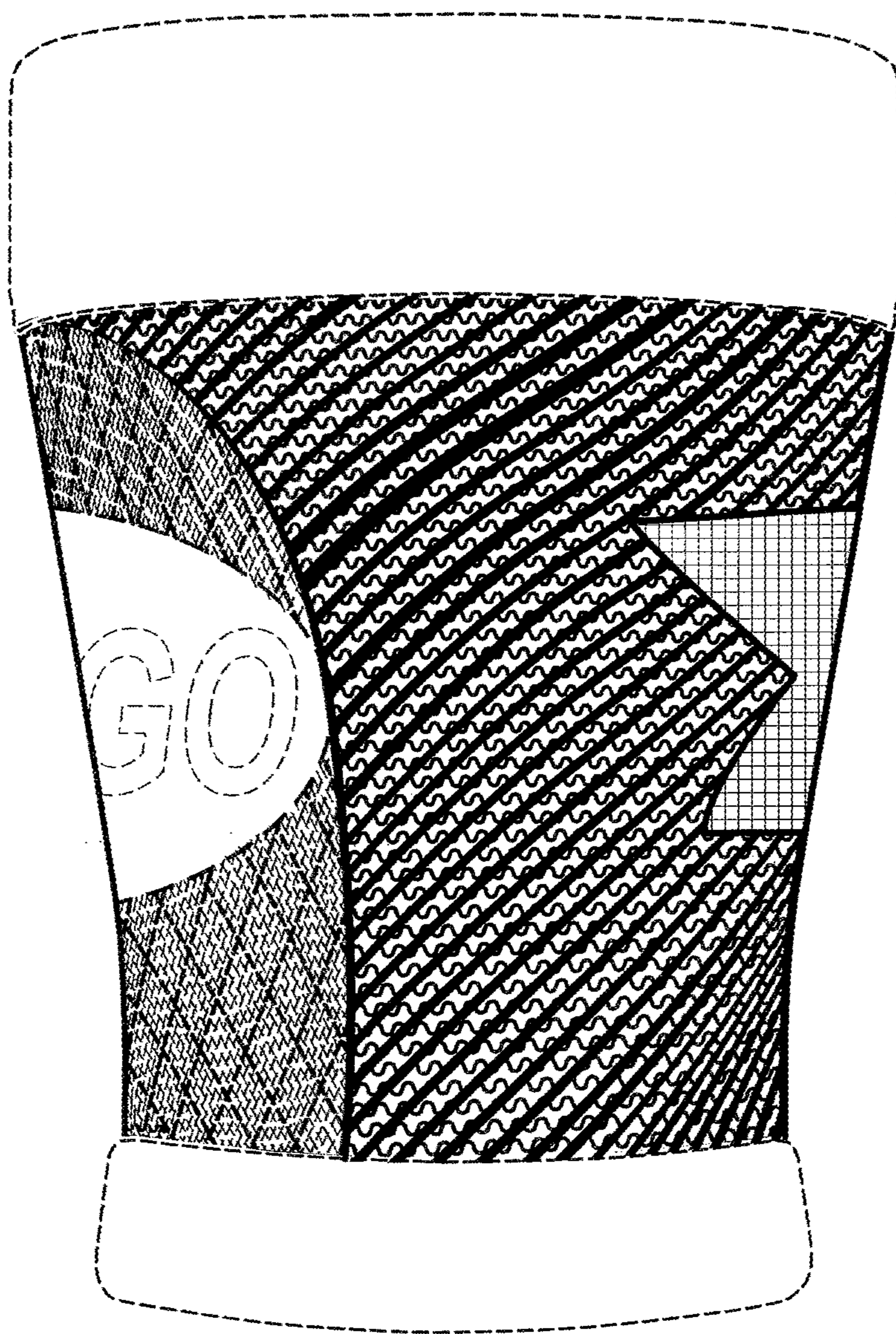
