**DESCRIPTION**

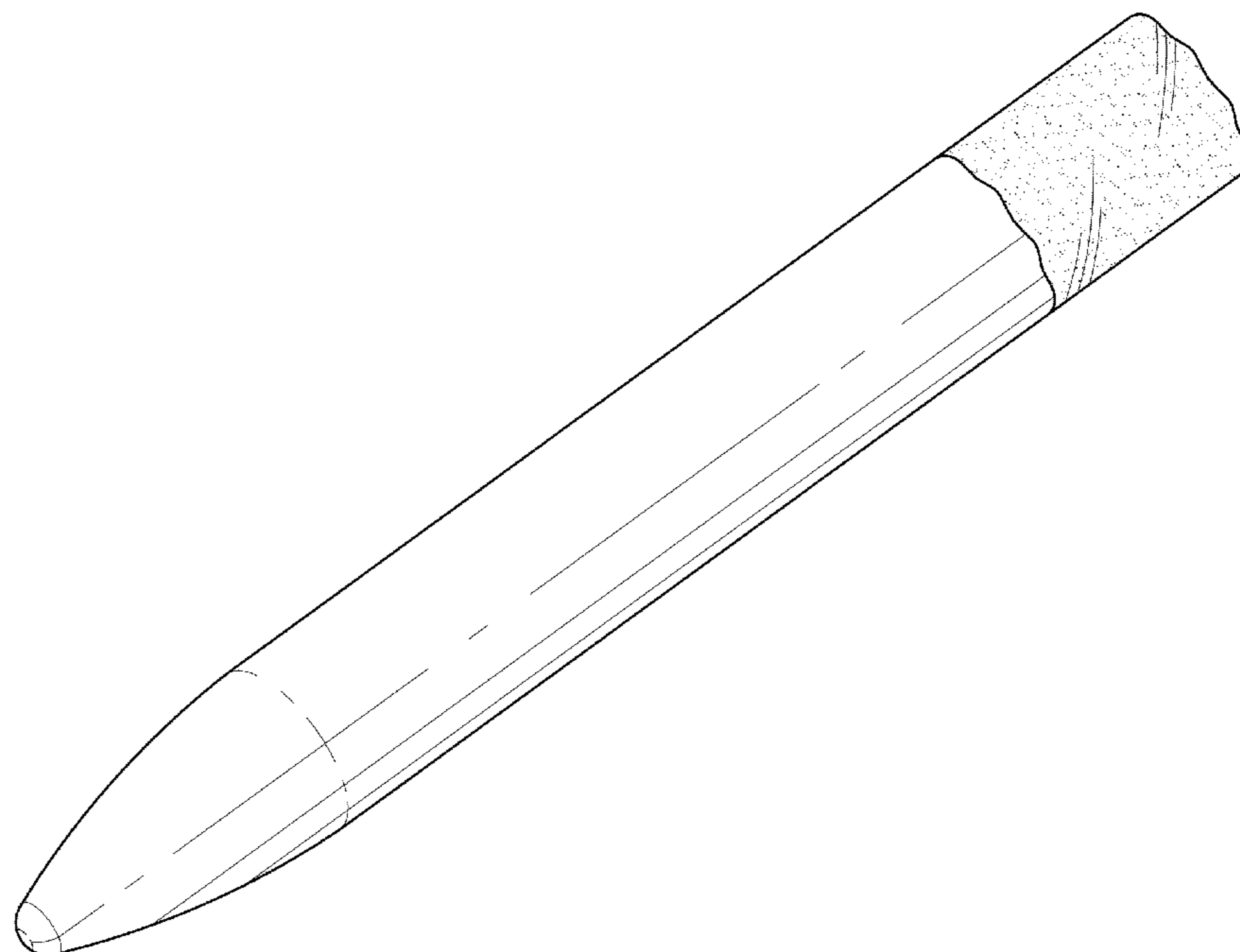
FIG. 1 is a perspective view of an electronic cigar, showing my new design;

The broken lines in the drawings depict parts of the electronic cigar that form no part of the claimed design.

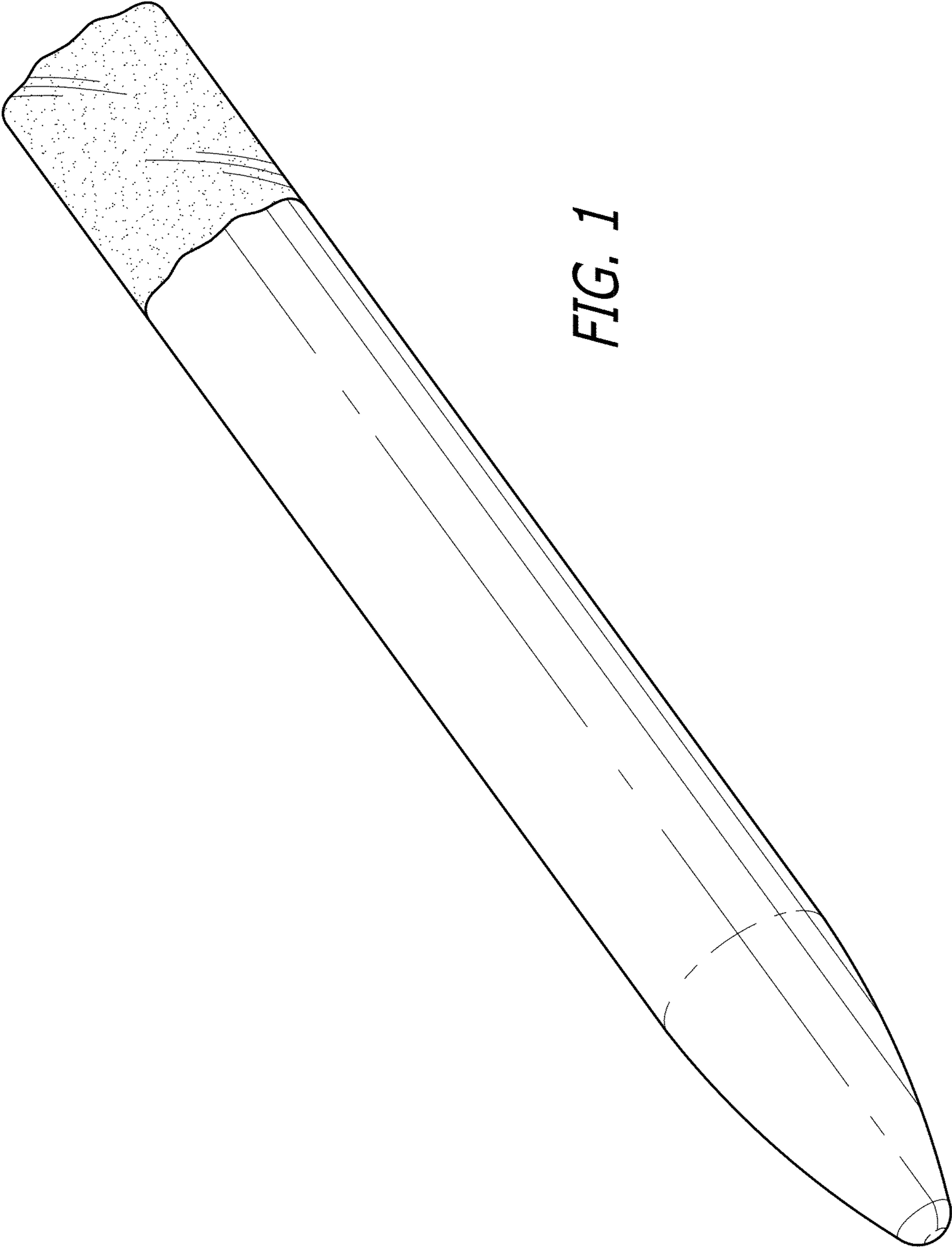

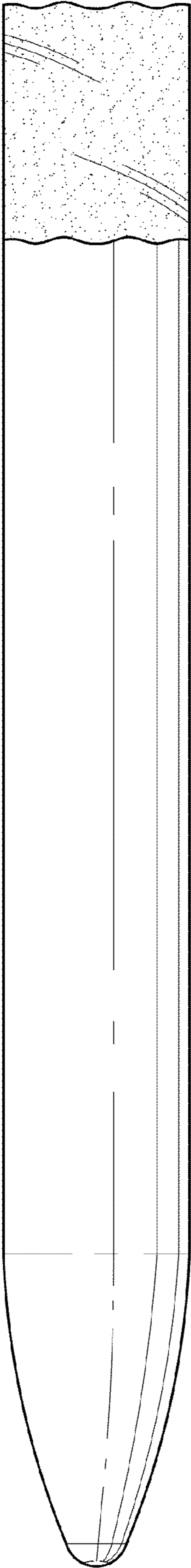

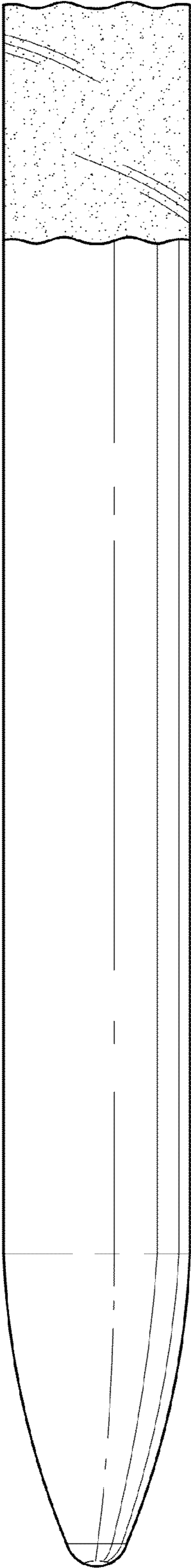

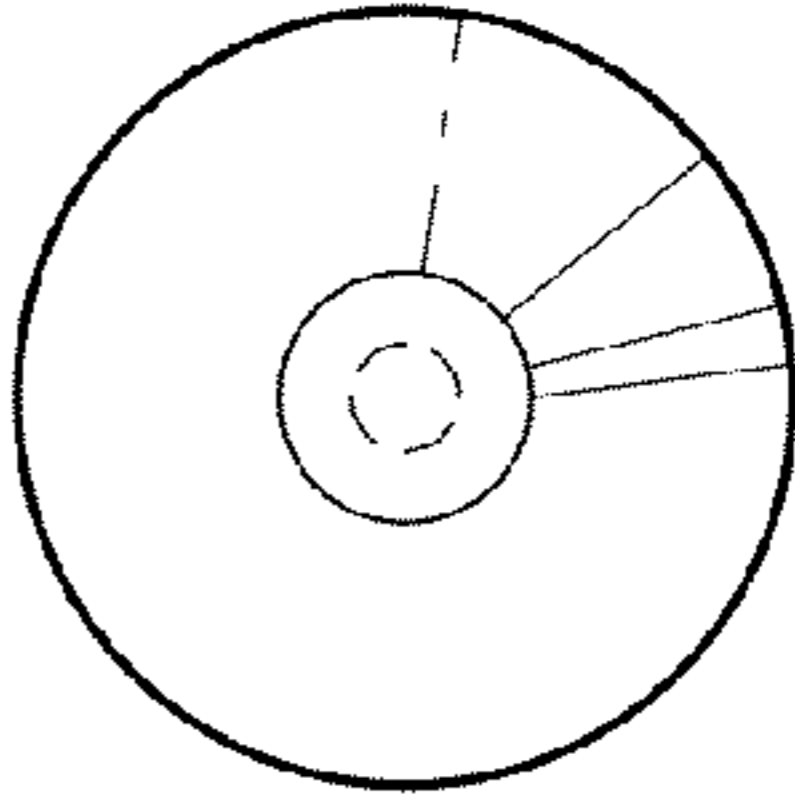

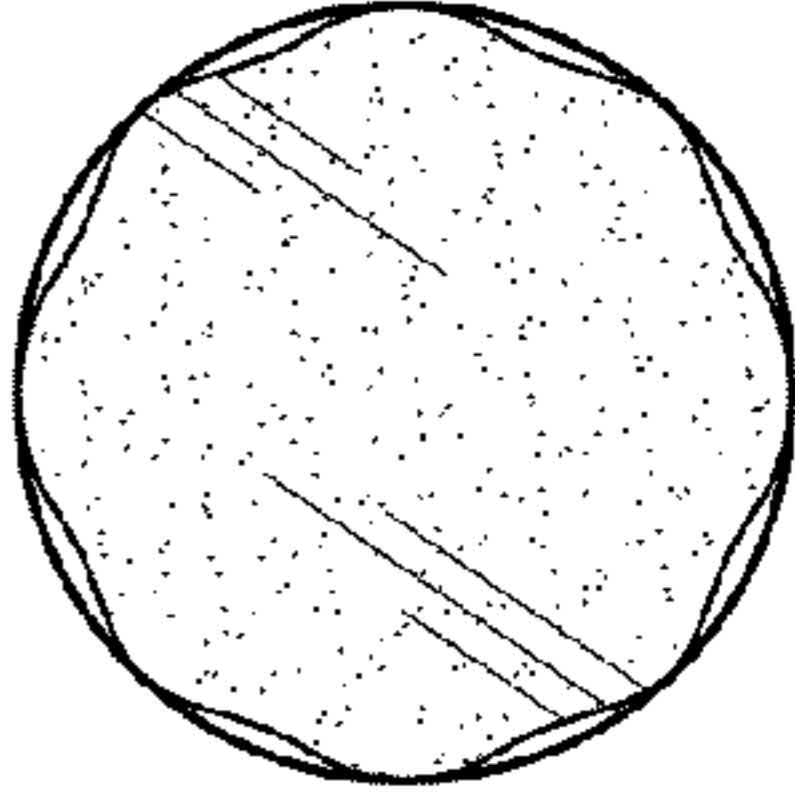
