**DESCRIPTION**

FIG. 5 is a top plan view thereof;

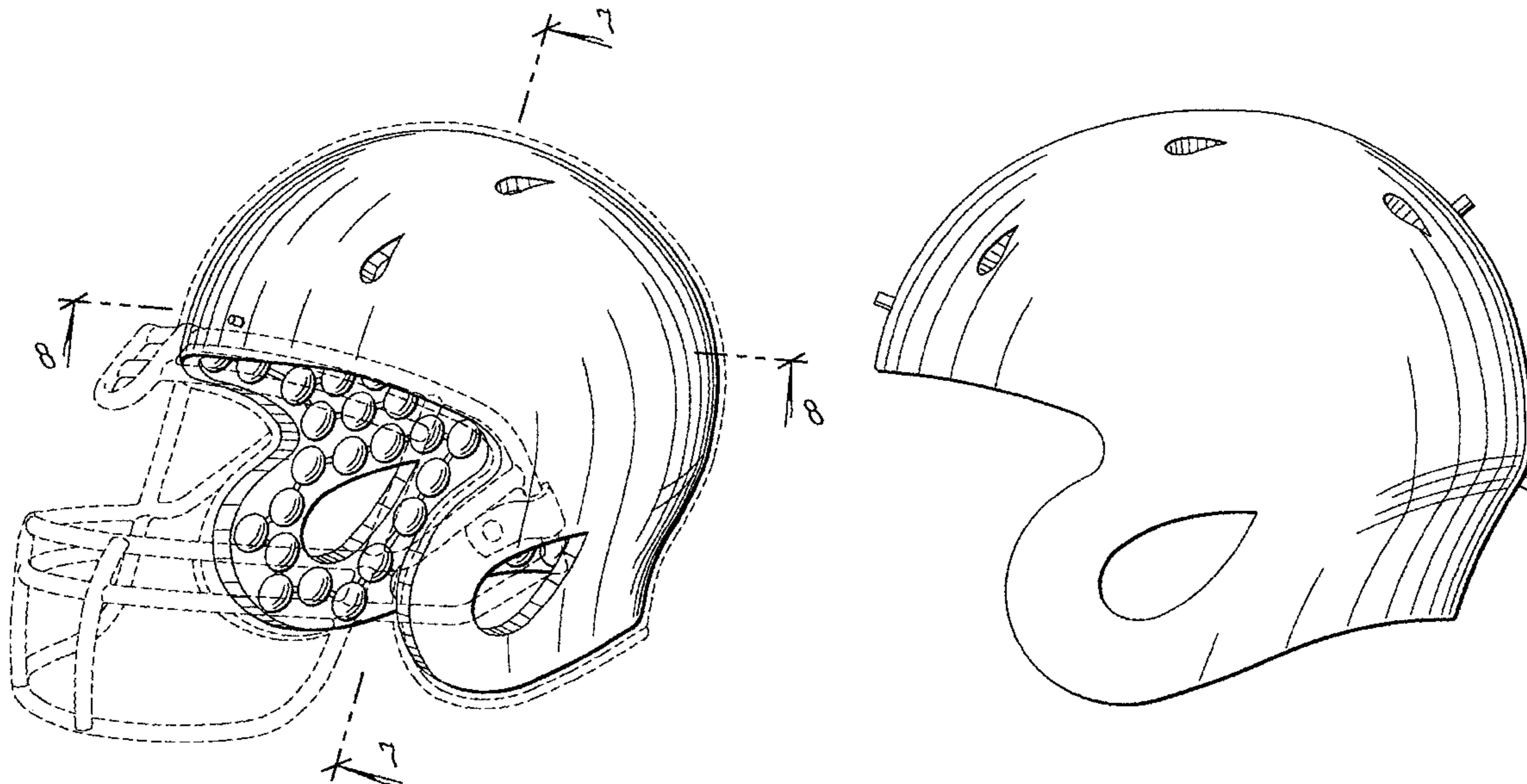
FIG. 6 is a bottom plan view thereof;

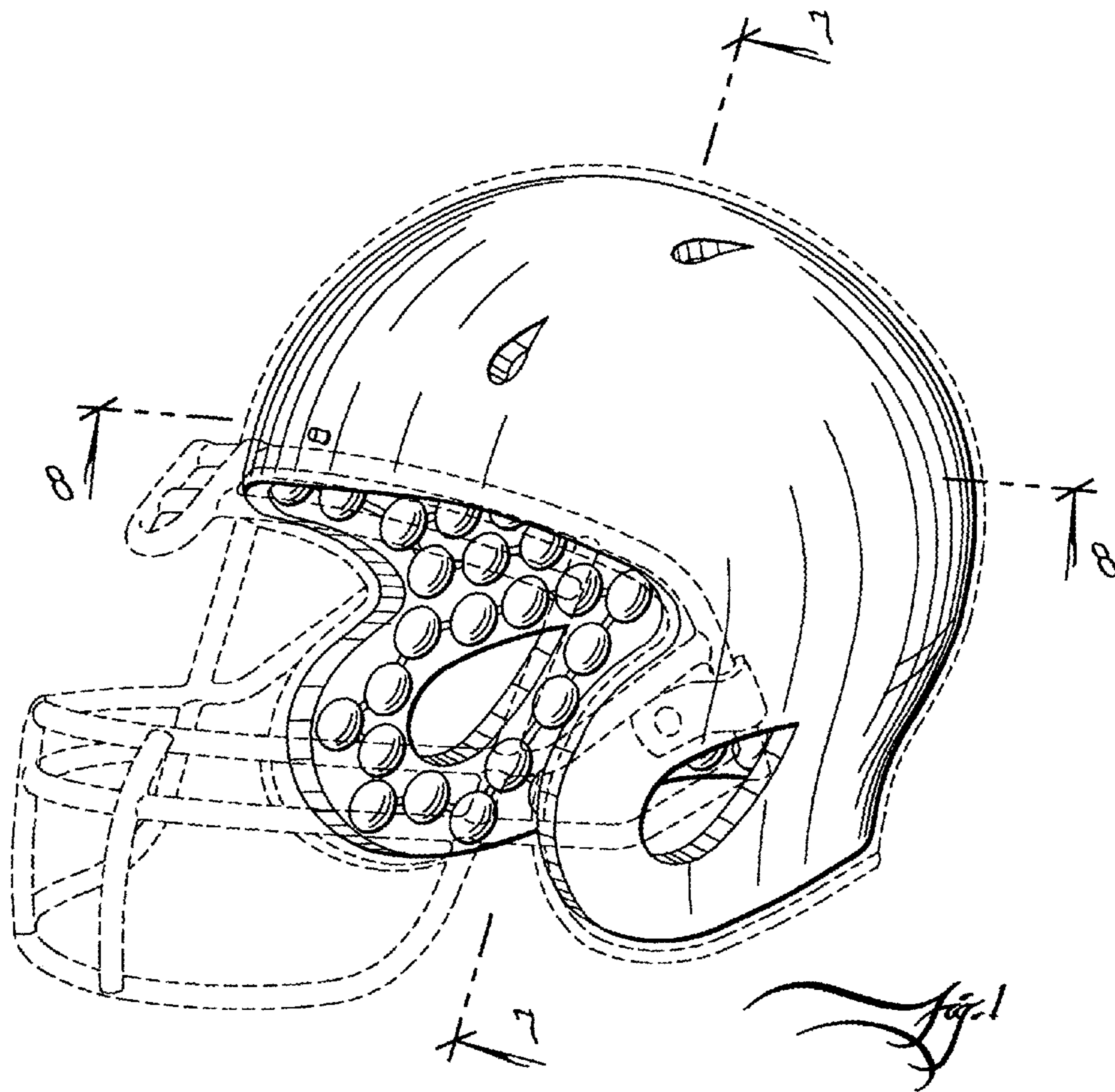
FIG. 7 is a section view taken along lines 7-7 in FIG. 1; and,

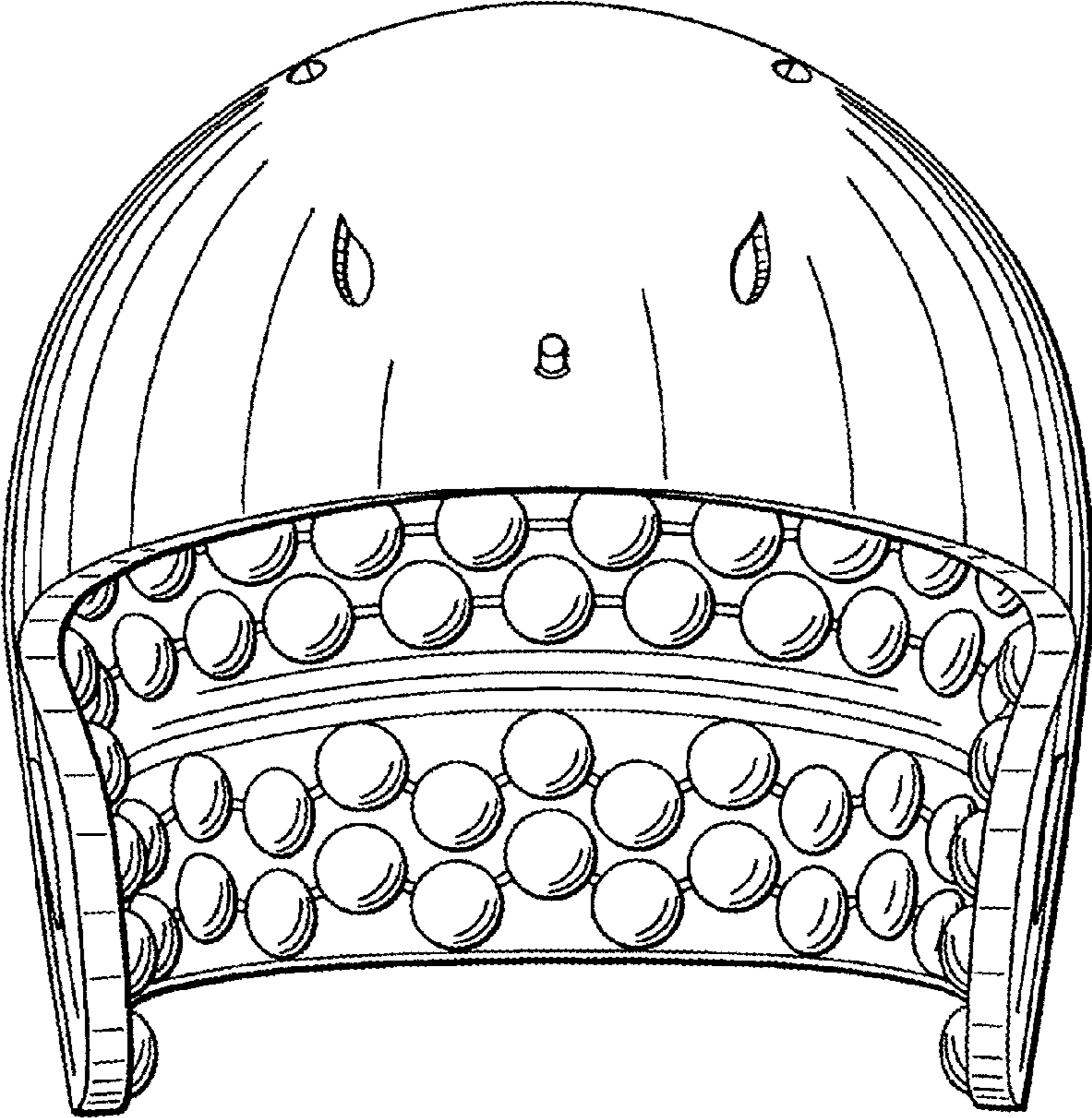
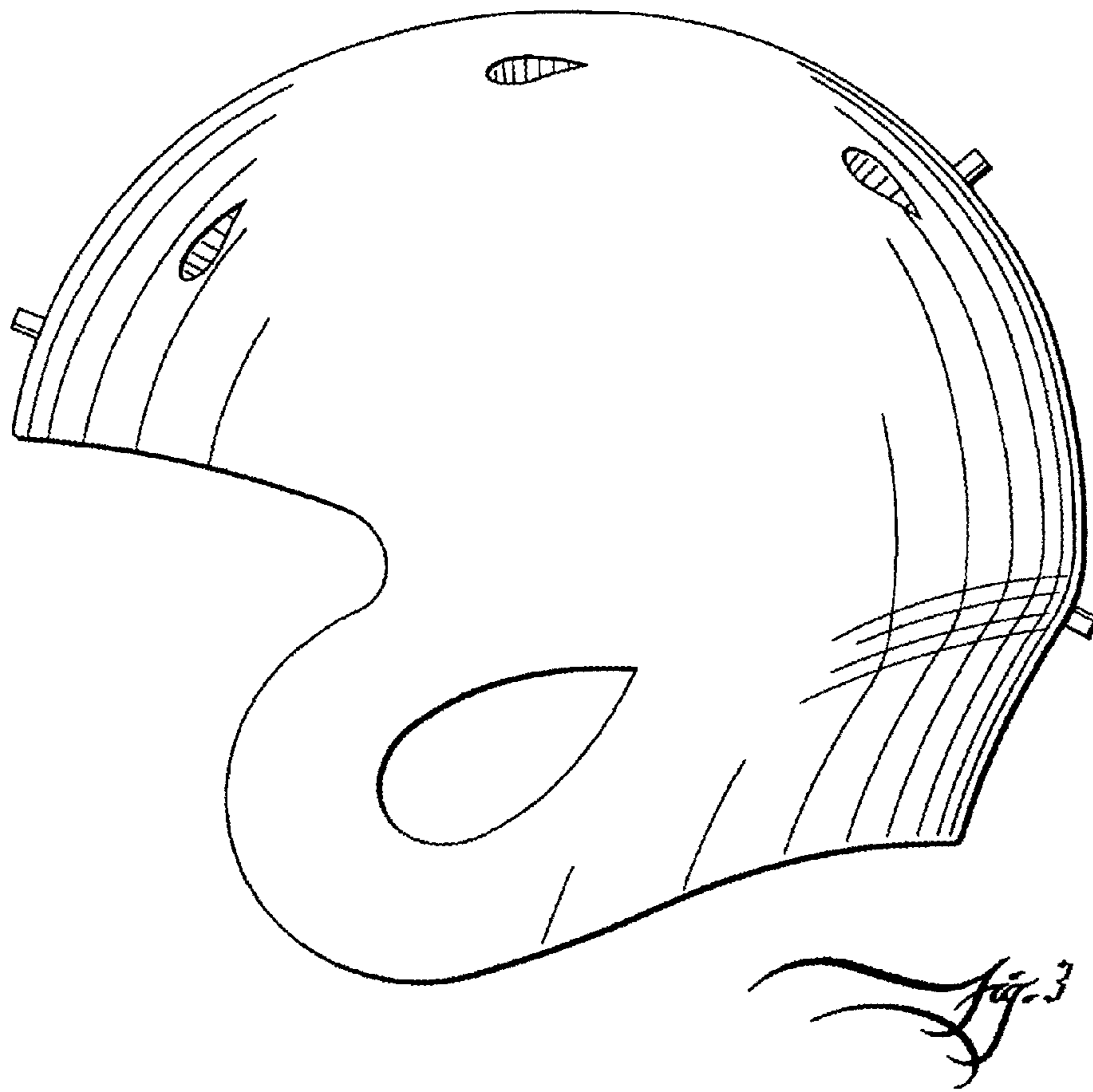
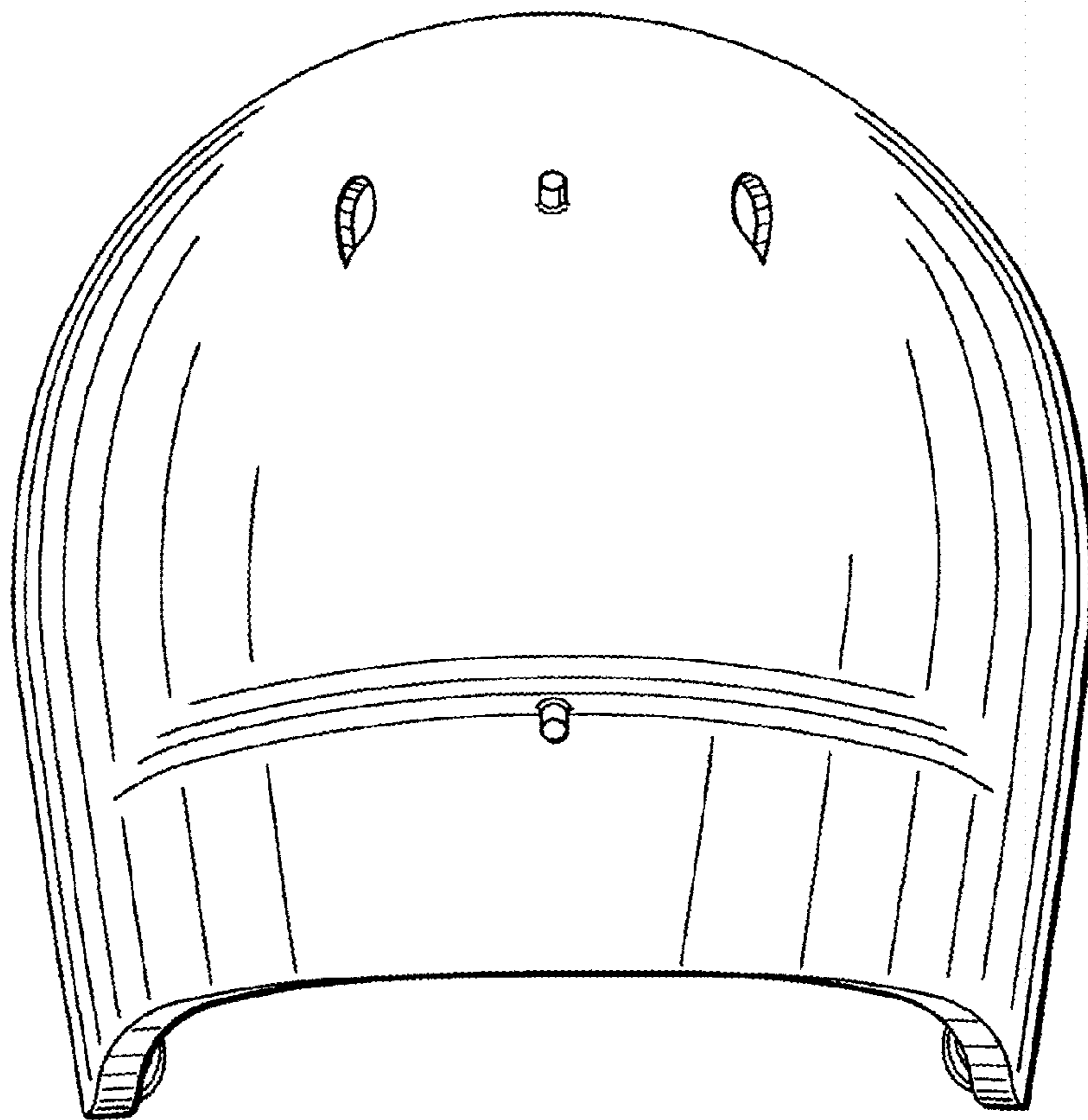


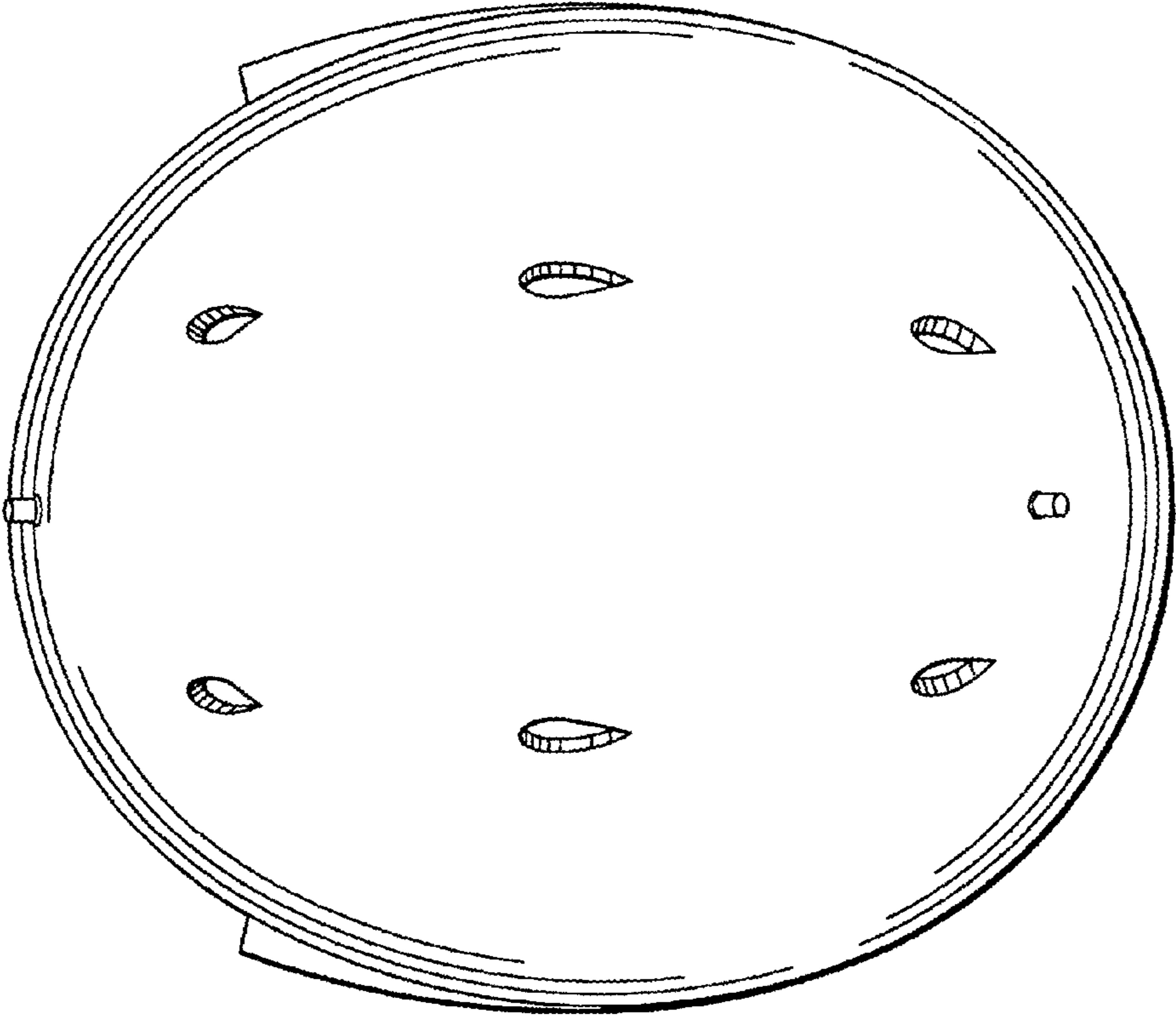

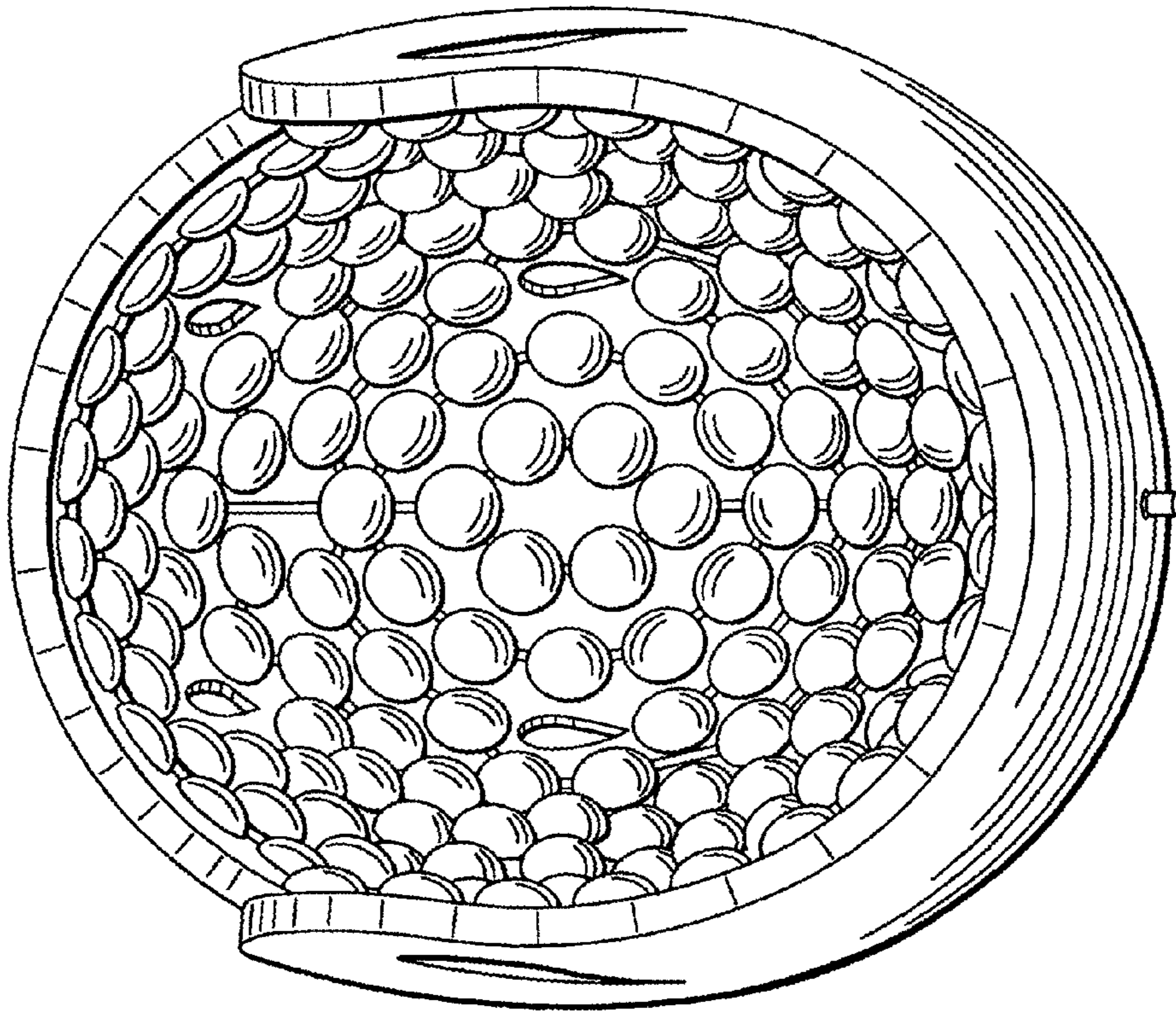




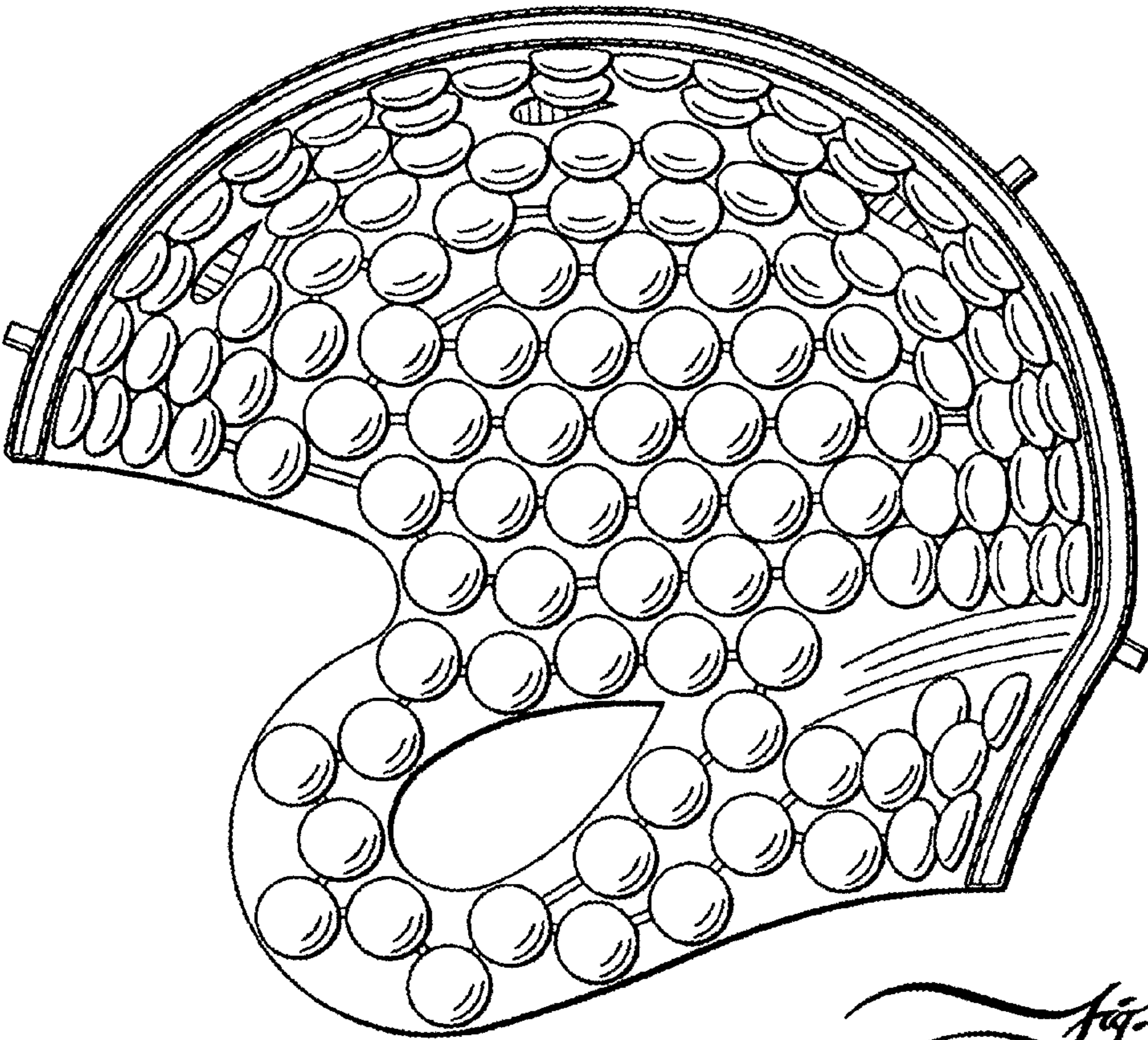

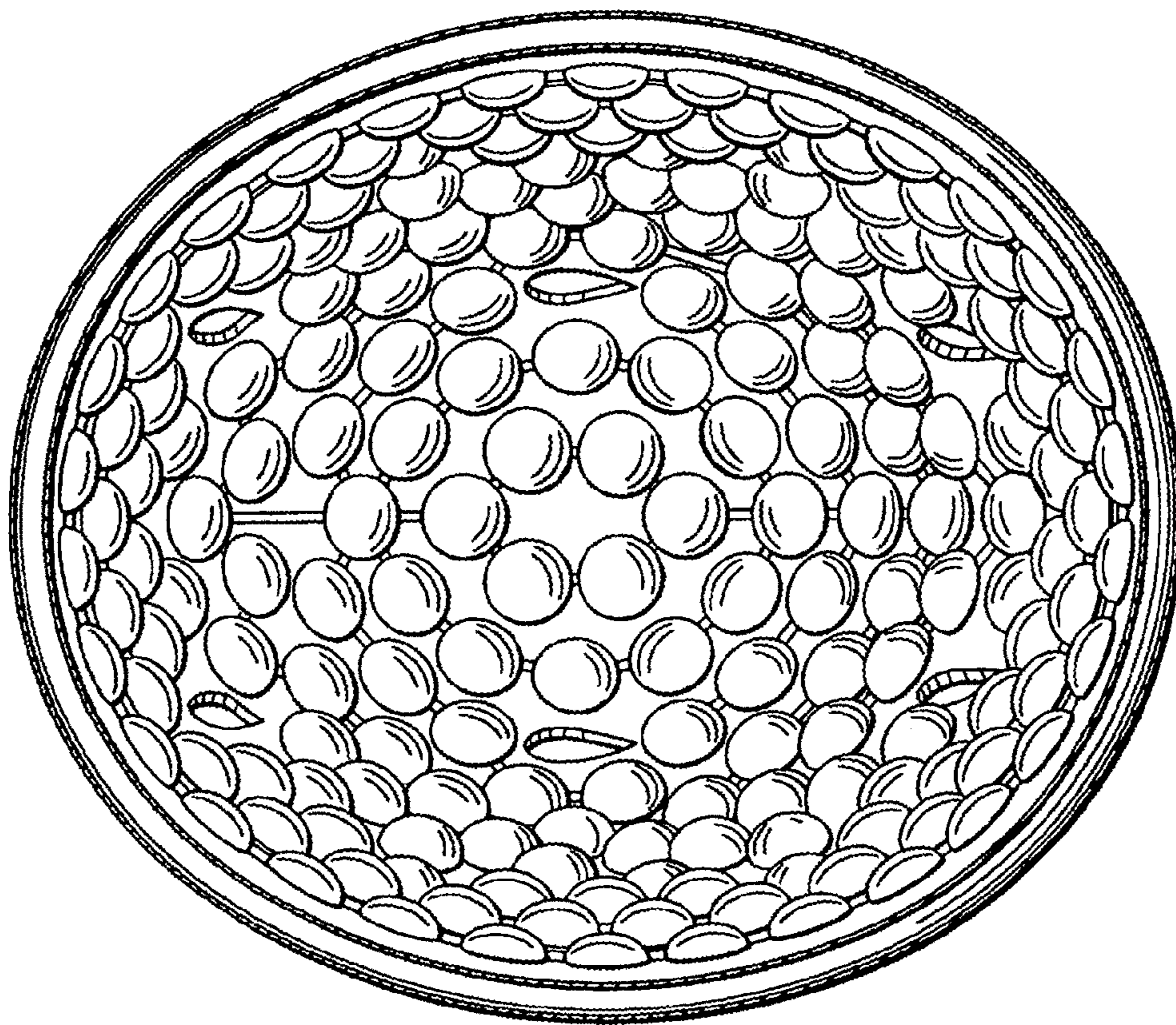
