The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

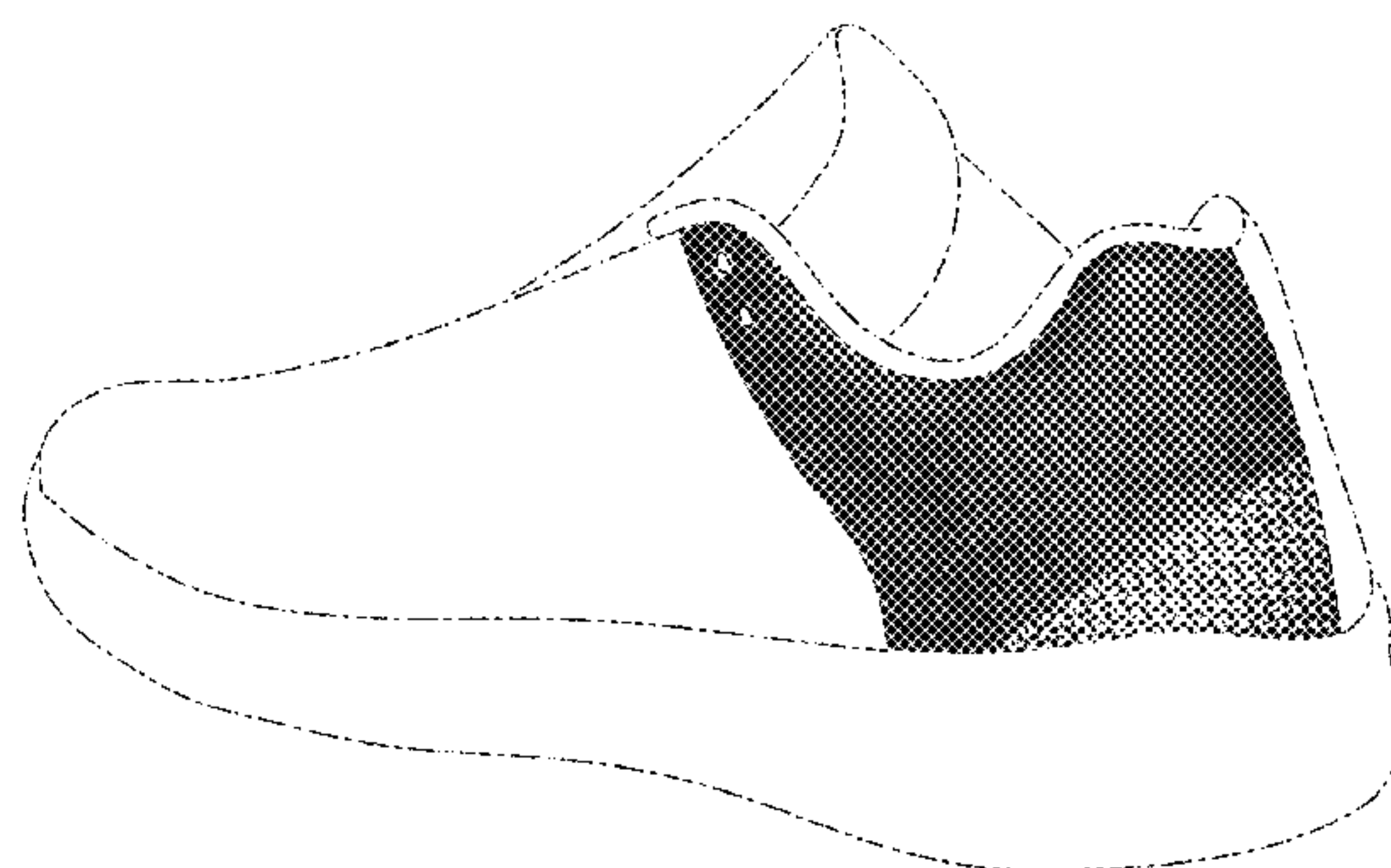
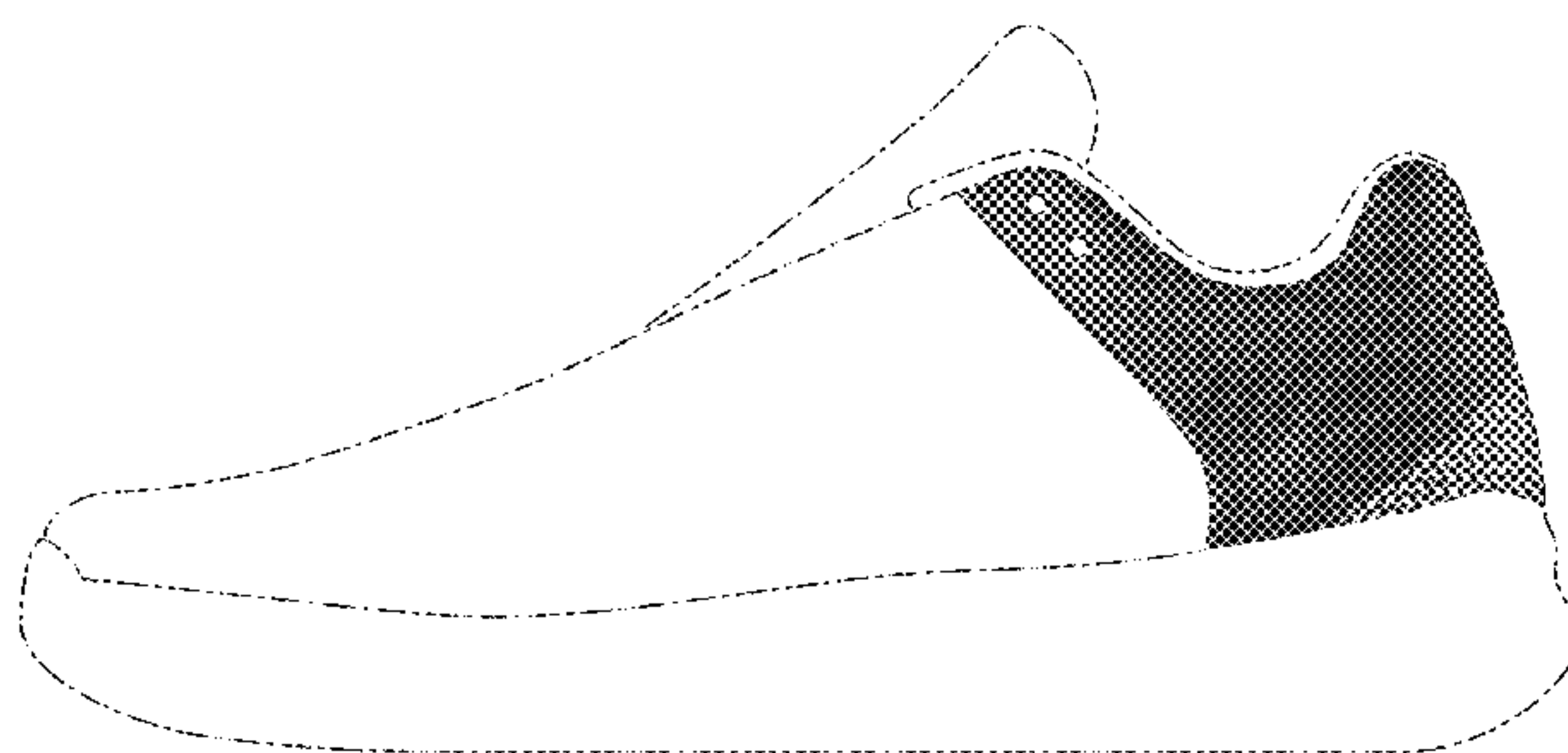
FIG. 1 is a front perspective view of a shoe upper showing our new design;

FIG. 2 is a side view thereof; and,

FIG. 3 is a rear perspective view thereof.

The photographic area is claimed. The broken lines immediately adjacent to the photographic area represent unclaimed boundaries of the design. The two unshaded eyelet regions within the photographic area form no part of the claimed design. The lack of a broken or solid line immediately adjacent to the photographic area indicates a claimed edge of the design. The broken lines showing the remainder of the shoe are for environmental purposes only and form no part of the claimed design.

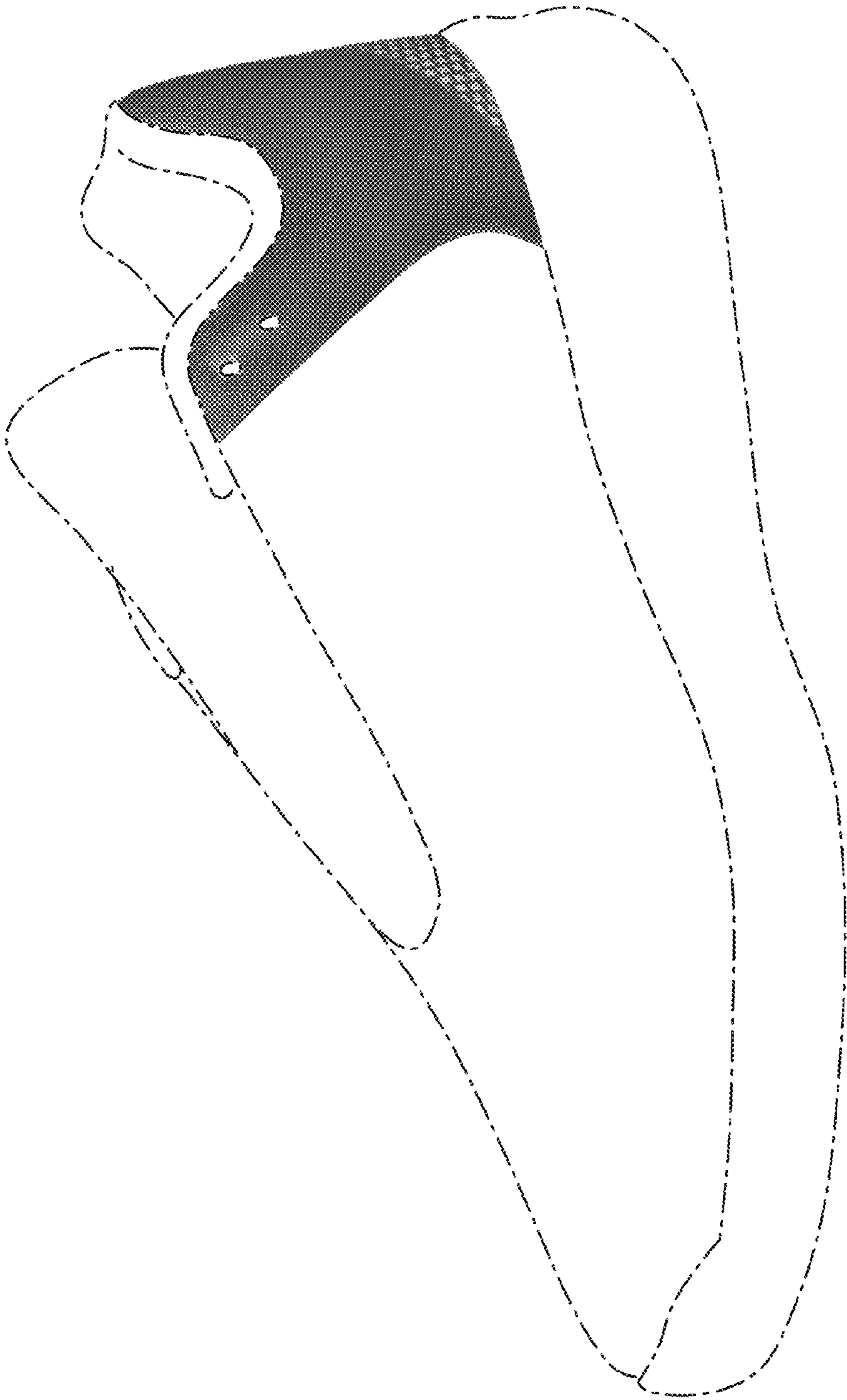

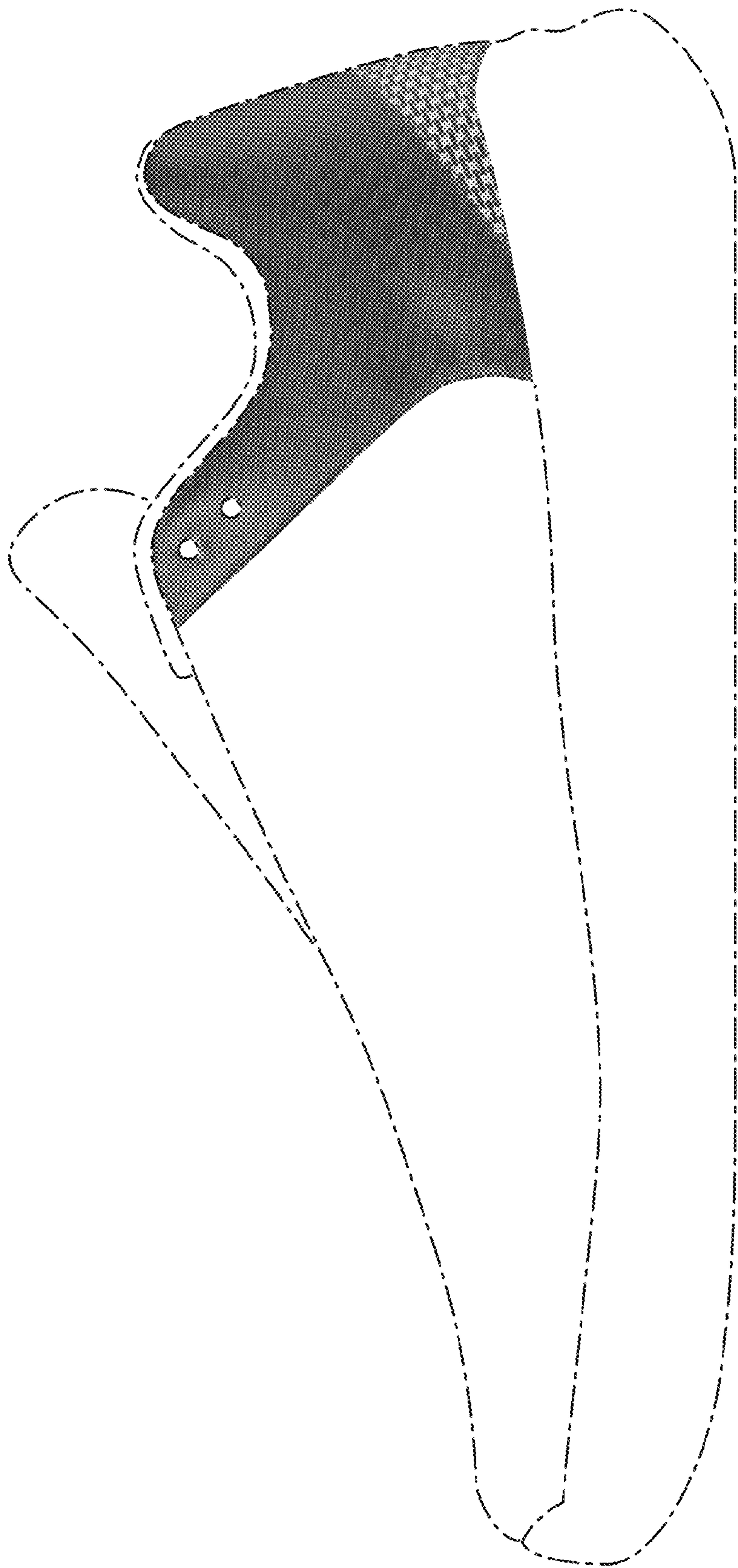

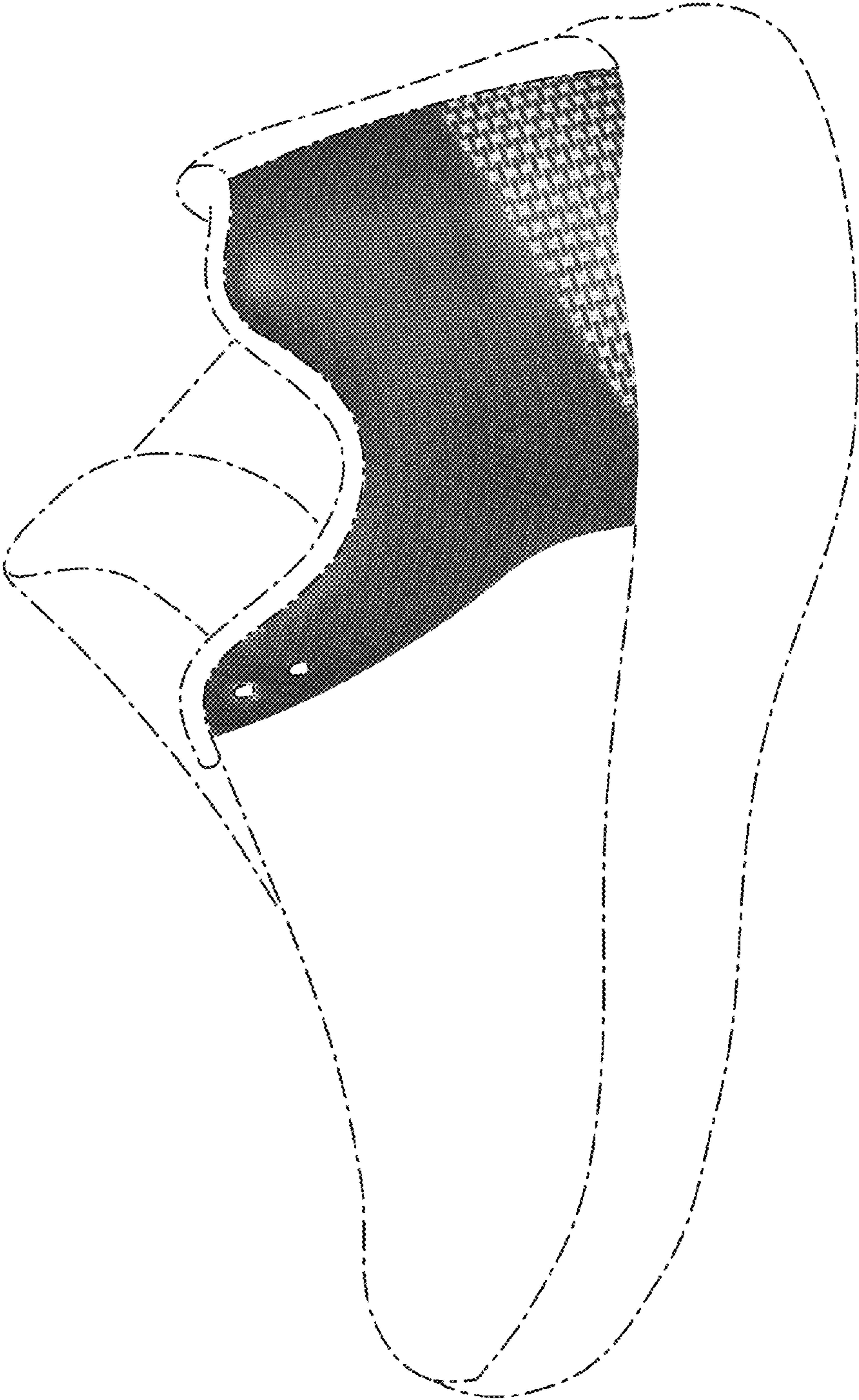
