The ornamental design for a bag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of my new bag having ornamental fringe tied on the bag;
FIG. 2 is a front elevational view of my new bag of FIG. 1;
FIG. 3 is a rear elevational view of my new bag, opposite that of FIG. 2;
FIG. 4 is a left side elevational view of my new bag of FIG. 1;
FIG. 5 is a right side elevational view of my new bag from a side opposite that of FIG. 4;
FIG. 6 is a top view of my new bag; and,
FIG. 7 is a bottom view of my new bag.

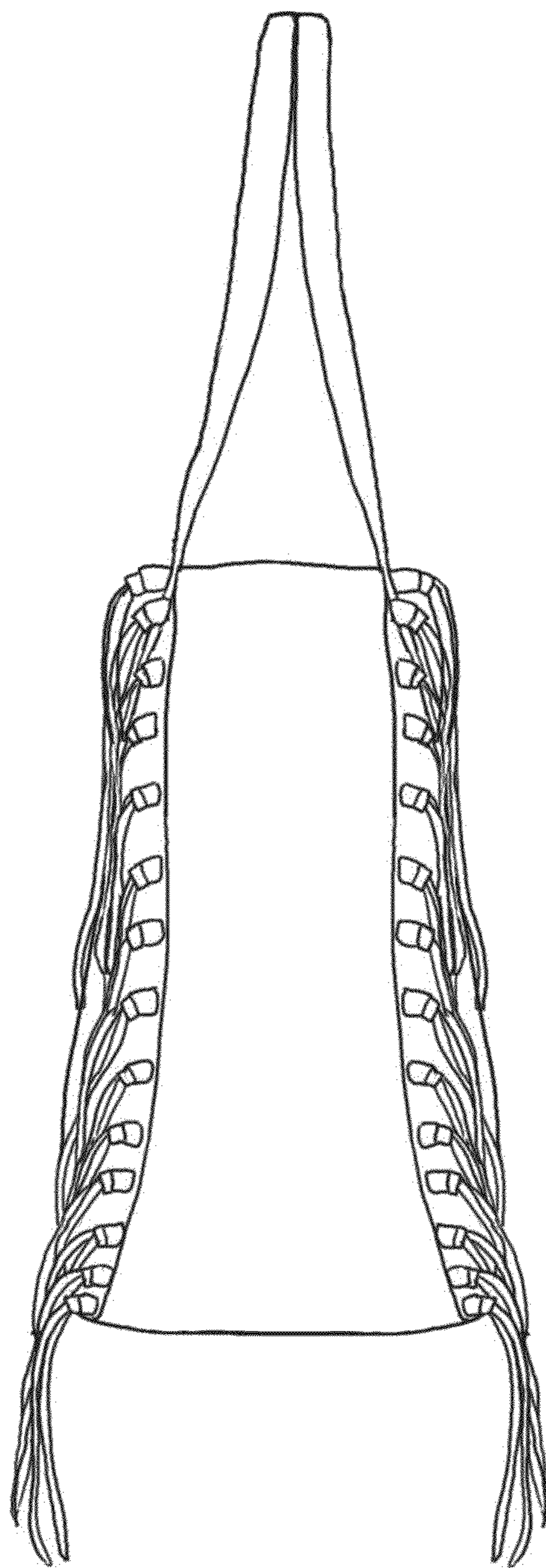

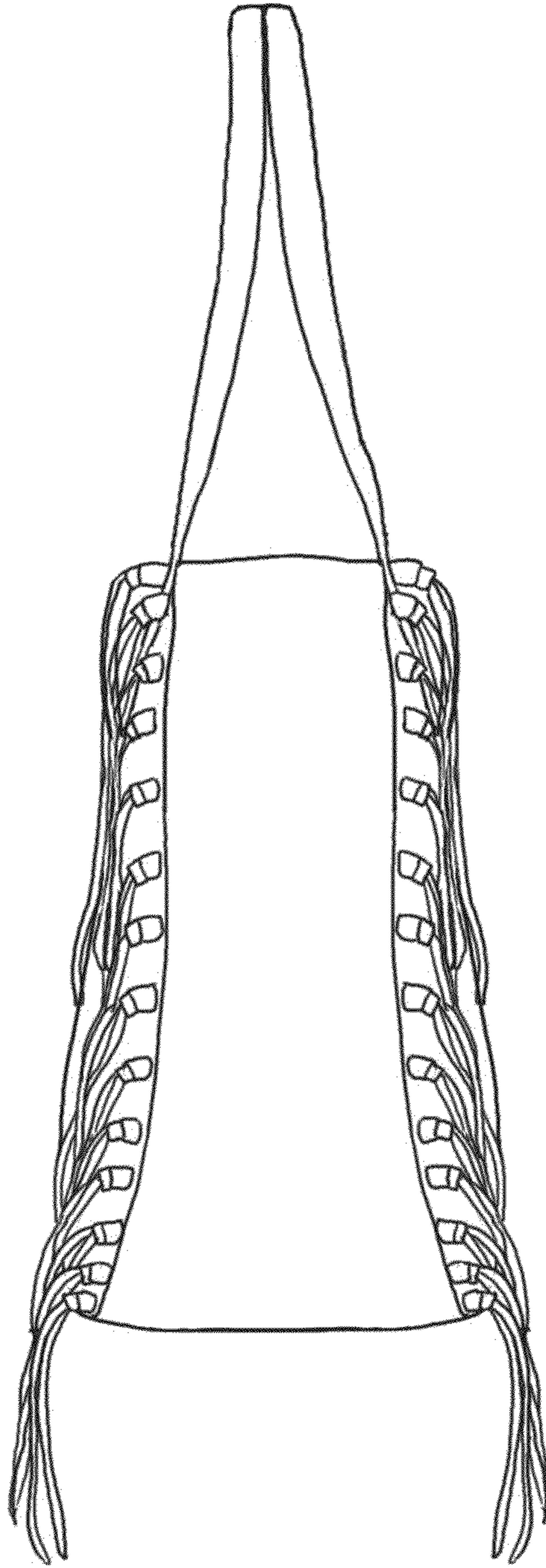

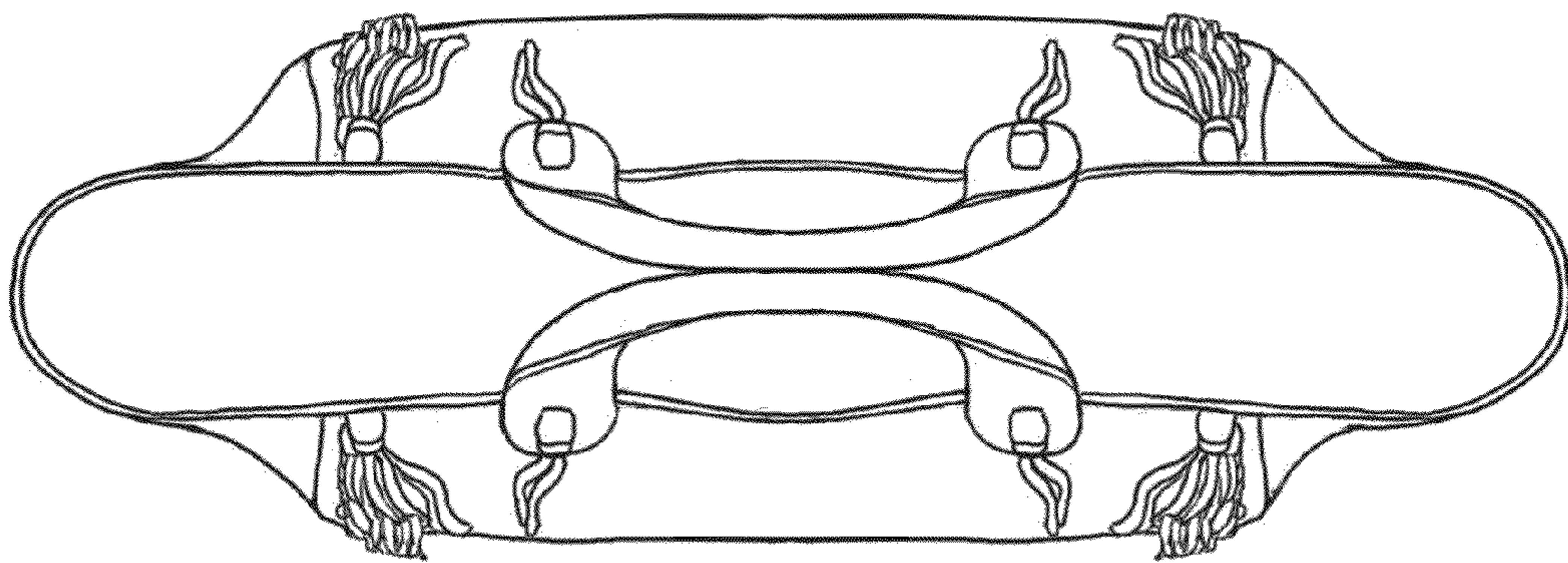

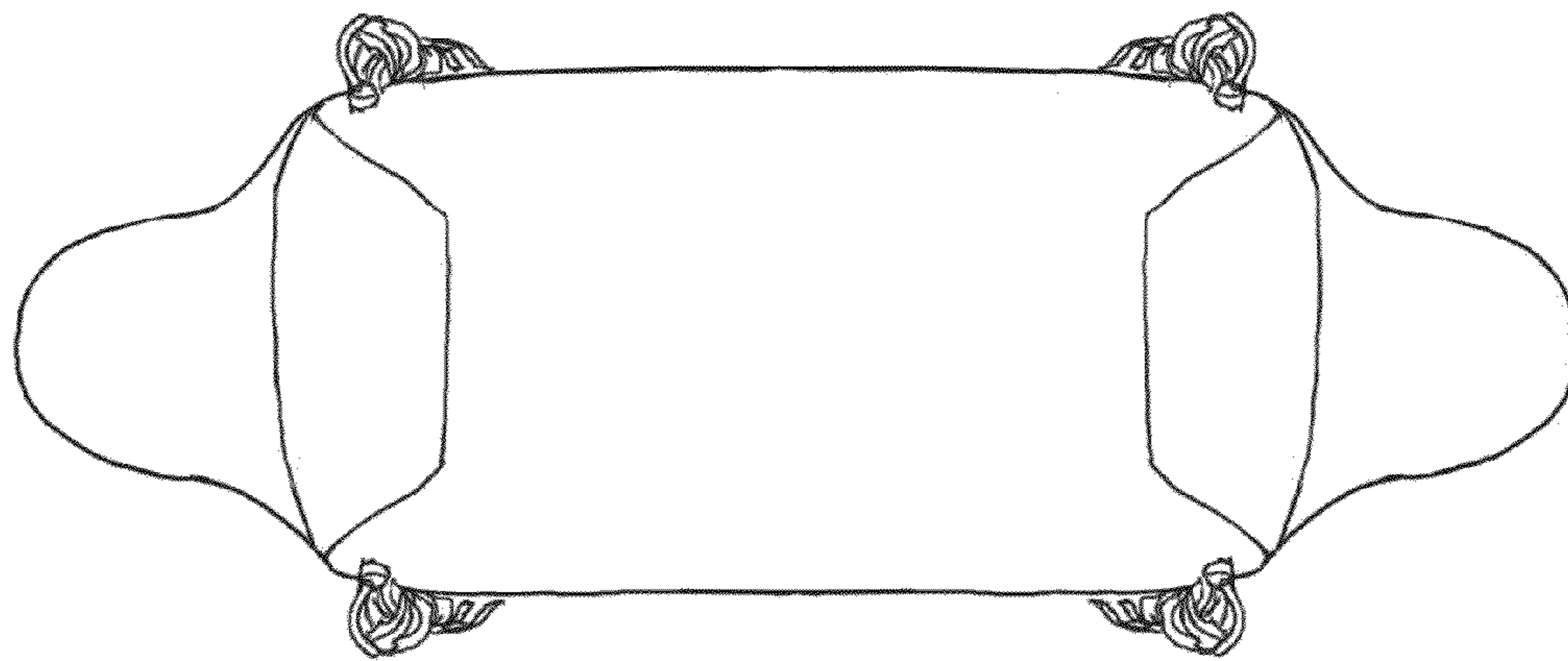
