FIG. 8 is a perspective view of a second embodiment of an over the counter medicinal container with surface ornamentation embodying our new design;

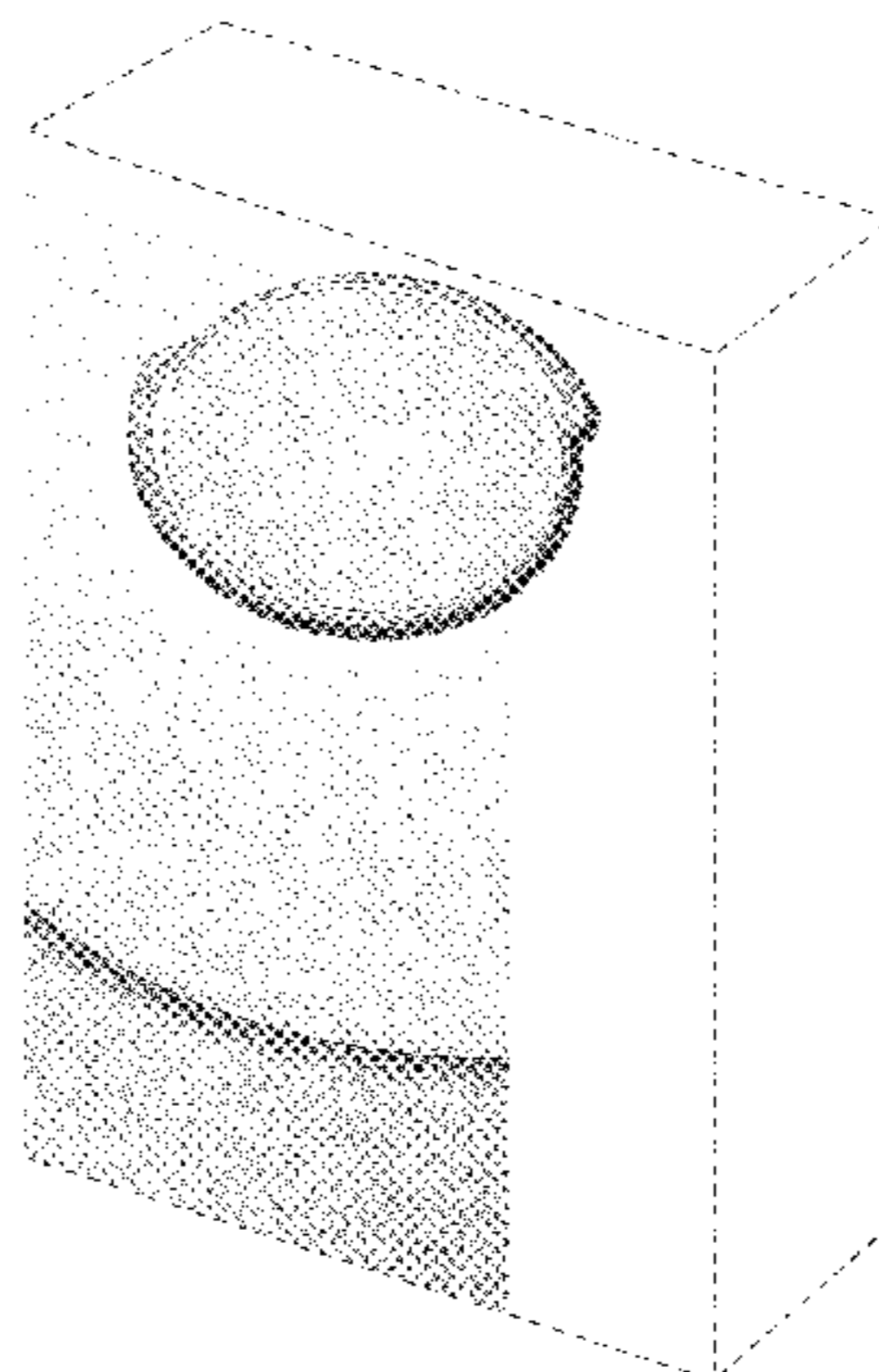

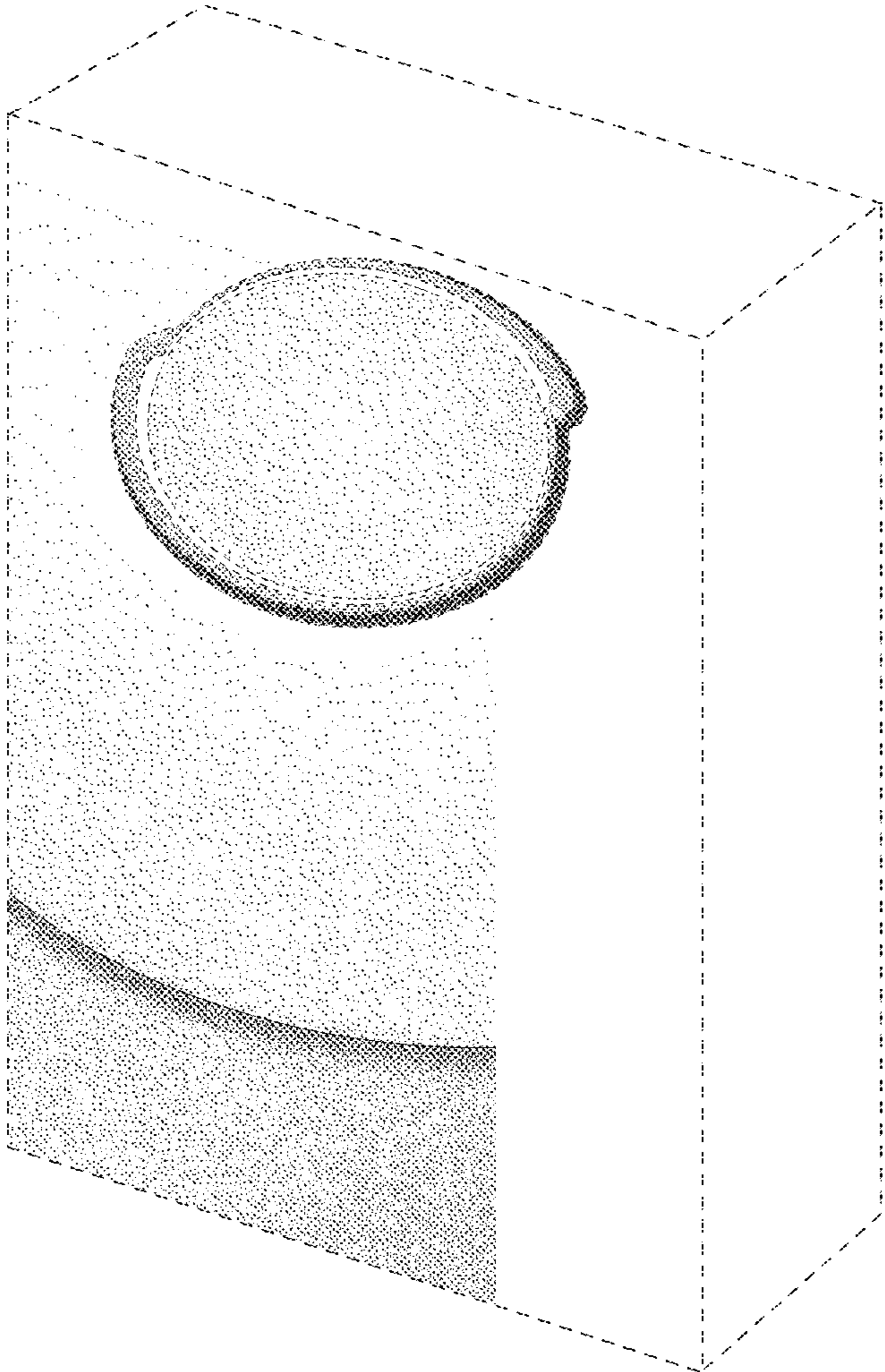

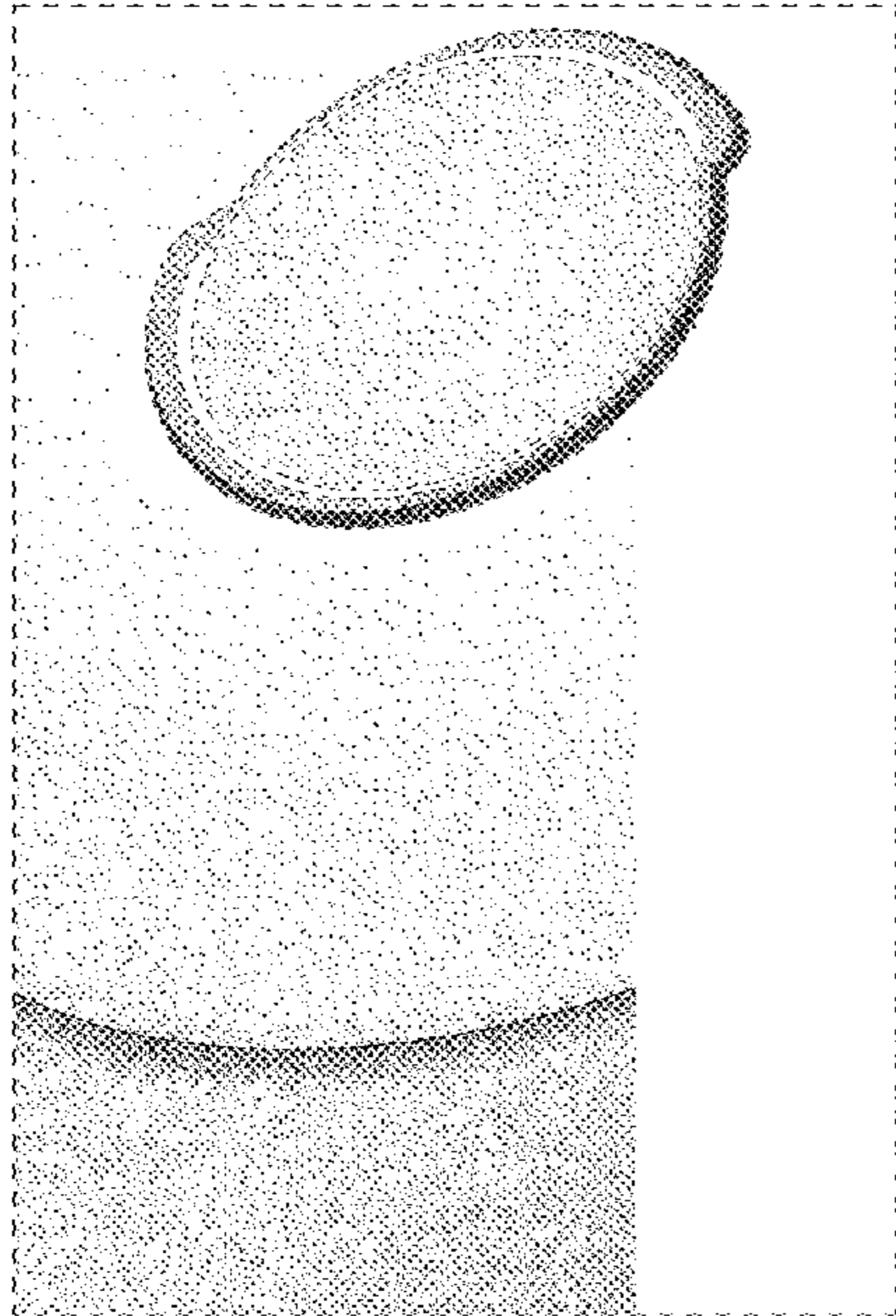

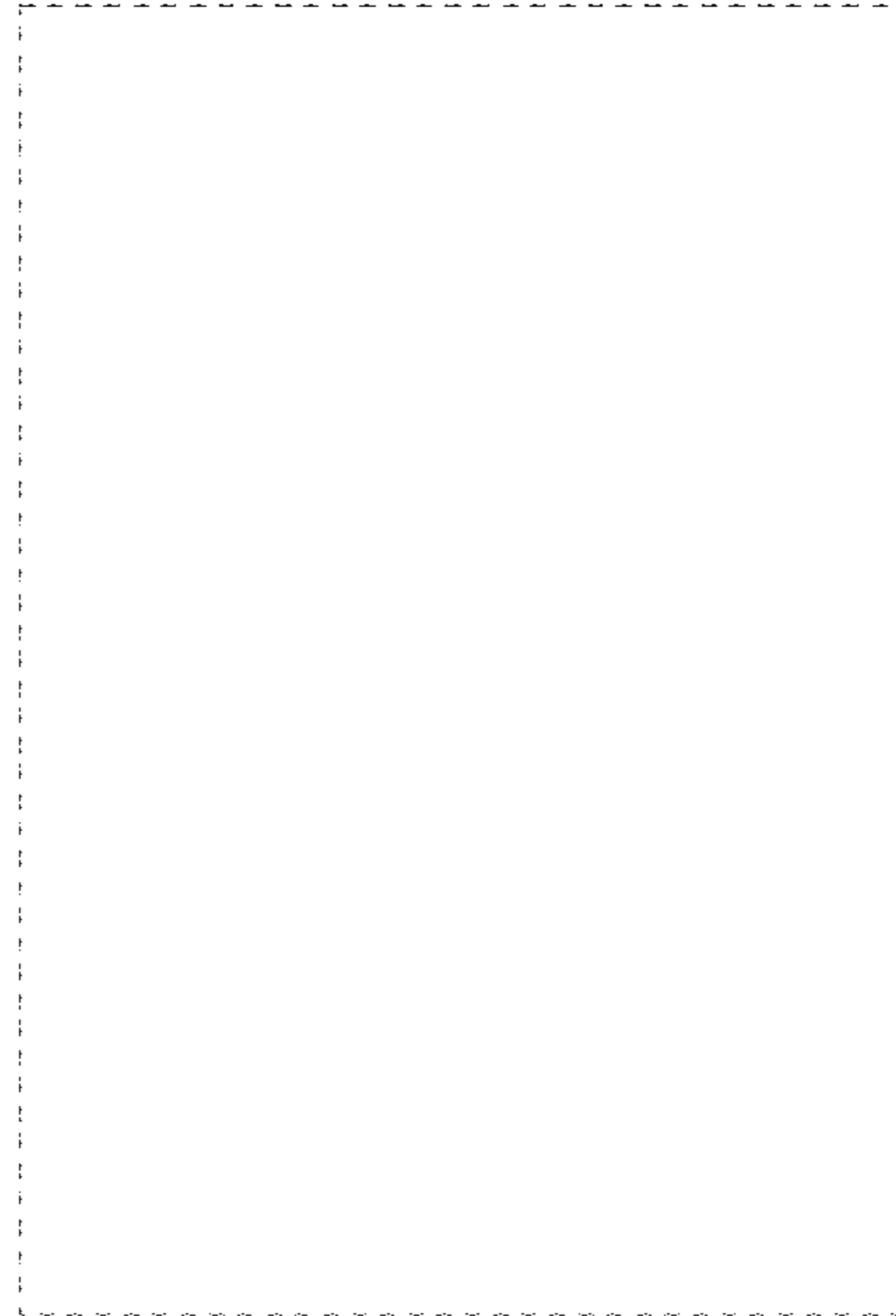

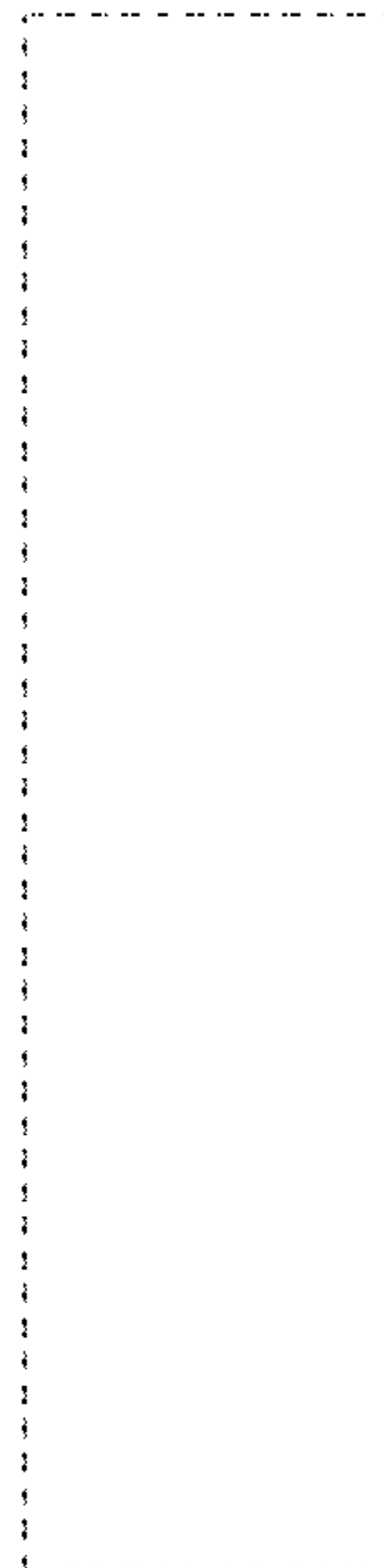

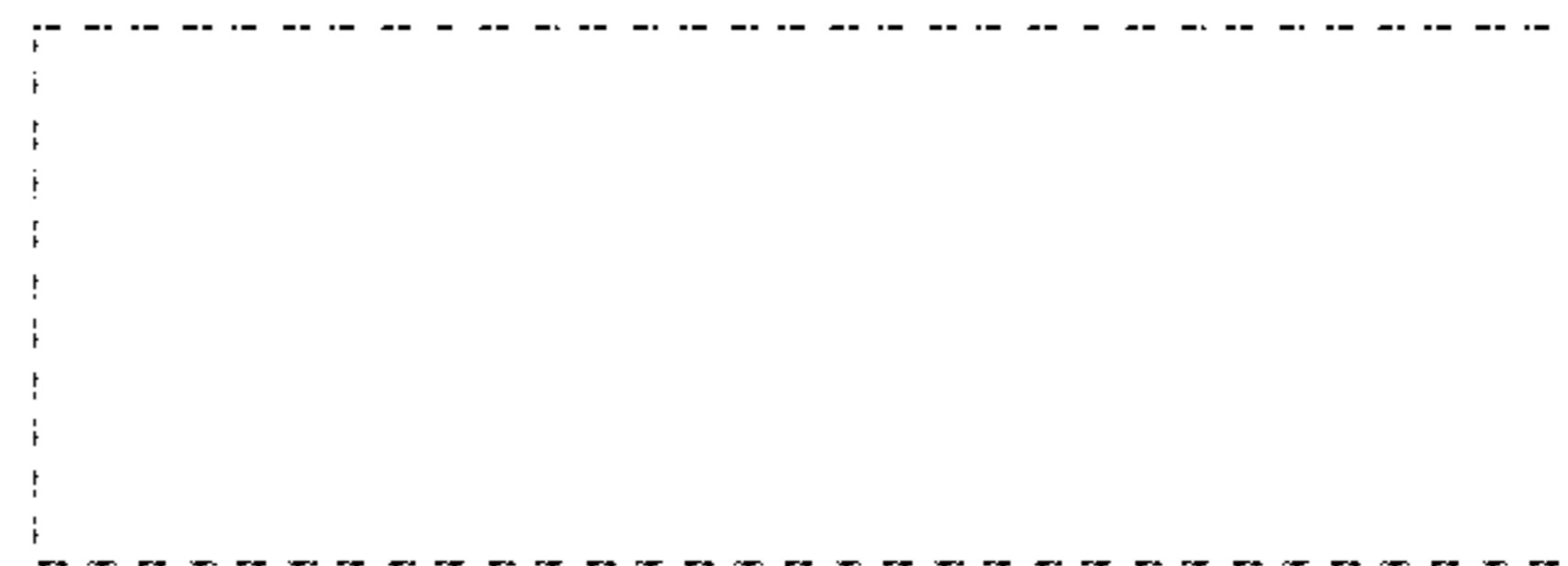

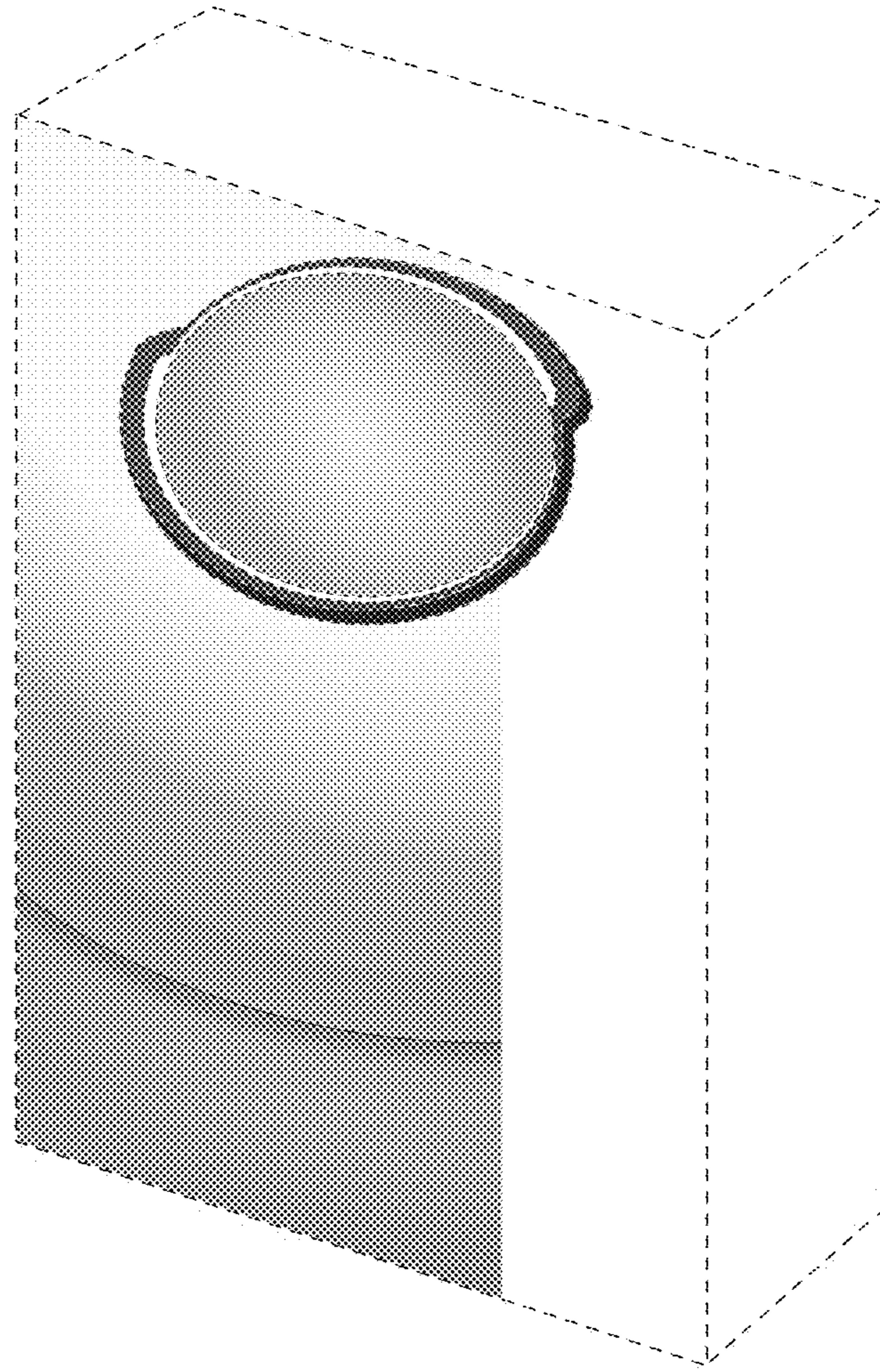

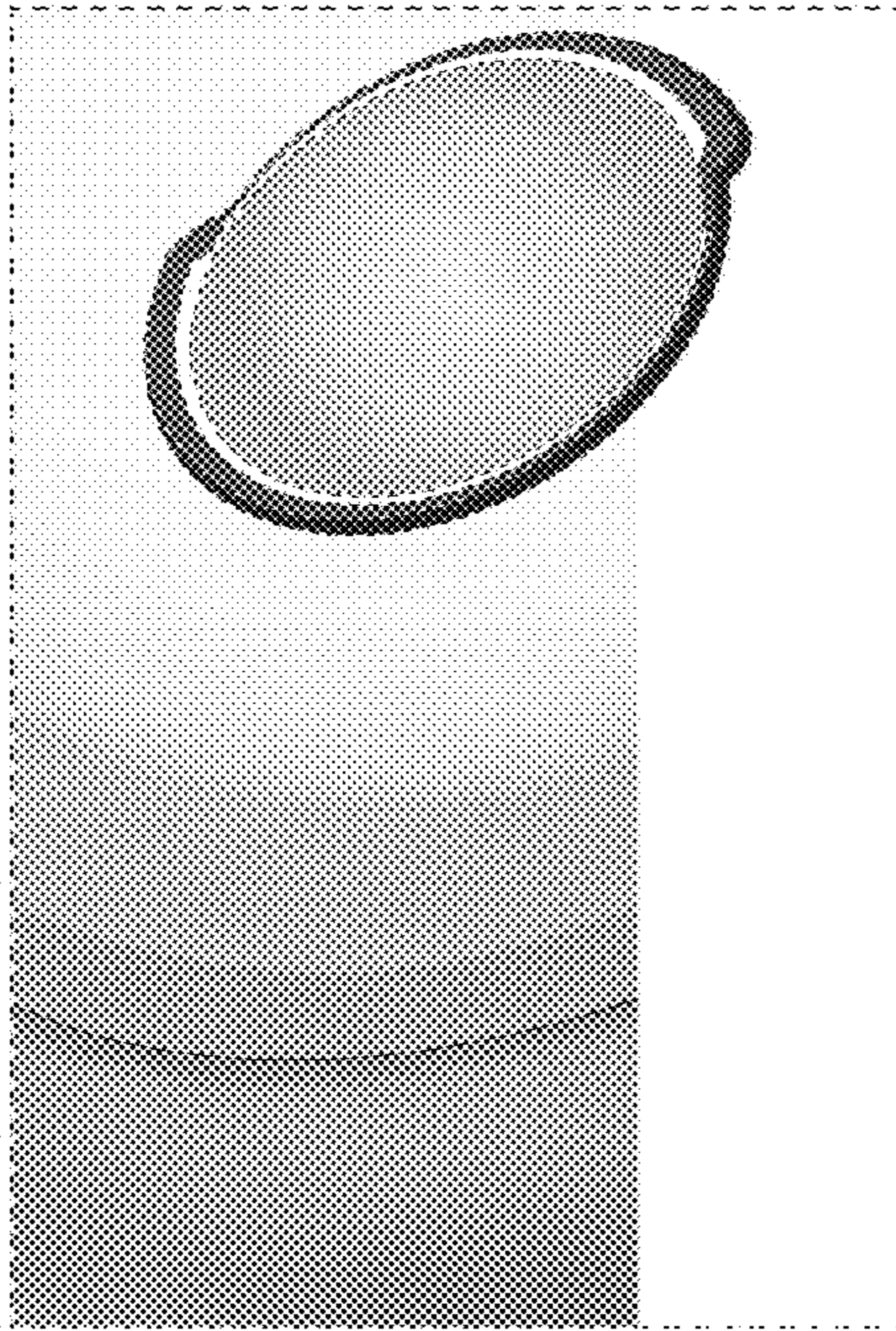

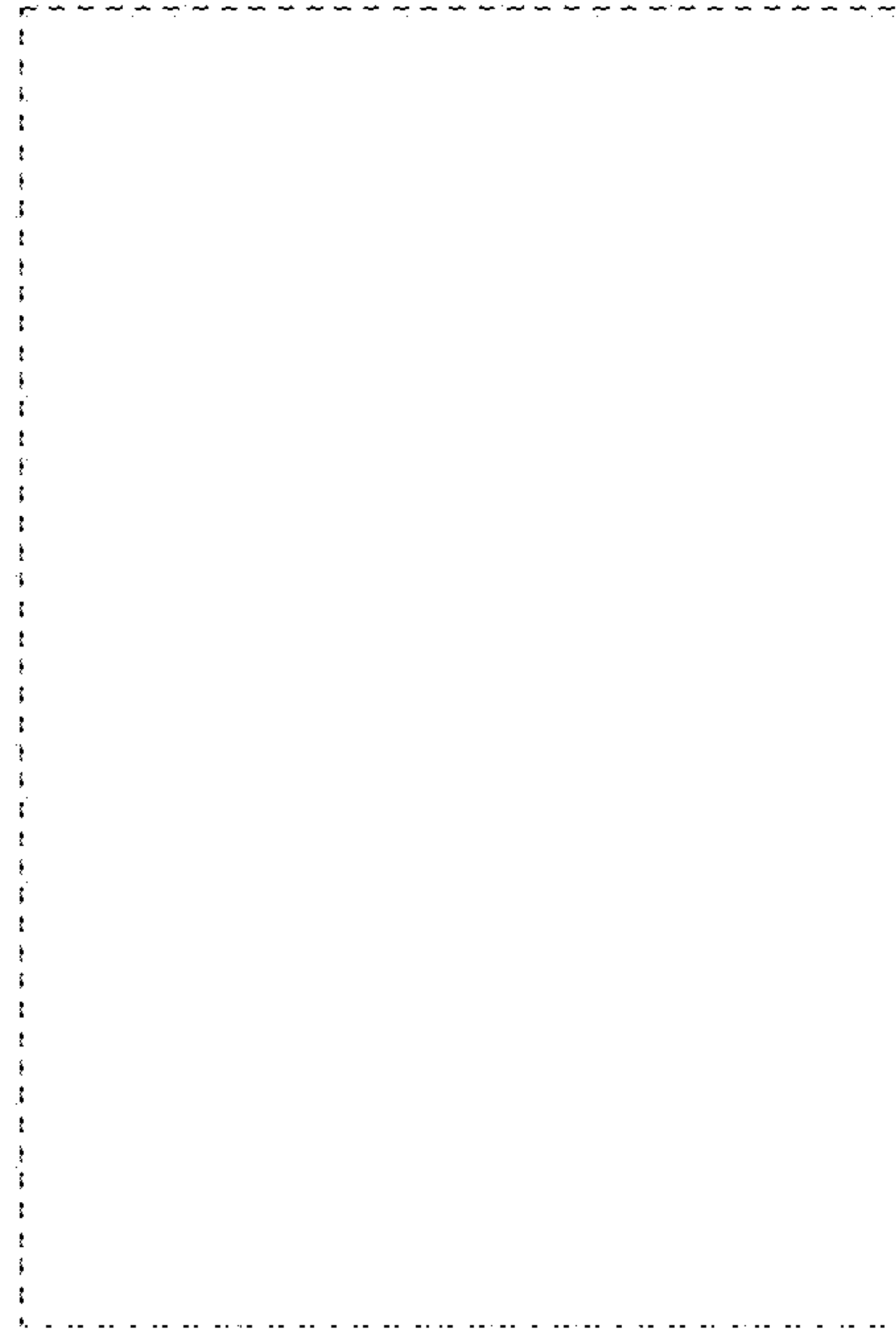

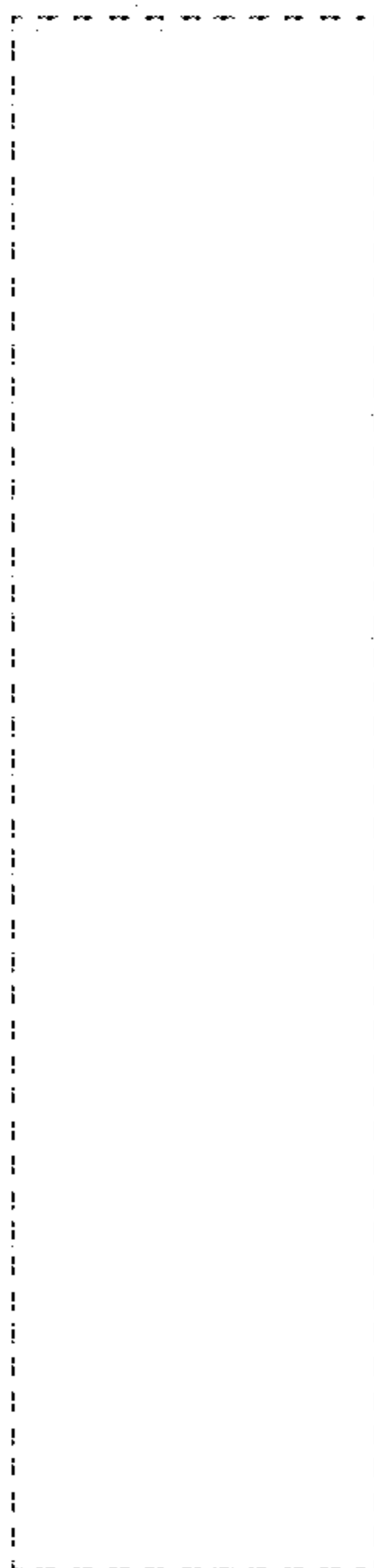

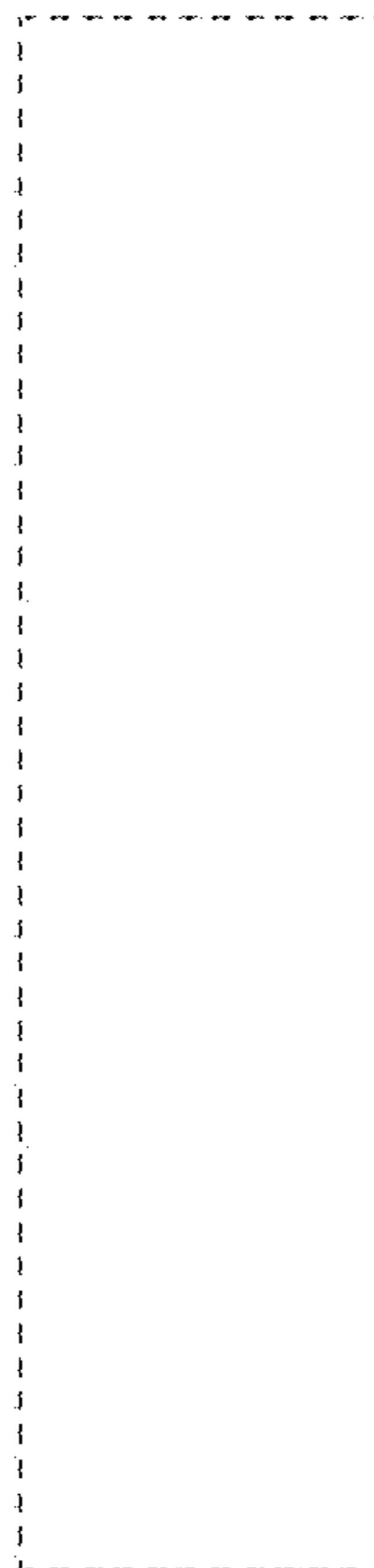

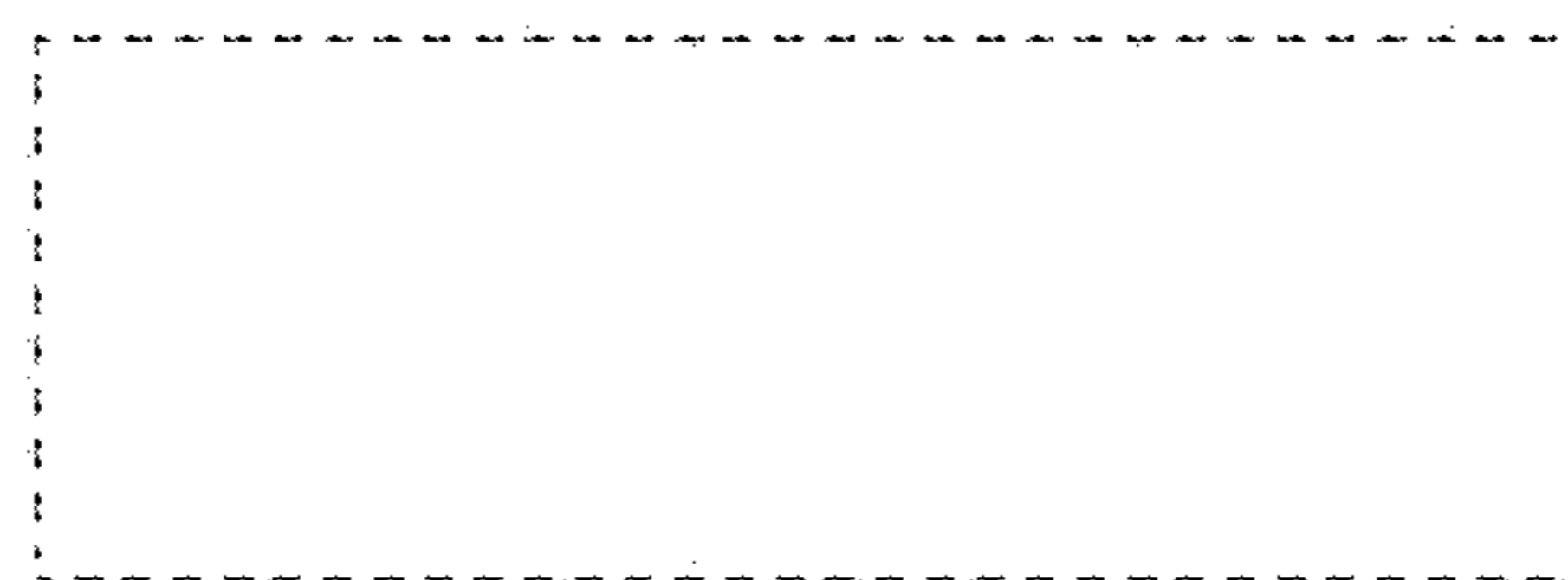

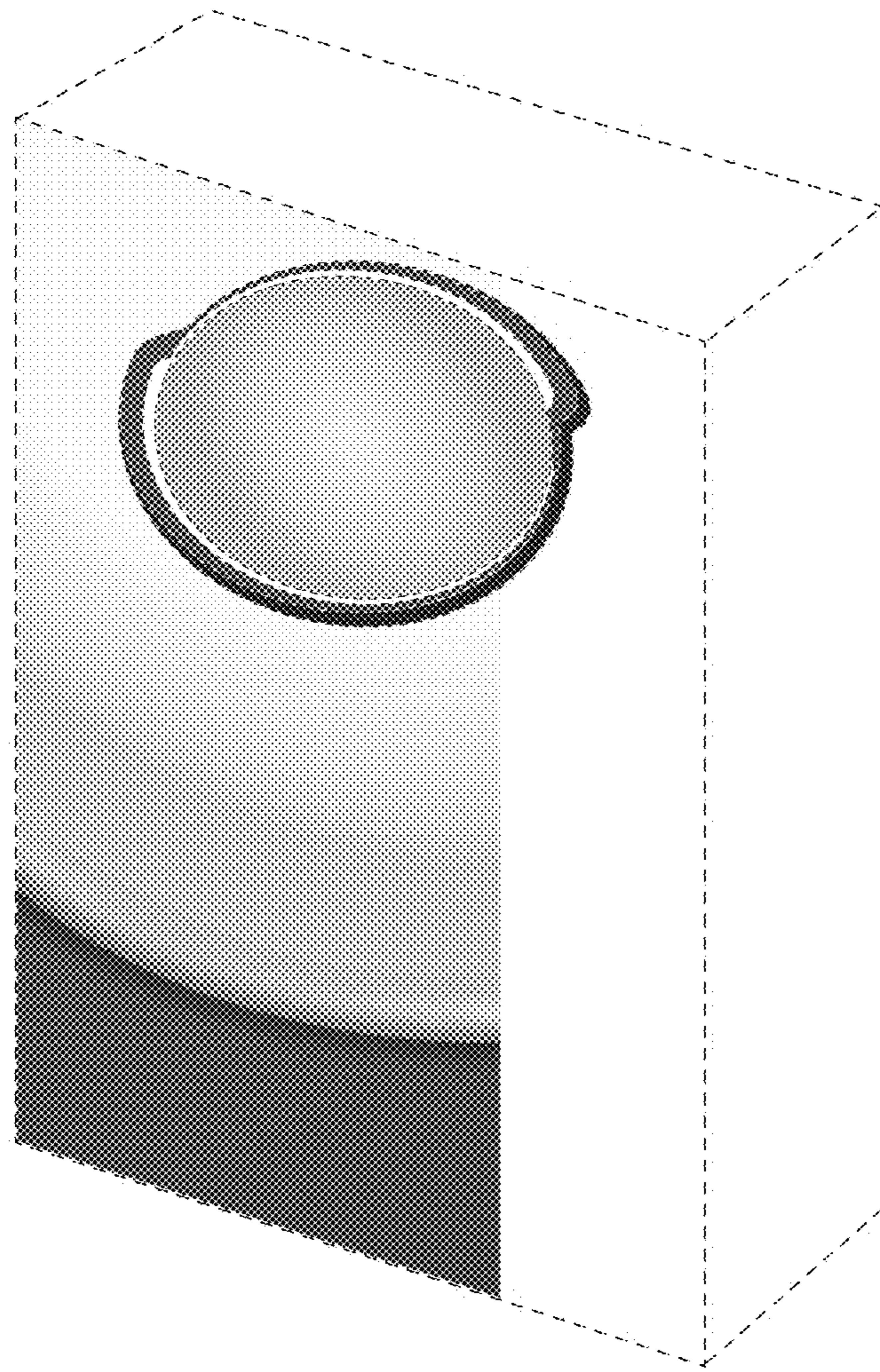

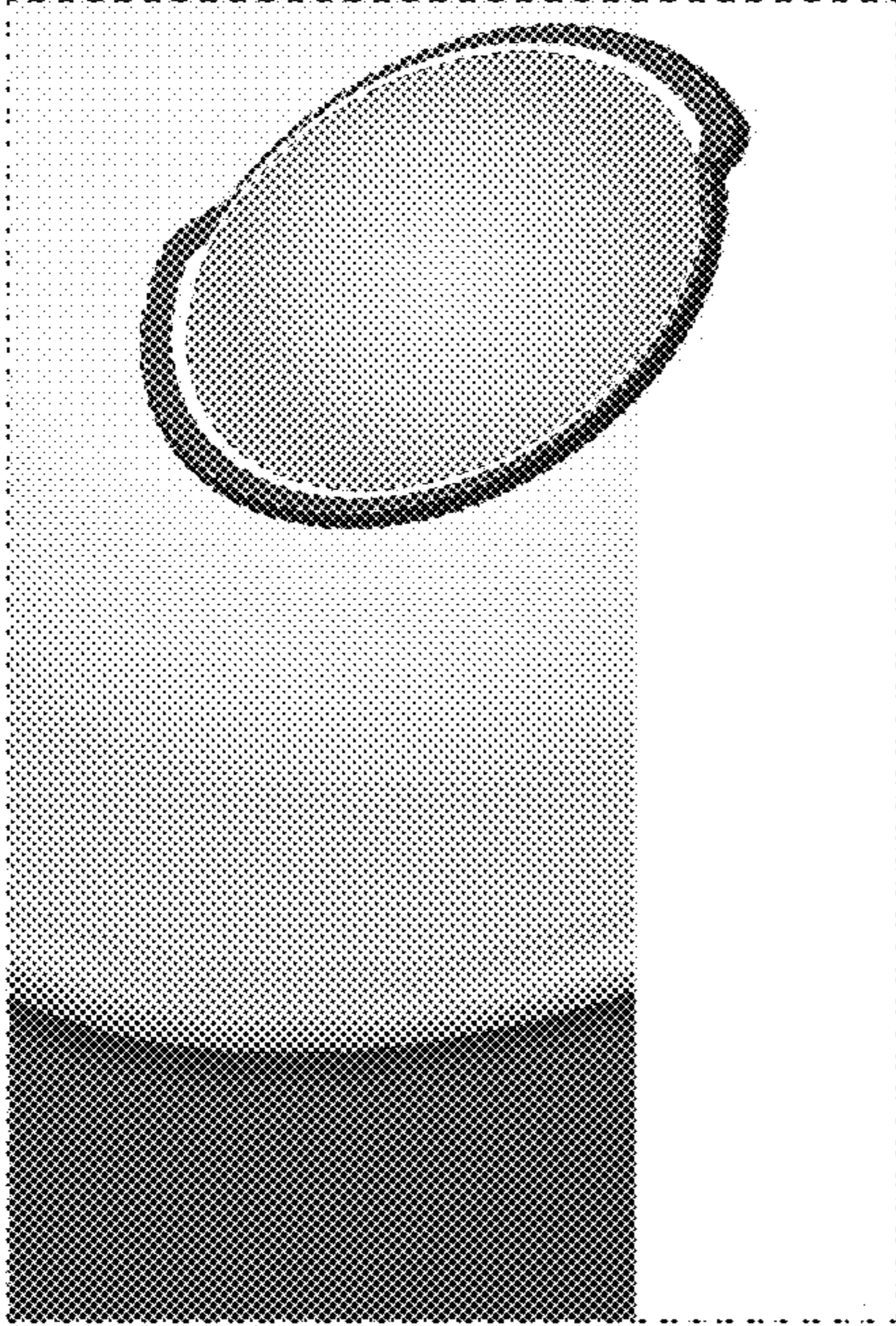

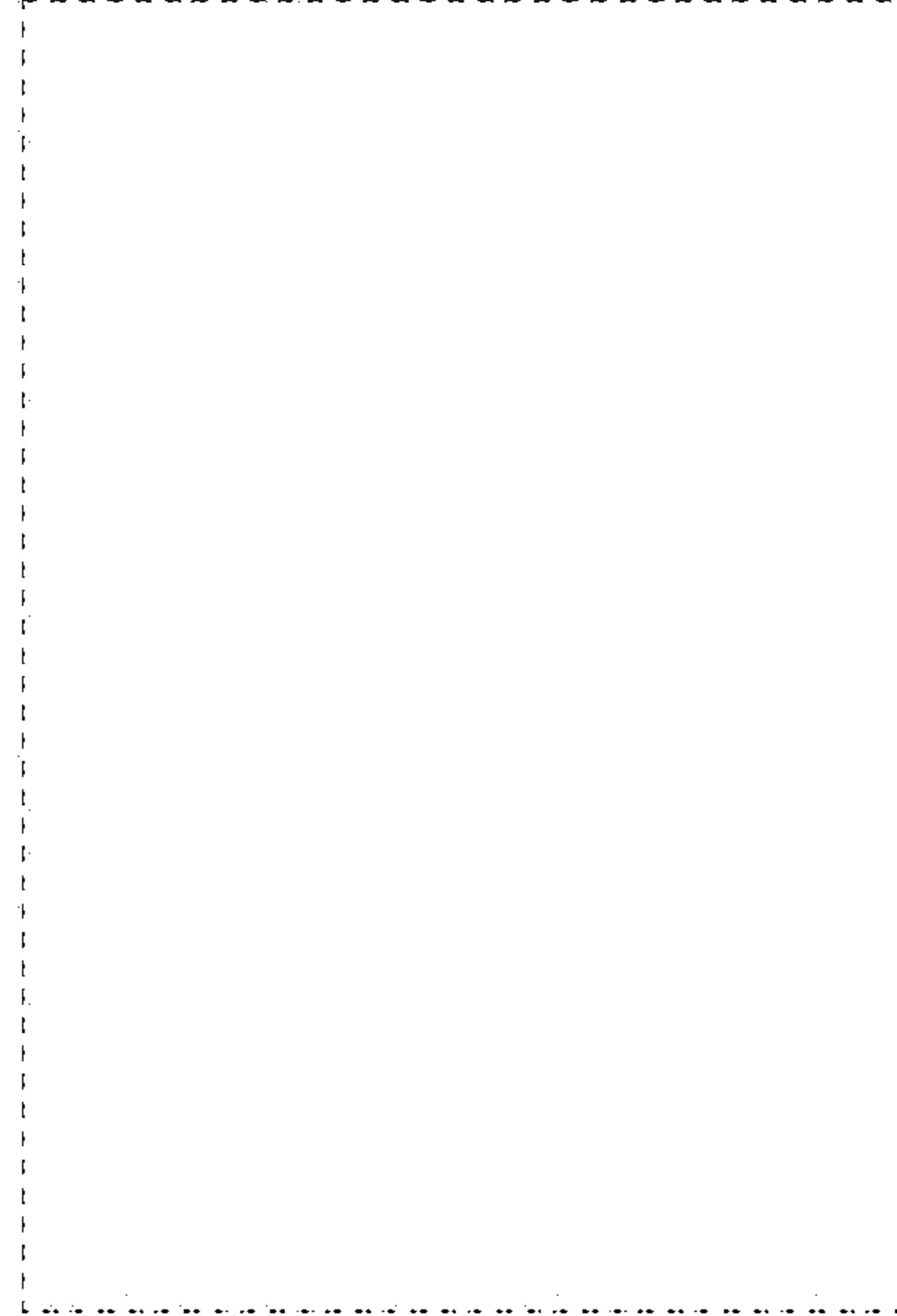

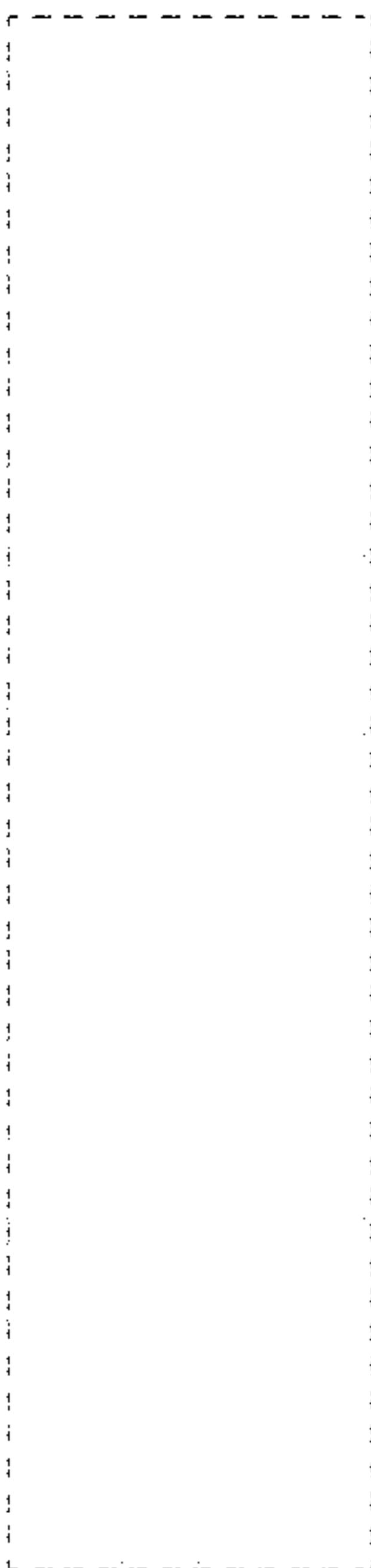

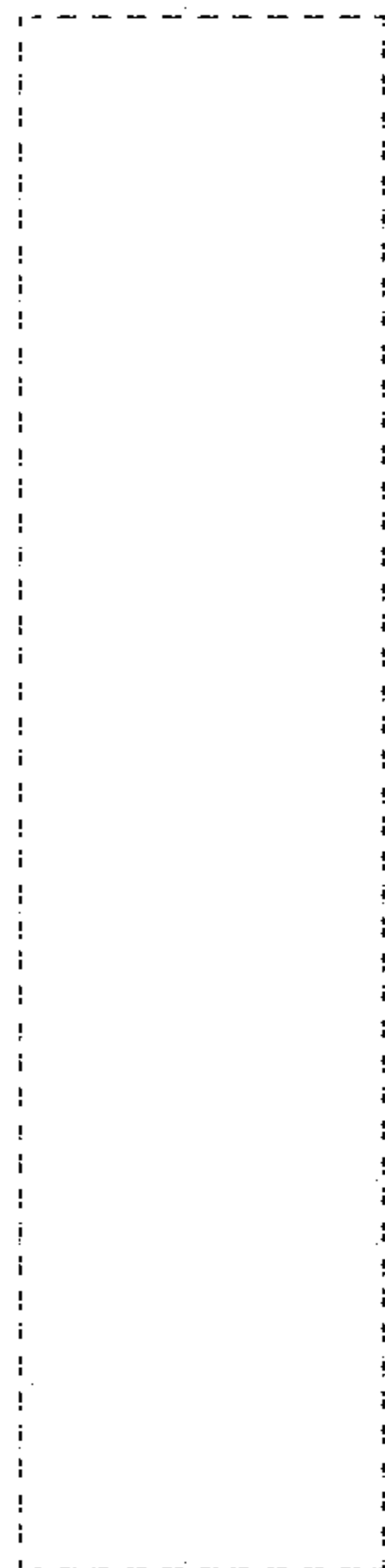

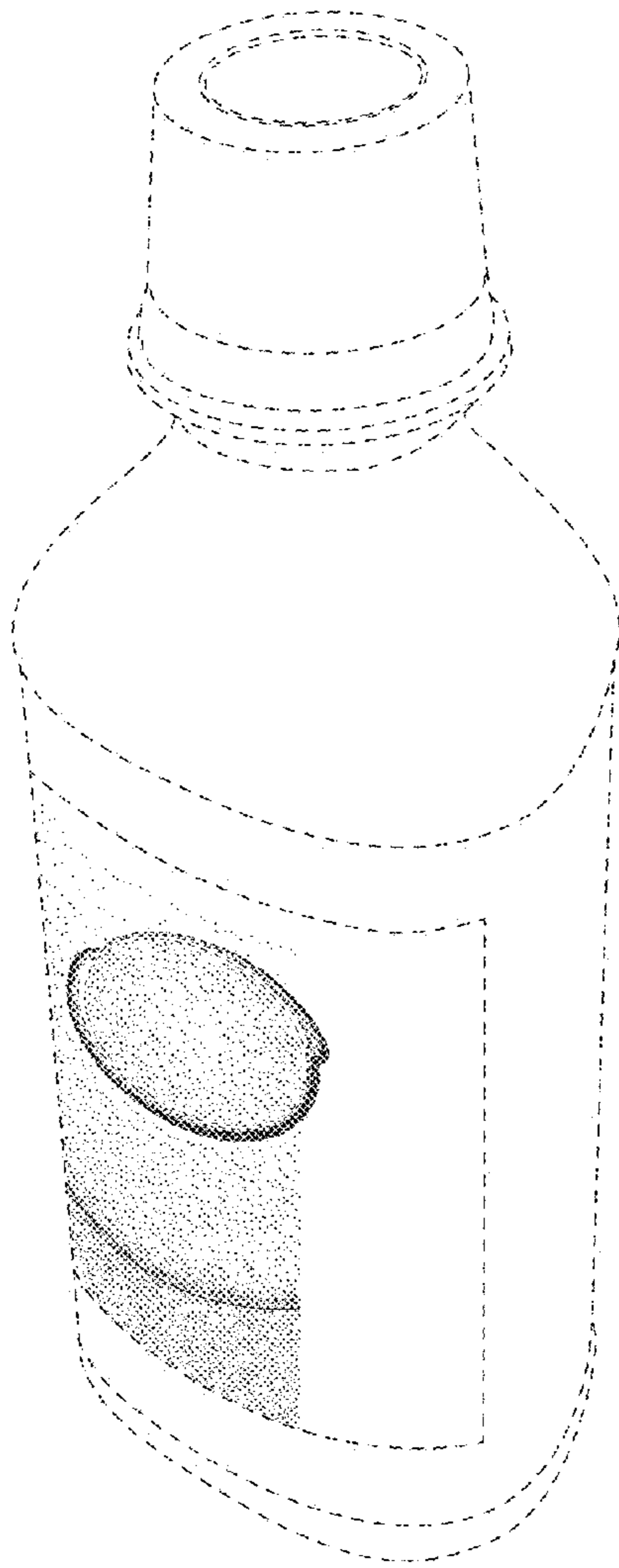

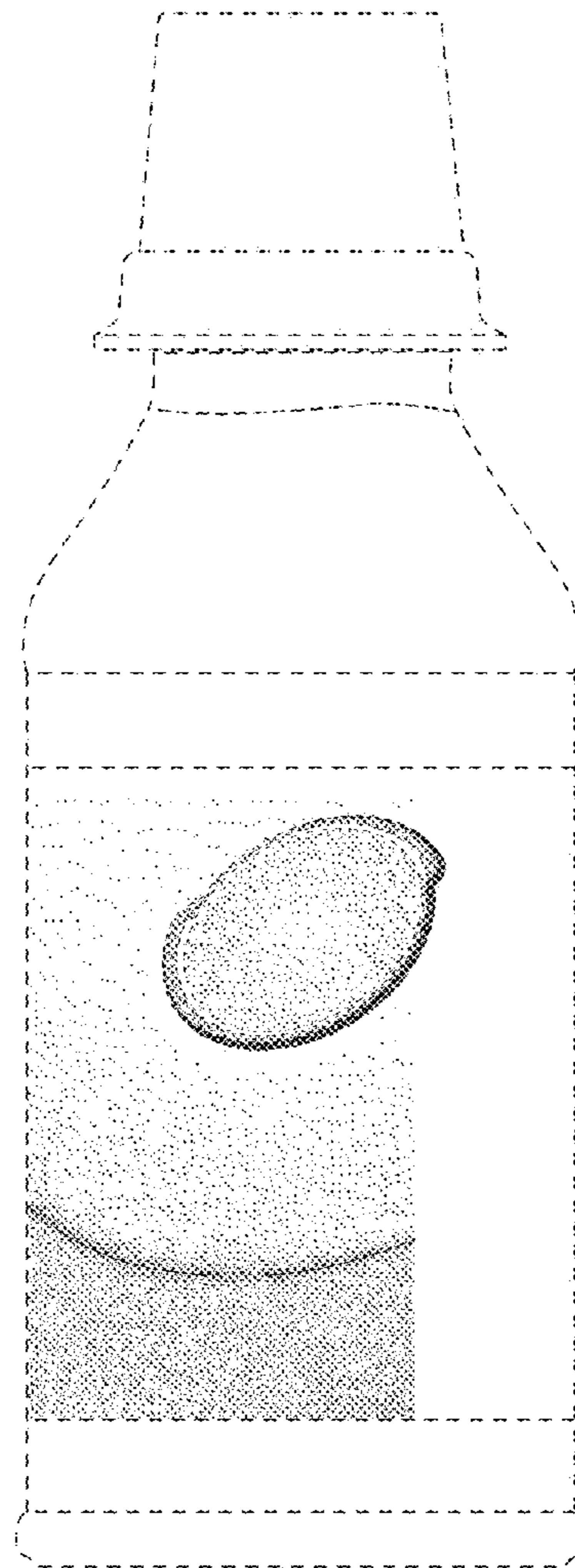

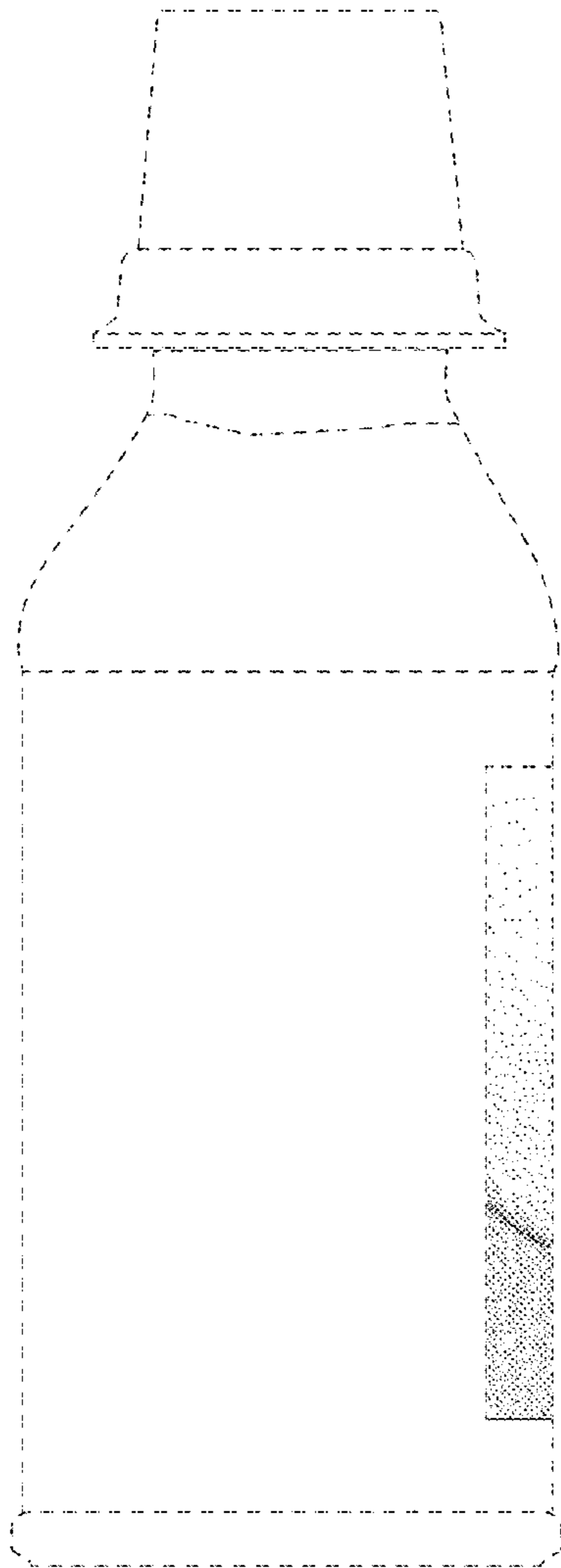

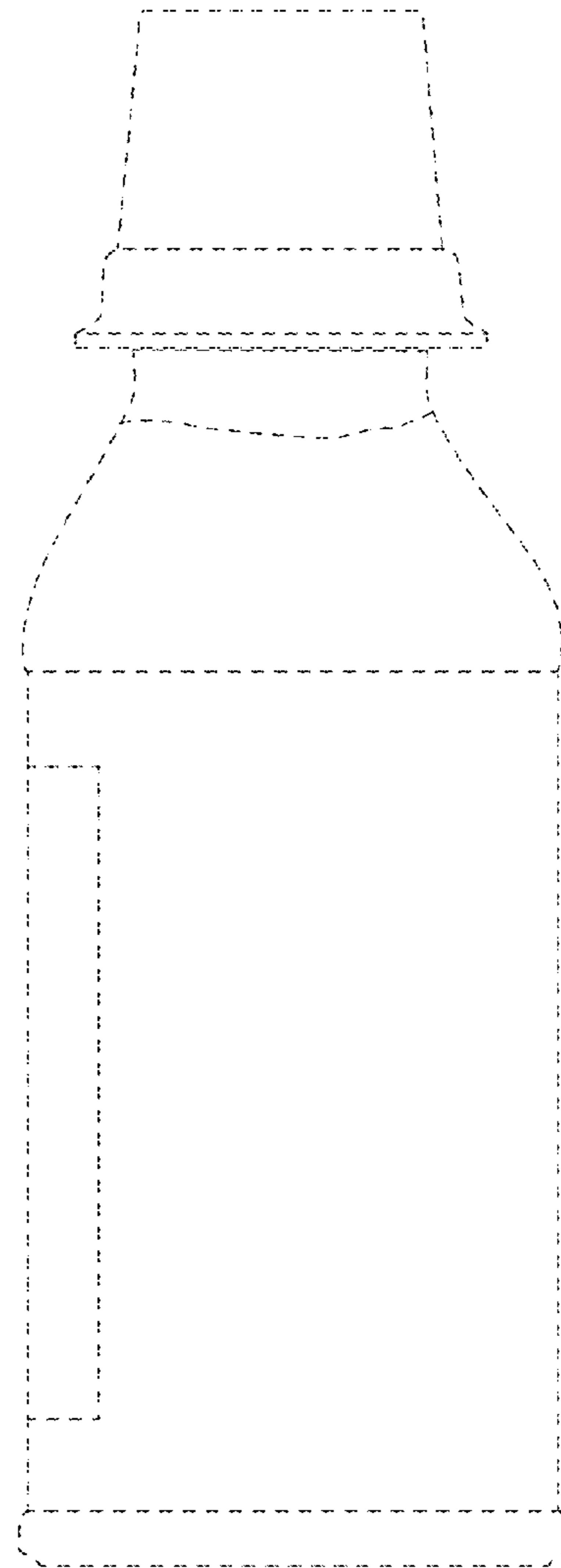

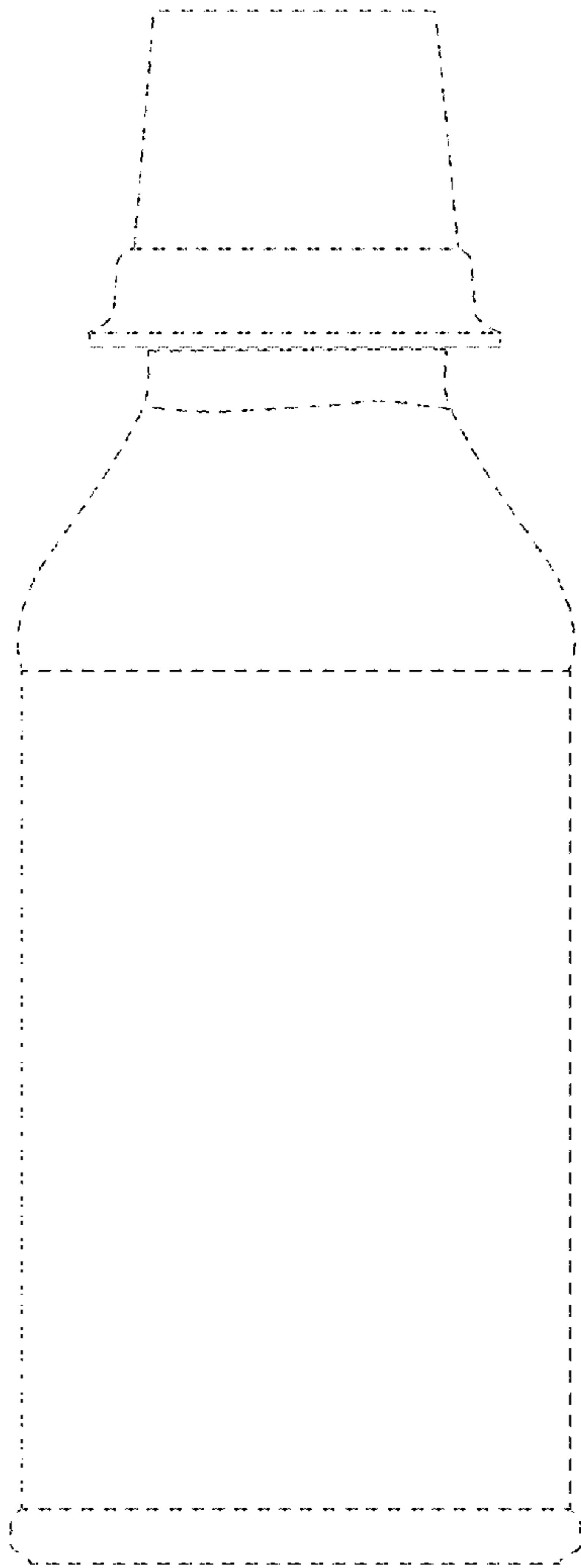

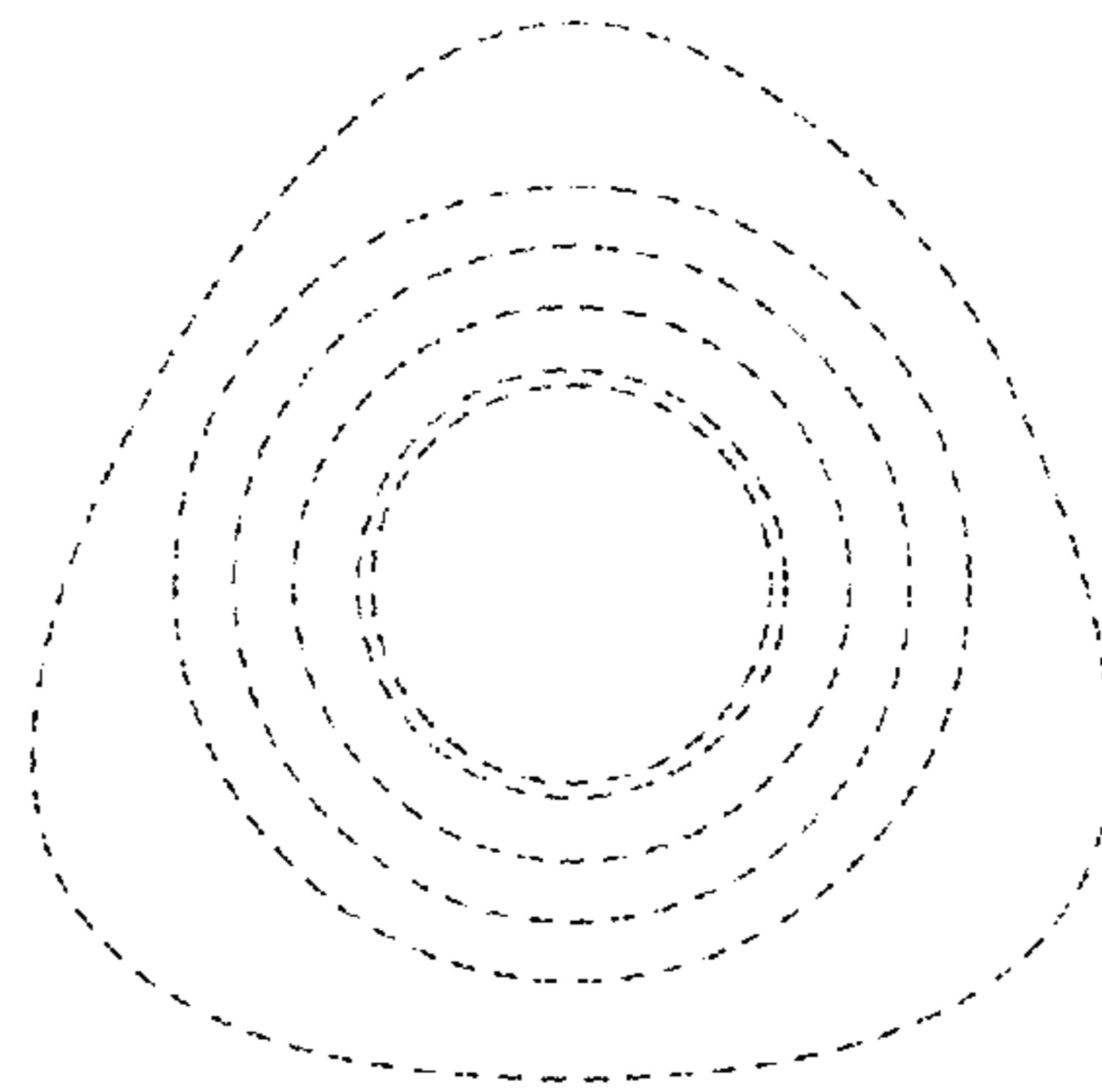

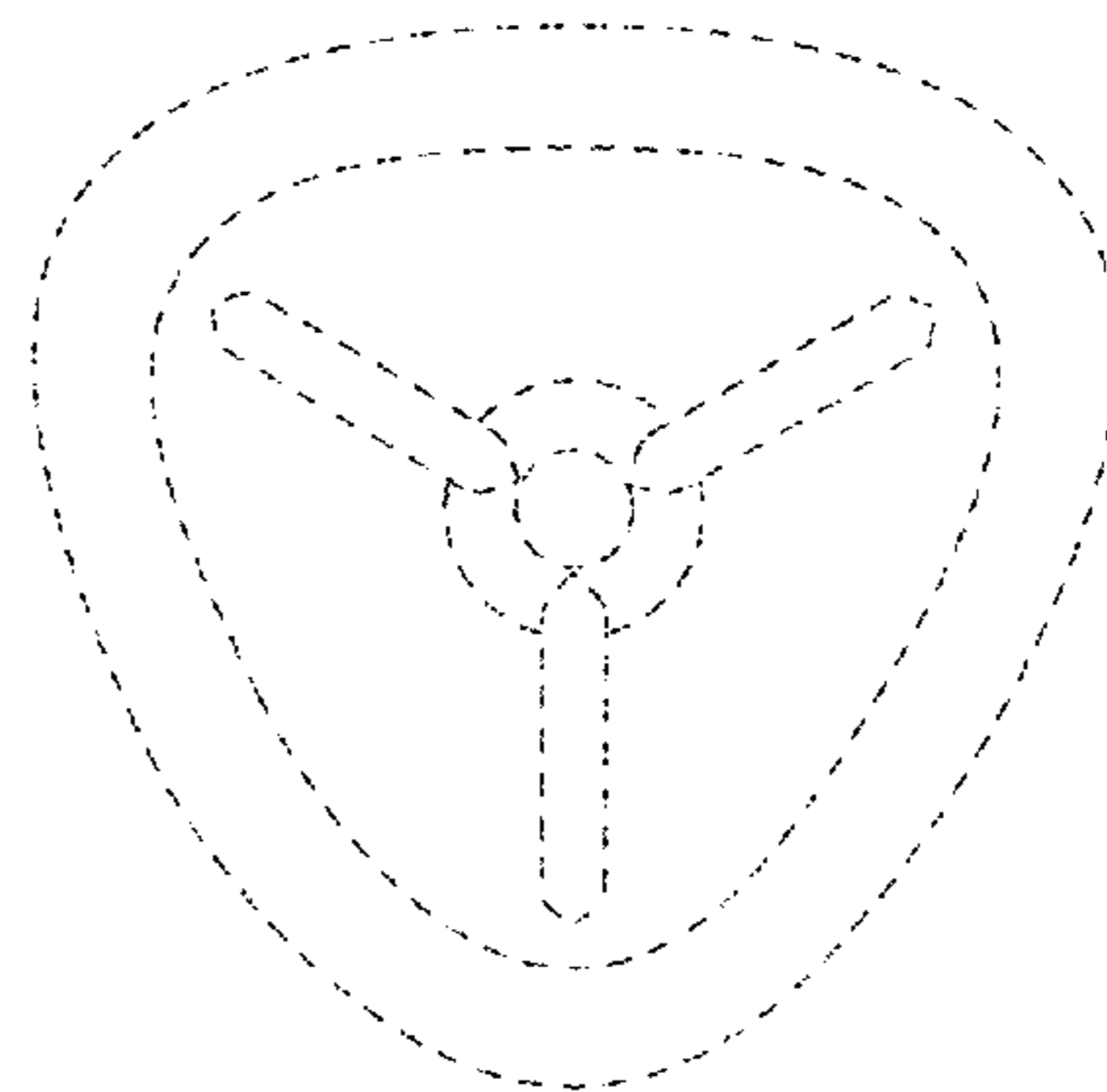

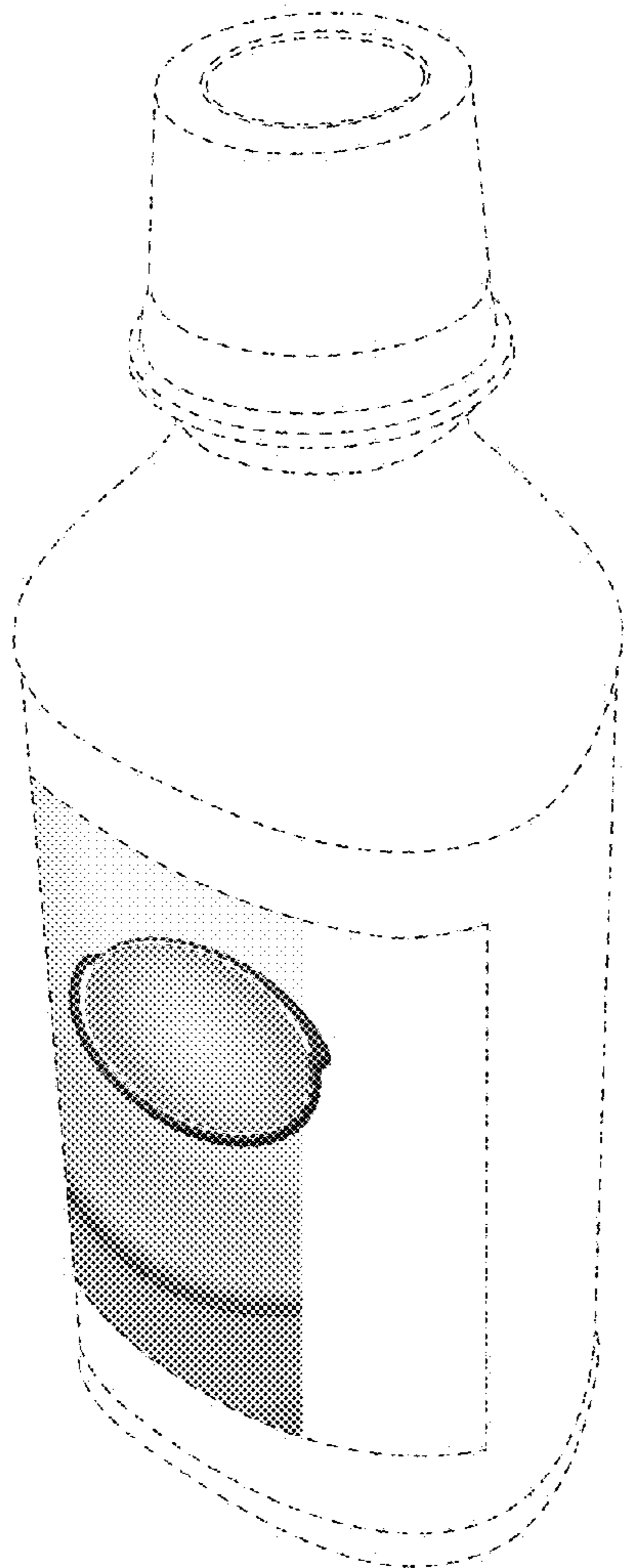

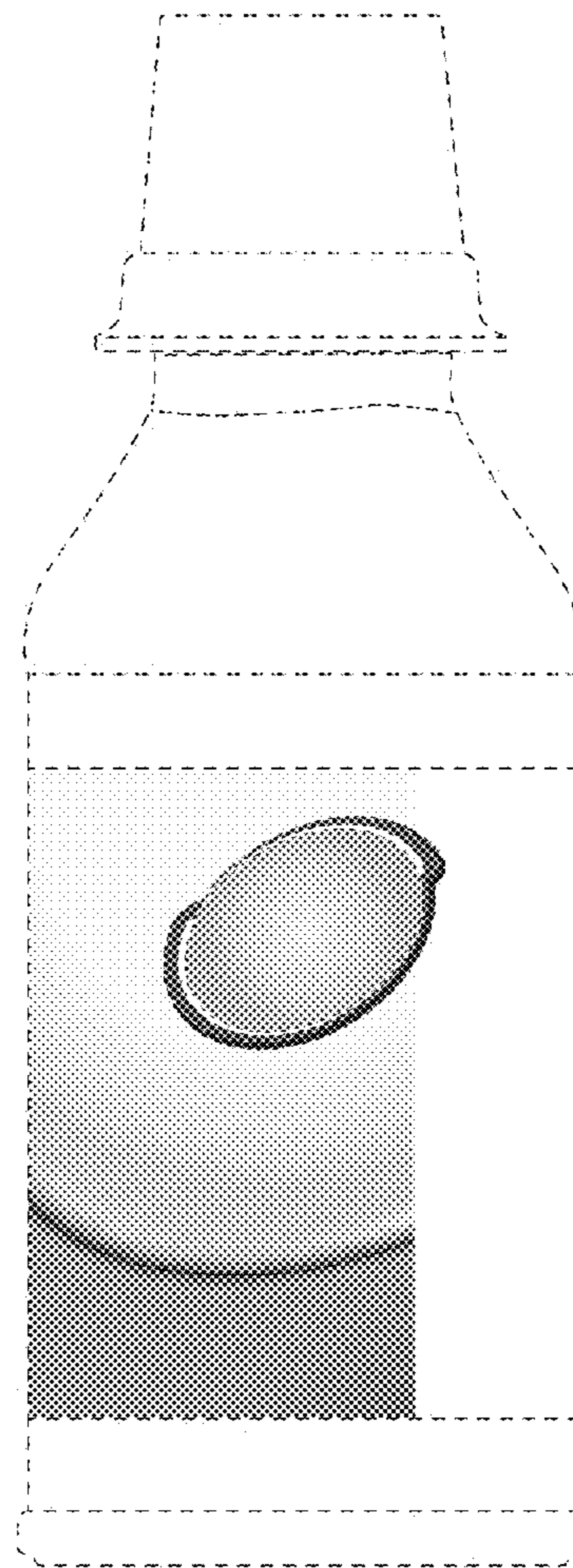

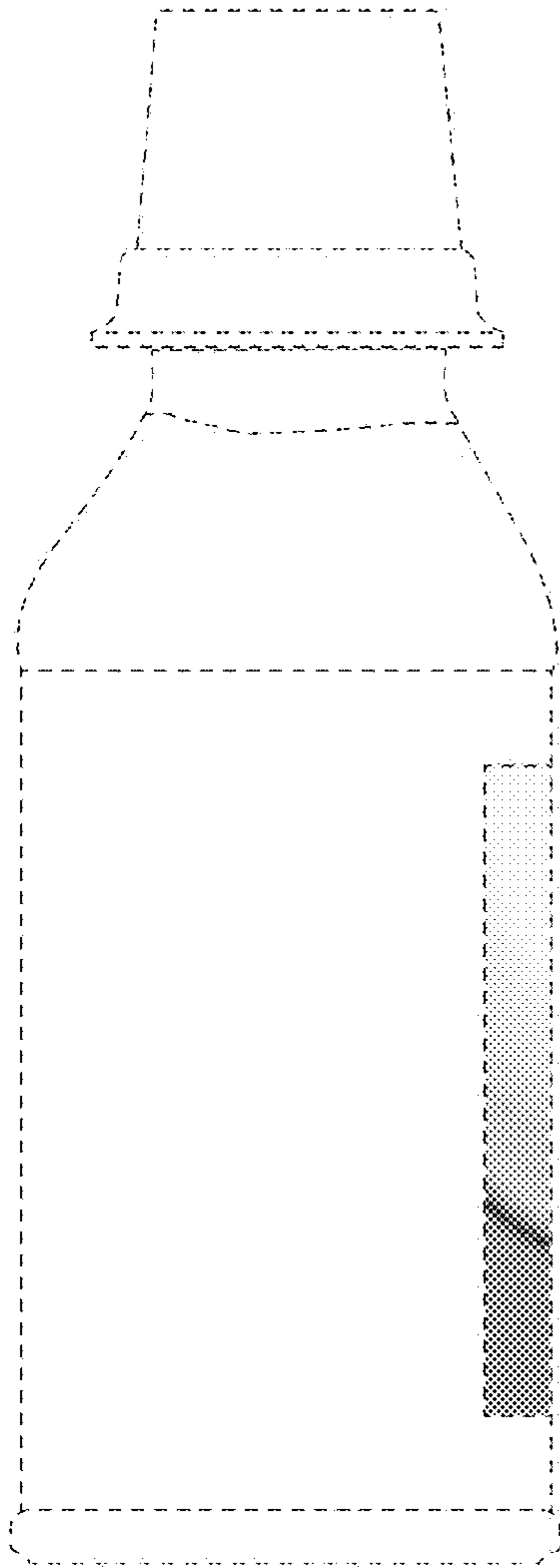

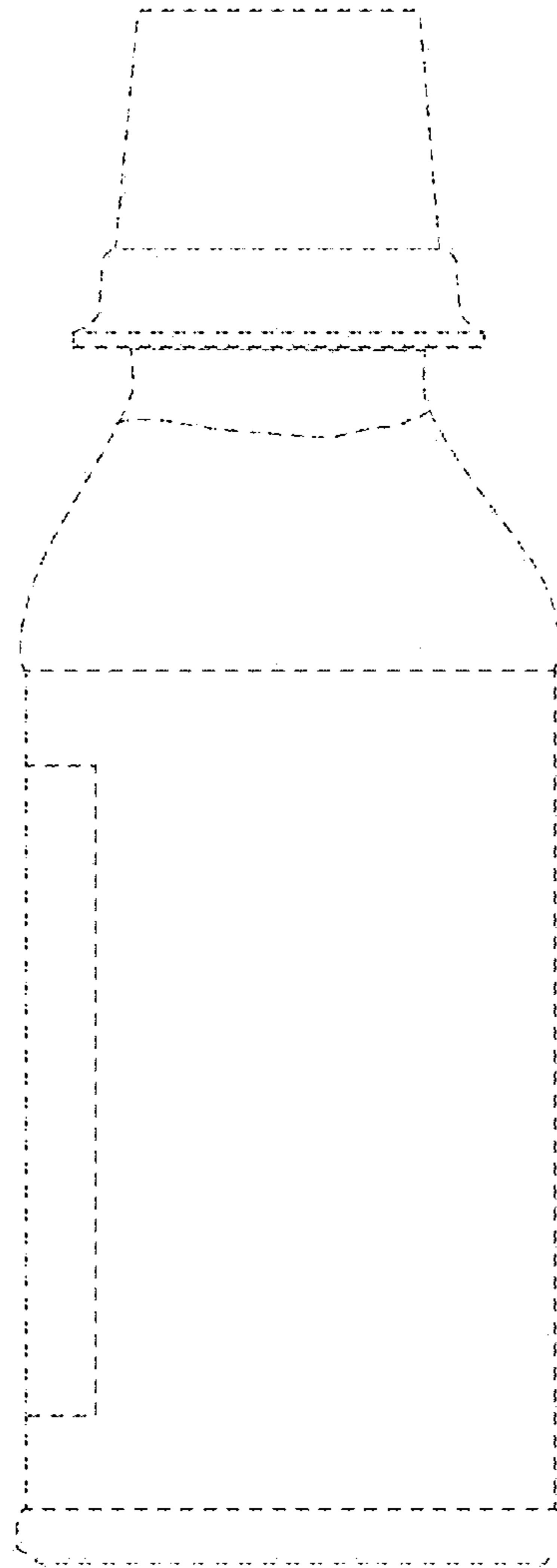

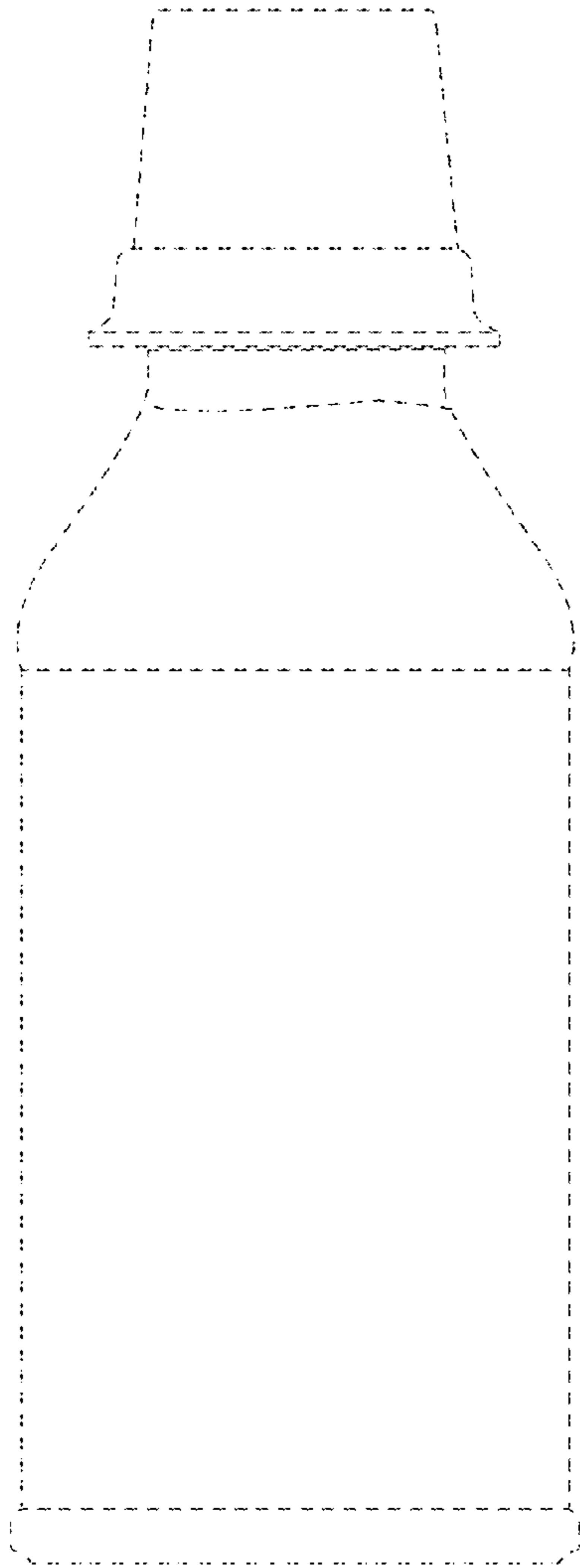

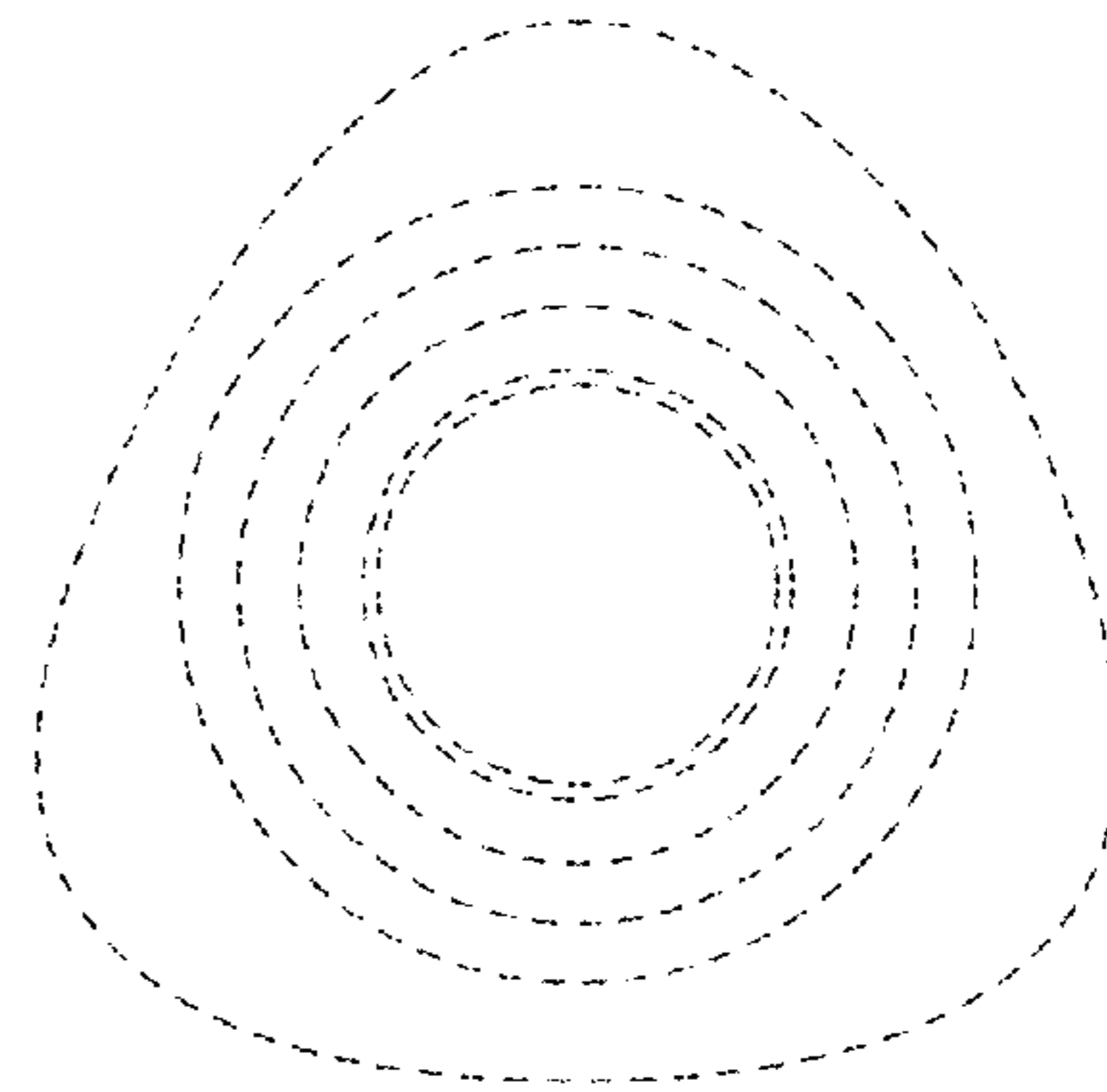

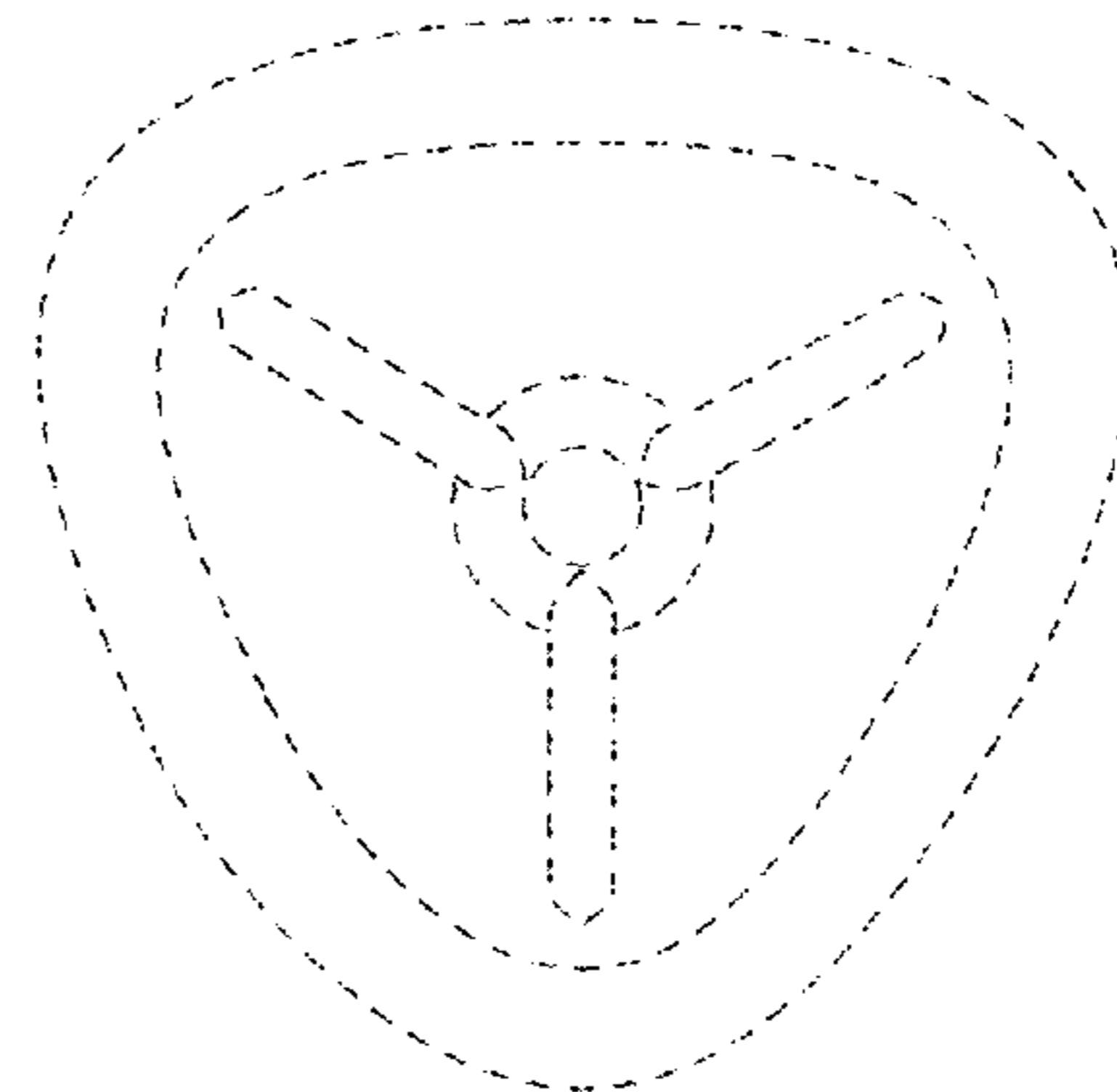
