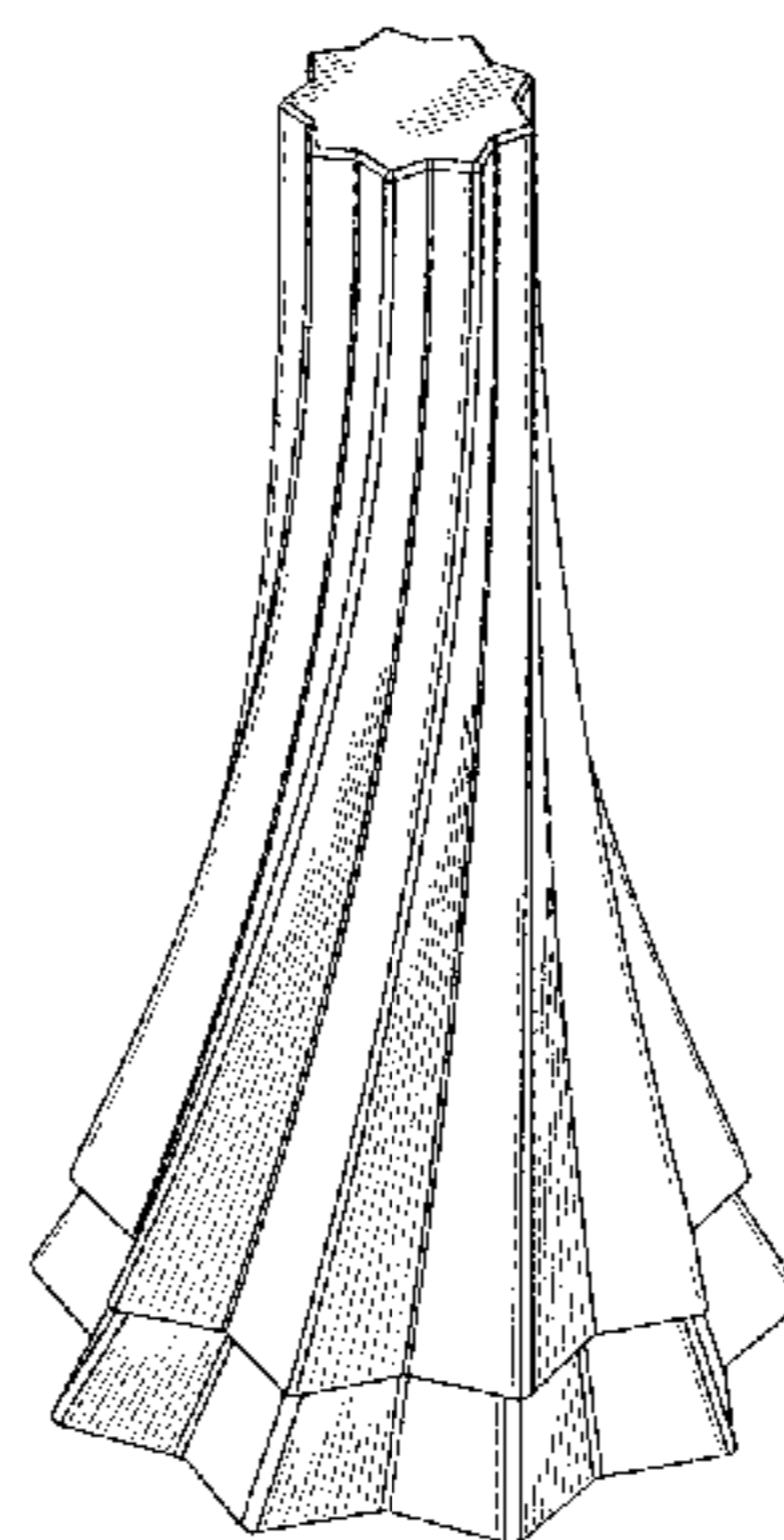
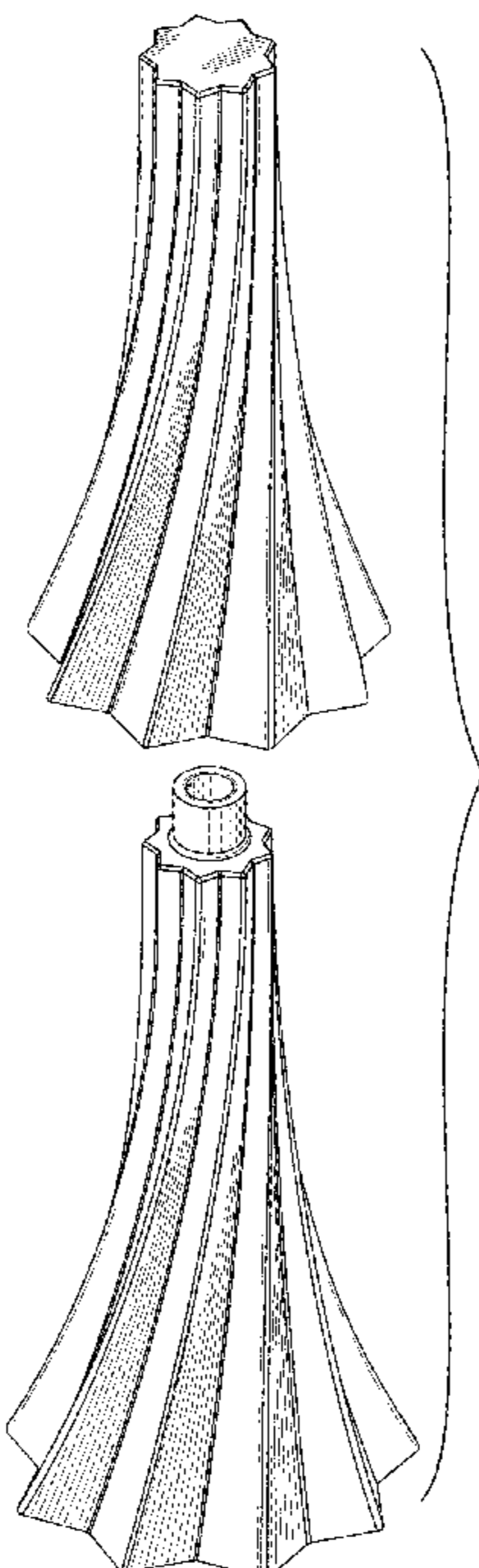
(57) **CLAIM**

The ornamental design for a bottle with cap, as shown and described.

**DESCRIPTION**

FIG. 1 is an exploded perspective view of a bottle with cap, showing my new design;  
FIG. 2 is a perspective view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a right-side elevational view thereof, the left-side elevational view being a mirror image thereof;

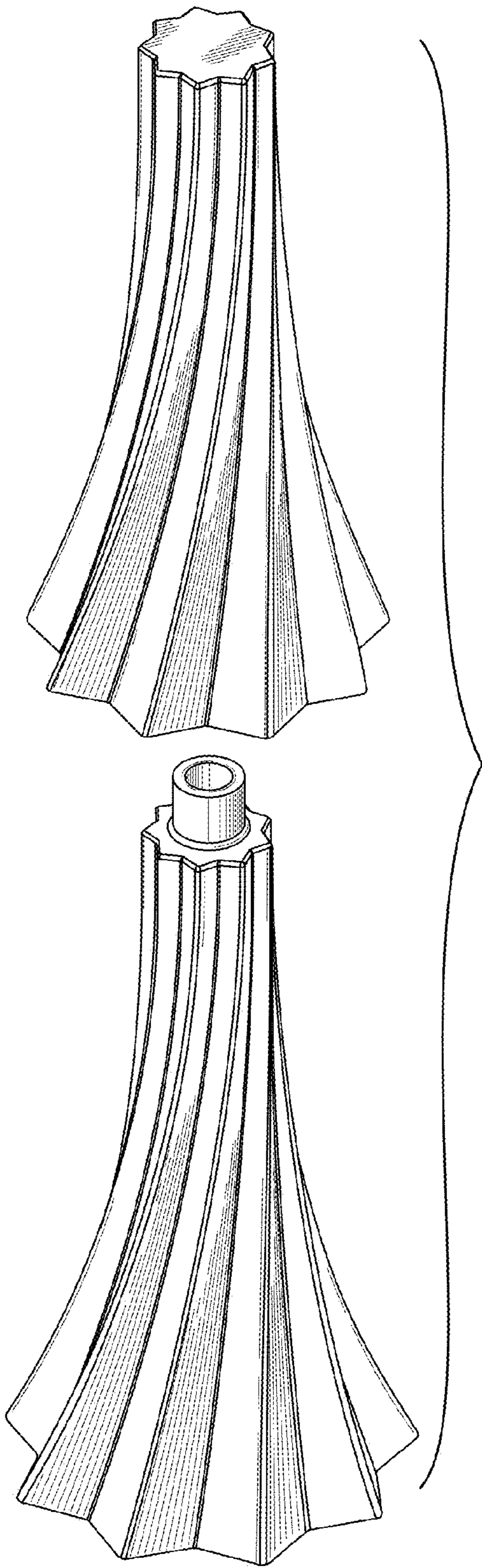

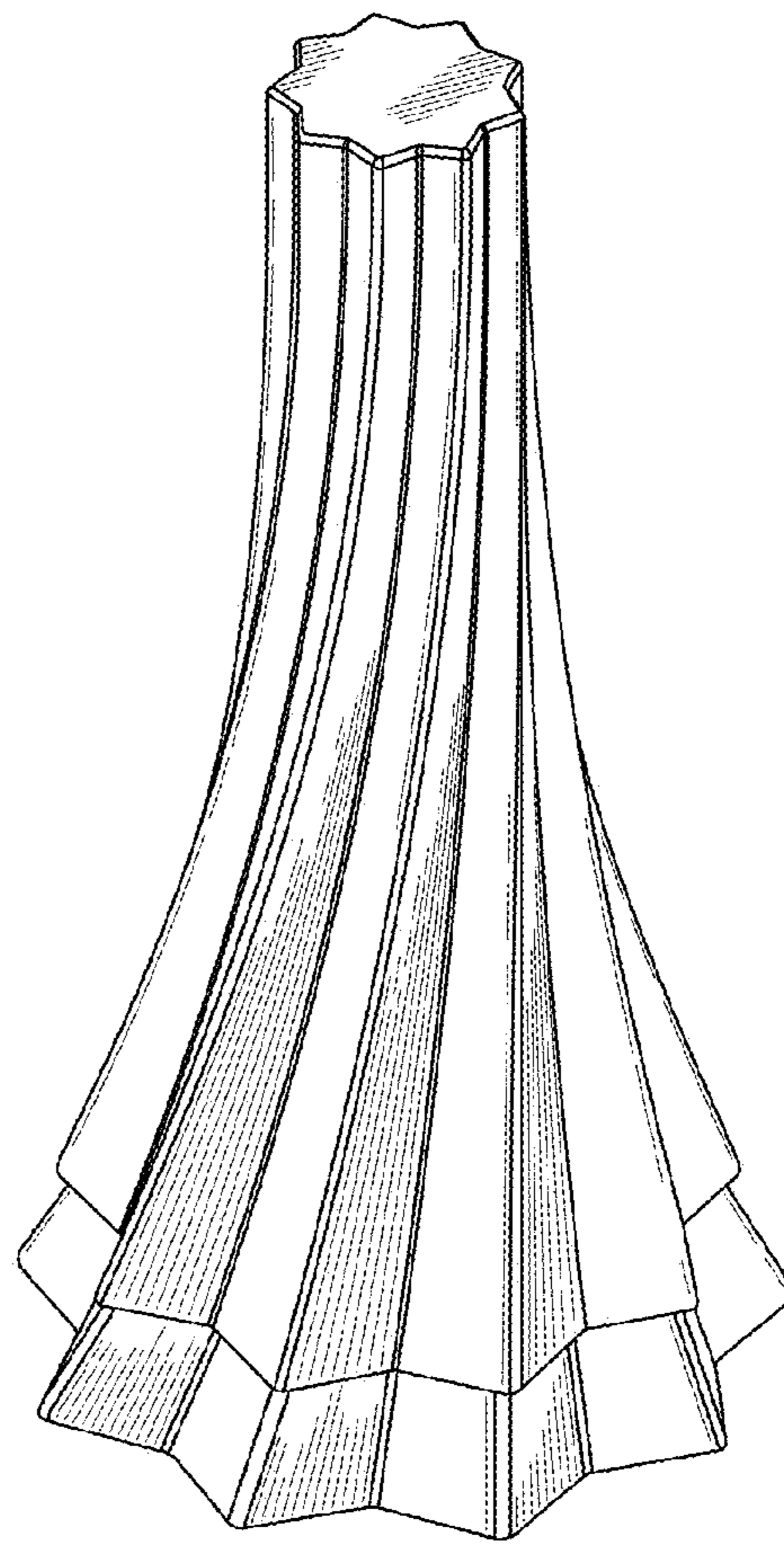

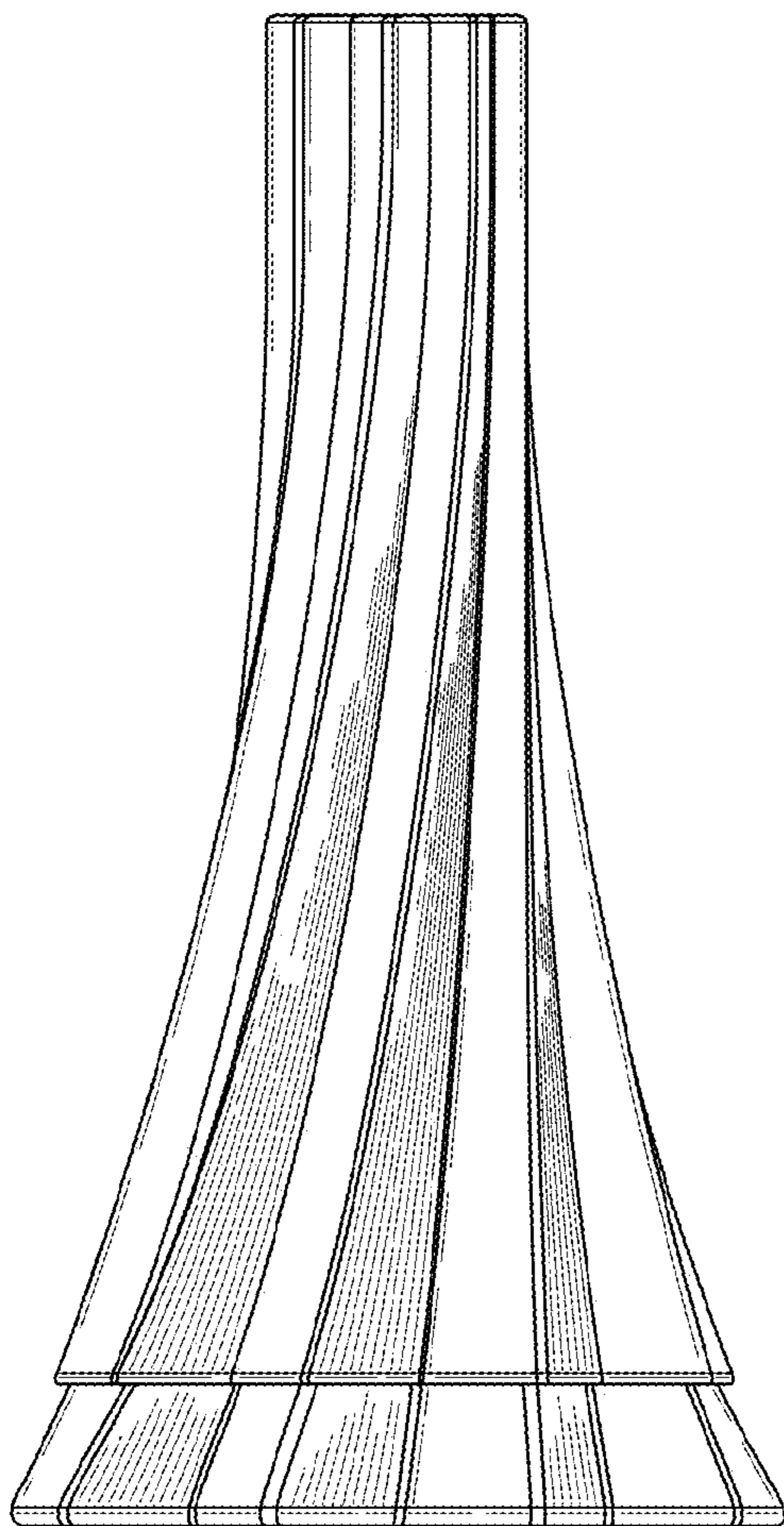

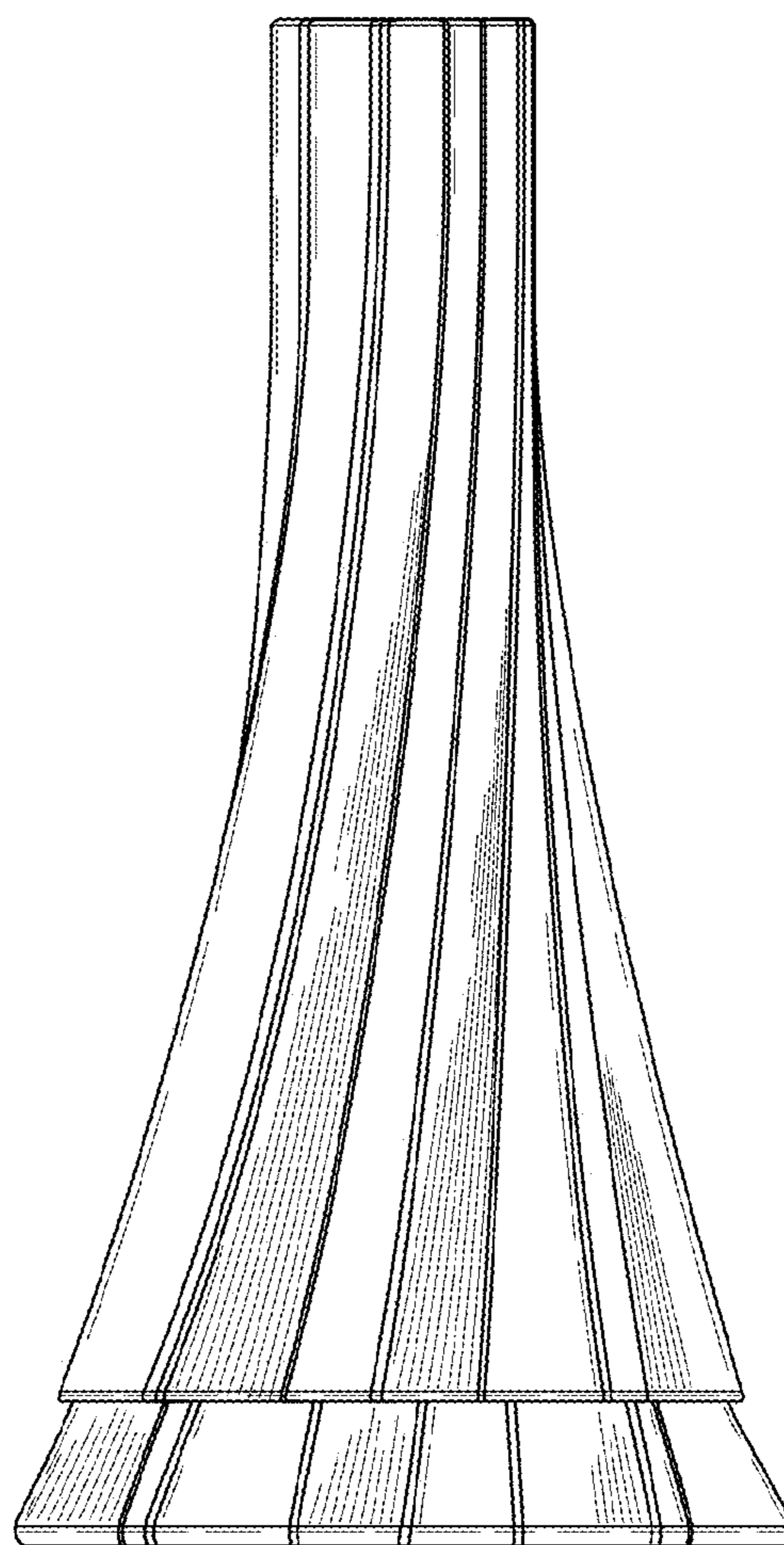

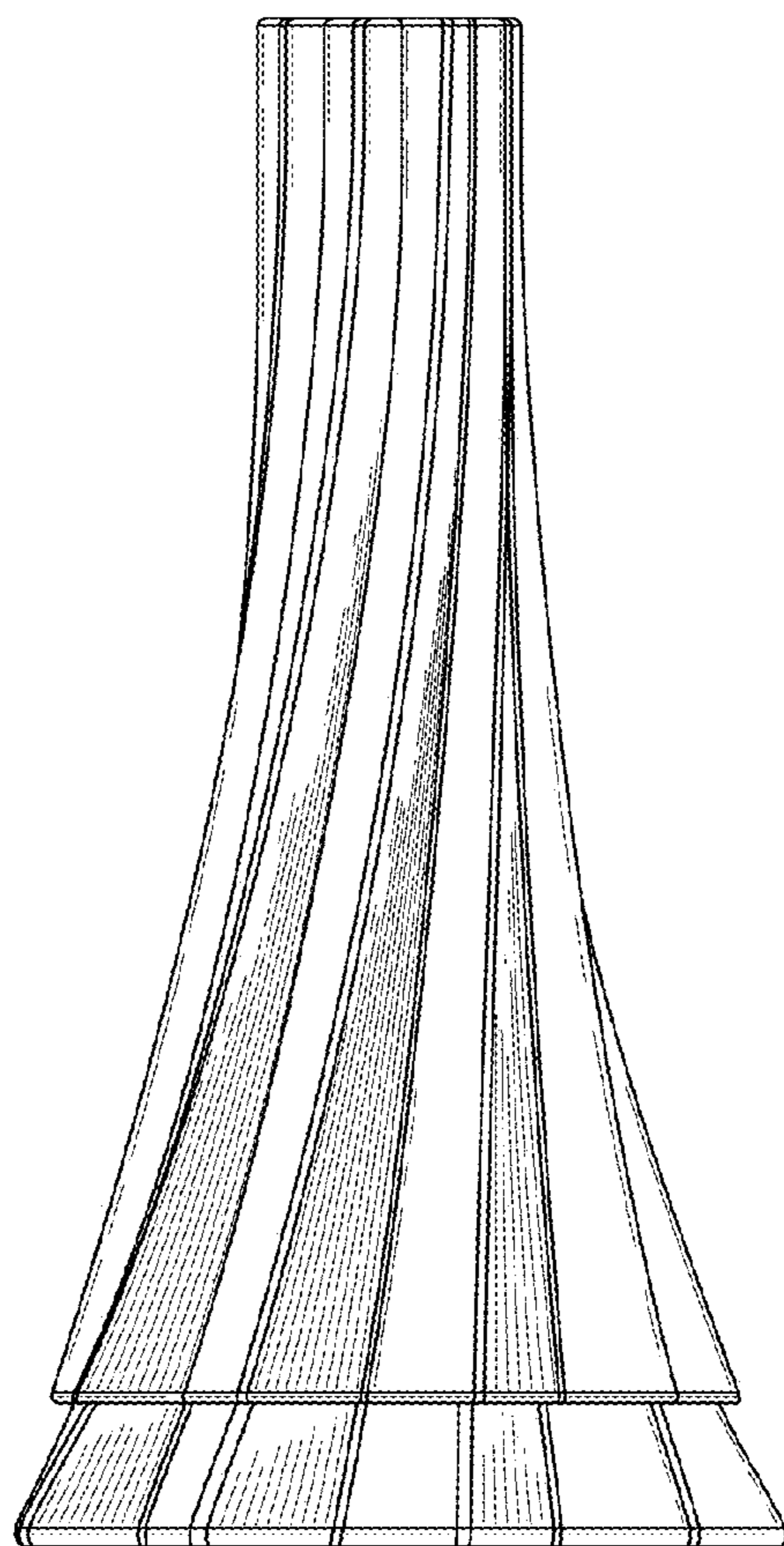

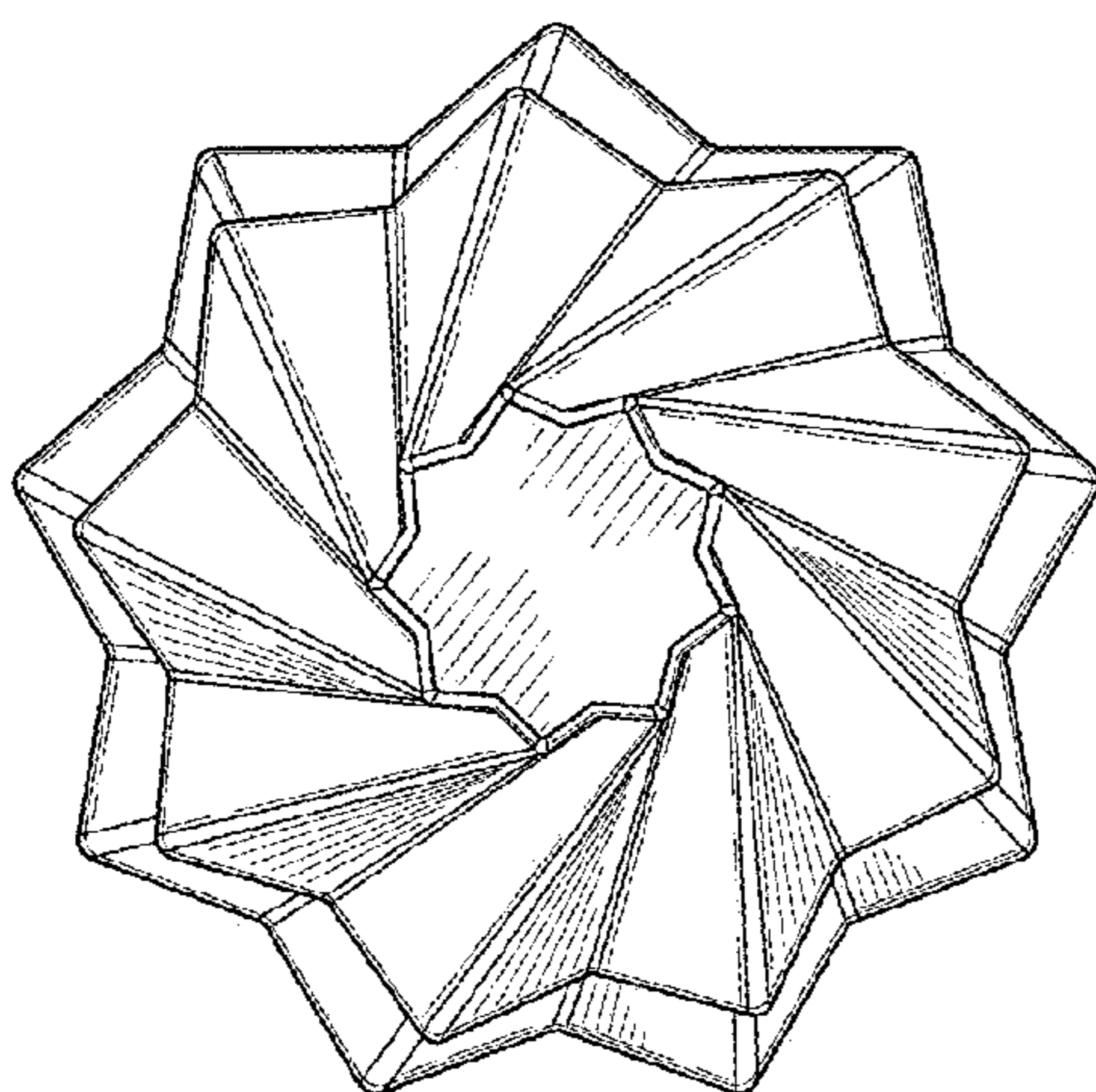

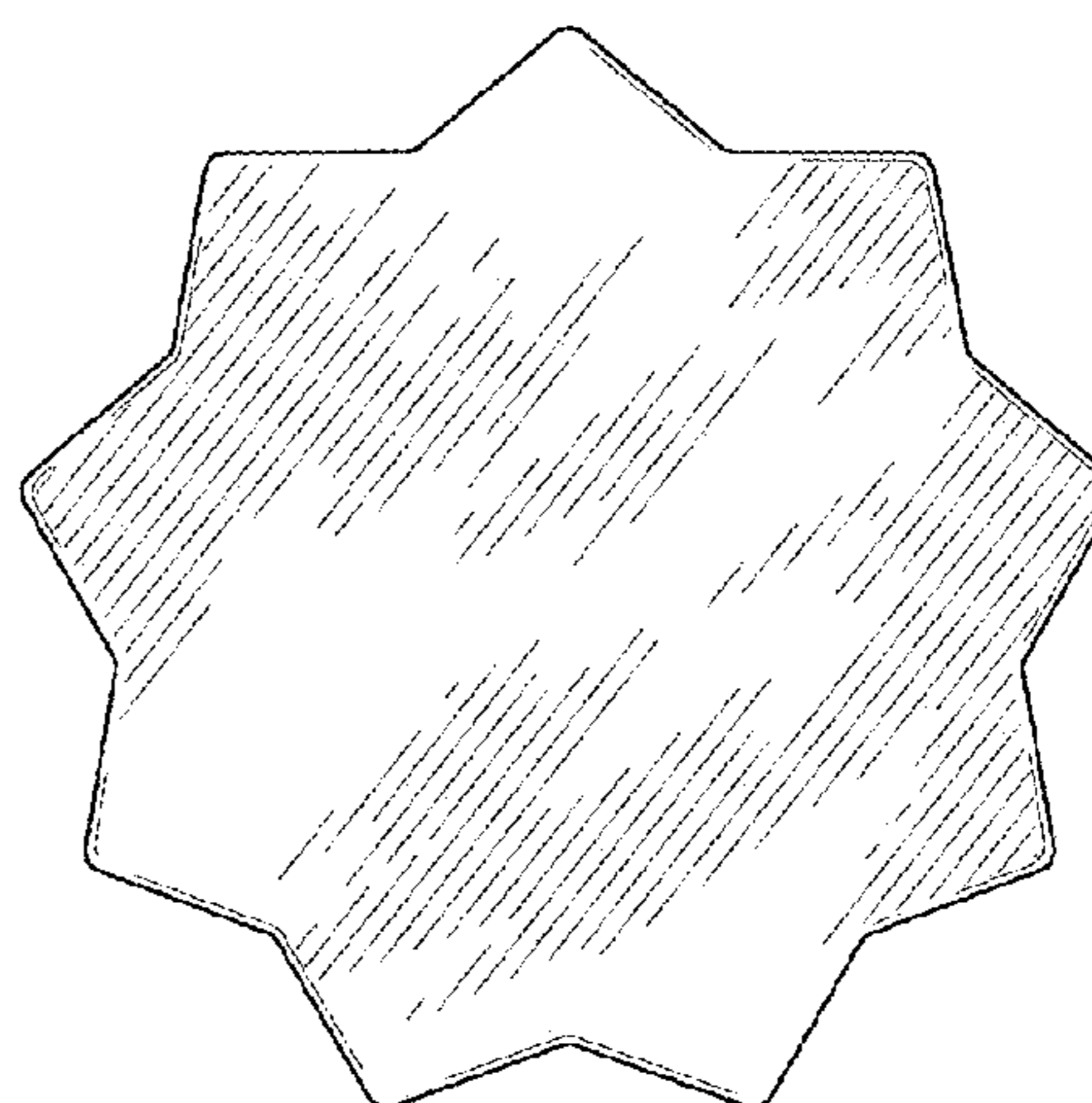
