DESCRIPTION

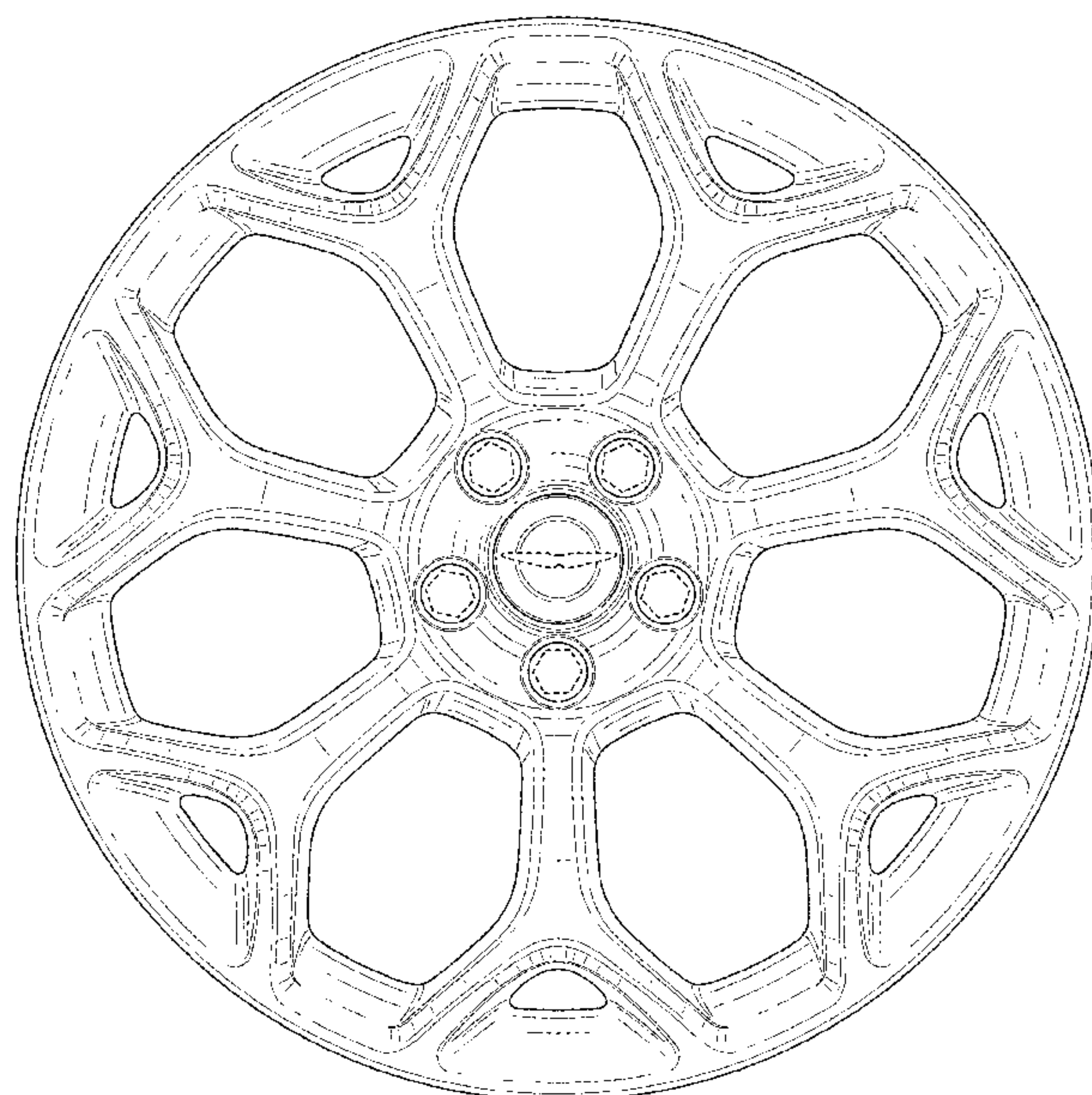
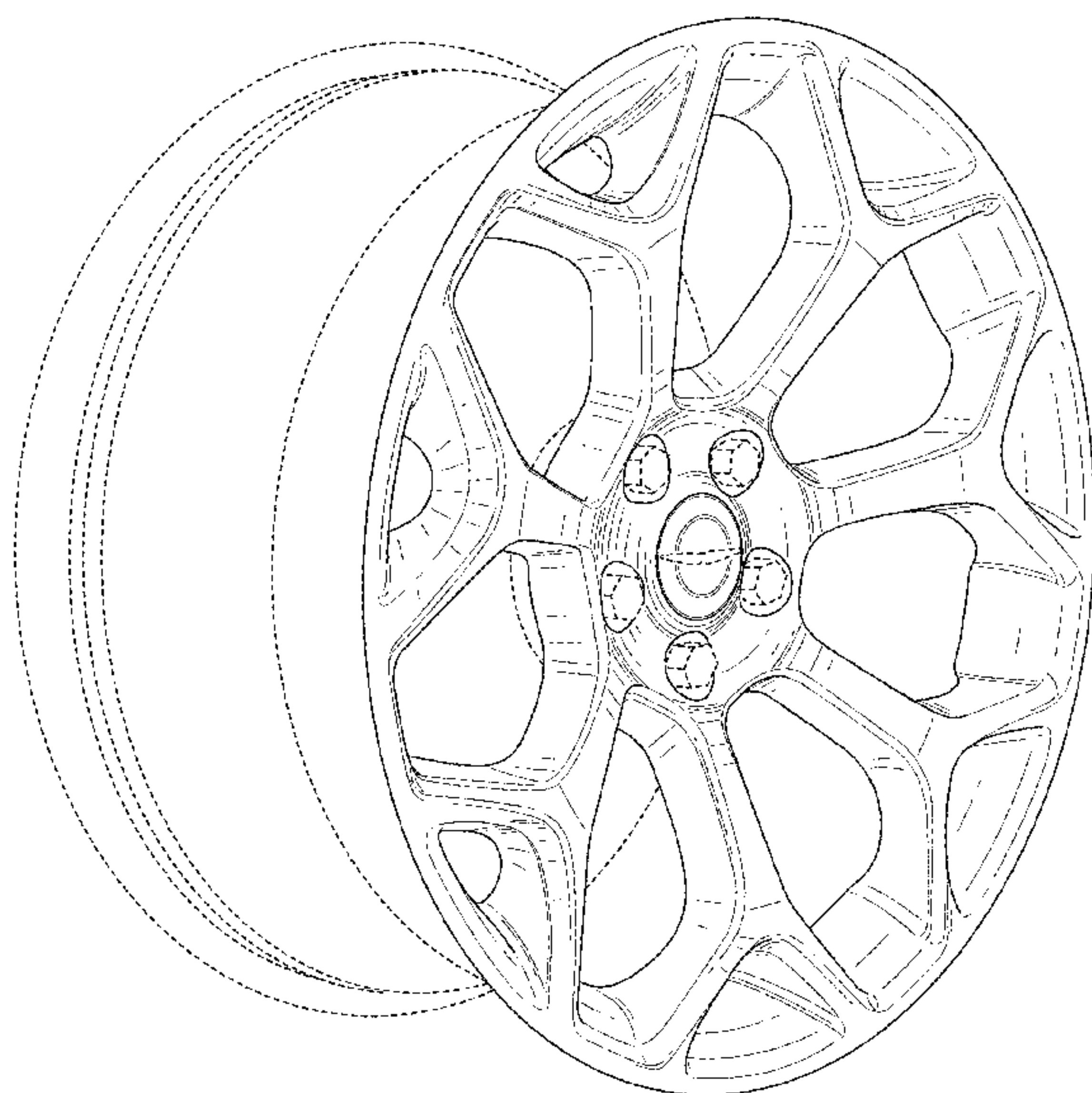
FIG. 1 is a left side perspective view of an automobile wheel showing the new design;

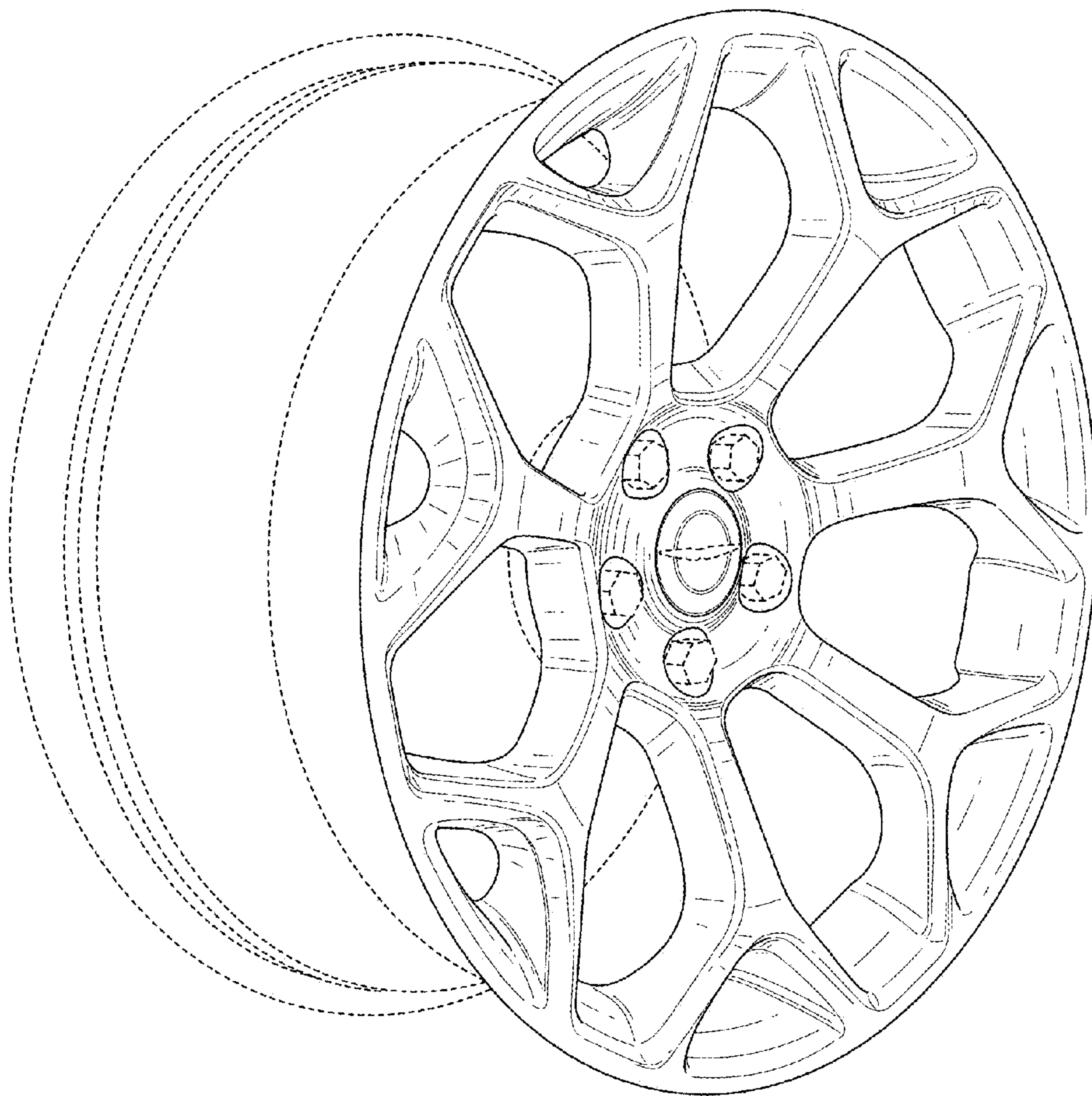

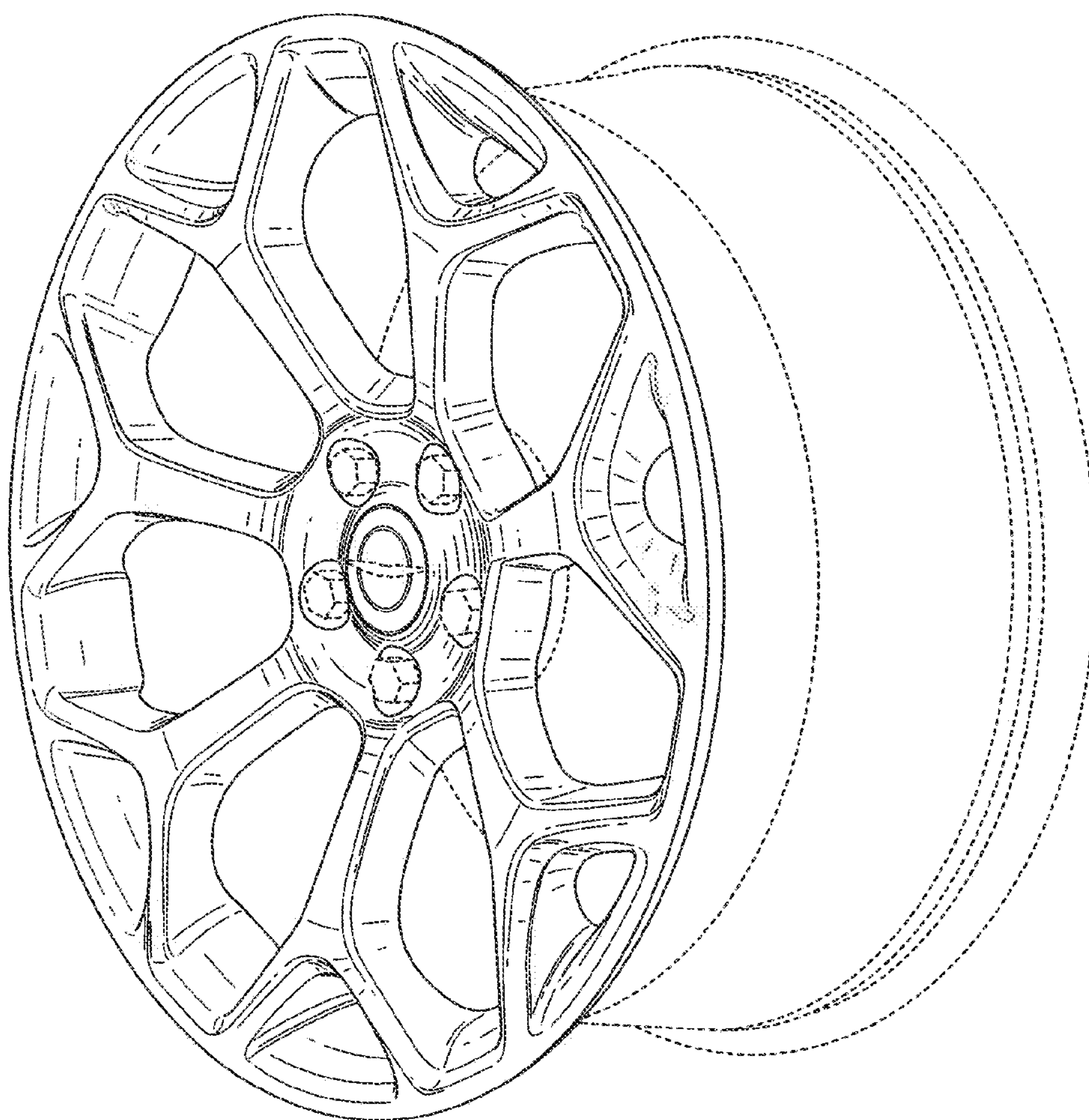

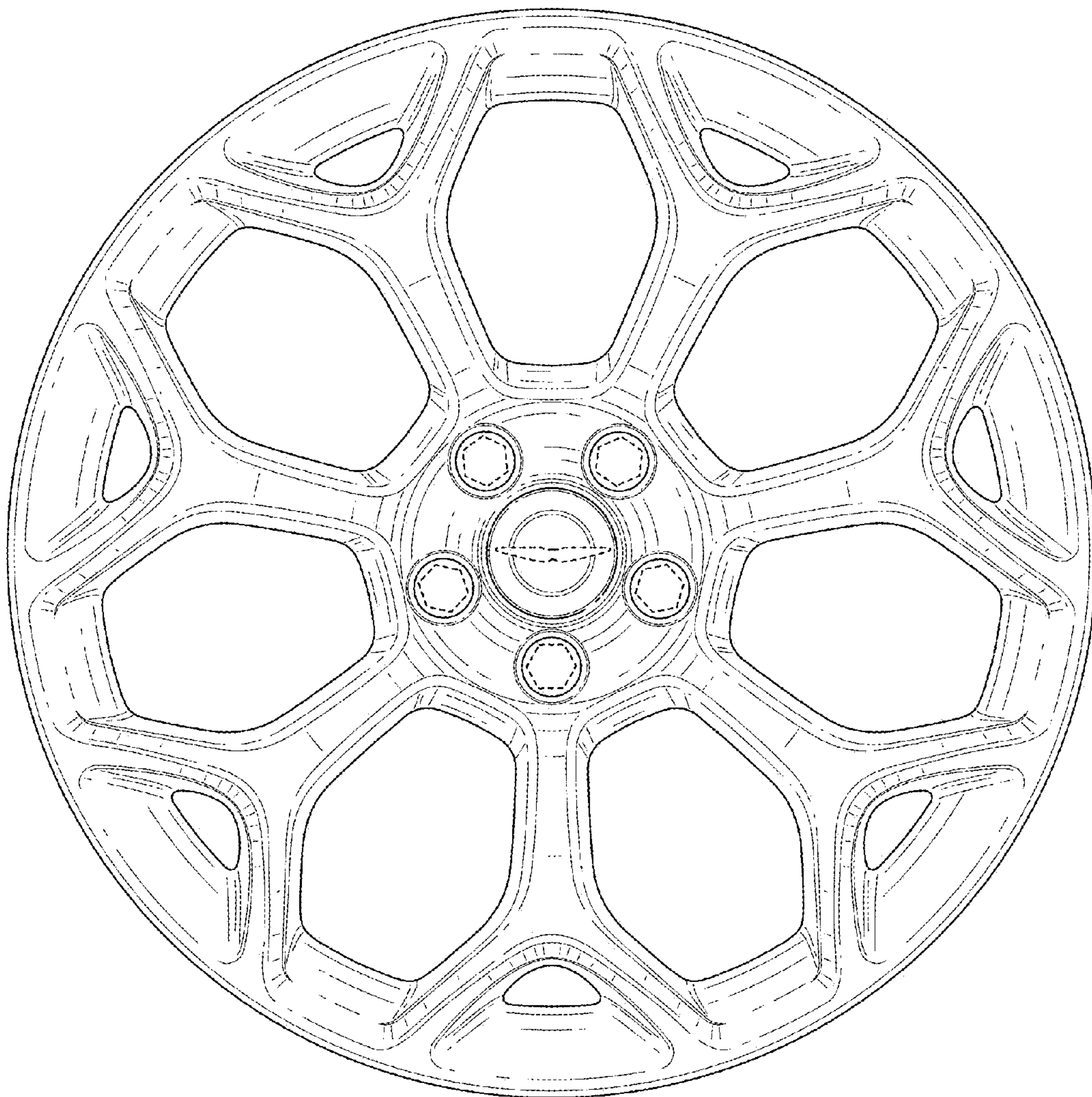
