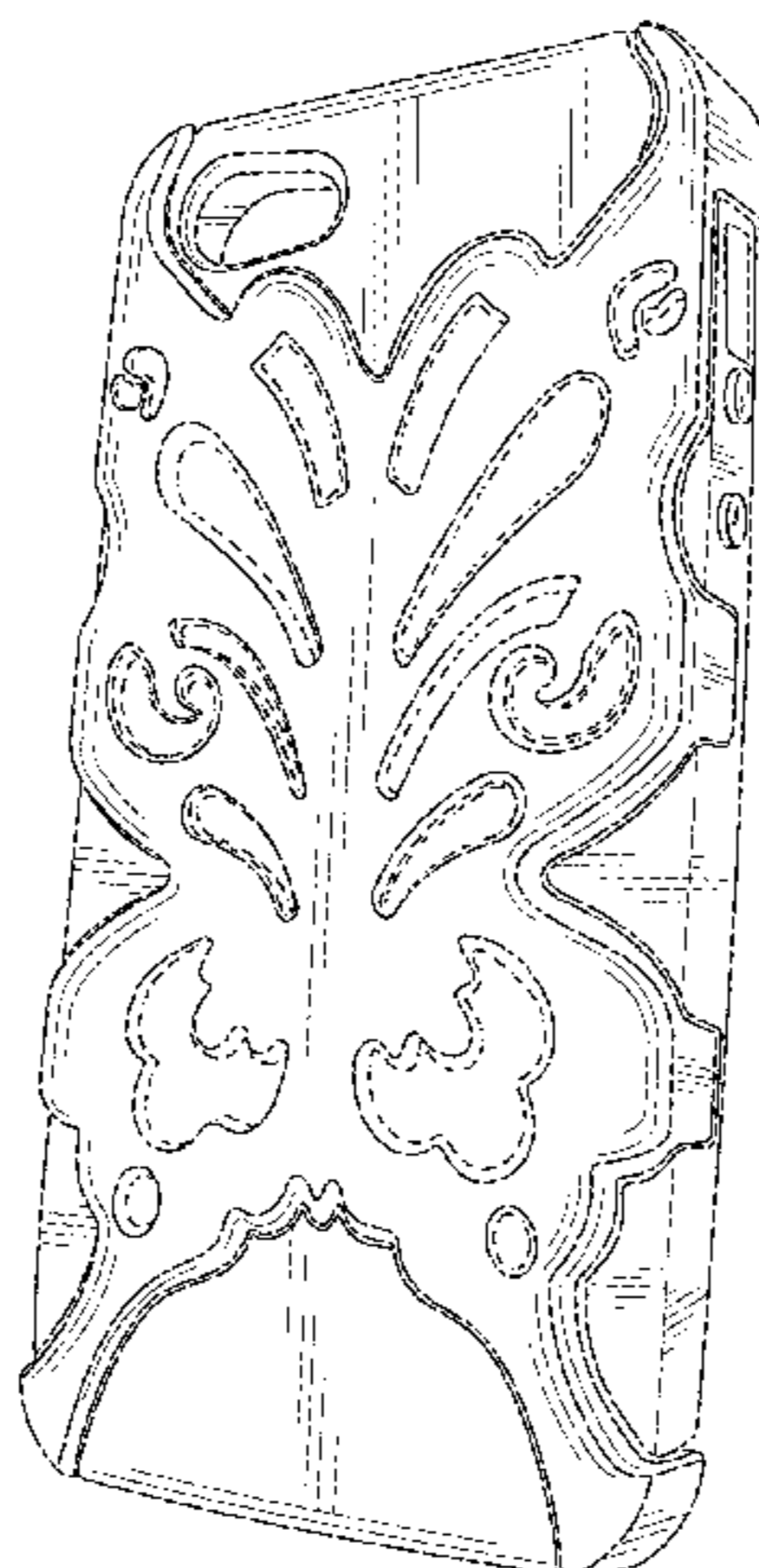
(57) **CLAIM**

The ornamental design for a cell phone protector case with butterfly design, as shown and described.

**DESCRIPTION**

FIG. 1 is a front side perspective view of a cell phone protector case with butterfly design, showing my new design;  
 FIG. 2 is a rear side perspective view thereof;  
 FIG. 3 is front elevational view thereof;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is a left side elevational view thereof;  
 FIG. 6 is a right side elevational view thereof;  
 FIG. 7 is a top plan view thereof;  
 FIG. 8 is a bottom plan view thereof;  
 FIG. 9 is another front elevational view with the butterfly design attachment separated from the cell phone protector case; and,  
 FIG. 10 is another rear elevational view with the butterfly design attachment separated from the cell phone protector case.  
 The broken lines in the drawings illustrate portions of the cell phone protector case with butterfly design which form no part of the claimed design.

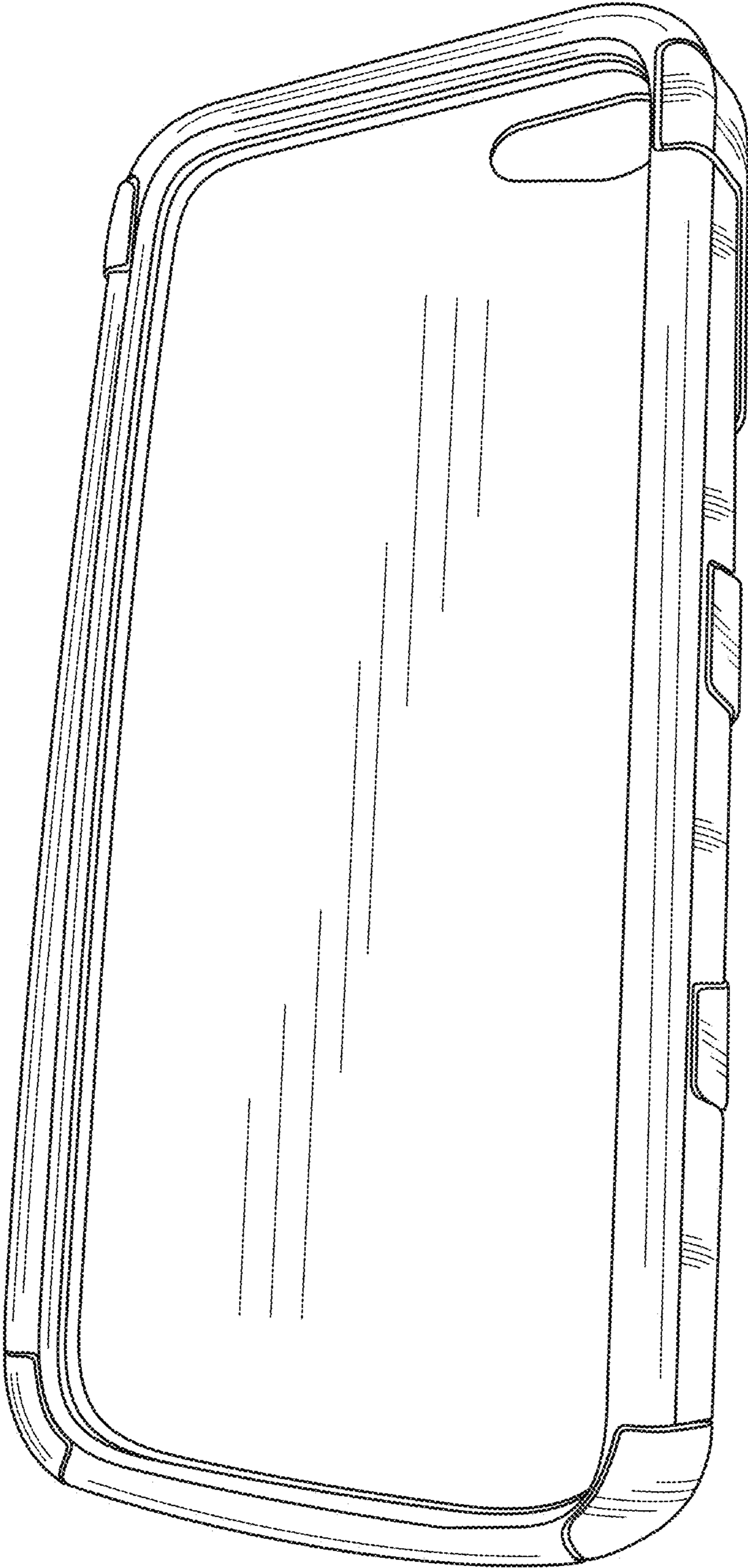

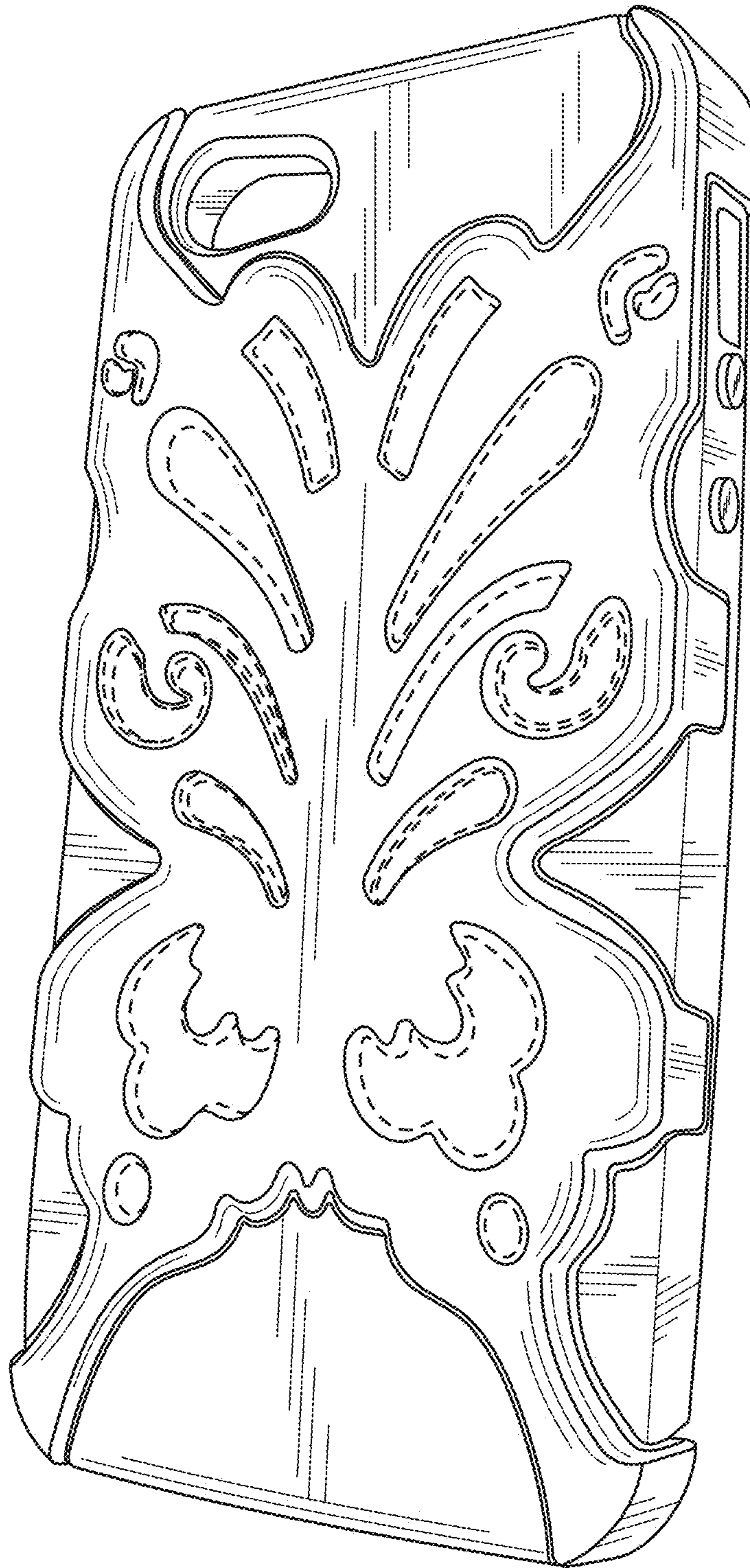

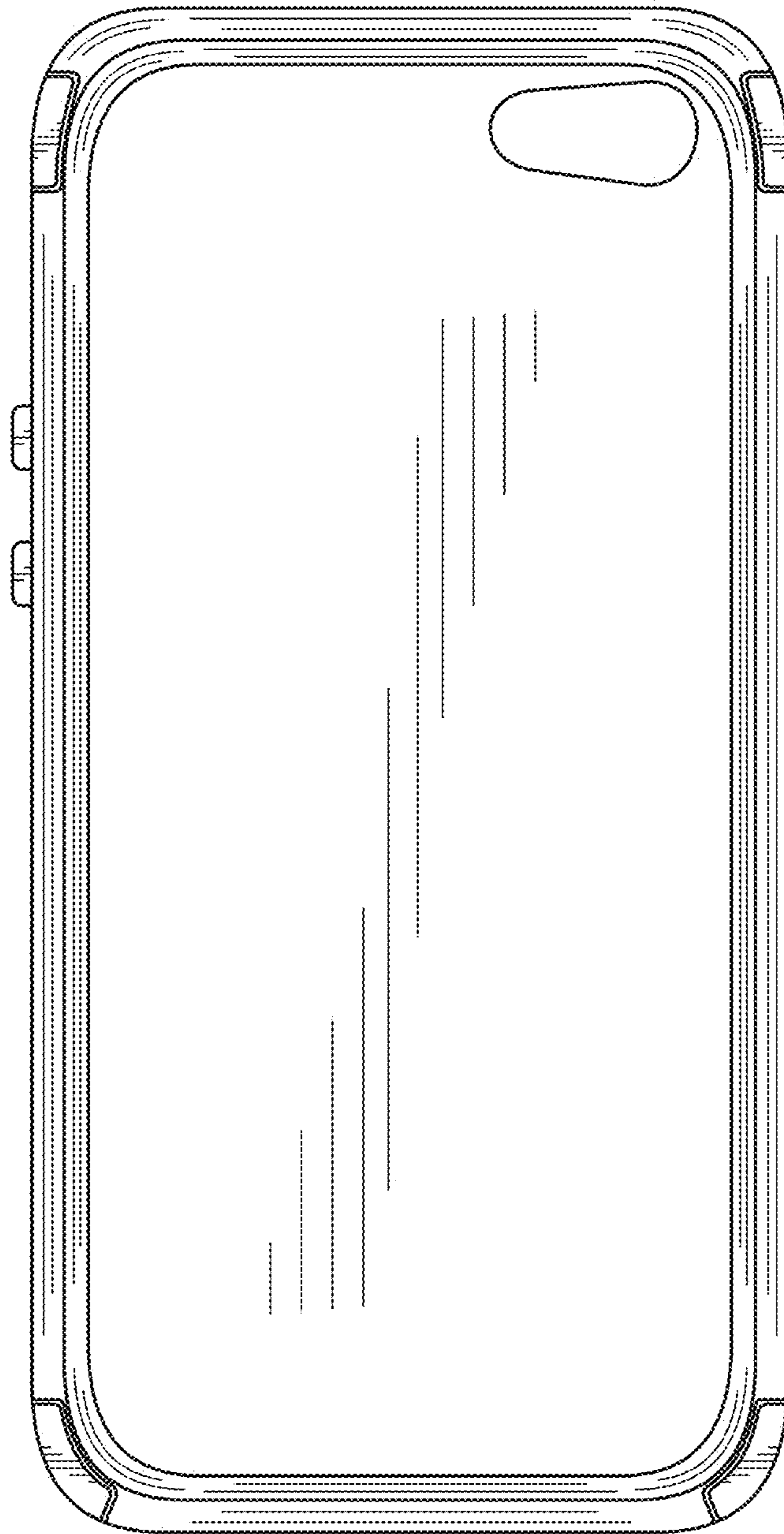

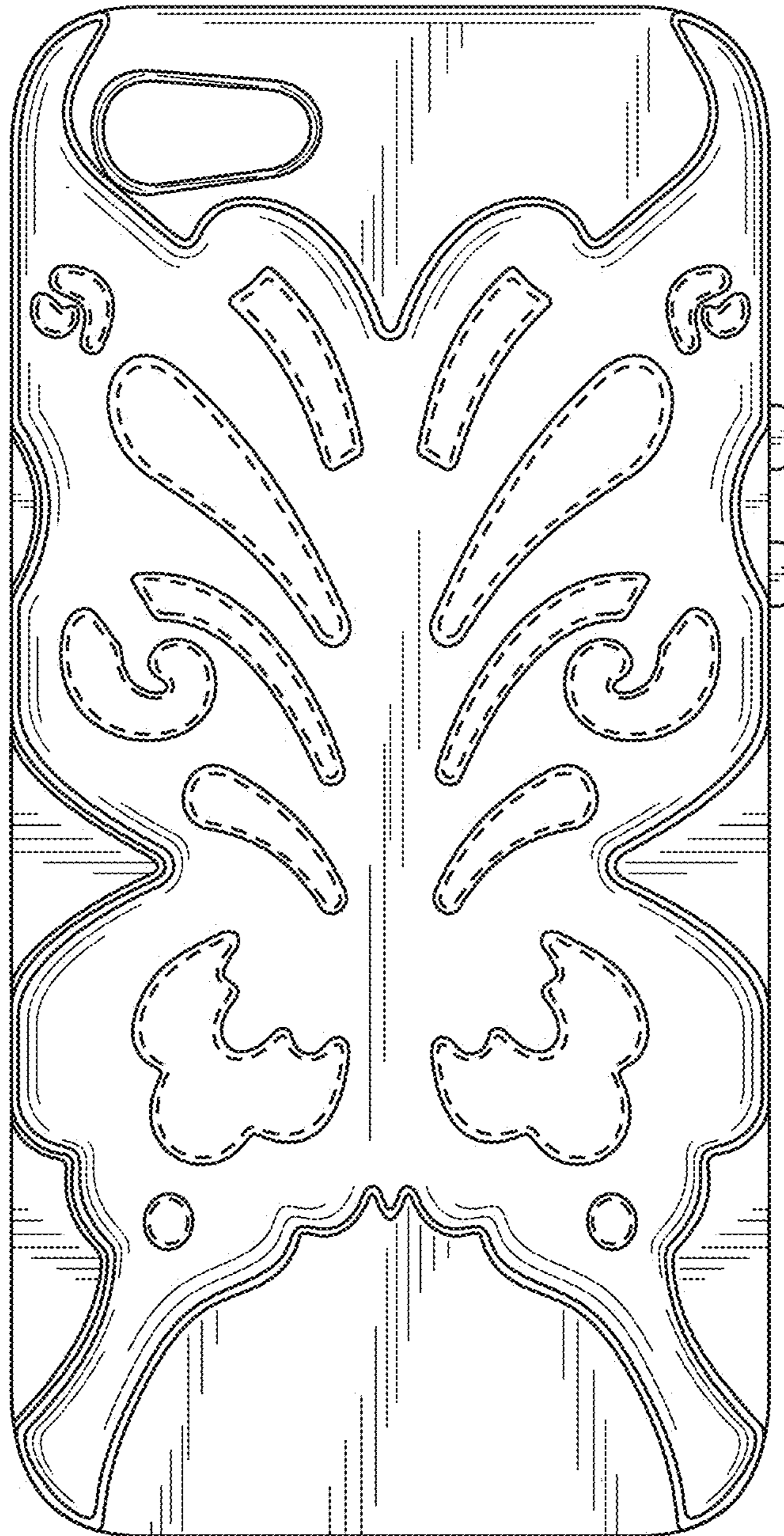

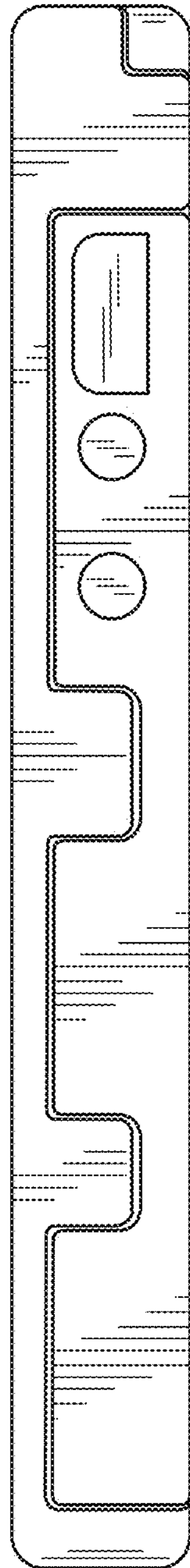

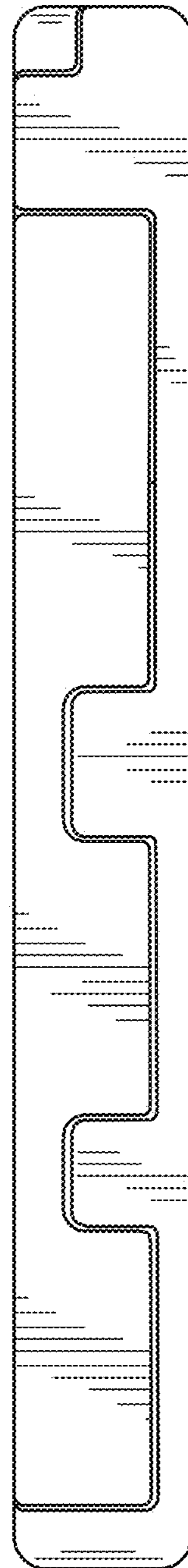

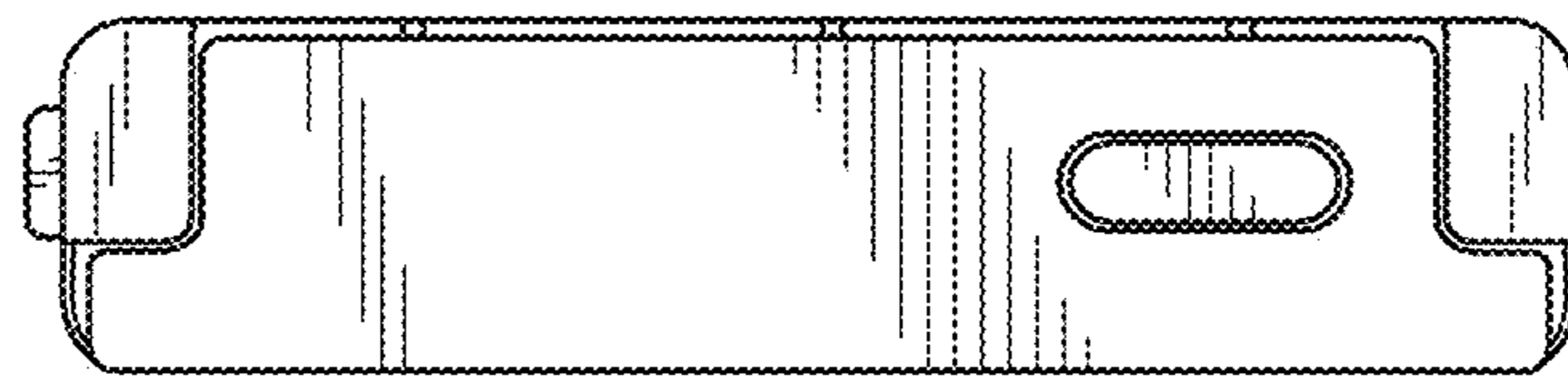

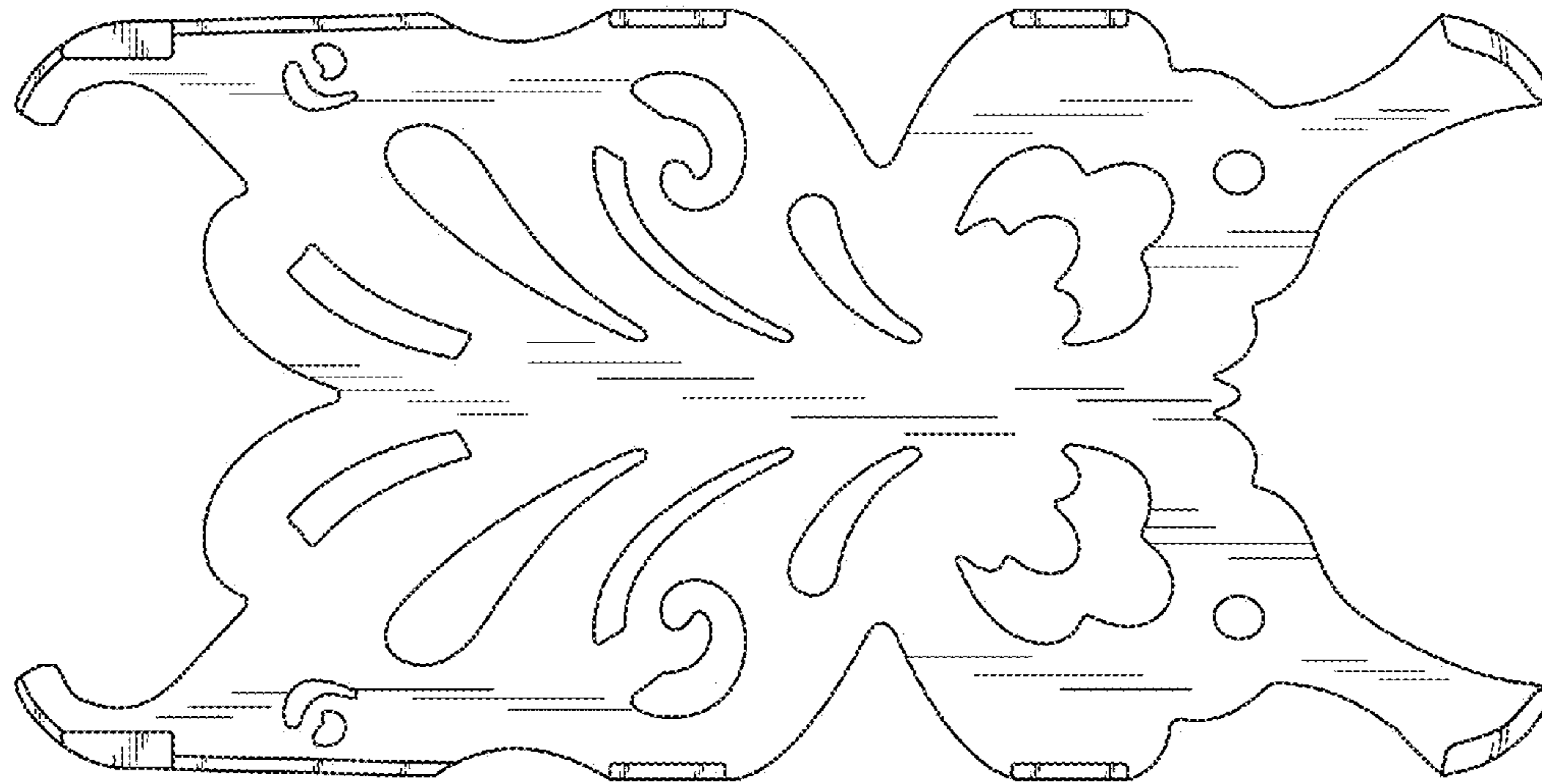
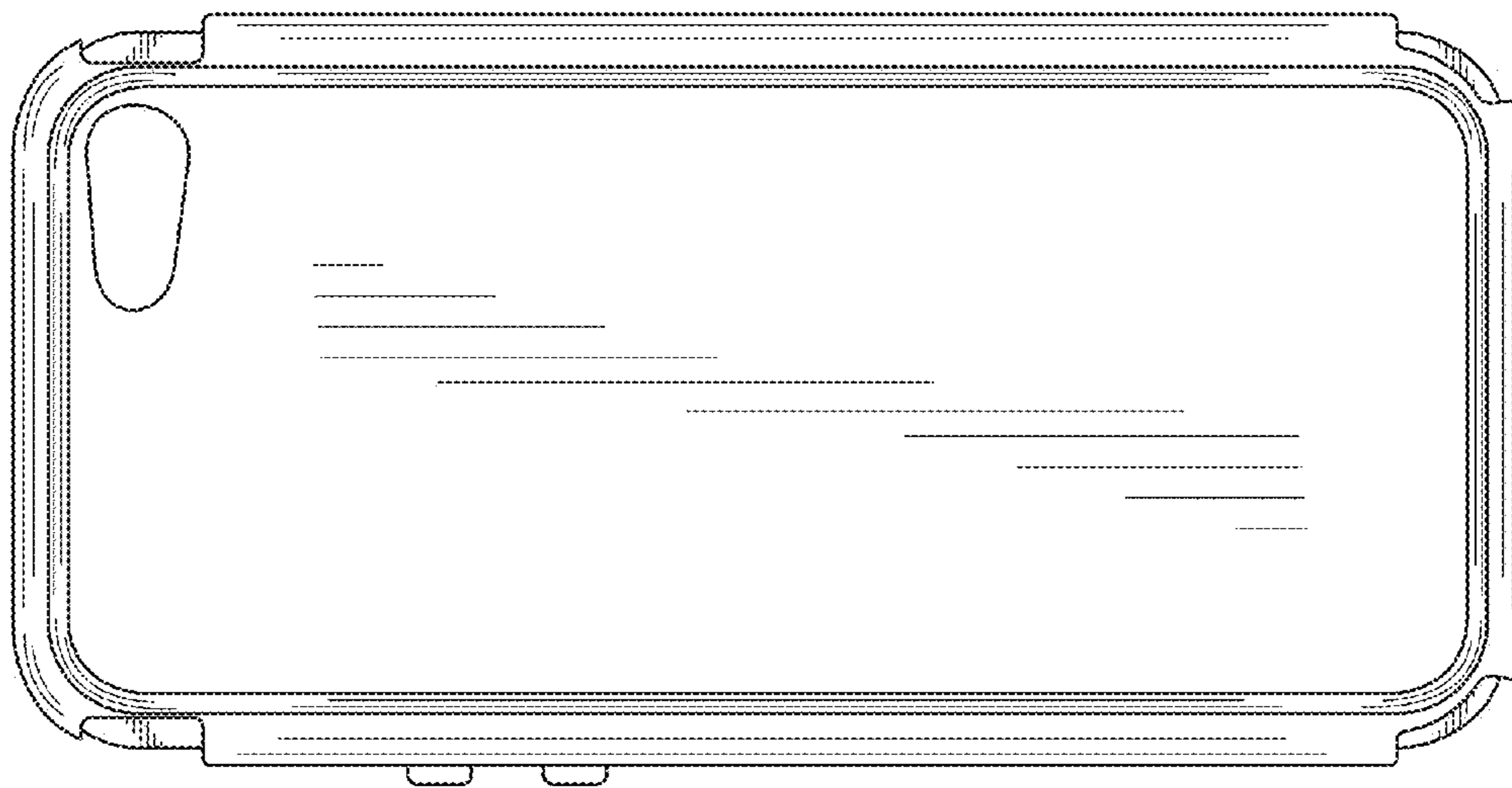

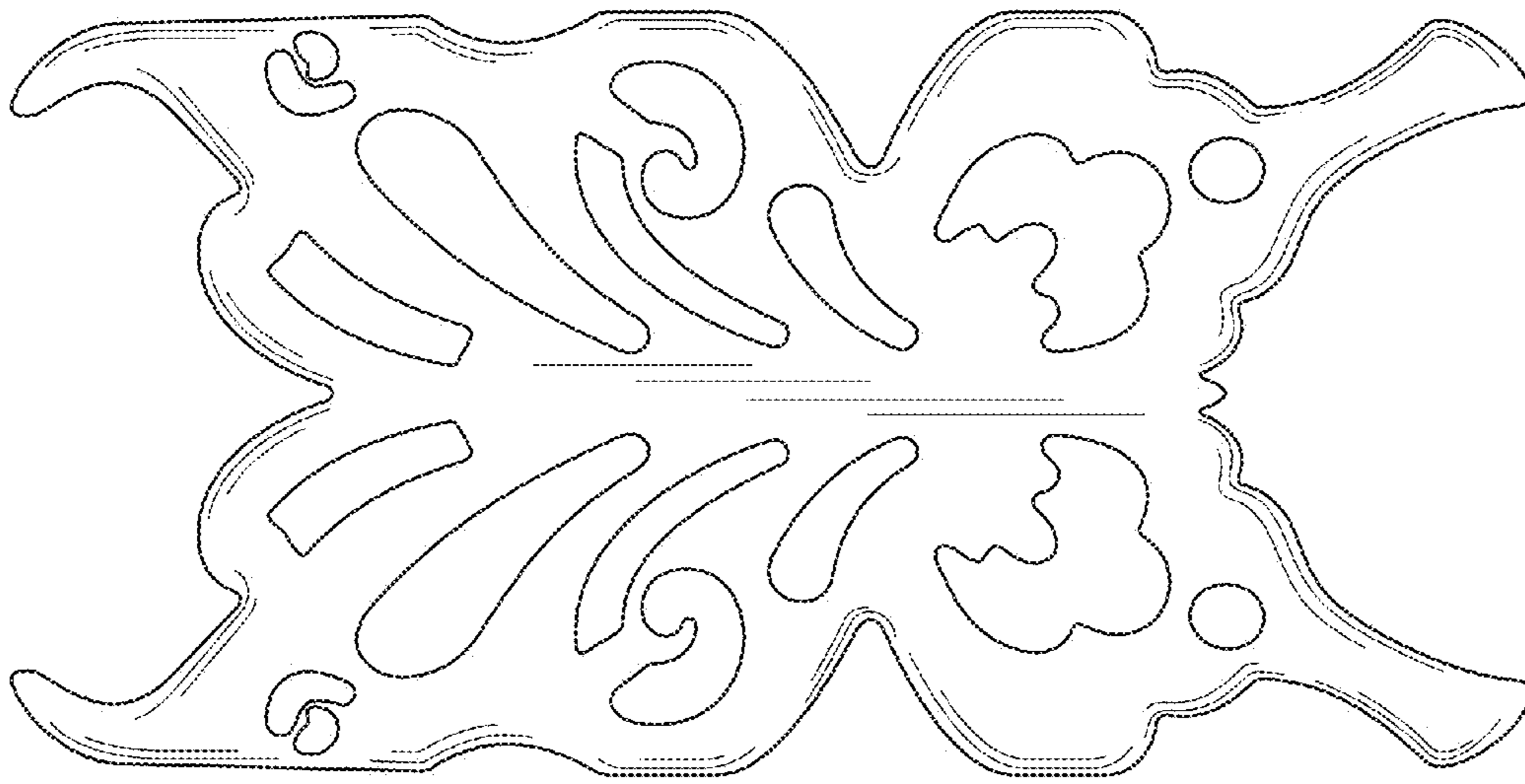
