DESCRIPTION

FIG. 1 is a top rear perspective view of an all-in-one computer showing my new design;

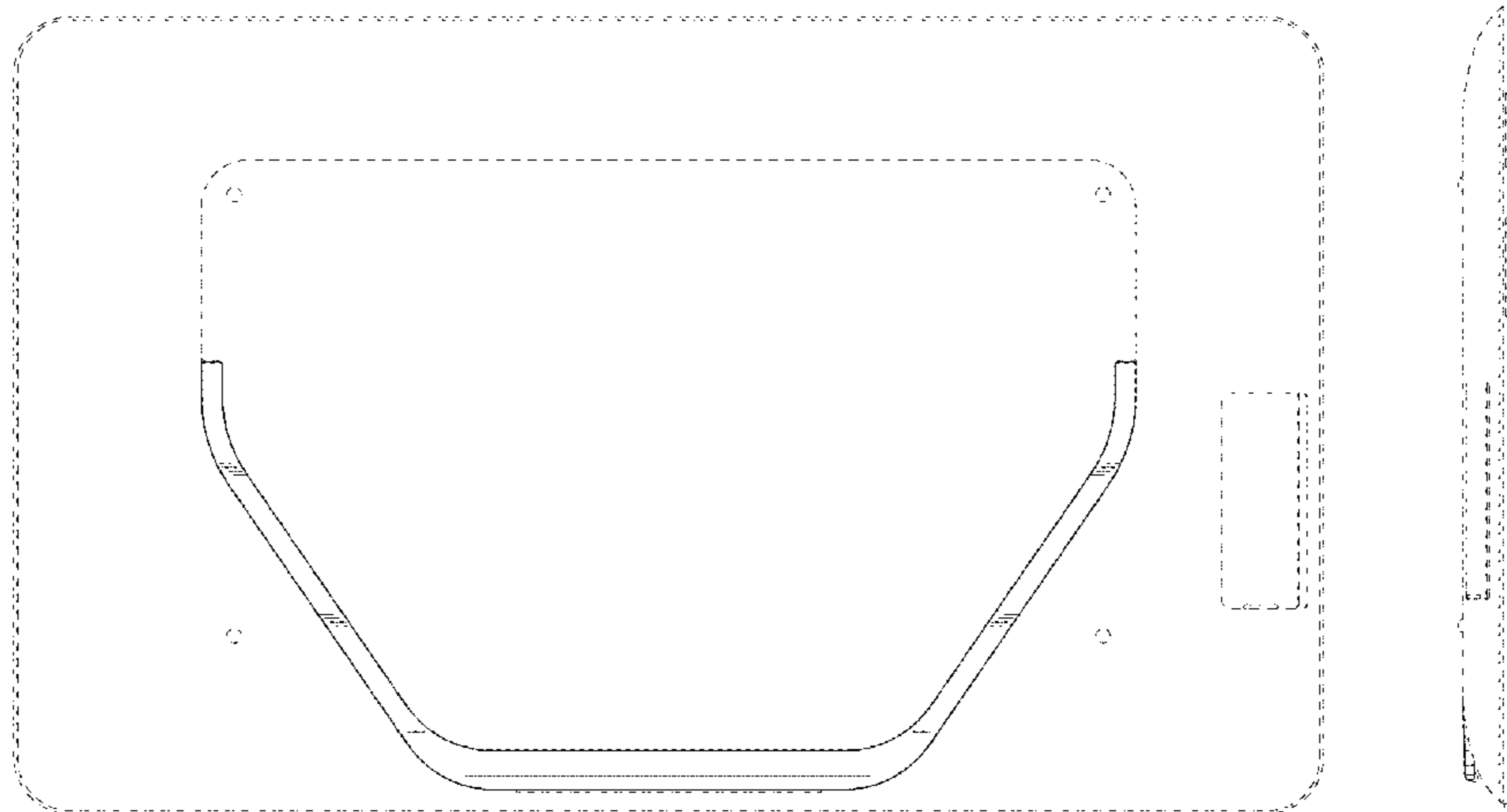

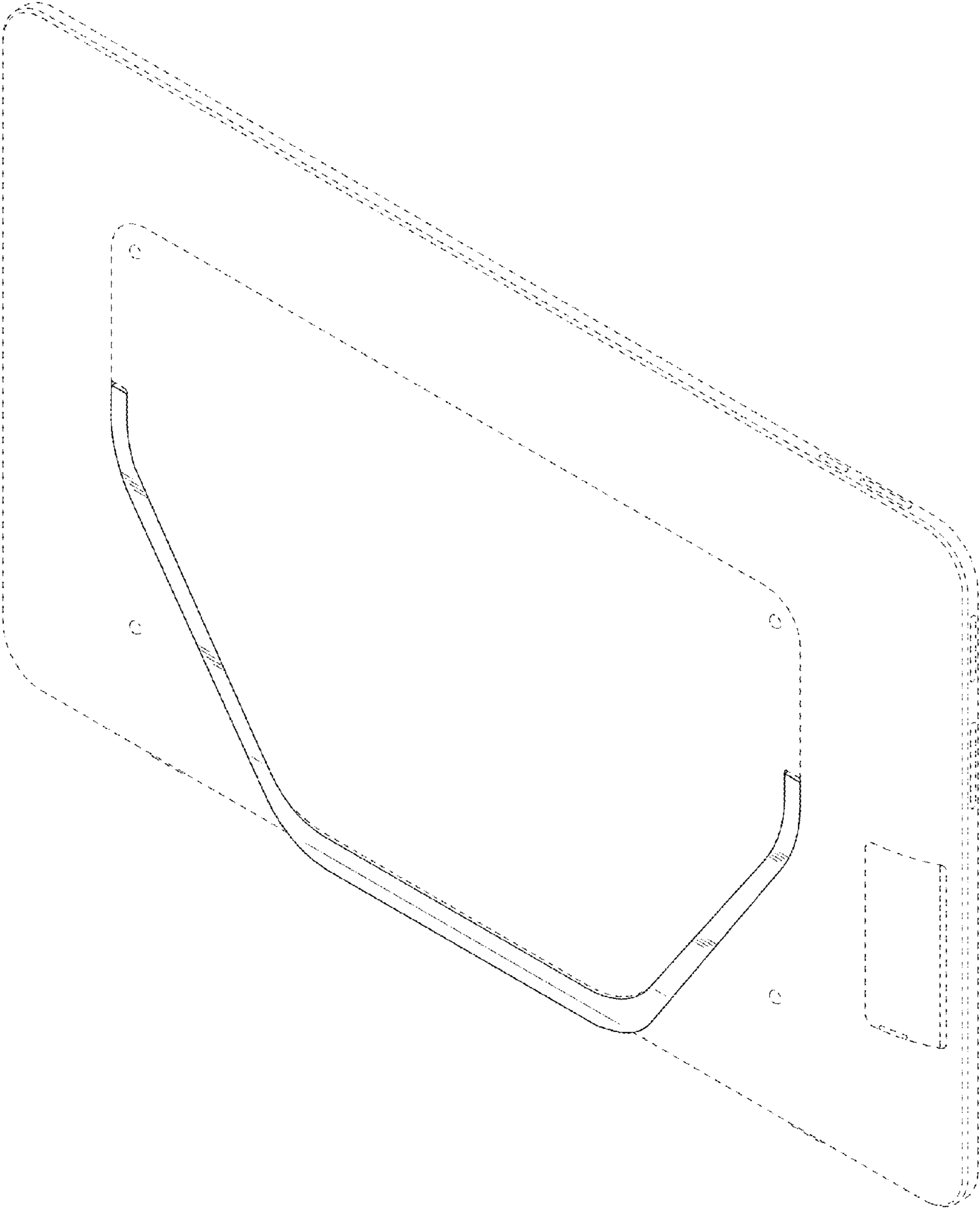

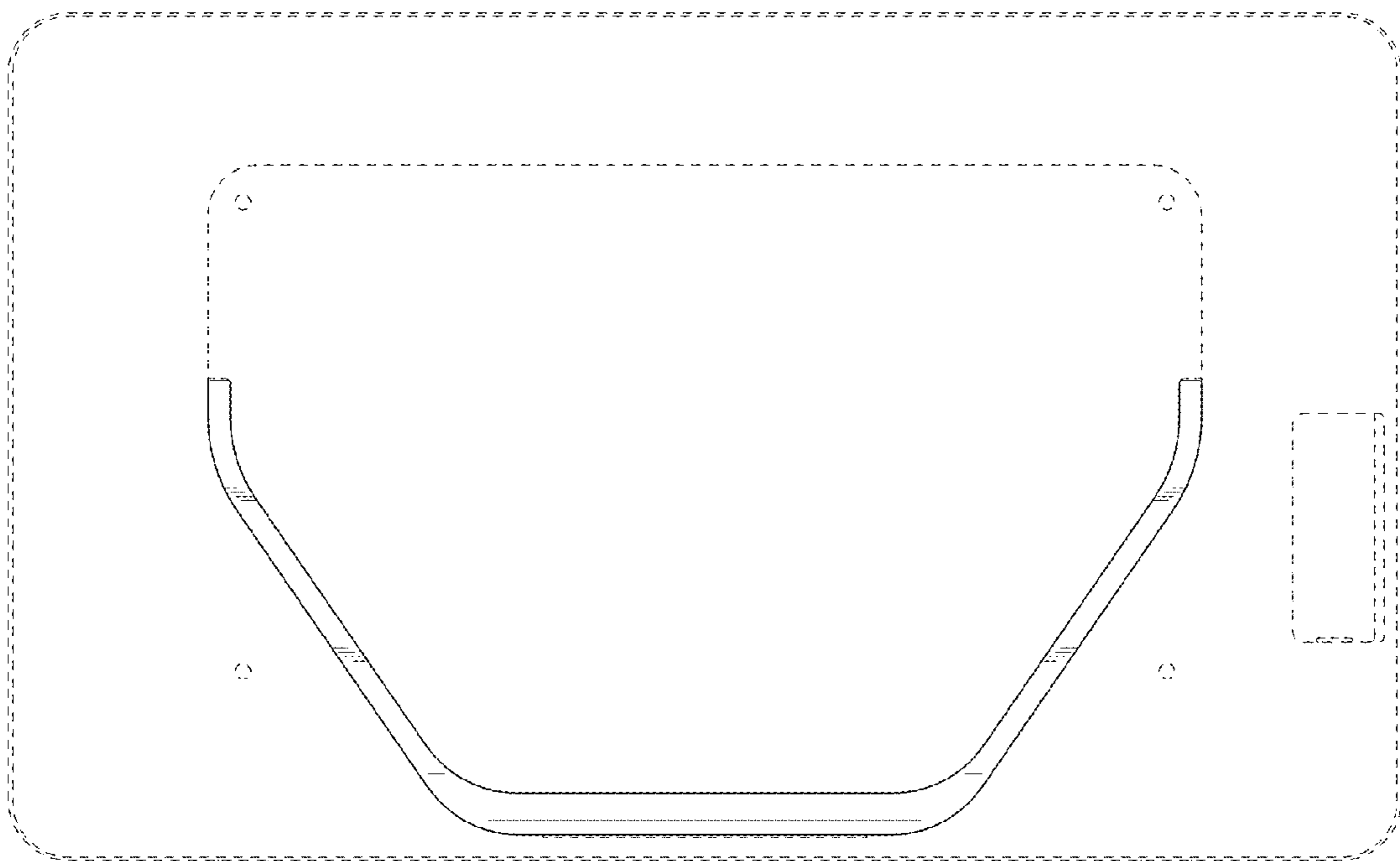

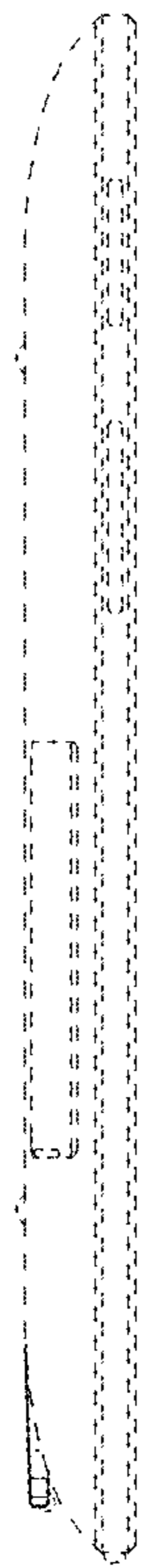

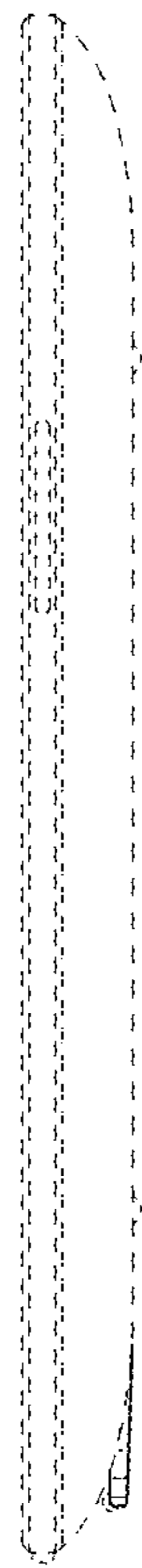

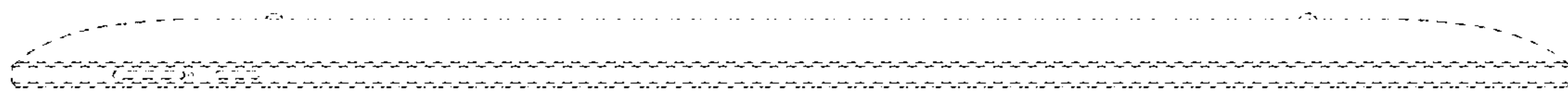

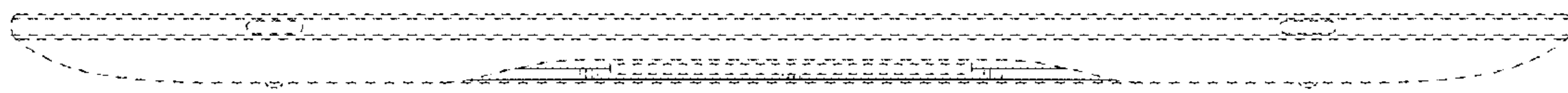
