We claim, the ornamental design for a display screen portion with icon, as shown and described.

DESCRIPTION

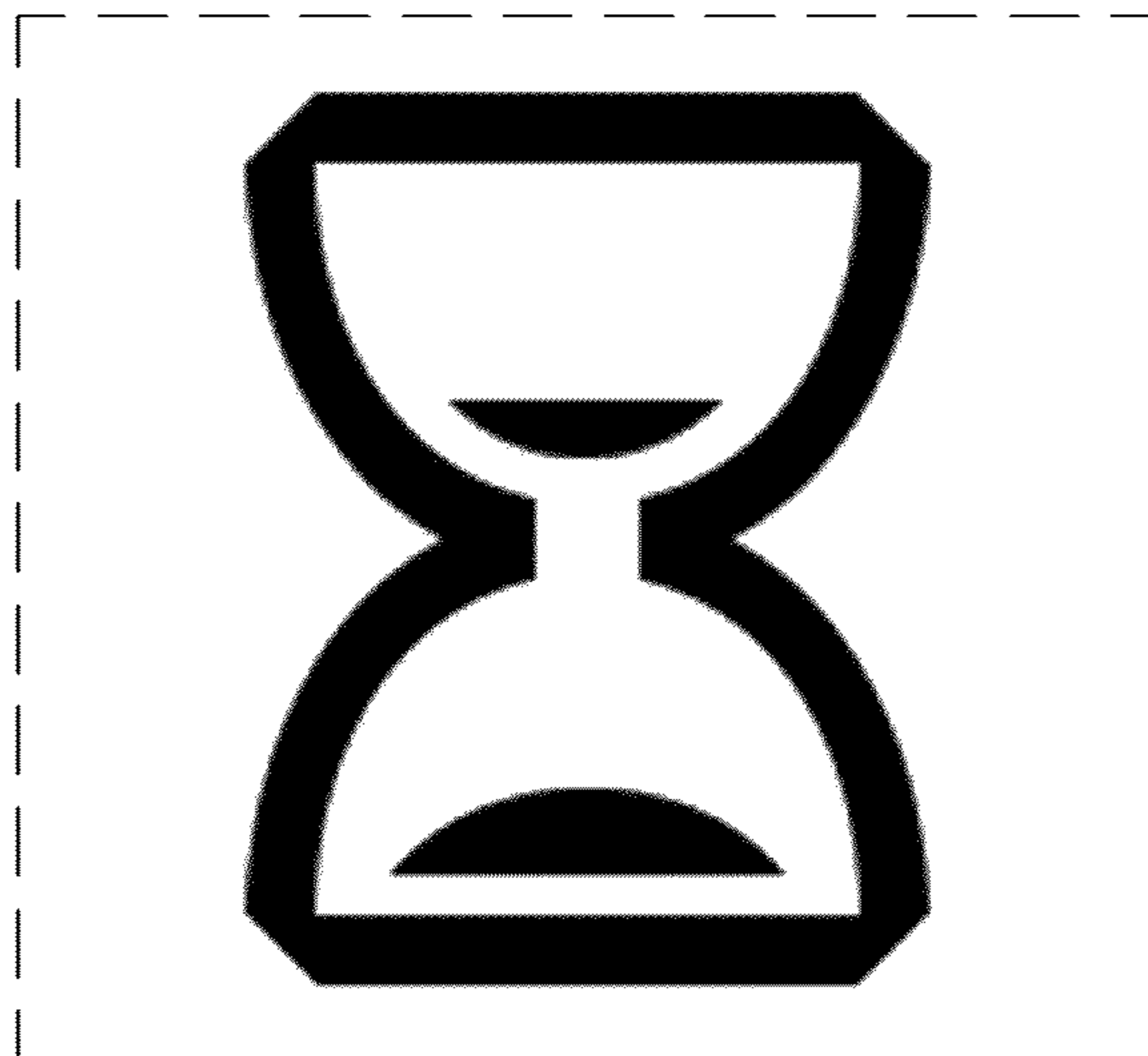

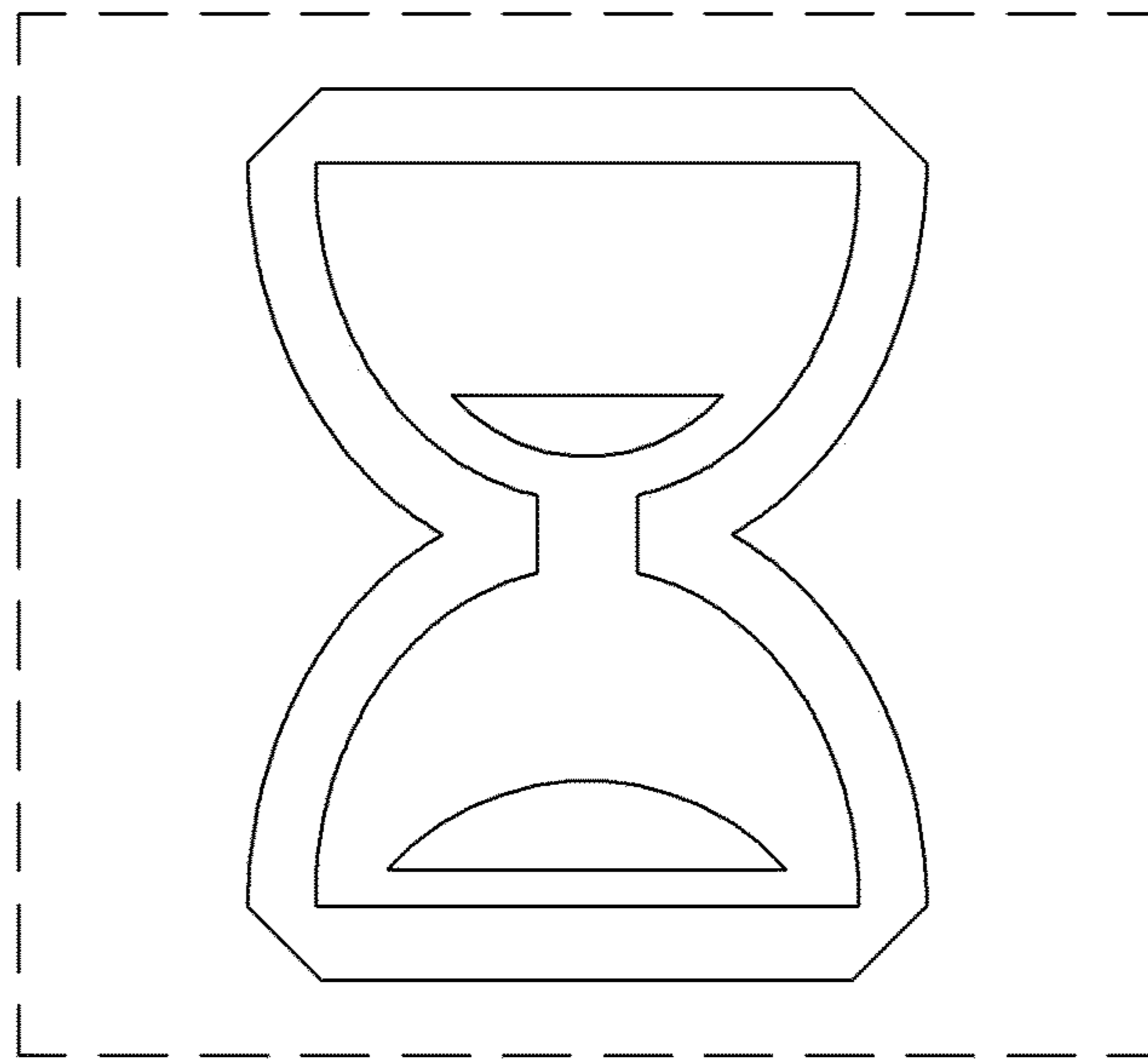

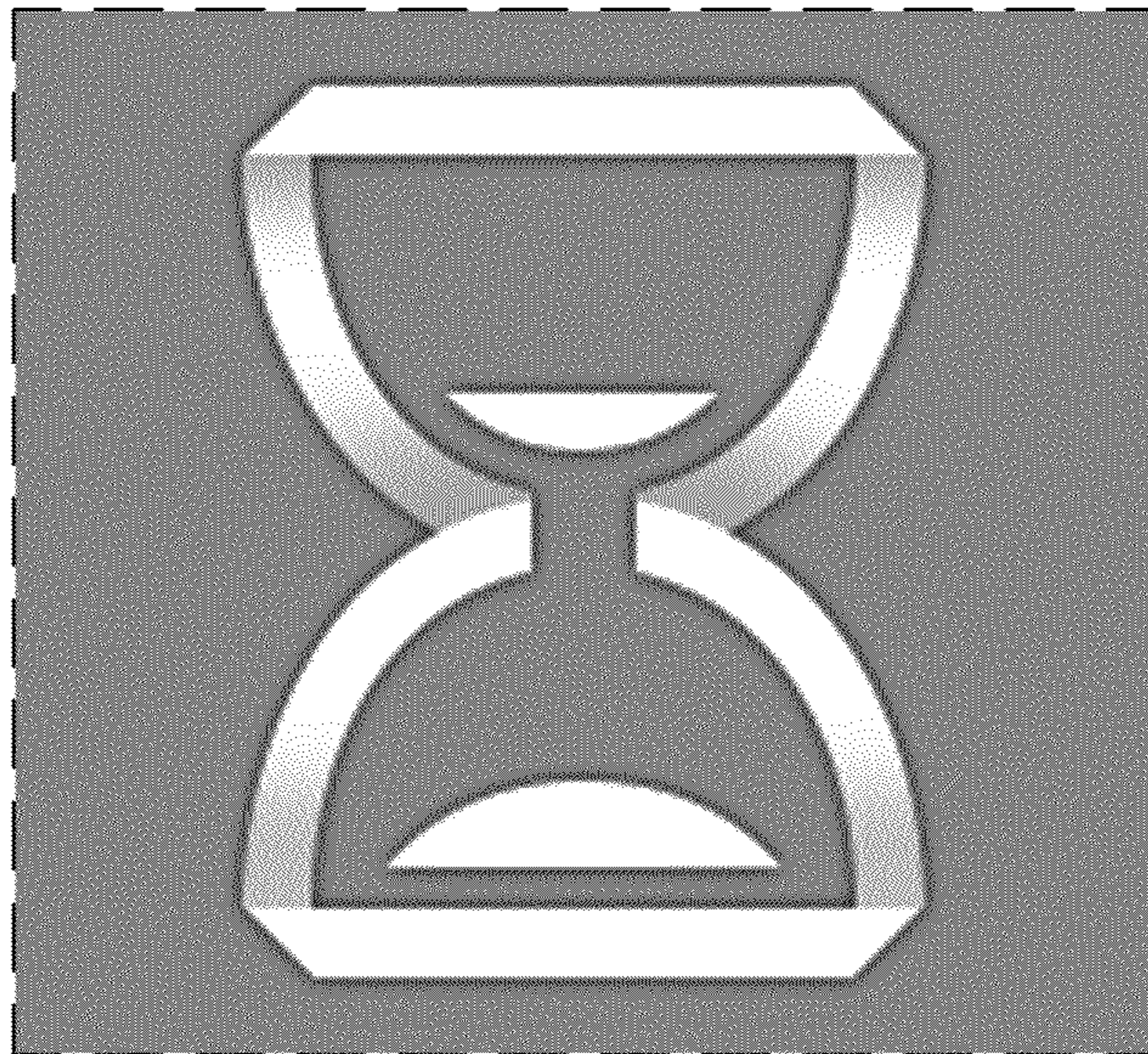

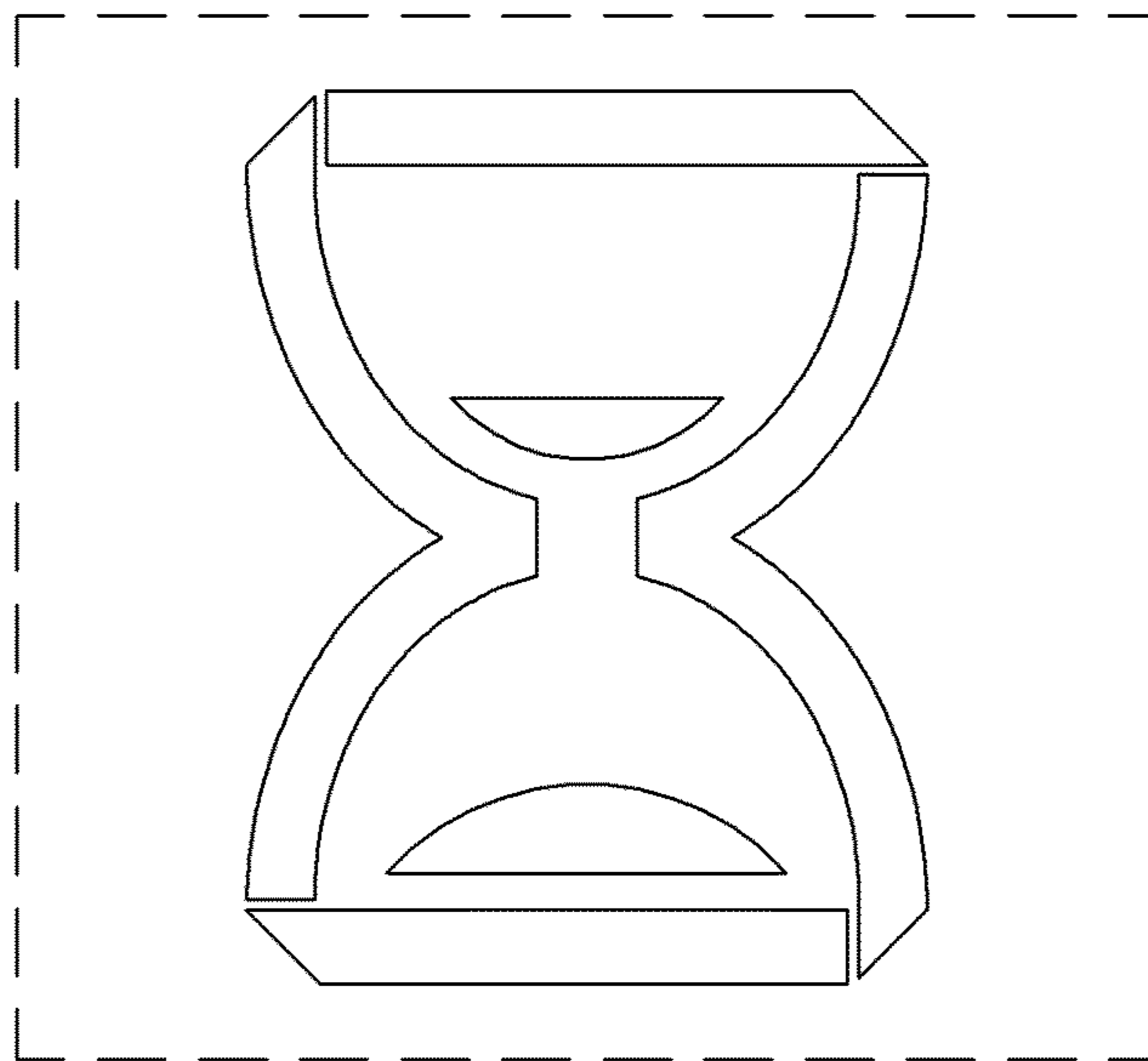

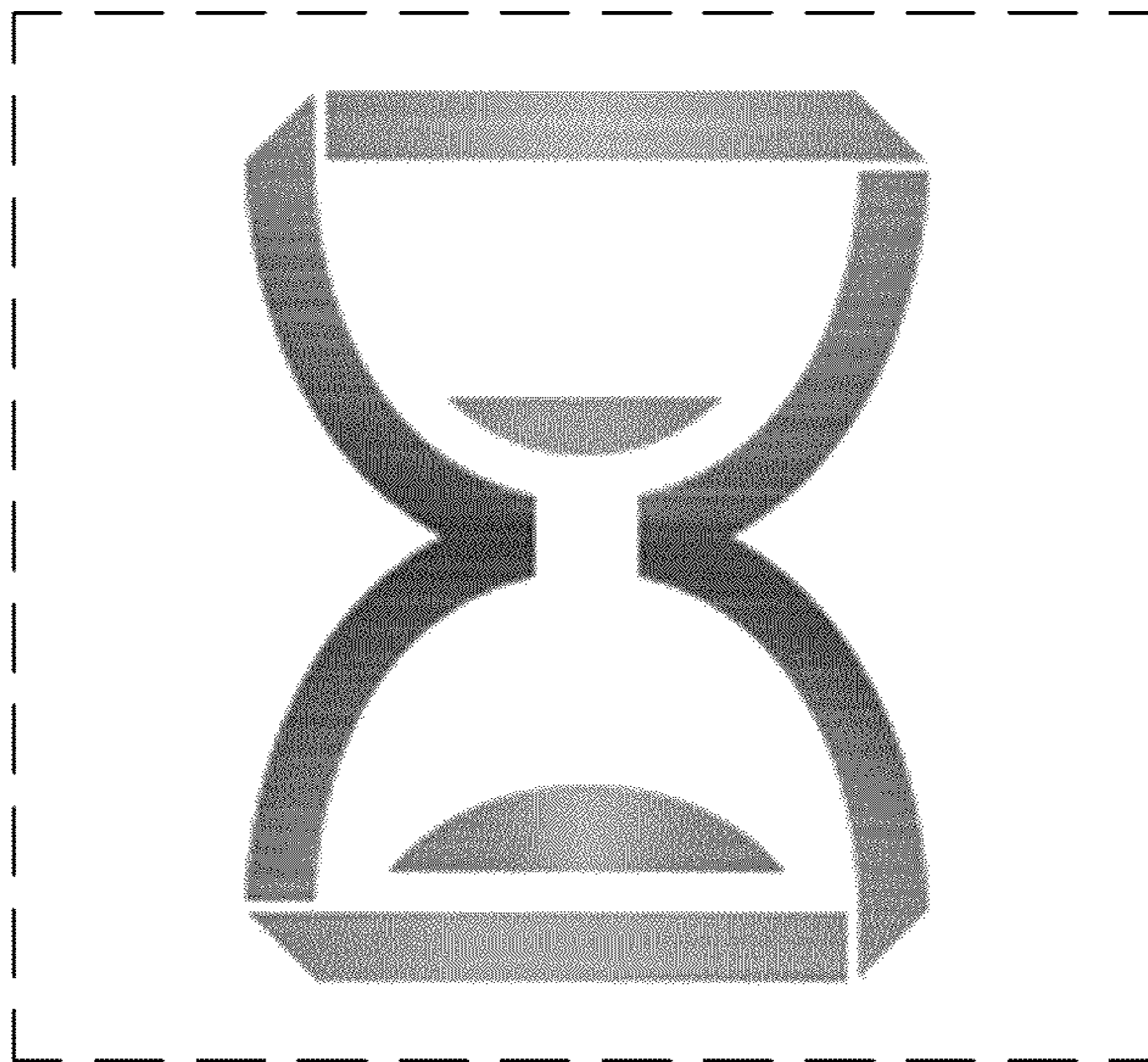
