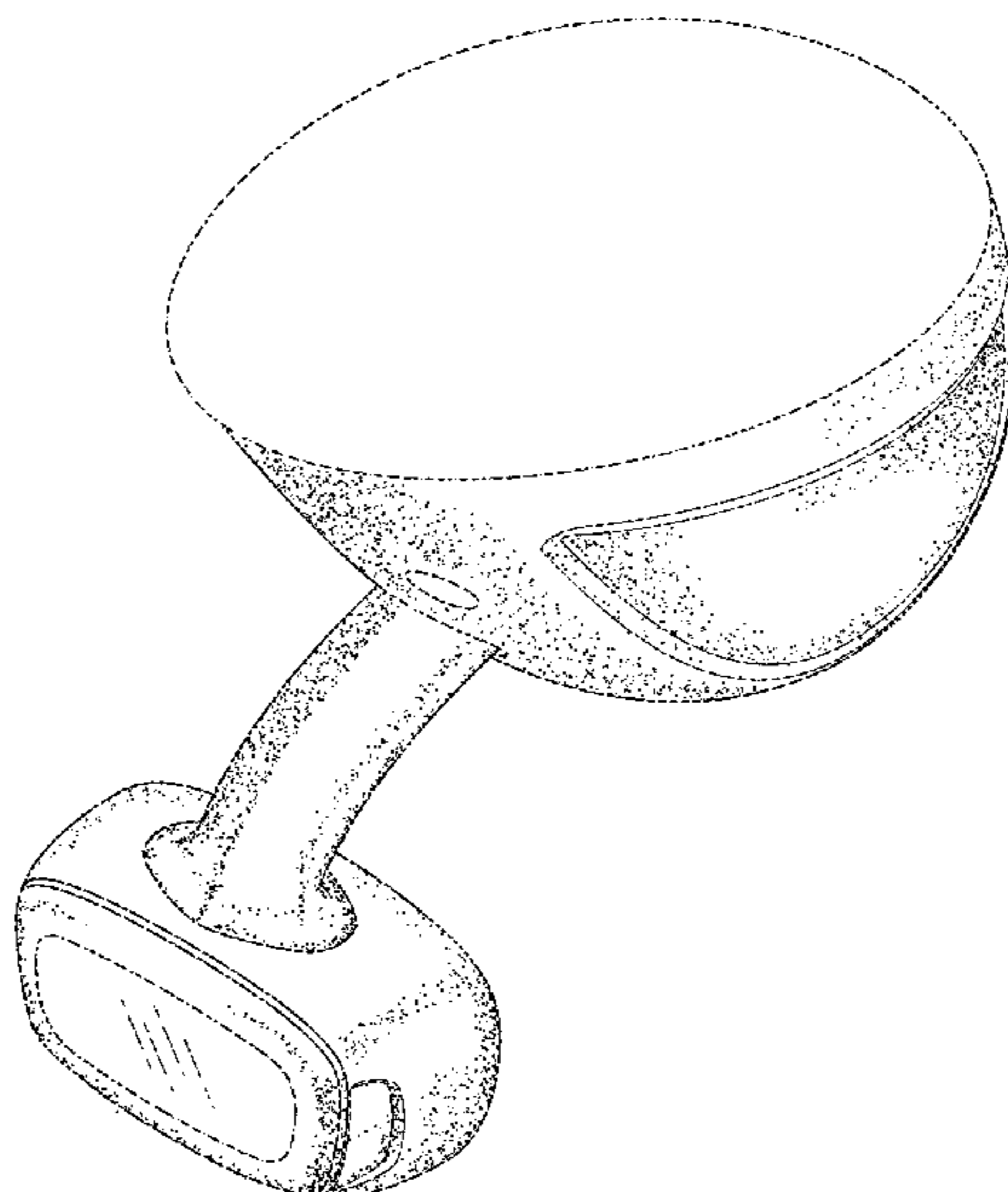
(57) **CLAIM**

We claim the ornamental design for a forward camera system,

DESCRIPTION

FIG. 1 is a front perspective view of a forward camera system
showing our new design;
FIG. 2 is a front elevational view of the forward camera
system of FIG. 1;
FIG. 3 is a rear elevational view of the forward camera system
of FIG. 1;
FIG. 4 is a right side elevational view of the forward camera

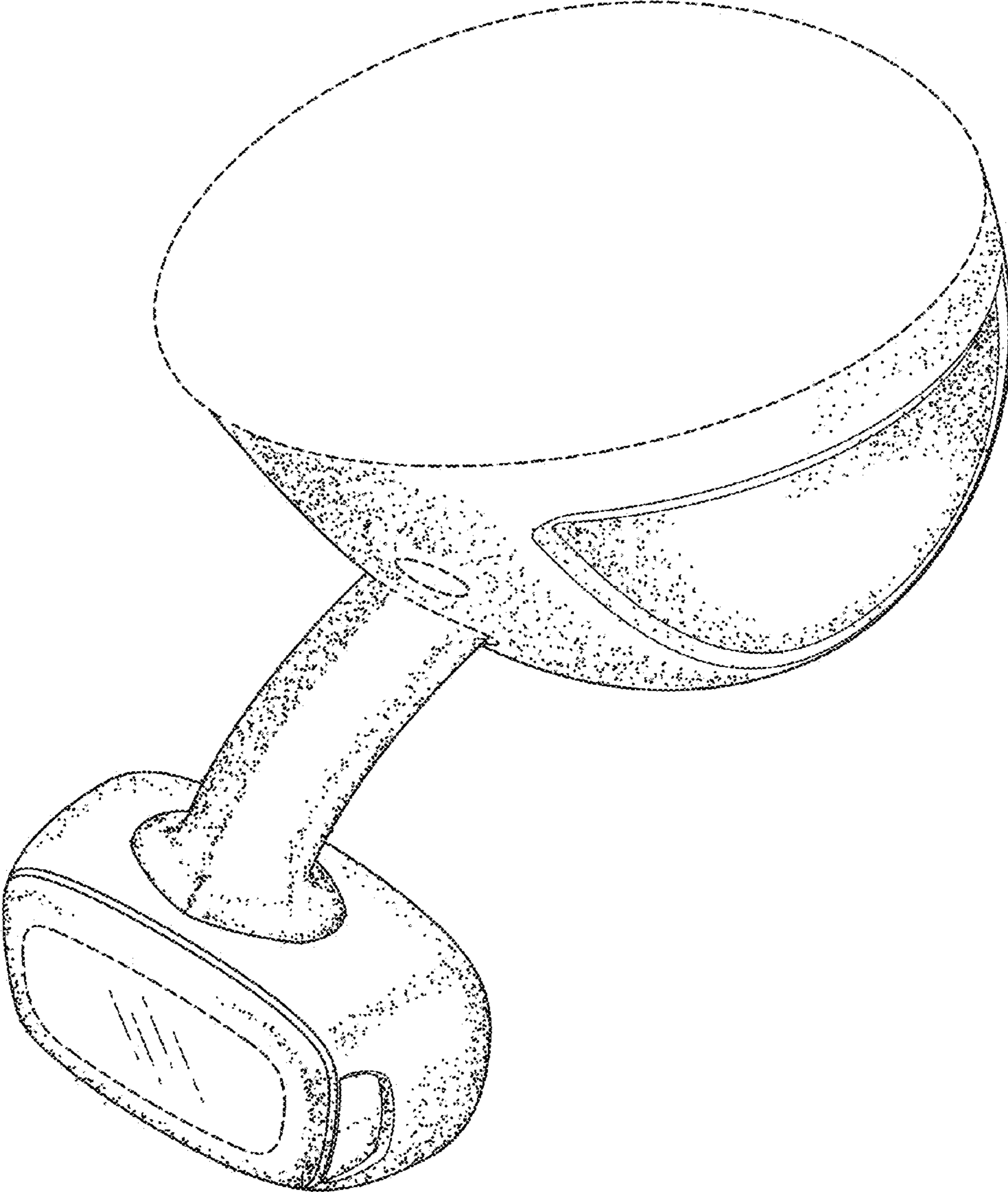

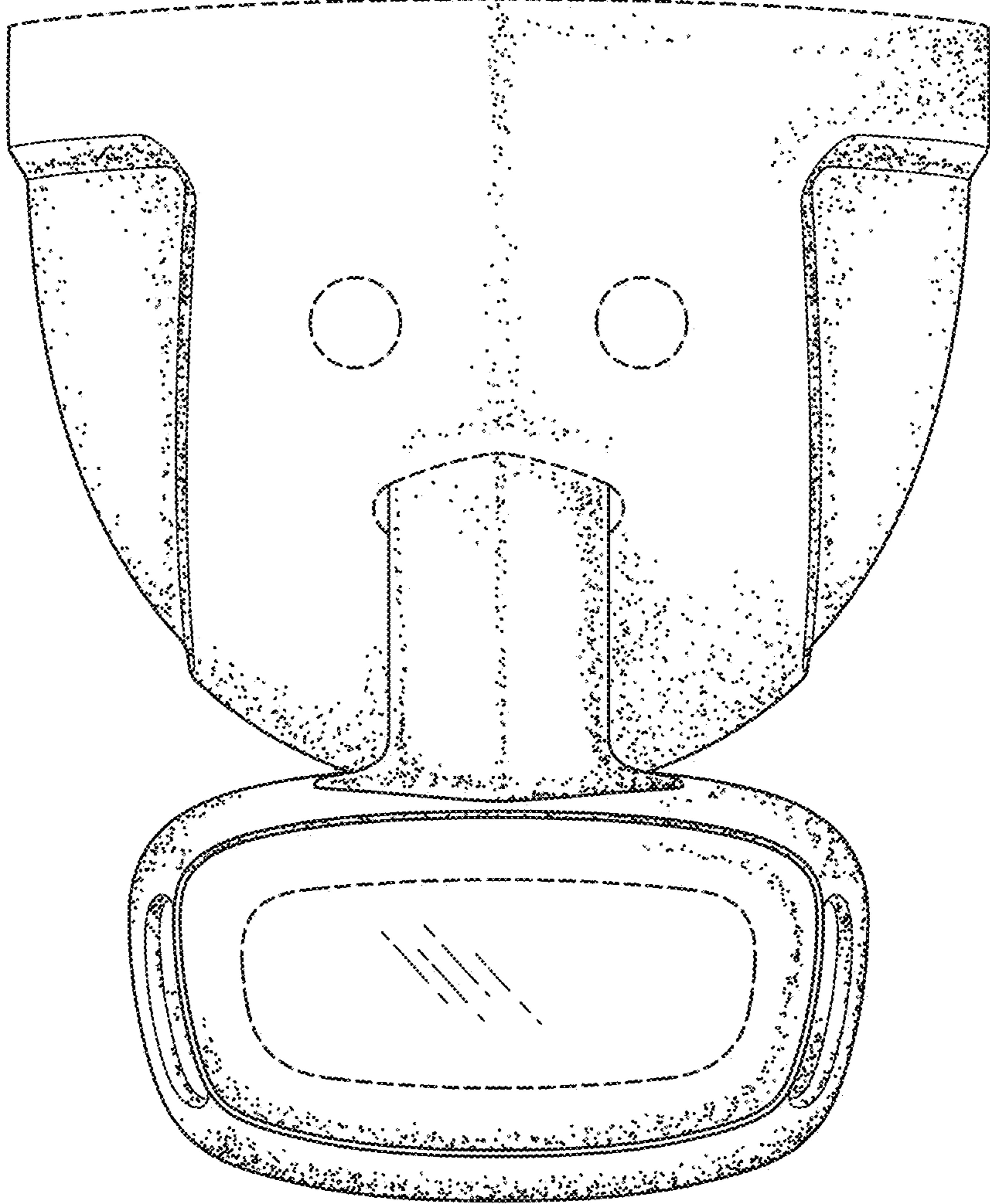

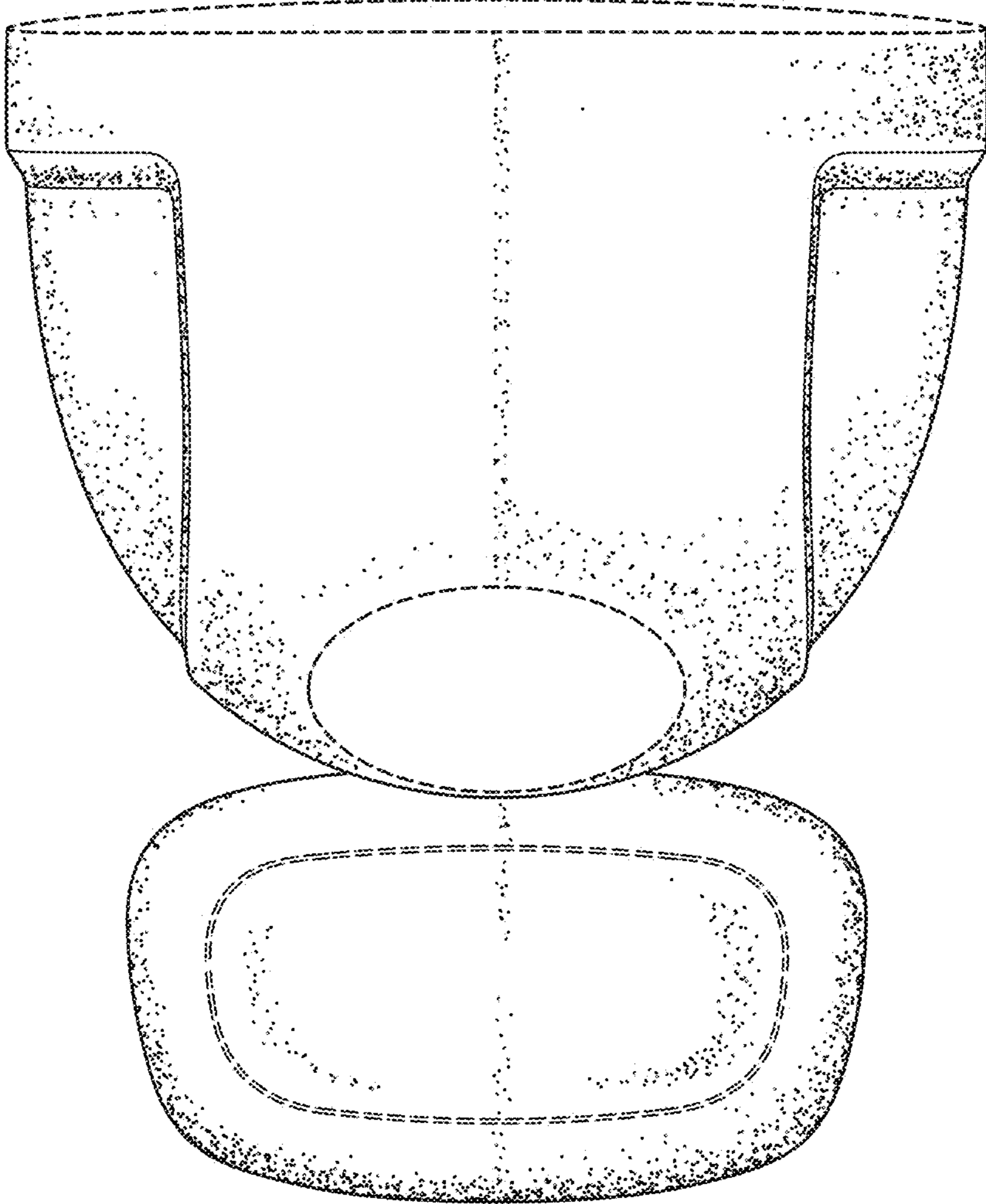

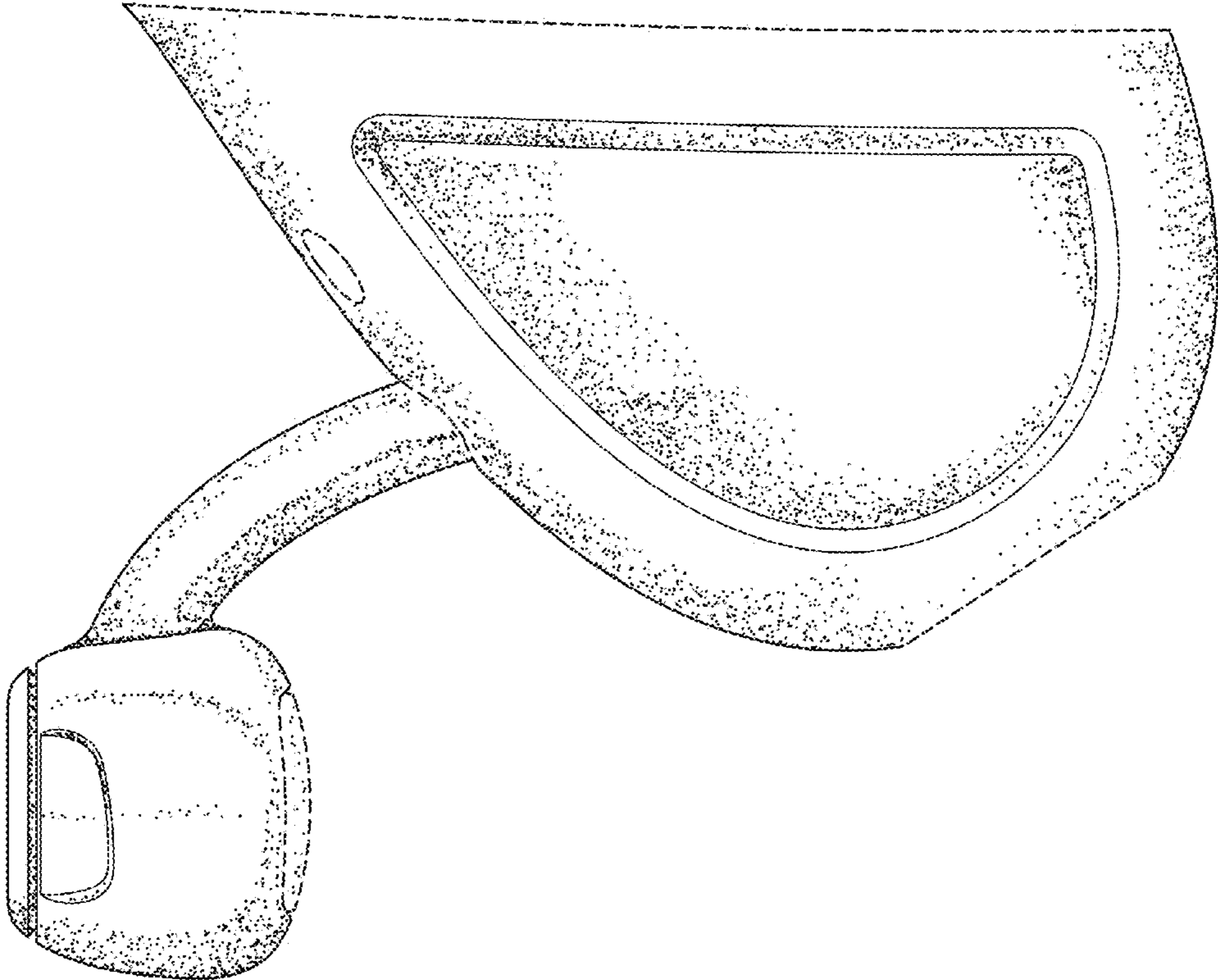

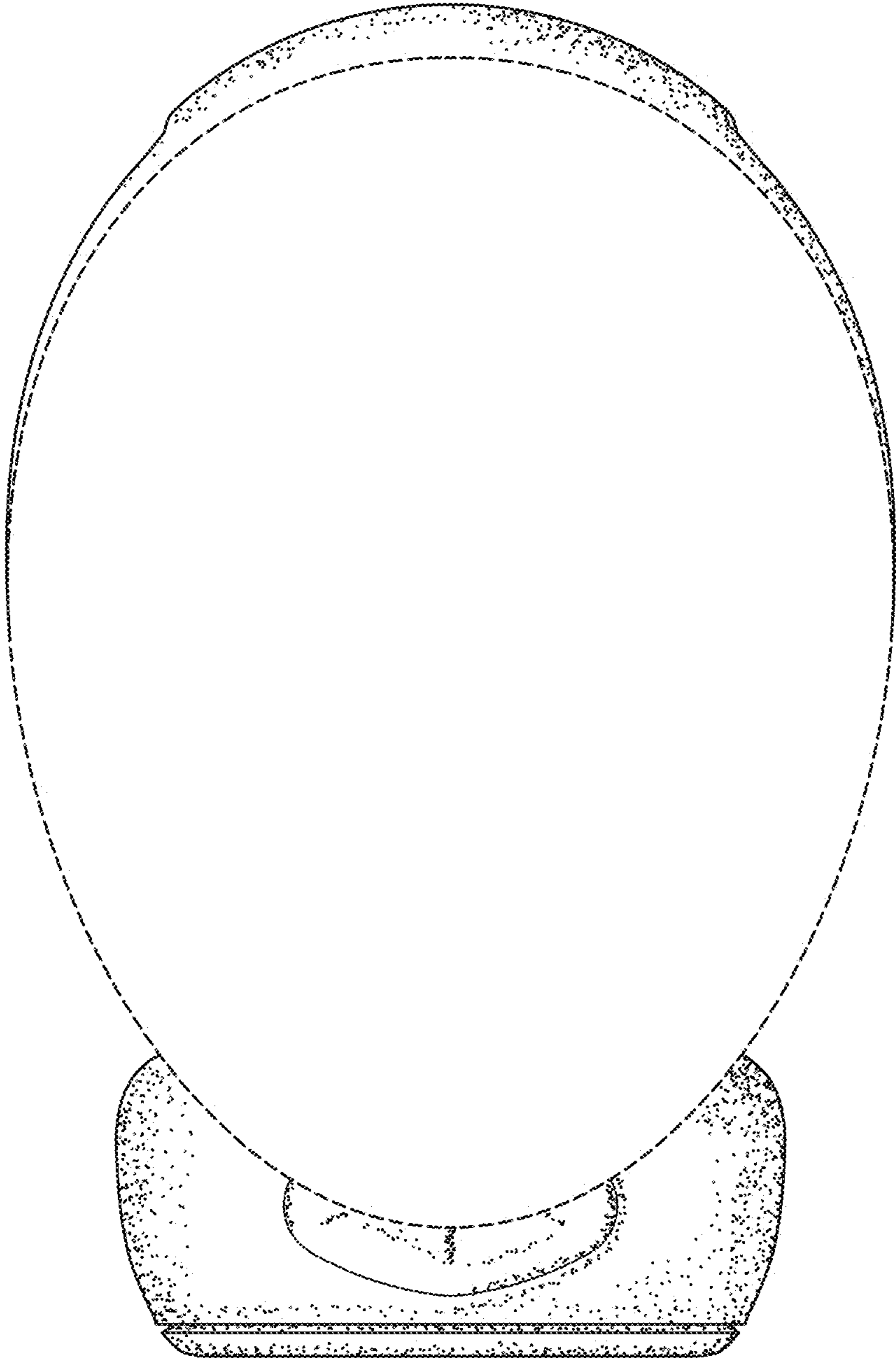

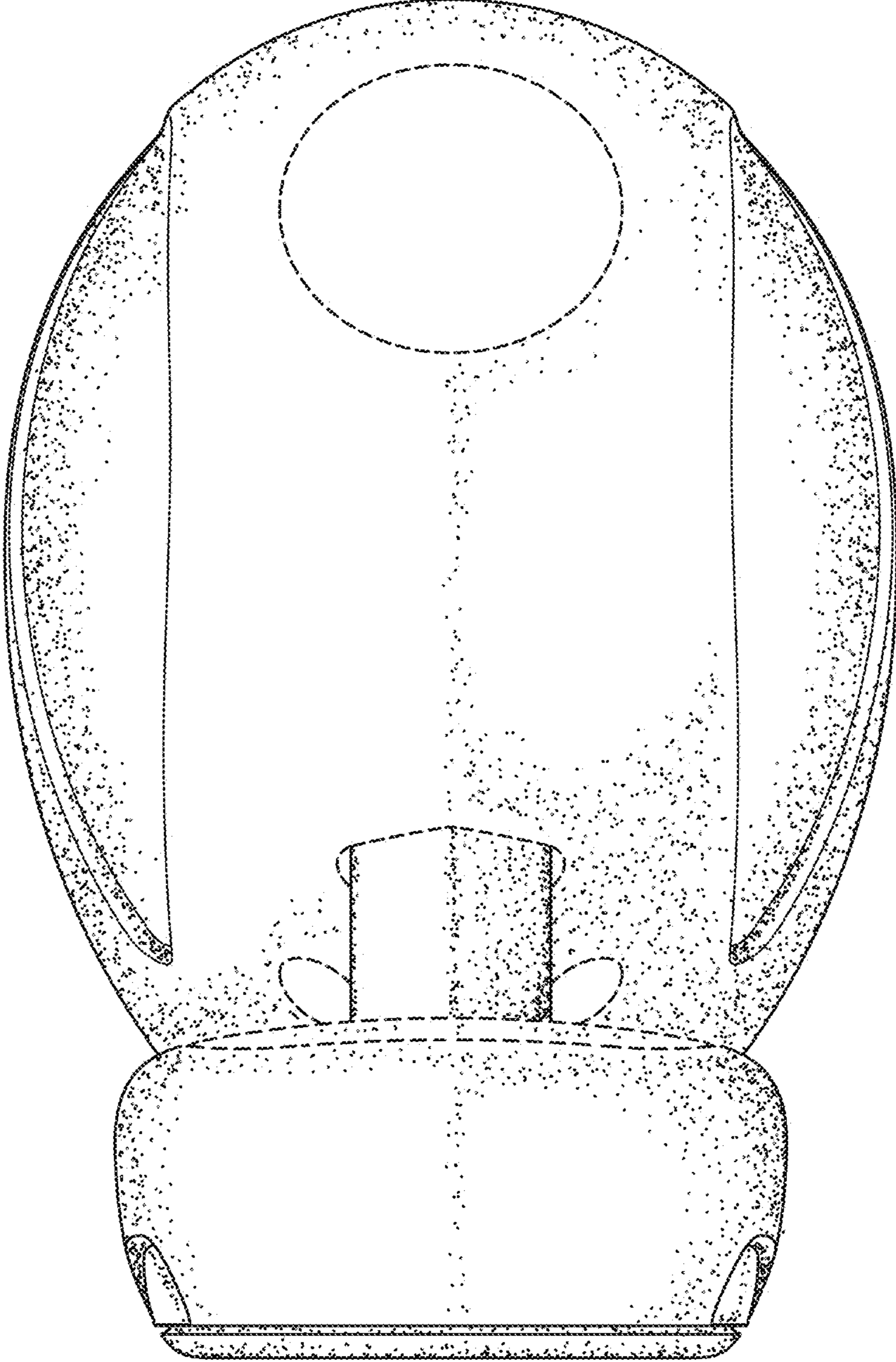
