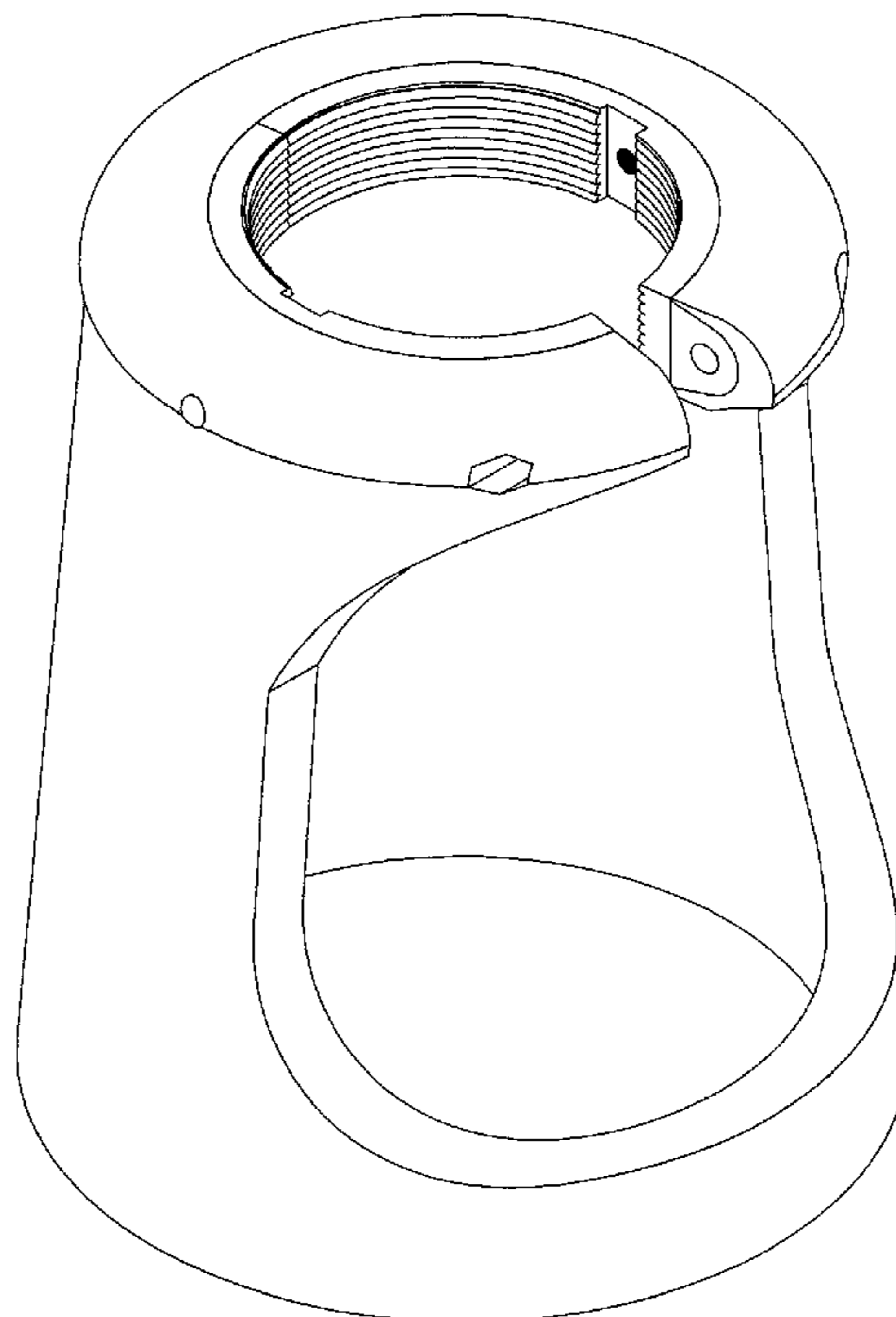
FIG. 1 is a perspective view of a gas cylinder safety guard of the present invention;

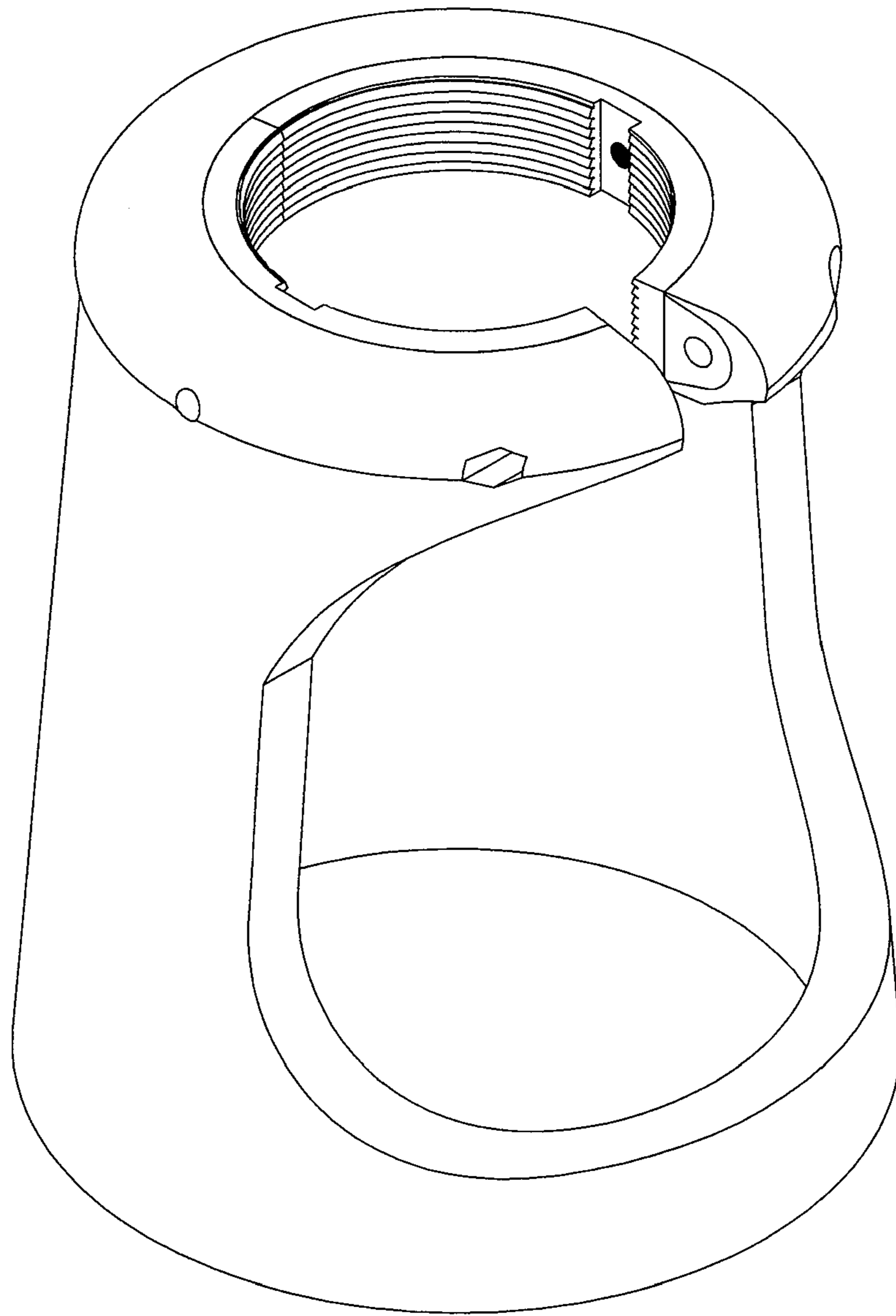

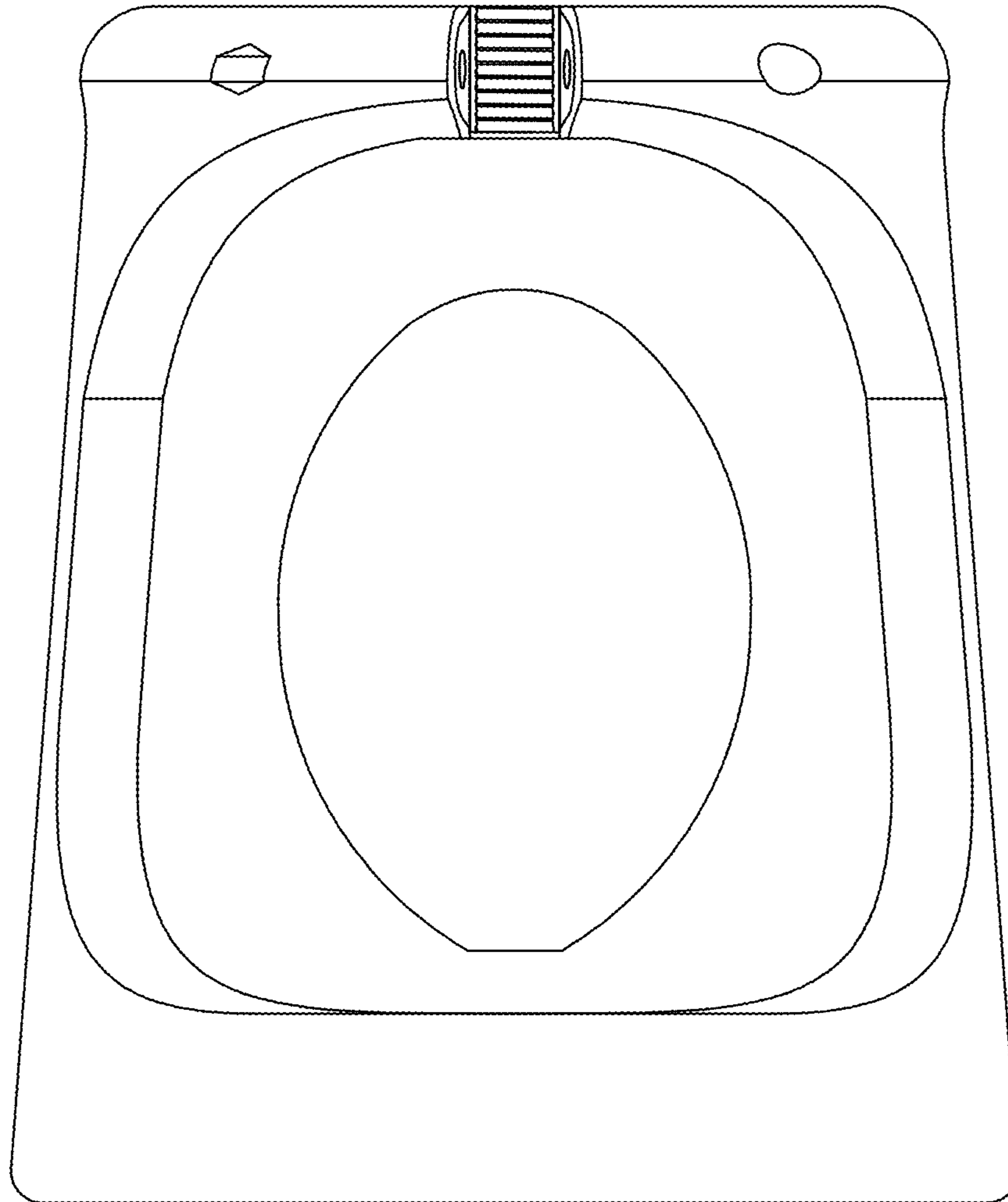

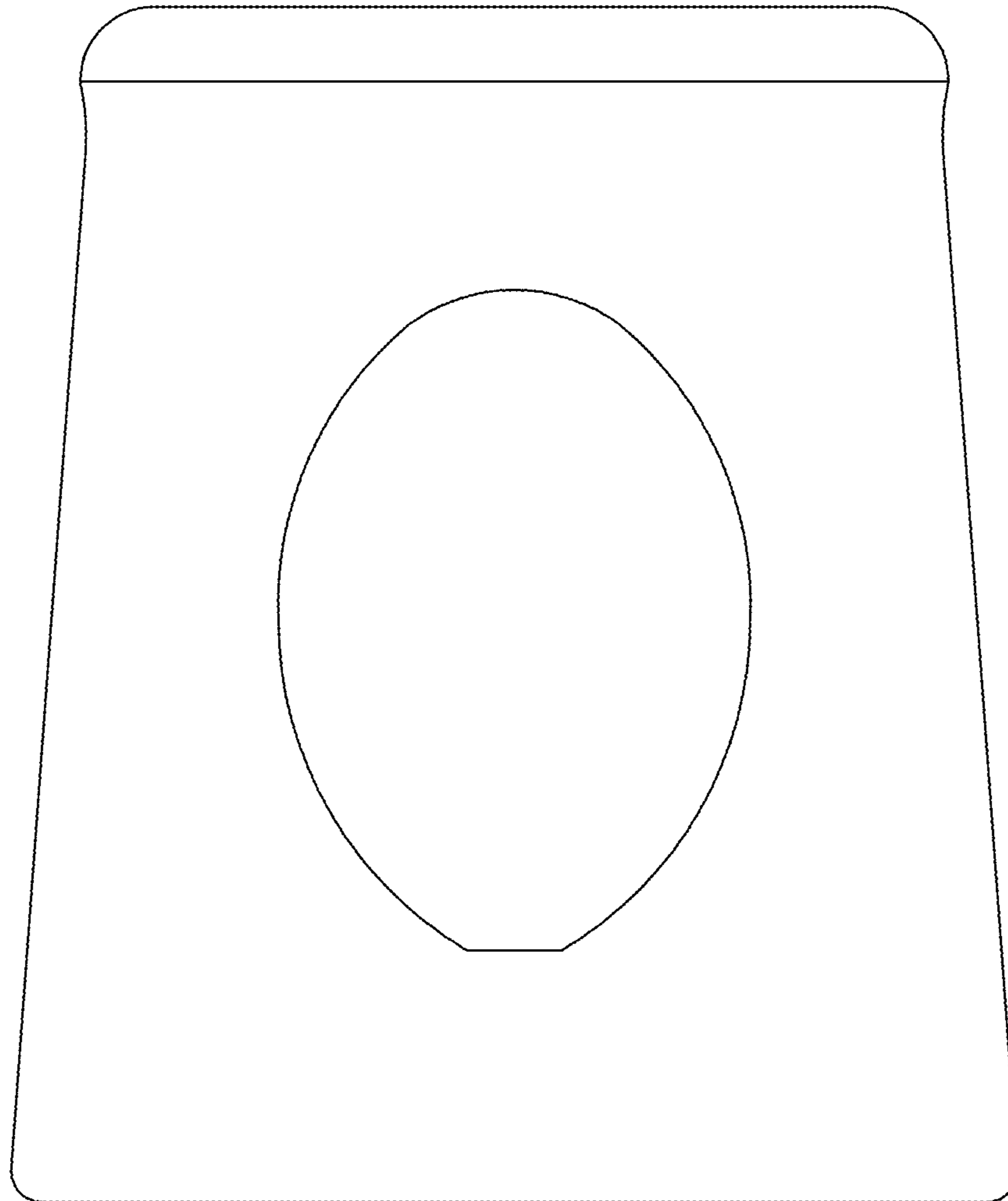

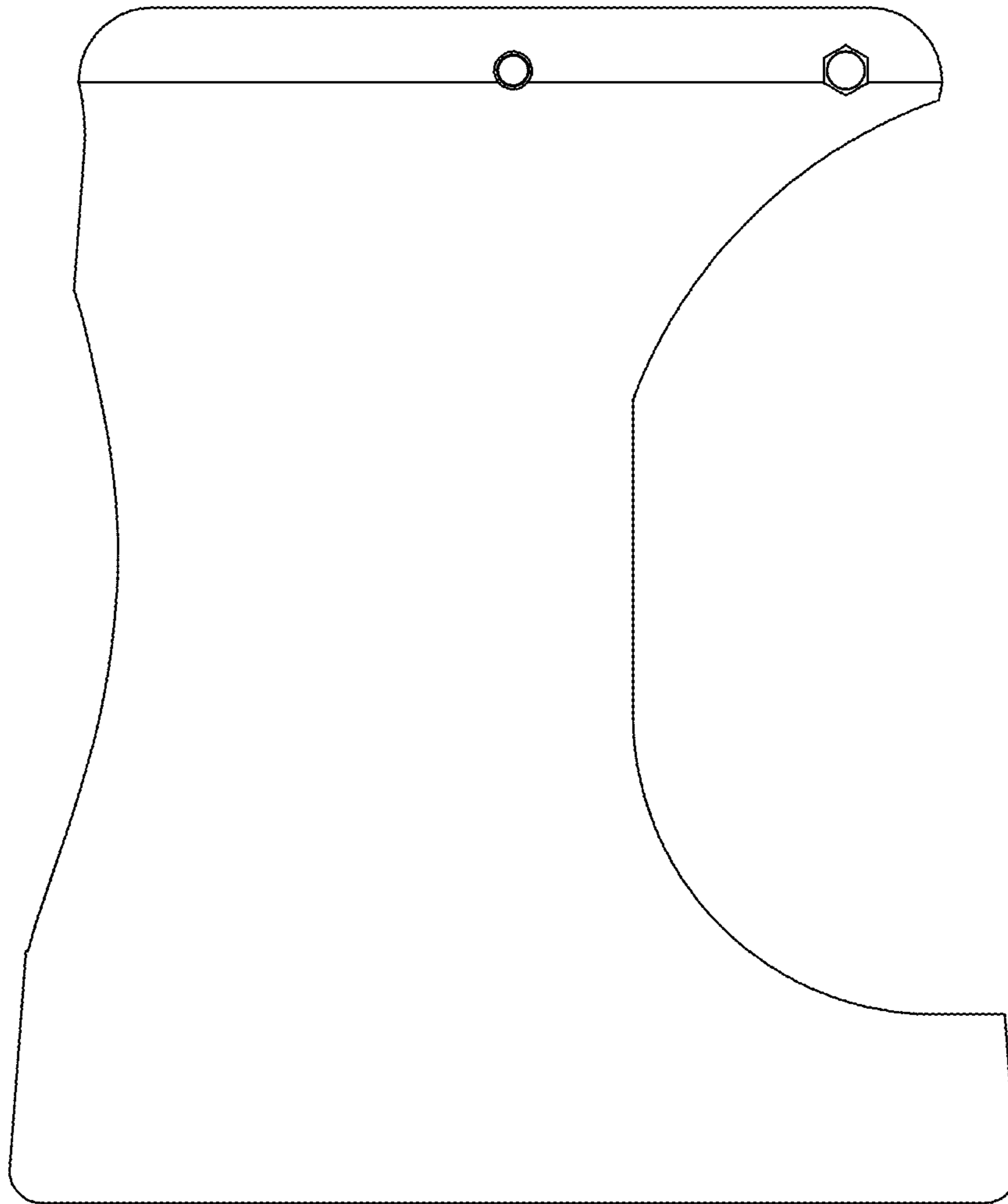

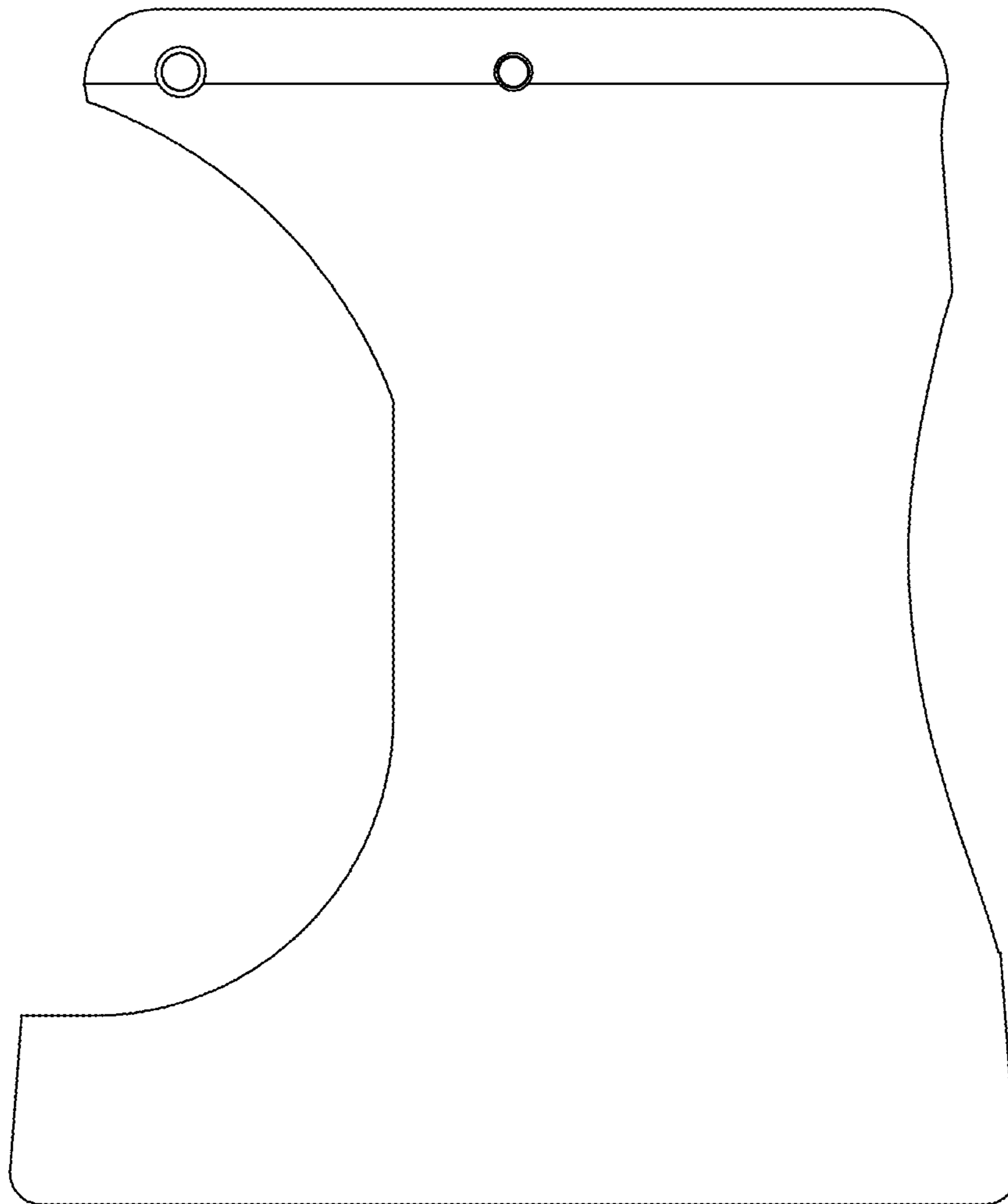

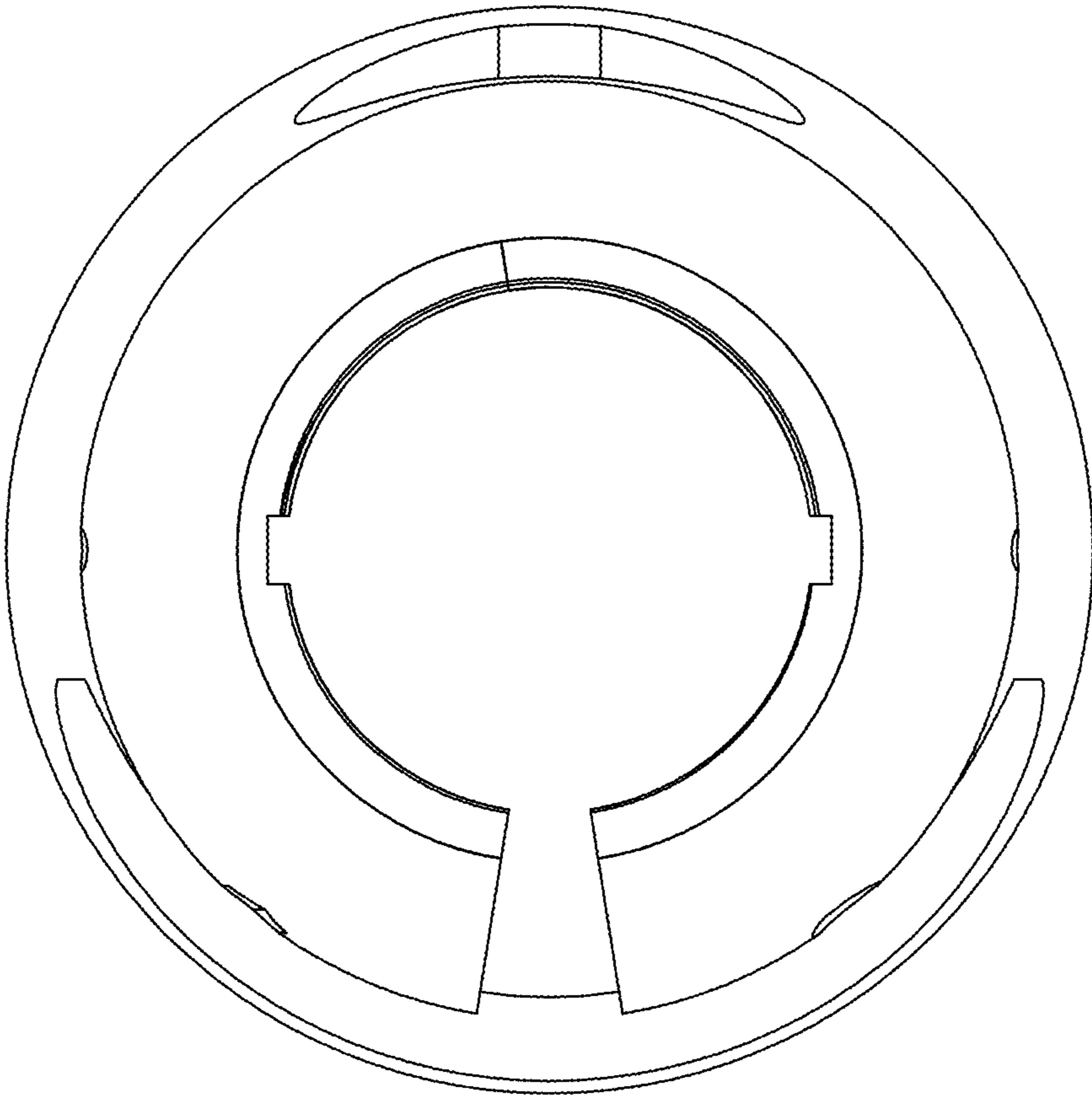

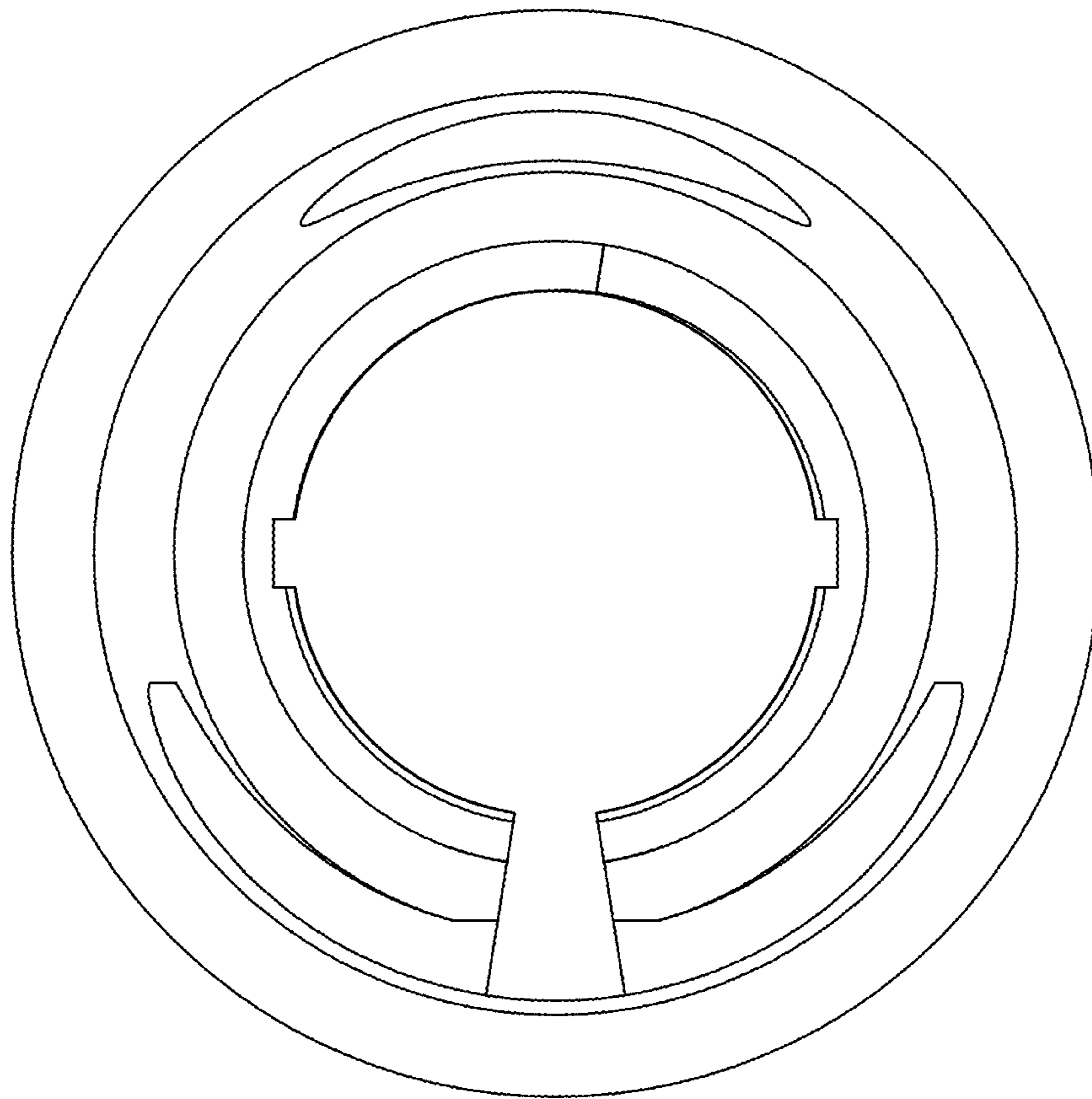
