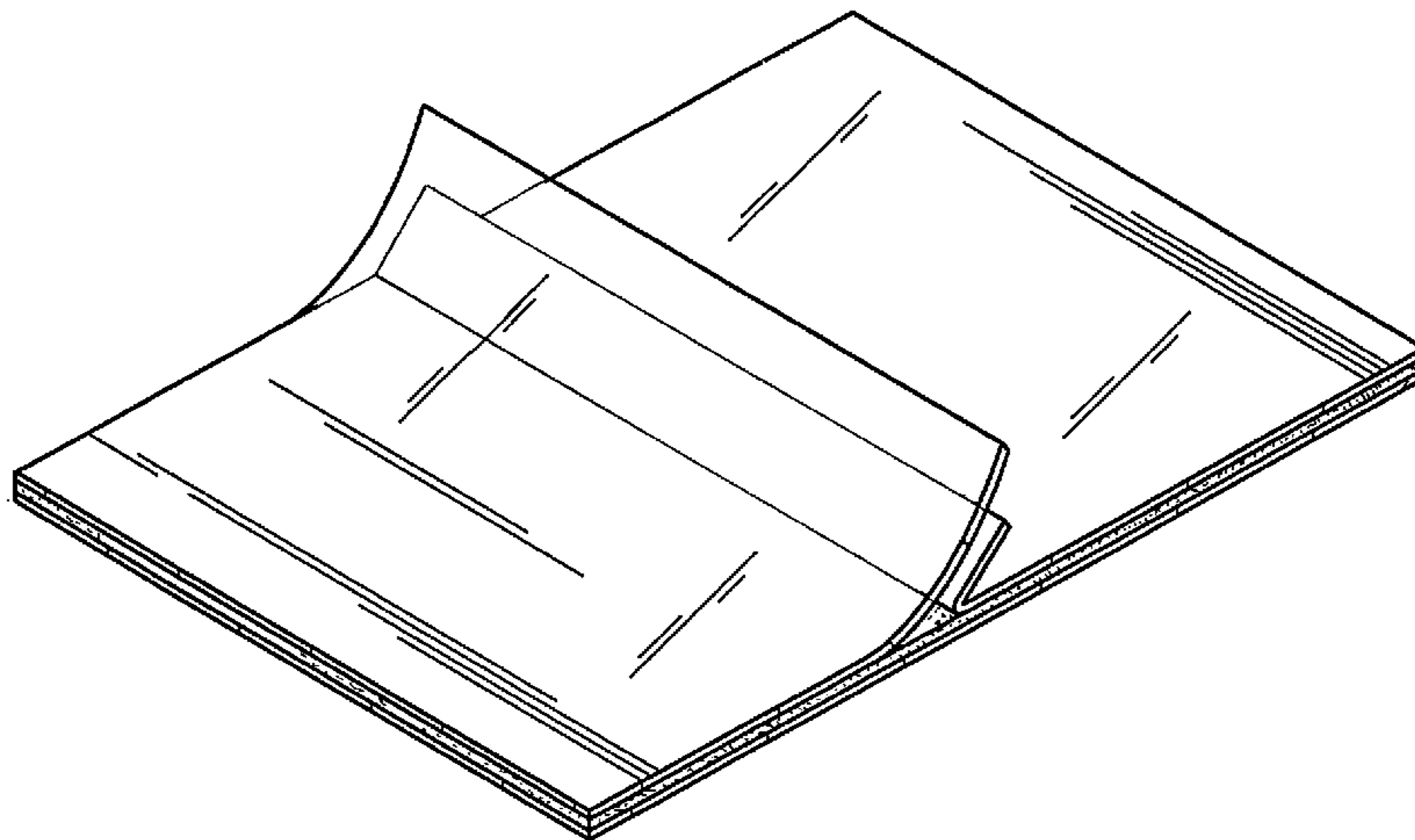

DESCRIPTION

FIG. 1 is a front view of an adhesive skin patch according to the design;
FIG. 2 is a rear view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is an enlarged cross-sectional view thereof, taken along line 7-7 shown in FIG. 1;
FIG. 8 is an enlarged cross-sectional view thereof, taken along line 7-7 shown in FIG. 1, the layers shown partially lifted for ease of illustration; and,
FIG. 9 is a perspective view thereof.

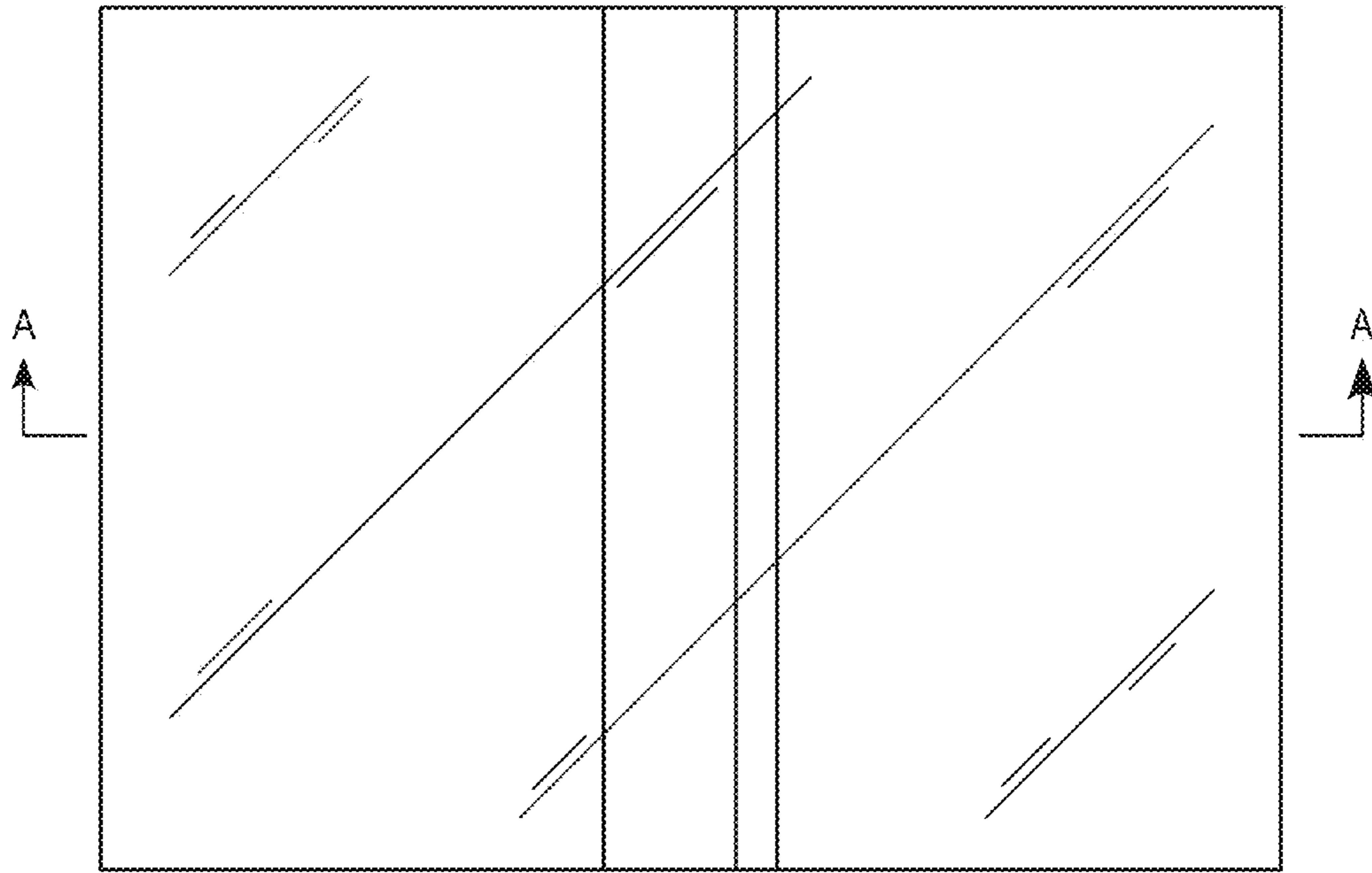

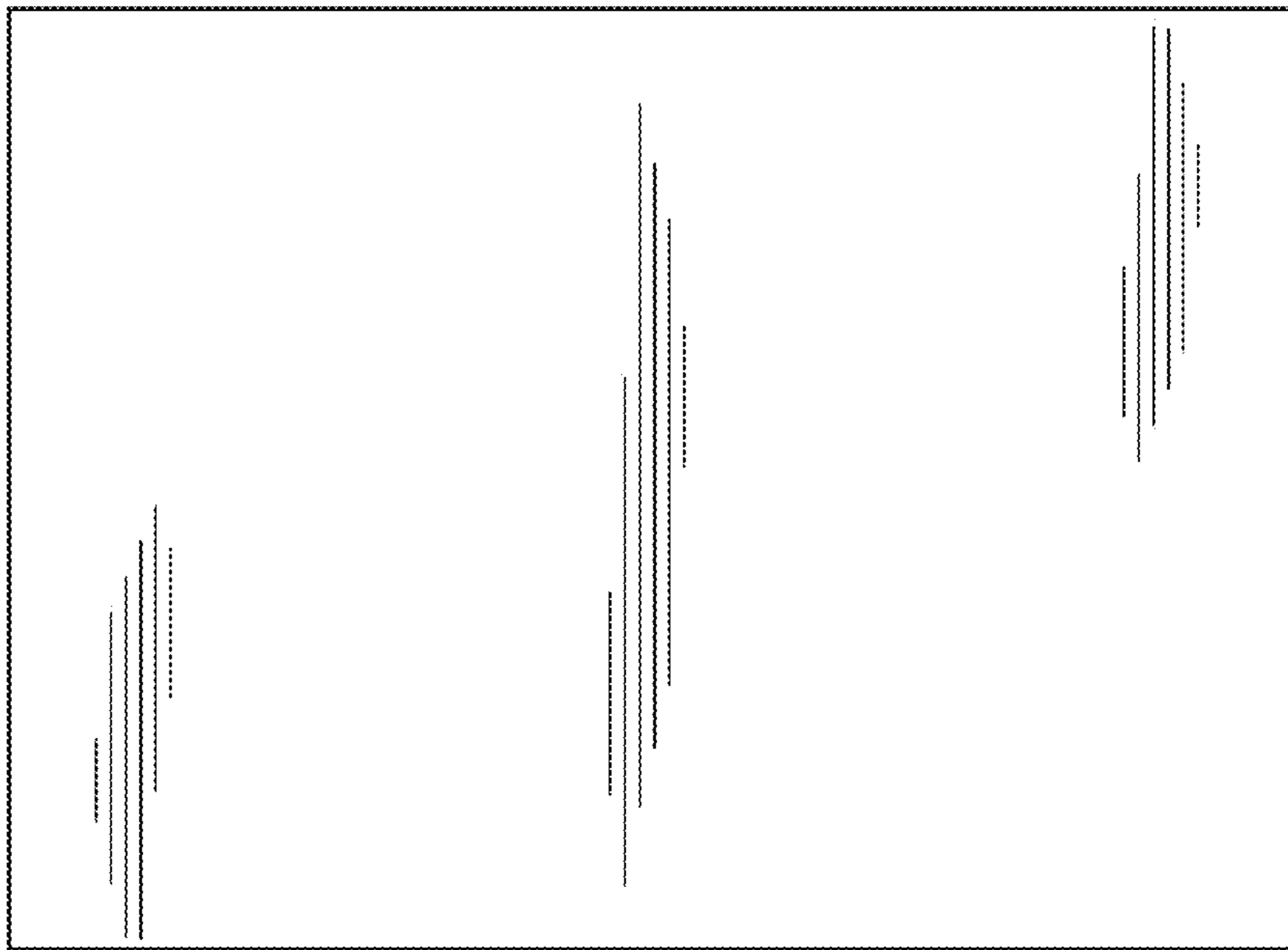

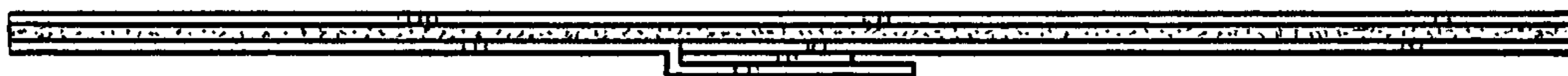

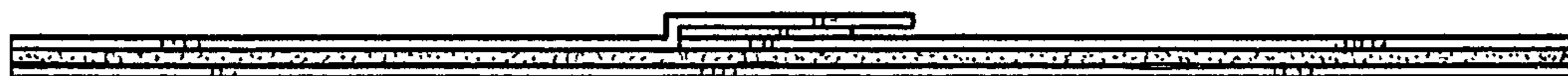

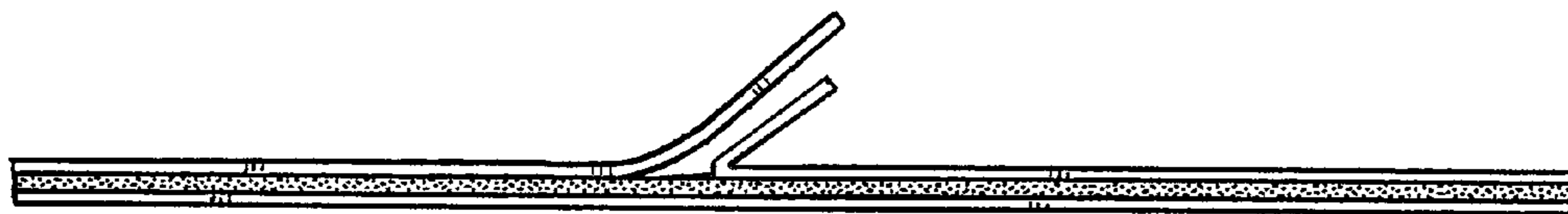

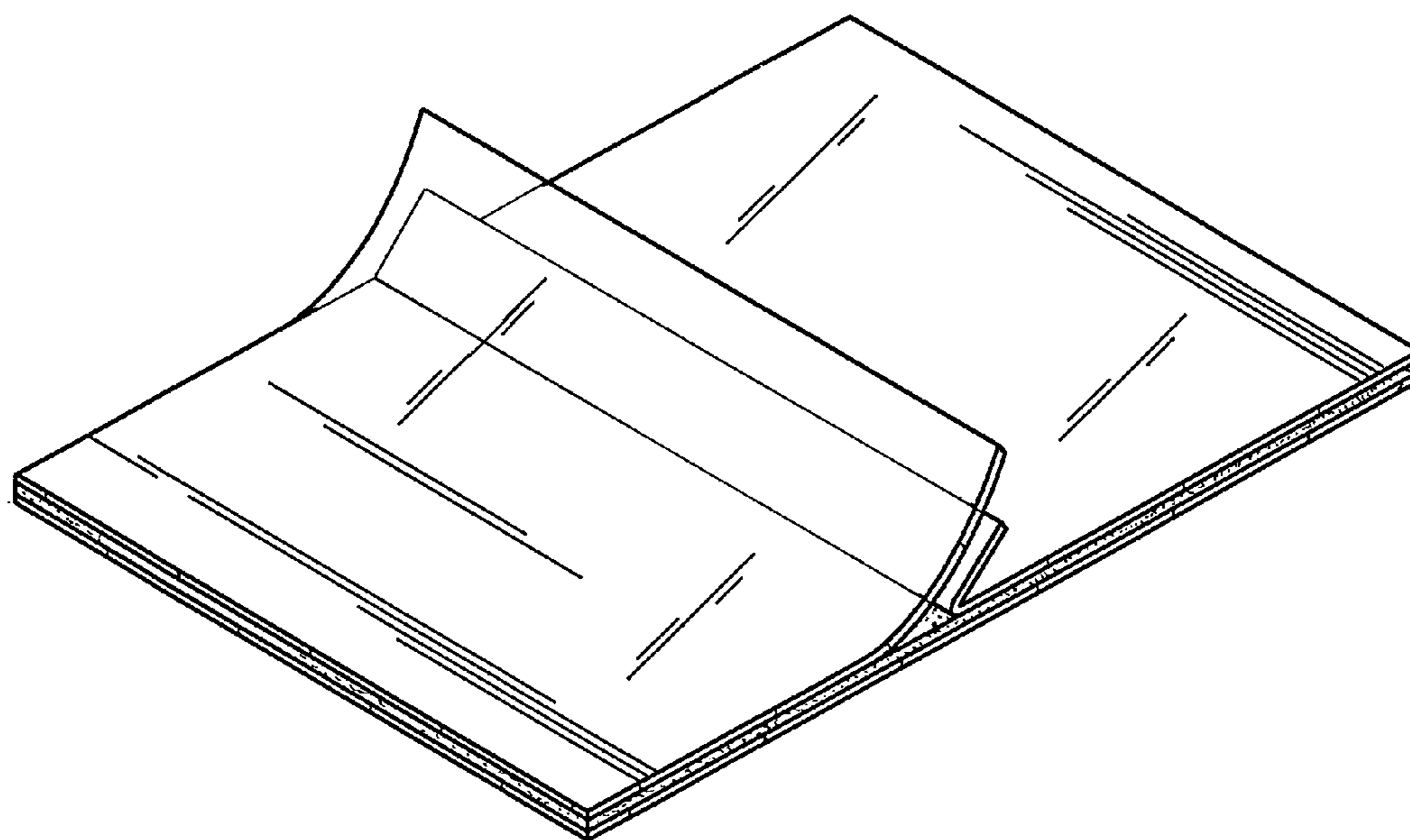
