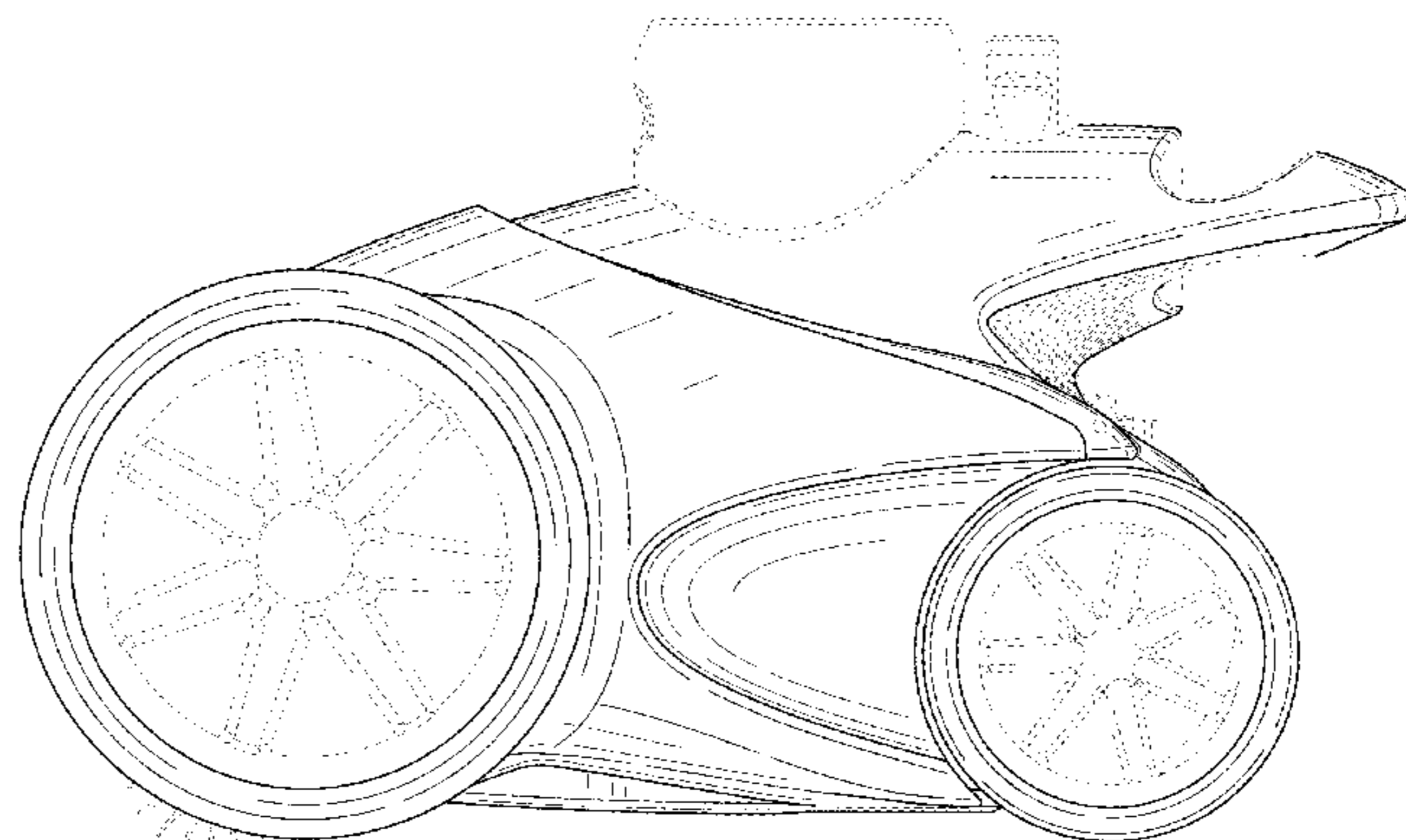
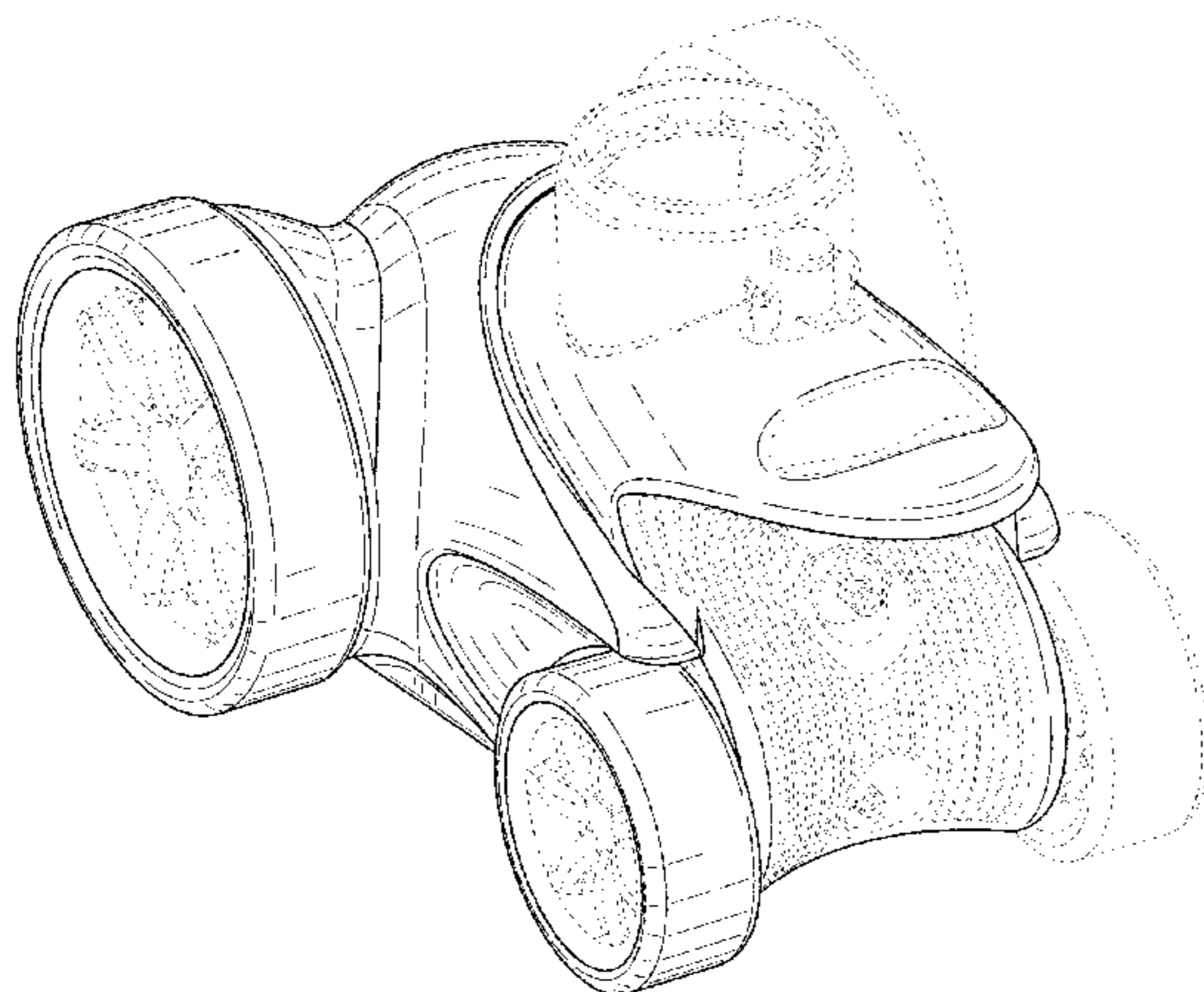
(57) **CLAIM**

The ornamental design for a pool cleaner, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a rear, top, and left side of an ornamental design for a pool cleaner;  
FIG. 2 is a rear elevational view of the pool cleaner of FIG. 1;  
FIG. 3 is a front elevational view of the pool cleaner of FIG. 1;  
FIG. 4 is a right side elevational view of the pool cleaner of FIG. 1;  
FIG. 5 is a left side elevational view of the pool cleaner of FIG. 1;  
FIG. 6 is a top plan view of the pool cleaner of FIG. 1; and  
FIG. 7 is a bottom plan view of the pool cleaner of FIG. 1.

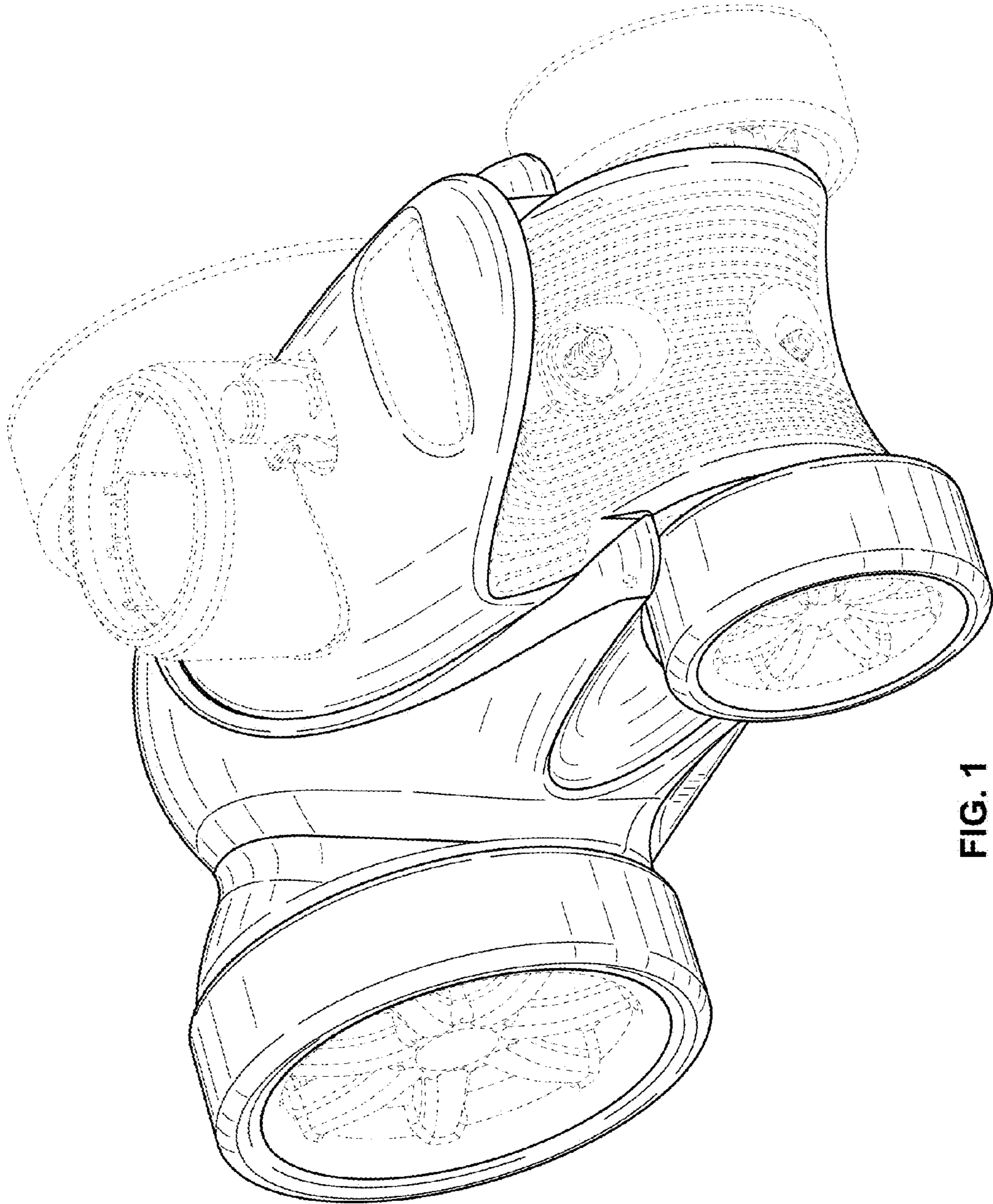

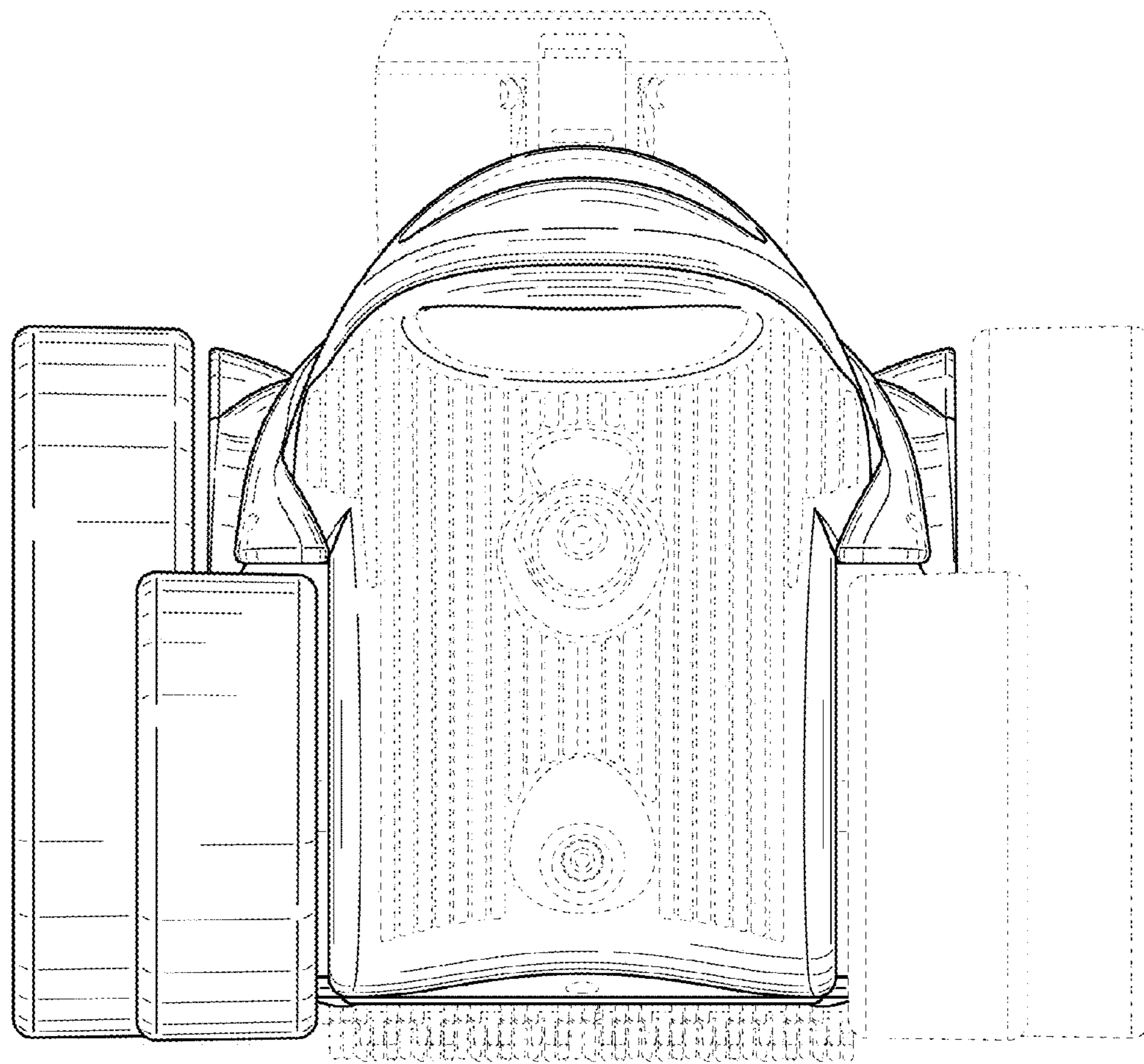

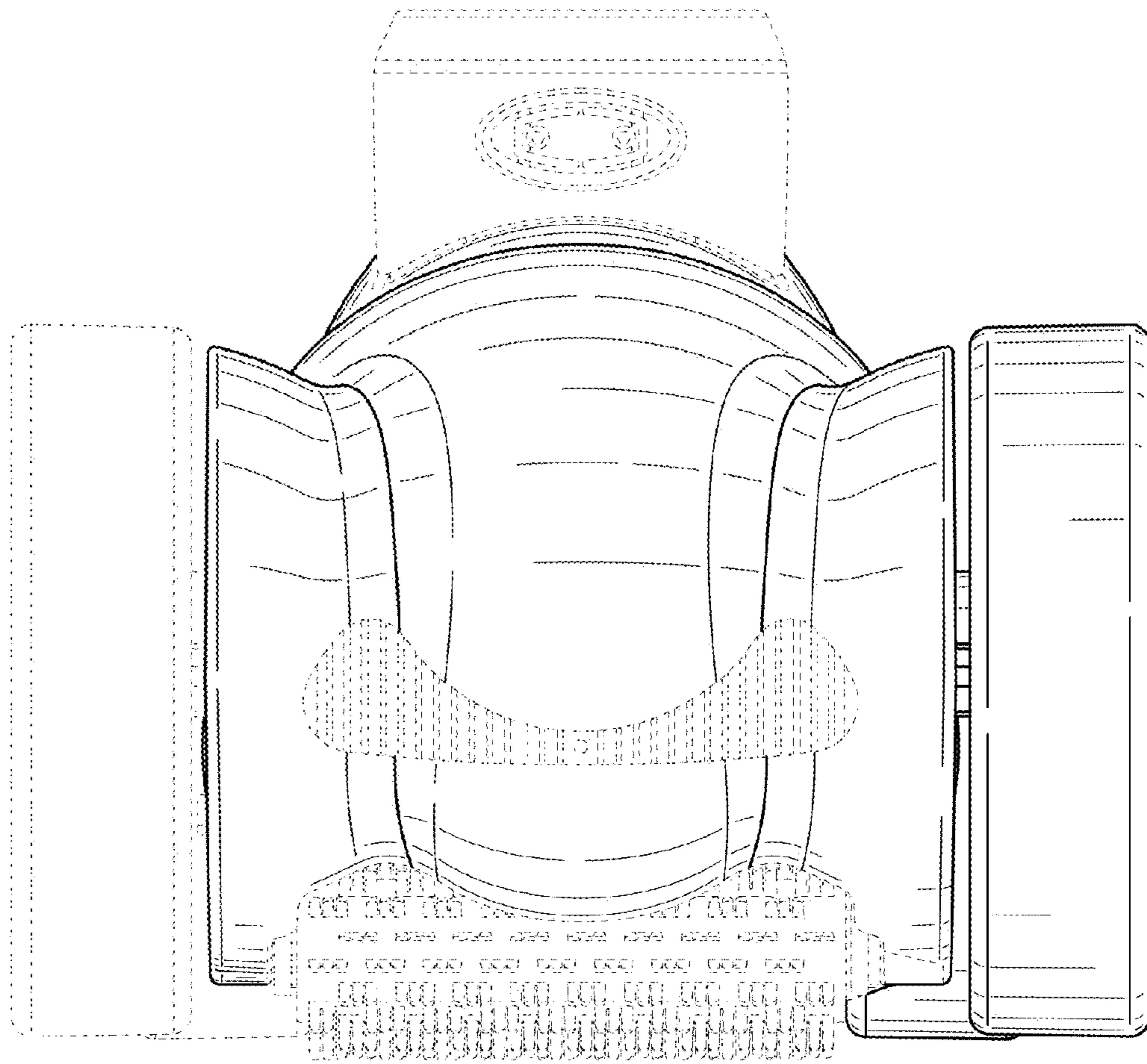

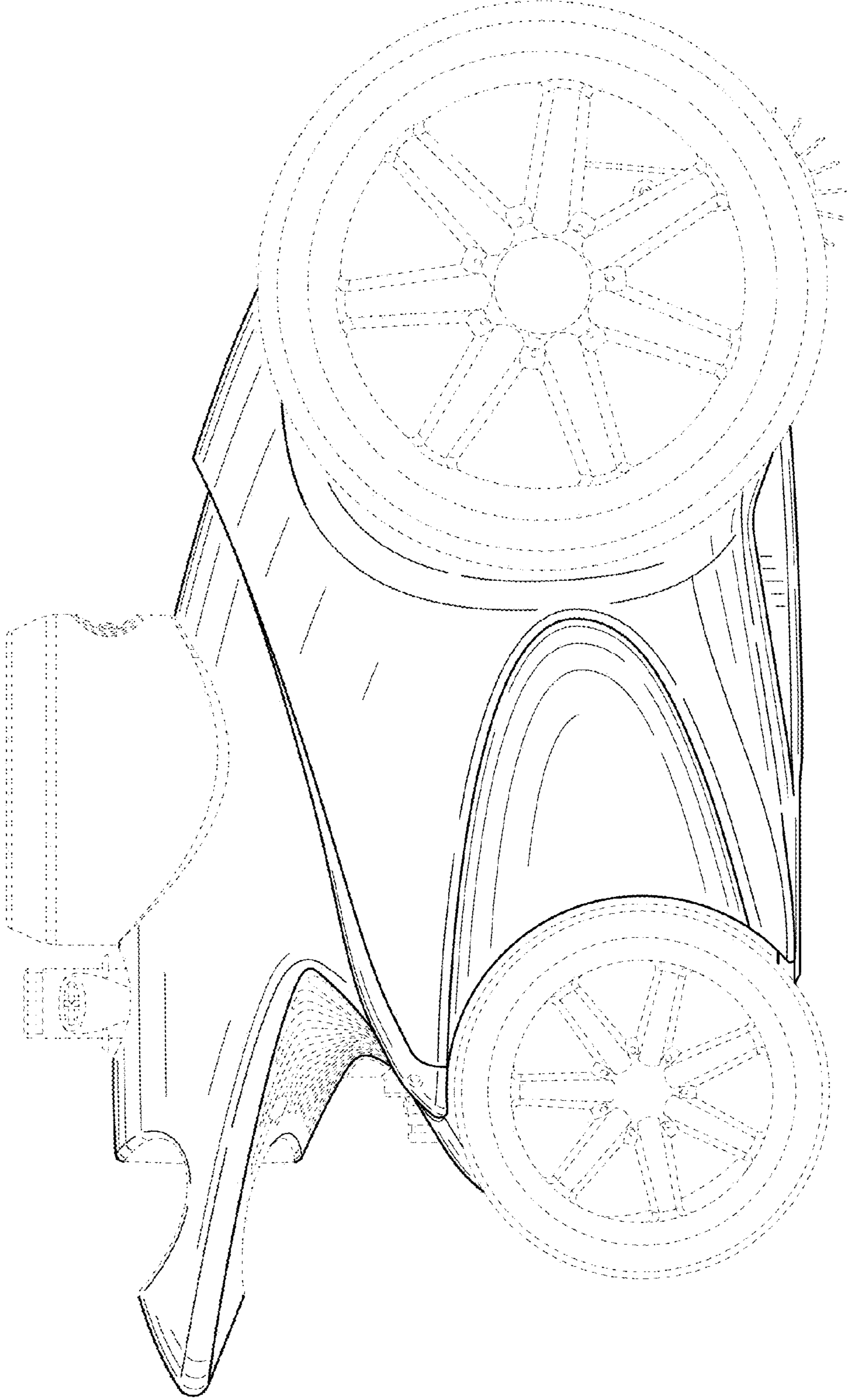

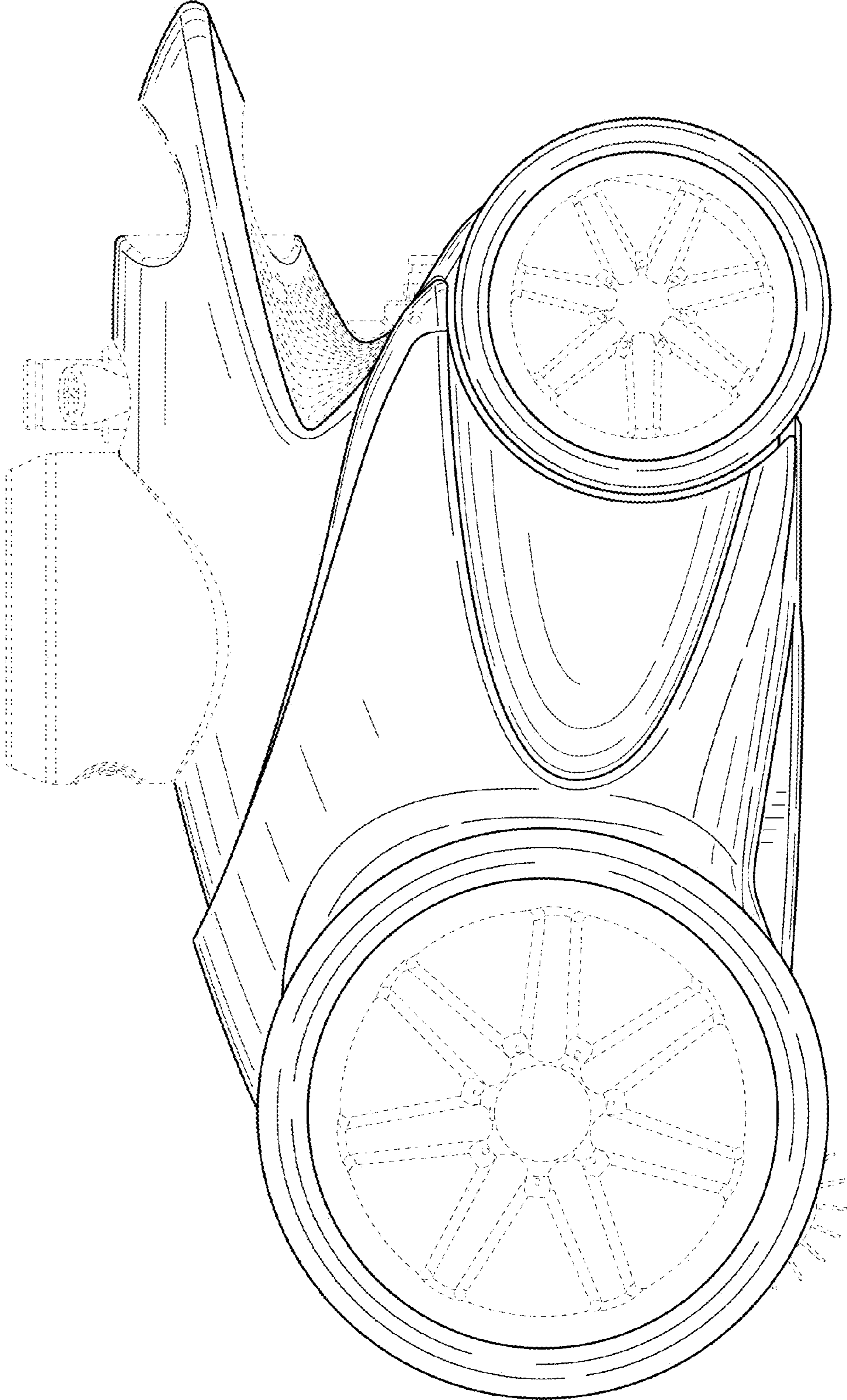

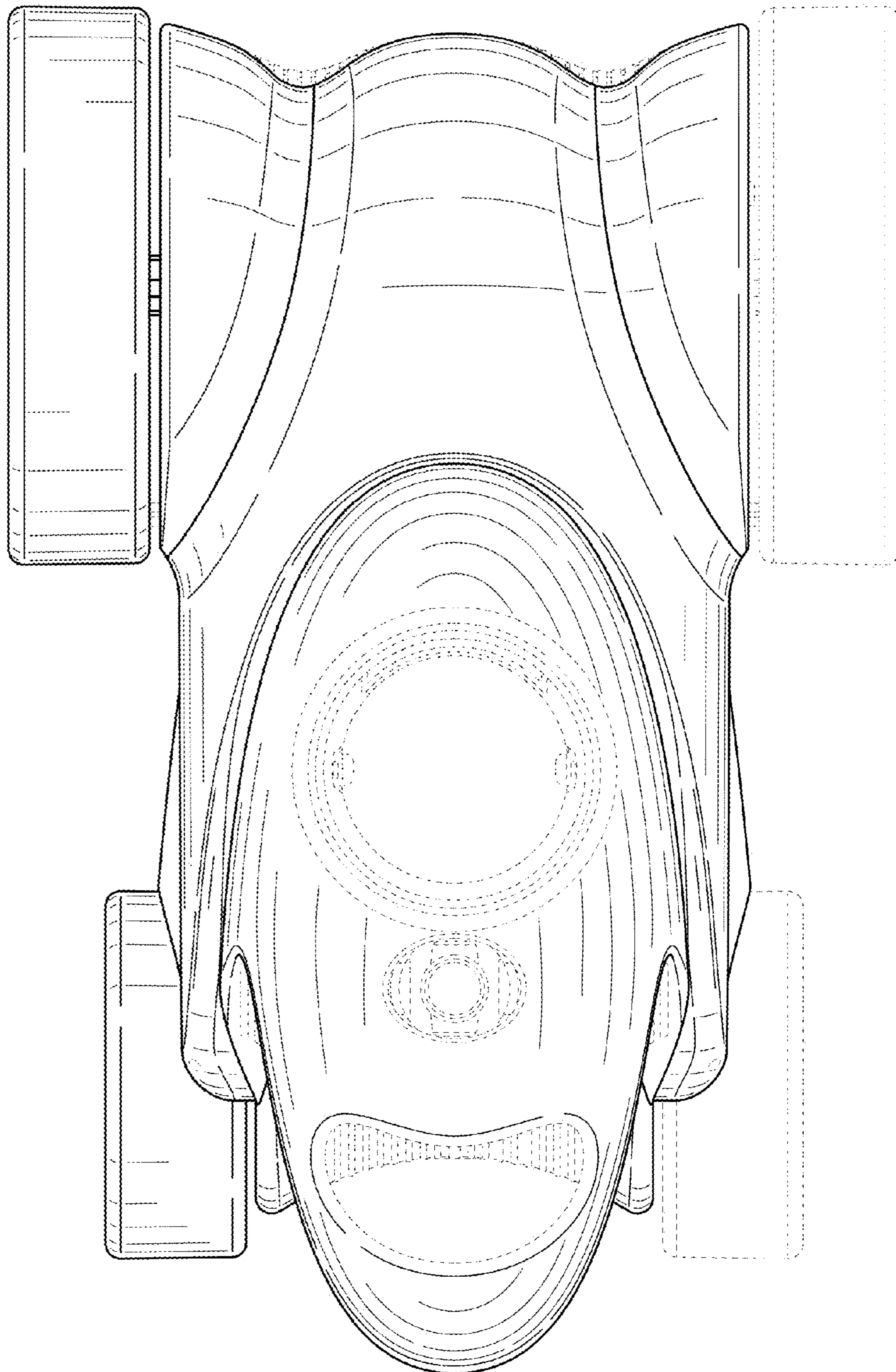

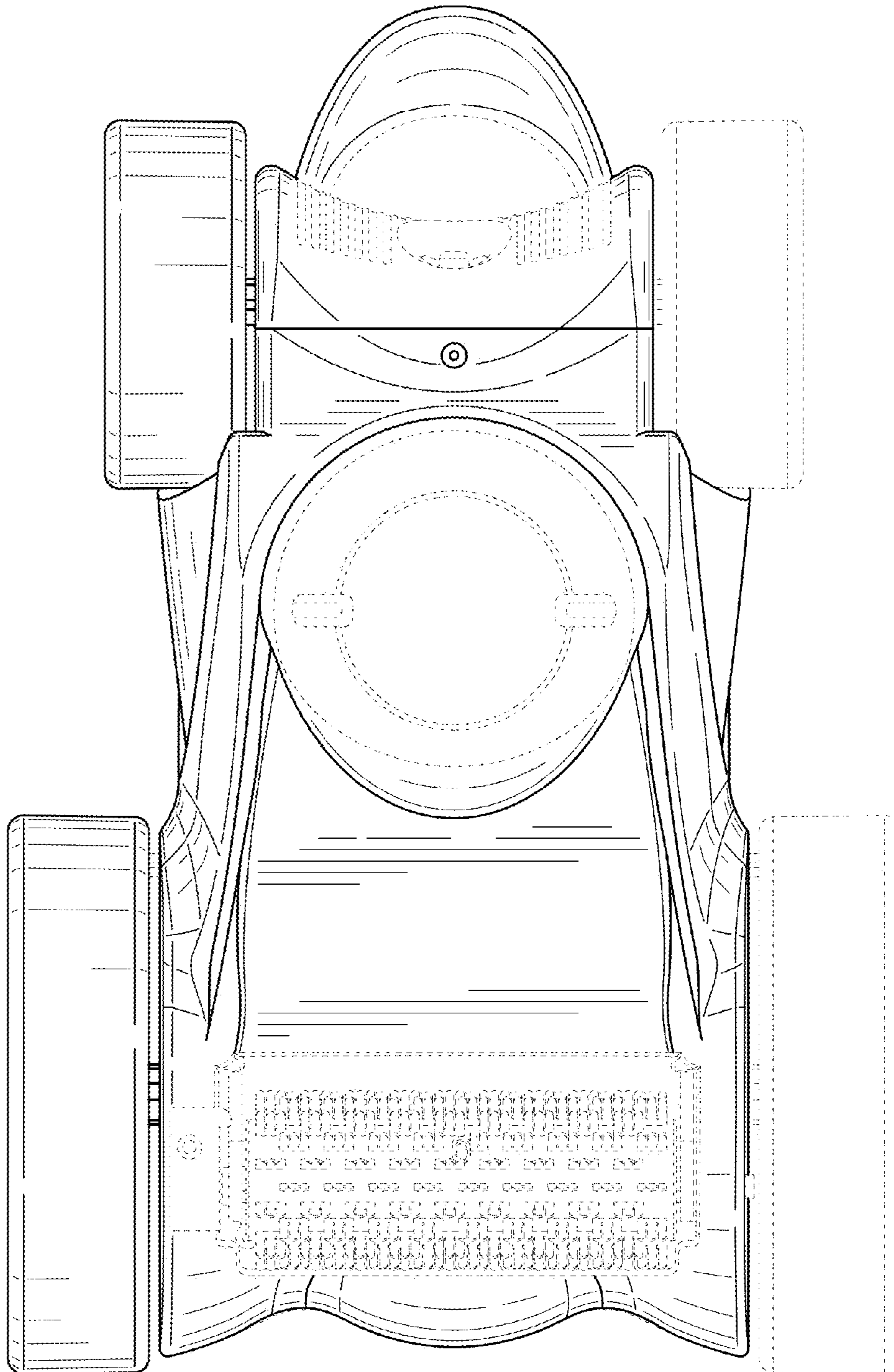
