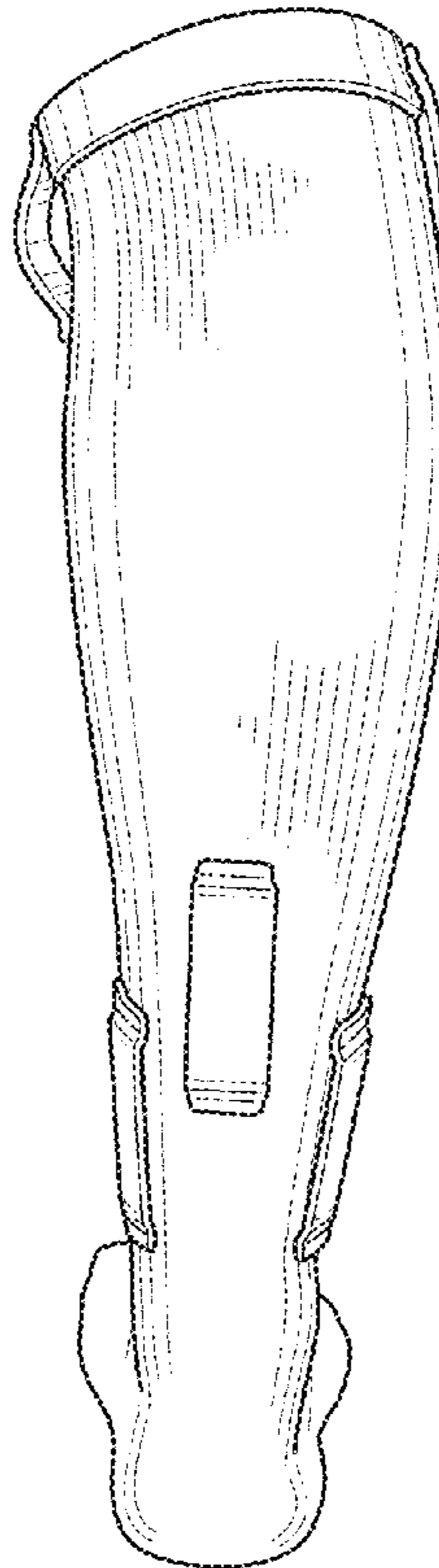
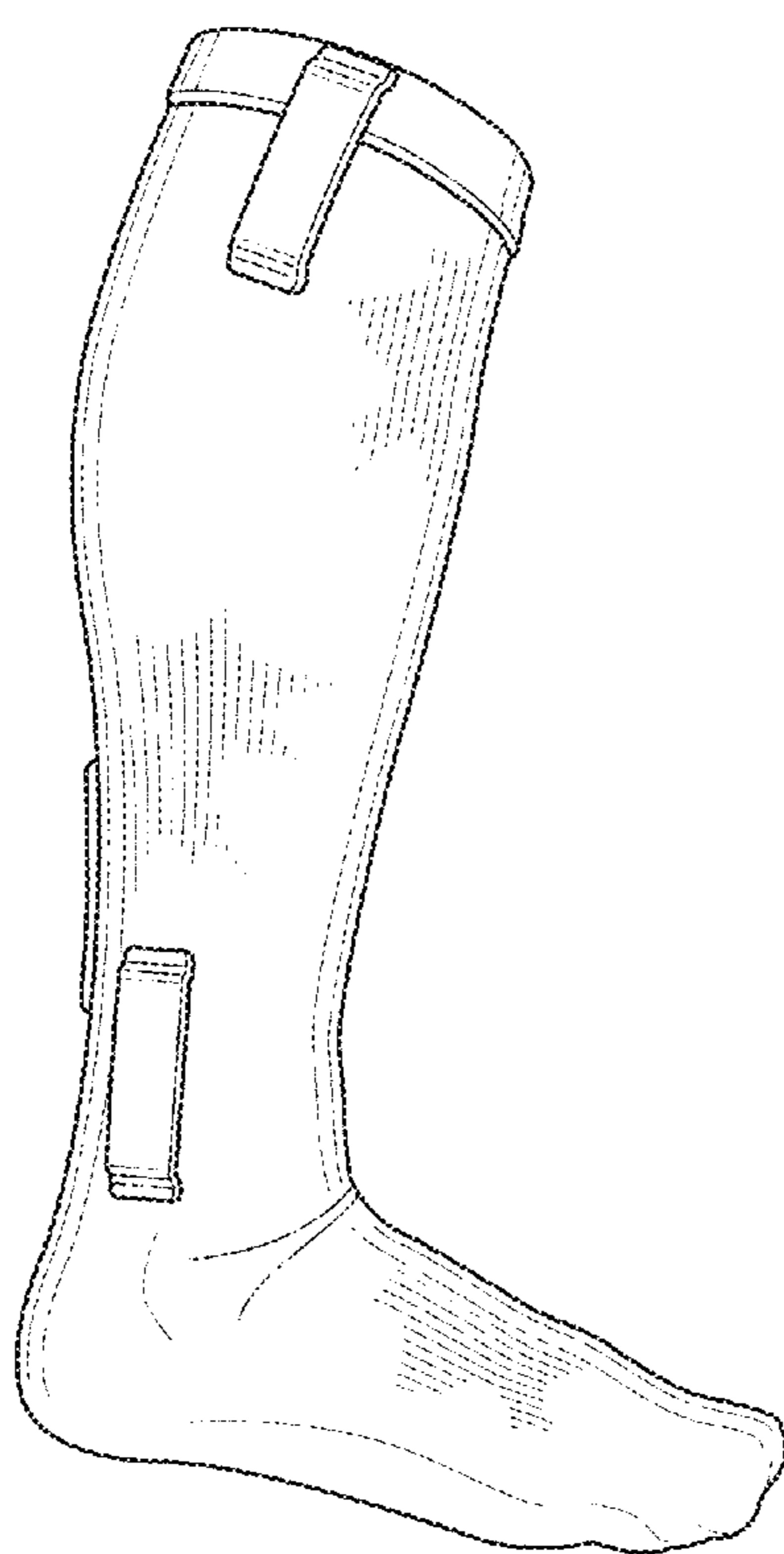
FIG. 1 shows a first side view of a compression sock with finger holds of the present invention.

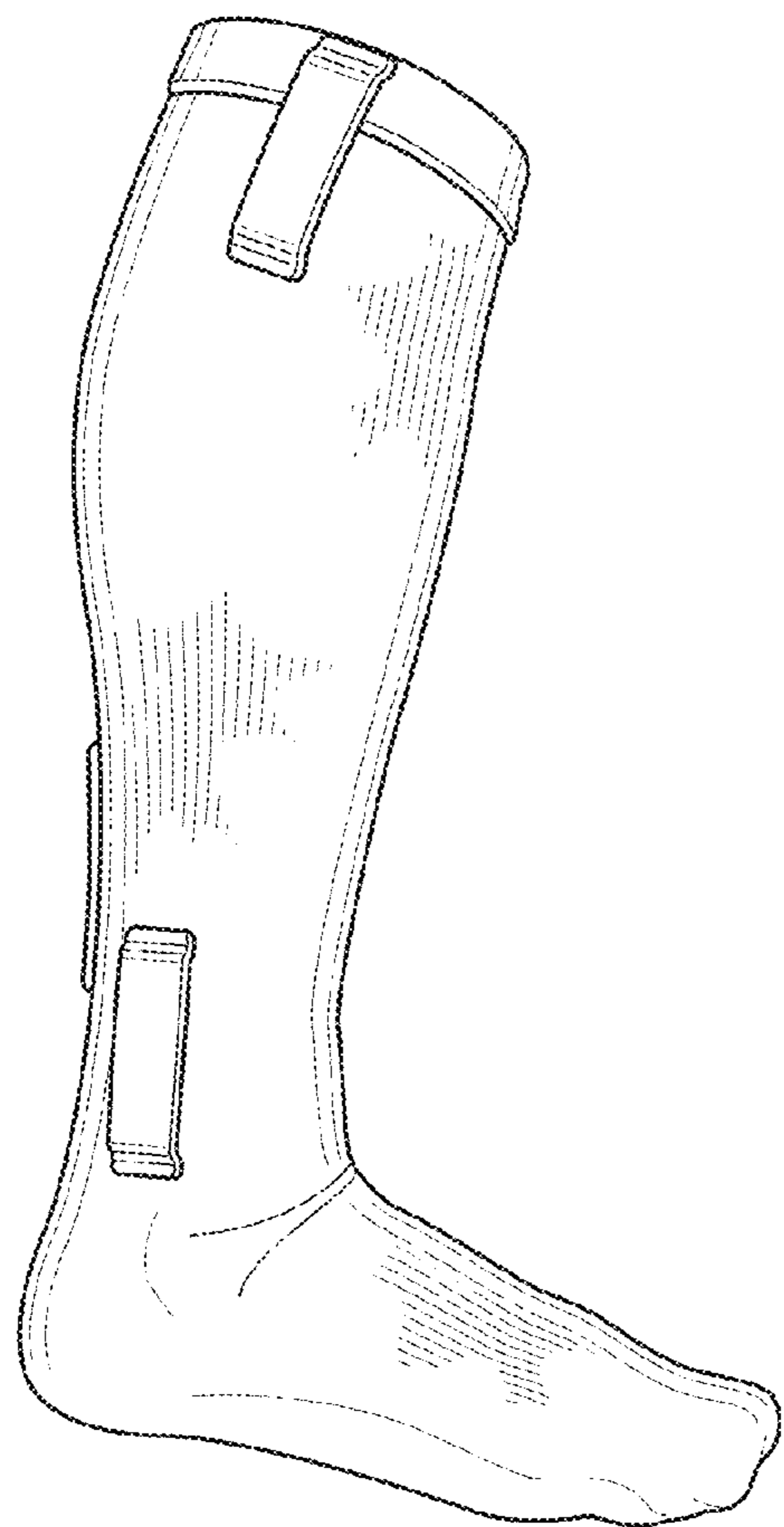

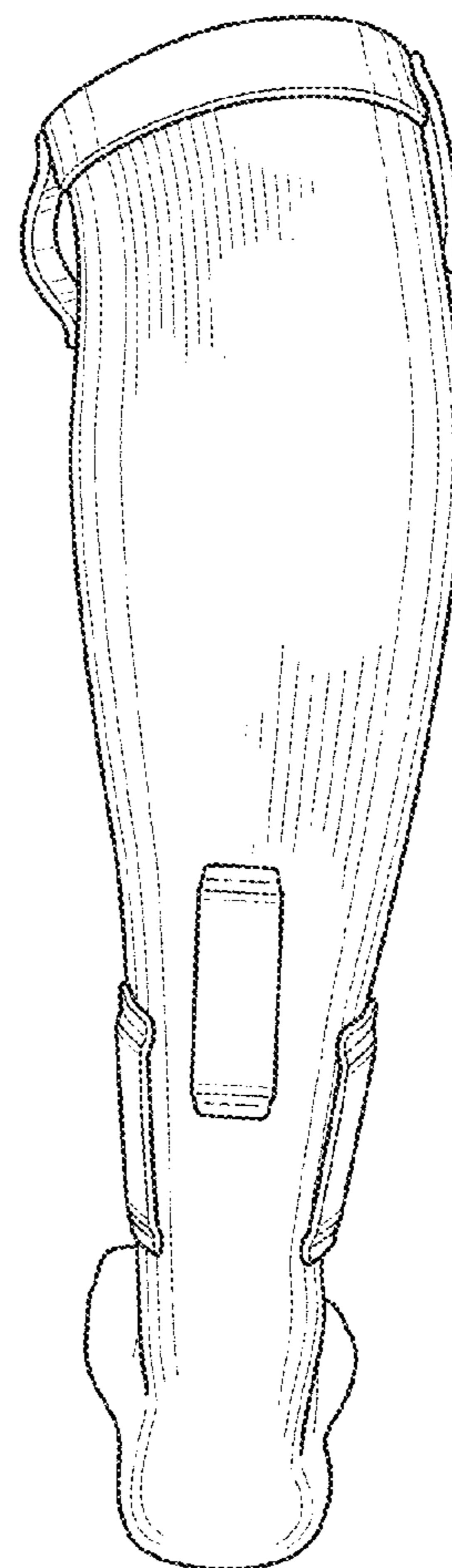

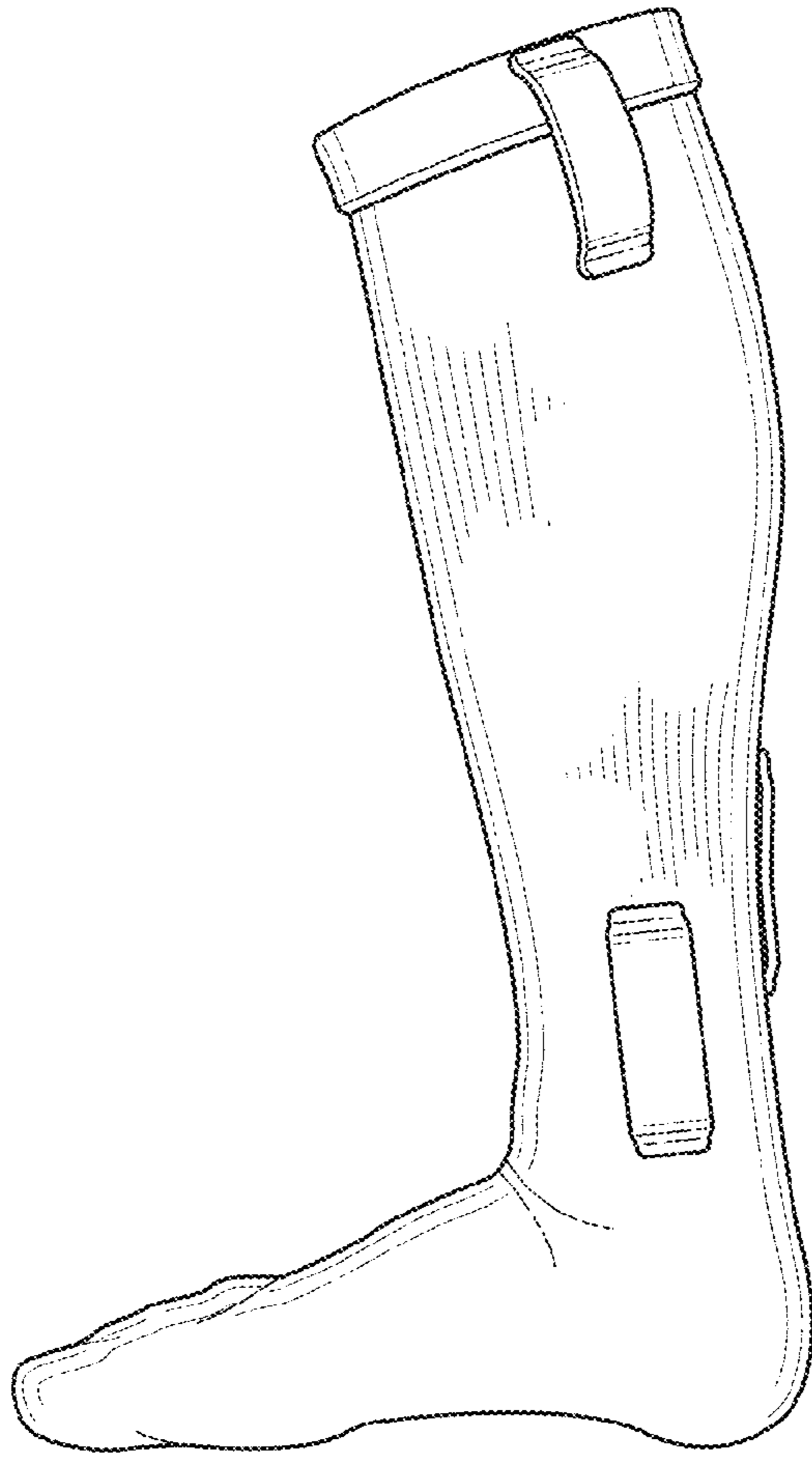

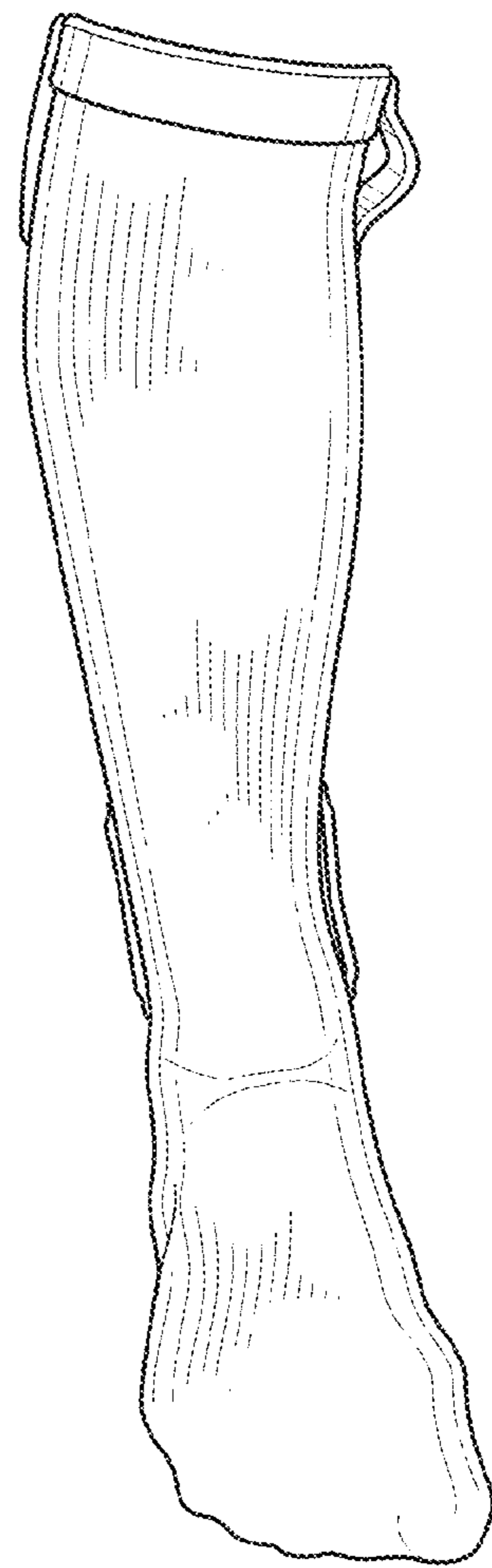
