DESCRIPTION

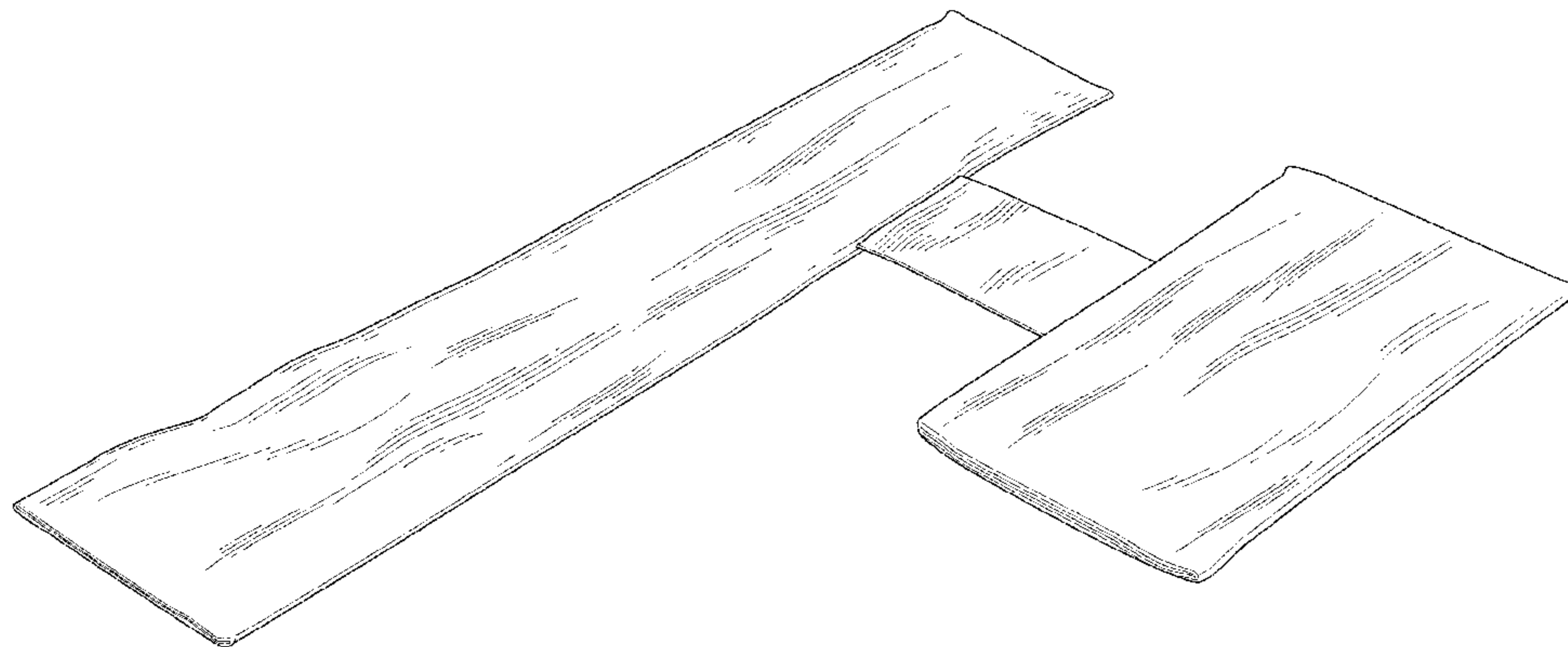
FIG. 1 is a perspective view of the pillowcase of the present invention;

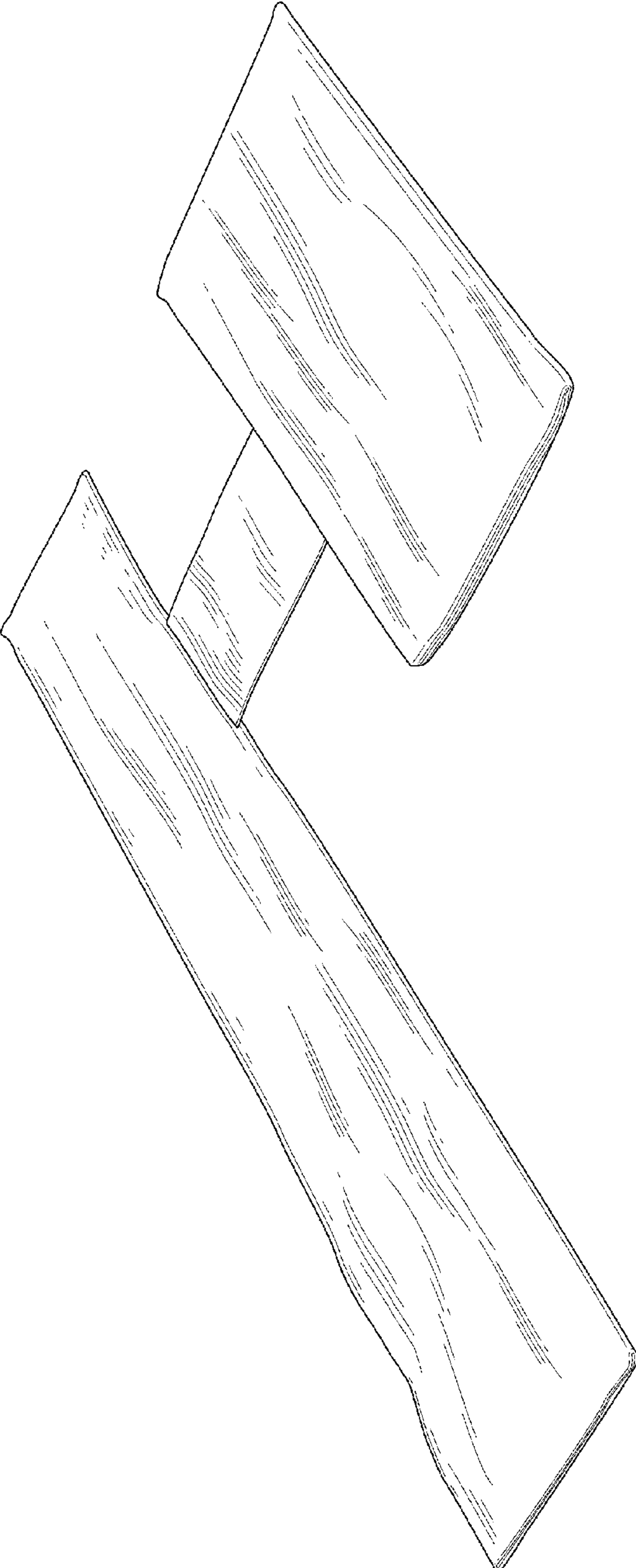

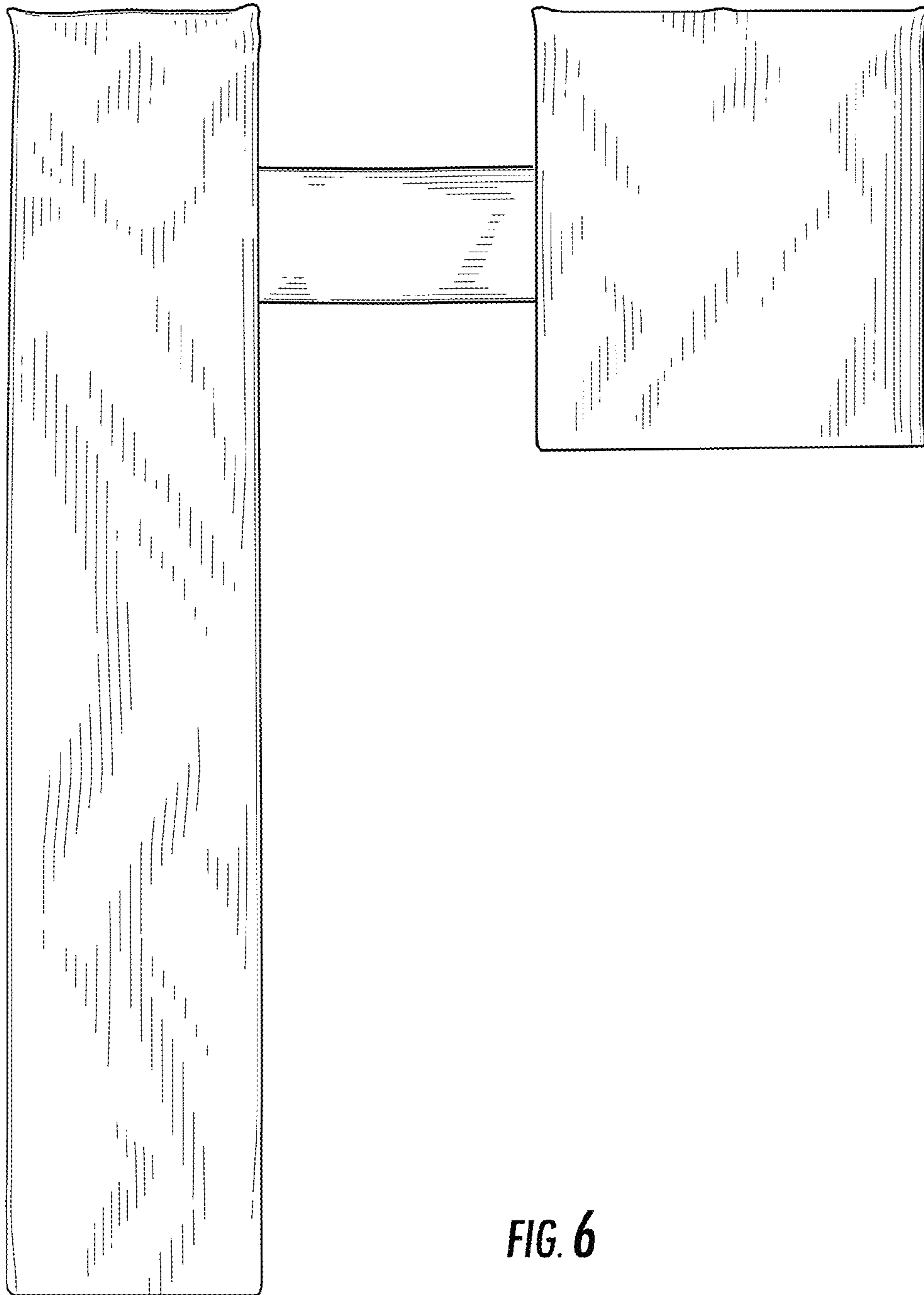

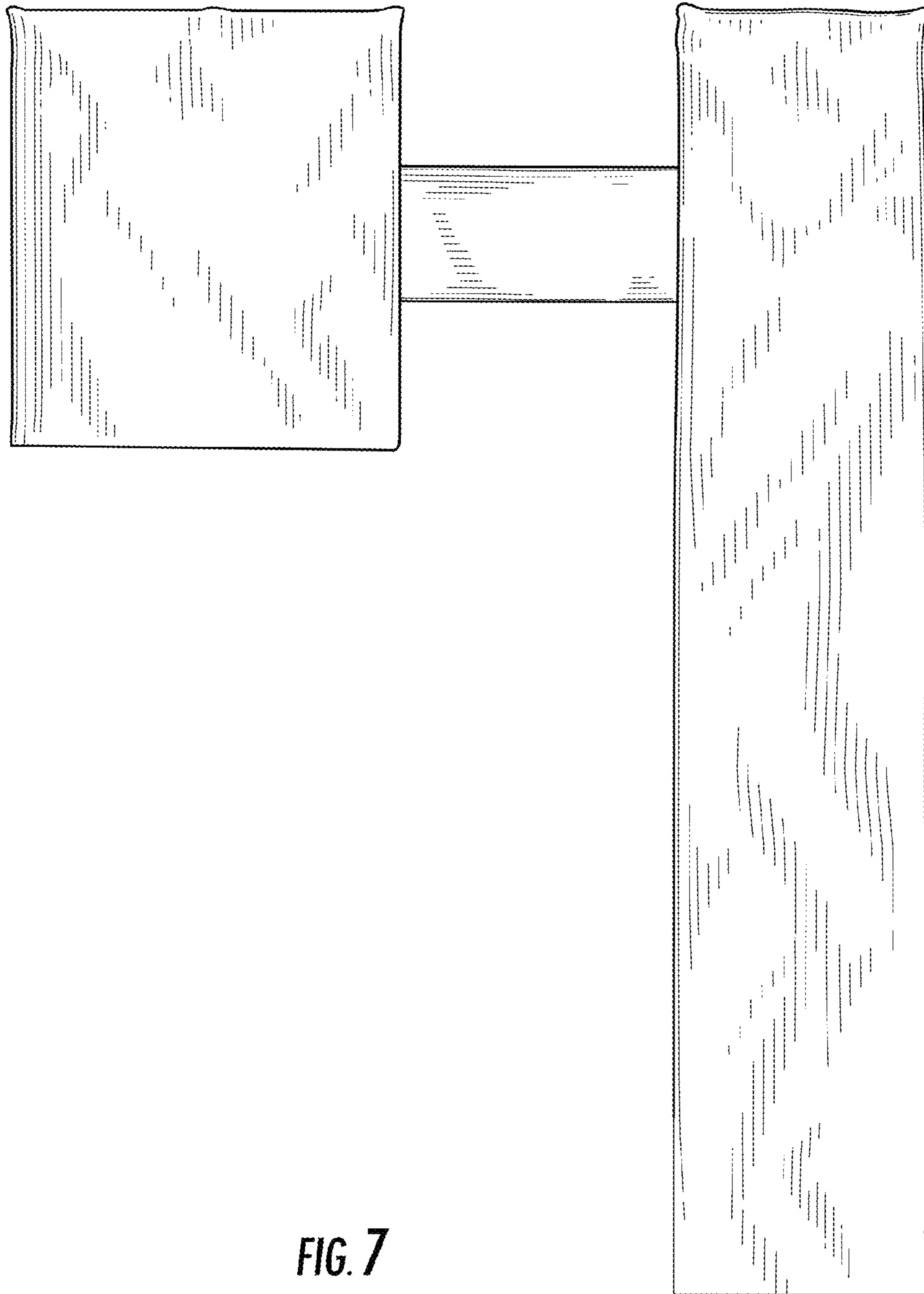

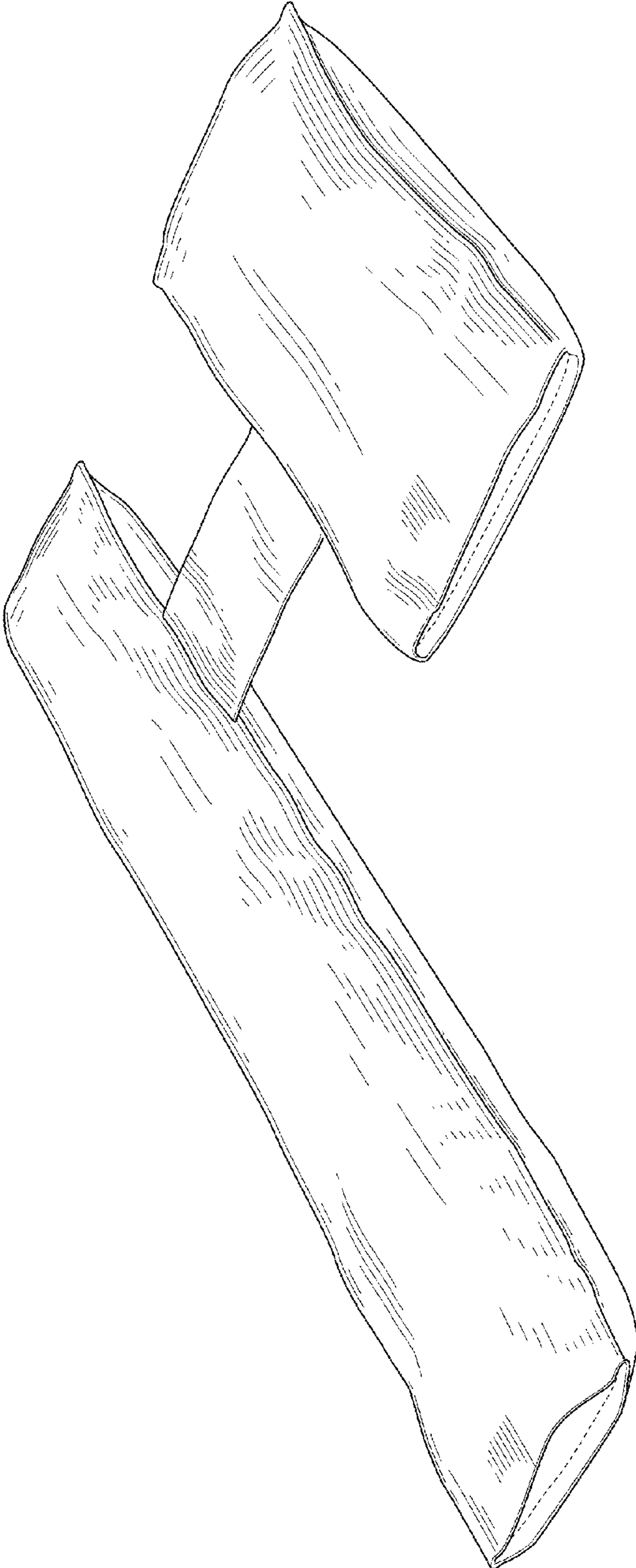

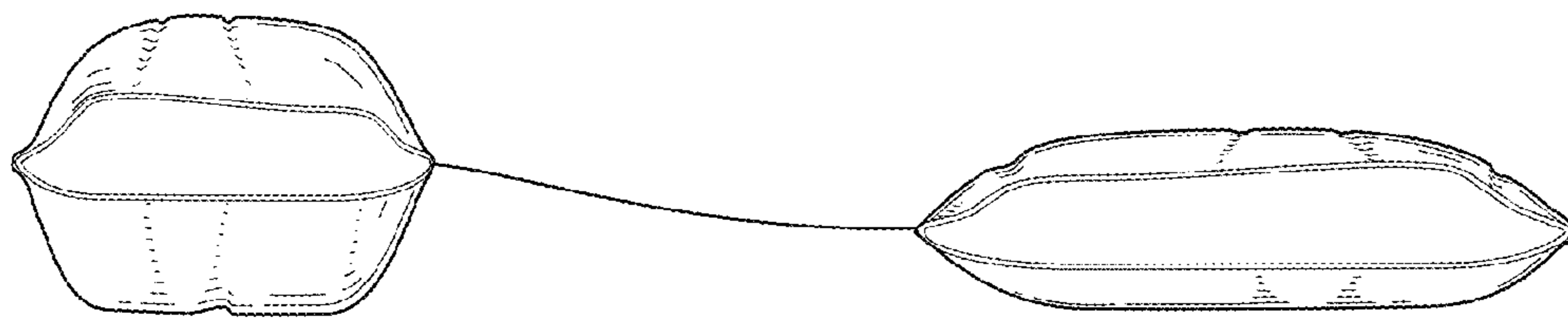

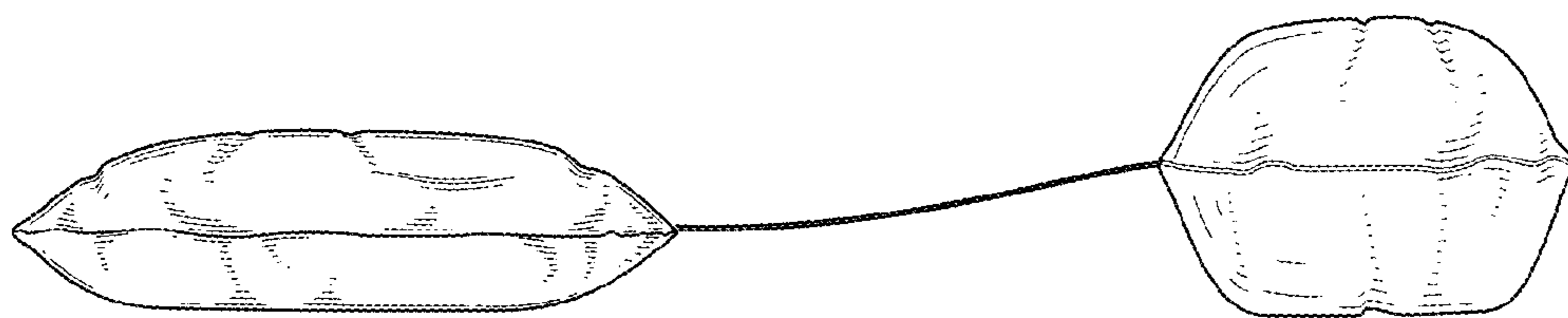

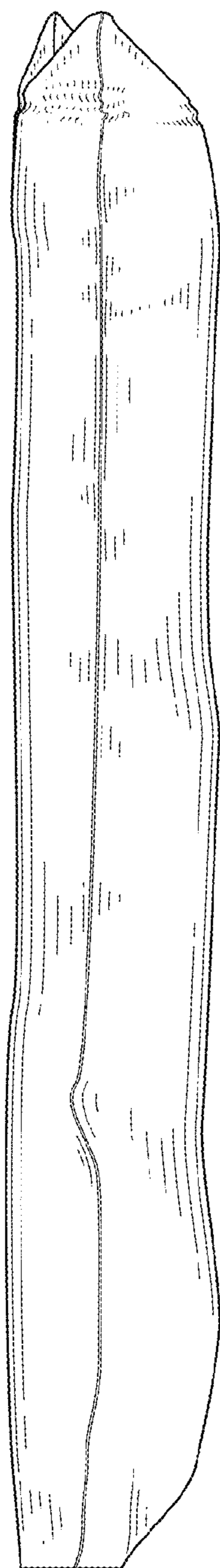

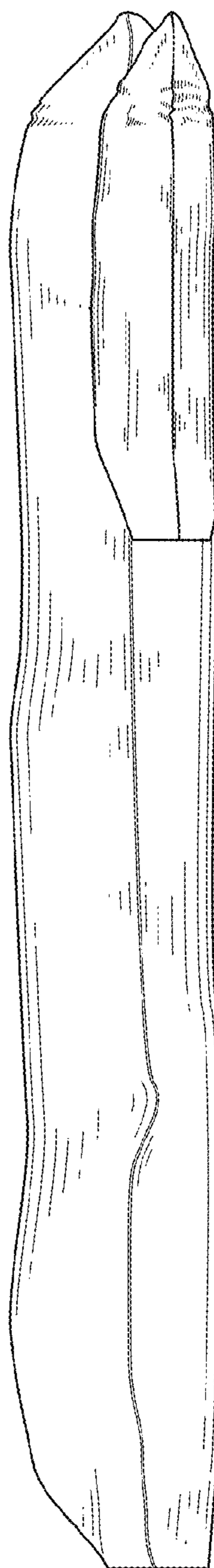

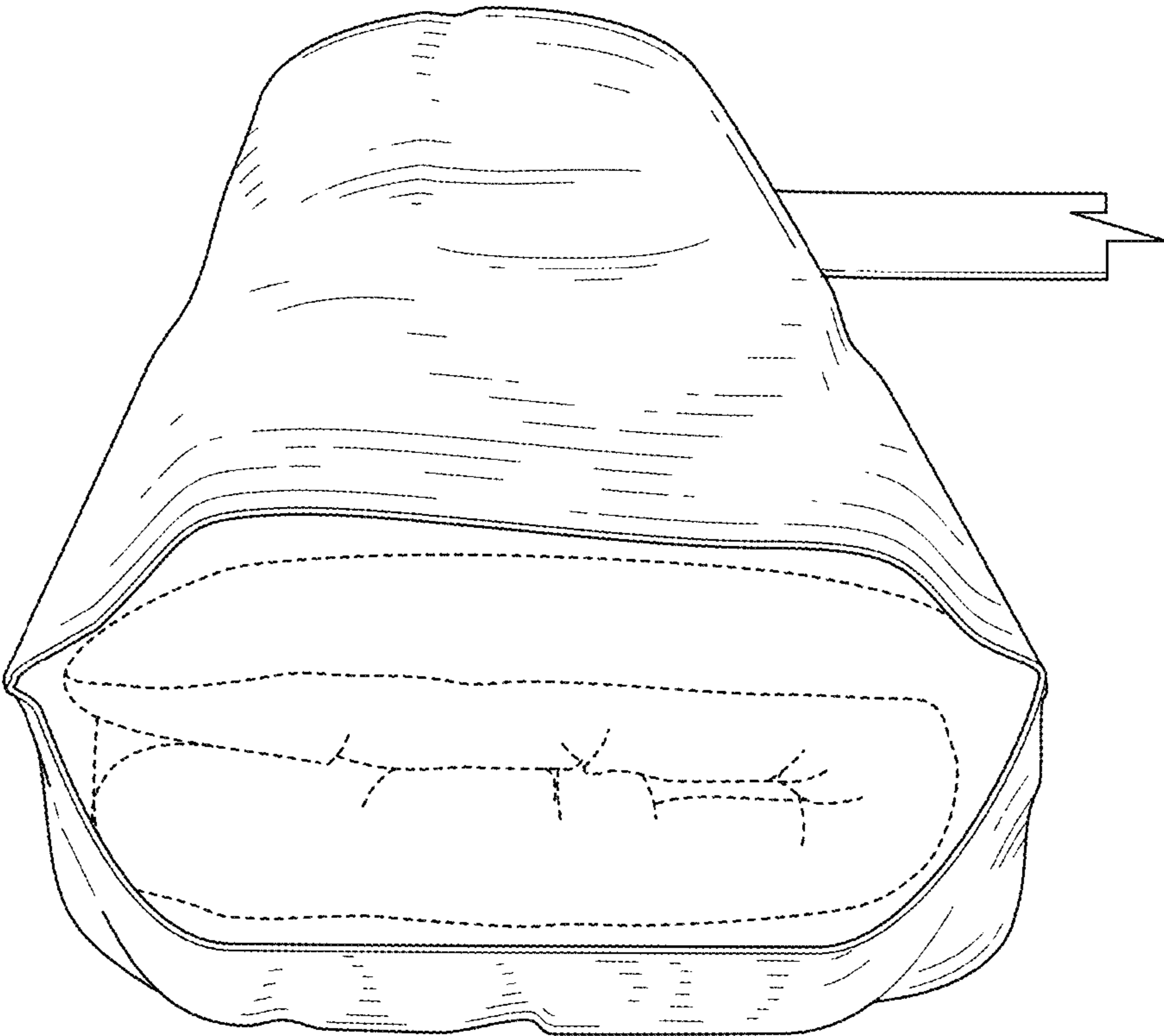
