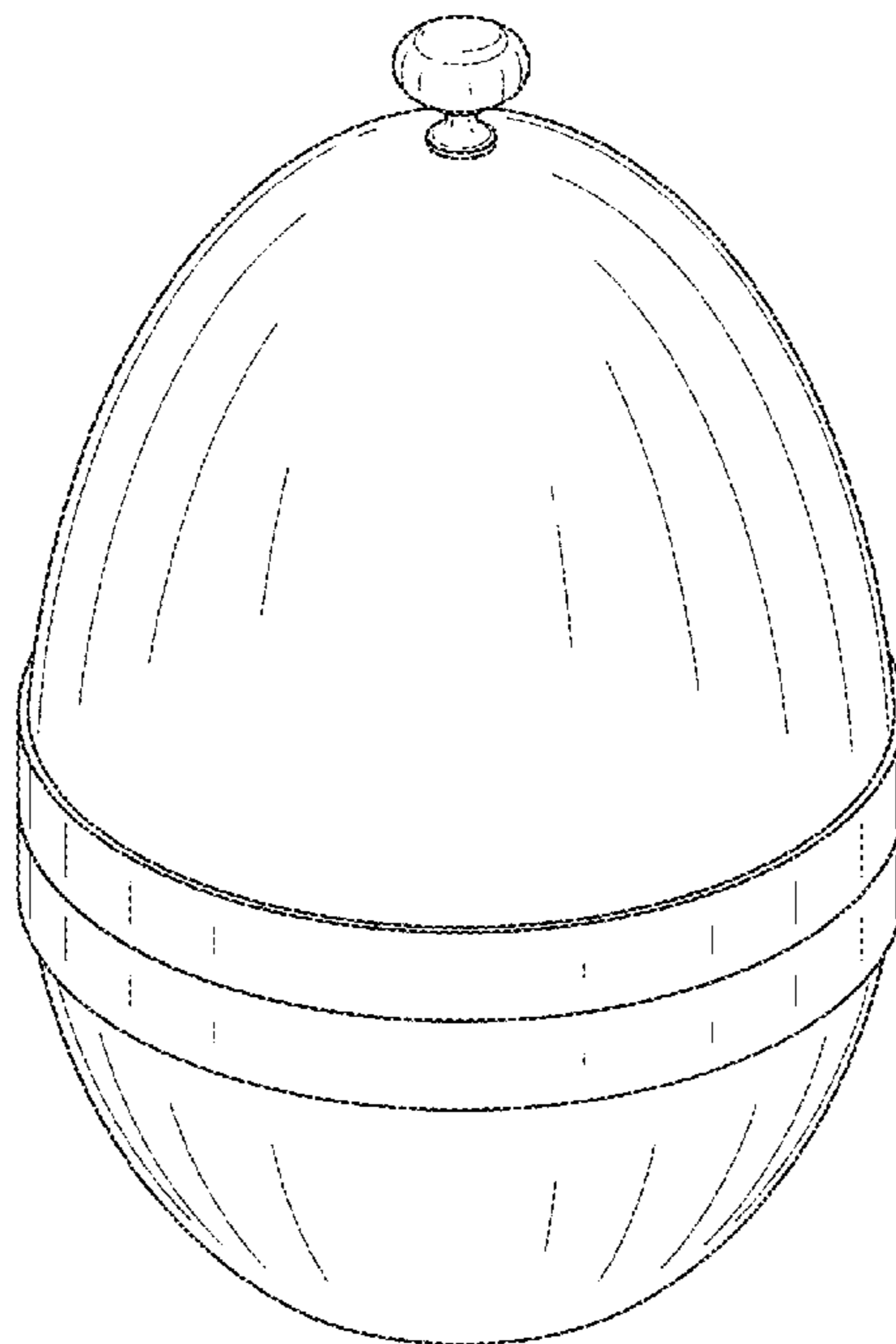
(57) **CLAIM**
The ornamental design for a ceramic cookware, as shown and described.

DESCRIPTION

FIG. 1 is a perspective front view of a ceramic cookware; FIG. 2 is a front elevation view of the ceramic cookware; the rear elevation view, the left side elevation view, and the right side elevation view all being a mirror image thereof; FIG. 3 is a top plan view of the ceramic cookware; and, FIG. 4 is a bottom plan view of the ceramic cookware.

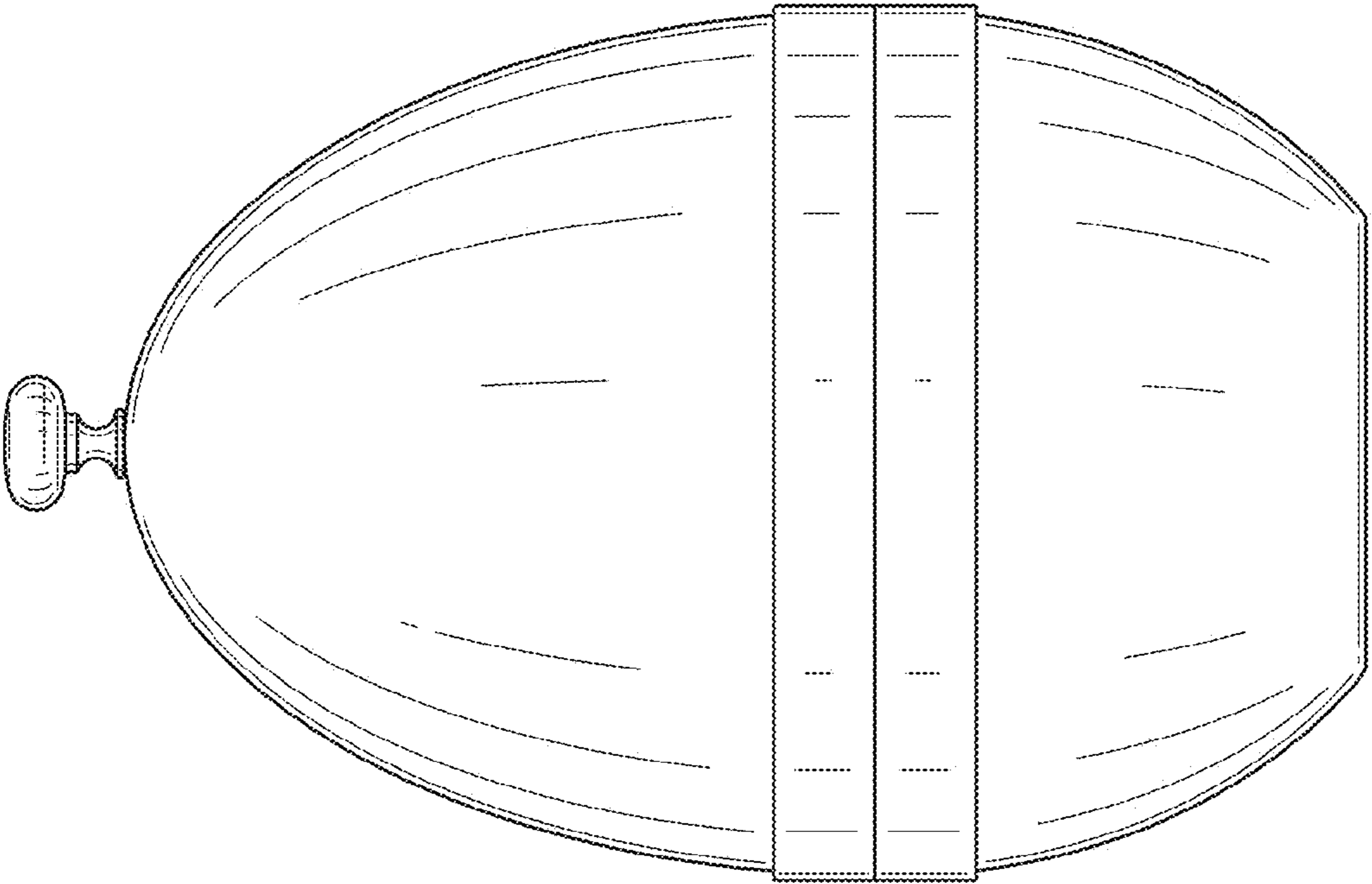

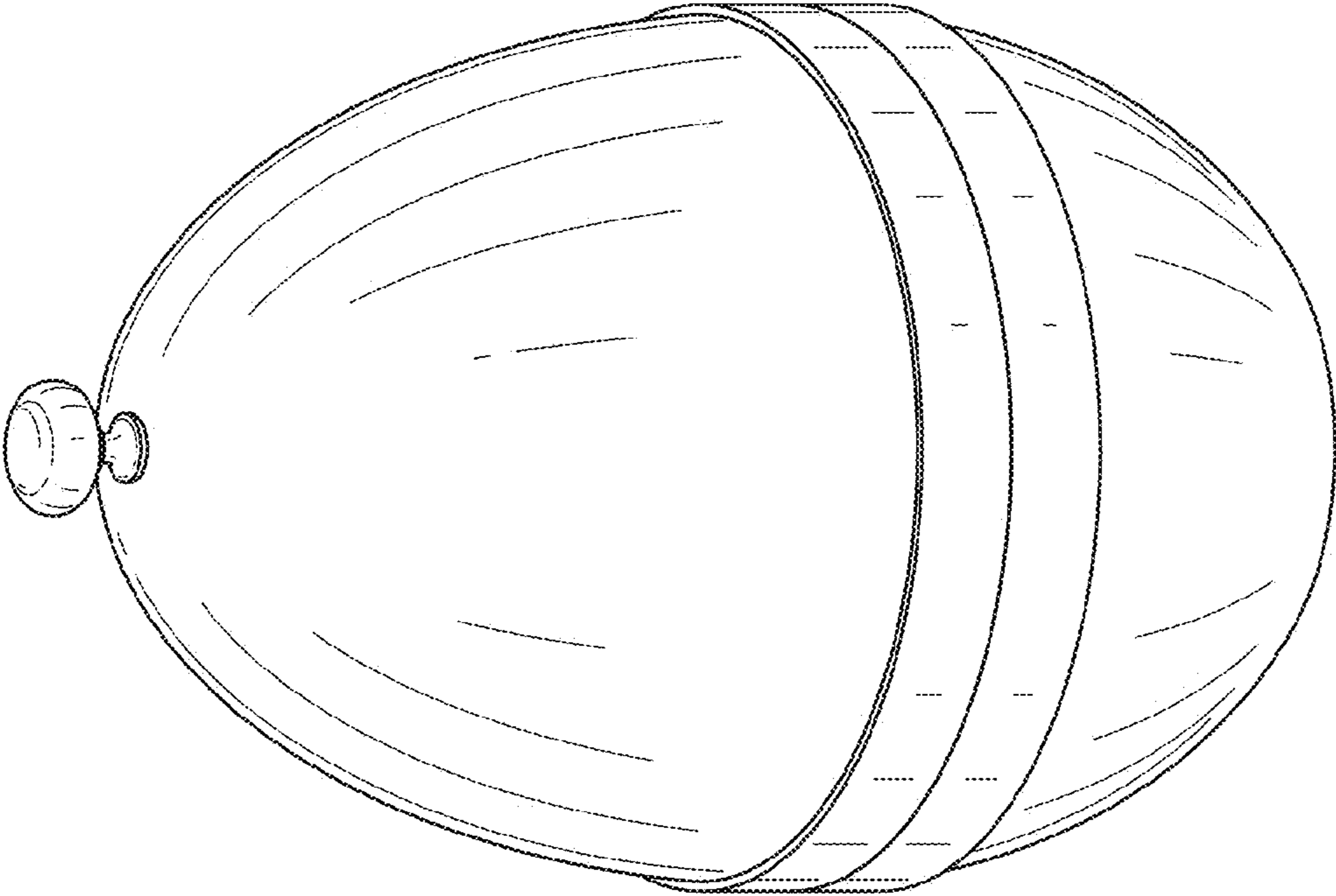

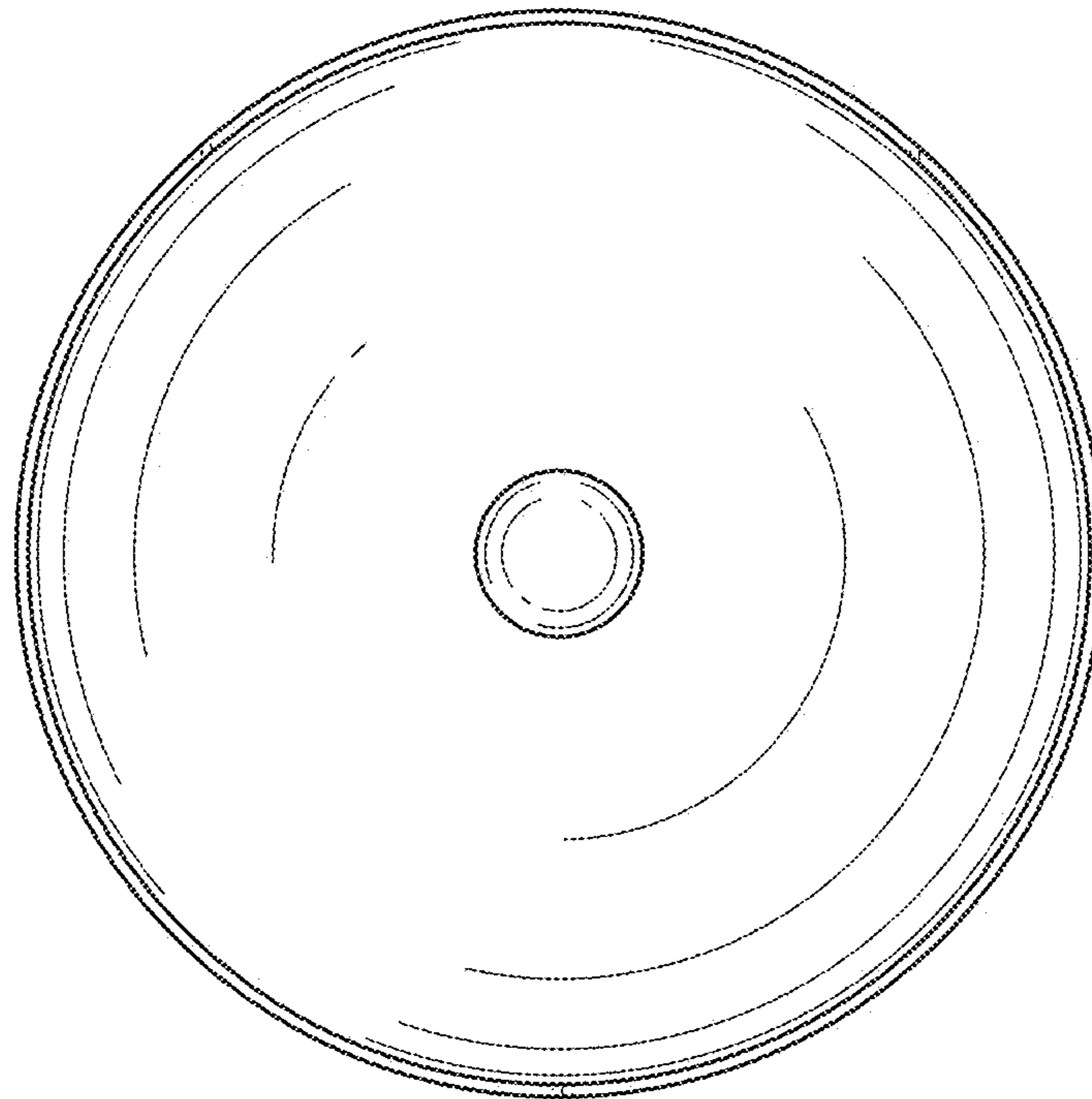

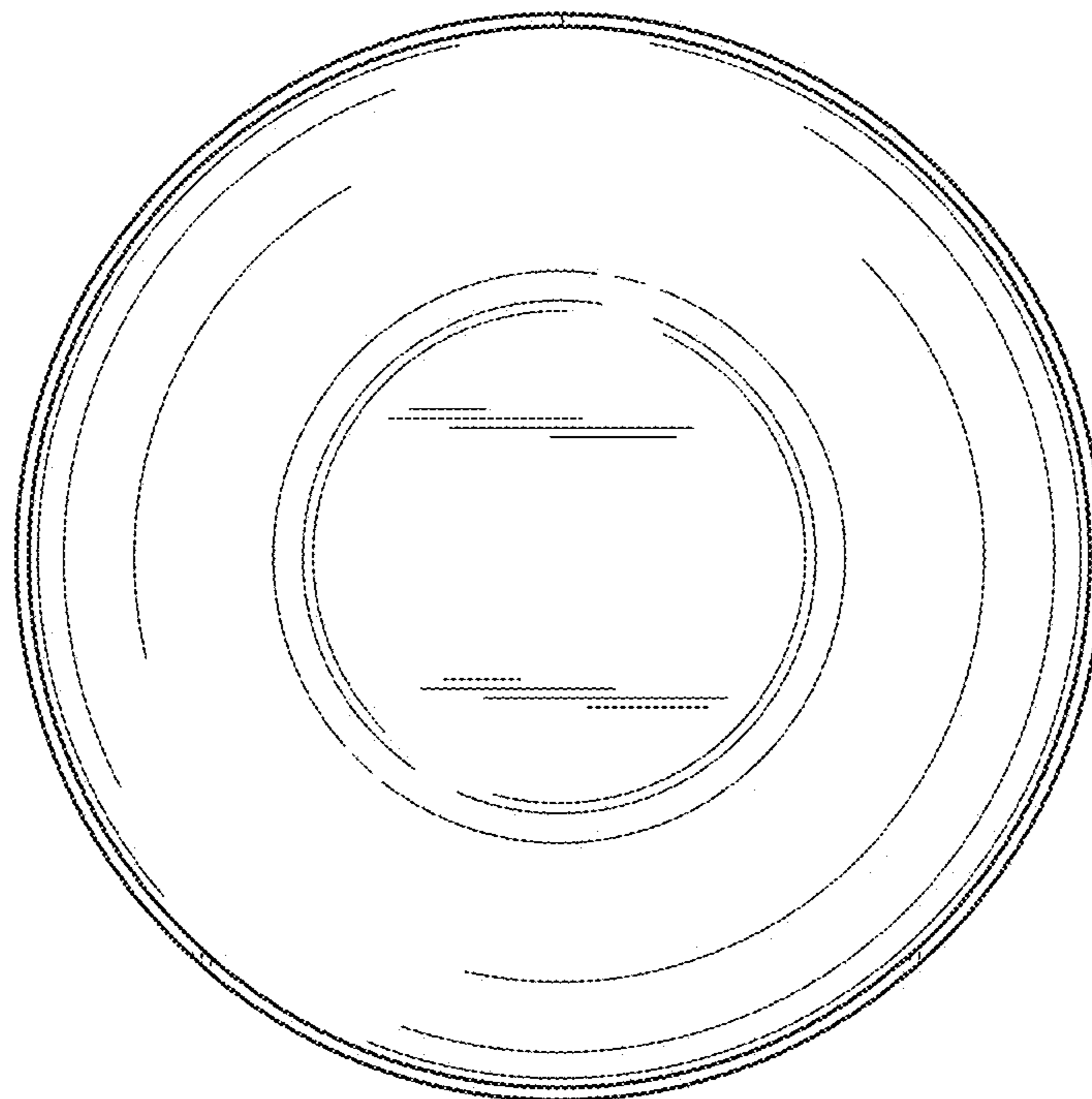
