DESCRIPTION

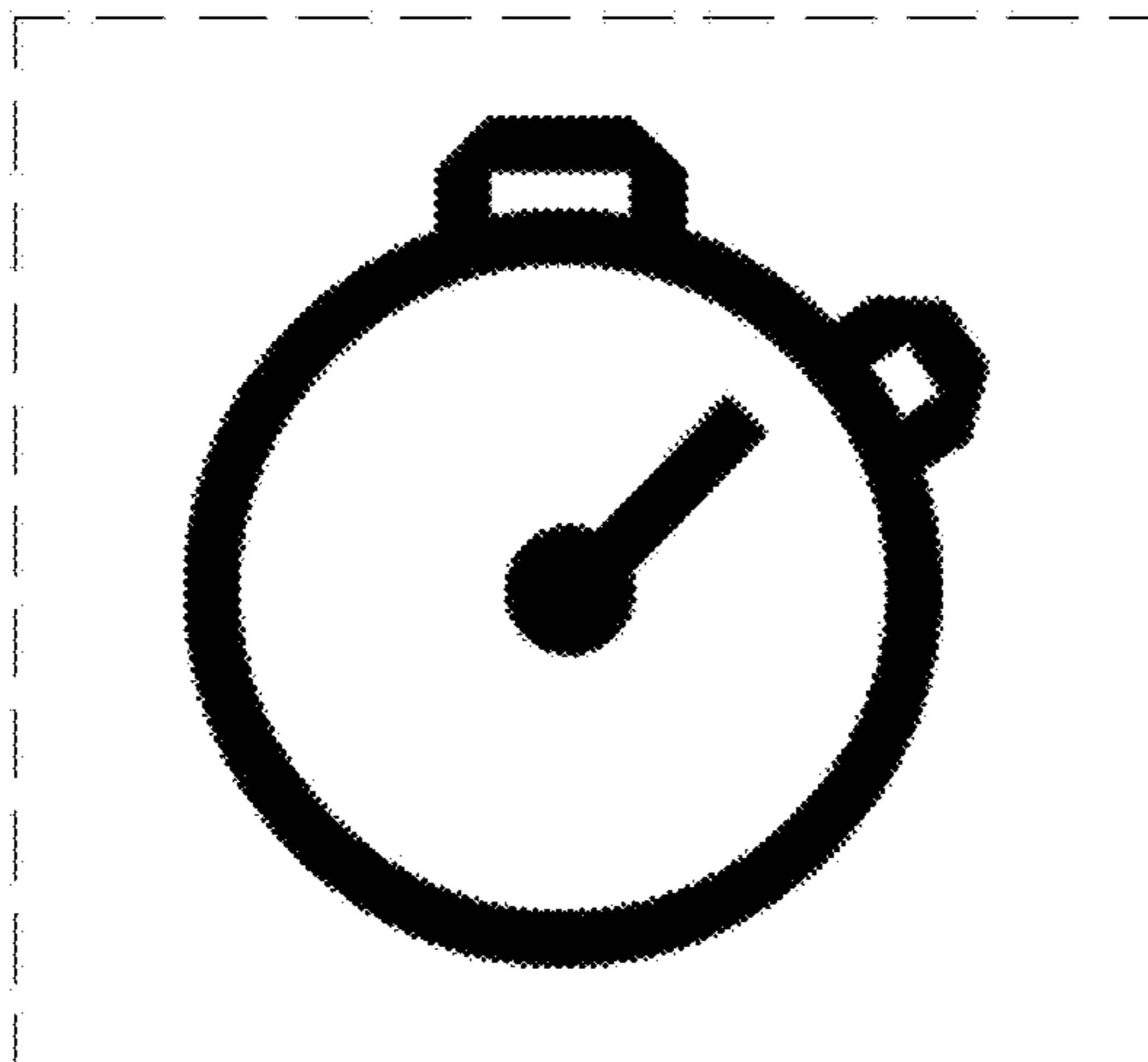
FIG. 1 is a front view of a display screen portion with icon showing our new design;

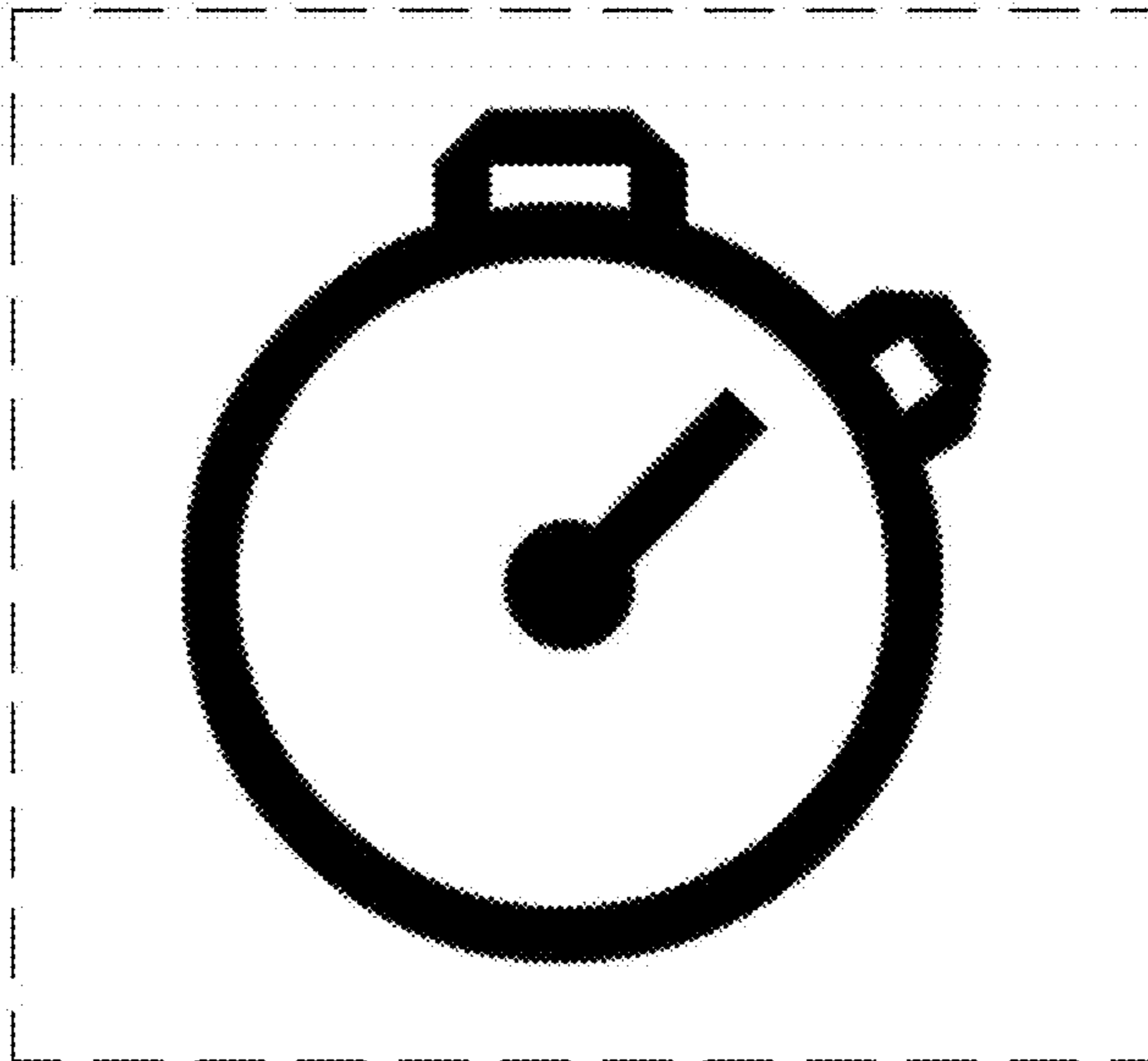

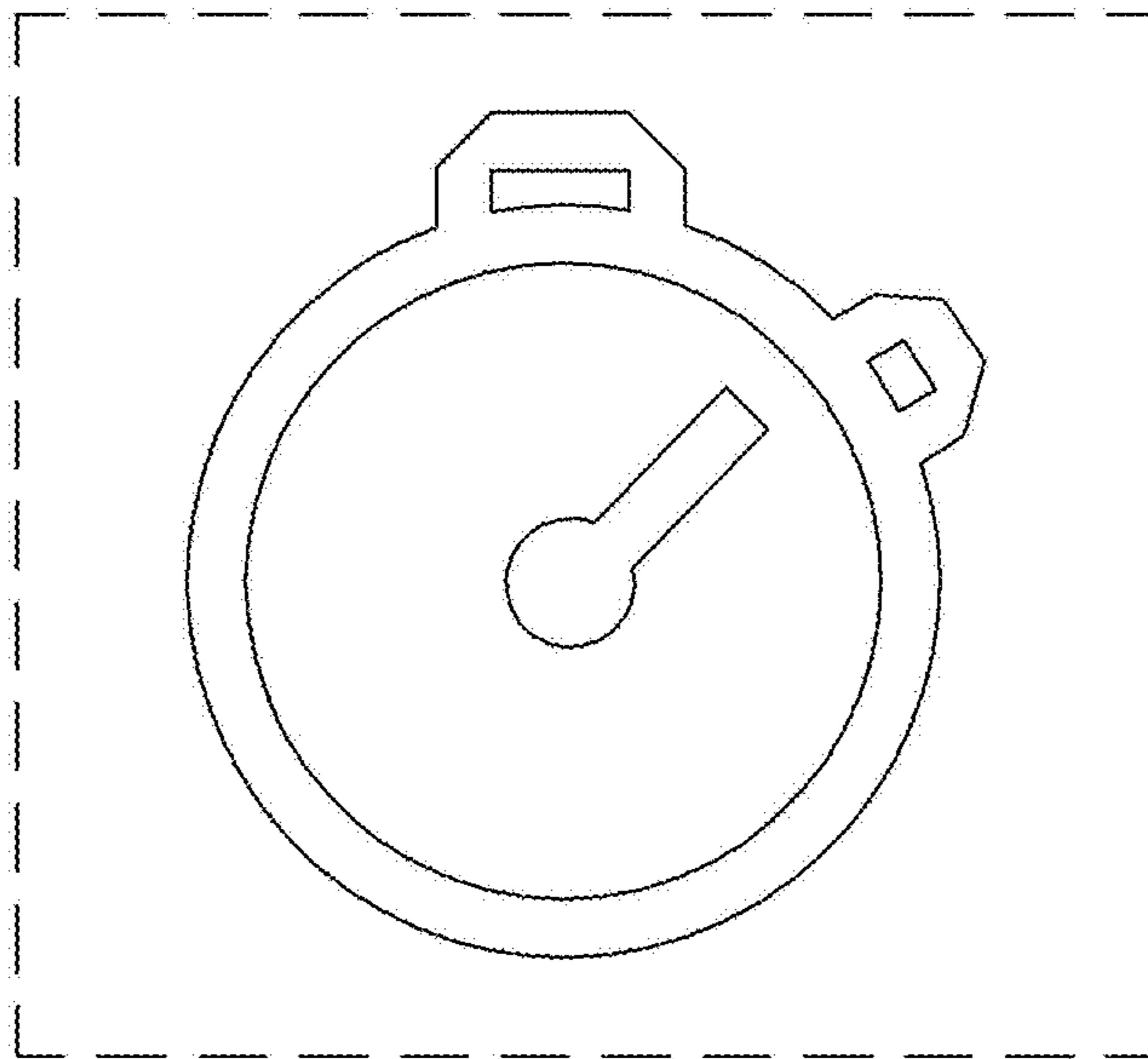

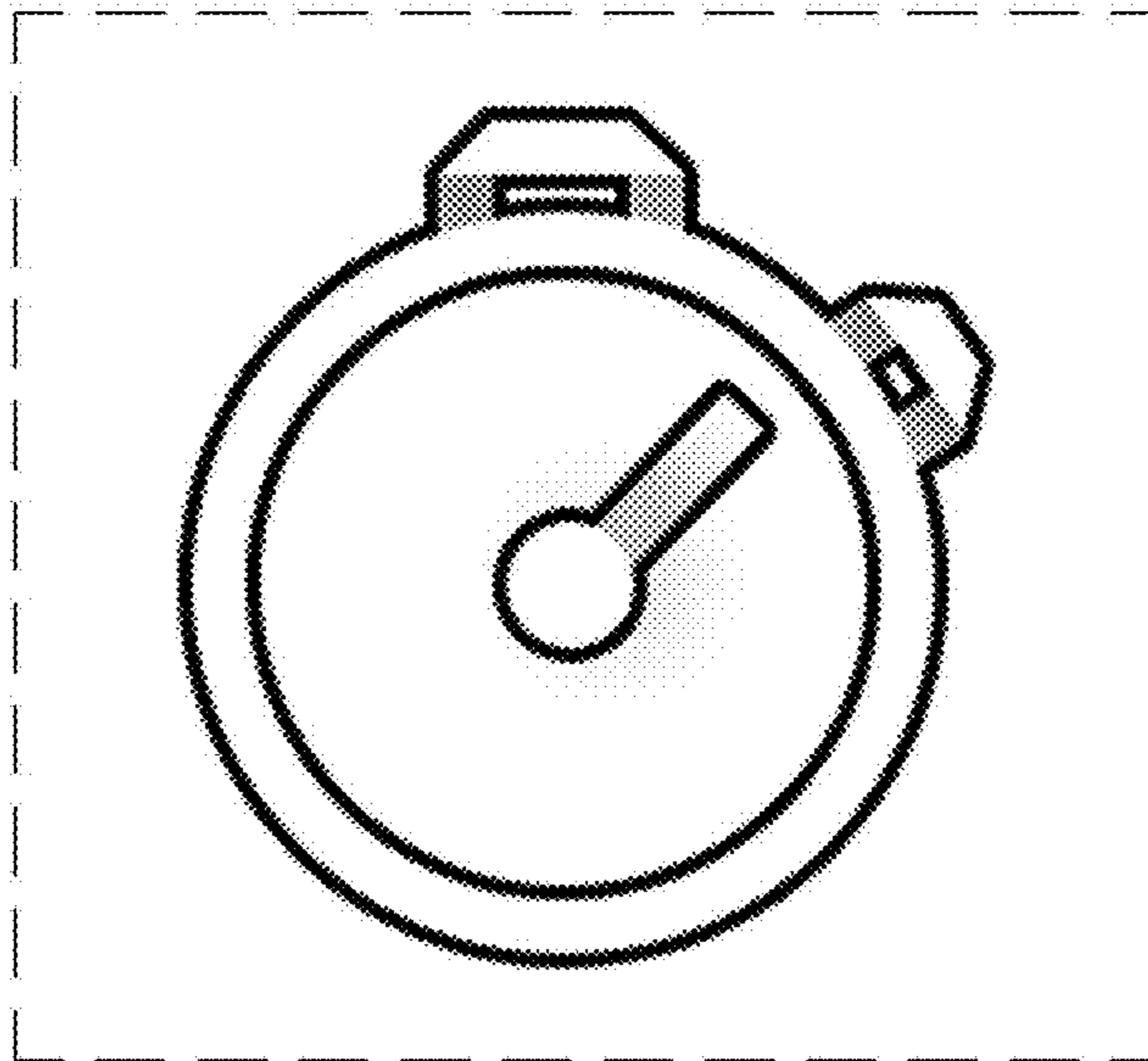

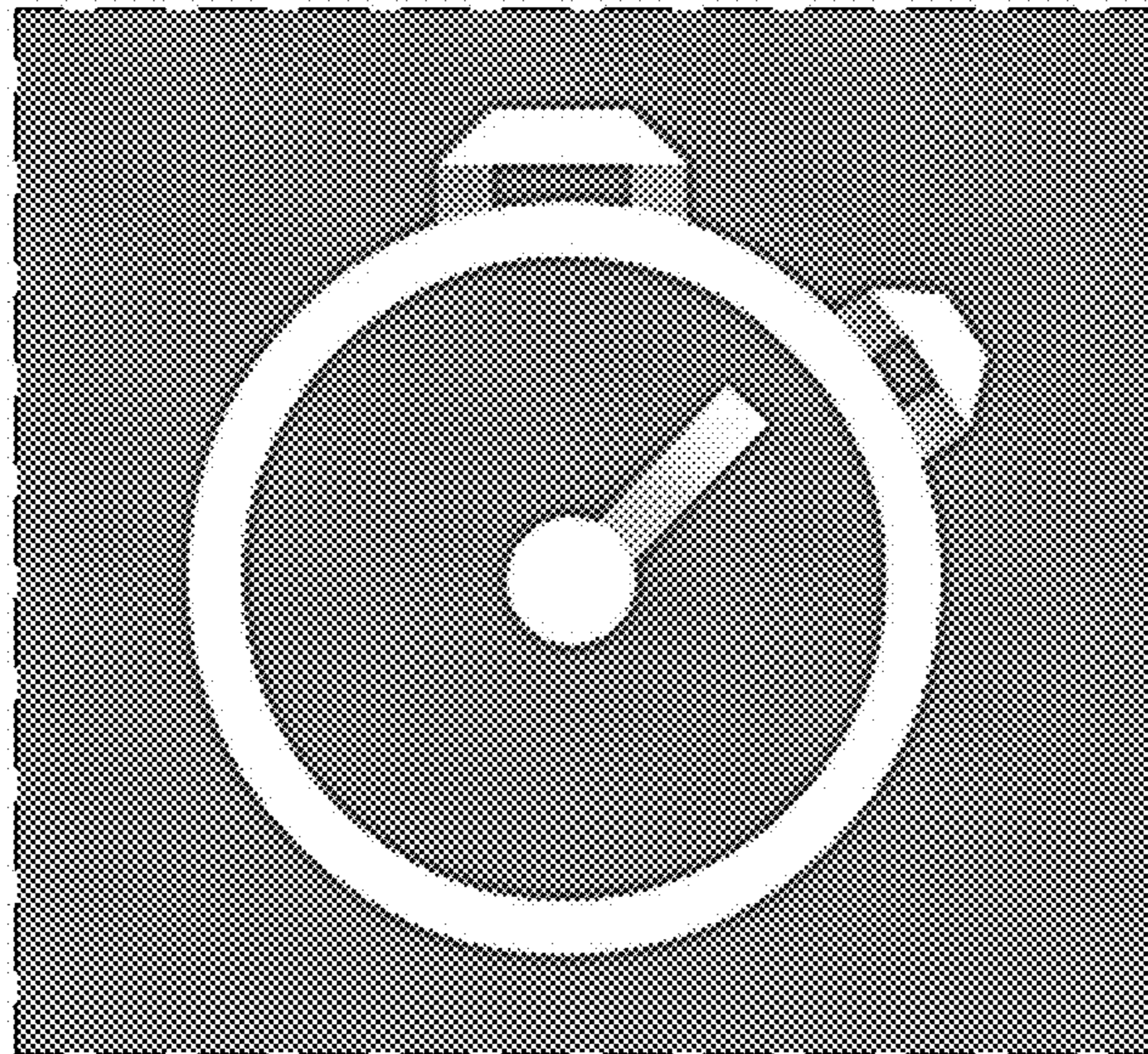

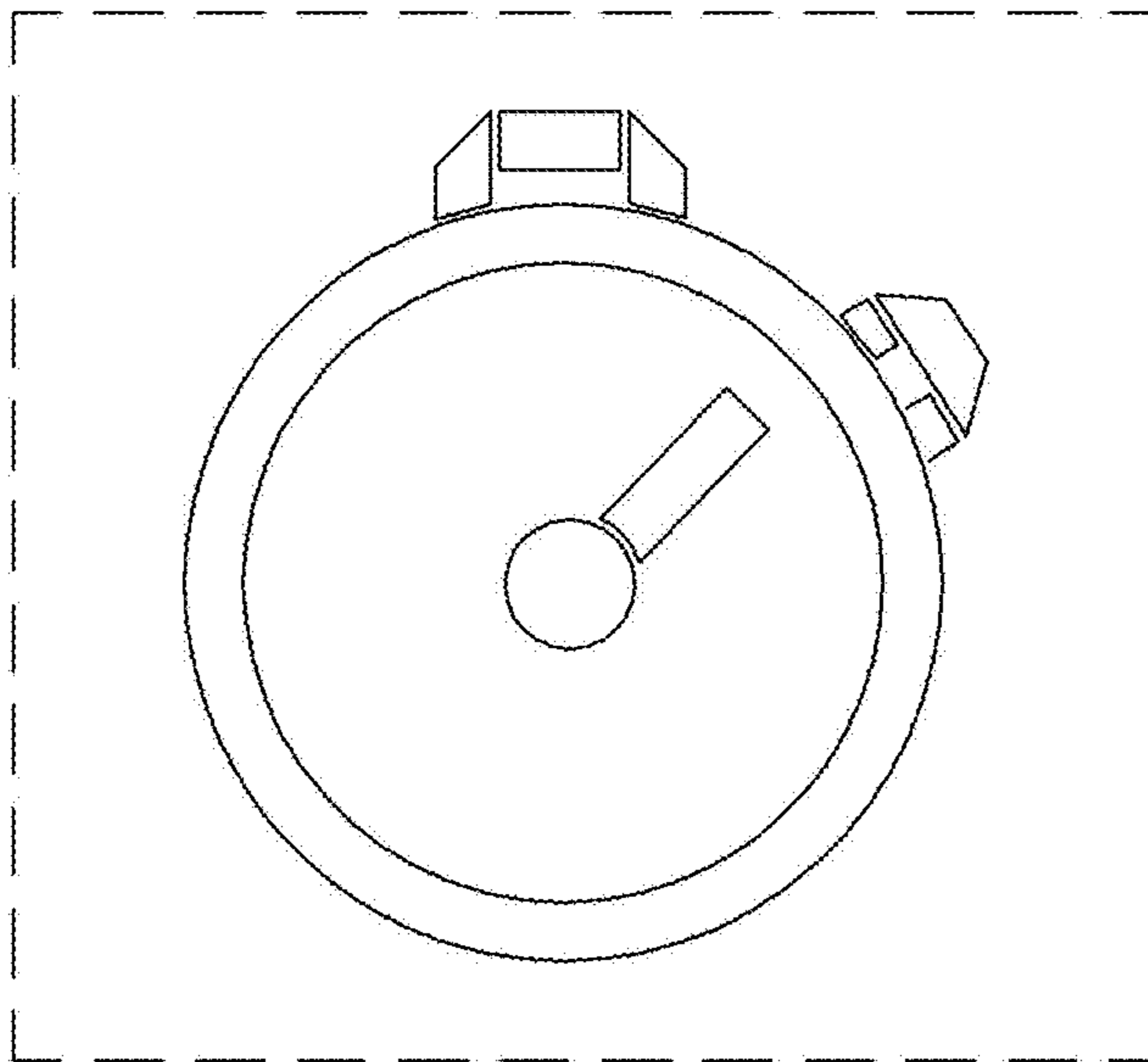

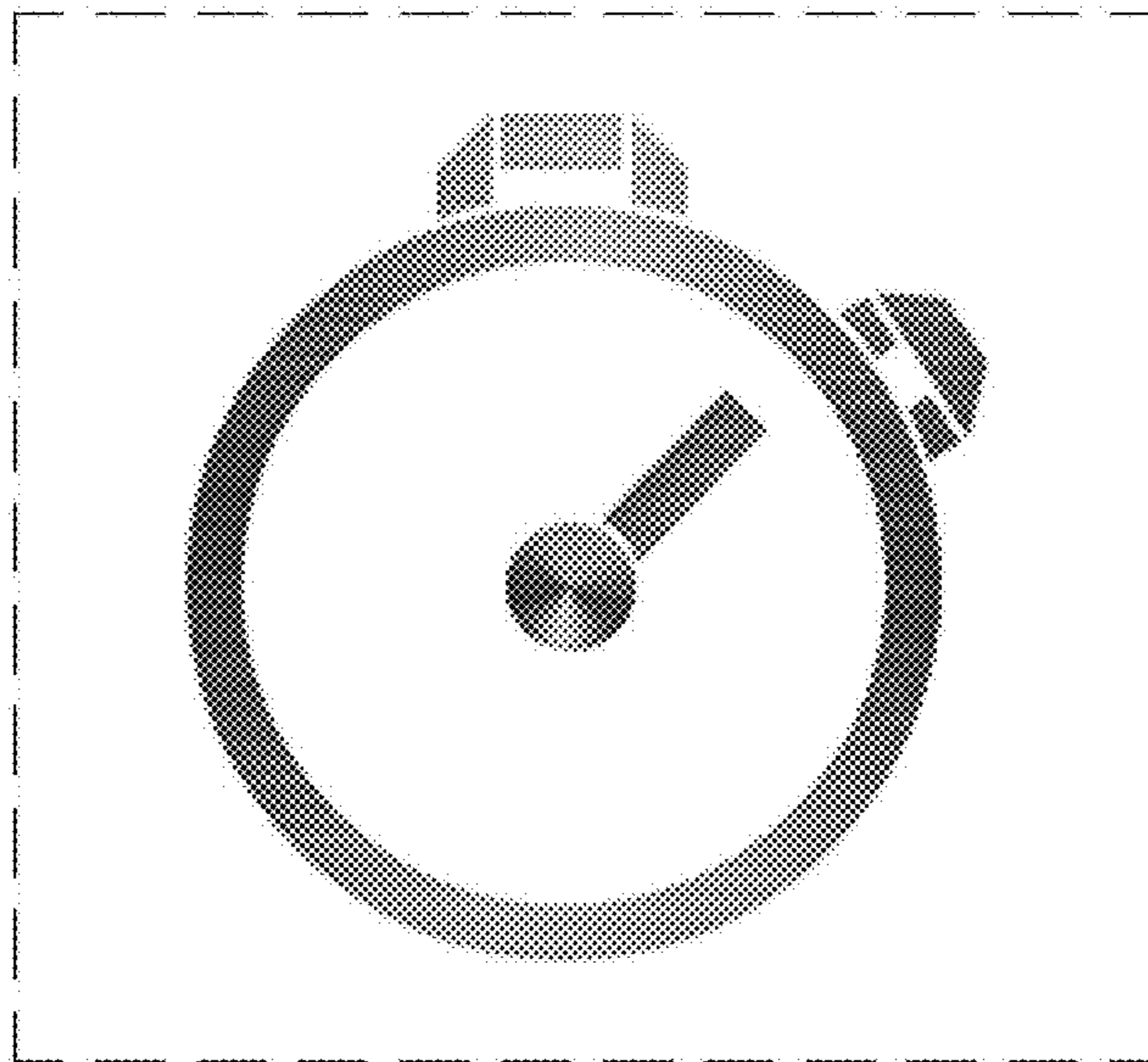
