DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a printer showing my new design;

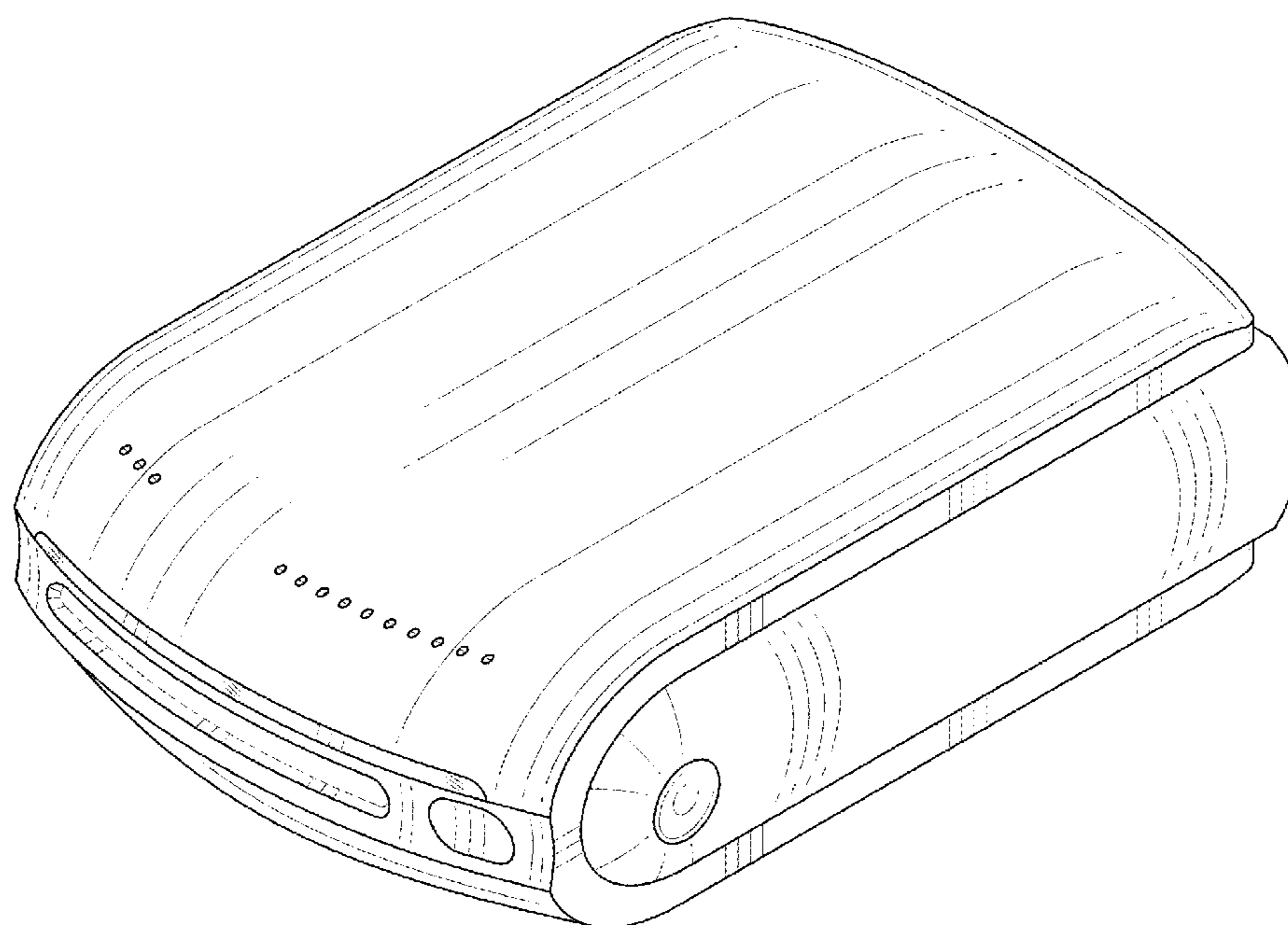

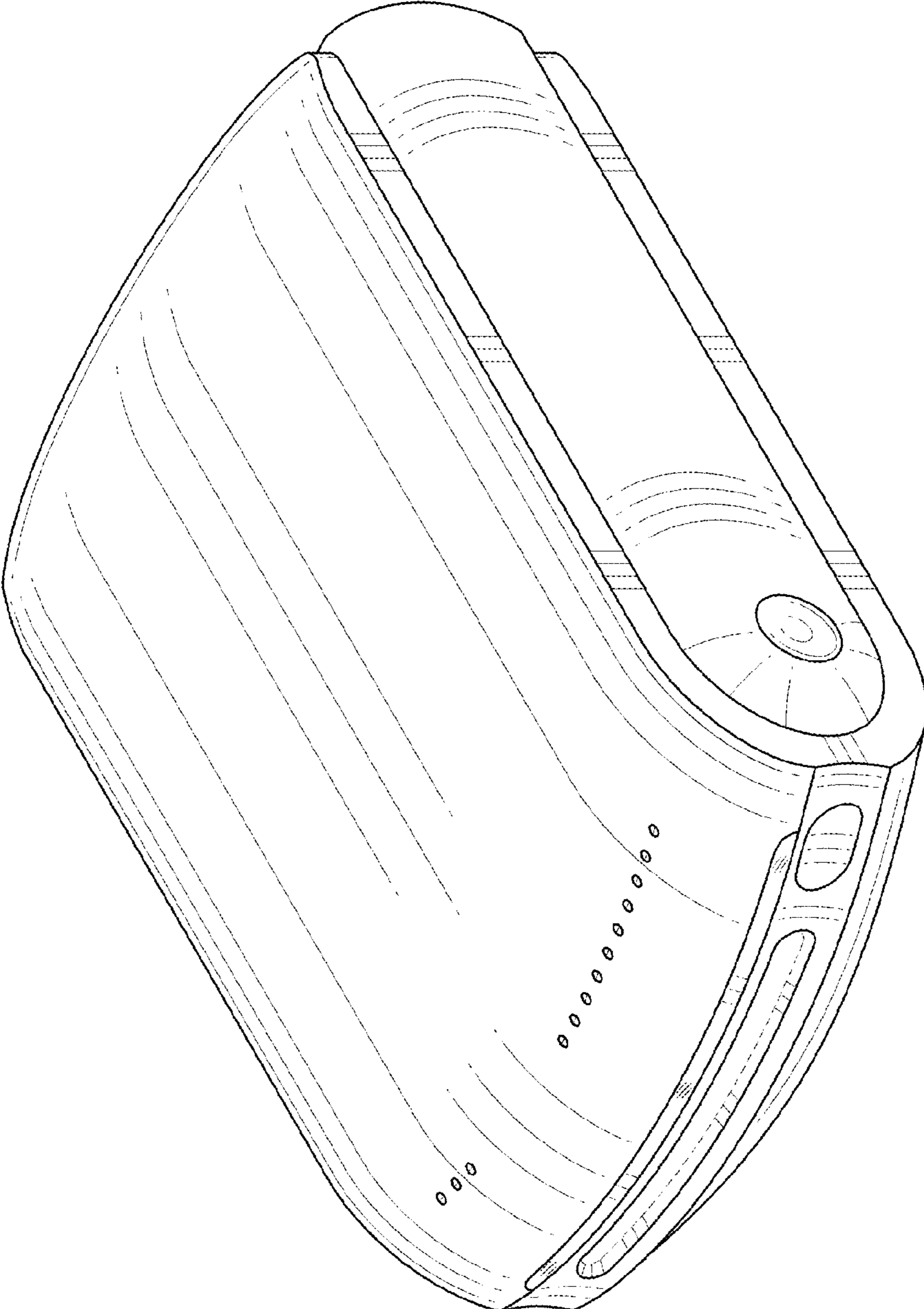

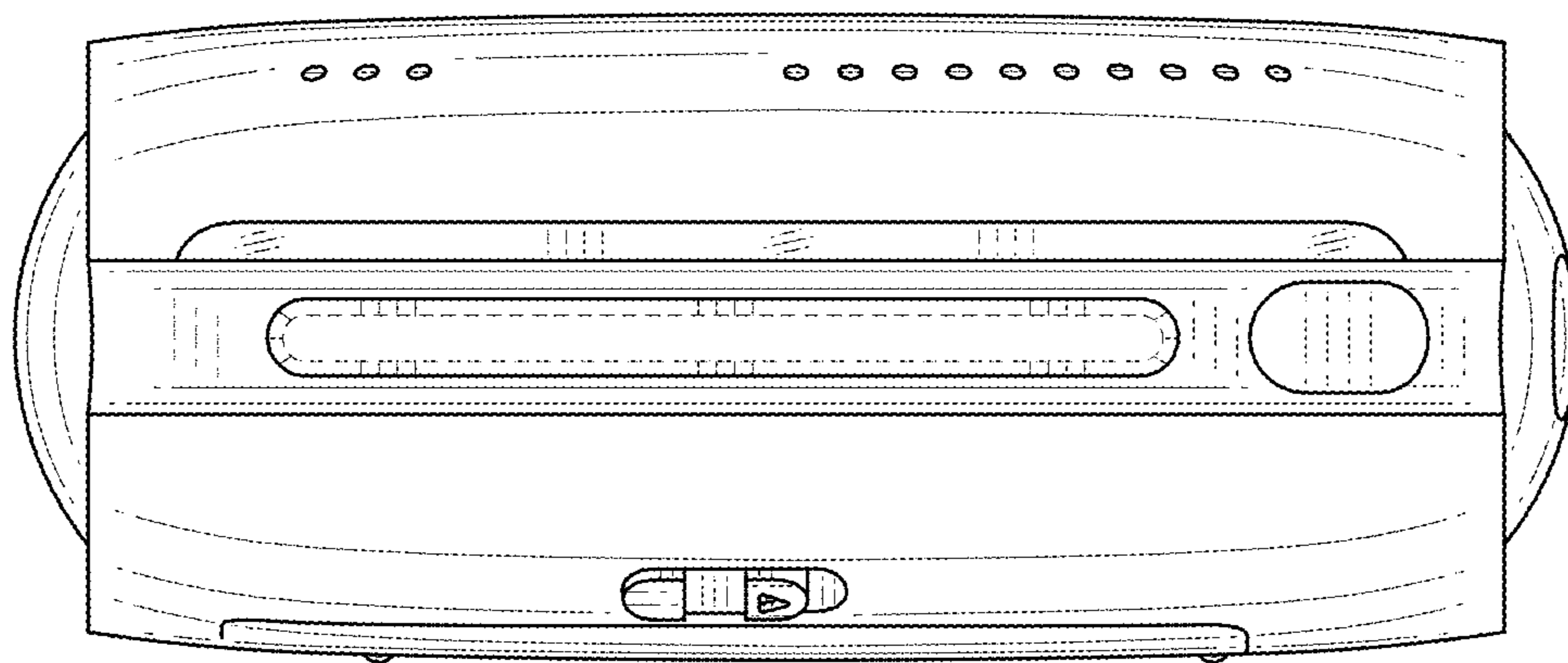

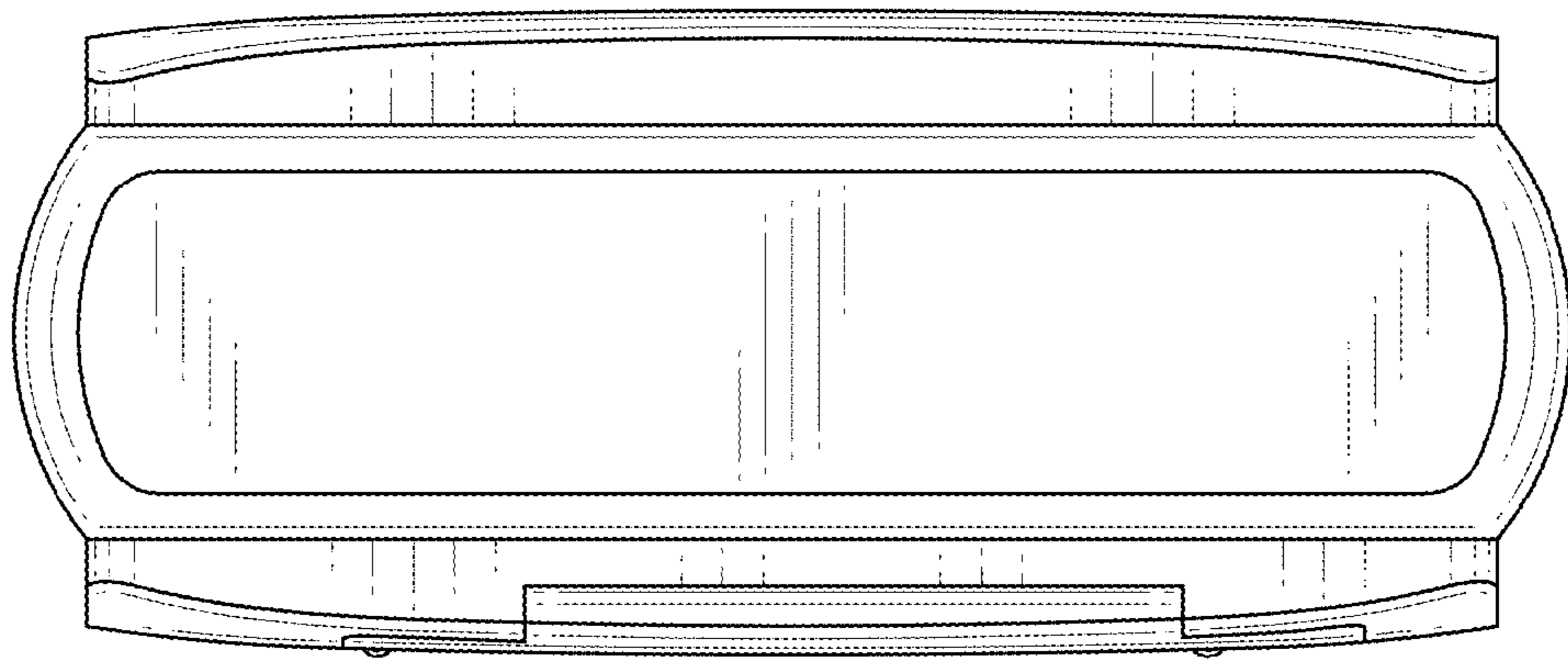

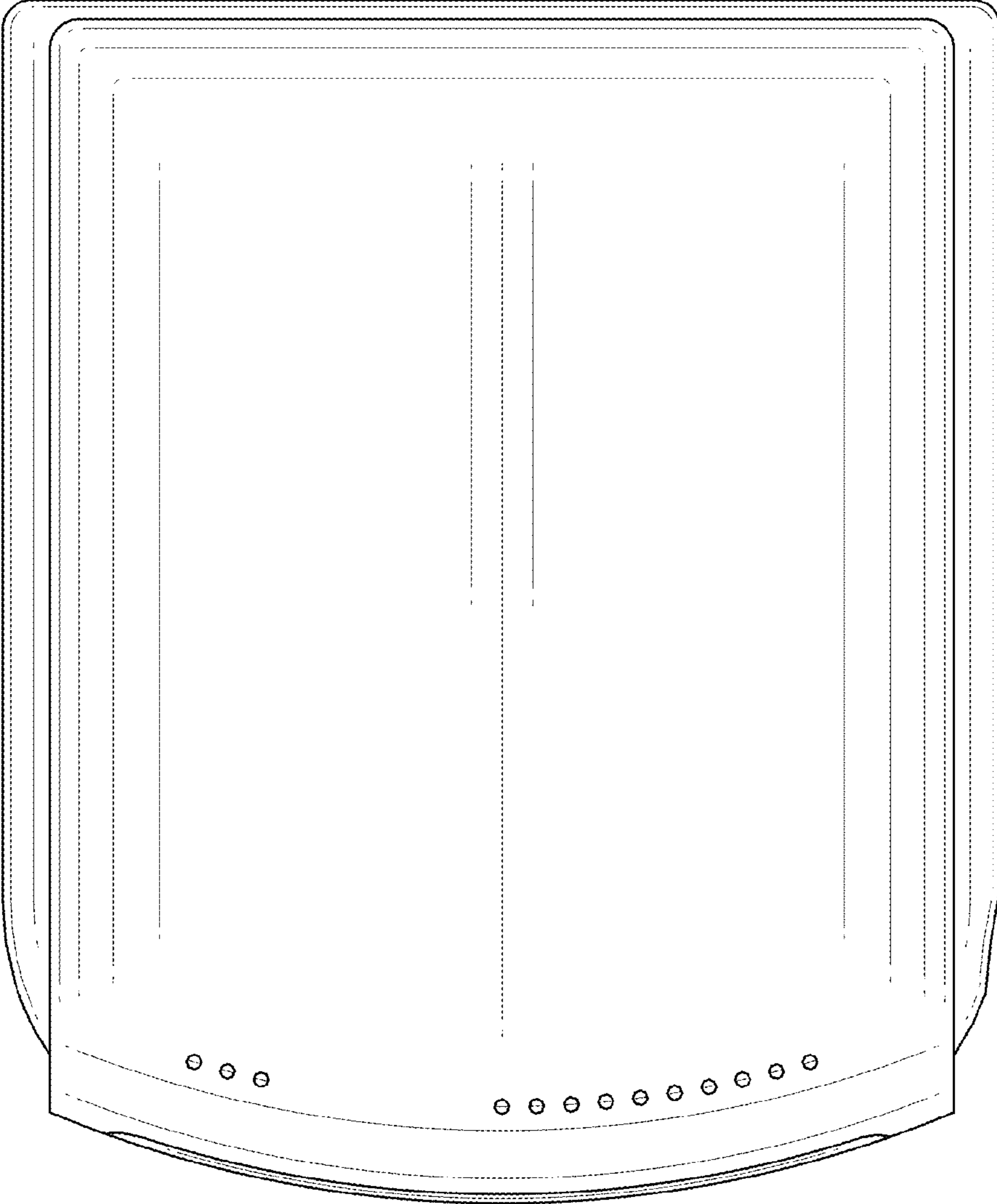

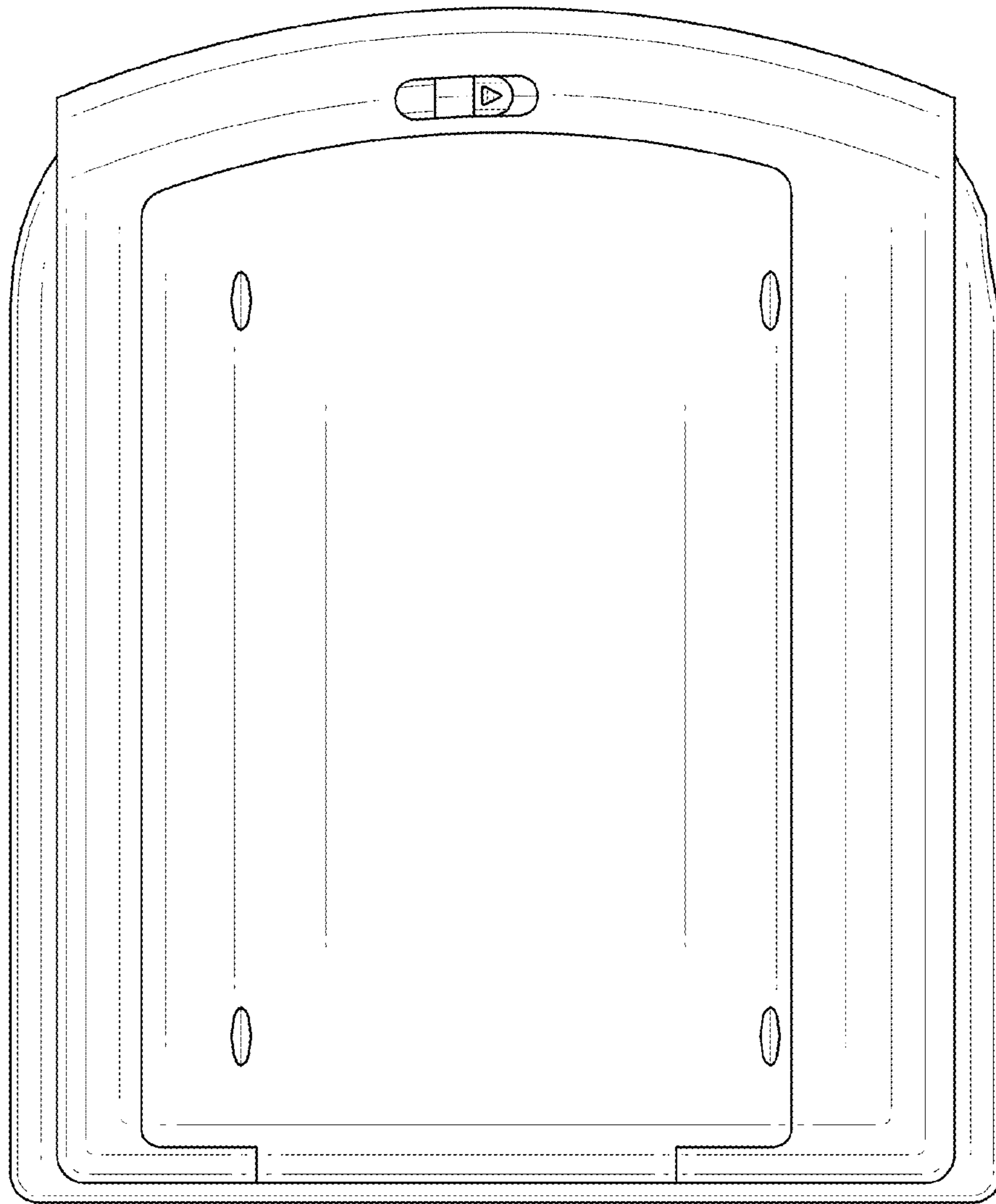

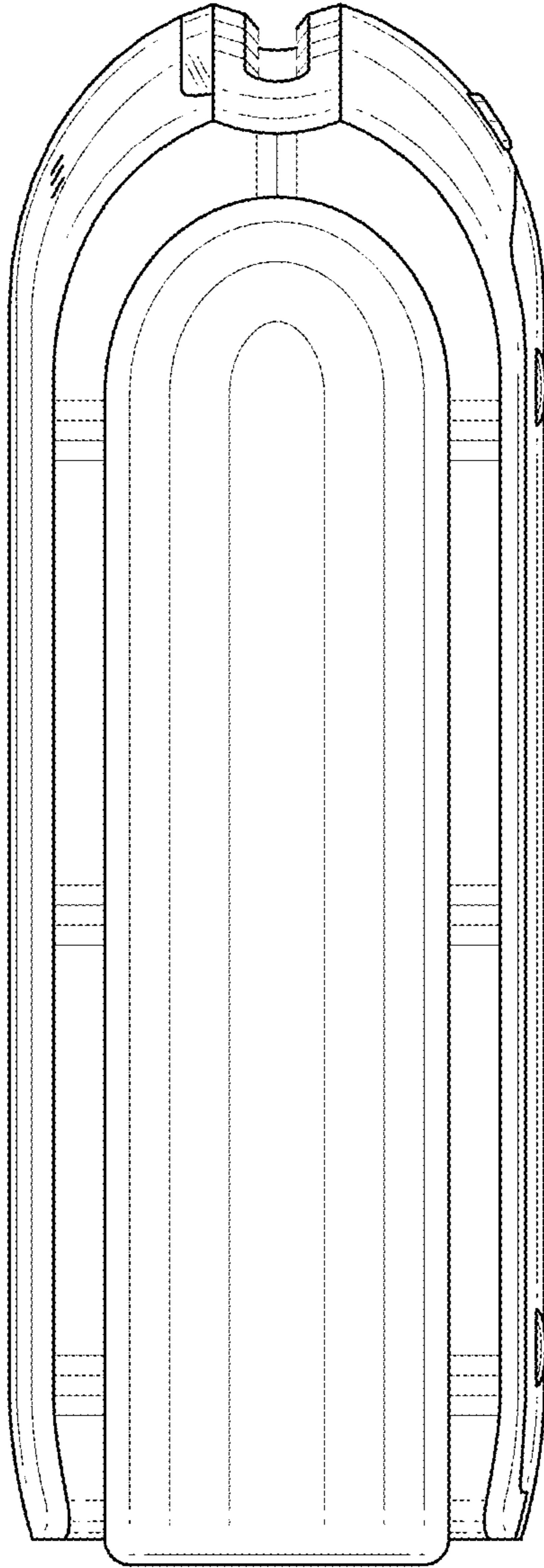
