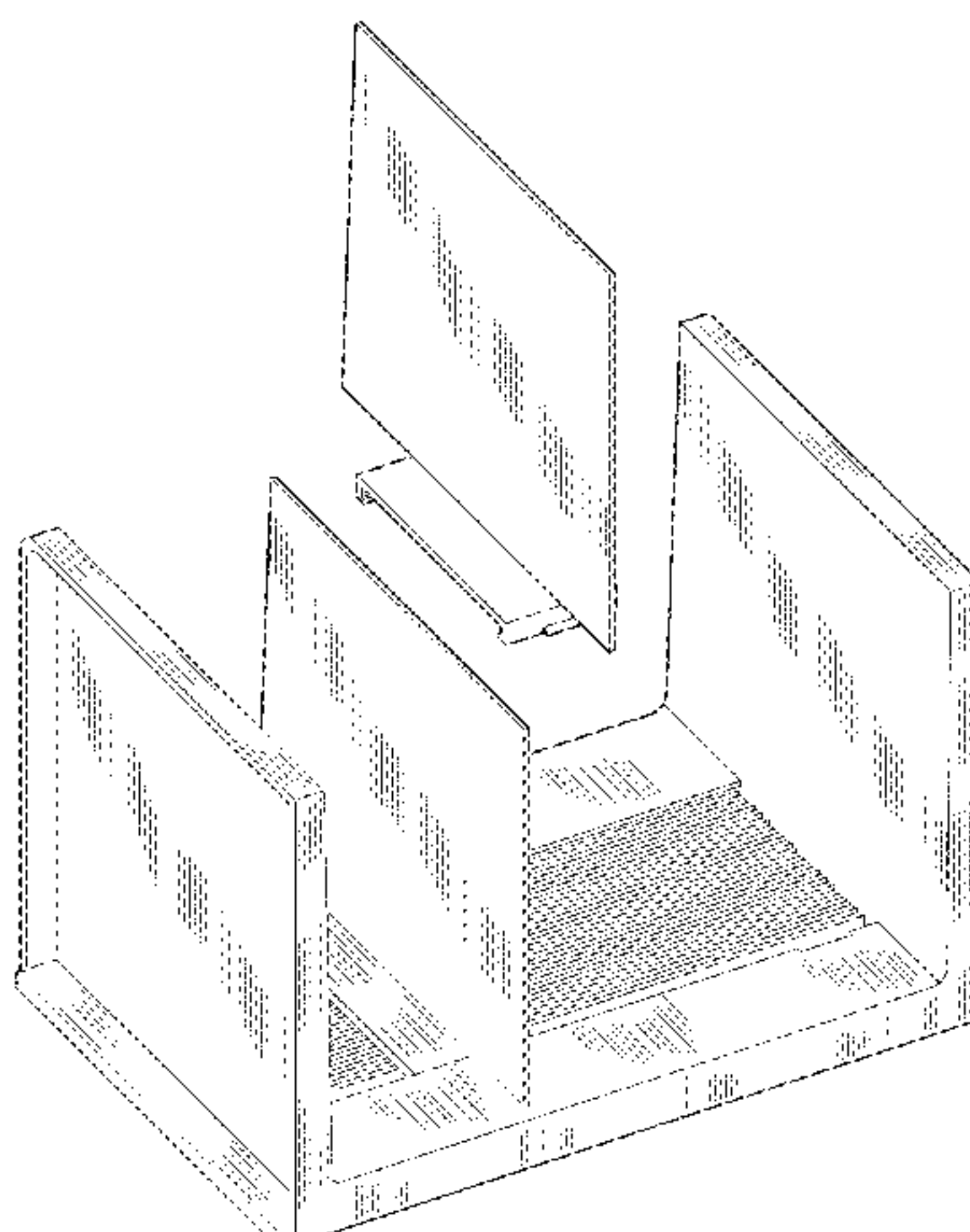
FIG. 1 is a front view of a book stand showing my new design;

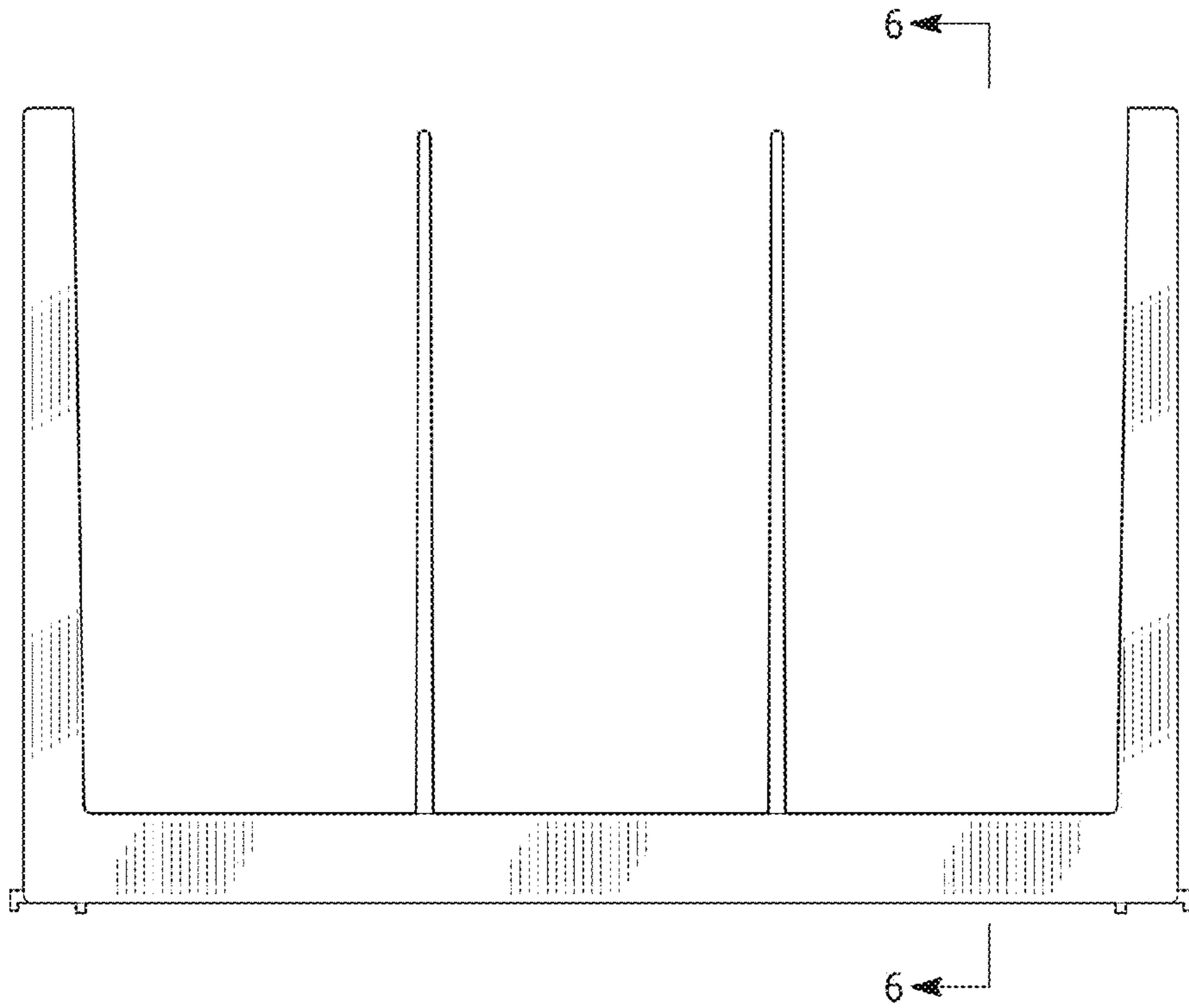

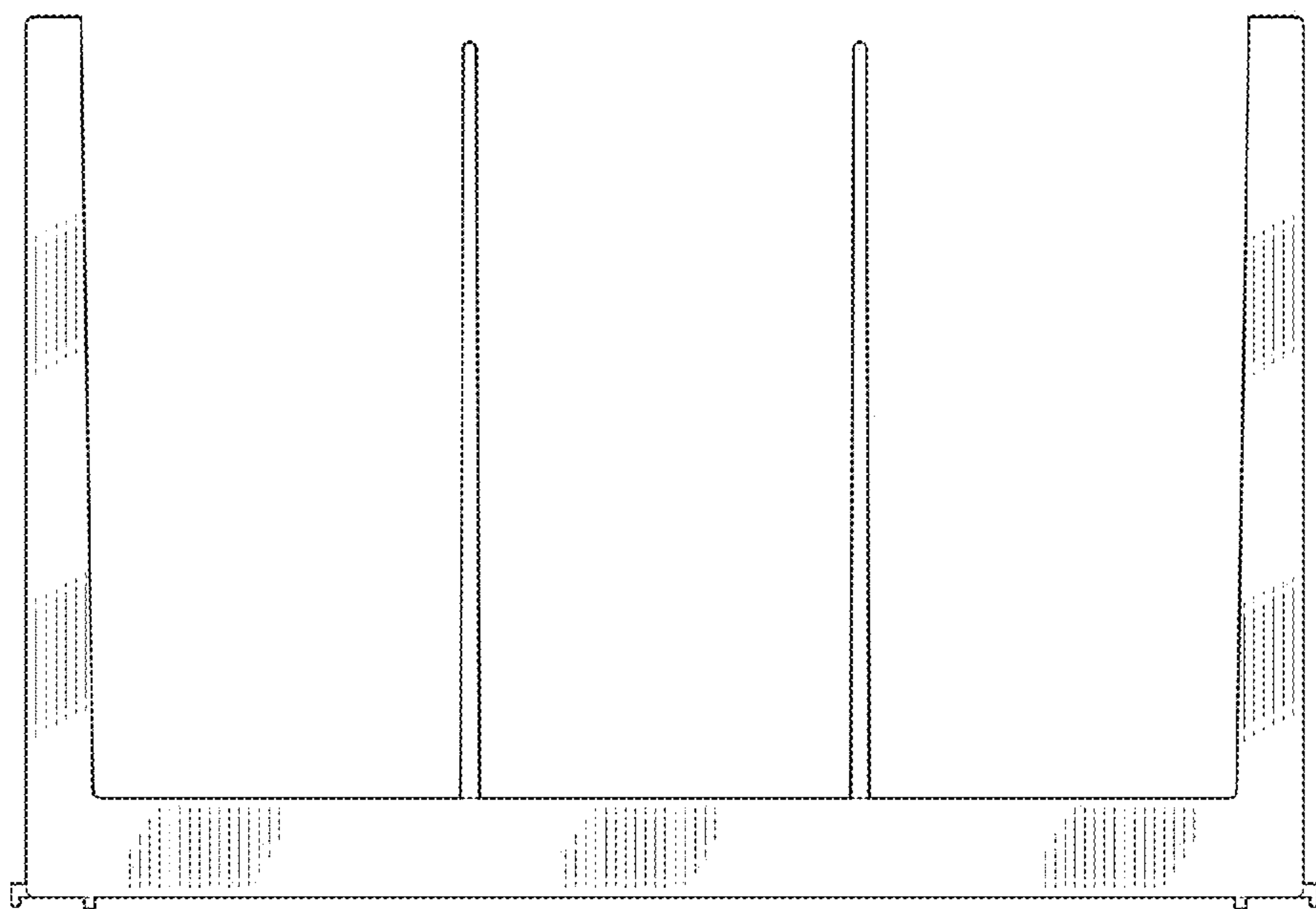

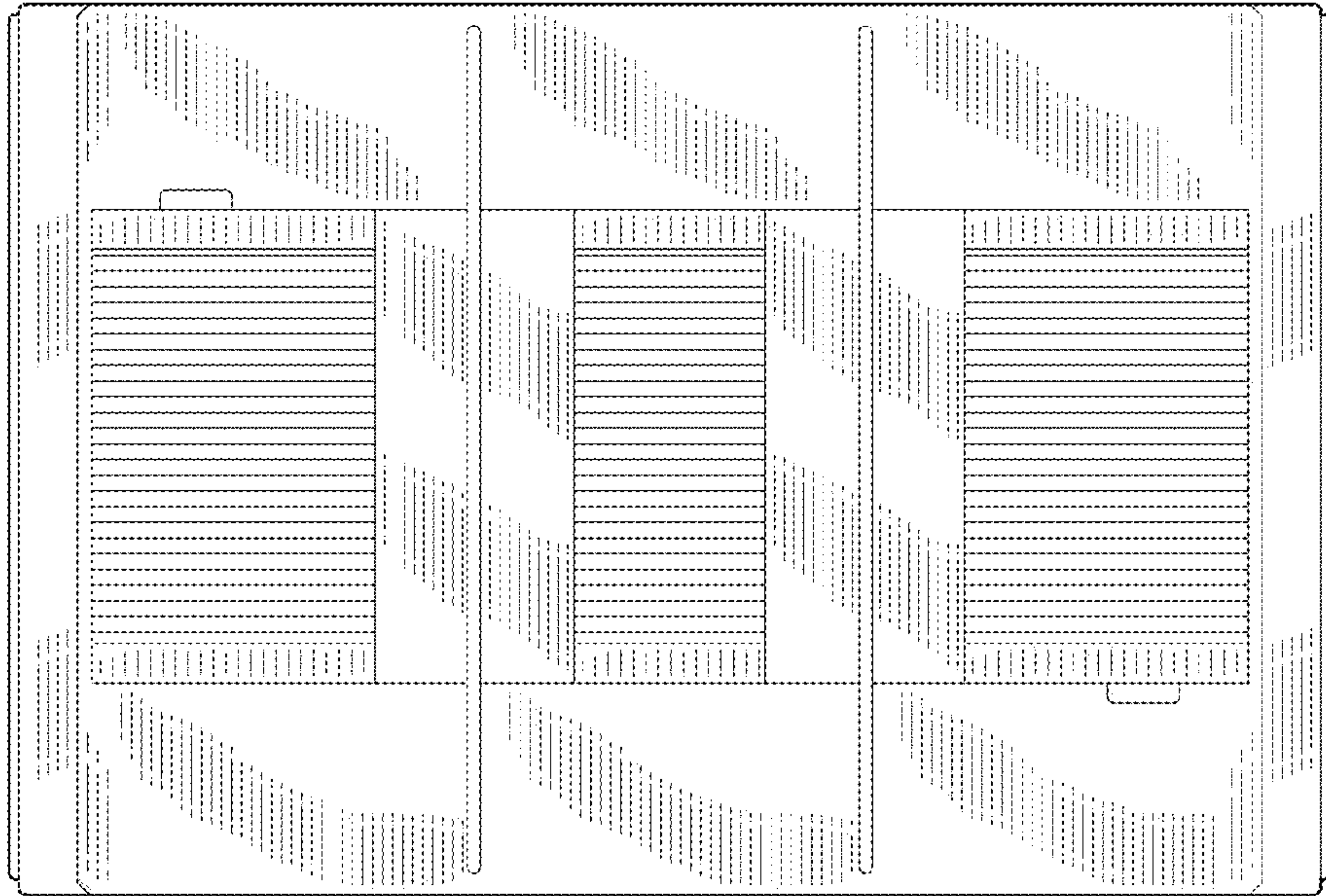

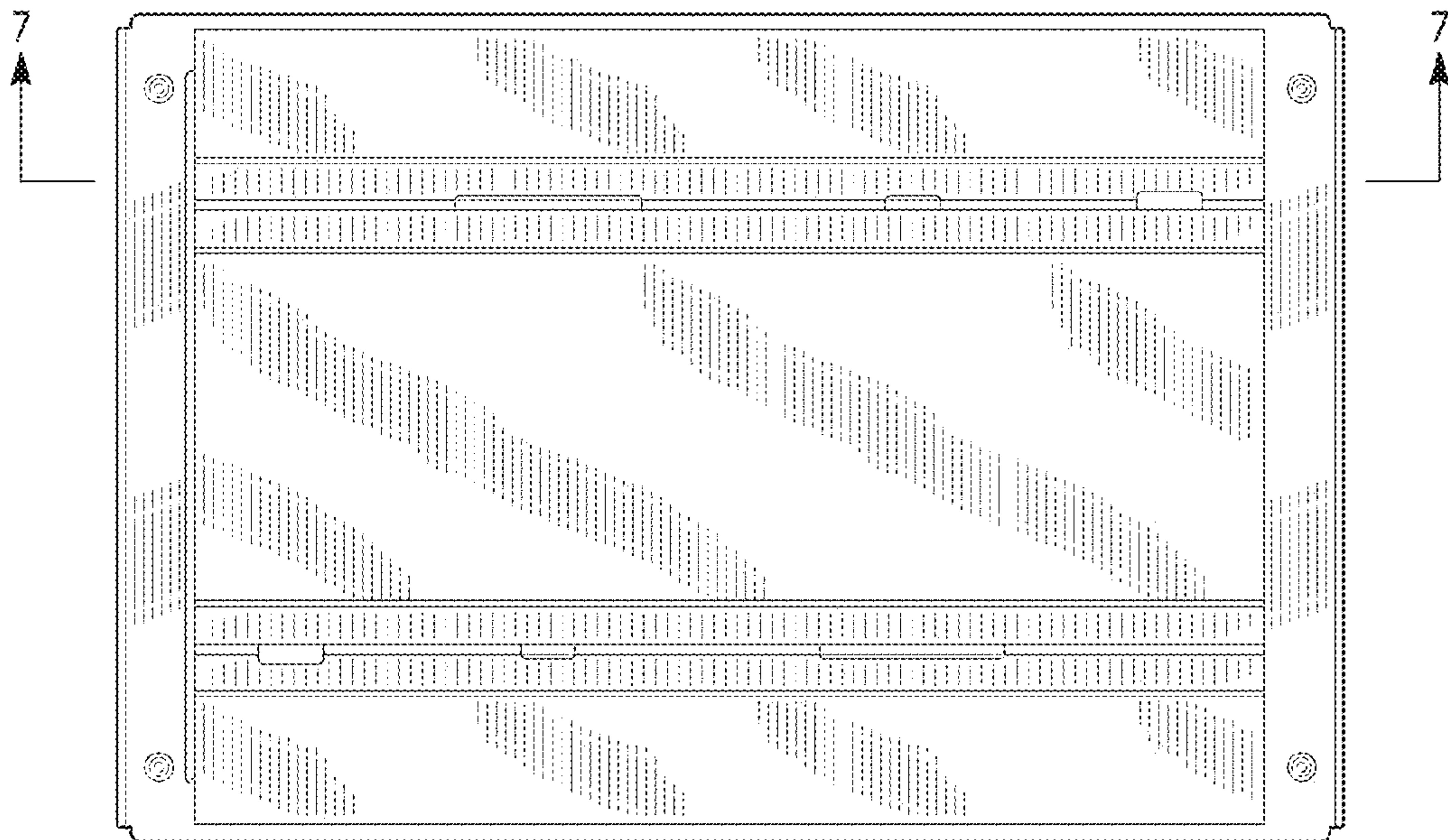

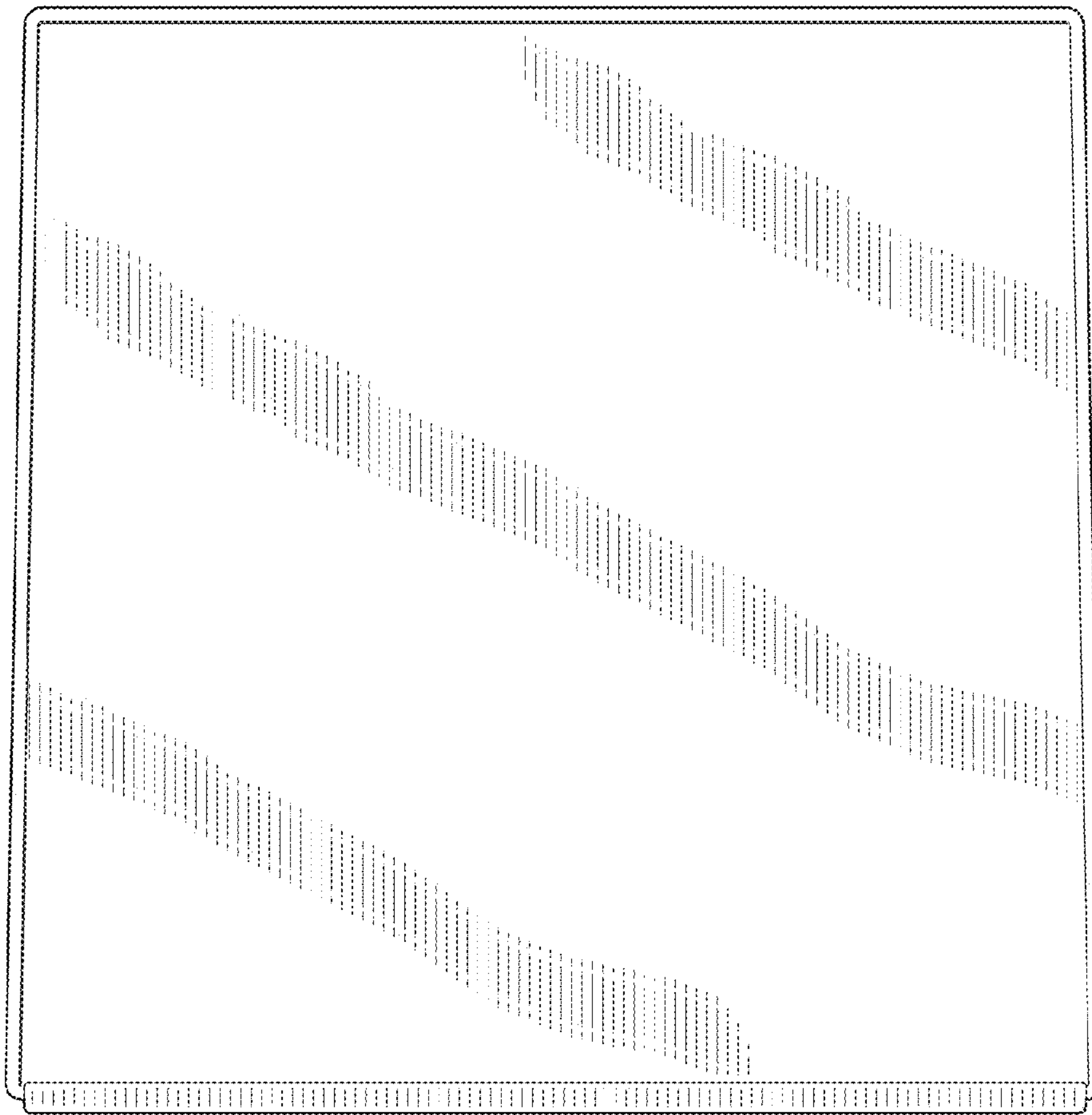

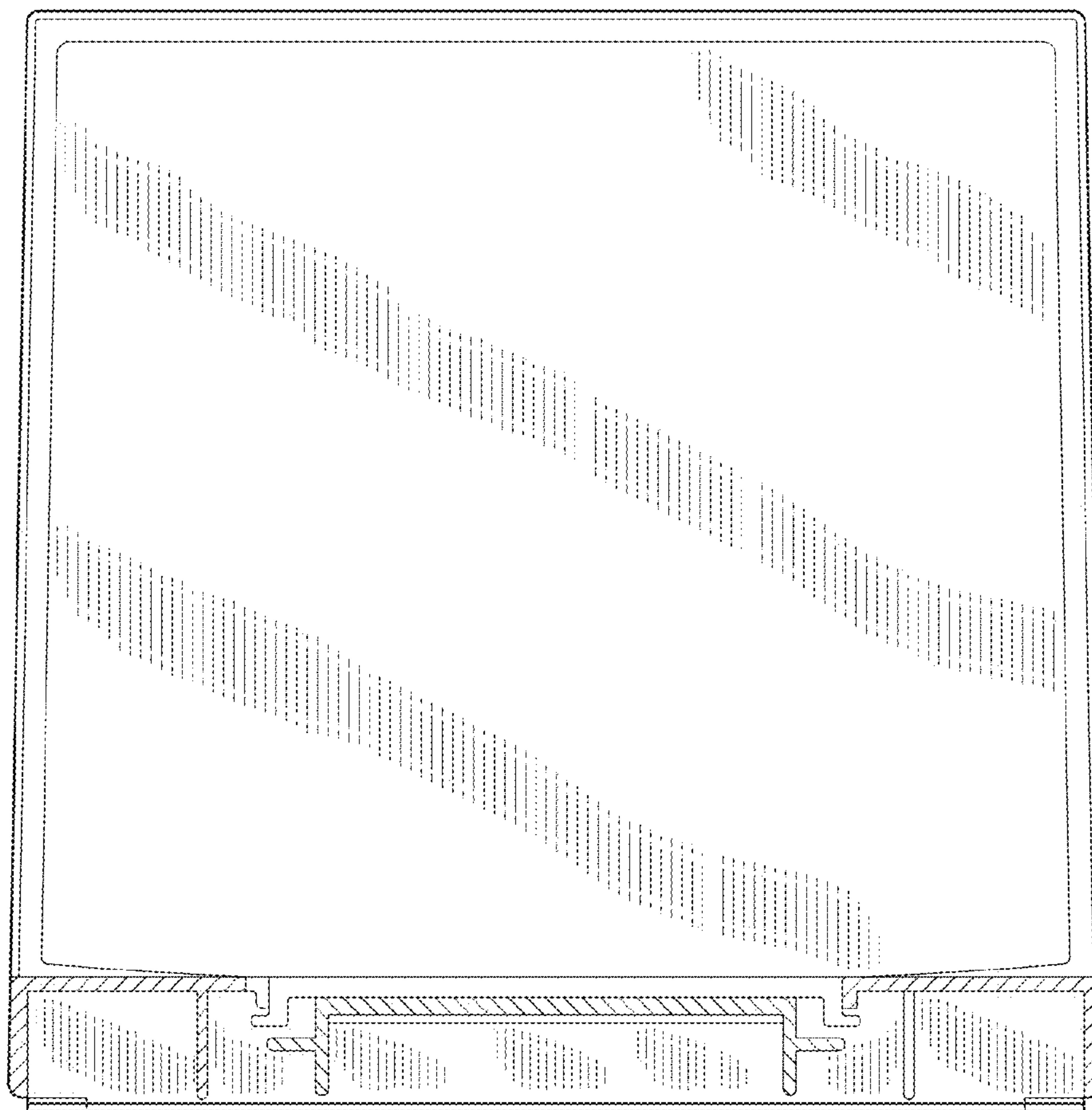

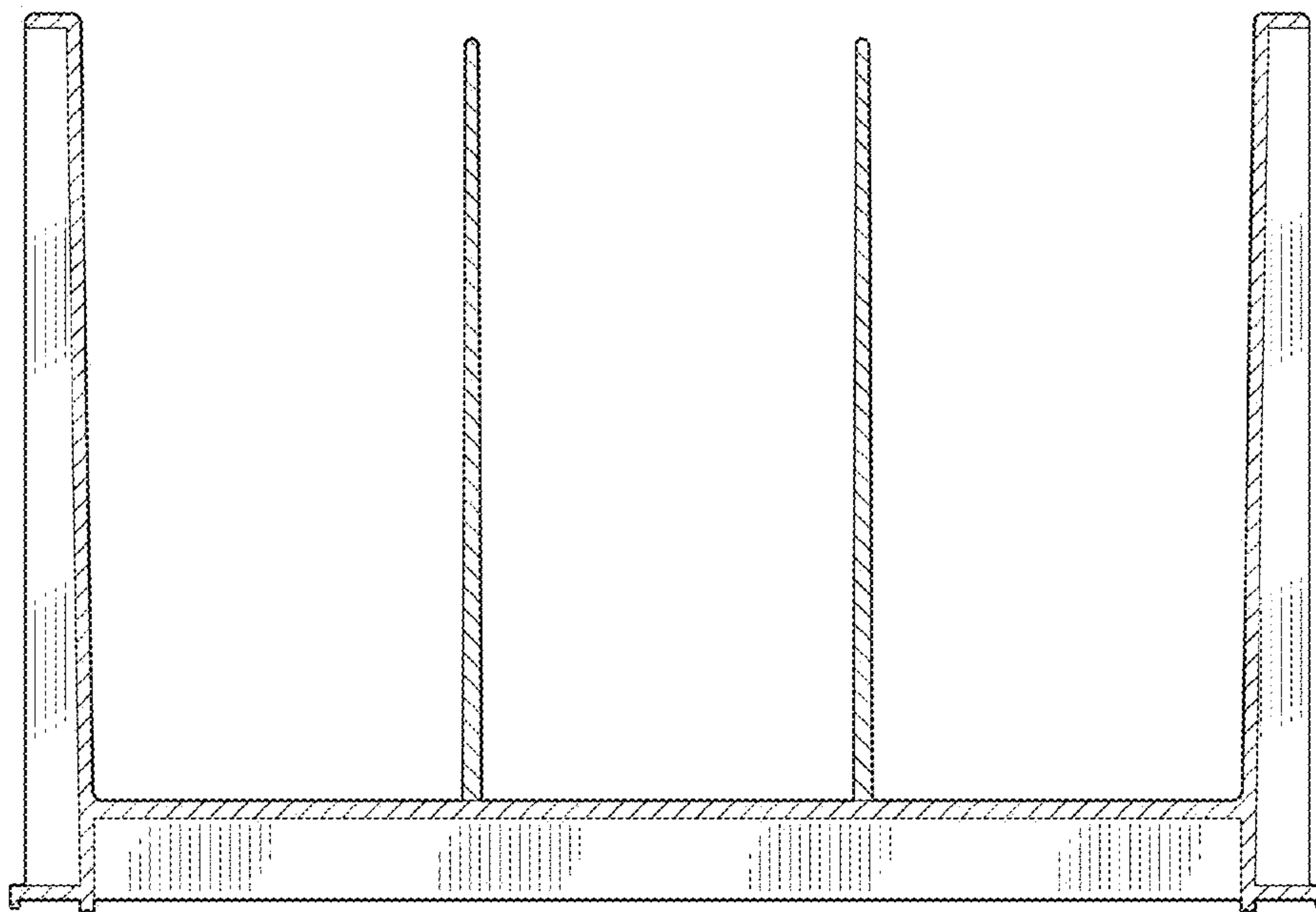

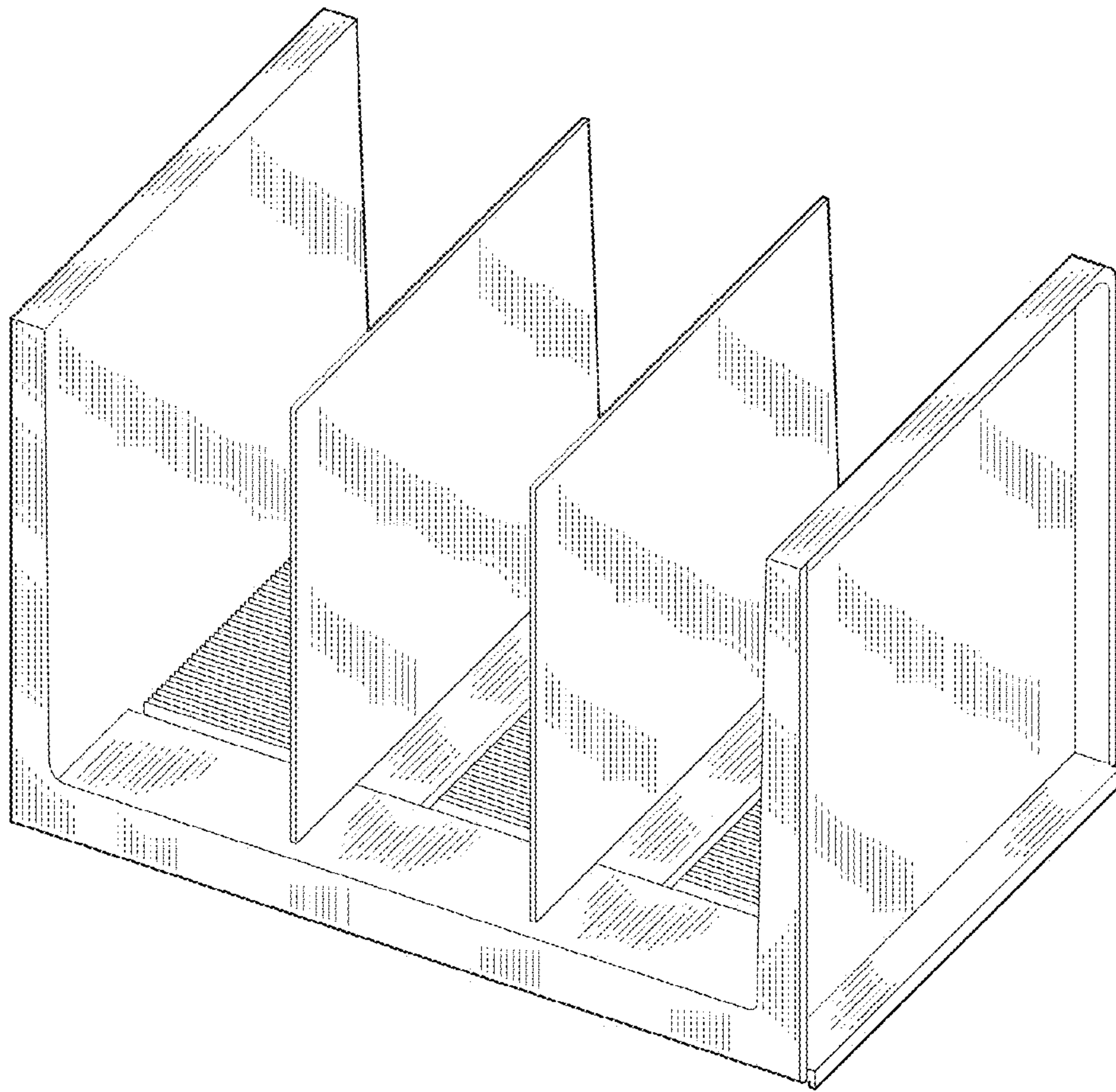

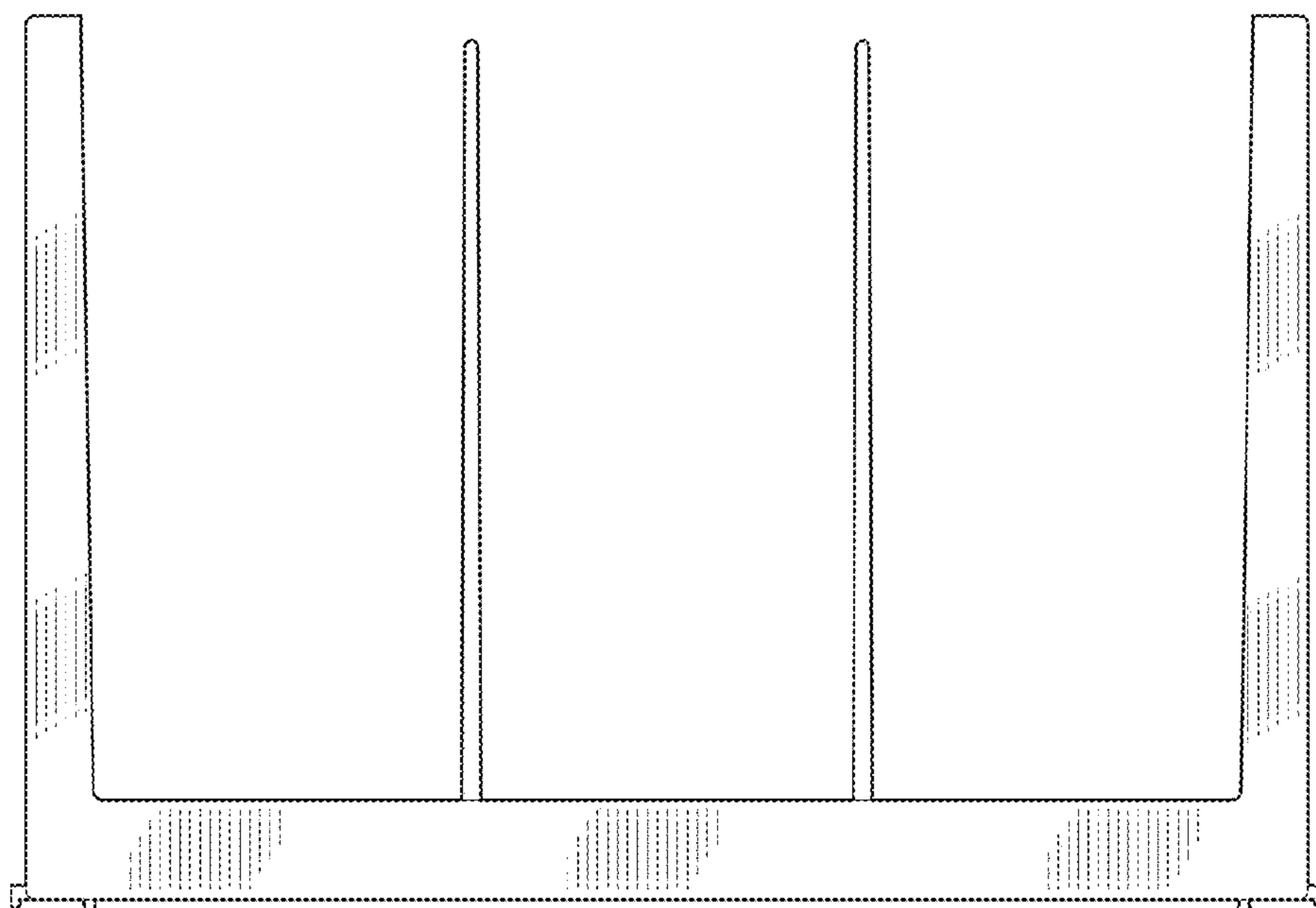

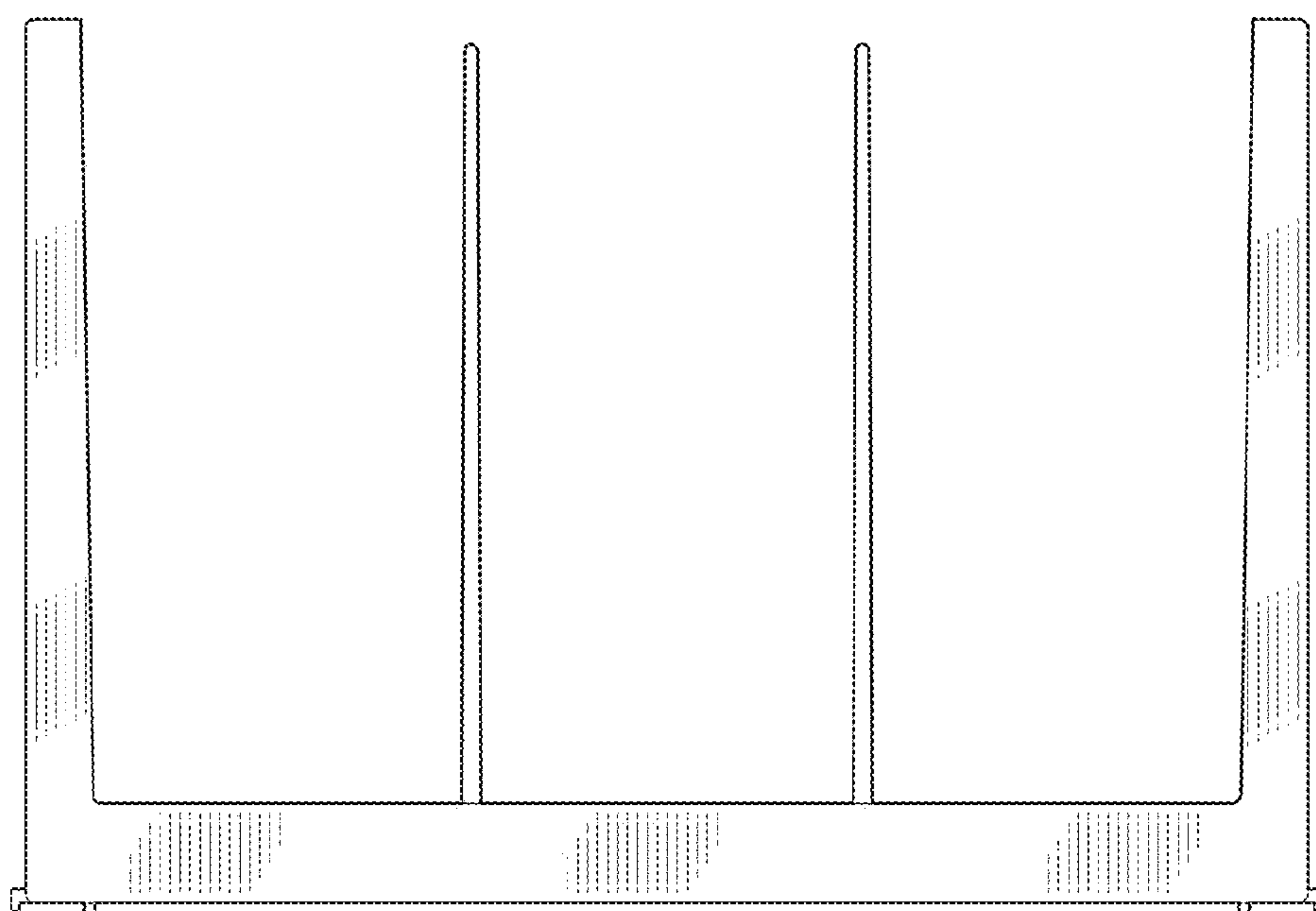

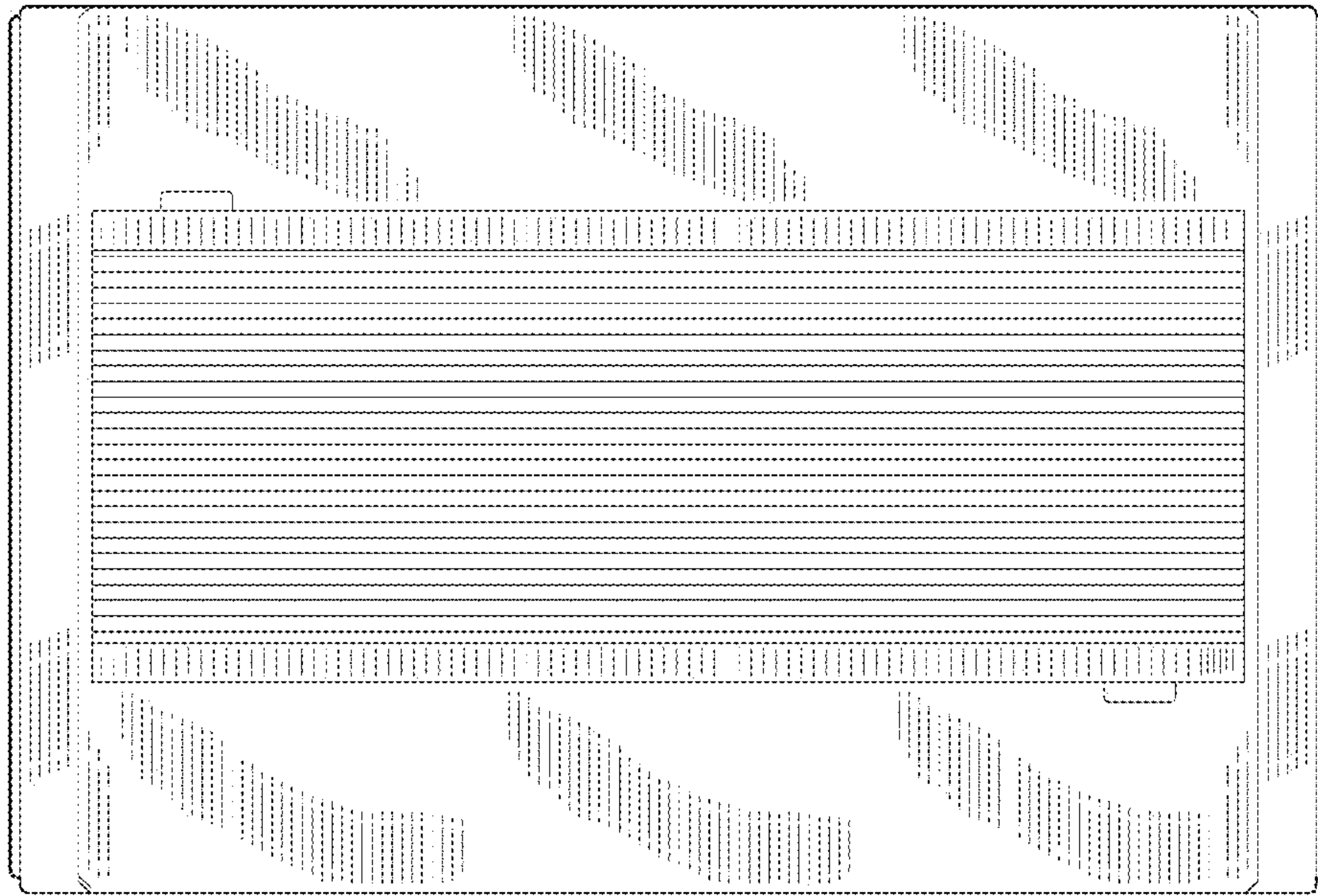

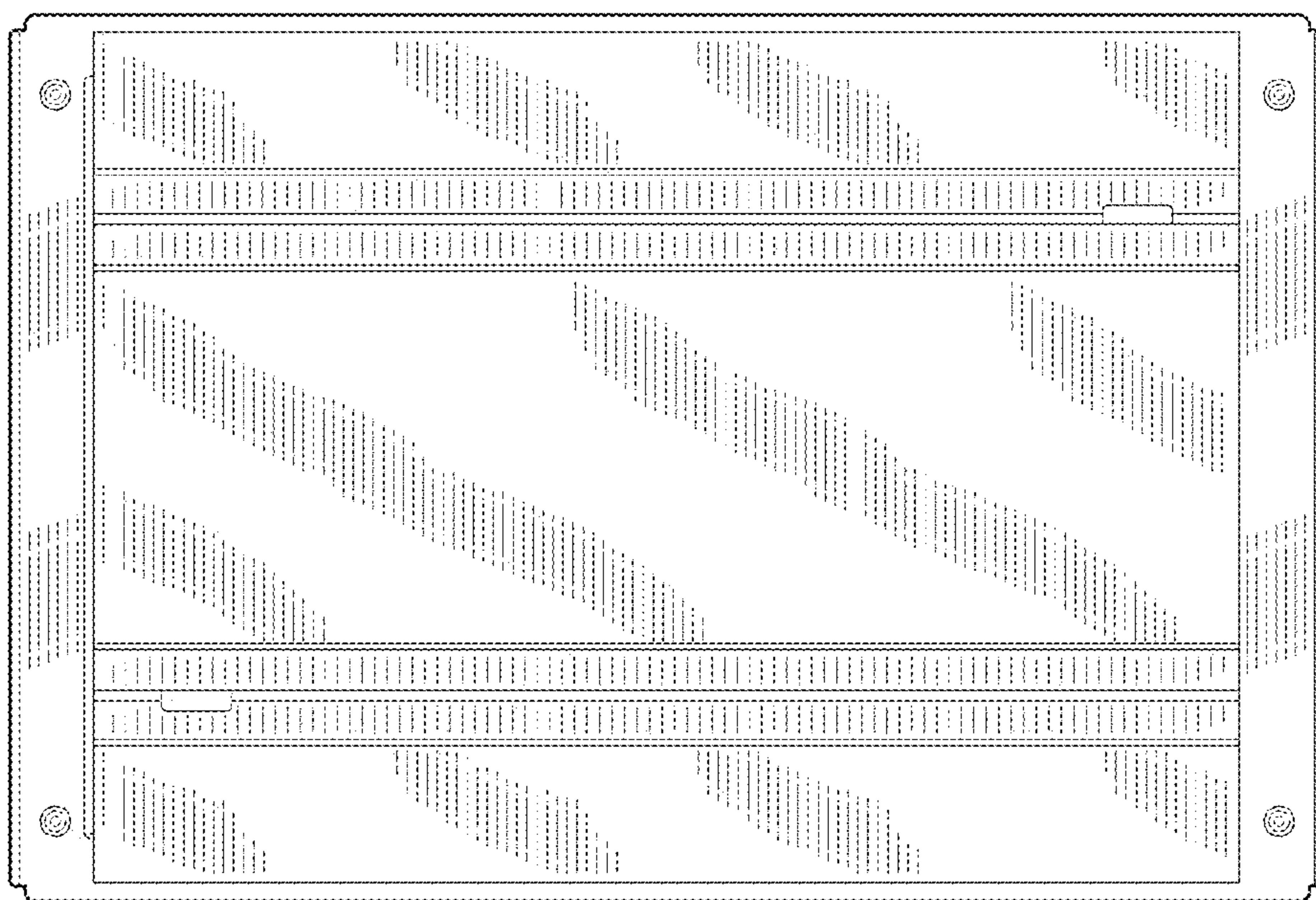

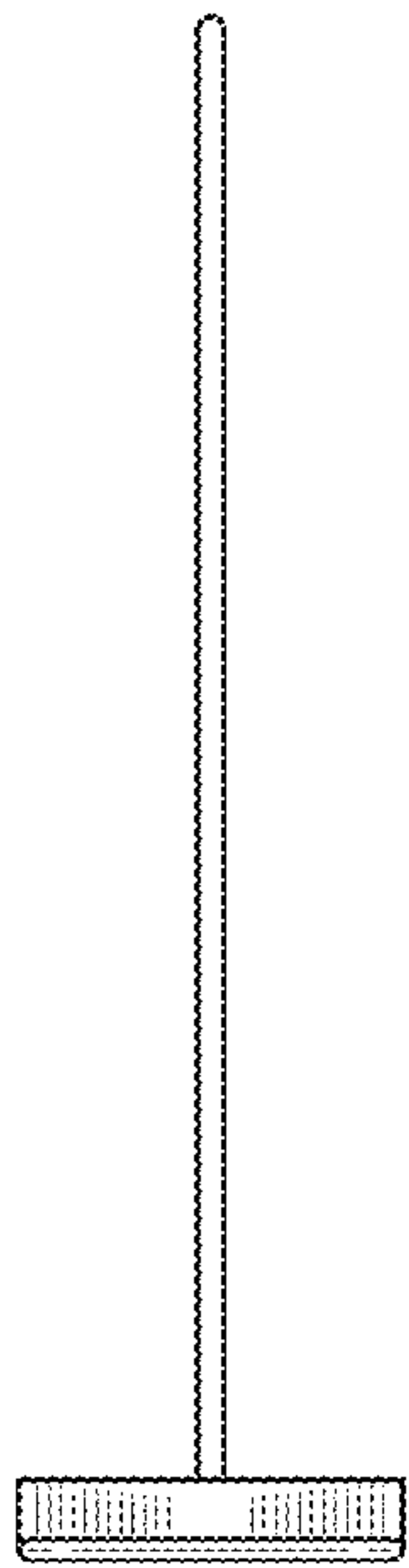

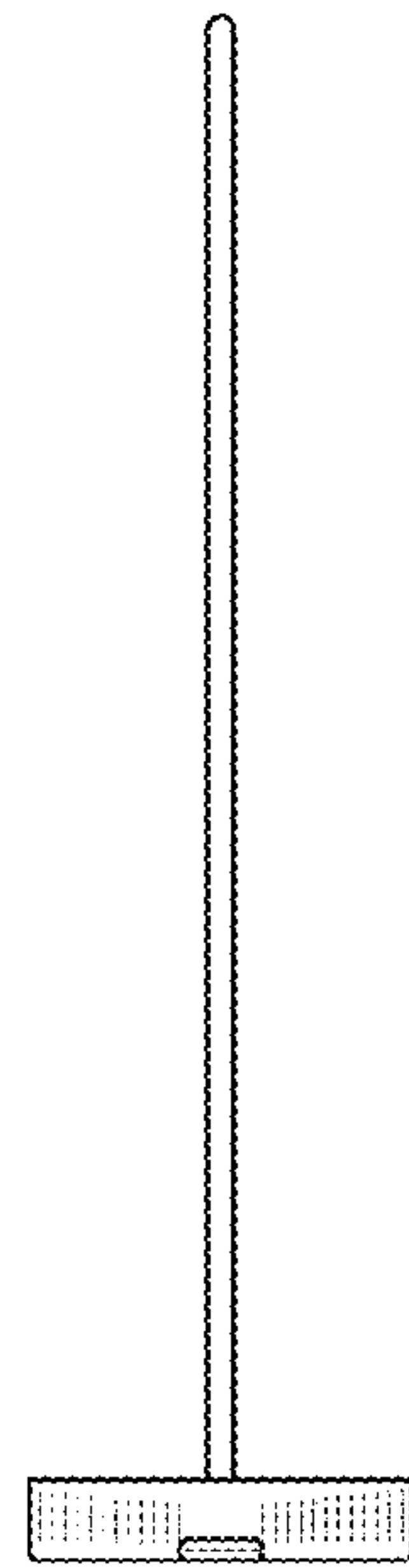

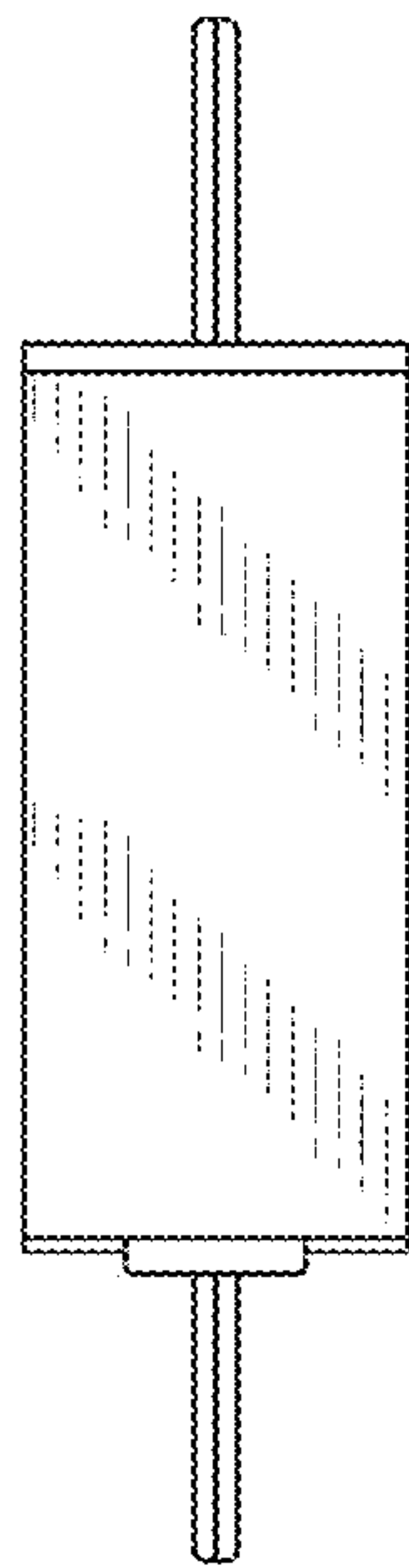

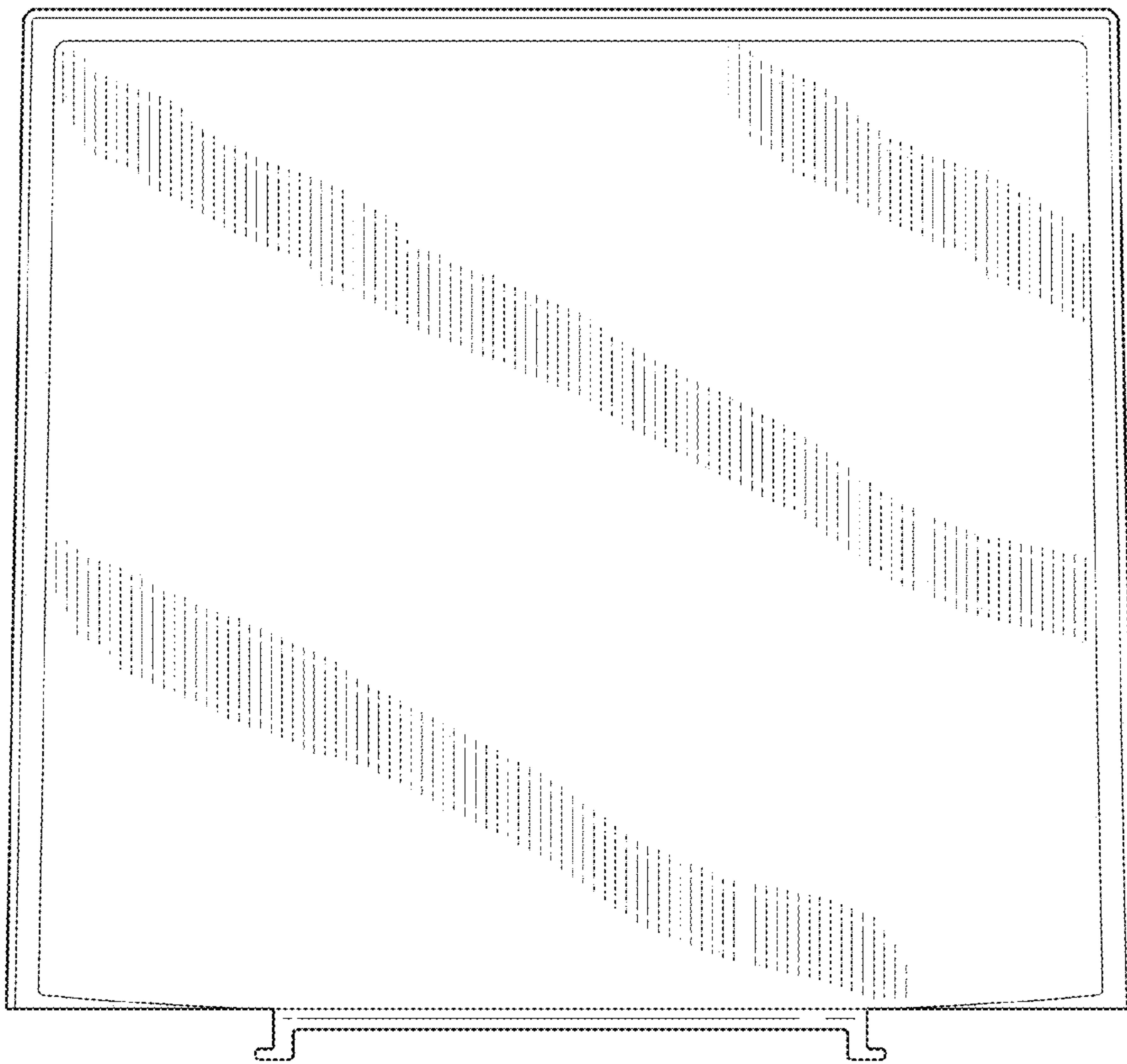
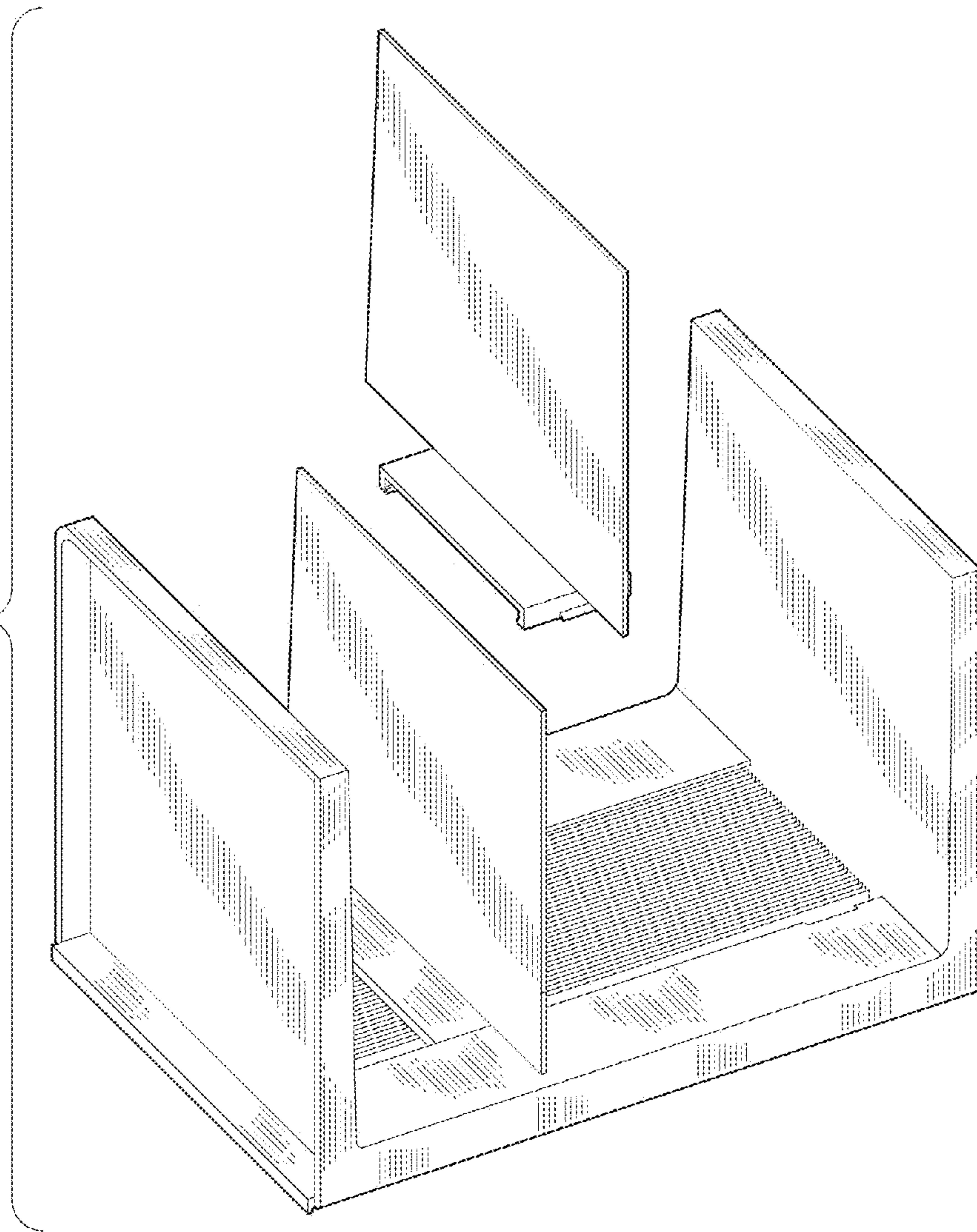

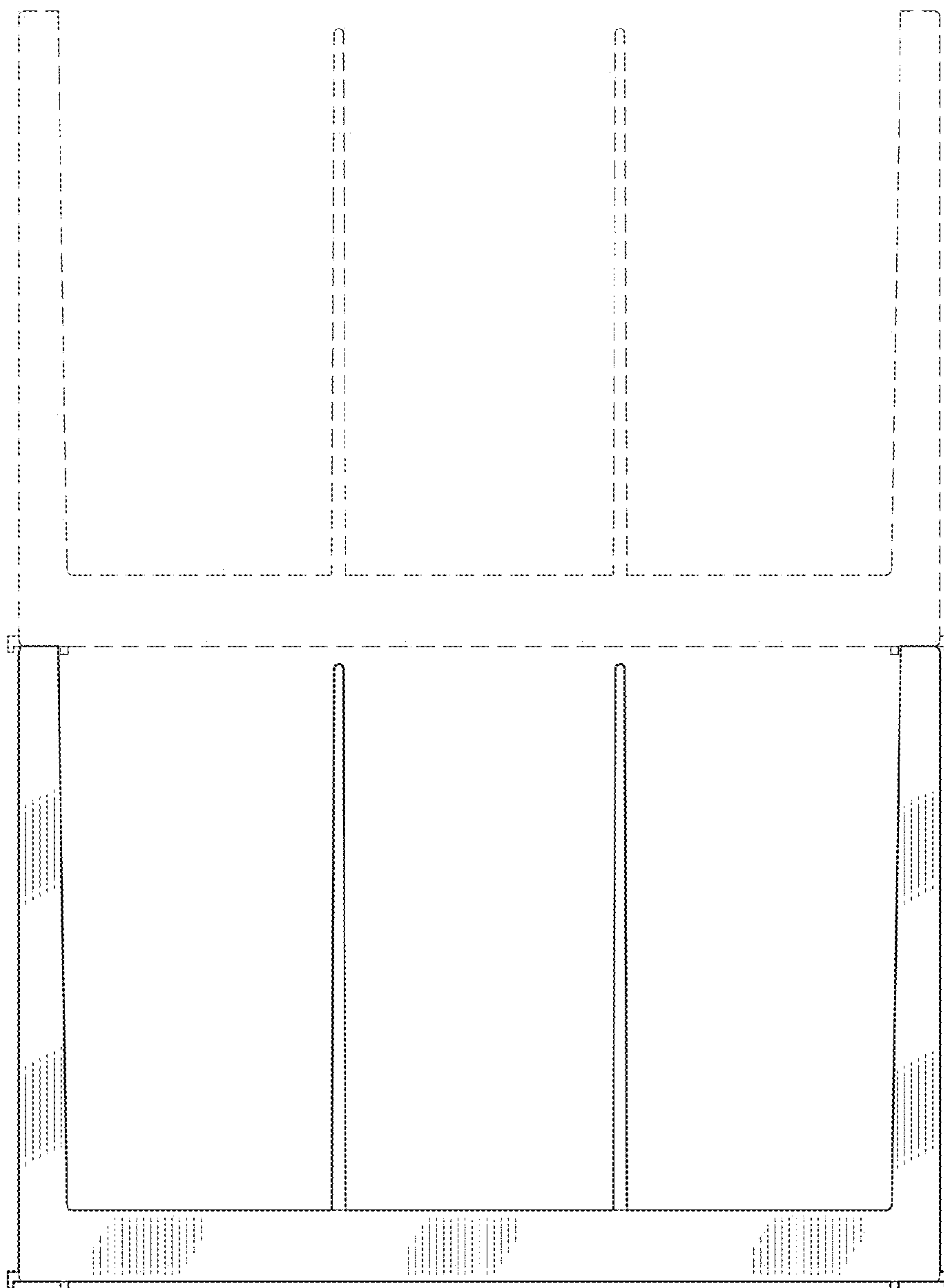
