DESCRIPTION

FIG. 1 is a front perspective view of the invention.

FIG. 2 is a front elevation view of FIG. 1, elevated.

FIG. 4 is a left side elevation view of FIG. 1.

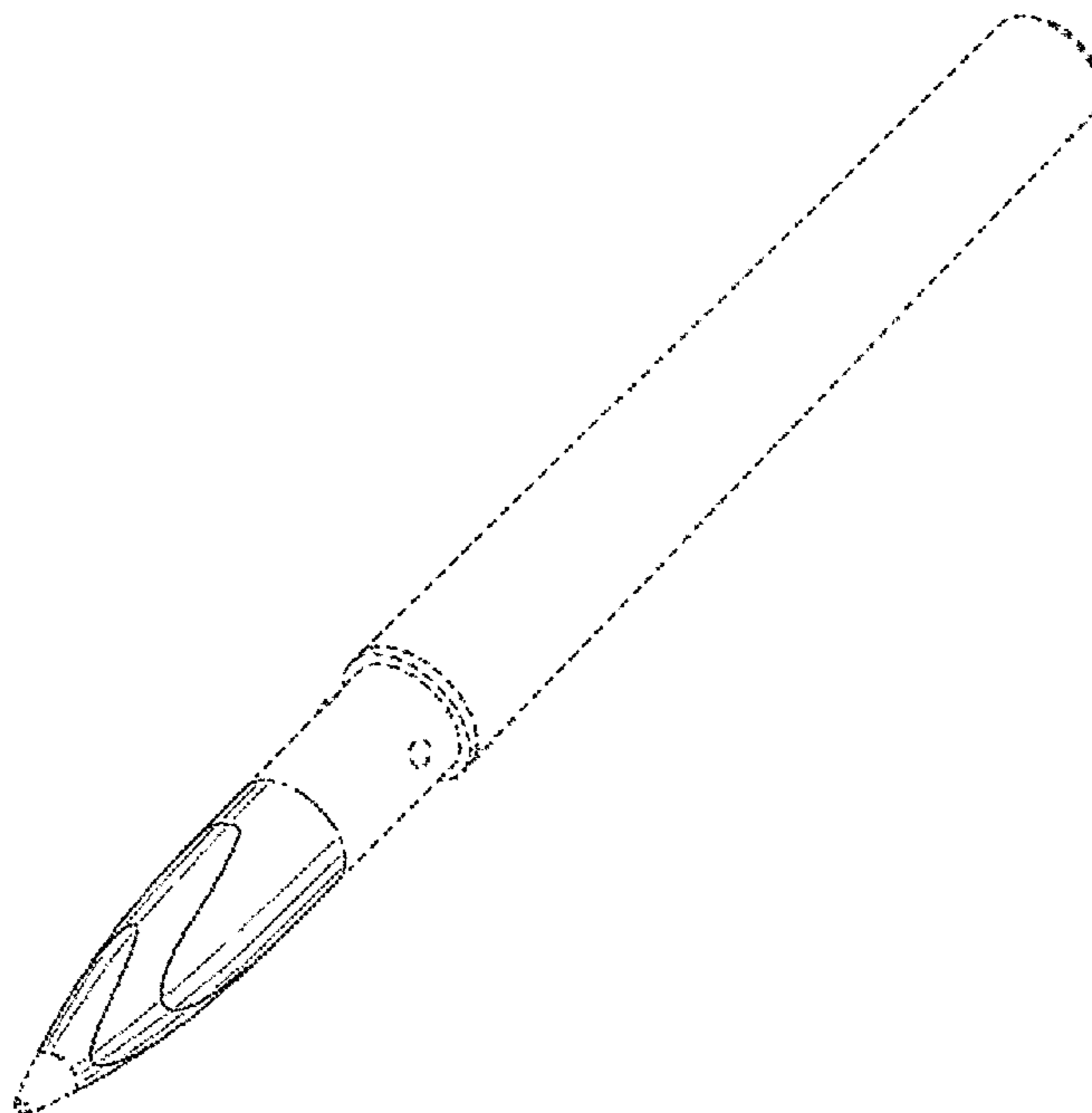

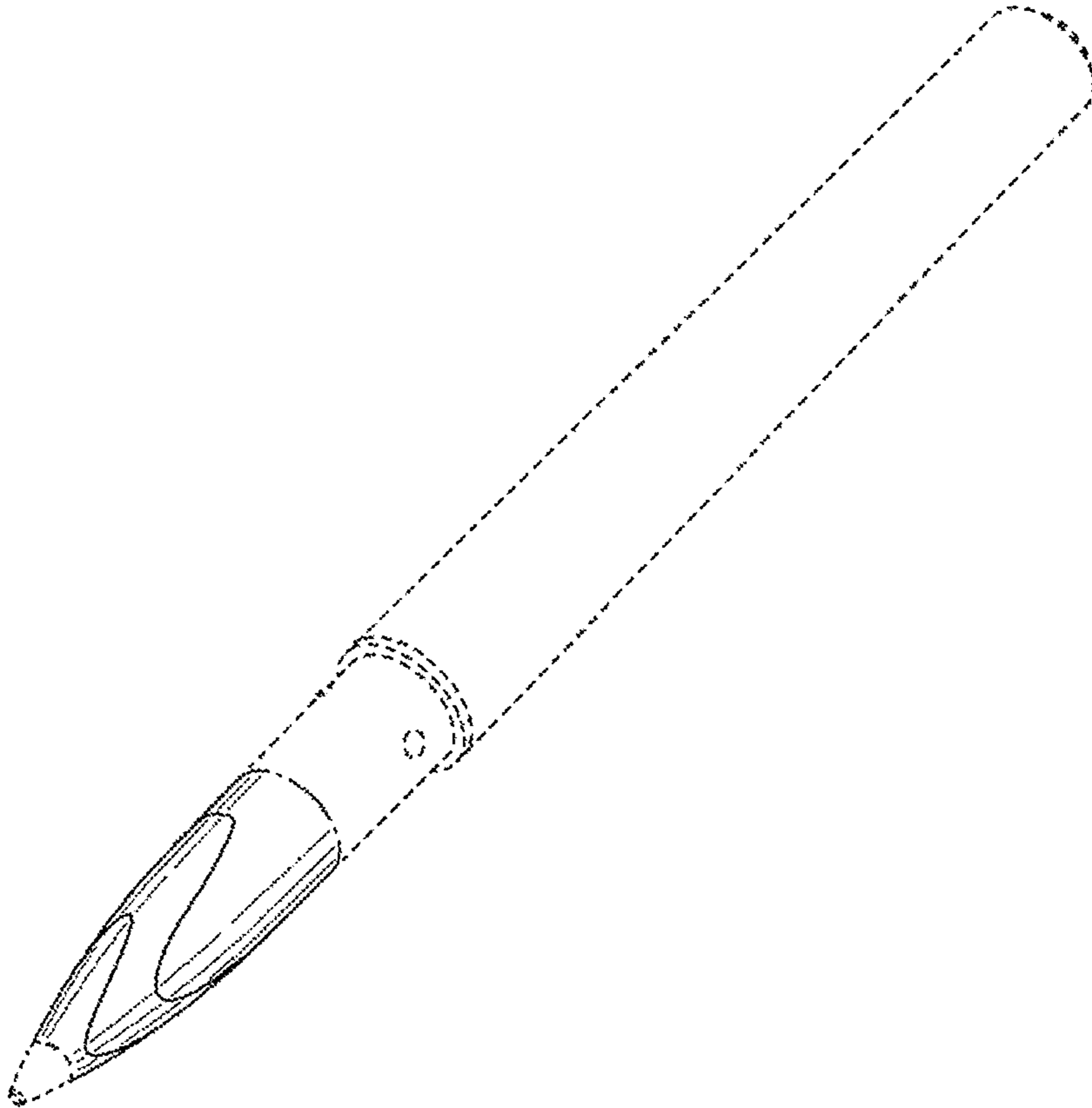

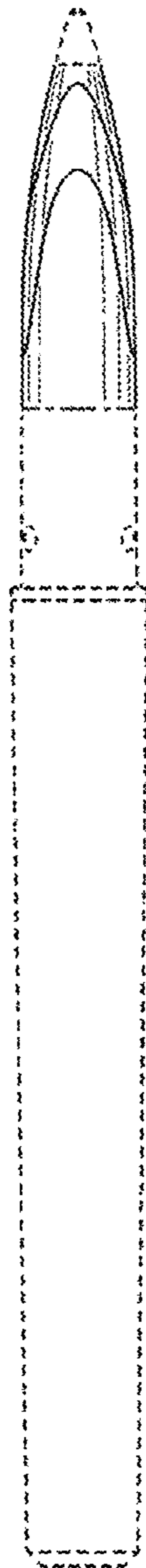

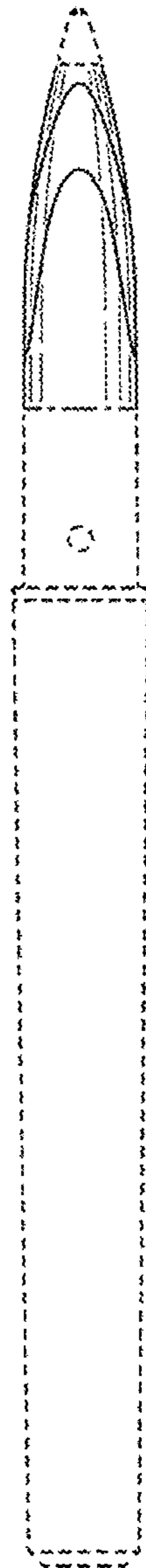

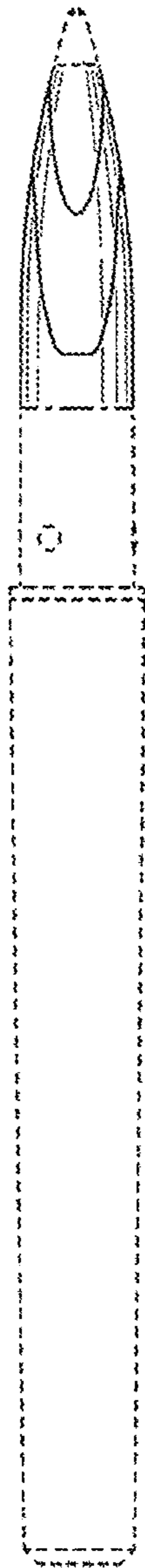
